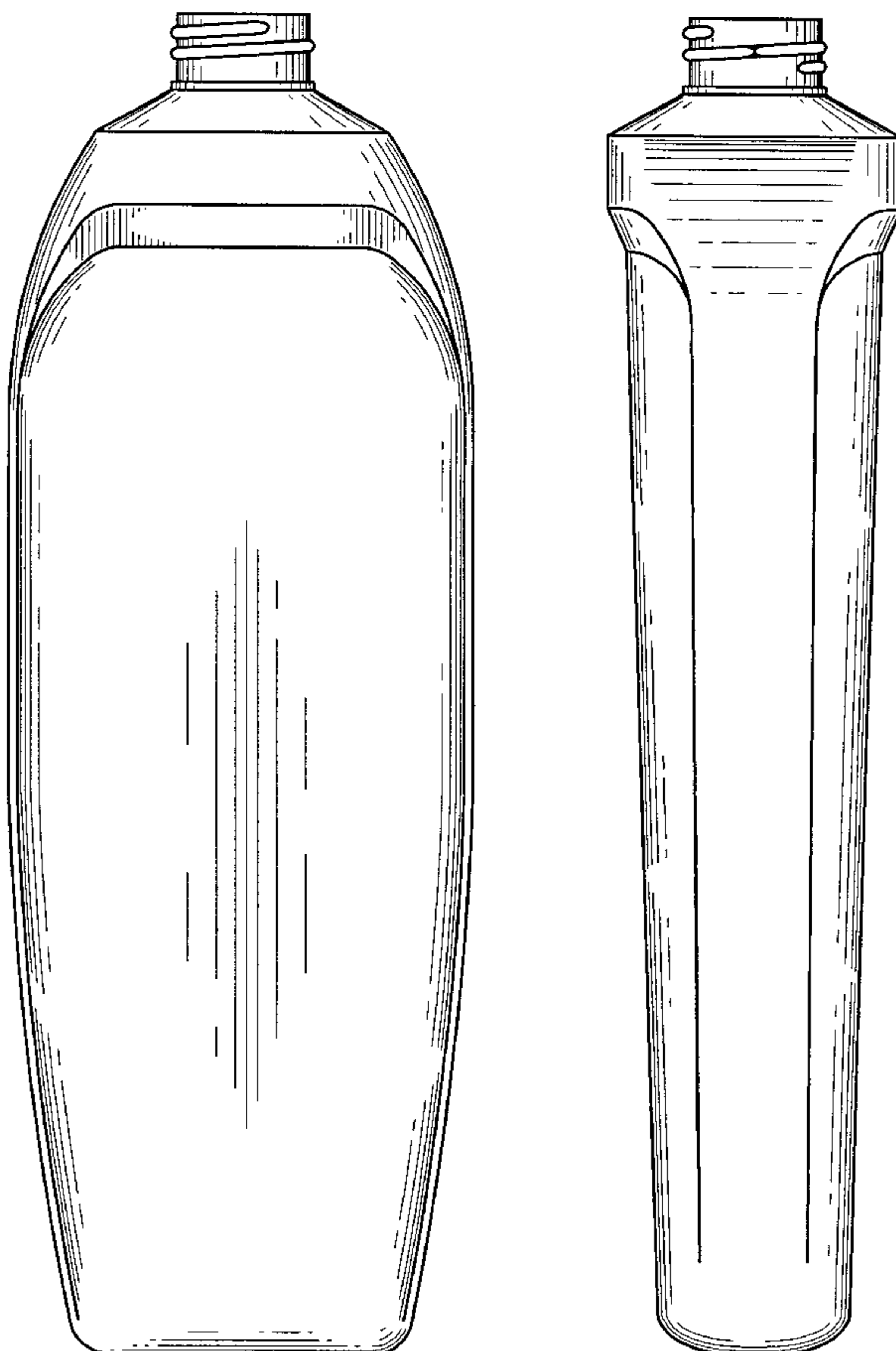

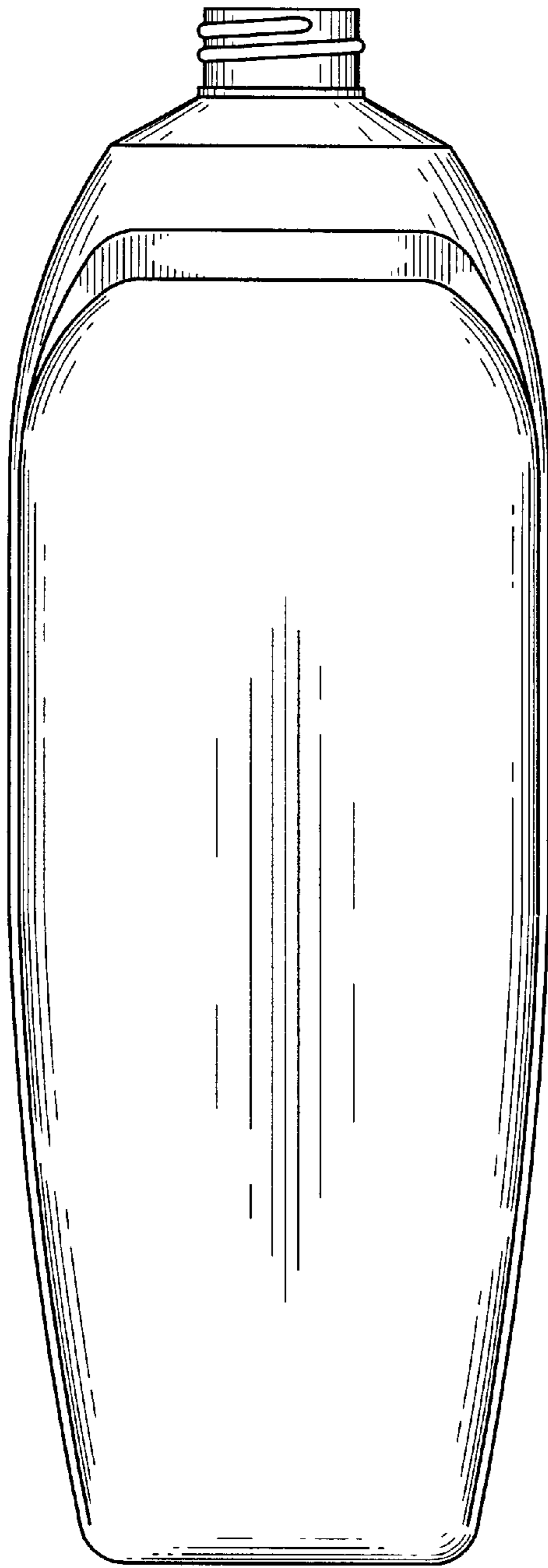
The ornamental design for a bottle, as shown and described.

**DESCRIPTION**

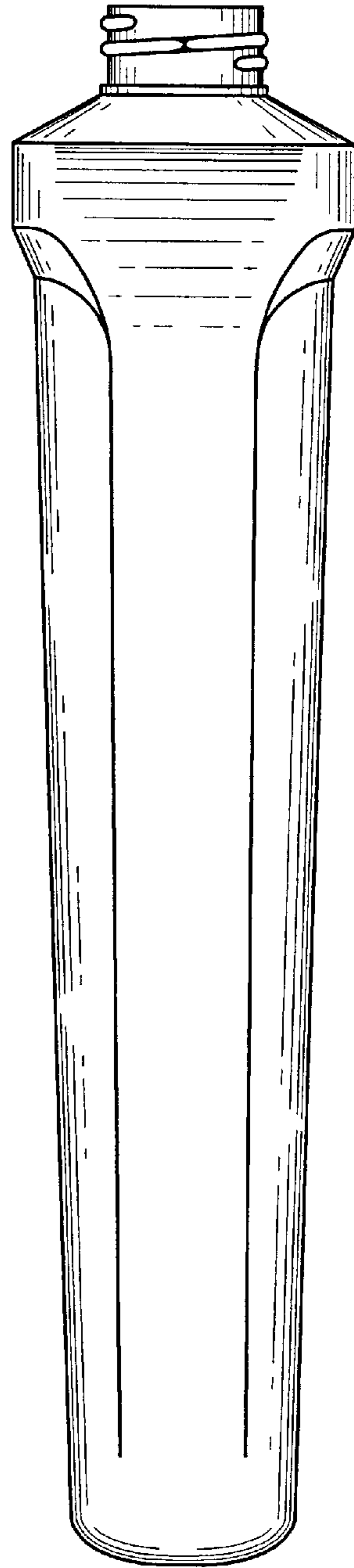
FIG. 1 is a front elevational view thereof;

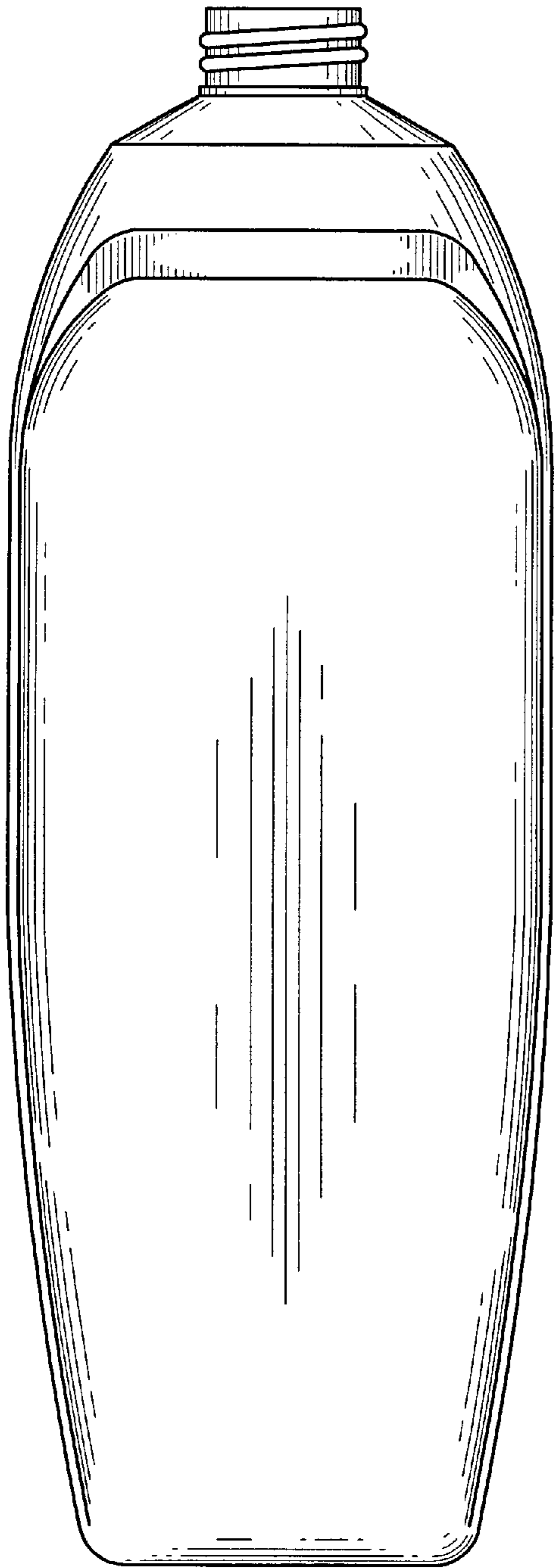




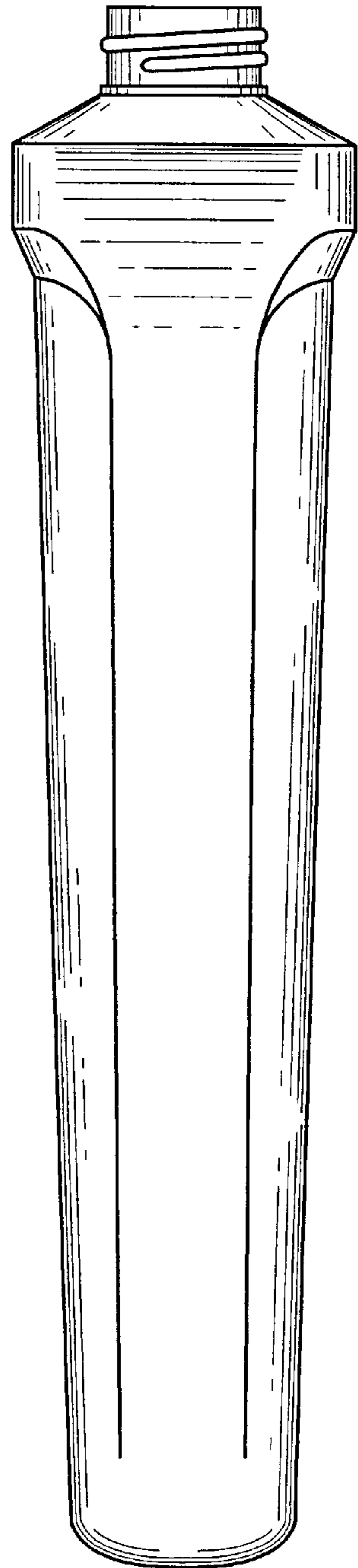

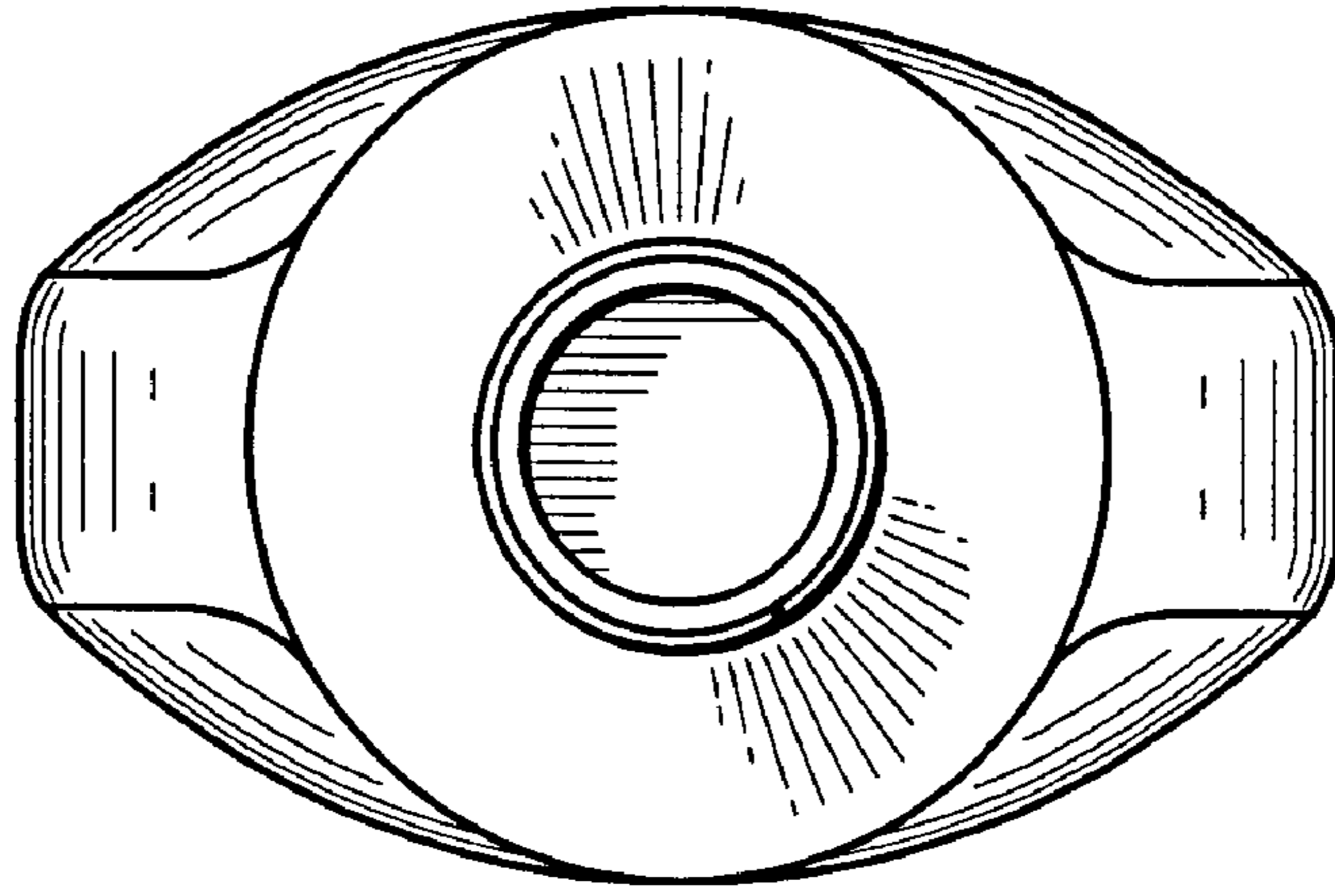

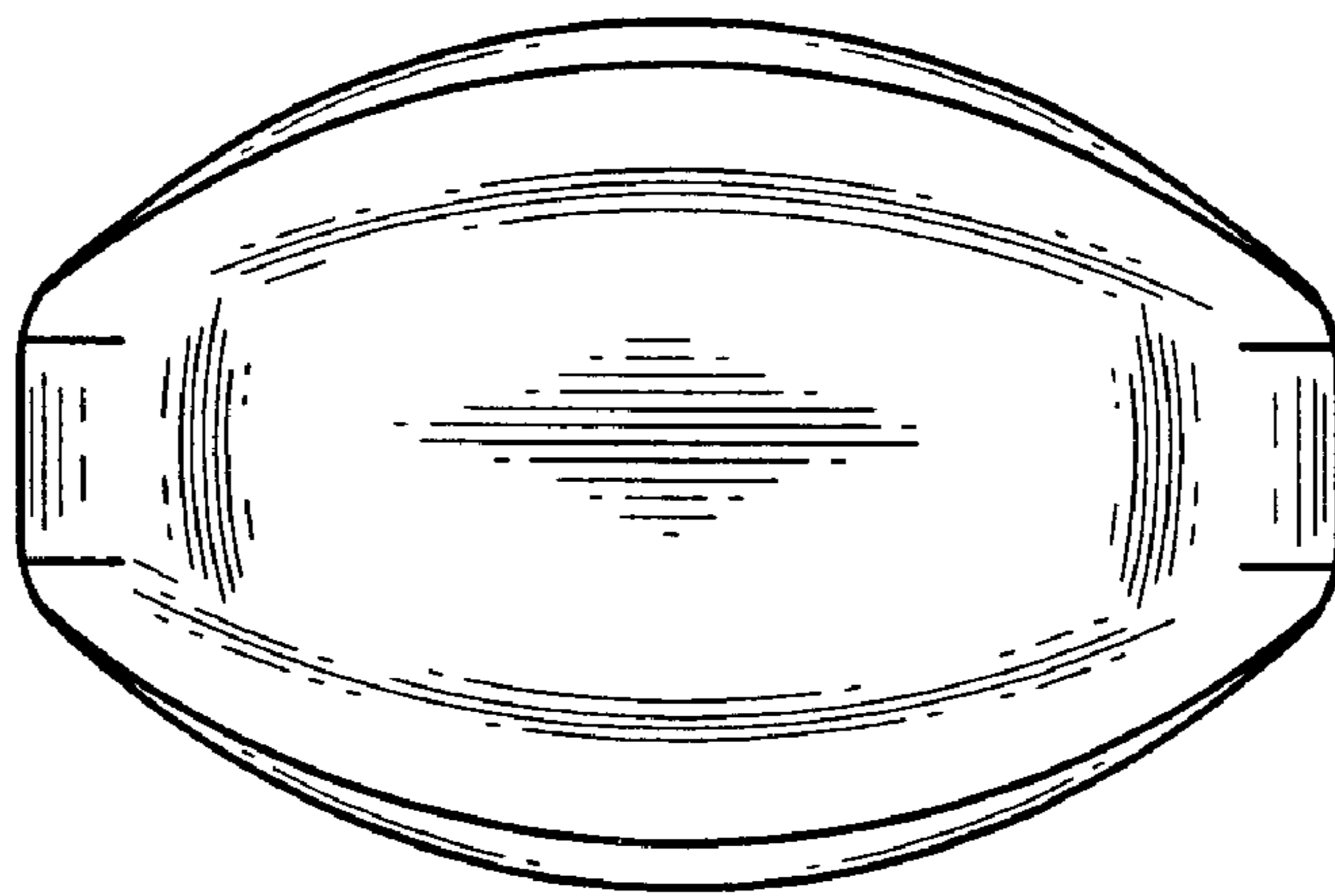
