(57) **CLAIM**

The ornamental design for a depth finder housing, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of our new design for a housing; FIG. 2 is a front view thereof; FIG. 3 is a back view thereof; FIG. 4 is a top side view thereof; FIG. 5 is a bottom side view thereof; and, FIG. 6 is a right side view thereof (in left side view being a mirror image thereof).

The phantom lines illustrating a stand in FIG. 1 form no part of the claimed design.

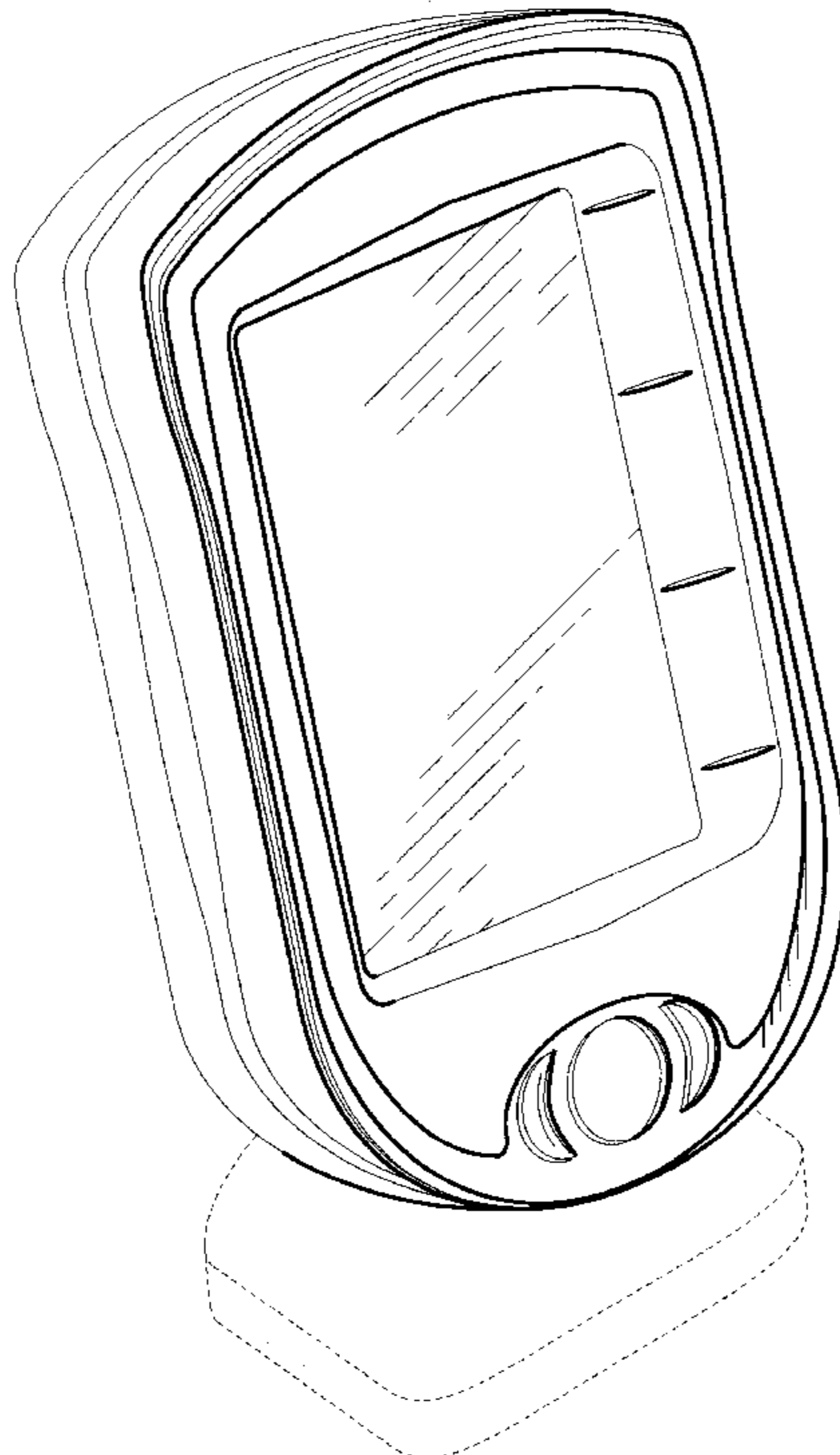

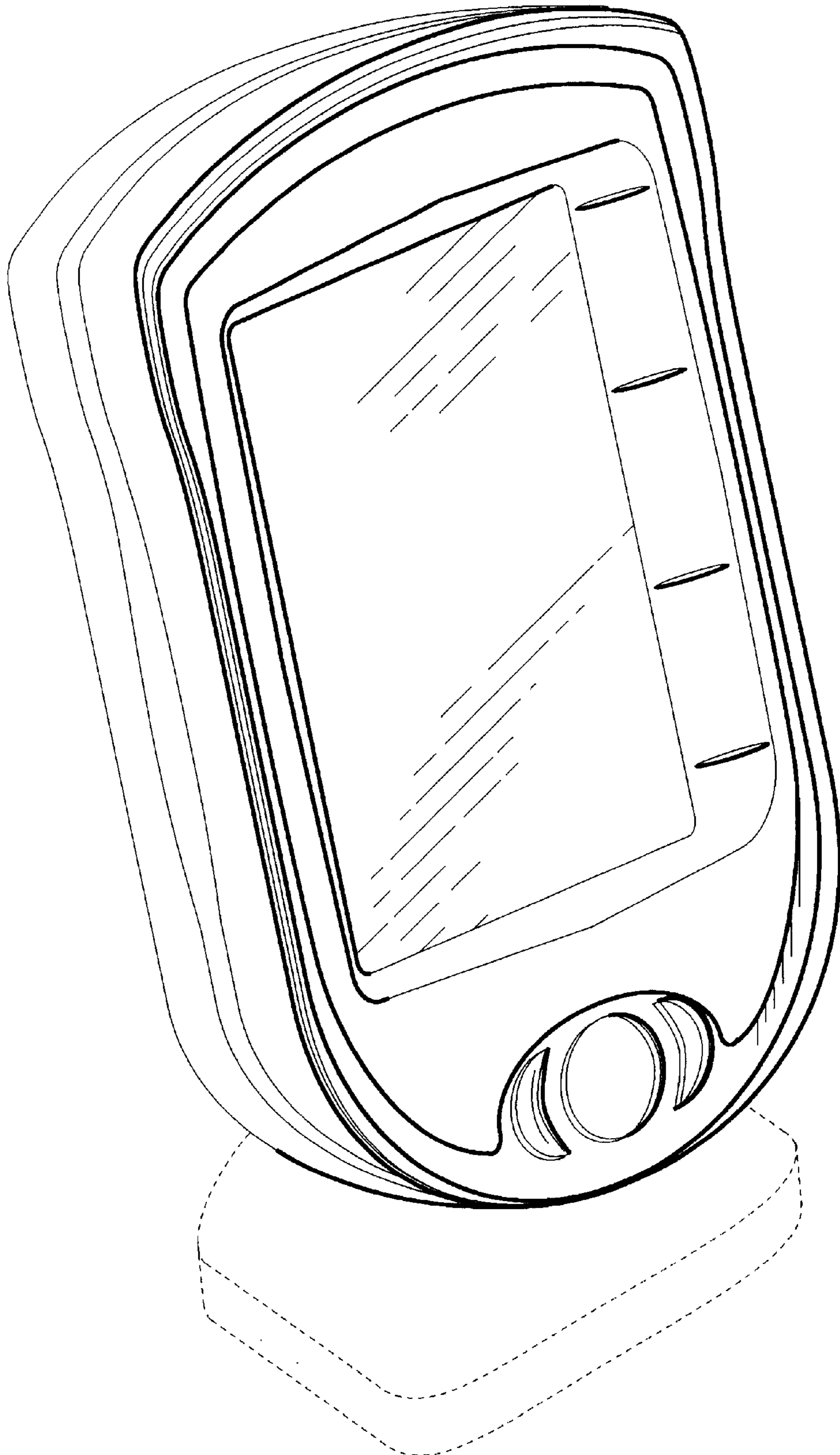

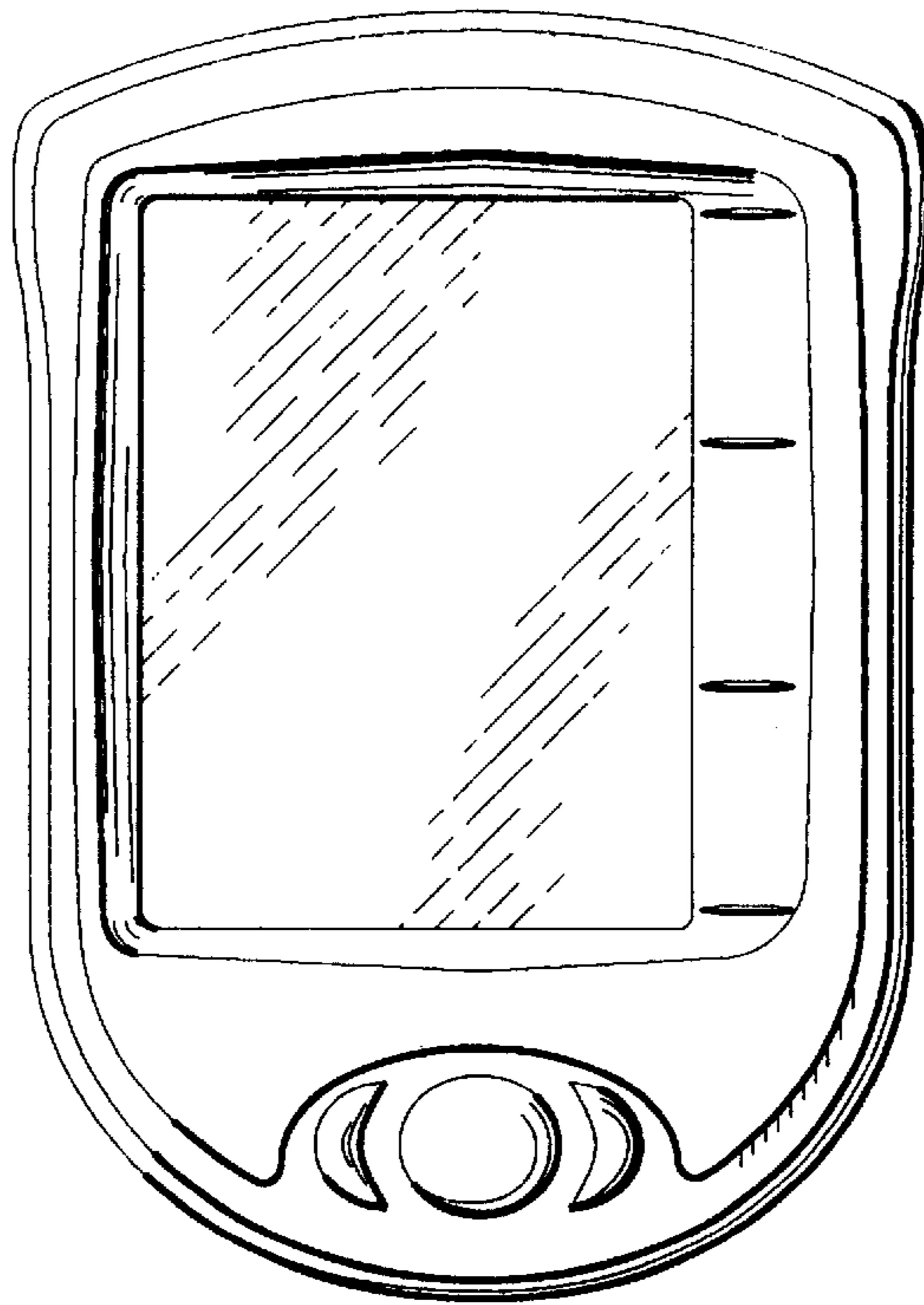

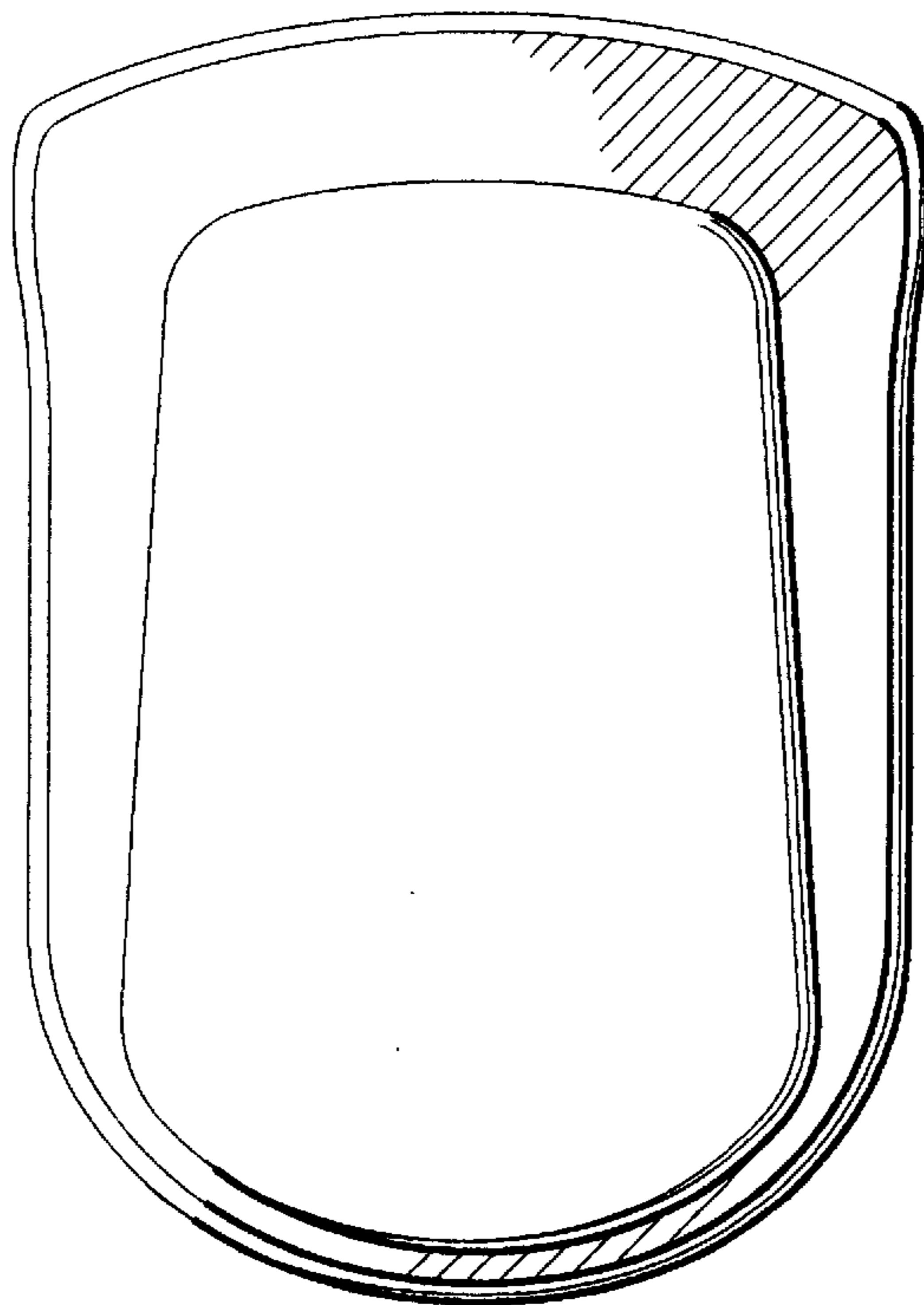

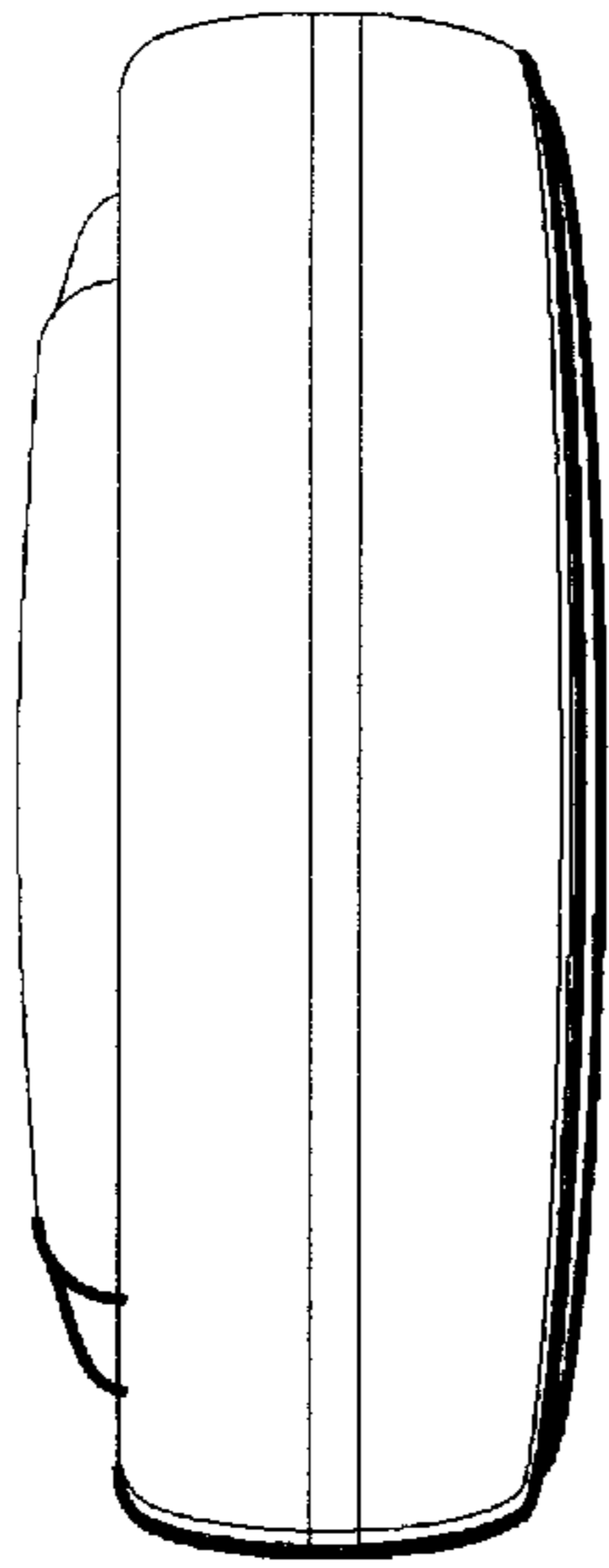

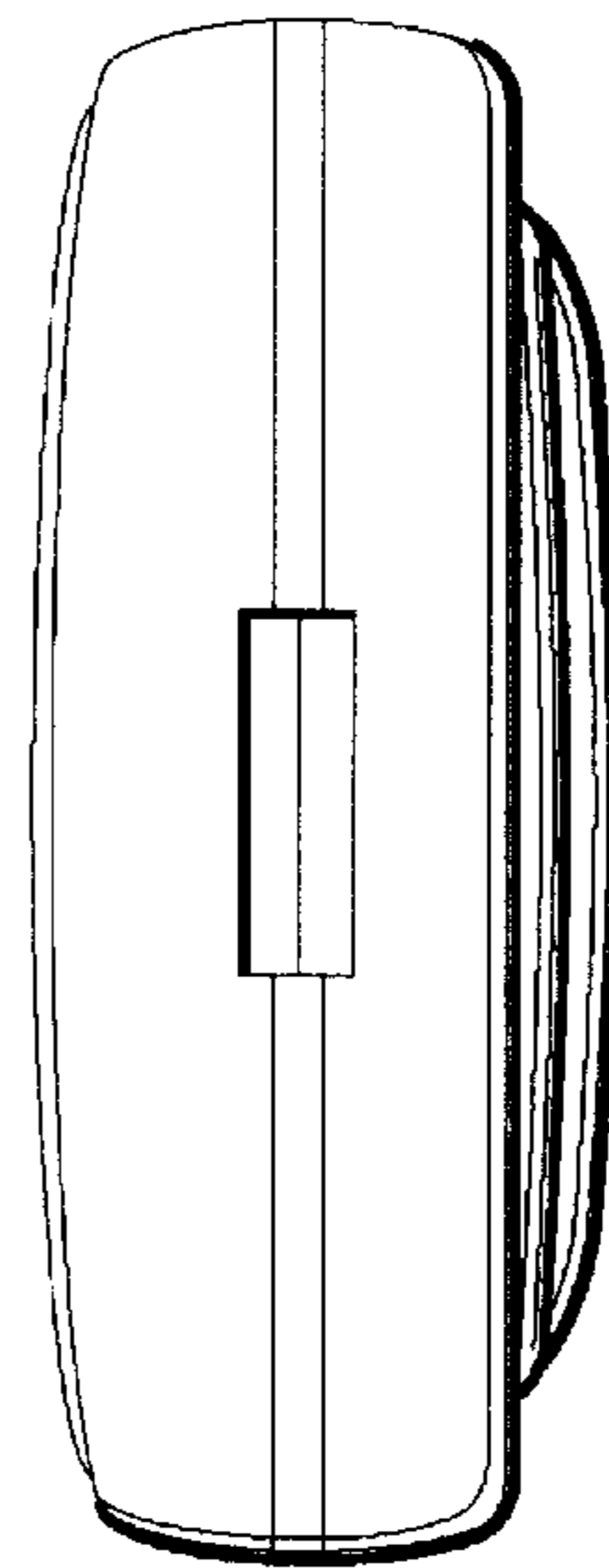
