(57) **CLAIM**

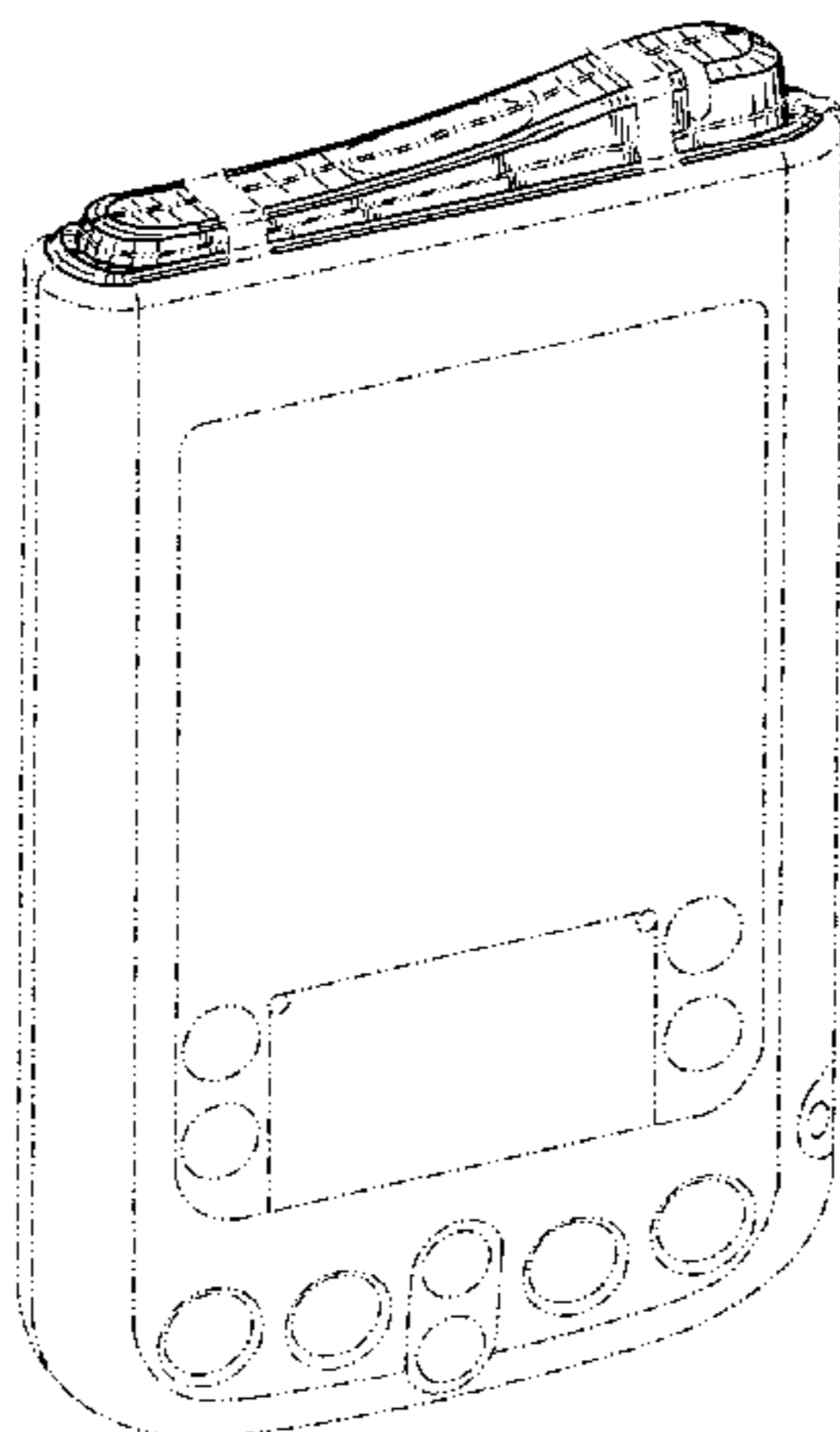
We claim the ornamental design for an antenna for a handheld computer, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a first embodiment of an antenna for a handheld computer showing our new design. FIG. 2 is a front elevation view. FIG. 3 is a rear elevation view. FIG. 4 is a top plan view. FIG. 5 is a left side elevation view. FIG. 6 is a right side elevation view. FIG. 7 is a perspective view of a second embodiment of an antenna for a handheld computer. FIG. 8 is a front elevation view. FIG. 9 is a rear elevation view. FIG. 10 is a top plan view. FIG. 11 is a left side view. FIG. 12 is a right side view. FIG. 13 is a perspective view of a third embodiment of an antenna for a handheld computer. FIG. 14 is a front elevation view. FIG. 15 is a rear elevation view. FIG. 16 is a top plan view. FIG. 17 is a left side elevation view. FIG. 18 is a right side elevation view. FIG. 19 is a perspective view of a fourth embodiment of an antenna for a handheld computer. FIG. 20 is a front elevation view. FIG. 21 is a top plan view; and, FIG. 22 is a left side elevation view.

The broken line disclosure is for illustrative purposes only and forms no part of the claimed design. The ornamental design for an antenna for a handheld computer shown is a design whereby the right hand portion of the ornamental design for an antenna for a handheld computer is higher than the left hand portion of the ornamental design for an antenna for a handheld computer; the complementary design for an ornamental design for an antenna for a handheld computer having a left hand portion higher than a right hand portion is considered within the scope of the claimed design, described by a mirror image of FIGS. 1-22.

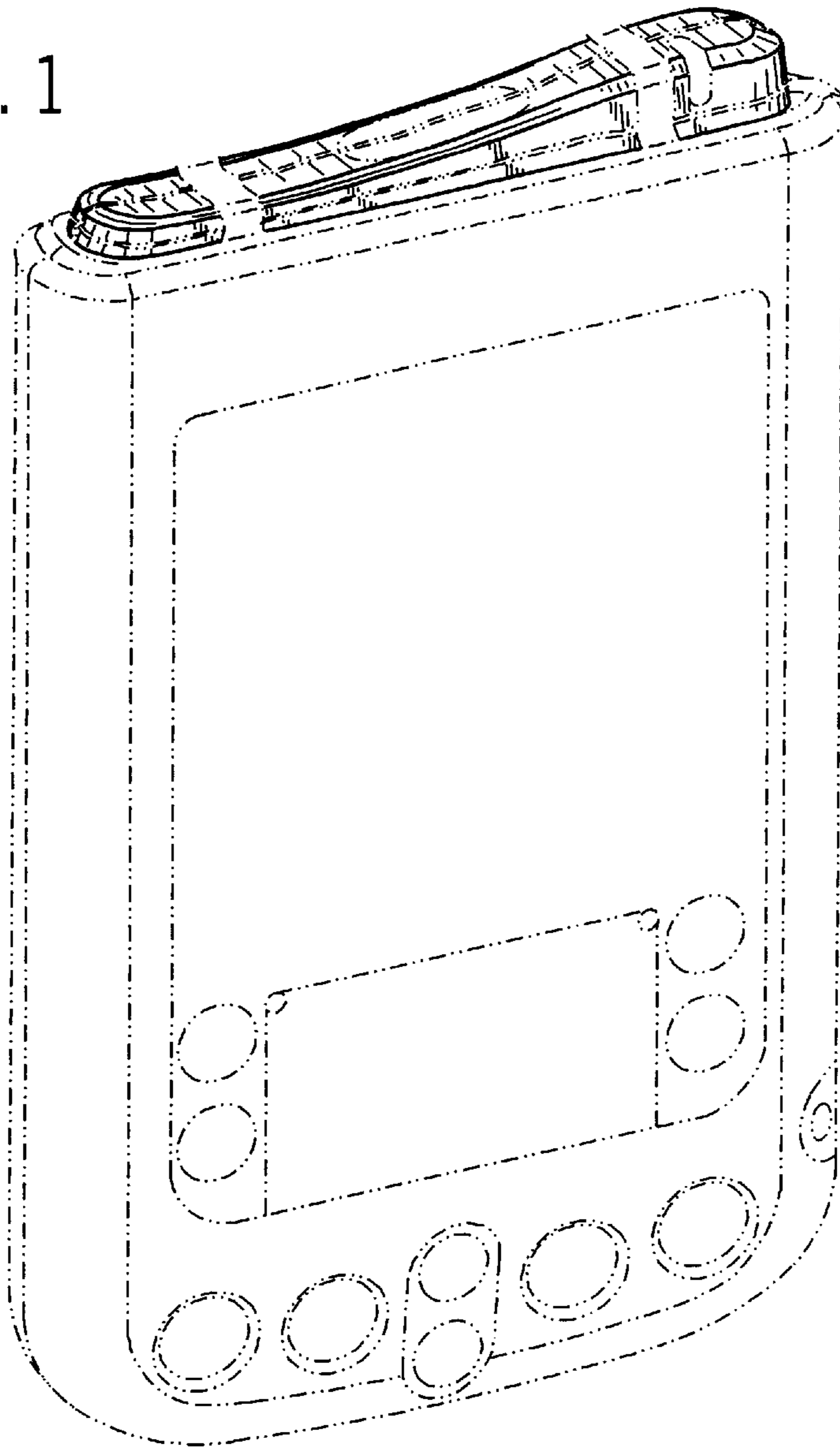

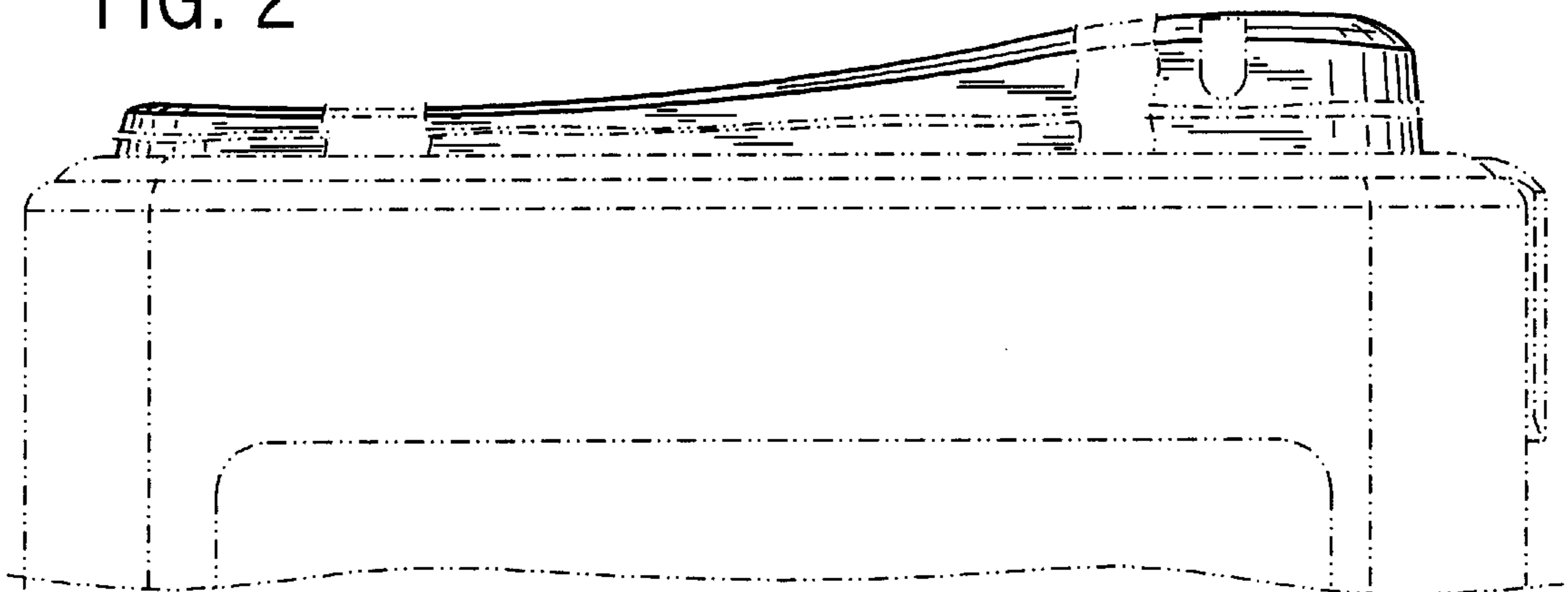

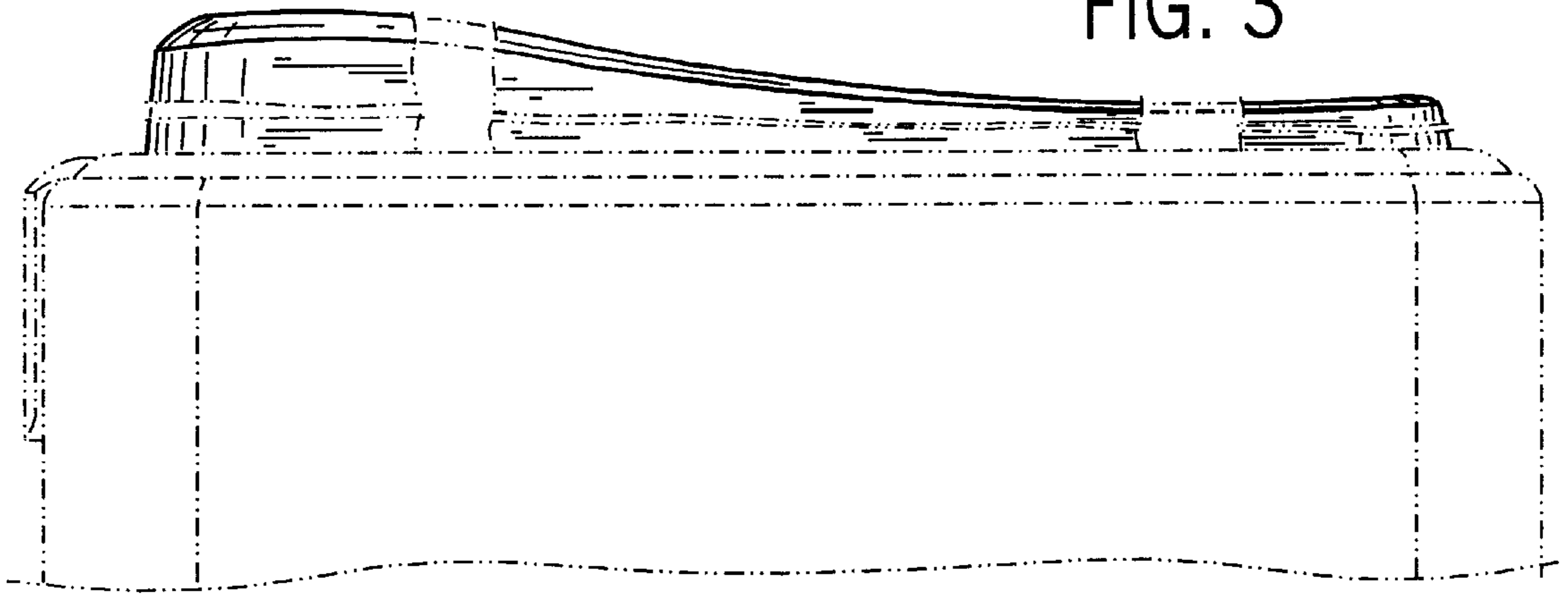

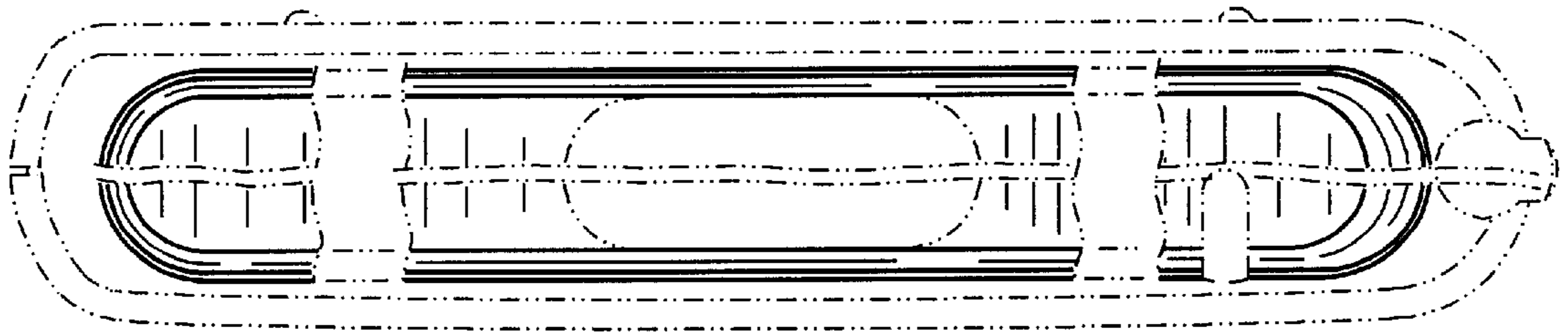

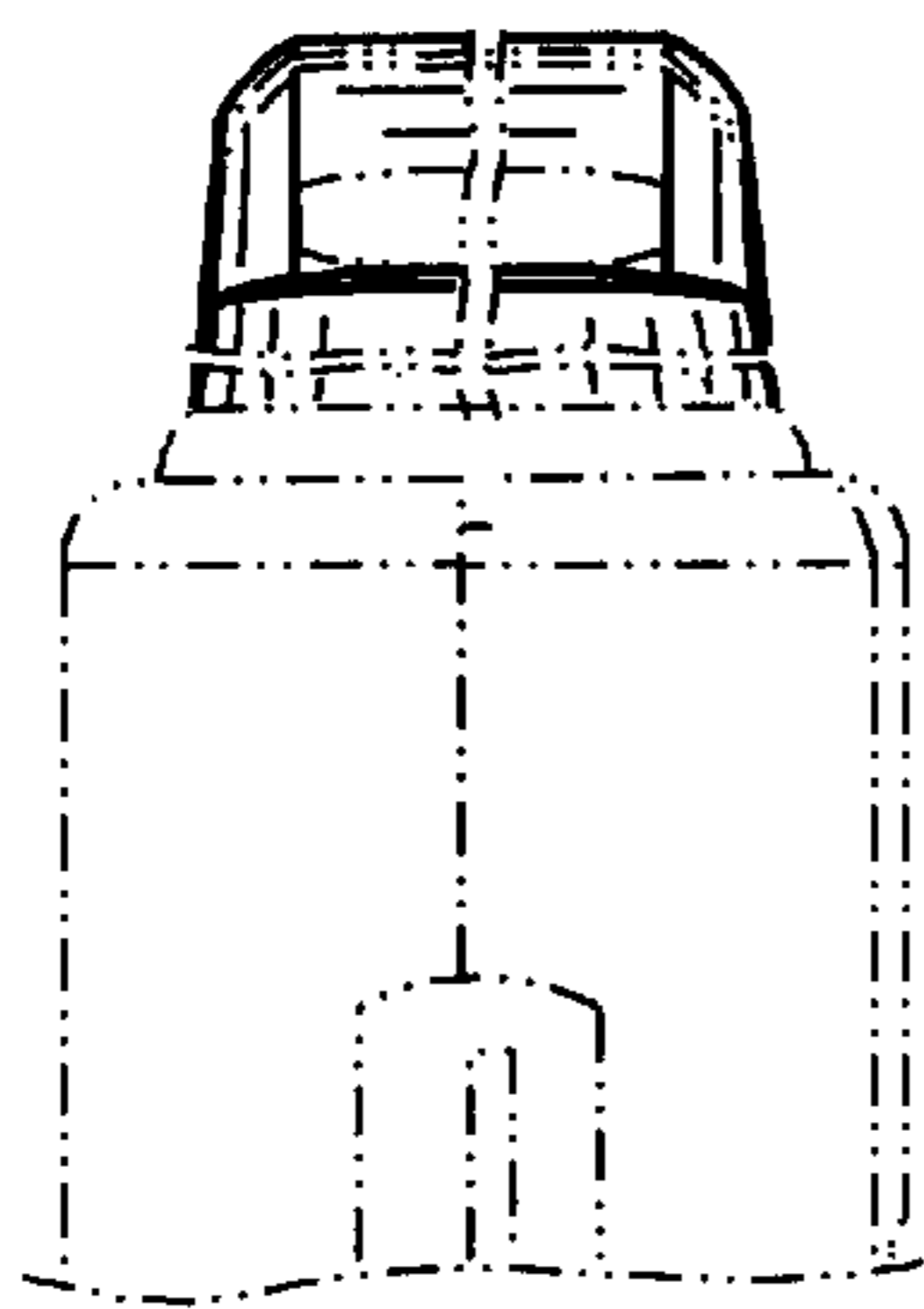

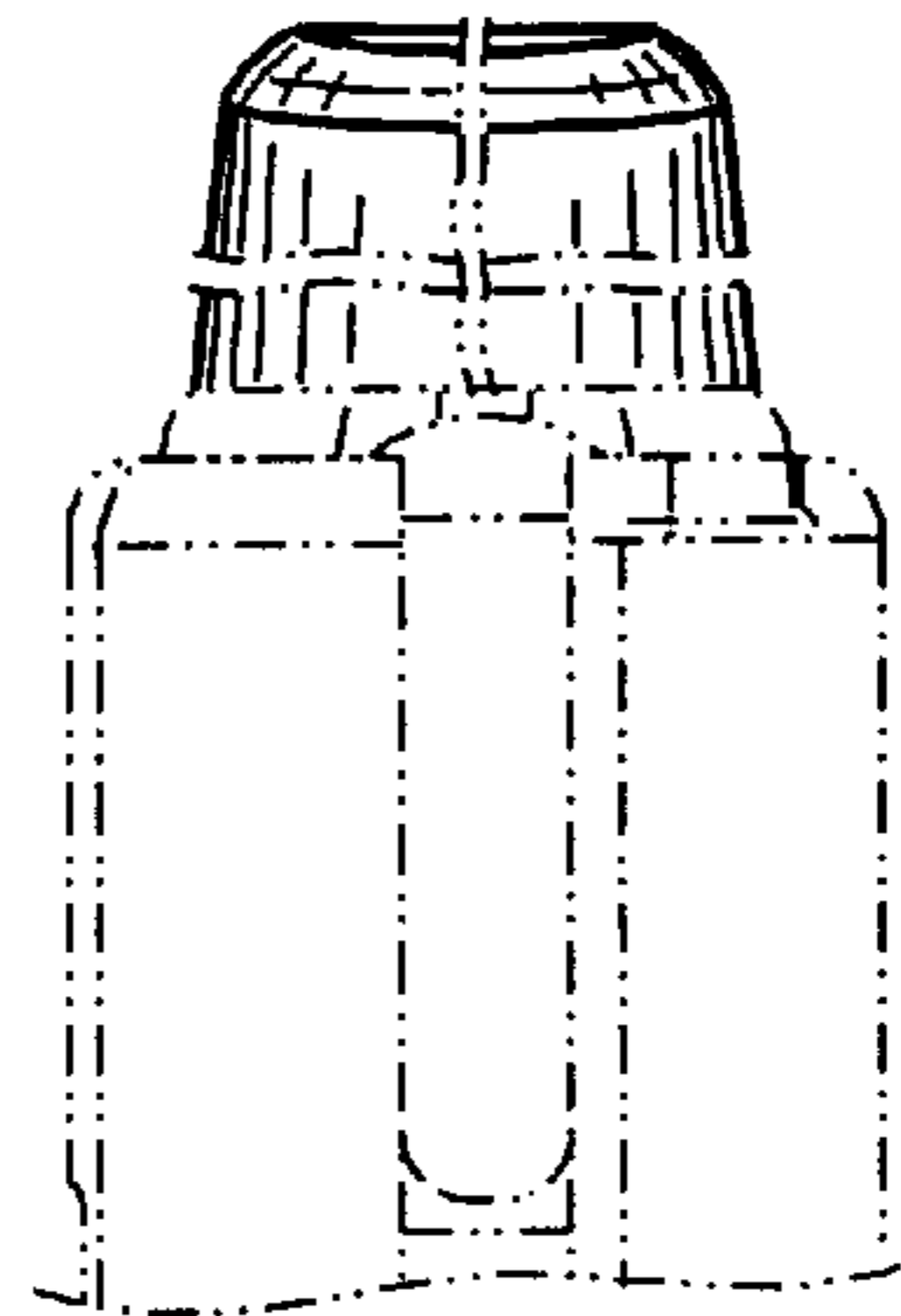

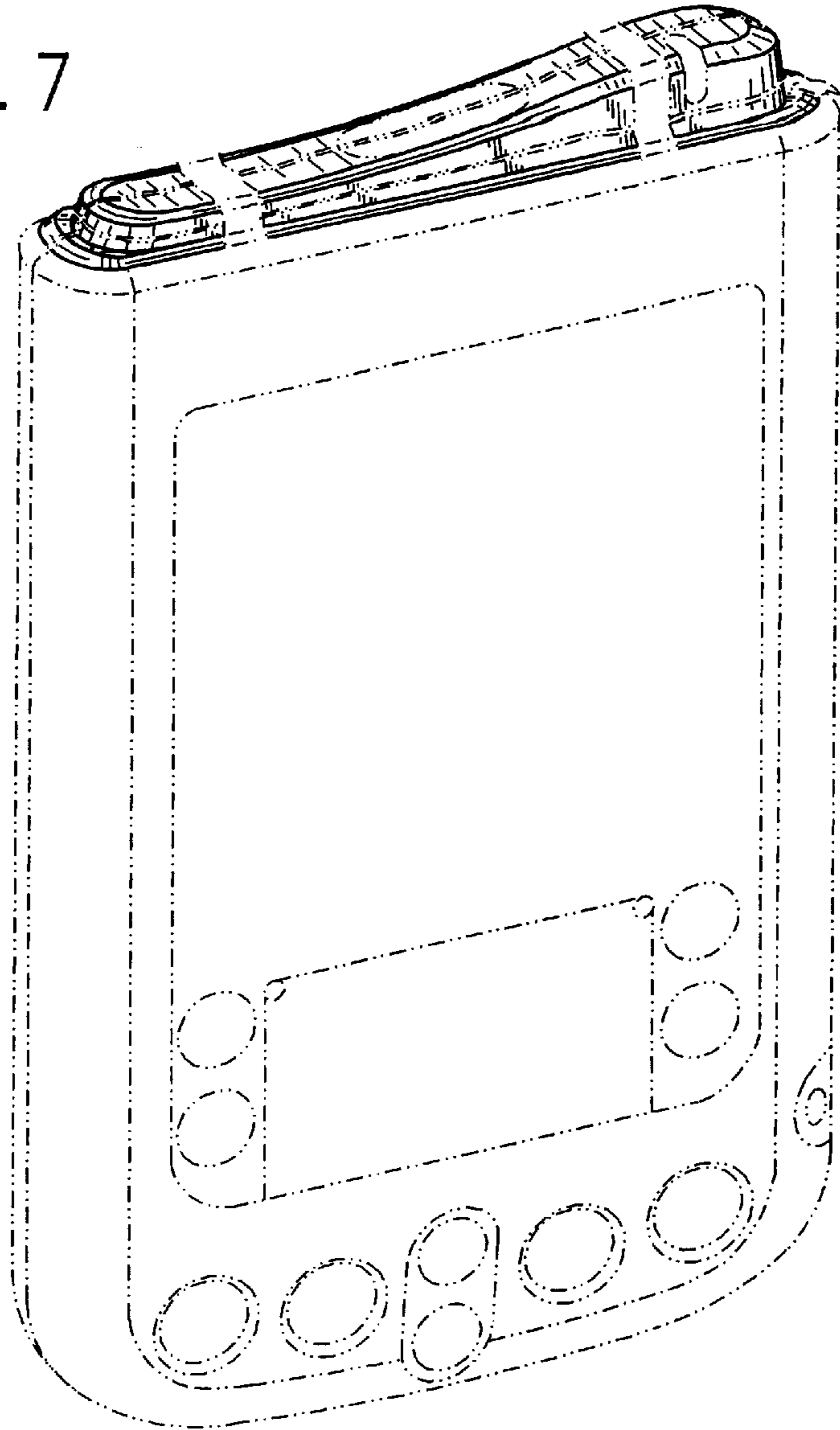

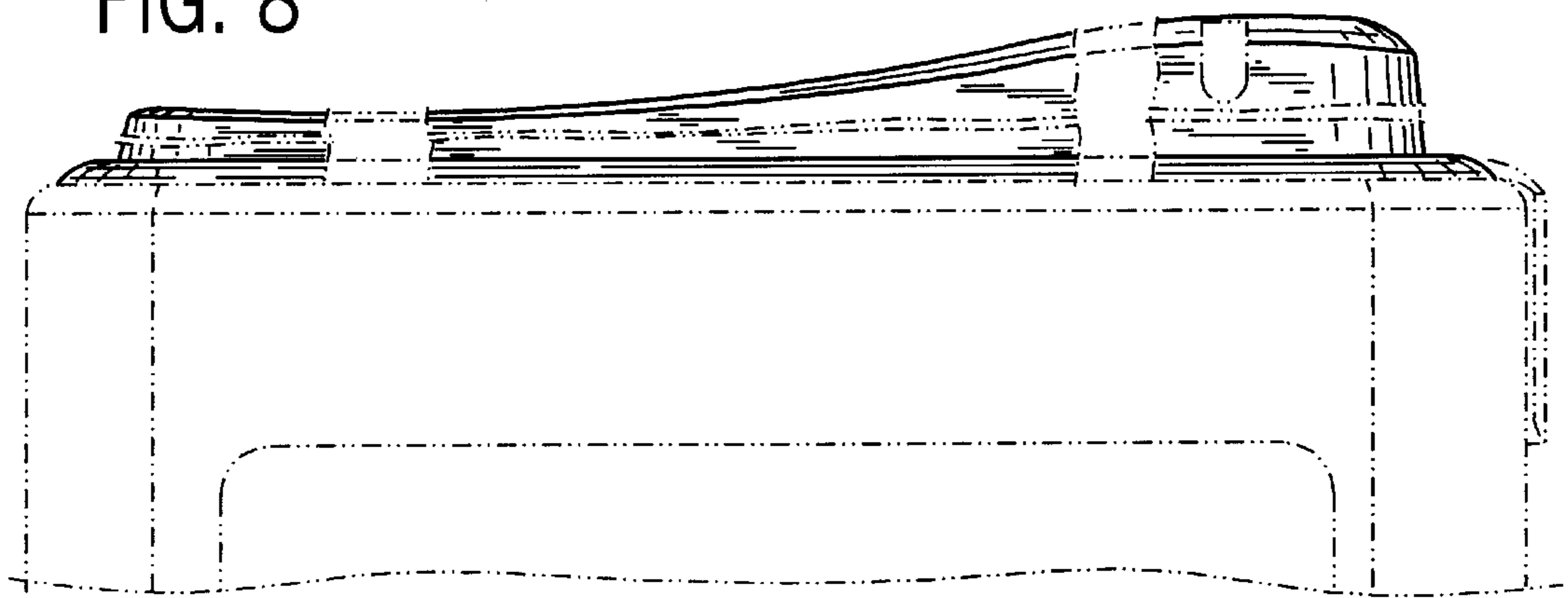

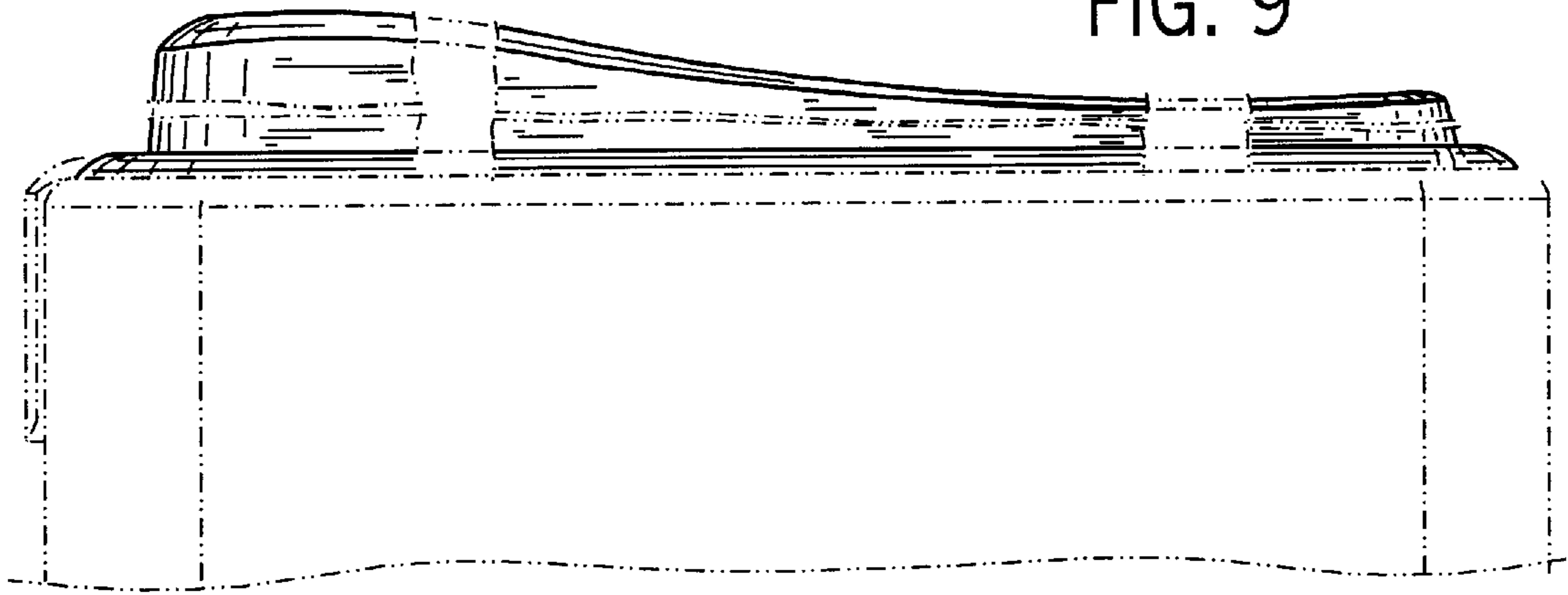

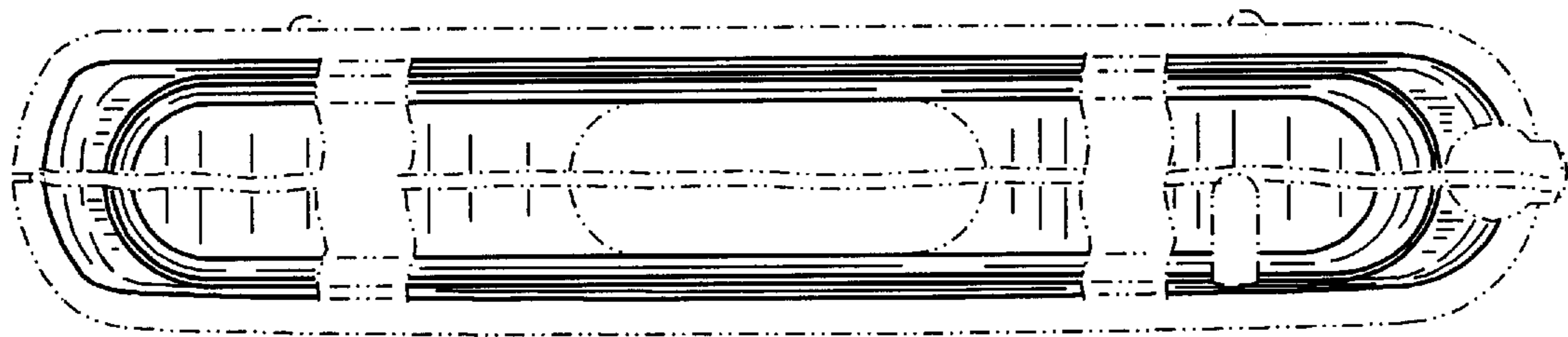

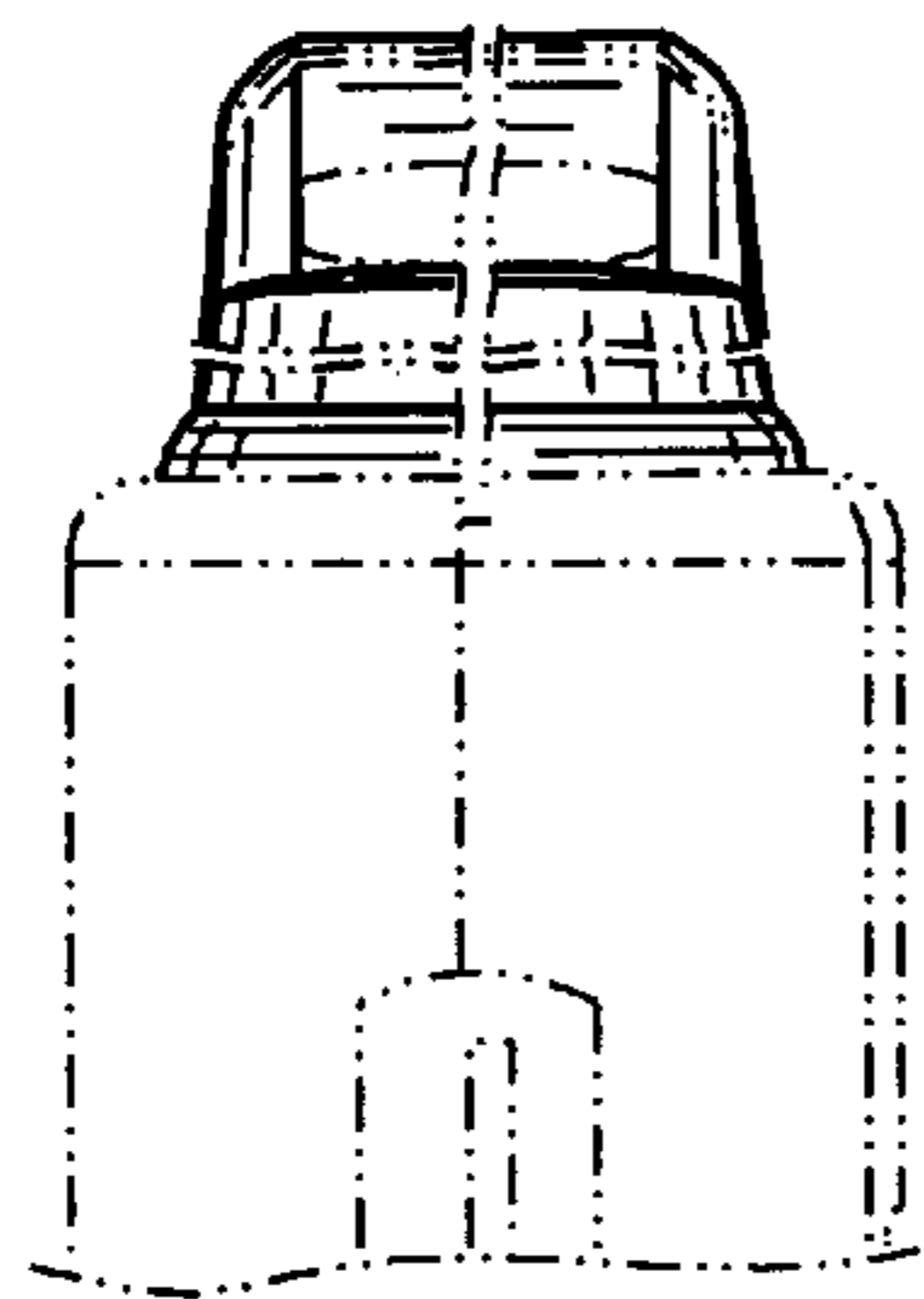

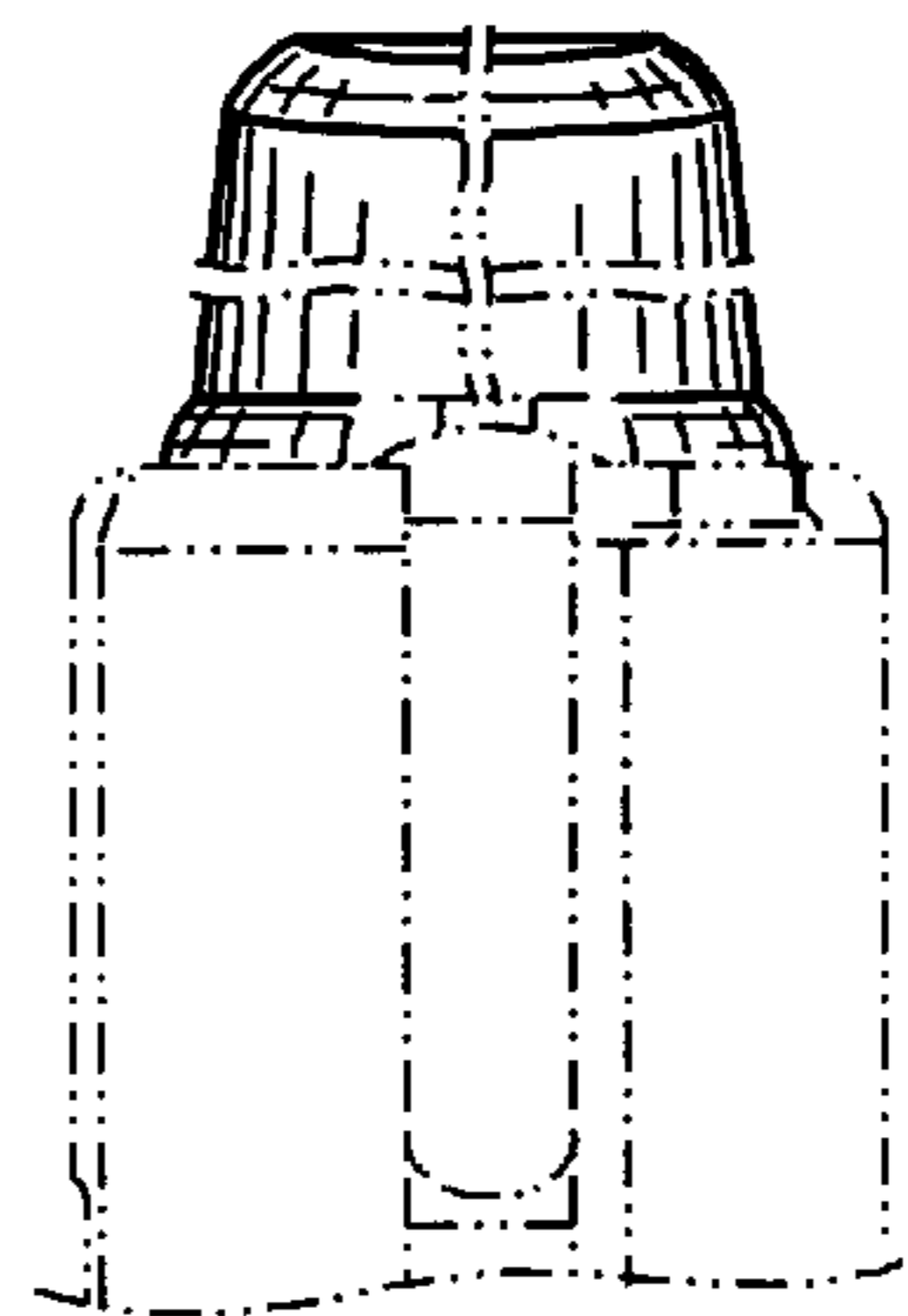

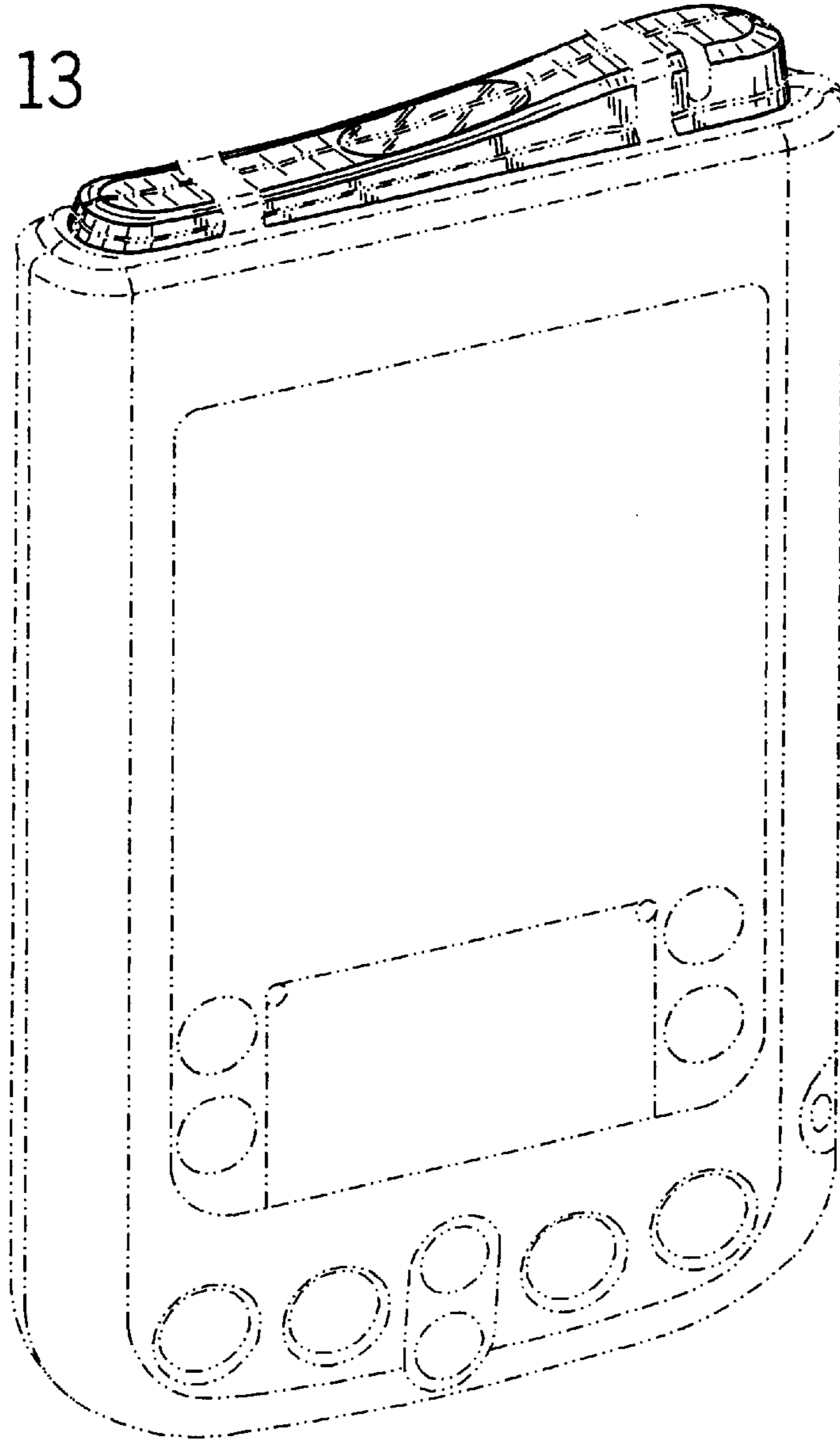

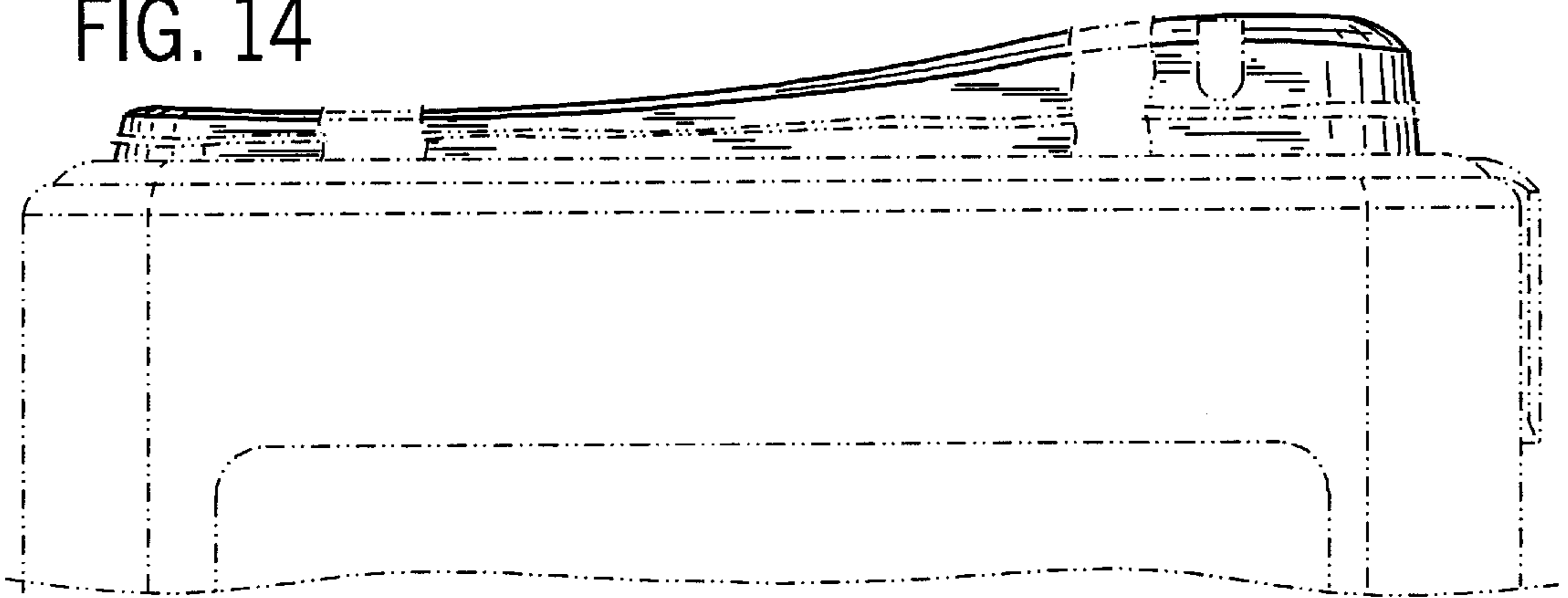

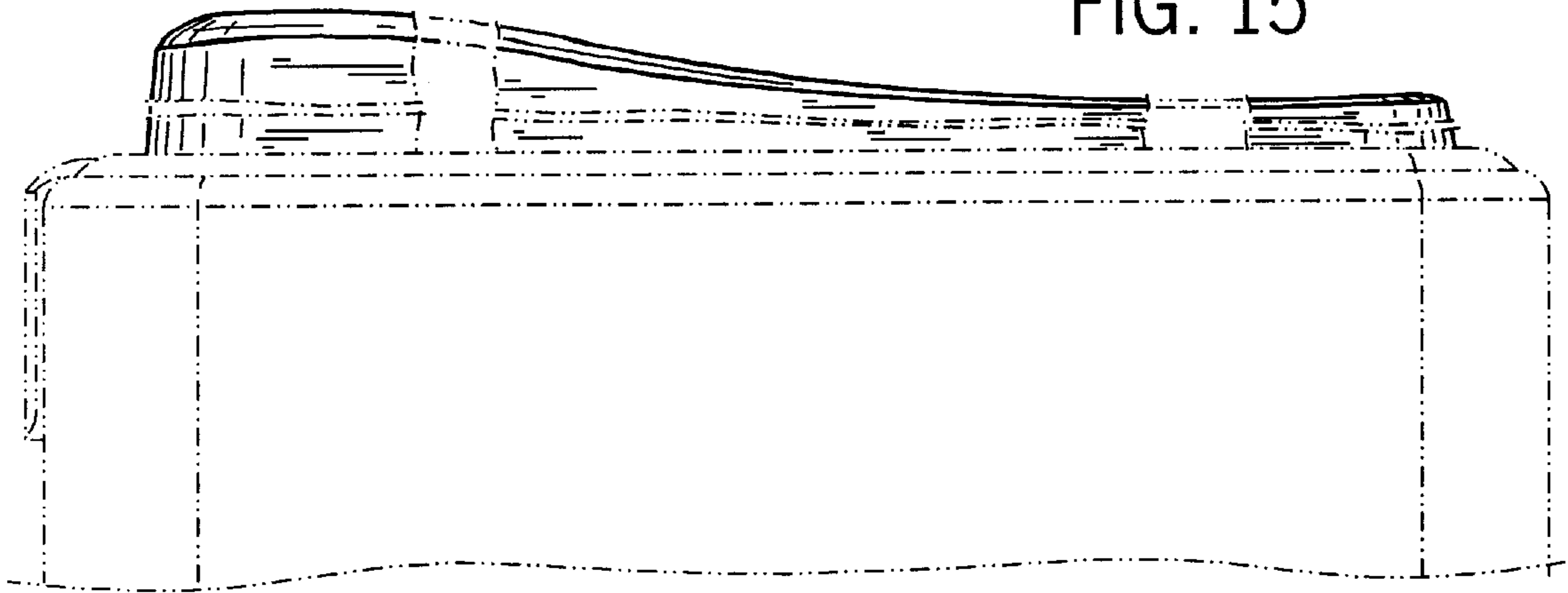

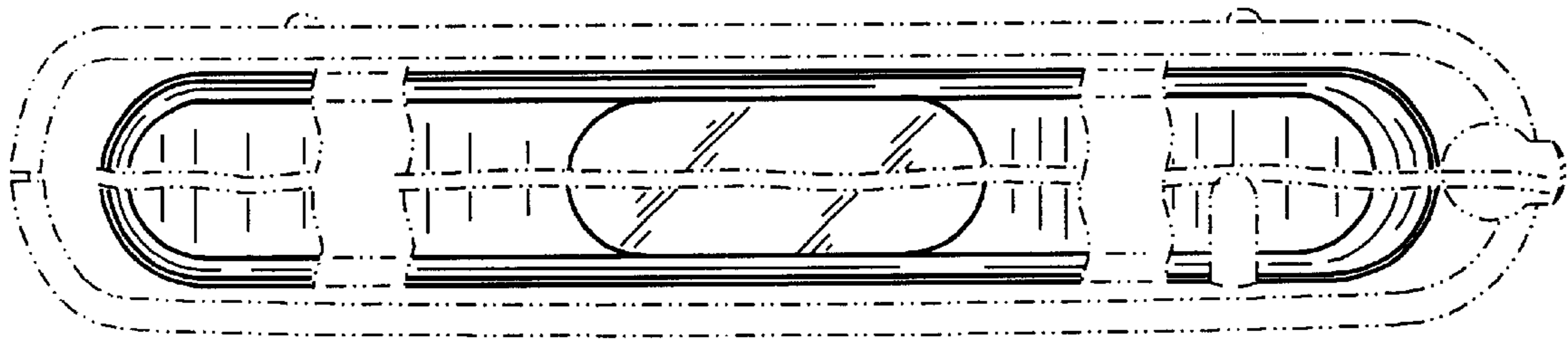

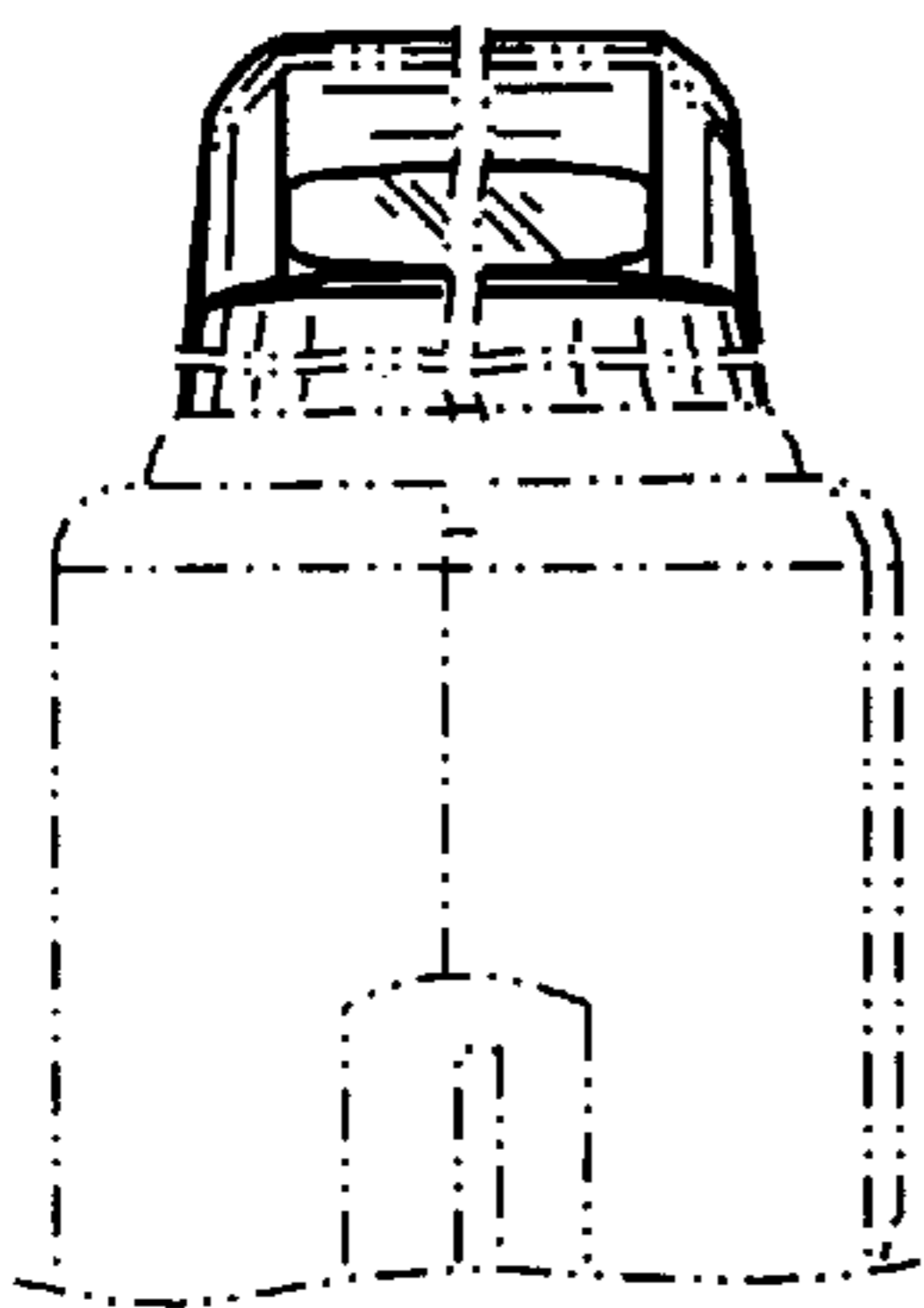

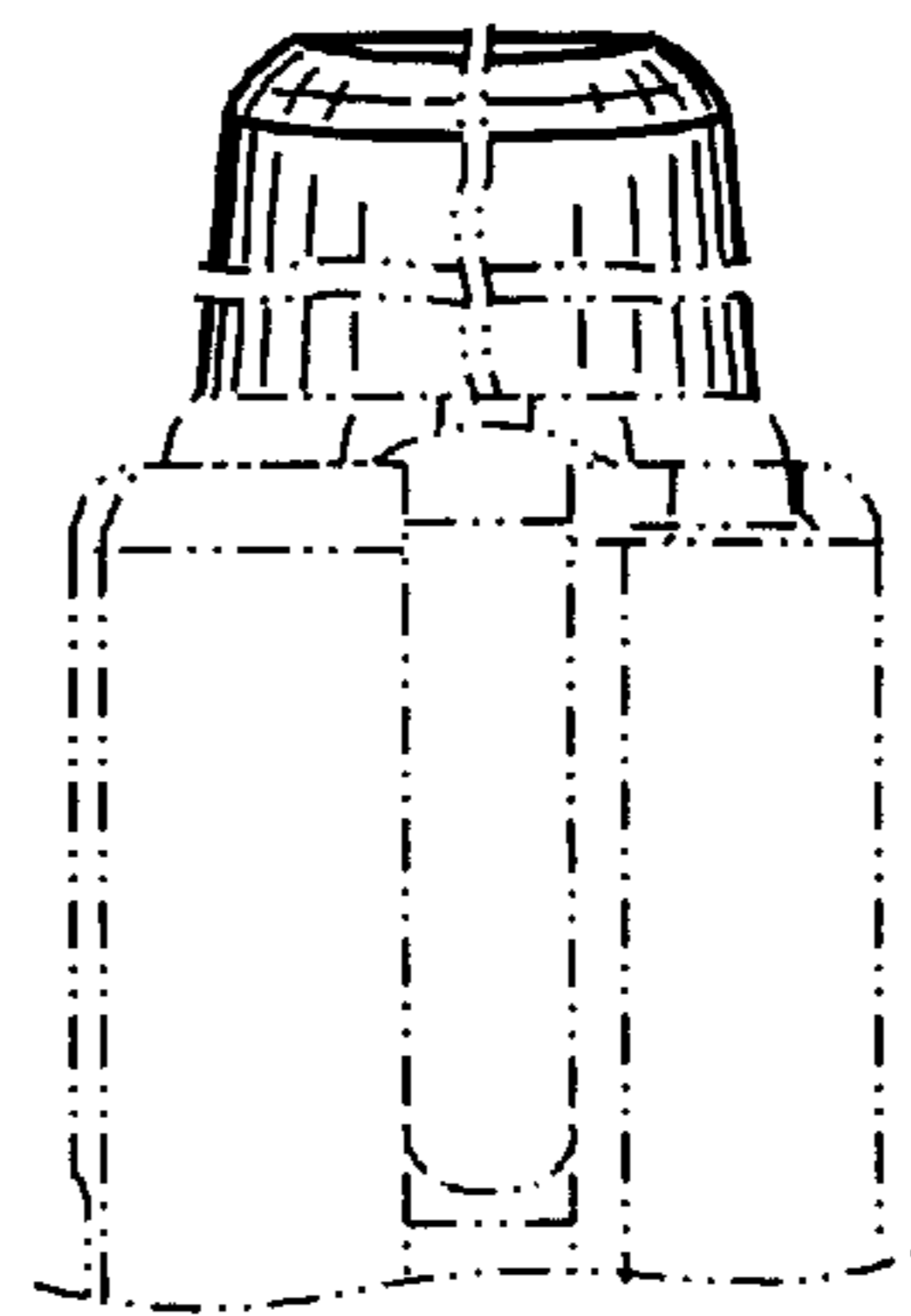

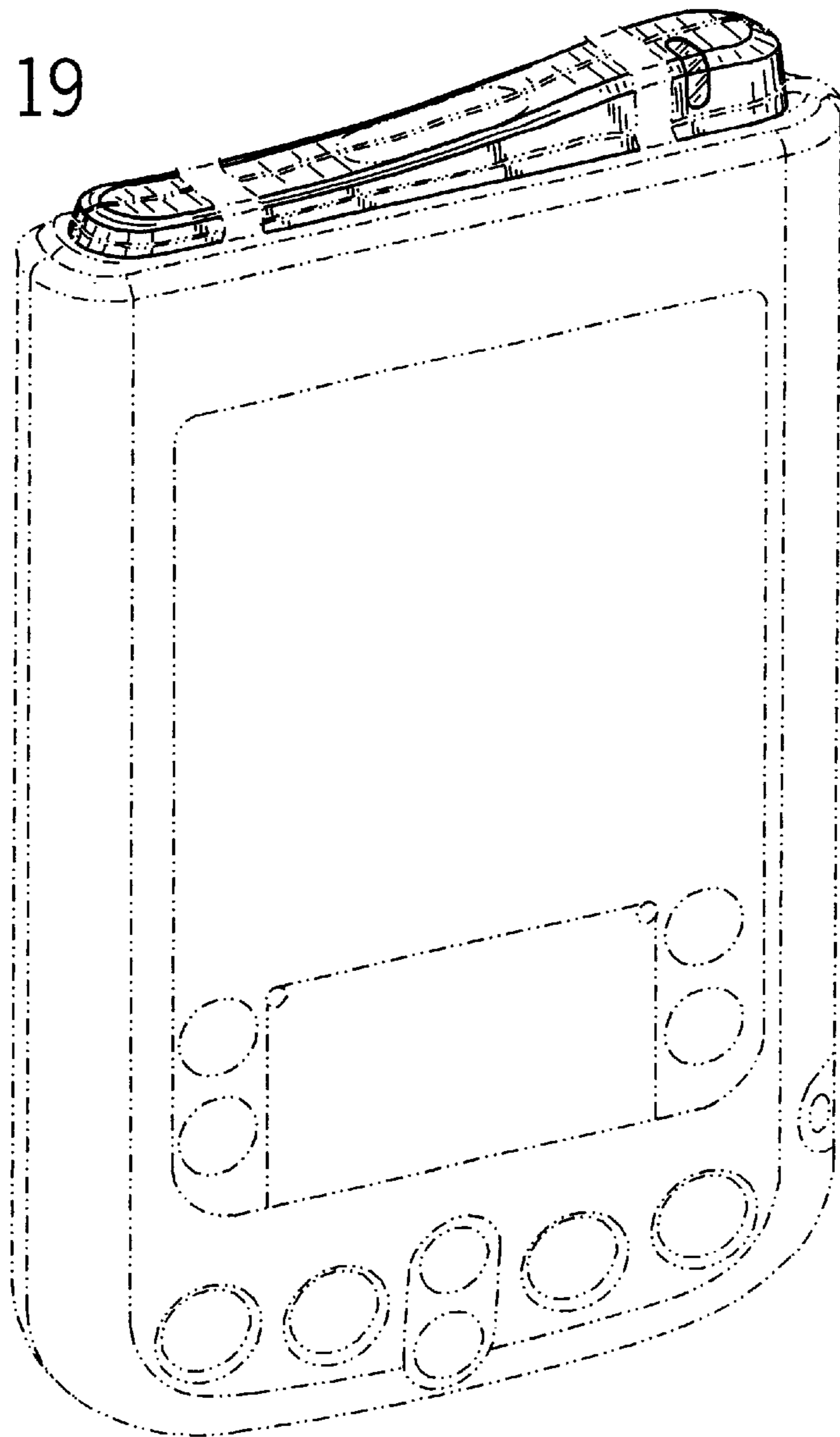

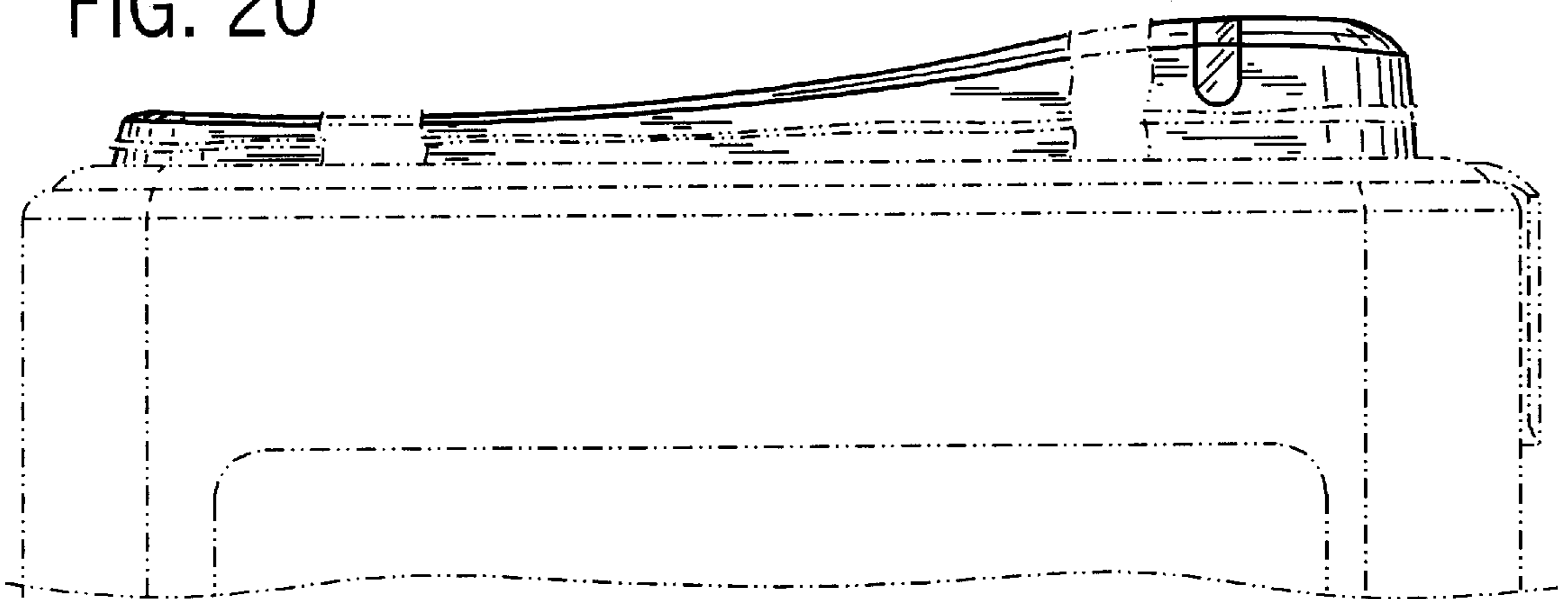

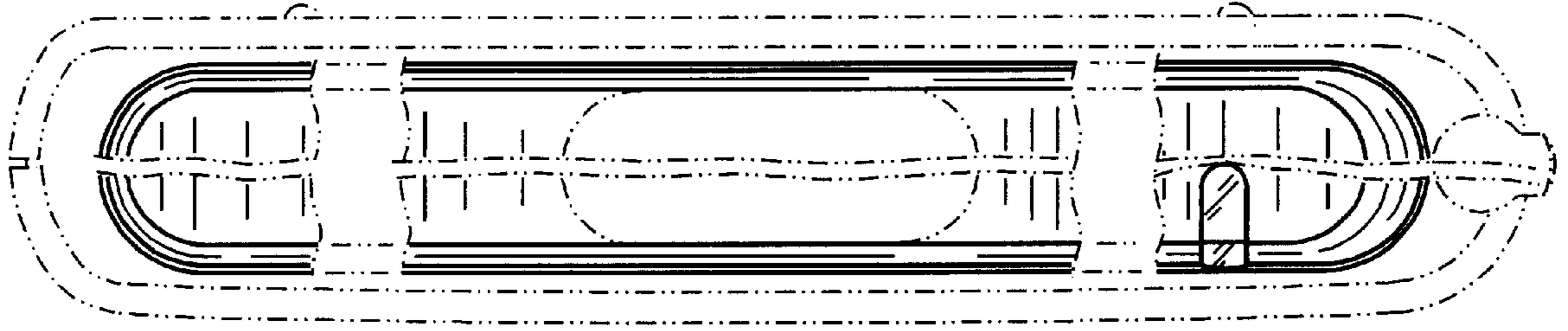
