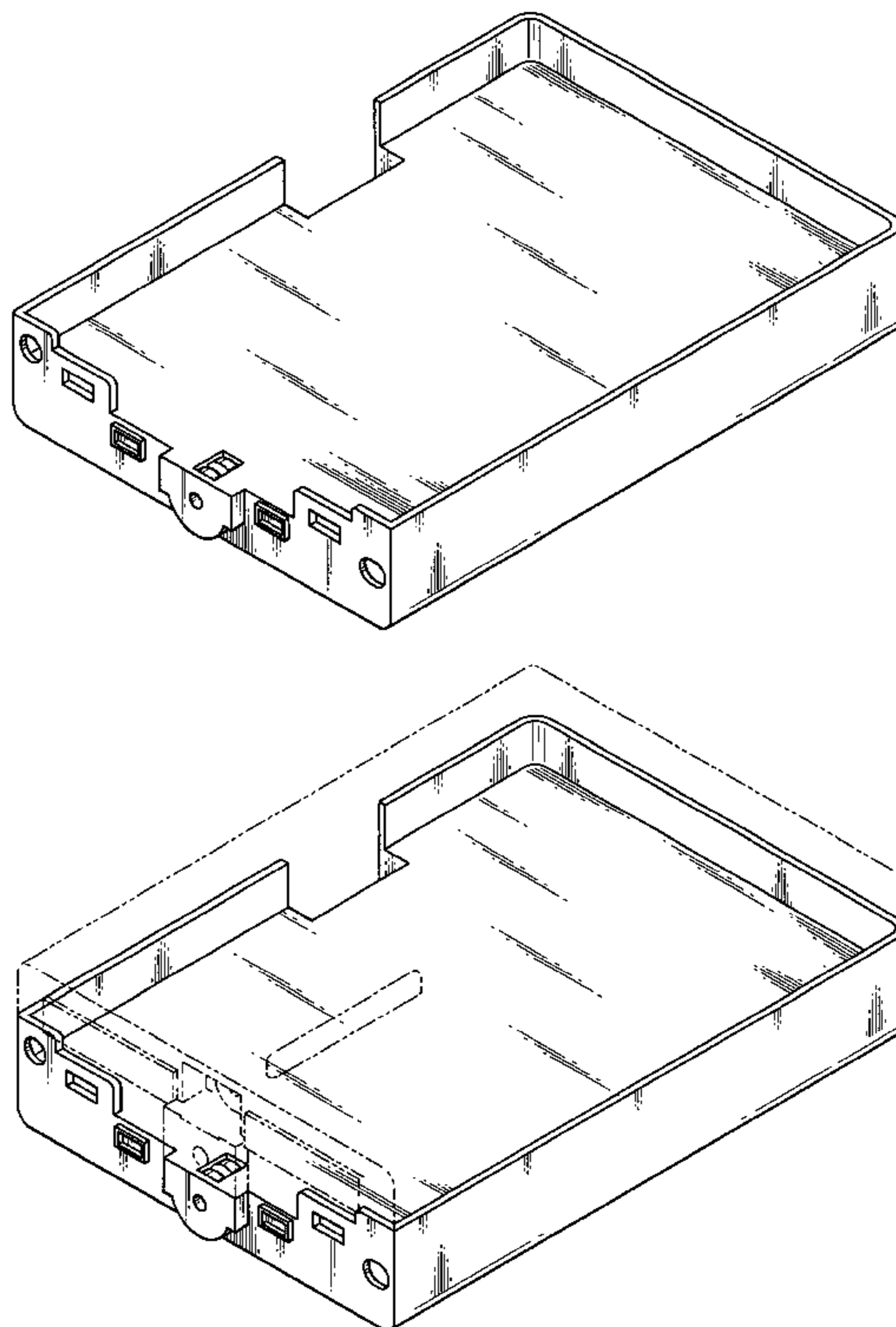

FIG. 1 is a top view of an ink cartridge;

FIG. 9 is a cross-sectional view thereof, taken along the lines 9—9 of FIG. 4;

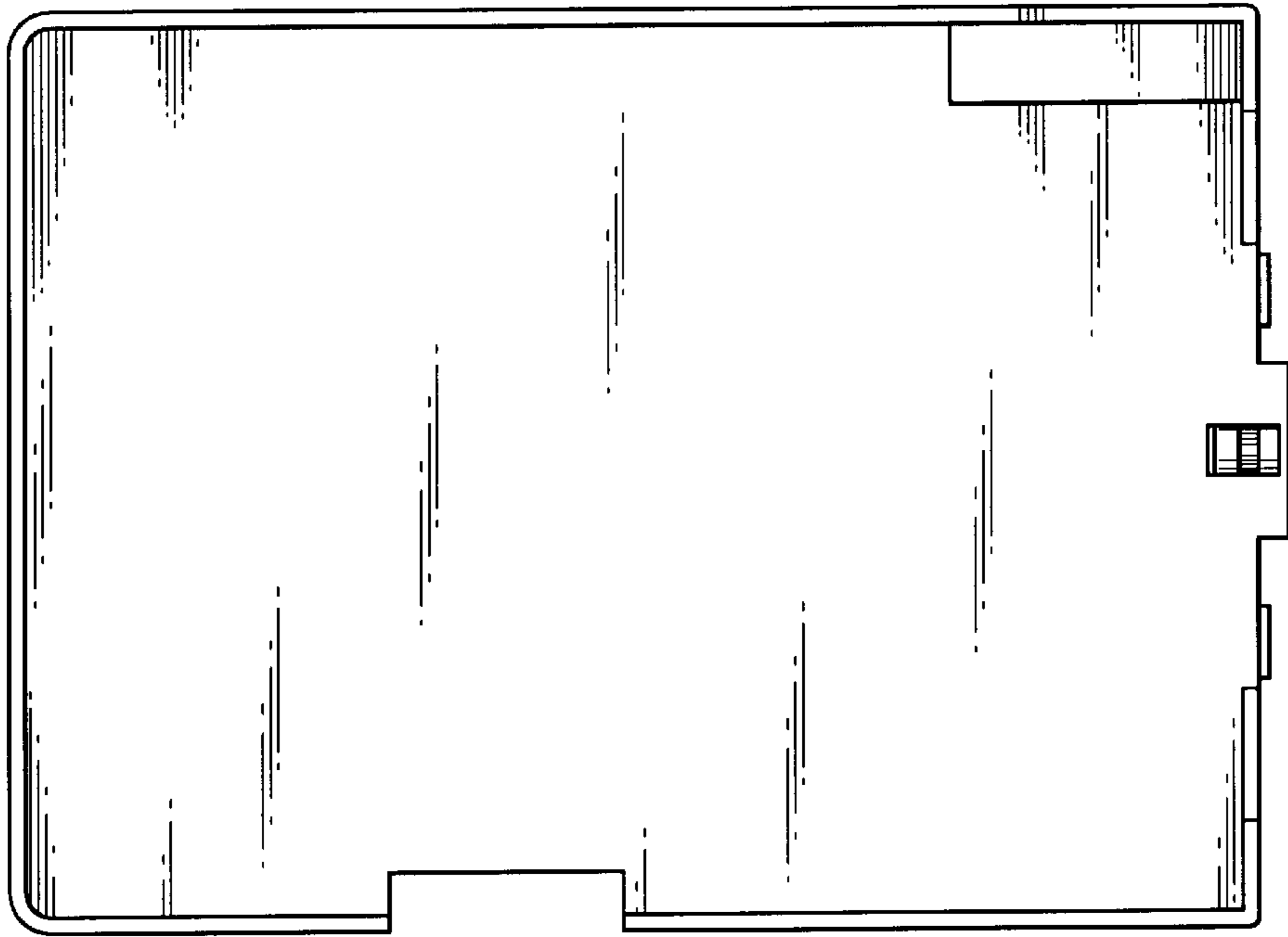

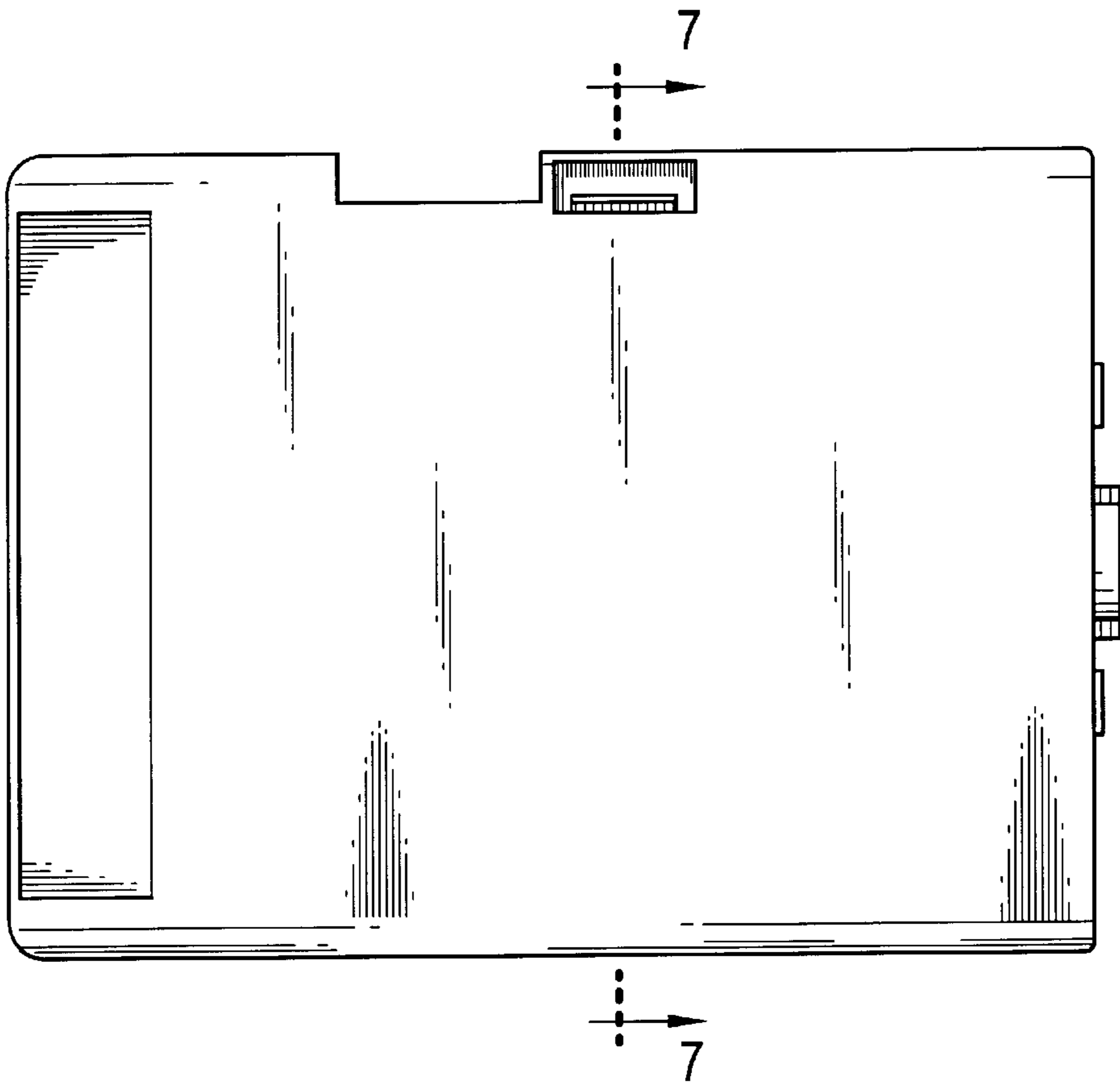

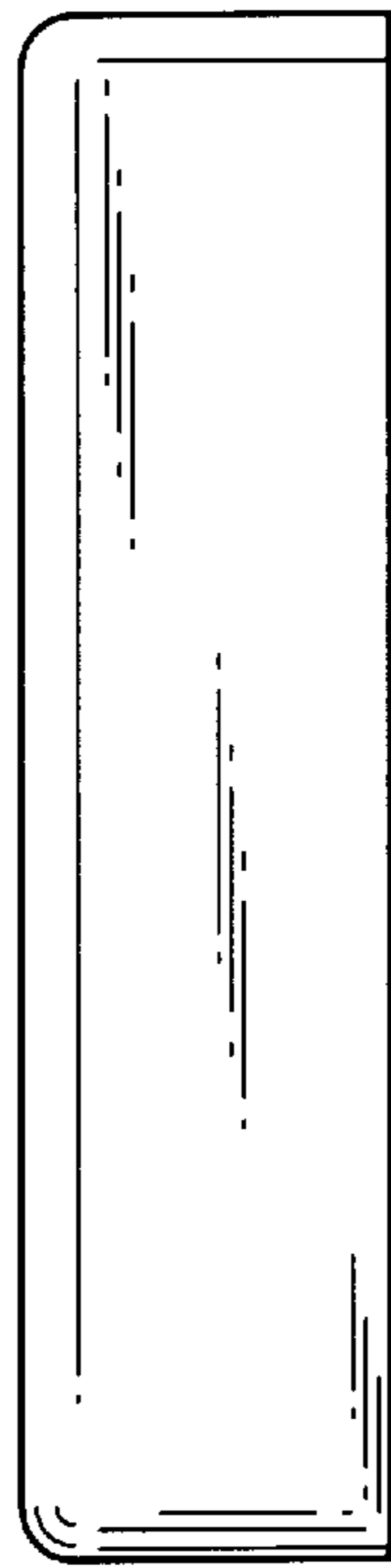

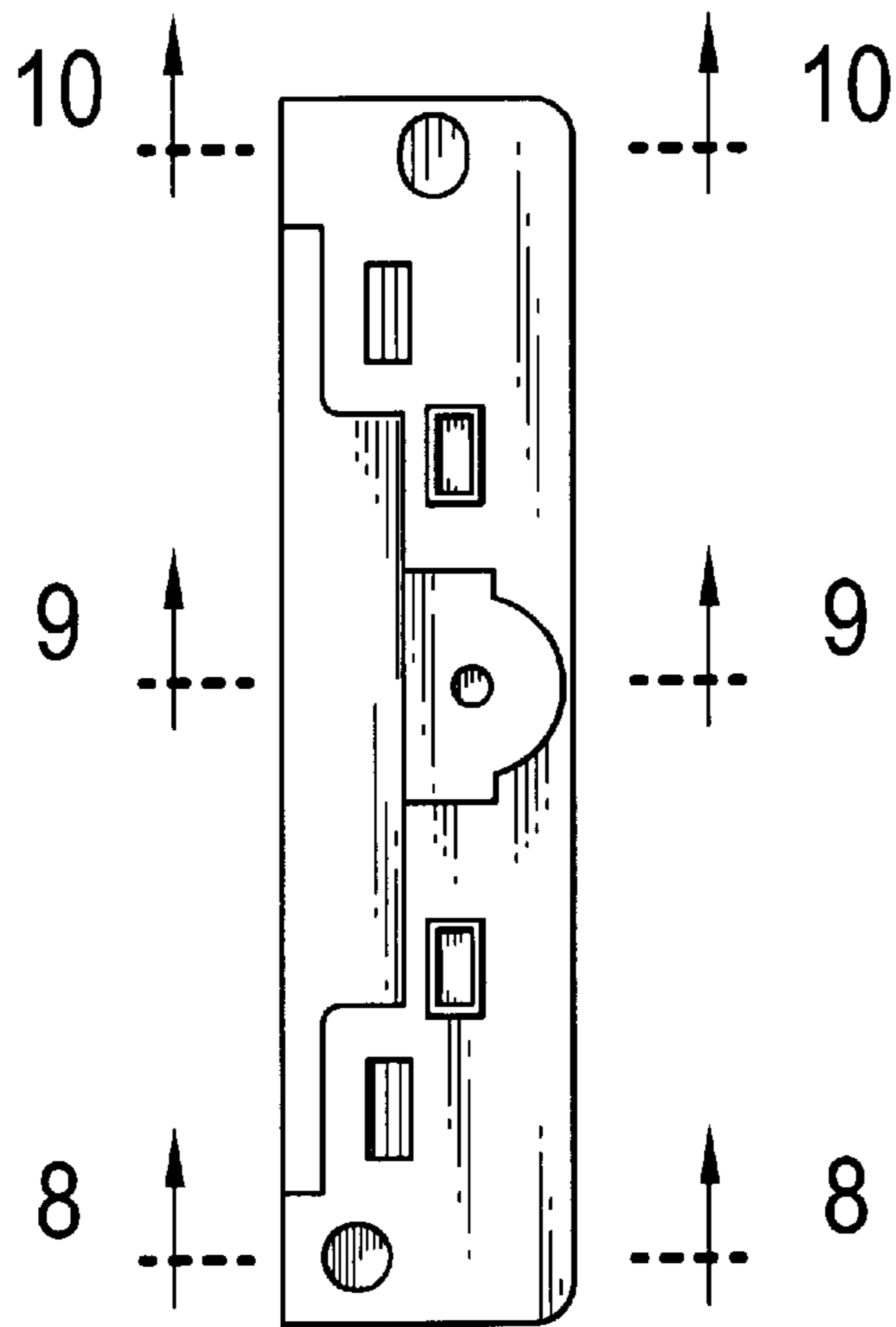

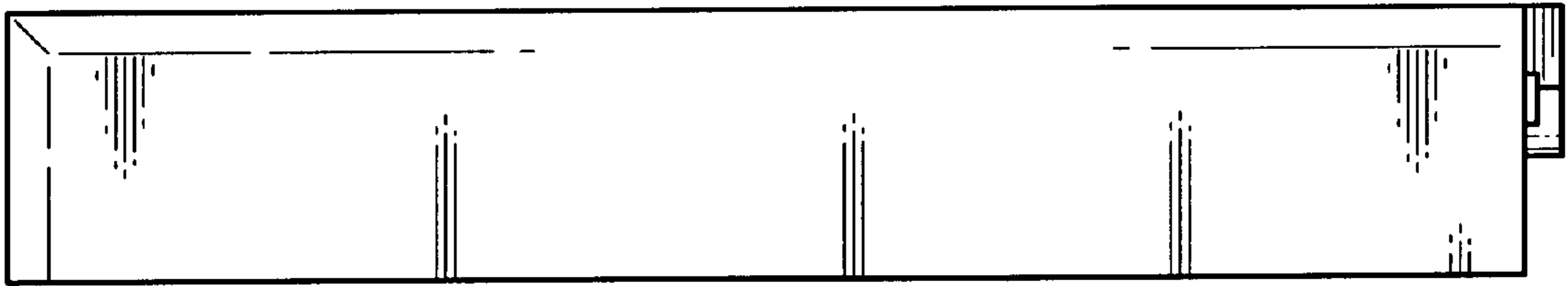

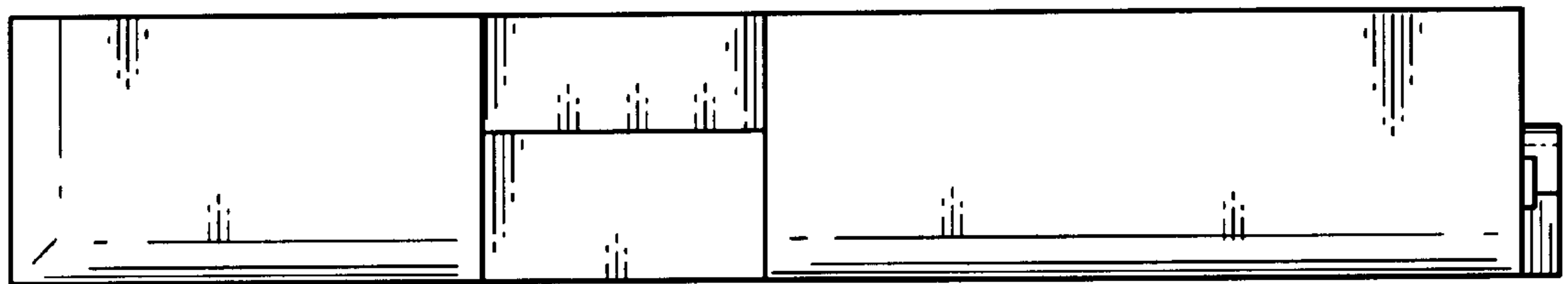

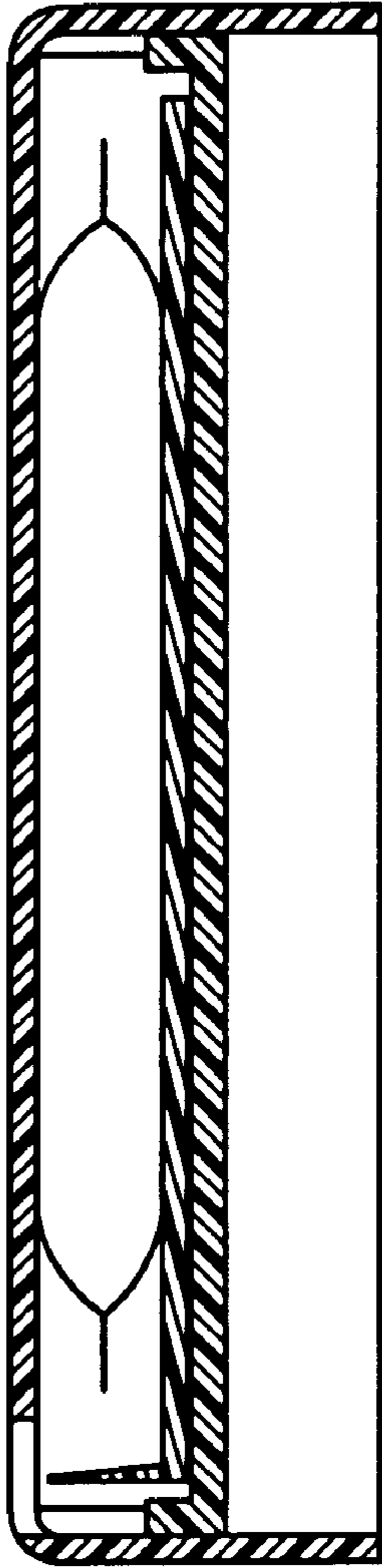

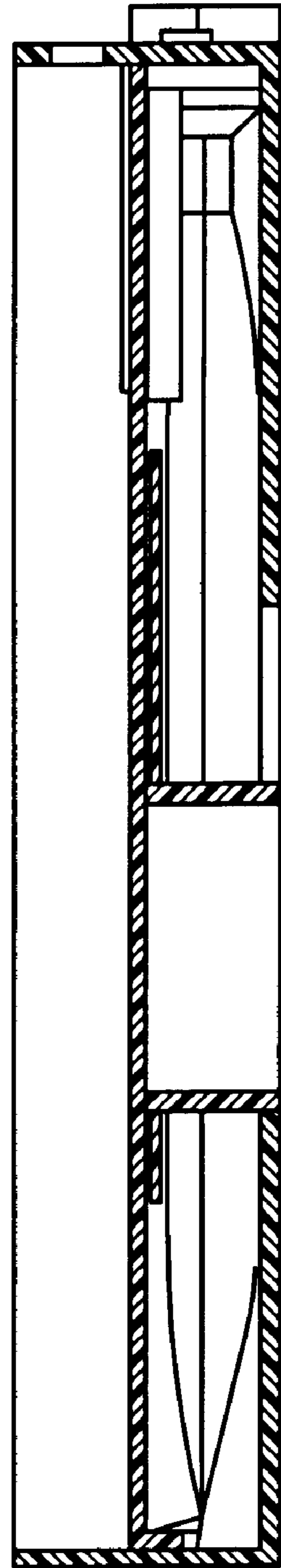

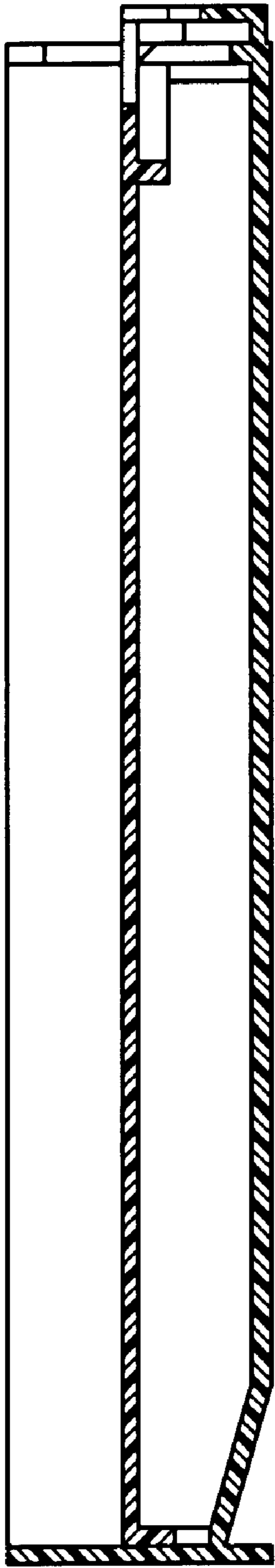

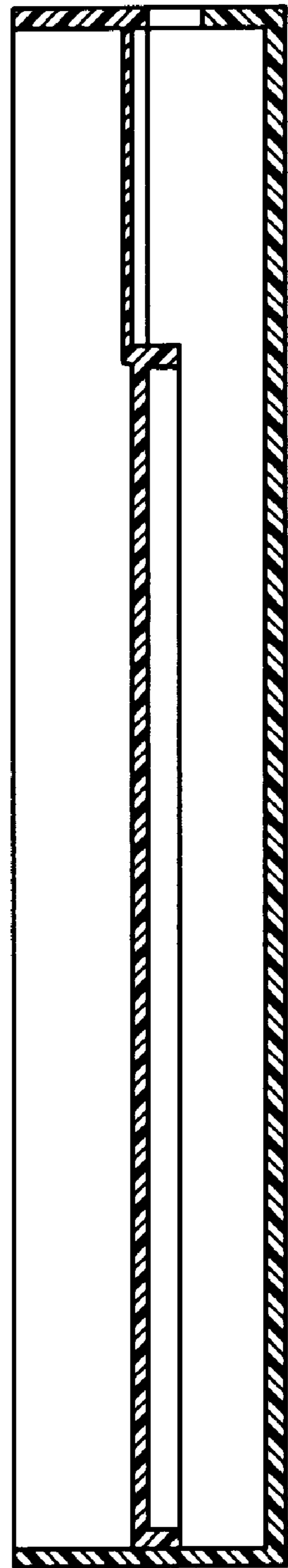

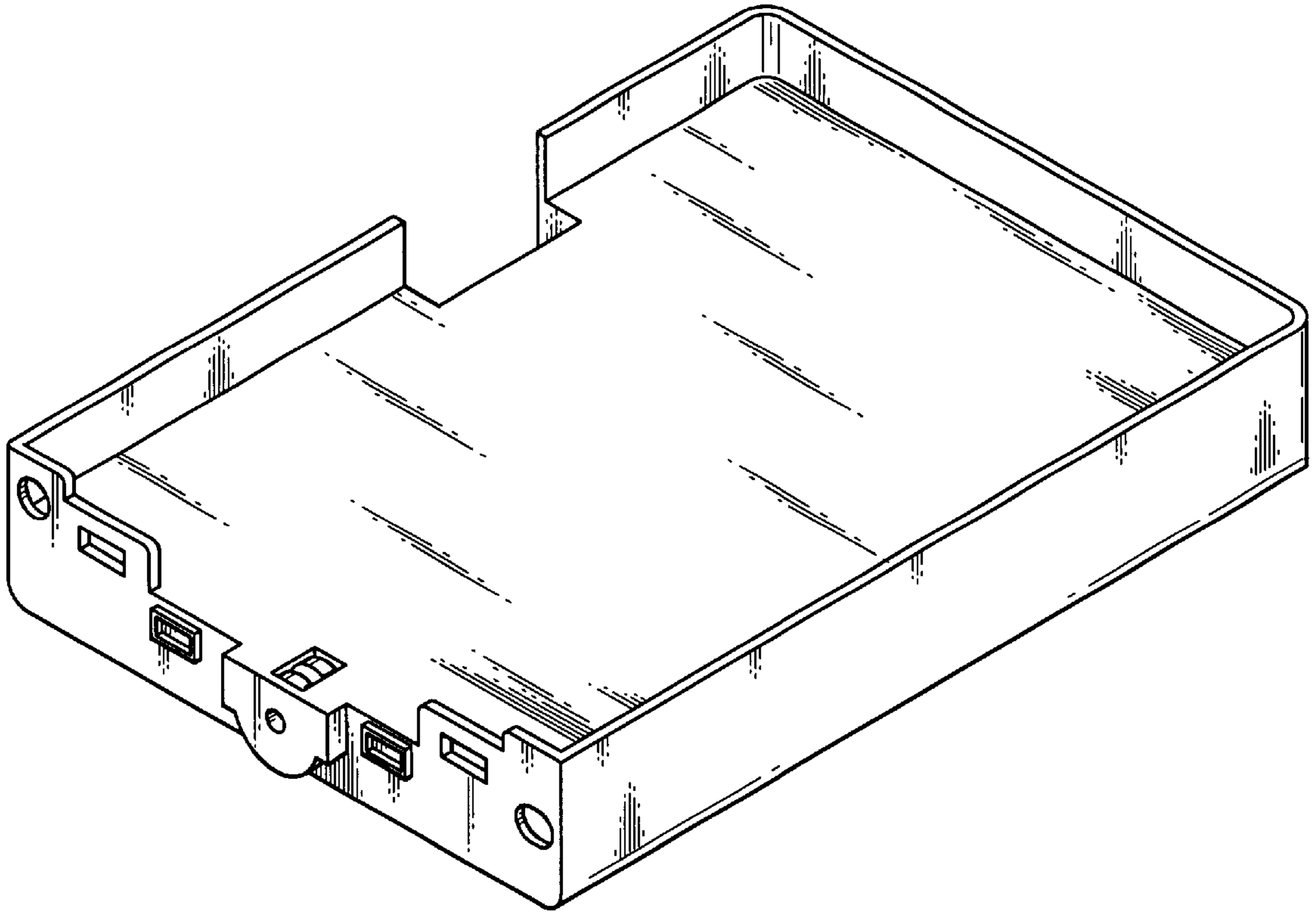

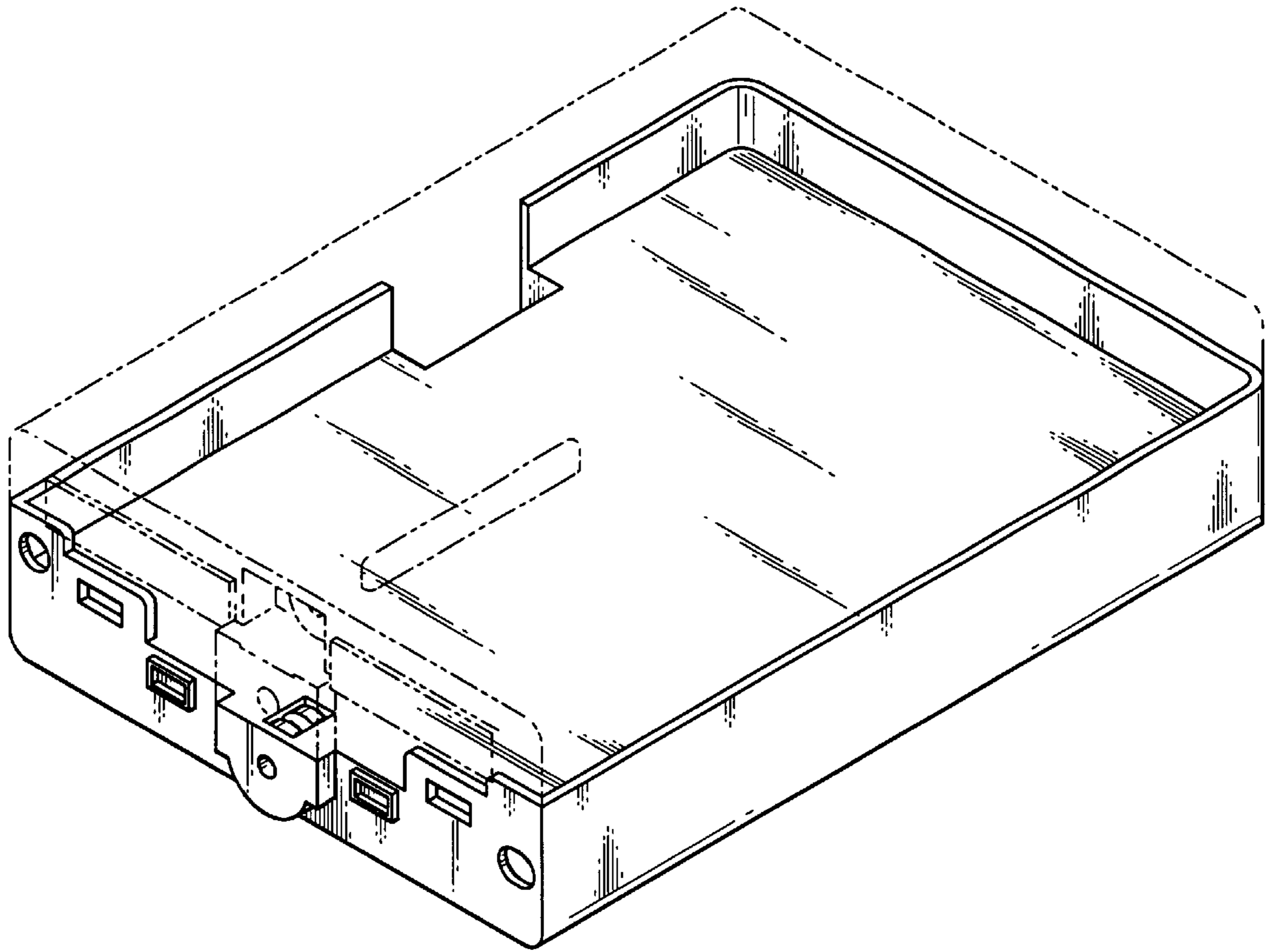
