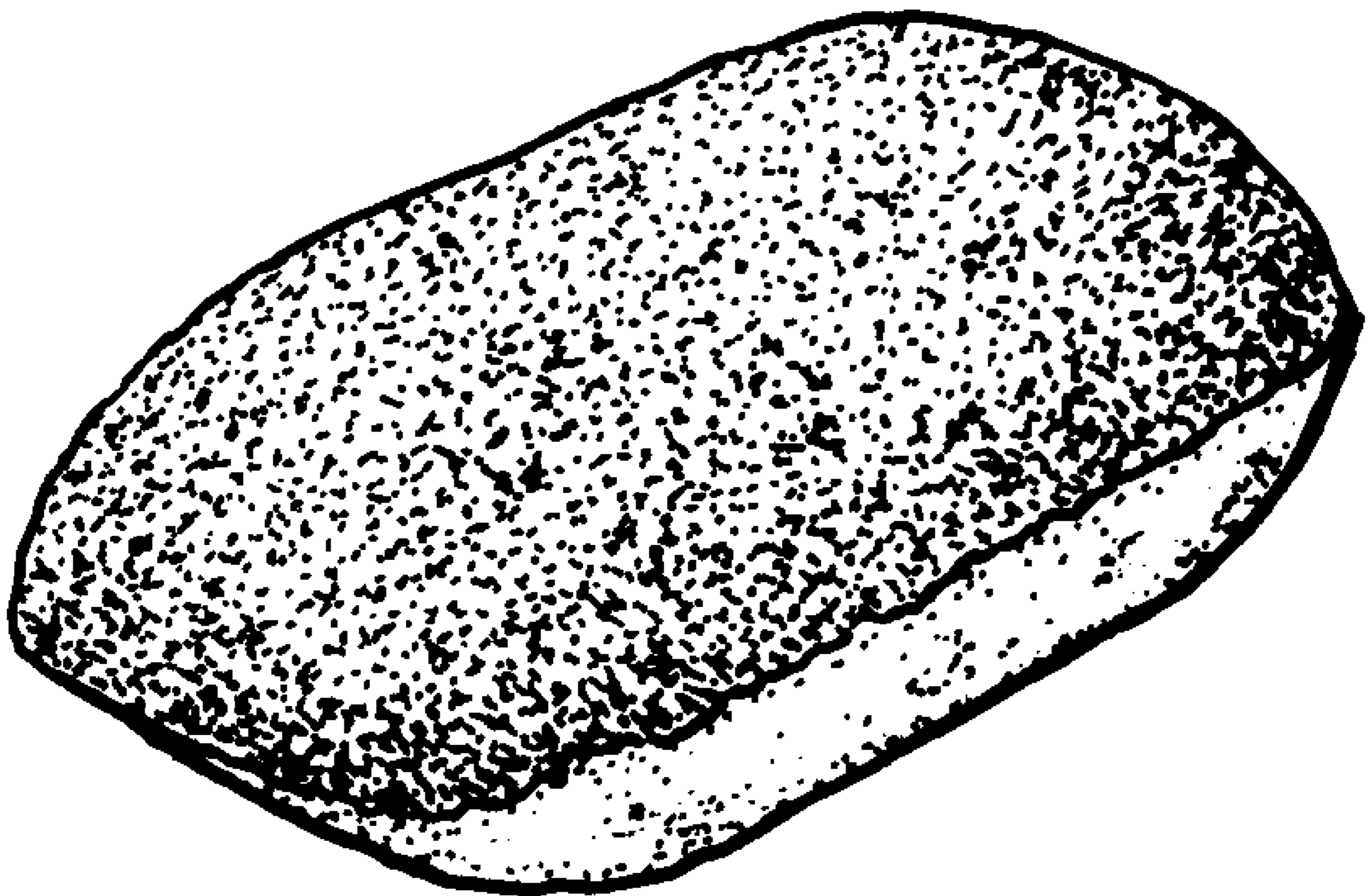
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a top perspective view in accordance with my new design;  
FIG. 2 is a right side elevational view thereof, a left side elevational view thereof being identical;

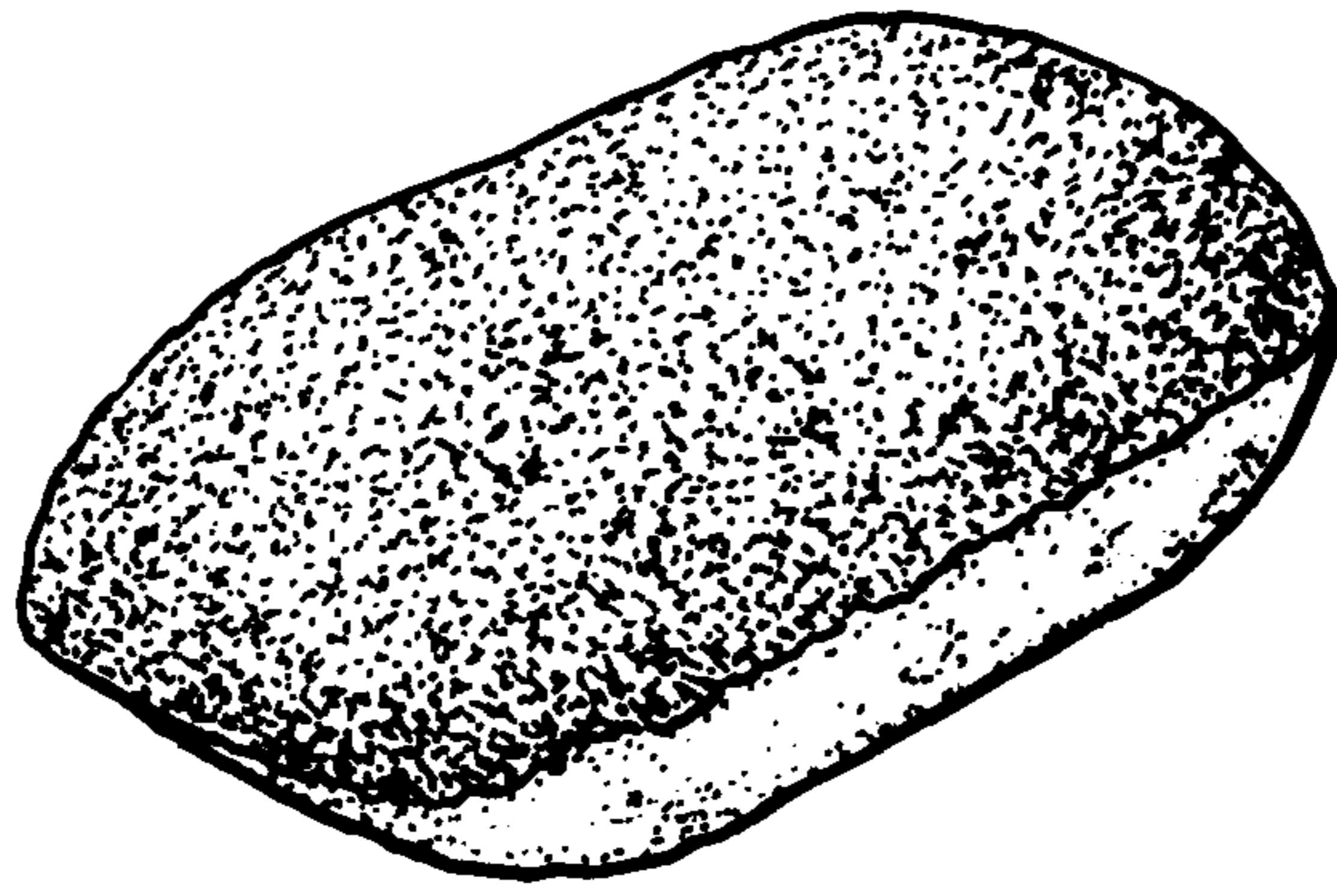

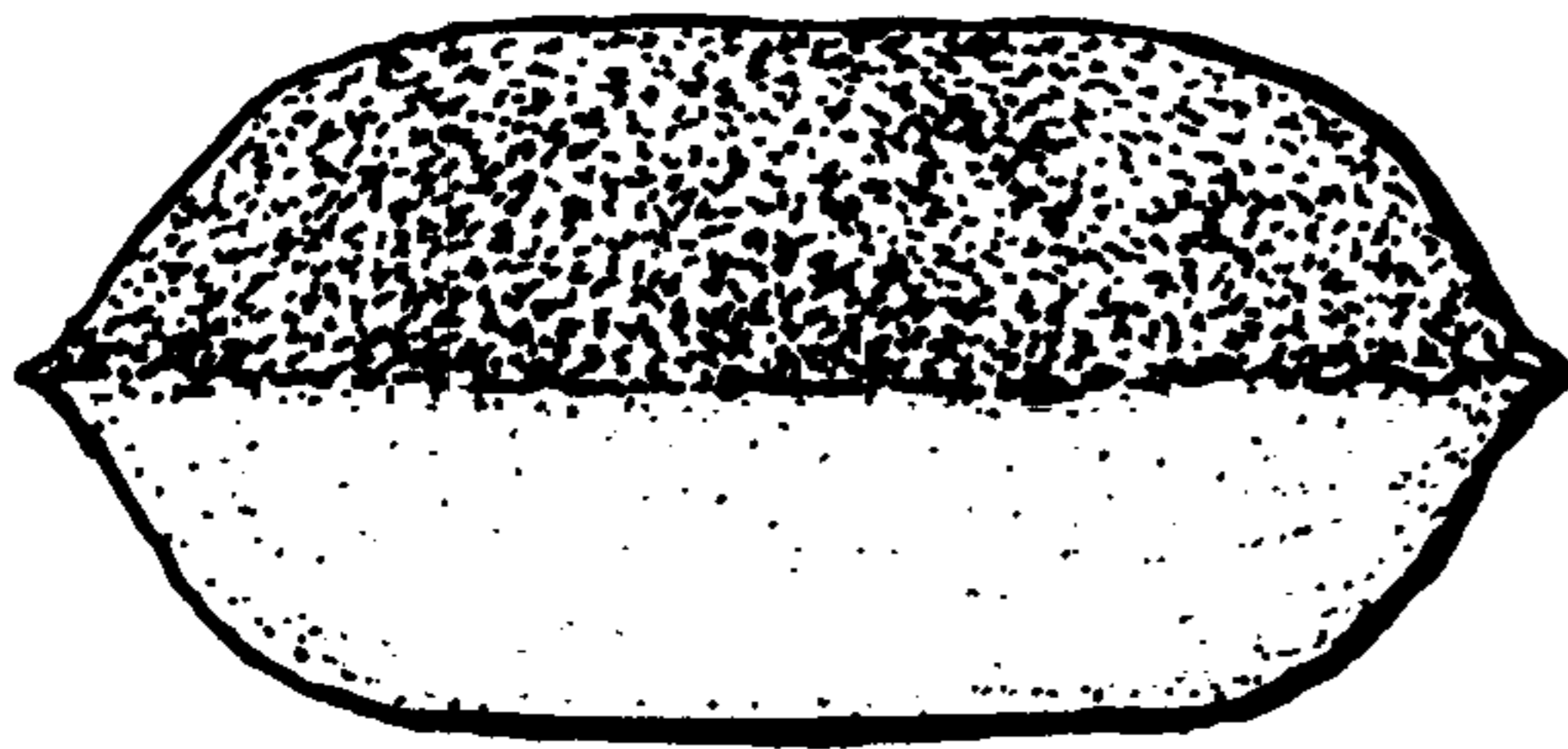

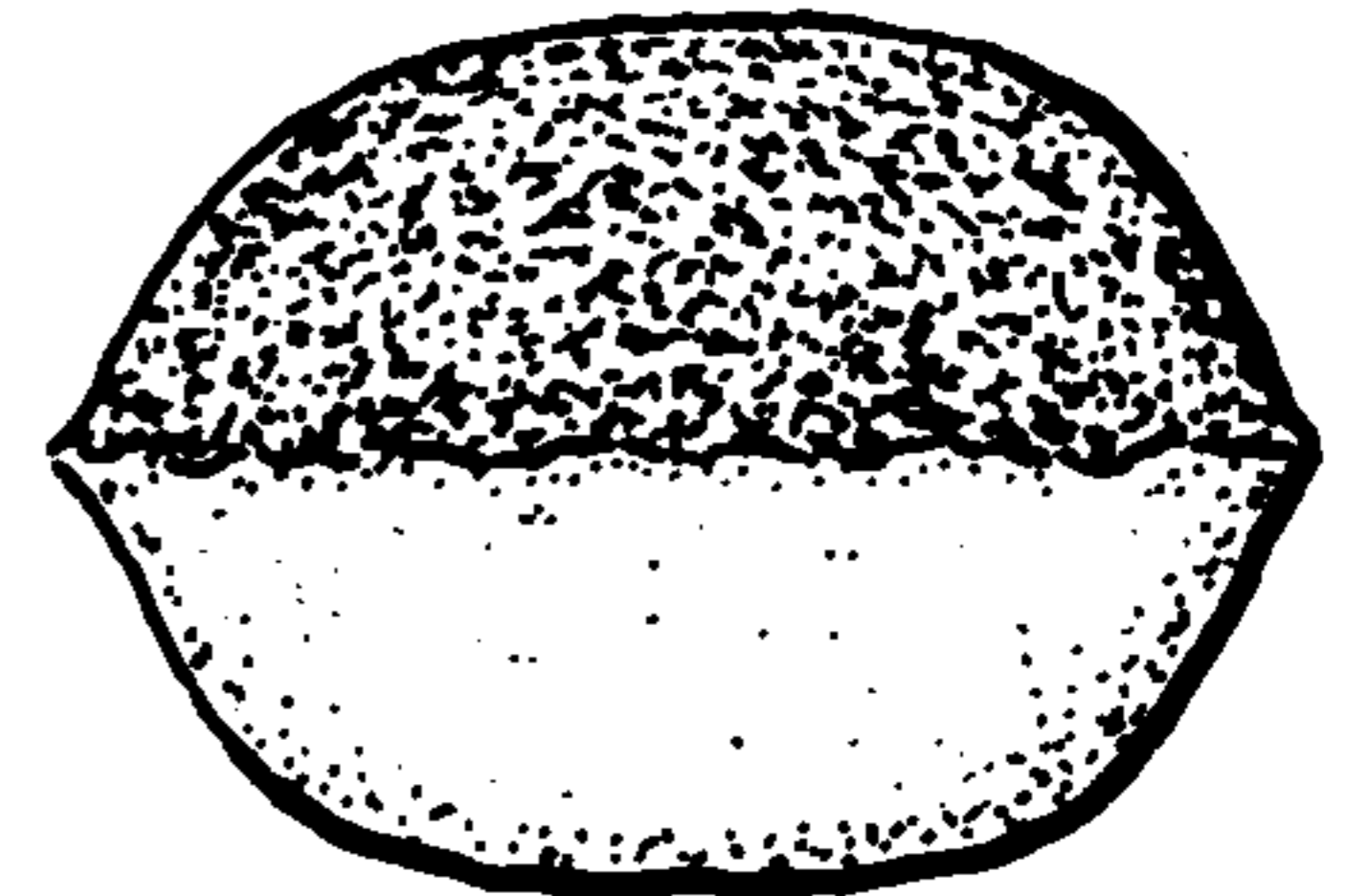

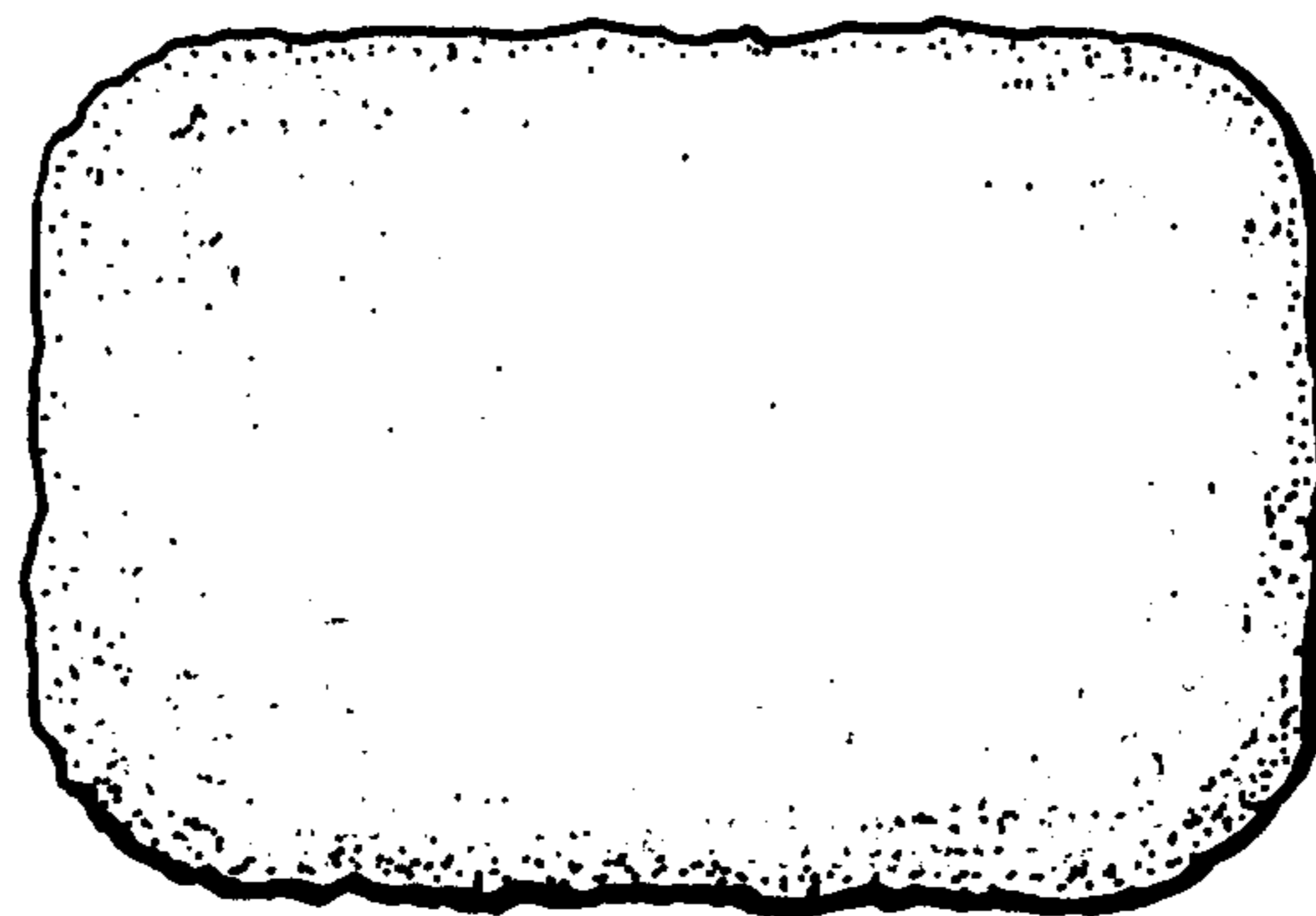
