(57) **CLAIM**

The ornamental design for a nail file, as shown and described.

**DESCRIPTION**

FIG. 1 is a side view of a nail file according to my design, showing one side thereof.

FIG. 2 is an end view of the nail file of FIG. 1, showing one end thereof.

FIG. 3 is an end view of the nail file of FIG. 1, showing the opposite end to that shown in FIG. 2.

FIG. 4 is a side view of the nail file of the FIG. 1, showing the opposite side thereof.

FIG. 5 is a bottom view of the nail file of FIG. 1.

FIG. 6 is a top view of the nail file of FIG. 1; and,

FIG. 7 is a perspective view of the nail file of the FIG. 1 showing the rotatable nail file element in an intermediate position.

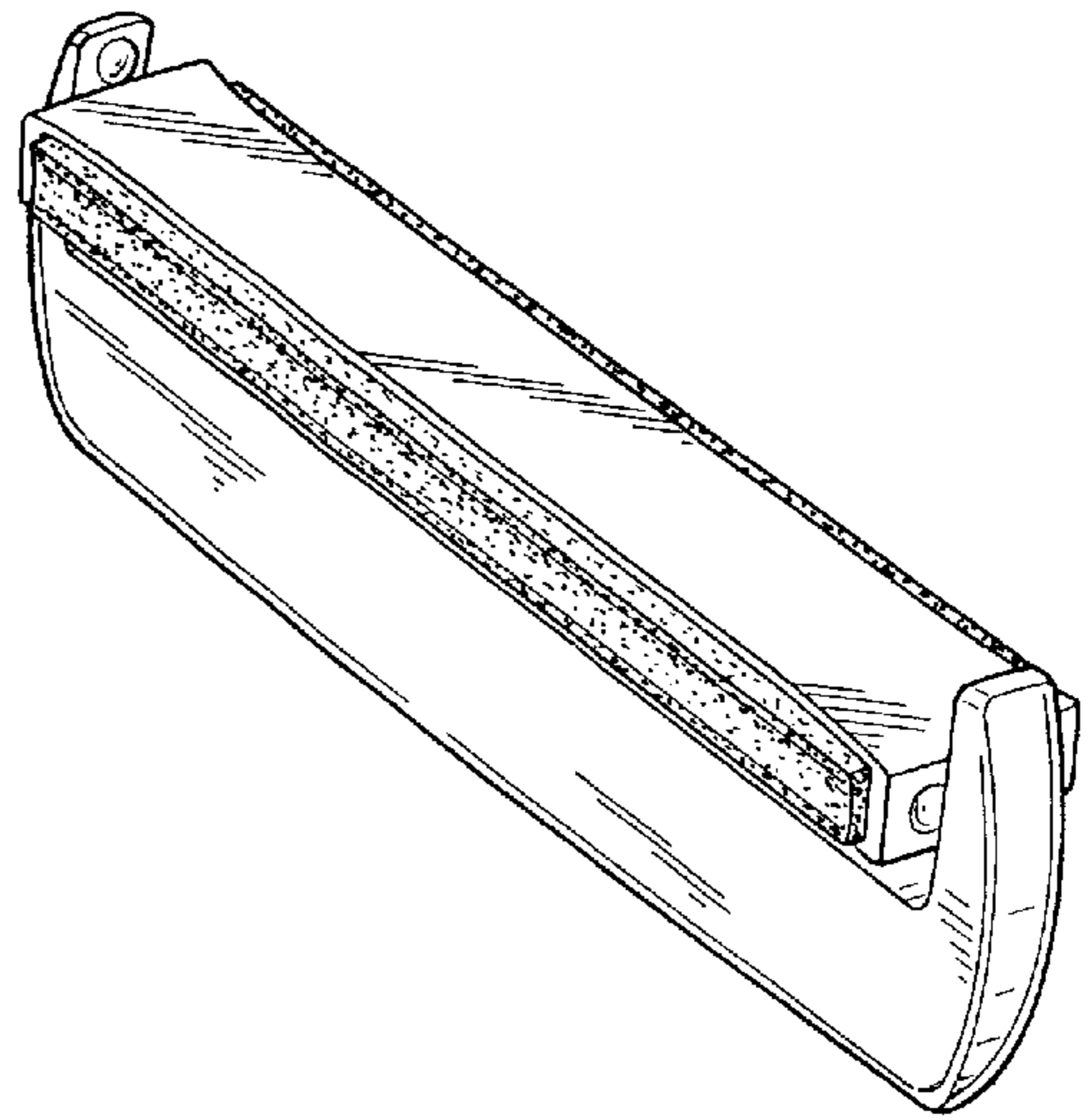
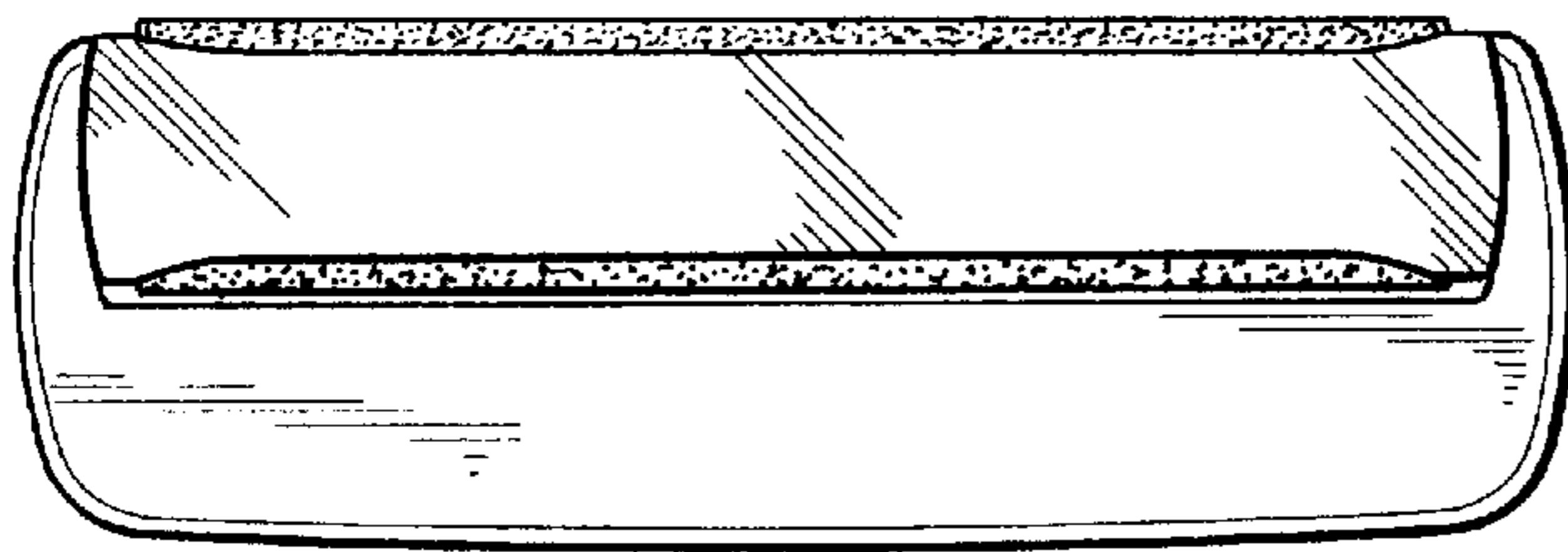

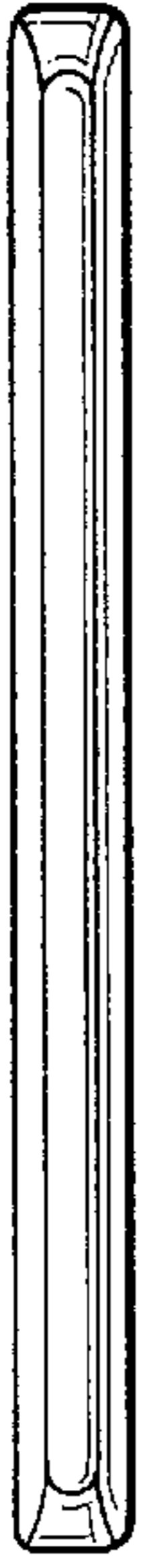

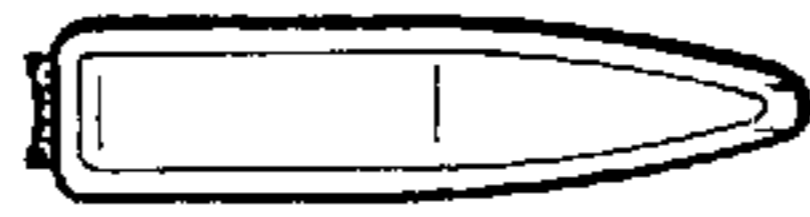

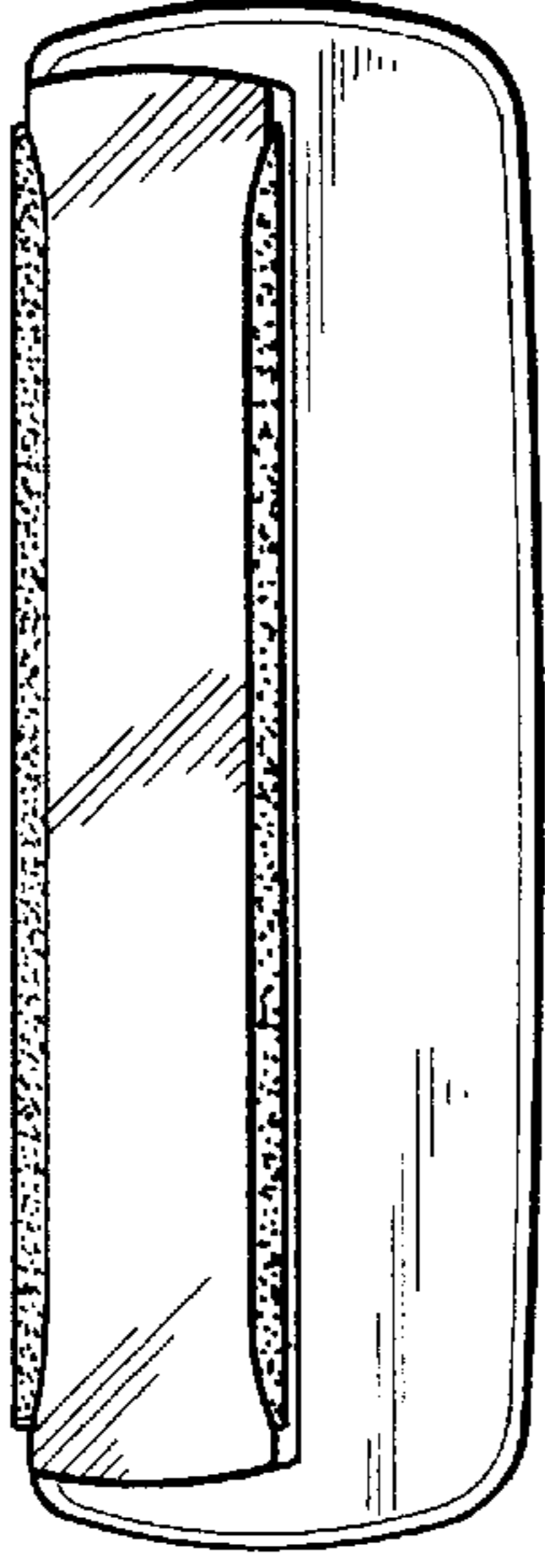

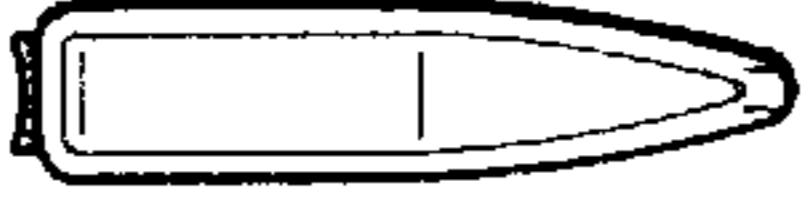

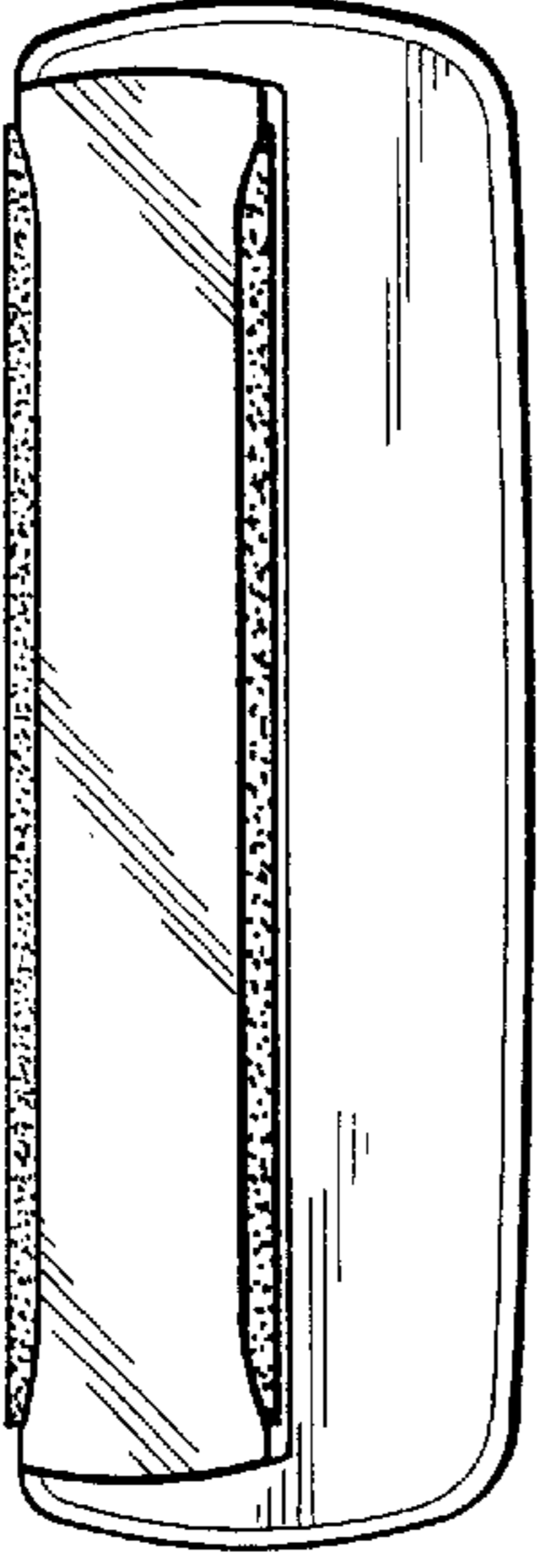
