(57) **CLAIM**

The ornamental design for a ladderback chair, as shown and described.

DESCRIPTION

FIG. 1 is a right front perspective view showing my new design of a ladderback chair;

FIG. 2 is a left front perspective view of a ladderback chair showing a second embodiment of my new design the sole difference being the fluted support members;

FIG. 3 is a front elevation view of my new design of FIG. 1;

FIG. 4 is a rear elevation view of my new design of FIG. 1; FIG. 5 is a left side view of my new design of FIG. 1, the right side view being a mirror image of that shown;

FIG. 6 is a top plan view of my new design of FIG. 1;

FIG. 7 is a bottom plan view of my new design of FIG. 1;

FIG. 8 is a right front perspective view of a ladderback chair showing a third embodiment of my new design in the form of a high chair;

FIG. 9 is a front elevation view of my new design of FIG. 8;

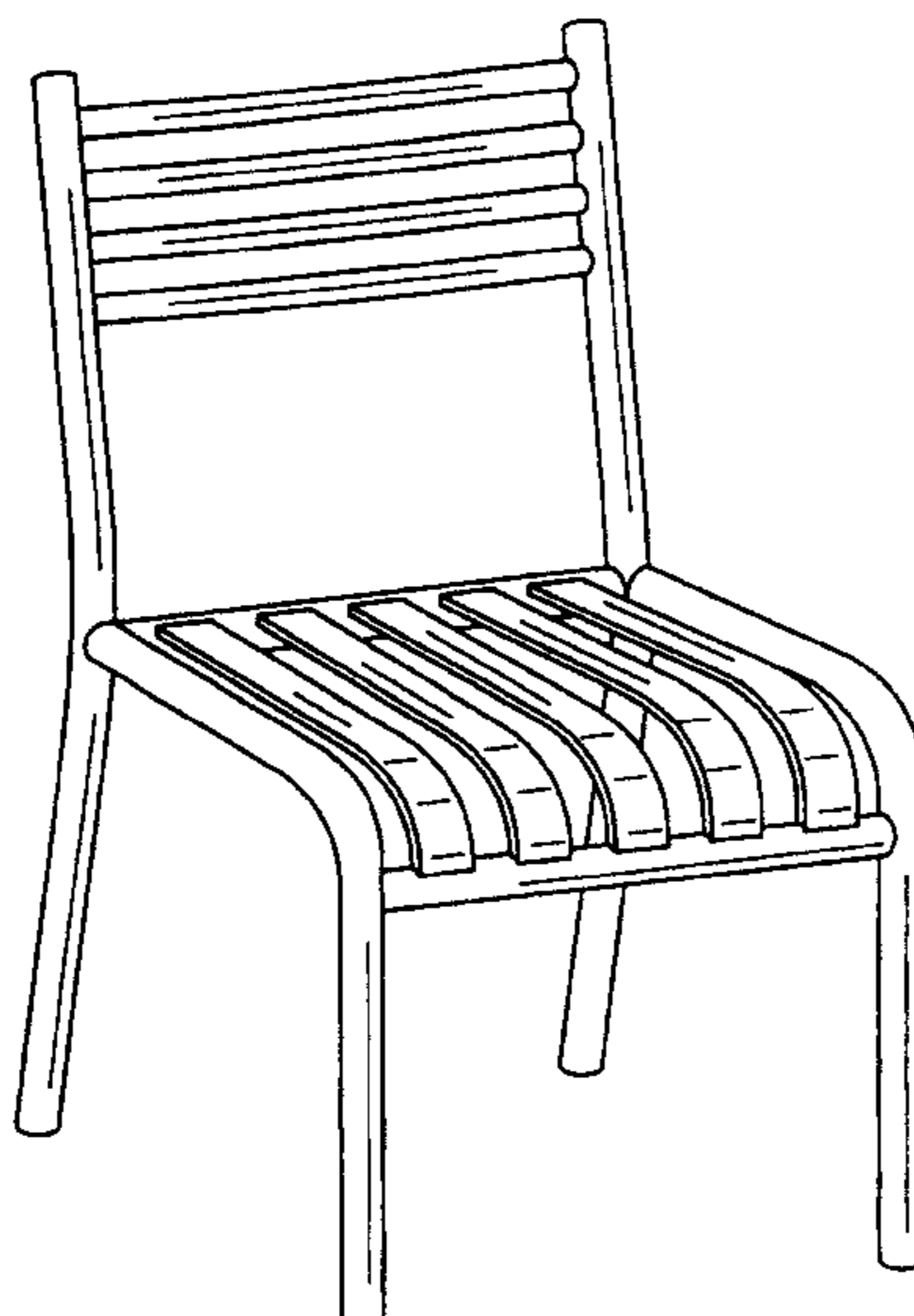
FIG. 10 is a rear elevation view of my new design of FIG. 8;

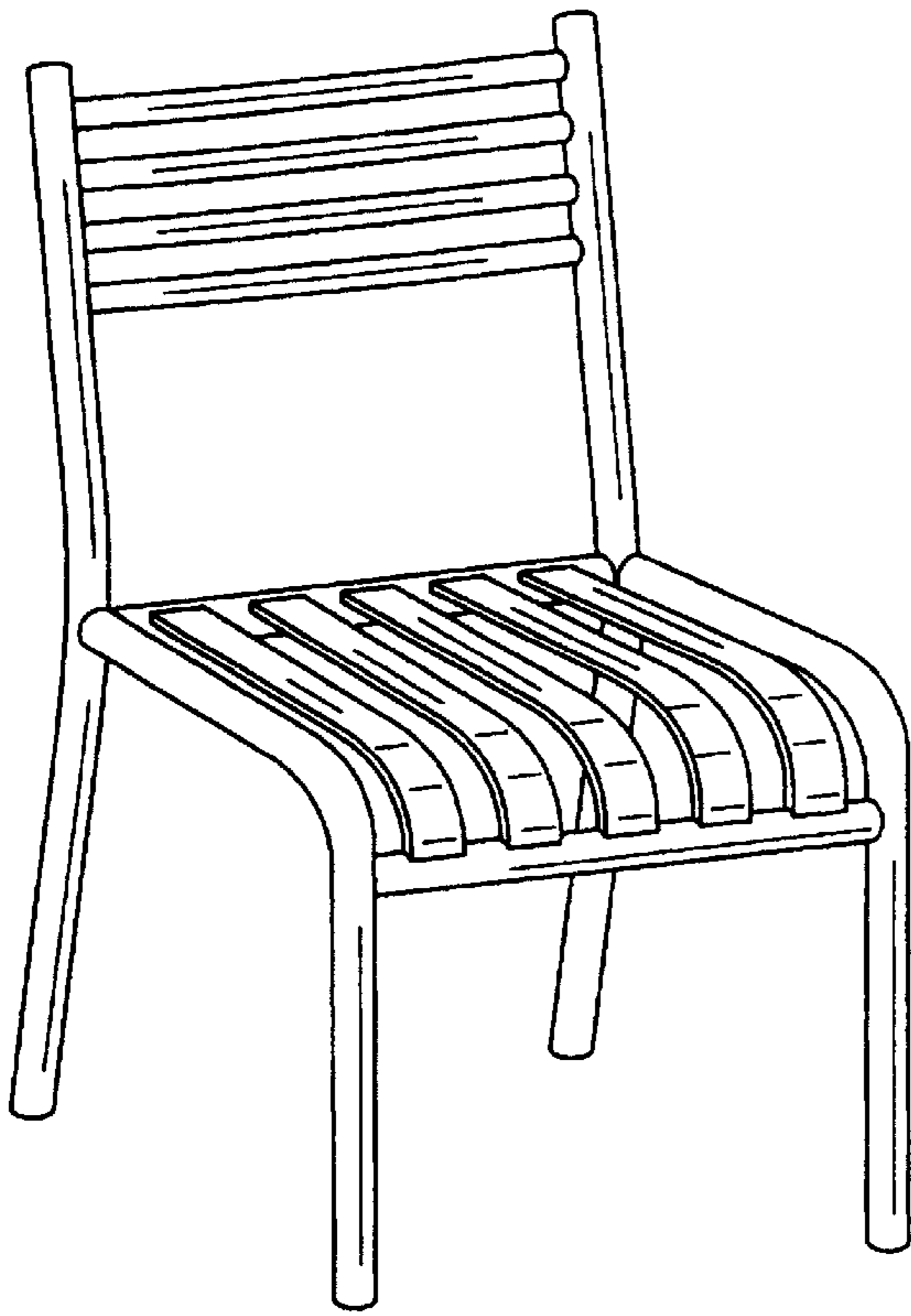

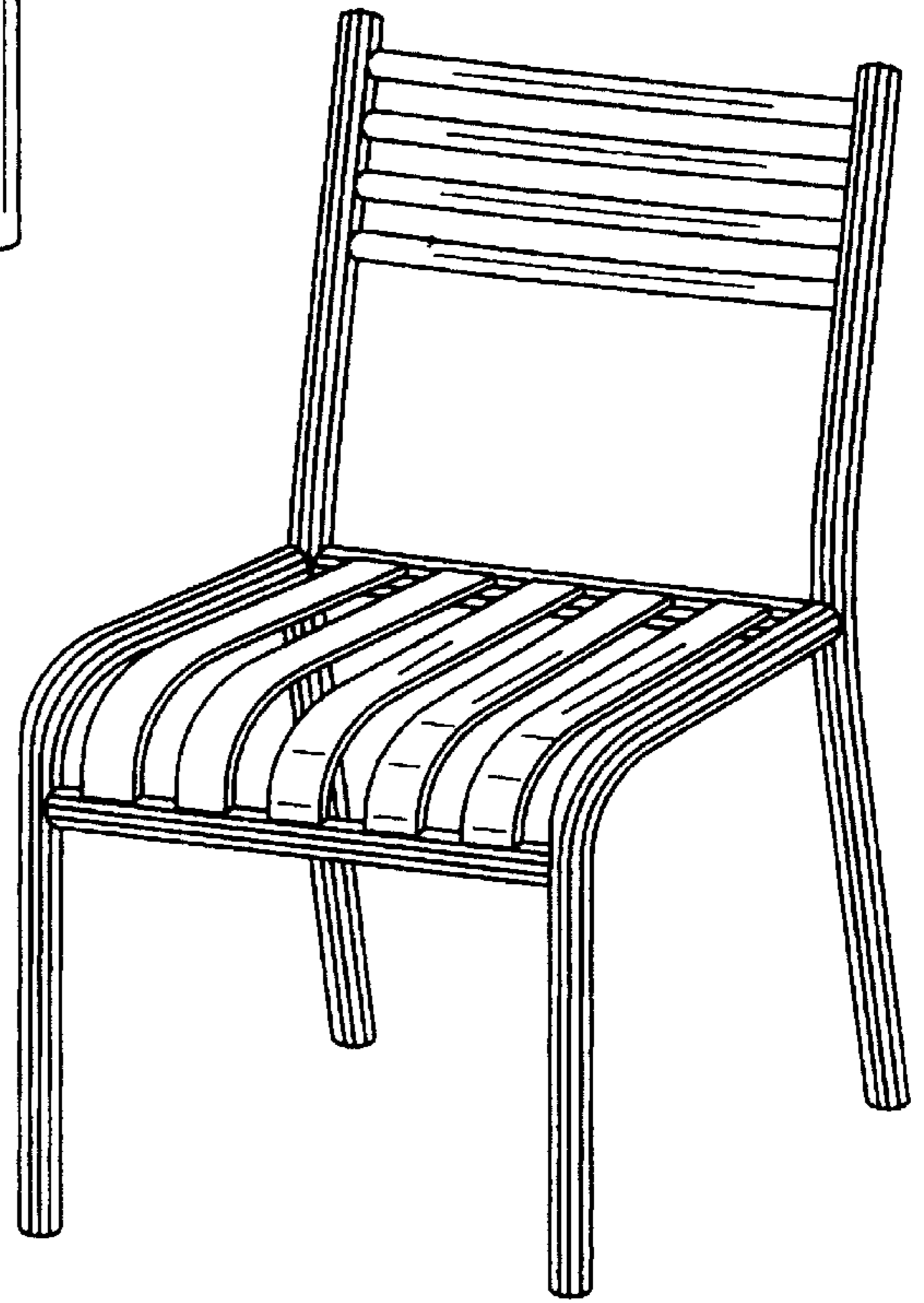

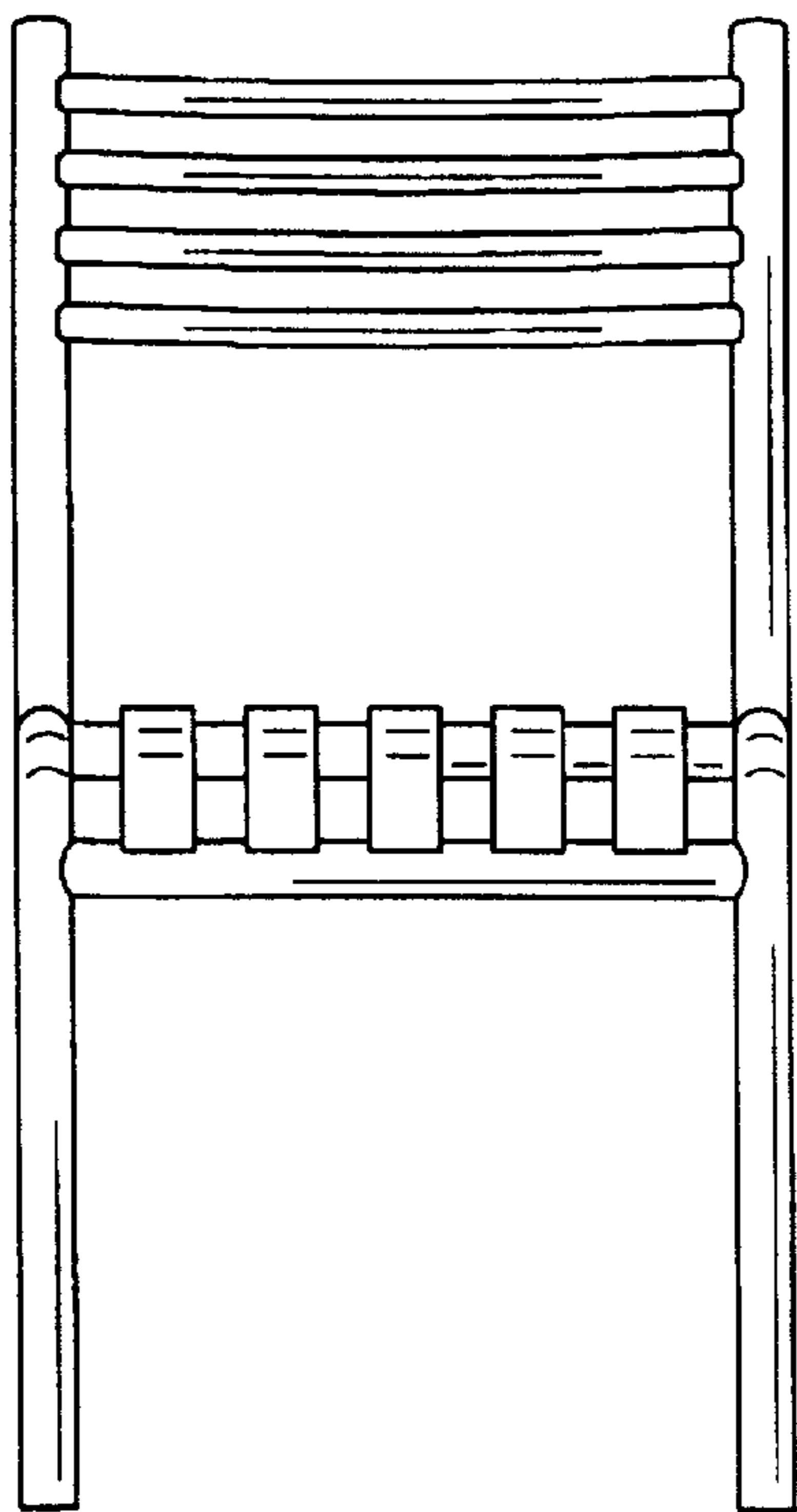

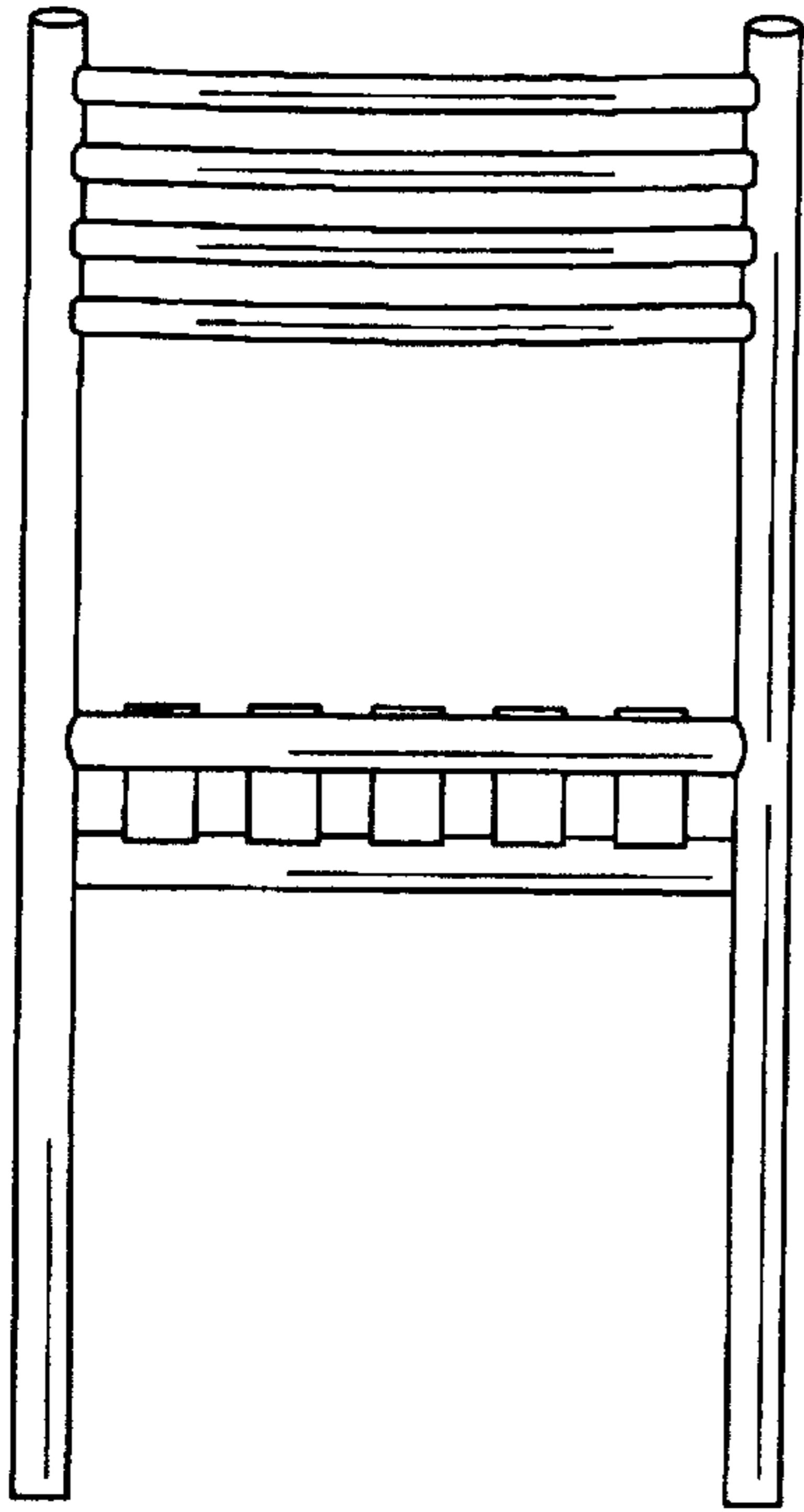

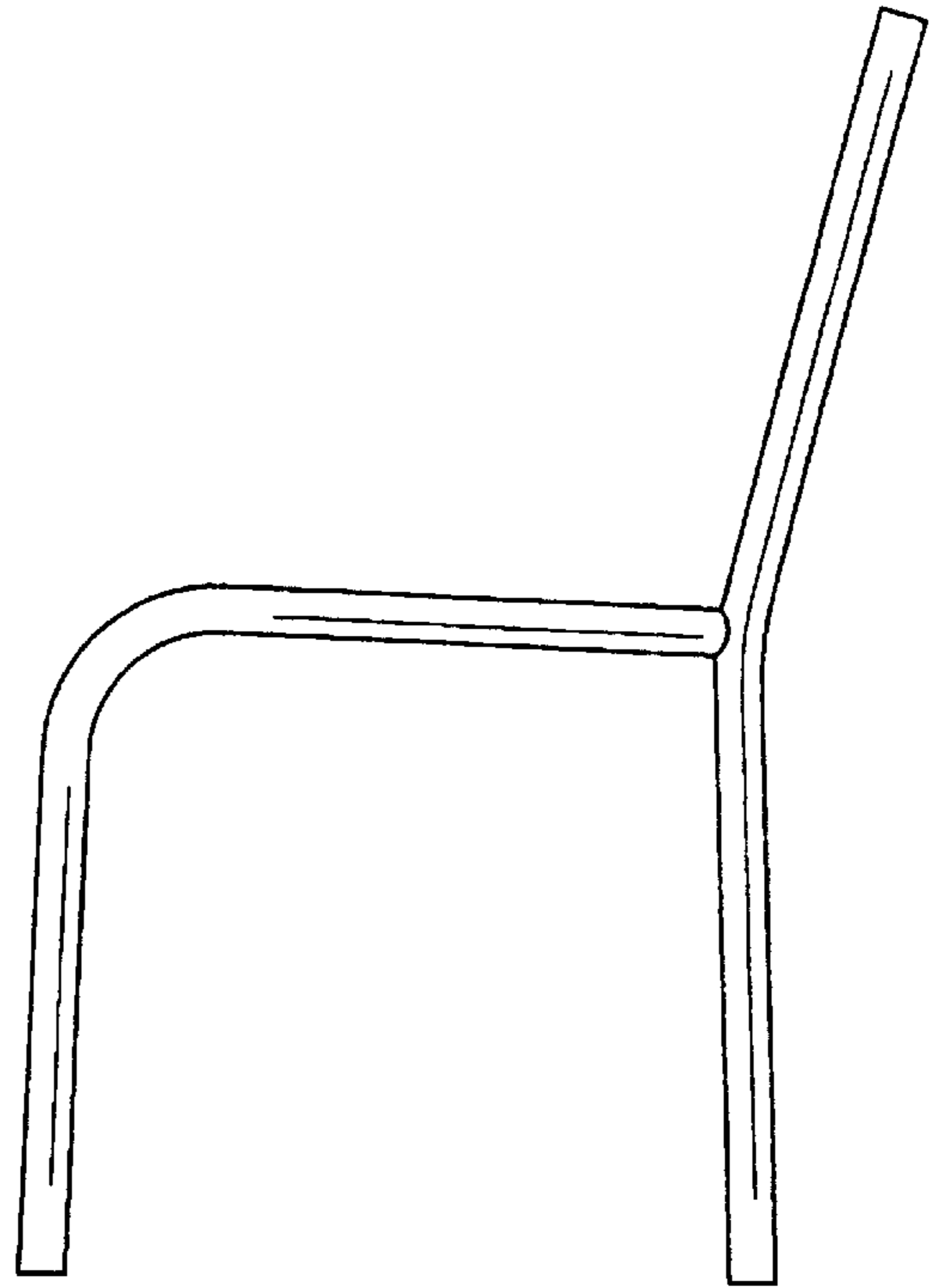

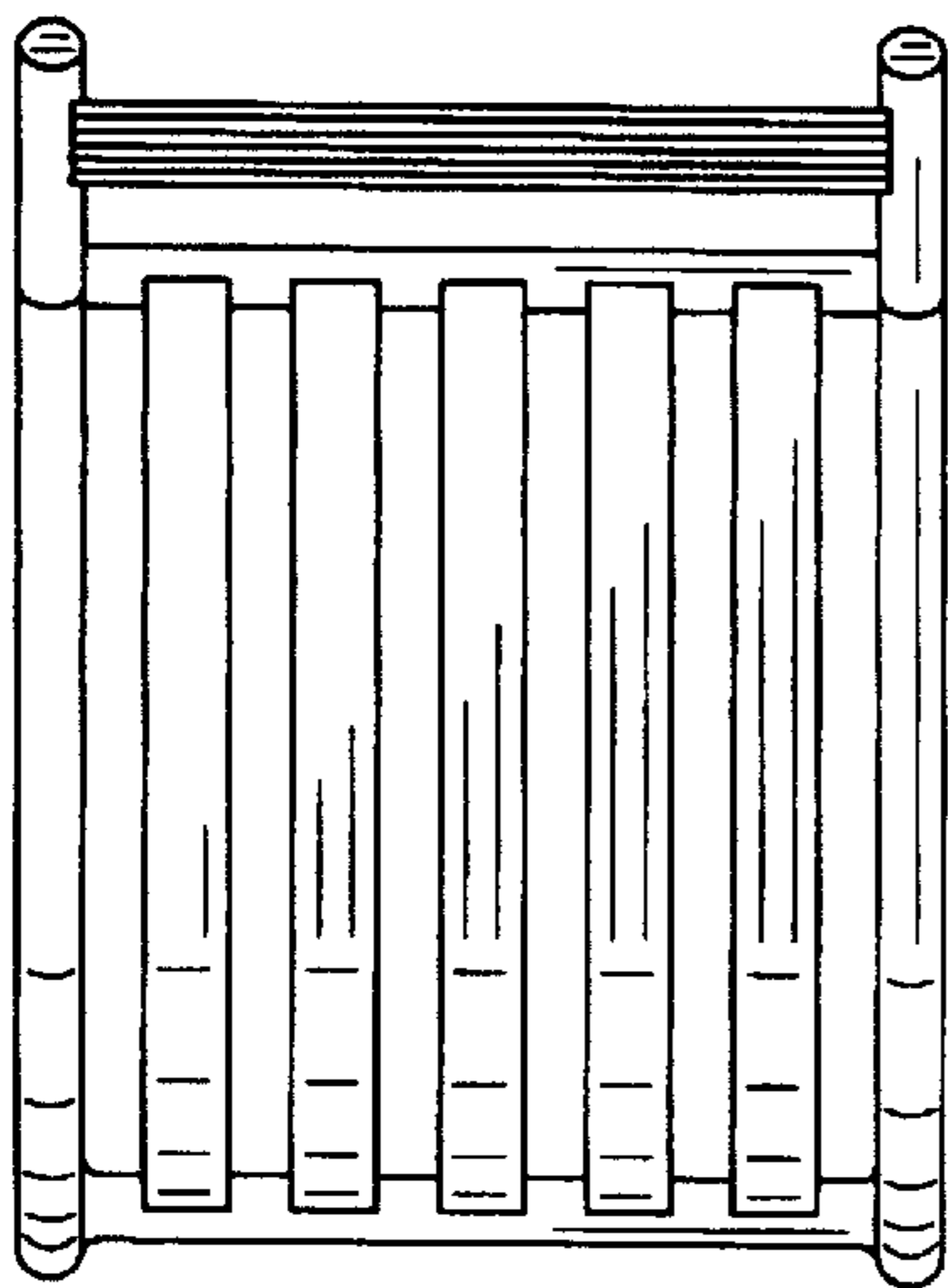

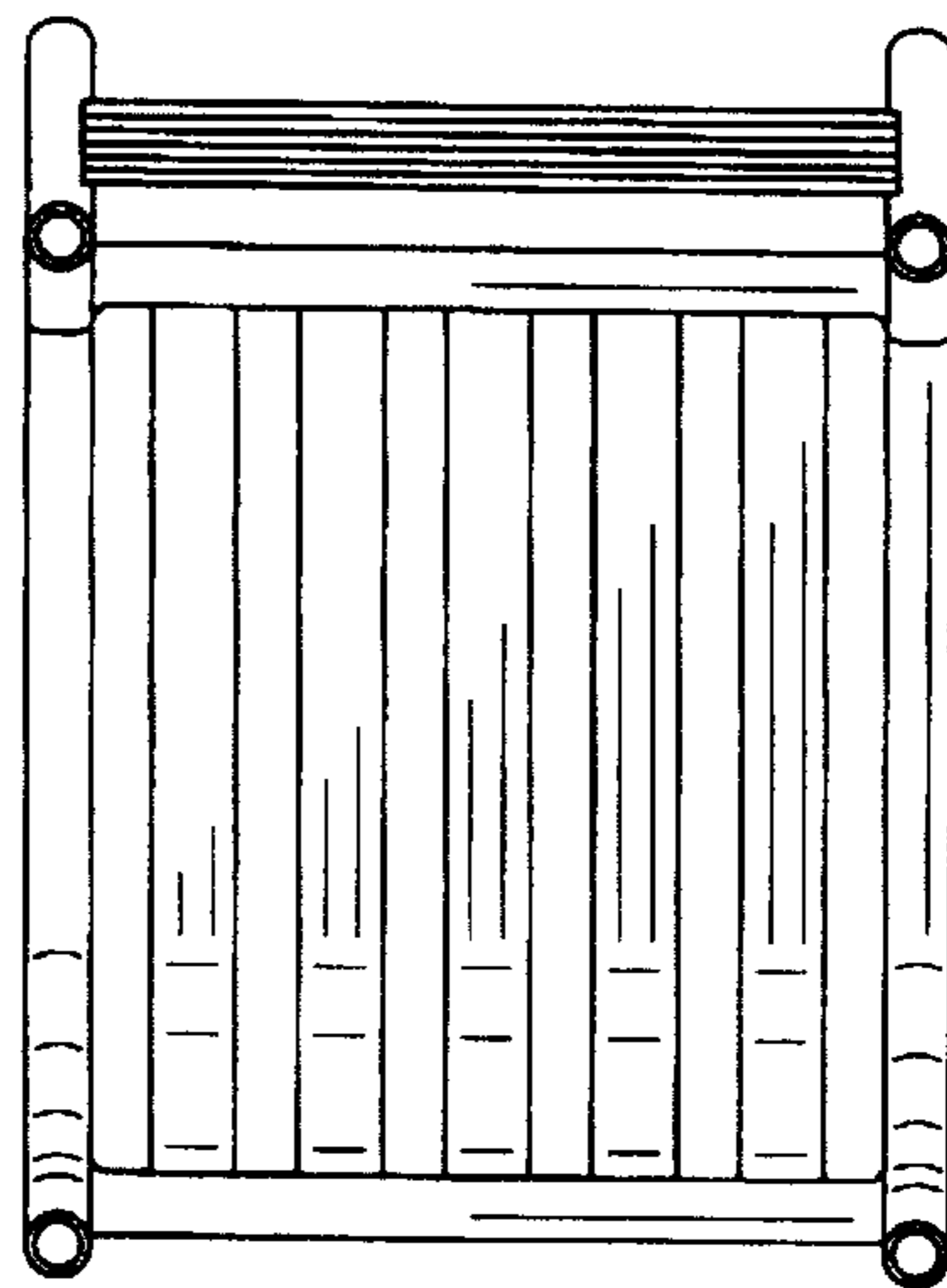

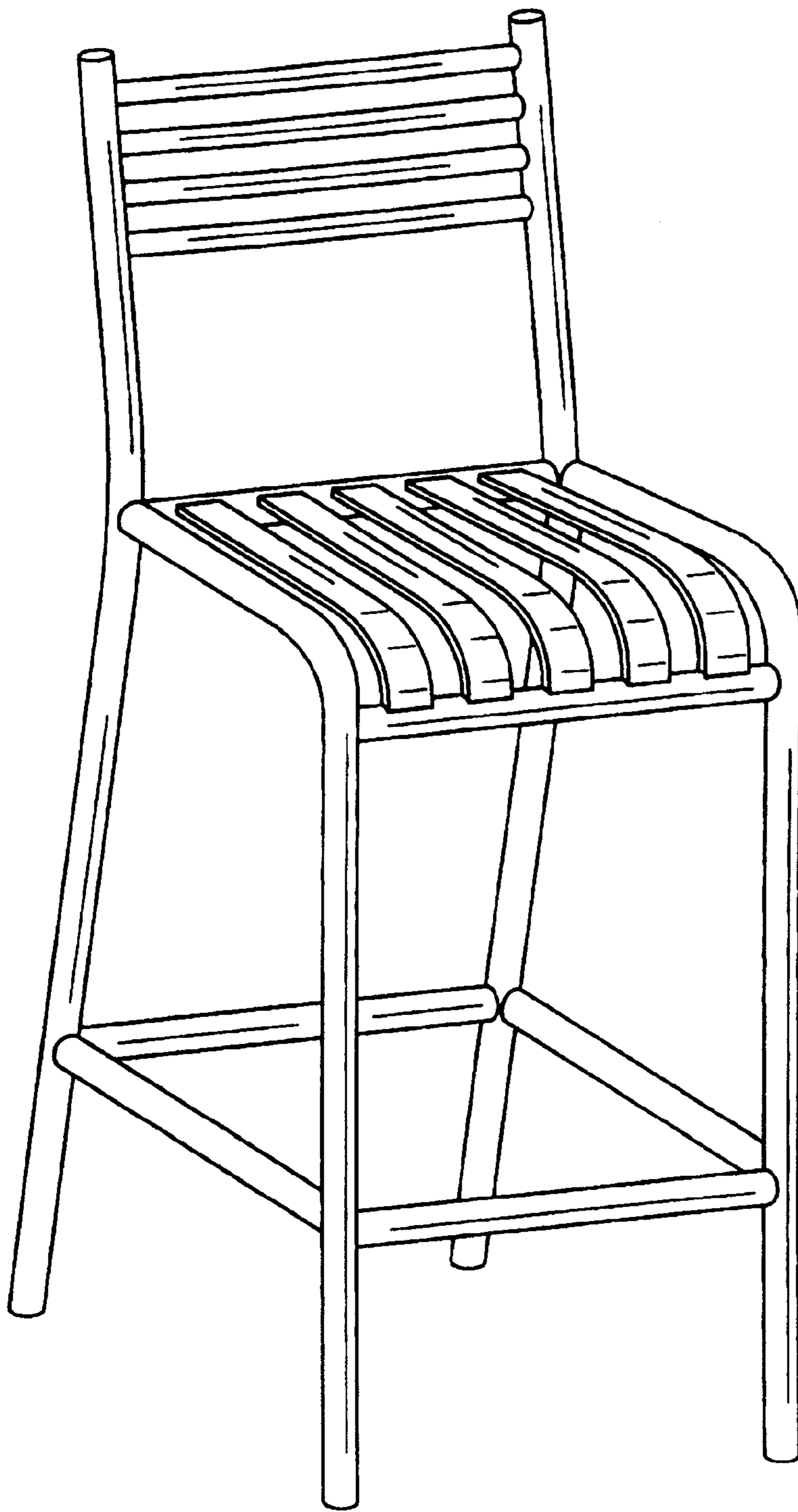

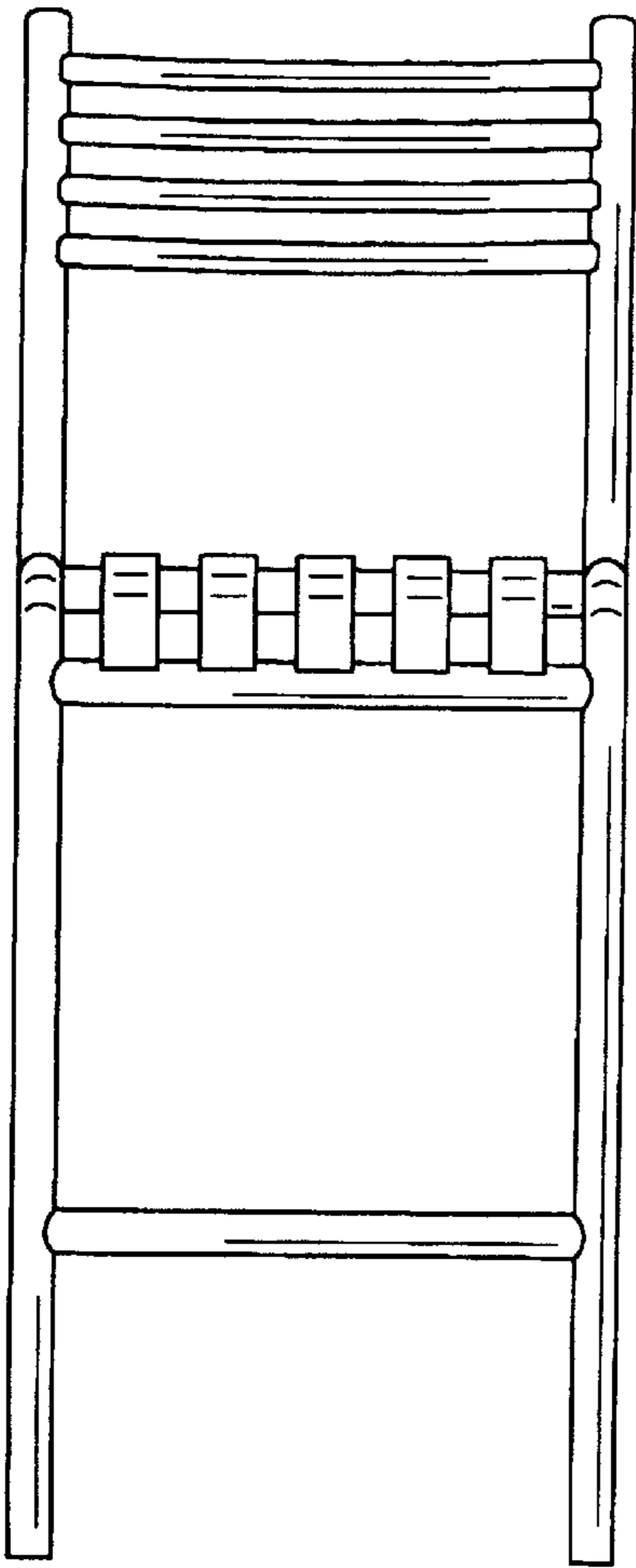

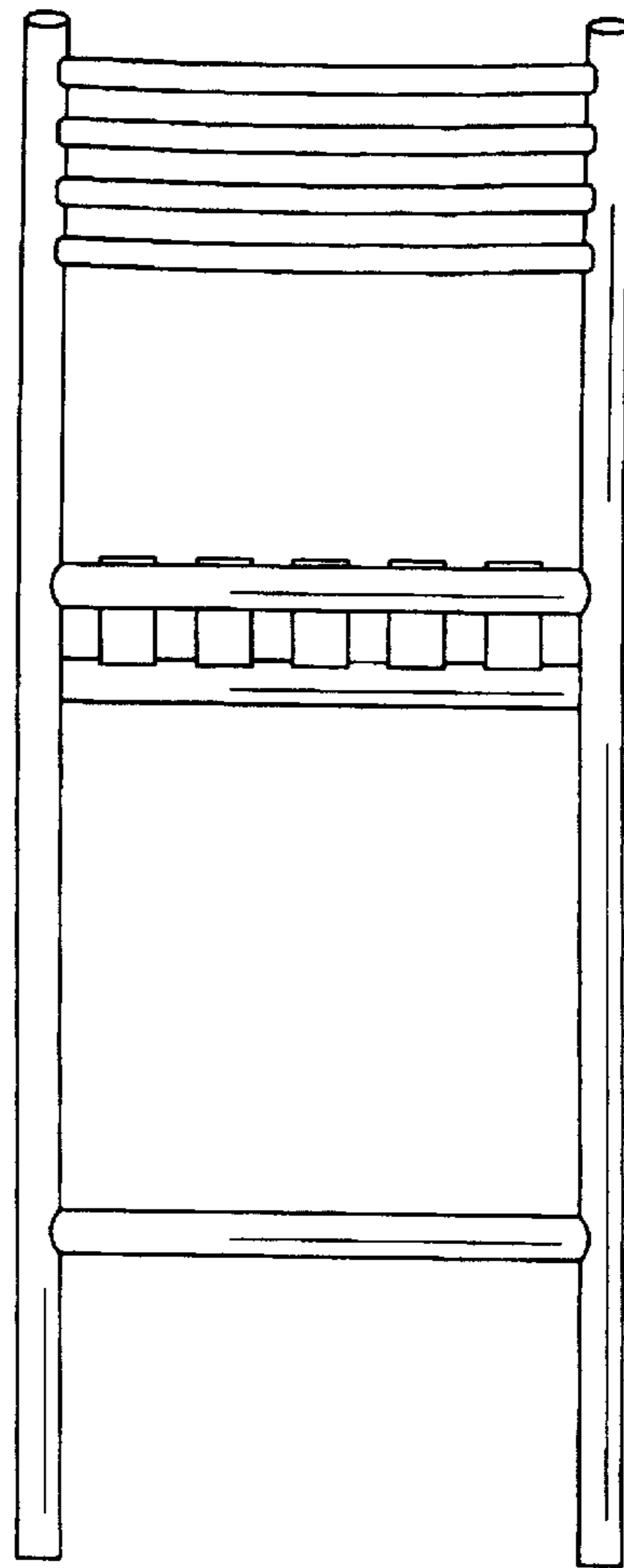

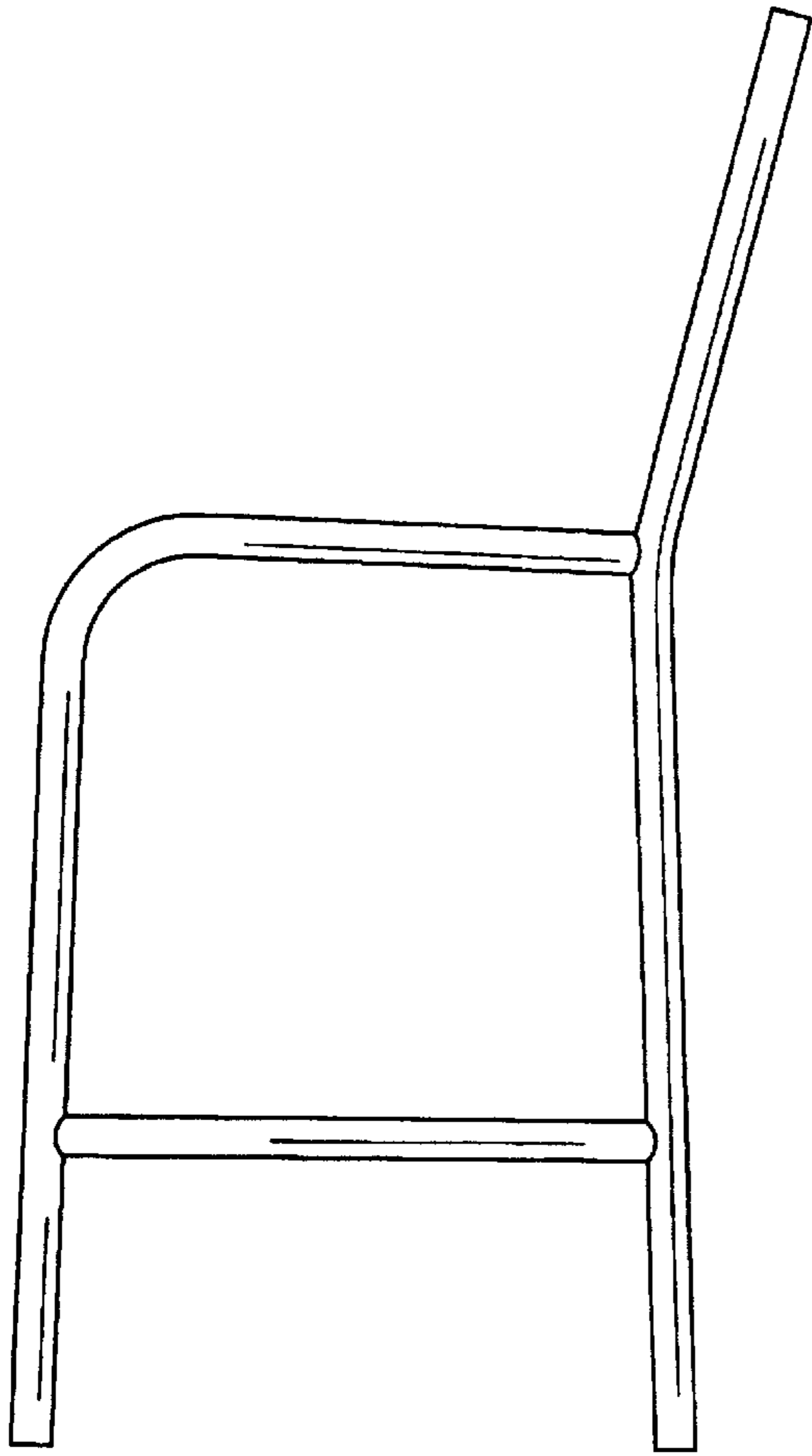

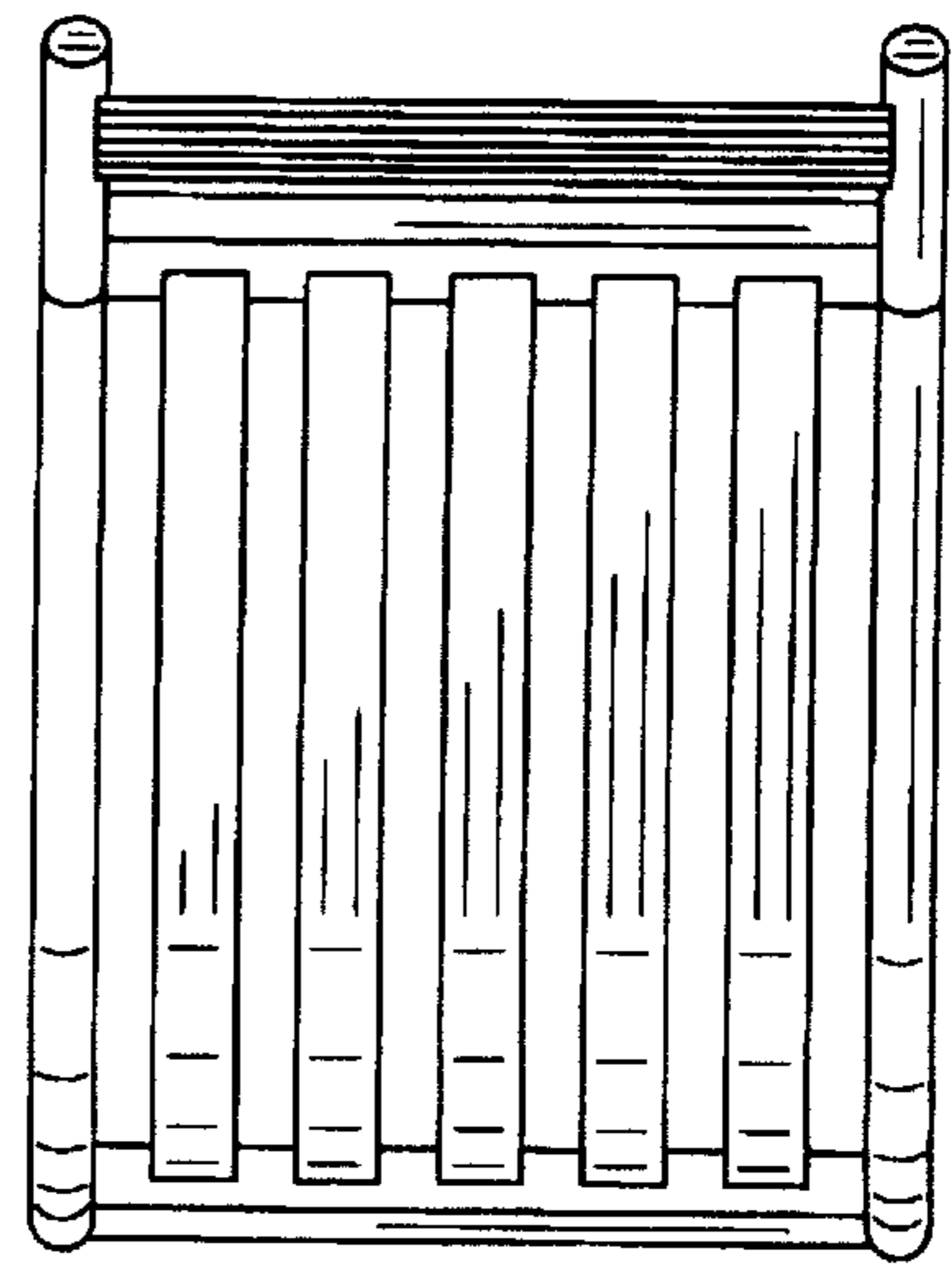

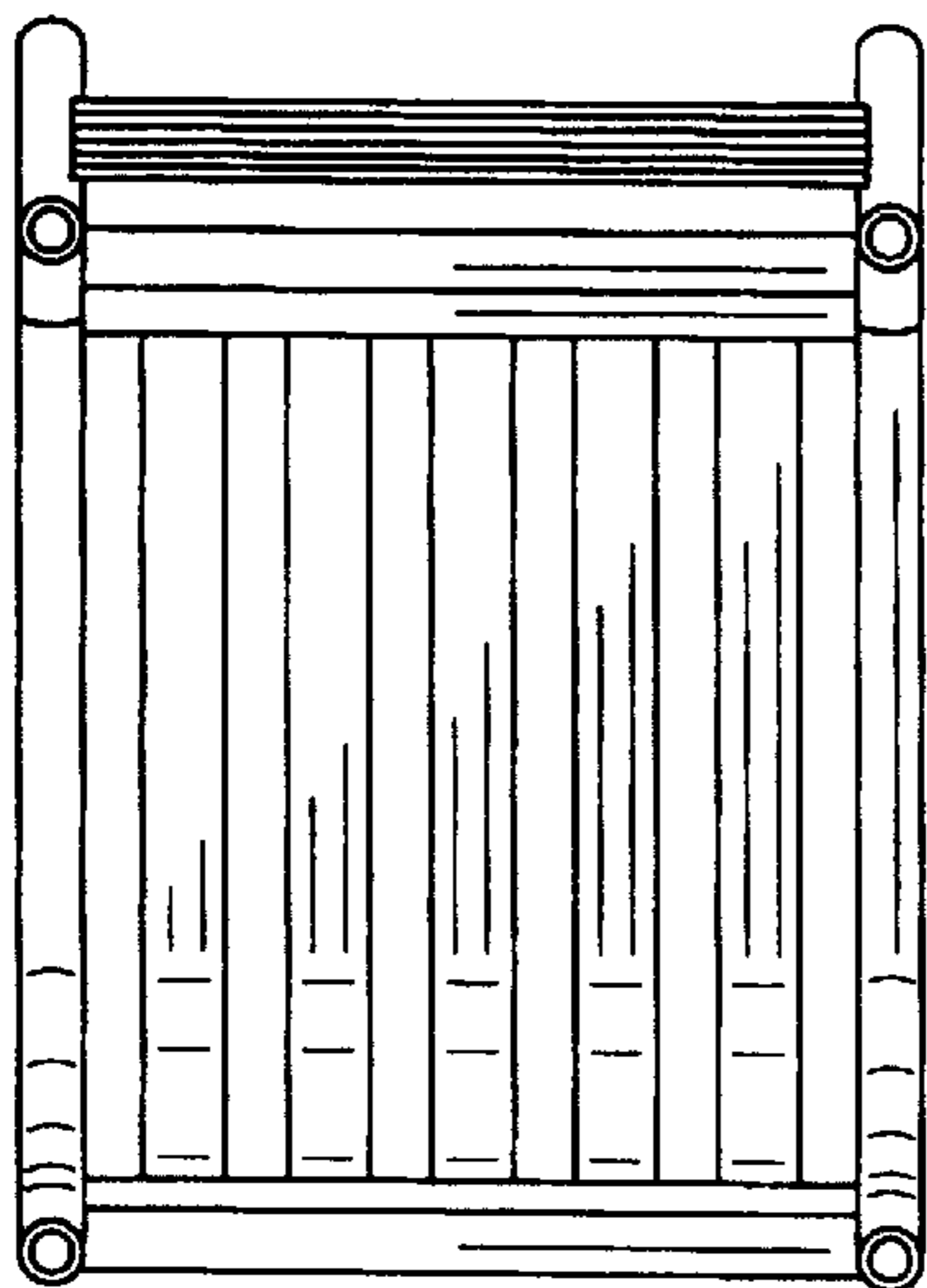
