The ornamental design for a chair, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a chair showing my new design;

FIG. 2 is a front view thereof;

FIG. 3 is a side view, the opposite side view being a mirror image thereof;

FIG. 4 is a back view thereof;

FIG. 5 is a top view thereof; and,

FIG. 6 is a perspective view of a second embodiment of the chair of the design shown in FIGS. 1-5.

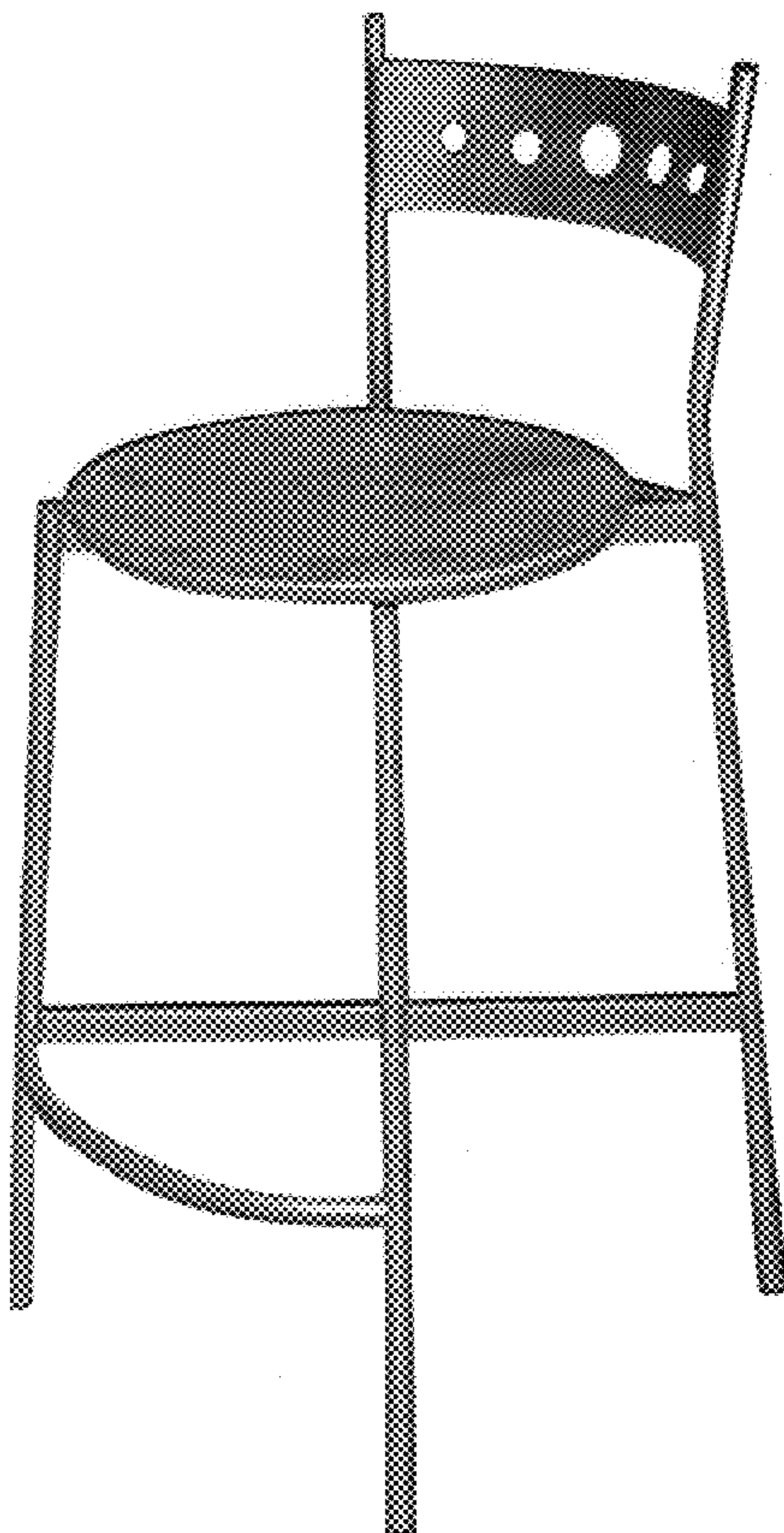

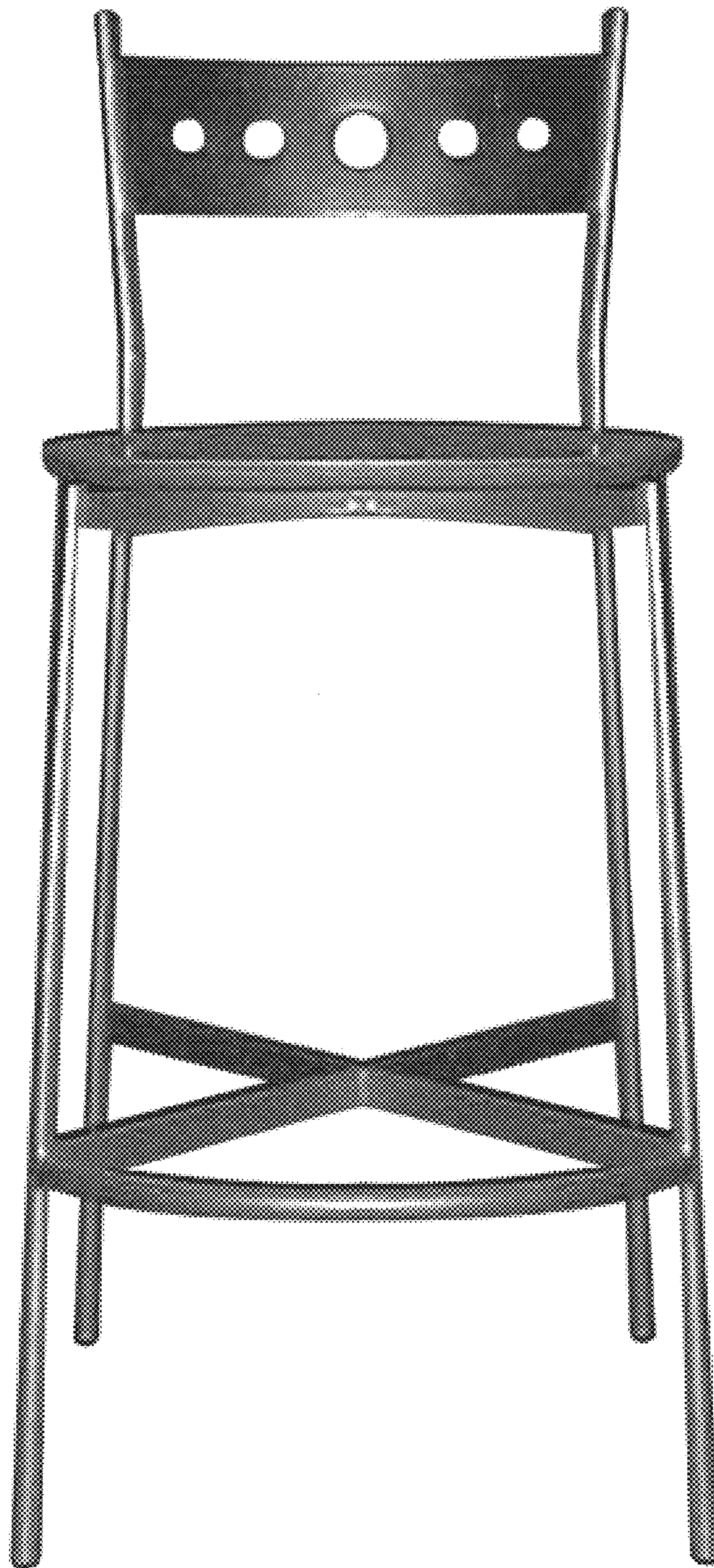

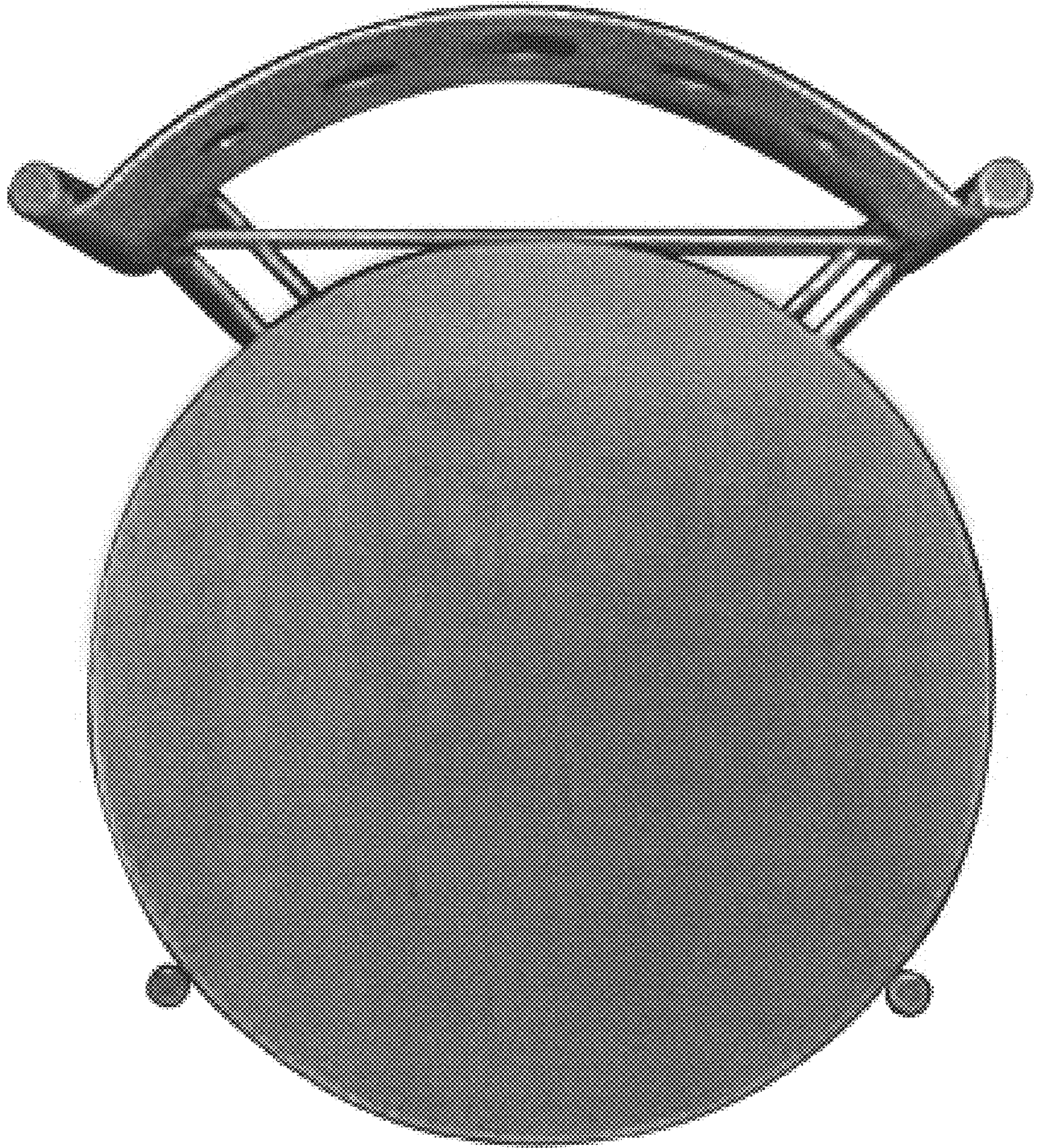
