(57) **CLAIM**

I claim the ornamental design for a tribal mask drink container, as shown.

DESCRIPTION

FIG. 1 is a front view of a tribal mask drink container according to my new design;

FIG. 2 is a rear view of the drink container of FIG. 1;

FIG. 3 is a left side view of the drink container of FIG. 1;

FIG. 4 is a right side view of the drink container of FIG. 1;

FIG. 5 is a top view of the drink container of FIG. 1; and,

FIG. 6 is a bottom view of the drink container of FIG. 1.

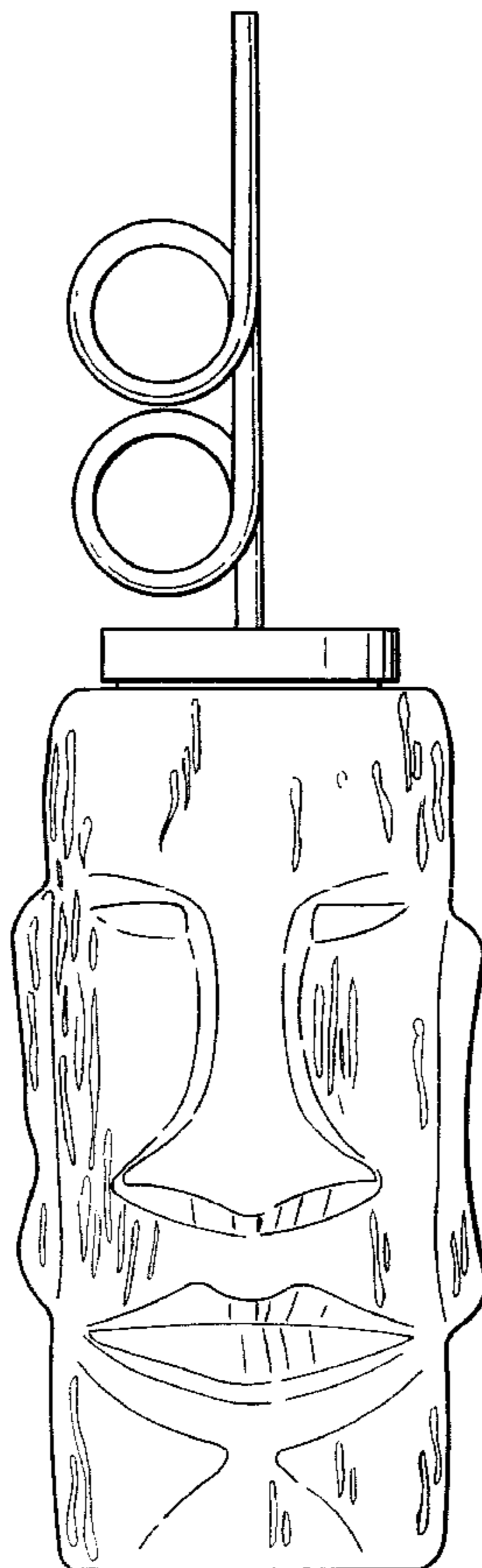

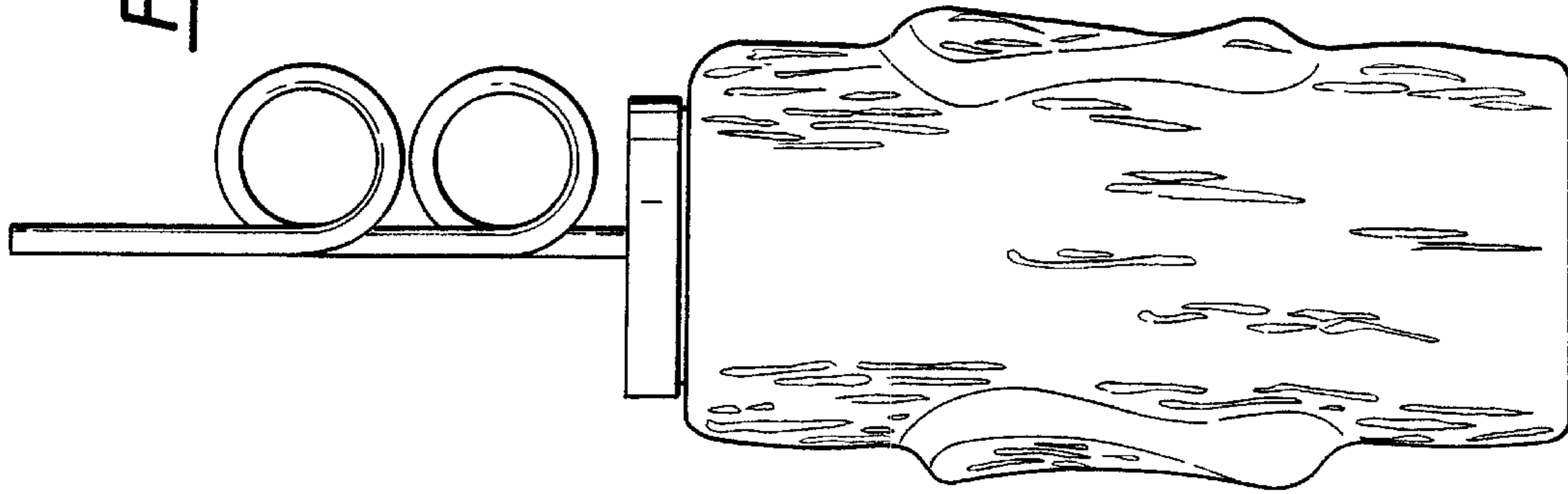
