(57) **CLAIM**

The ornamental design for a finger cutting ring, as shown and described.

DESCRIPTION

FIG. 1 is a front elevation view of a finger cutting ring, showing my new design;

FIG. 2 is a bottom plan view of the invention illustrated in FIG. 1;

FIG. 3 is a top plan view of the invention illustrated in FIG. 1;

FIG. 4 is a rear elevation view of the invention illustrated in FIG. 1;

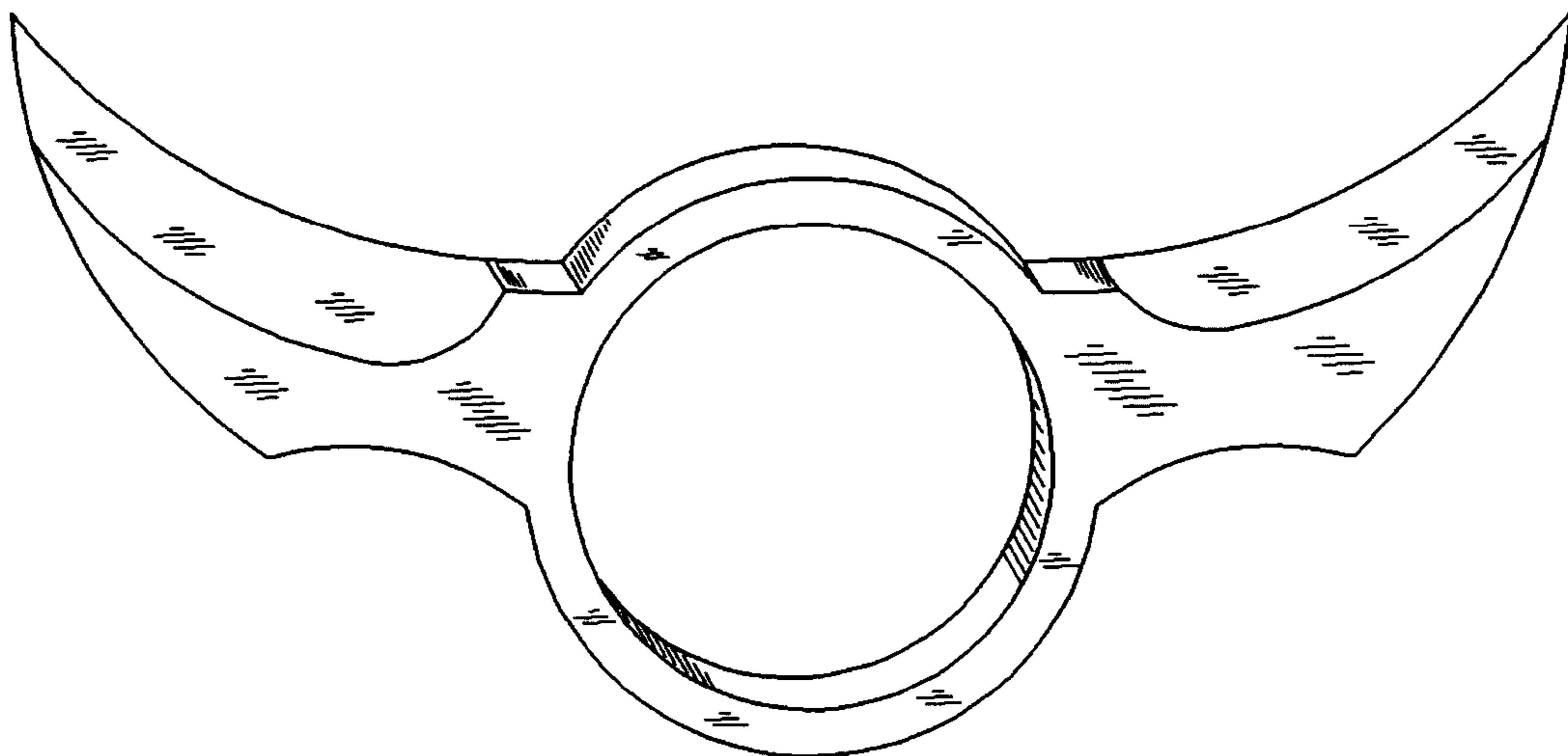
FIG. 5 is a left elevation end view of the invention illustrated in FIG. 1;

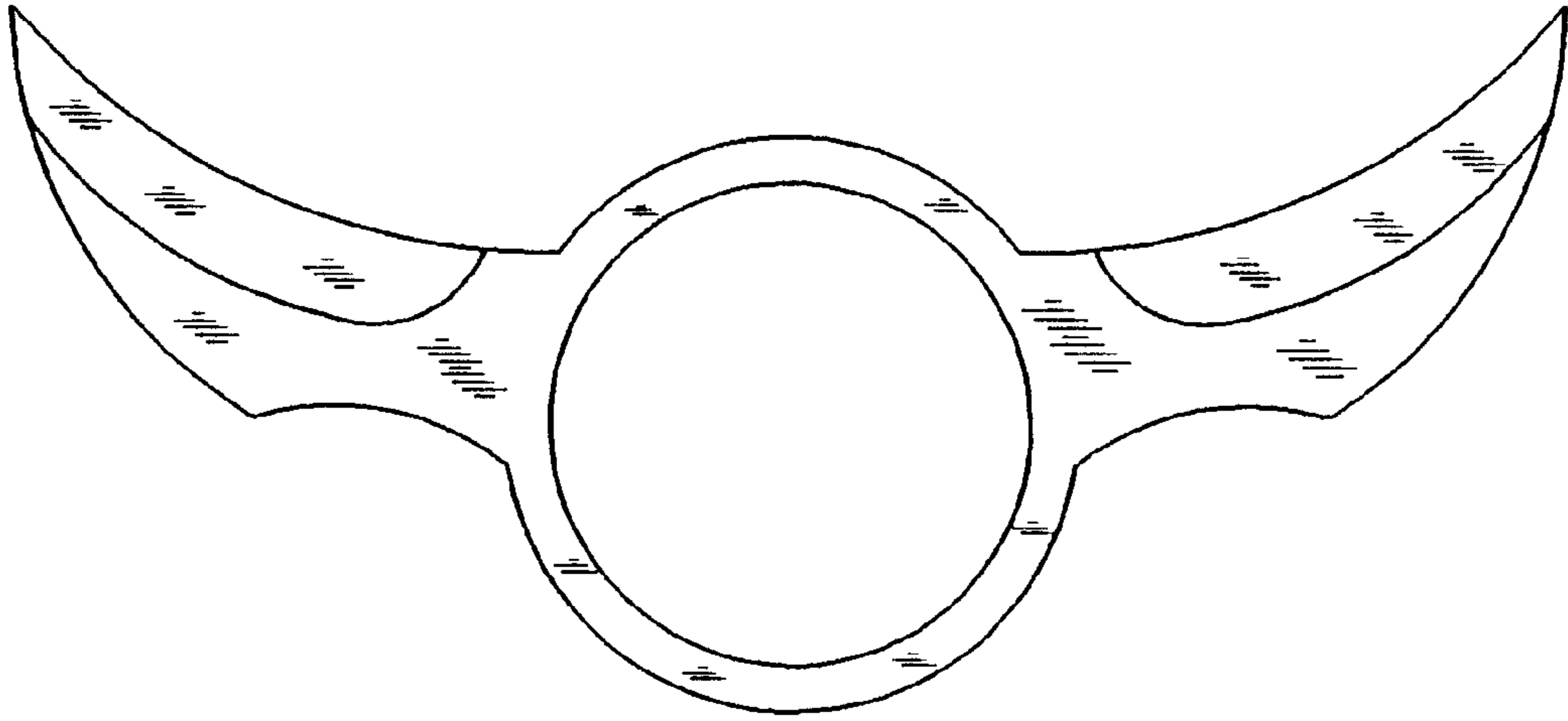

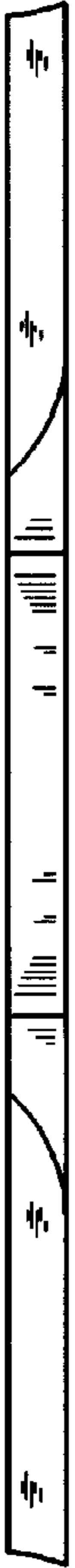

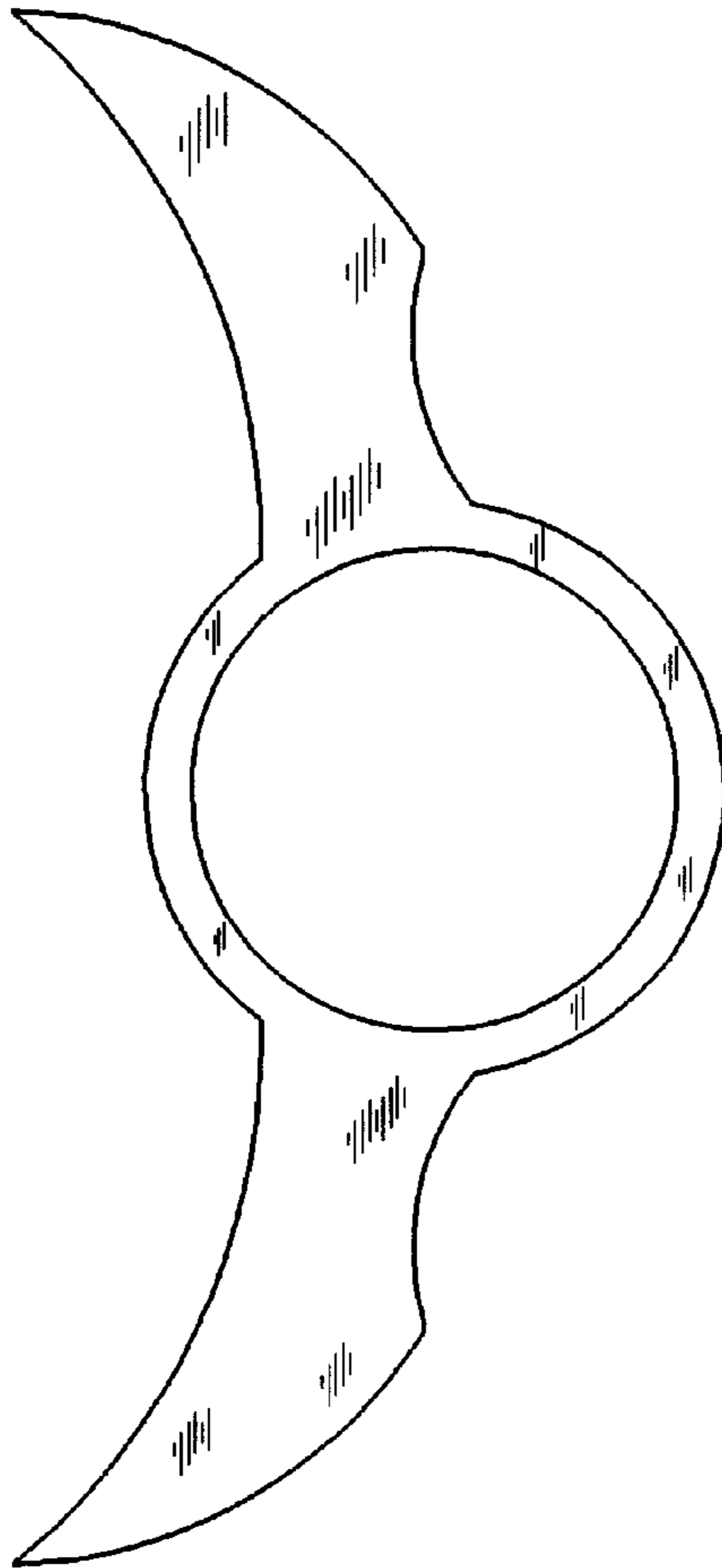

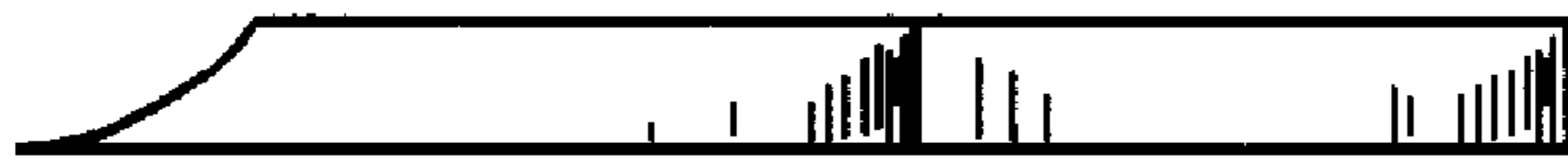

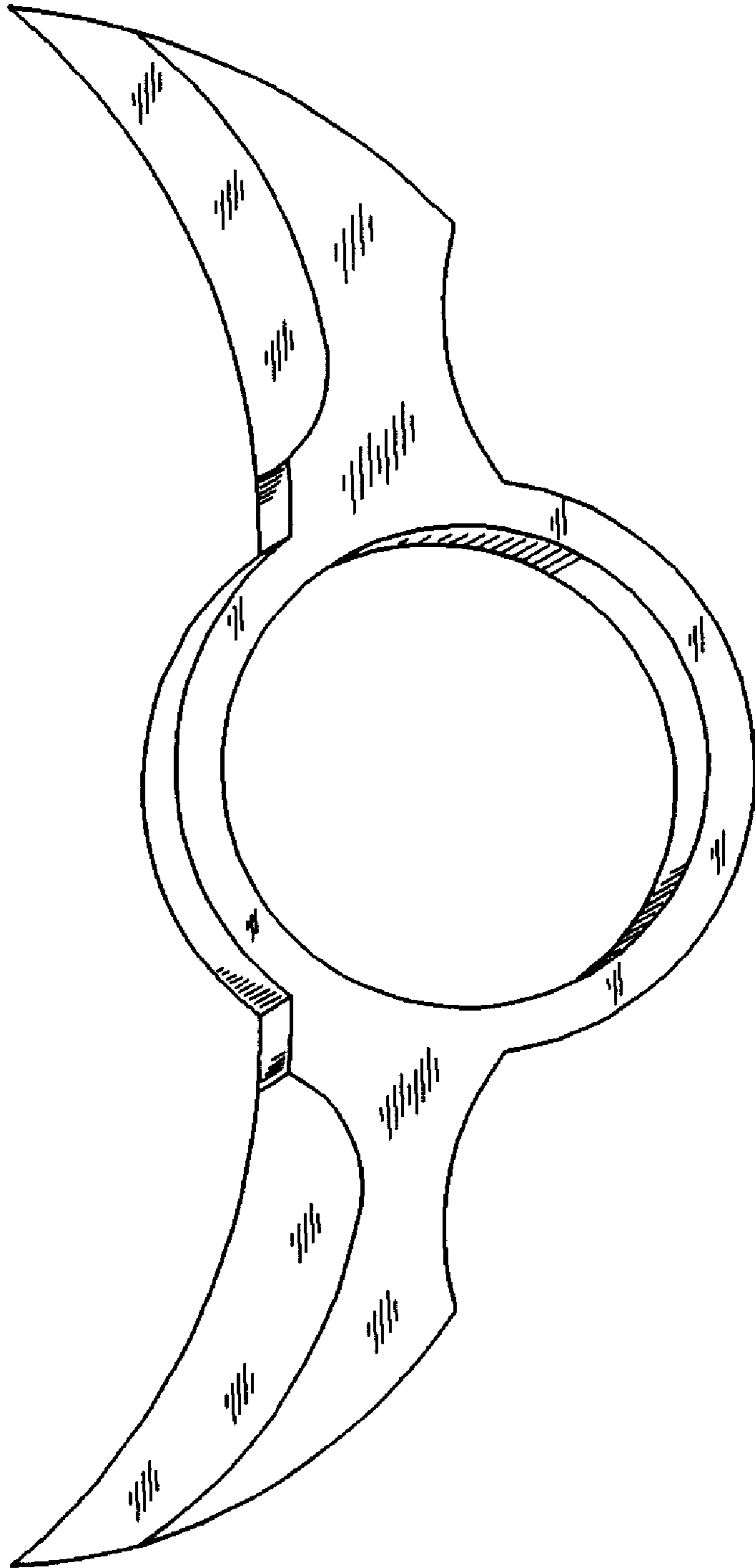
