FIG. 3 is a left side view thereof;

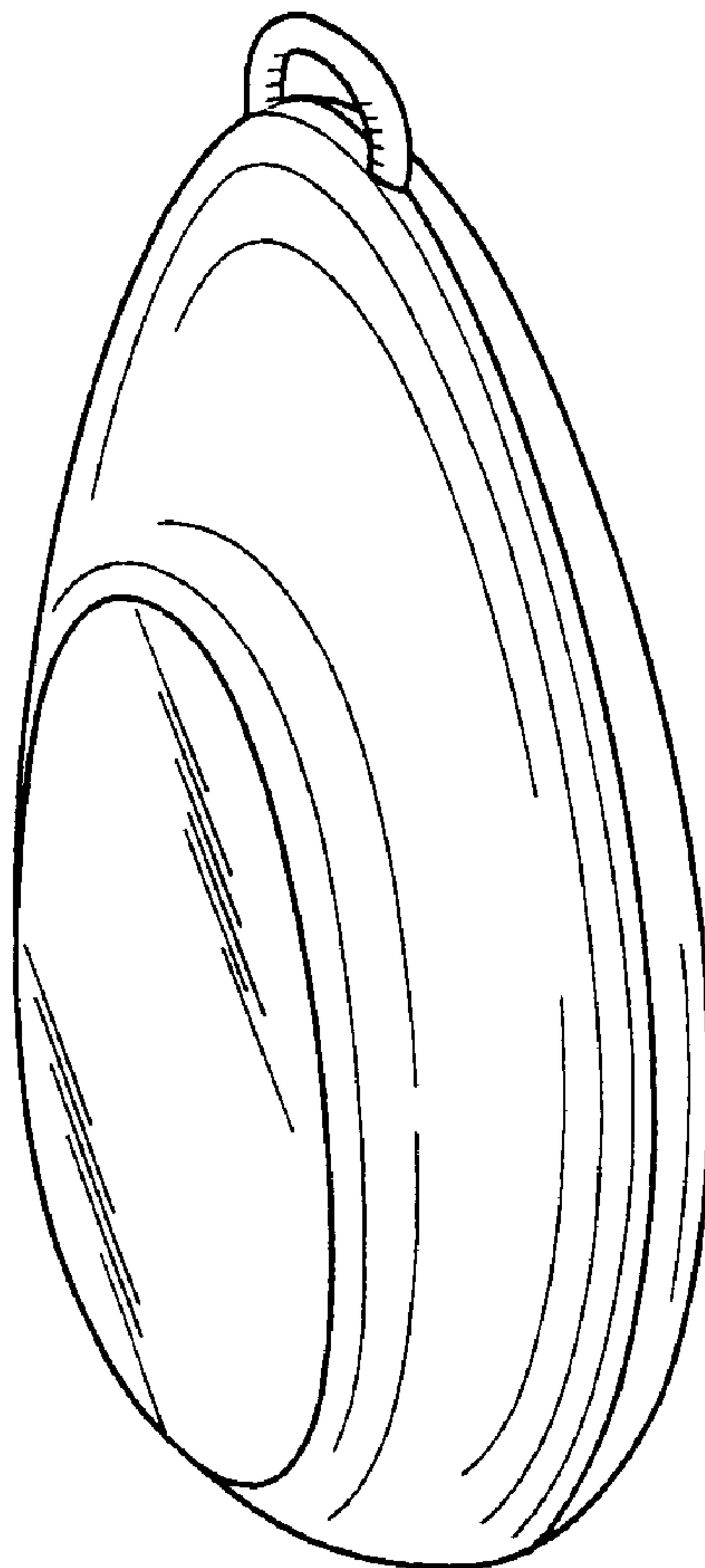
FIG. 4 is a right side view thereof;

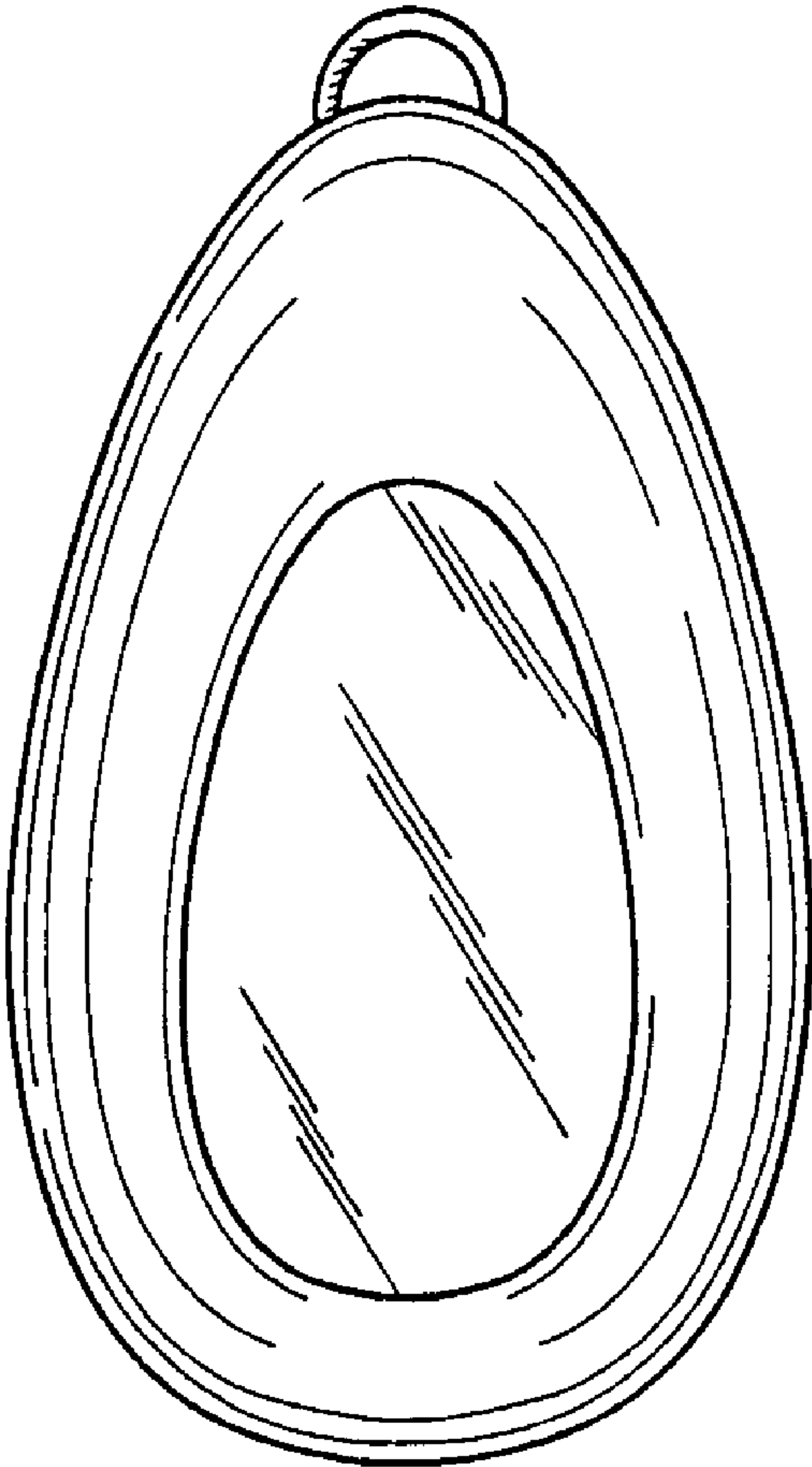

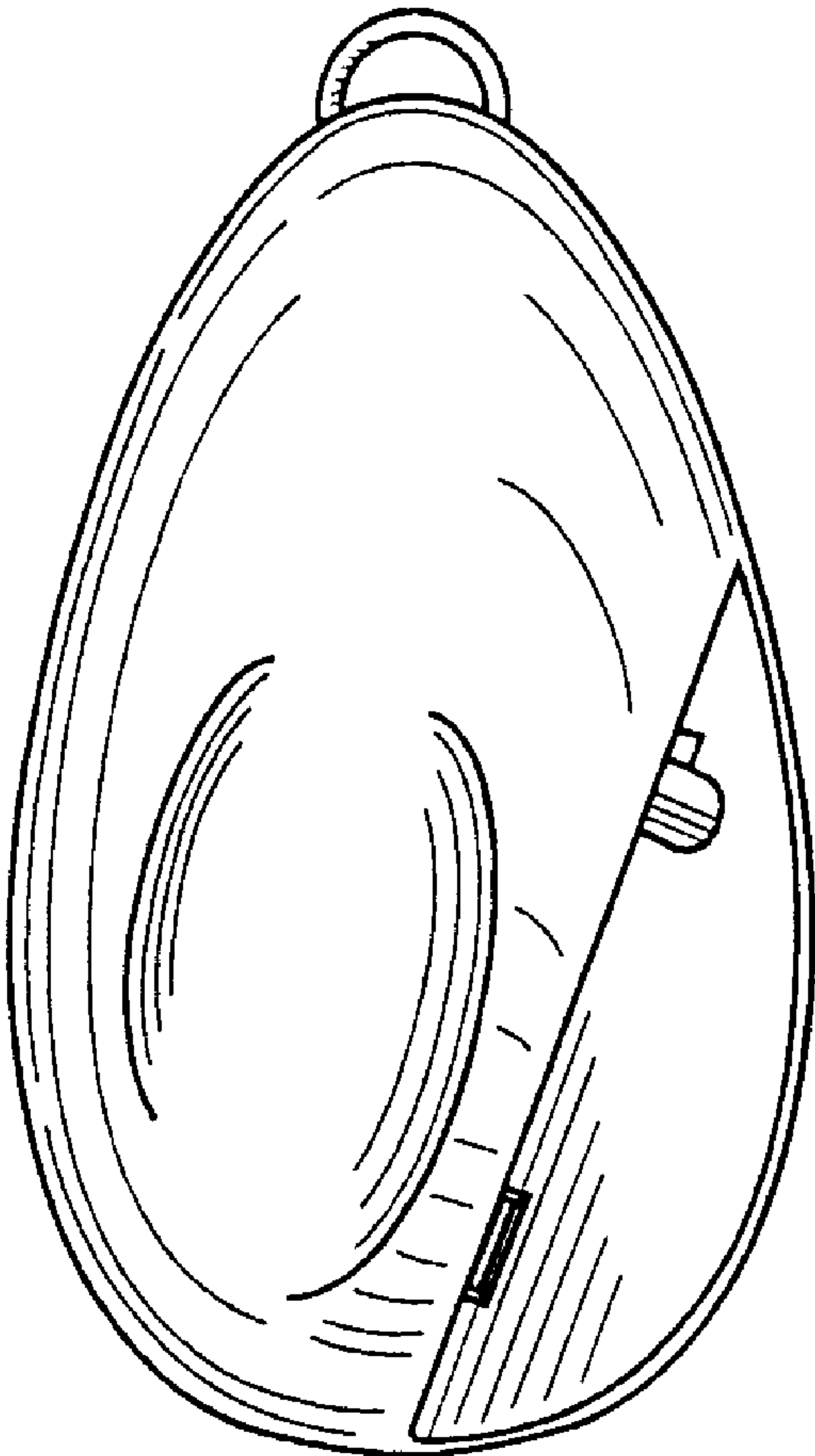

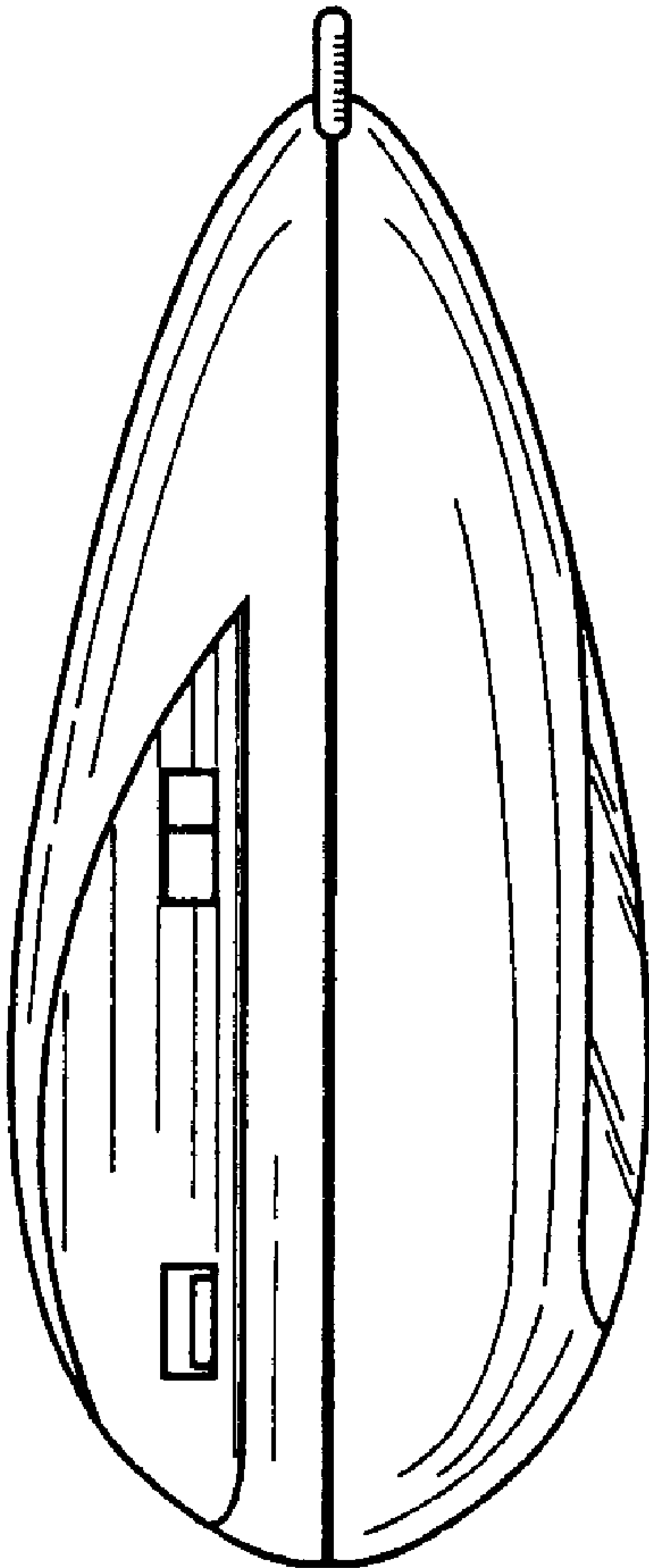

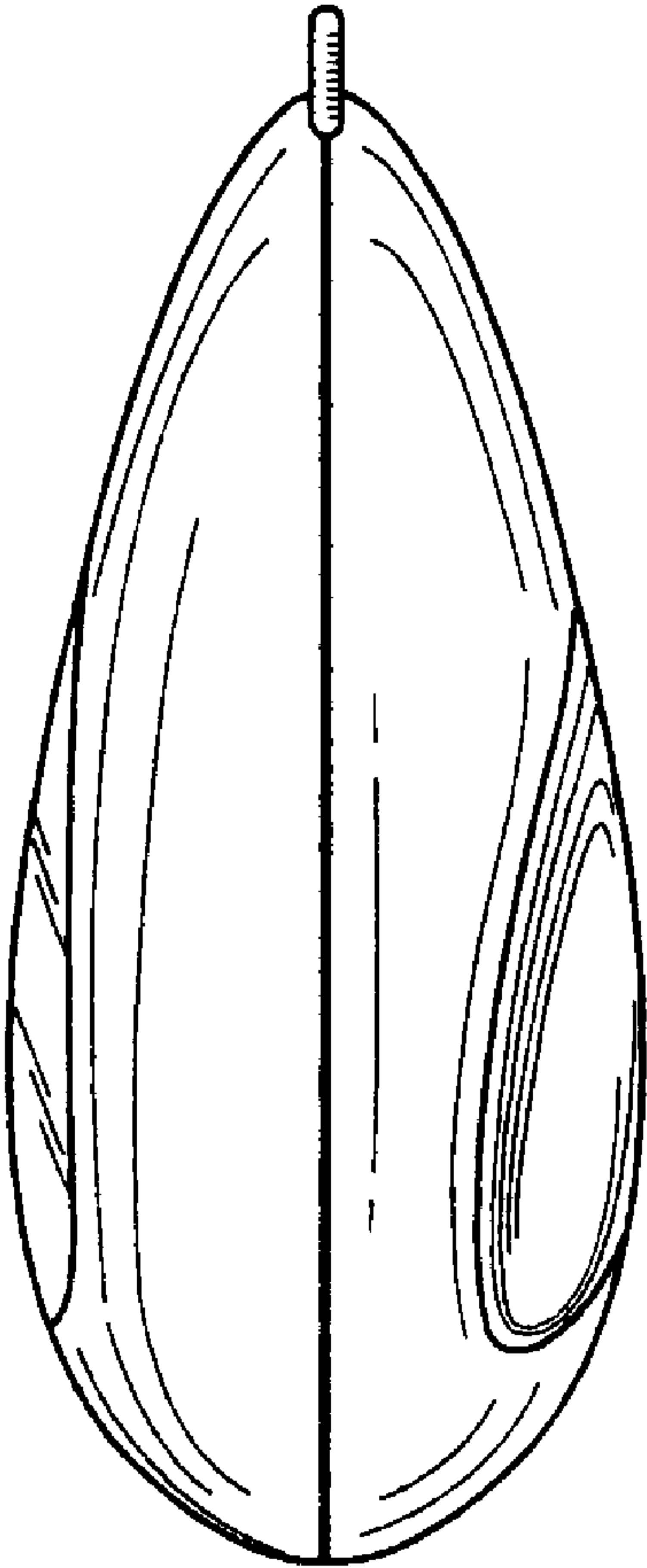

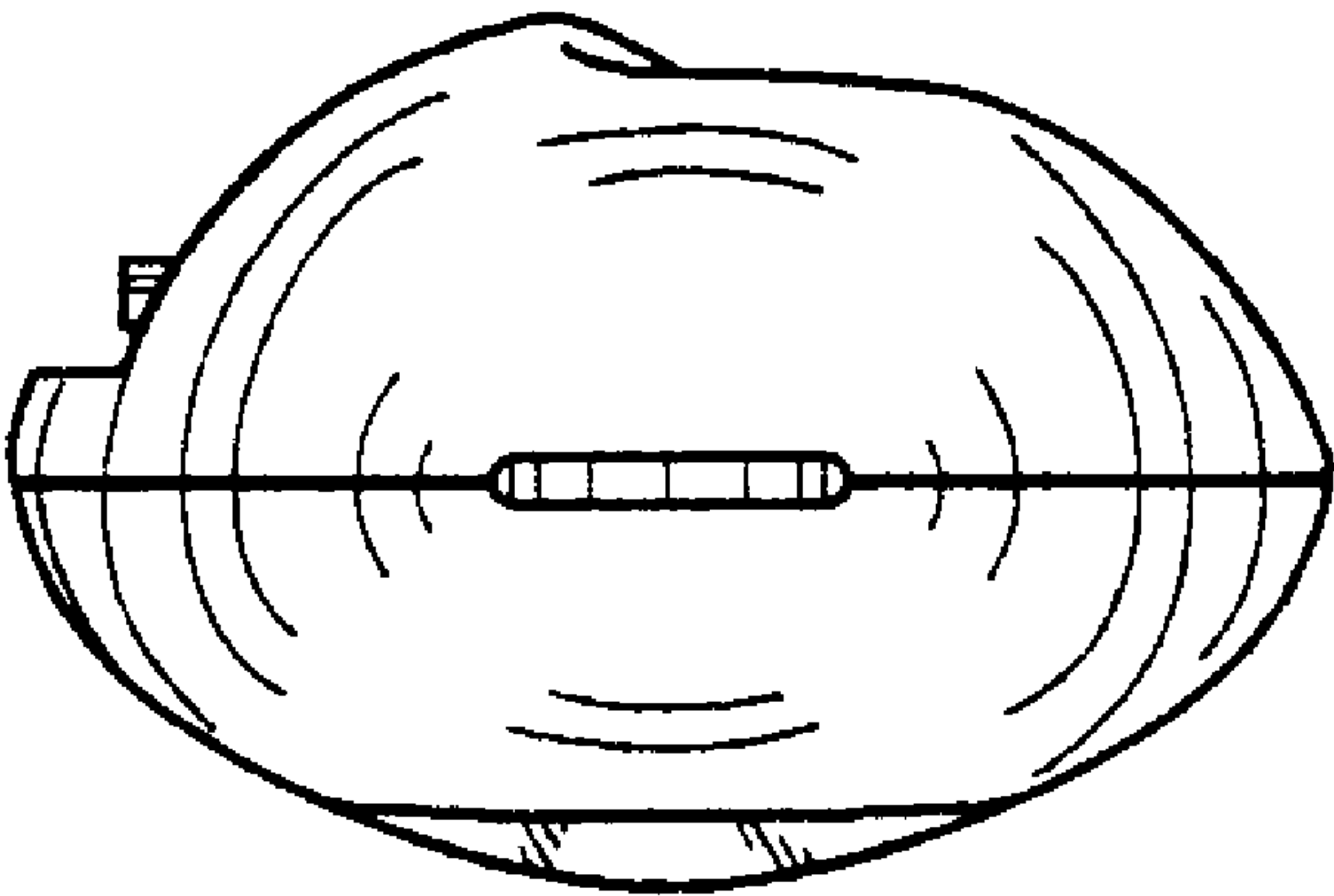

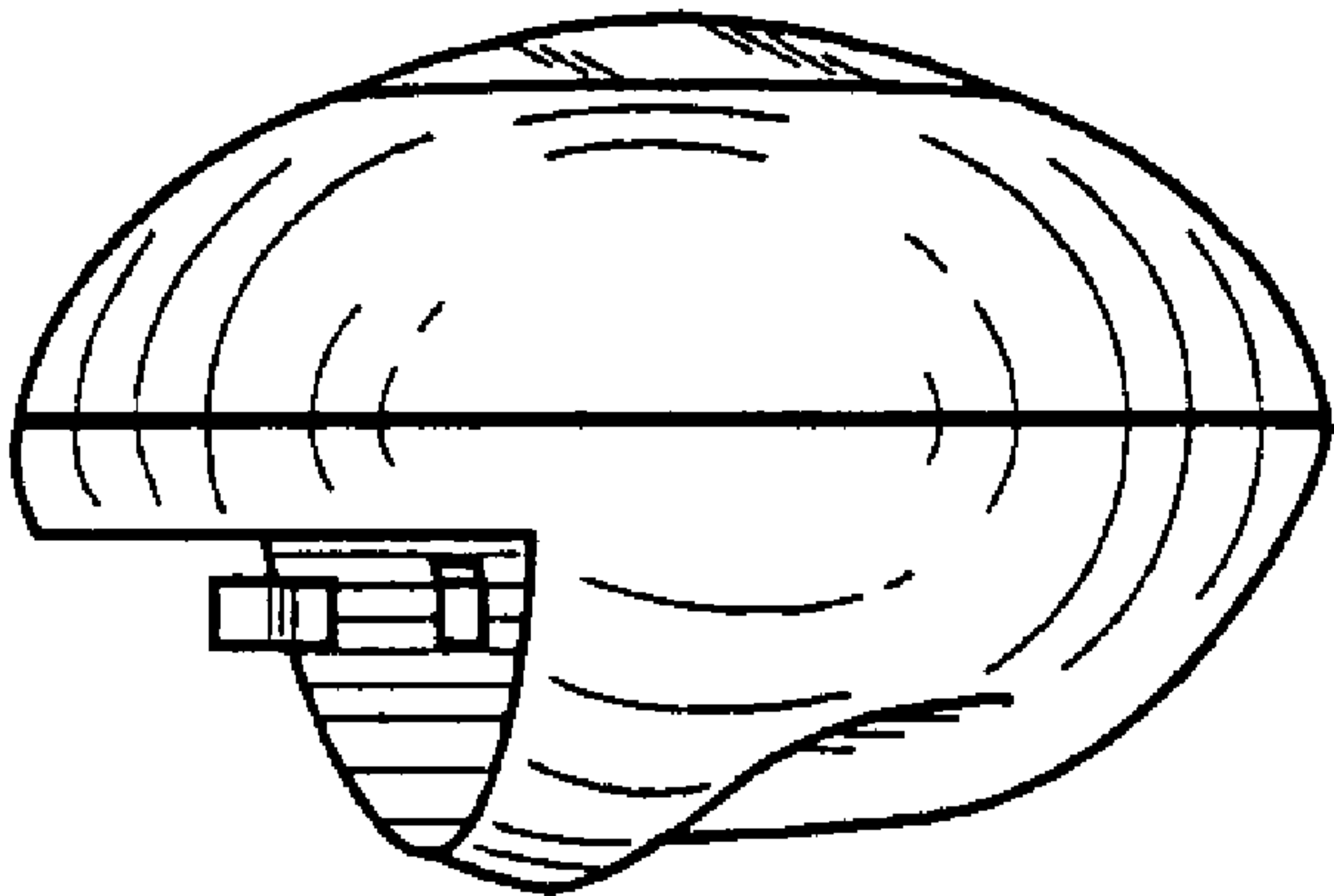

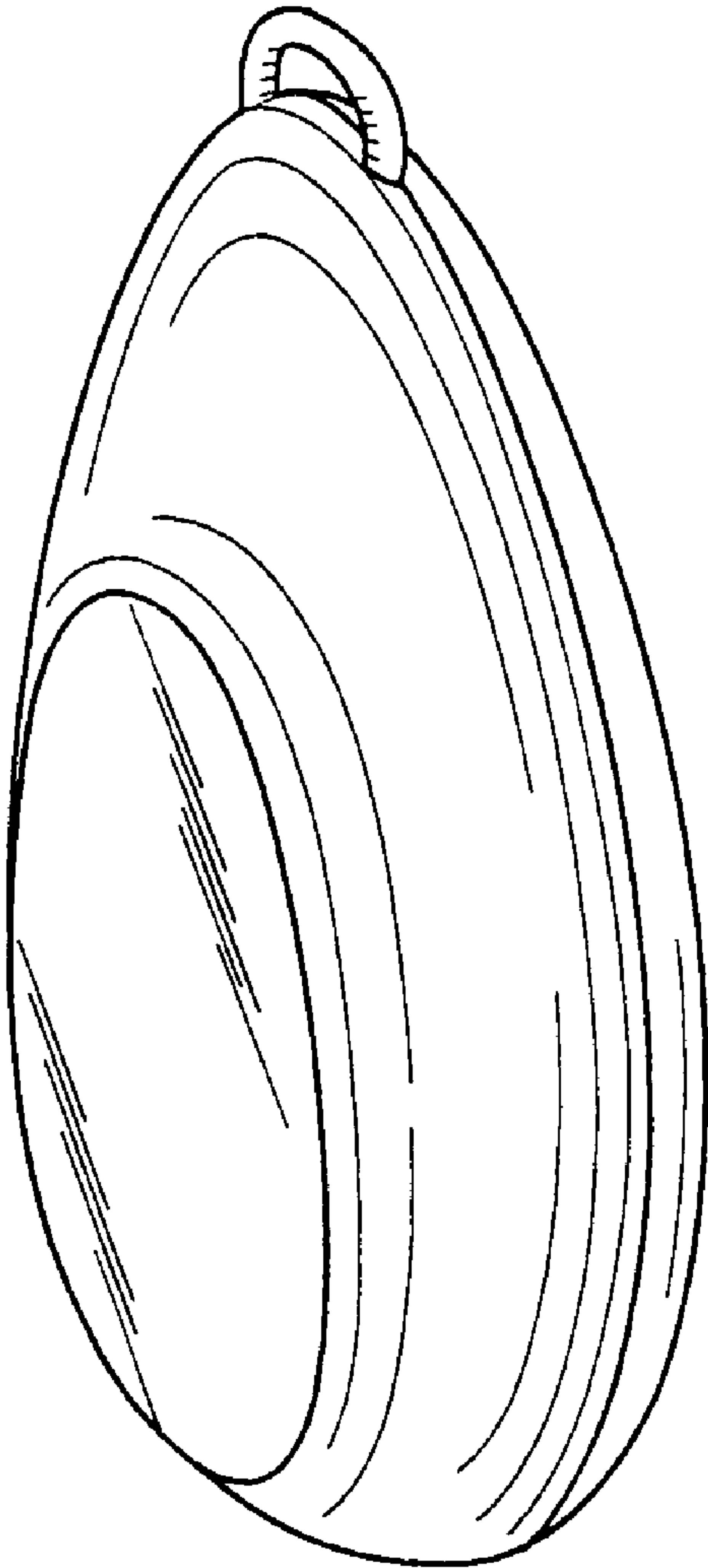

FIG. 3 is a back view of the embodiment of the golf club cover shown in FIG. 1;

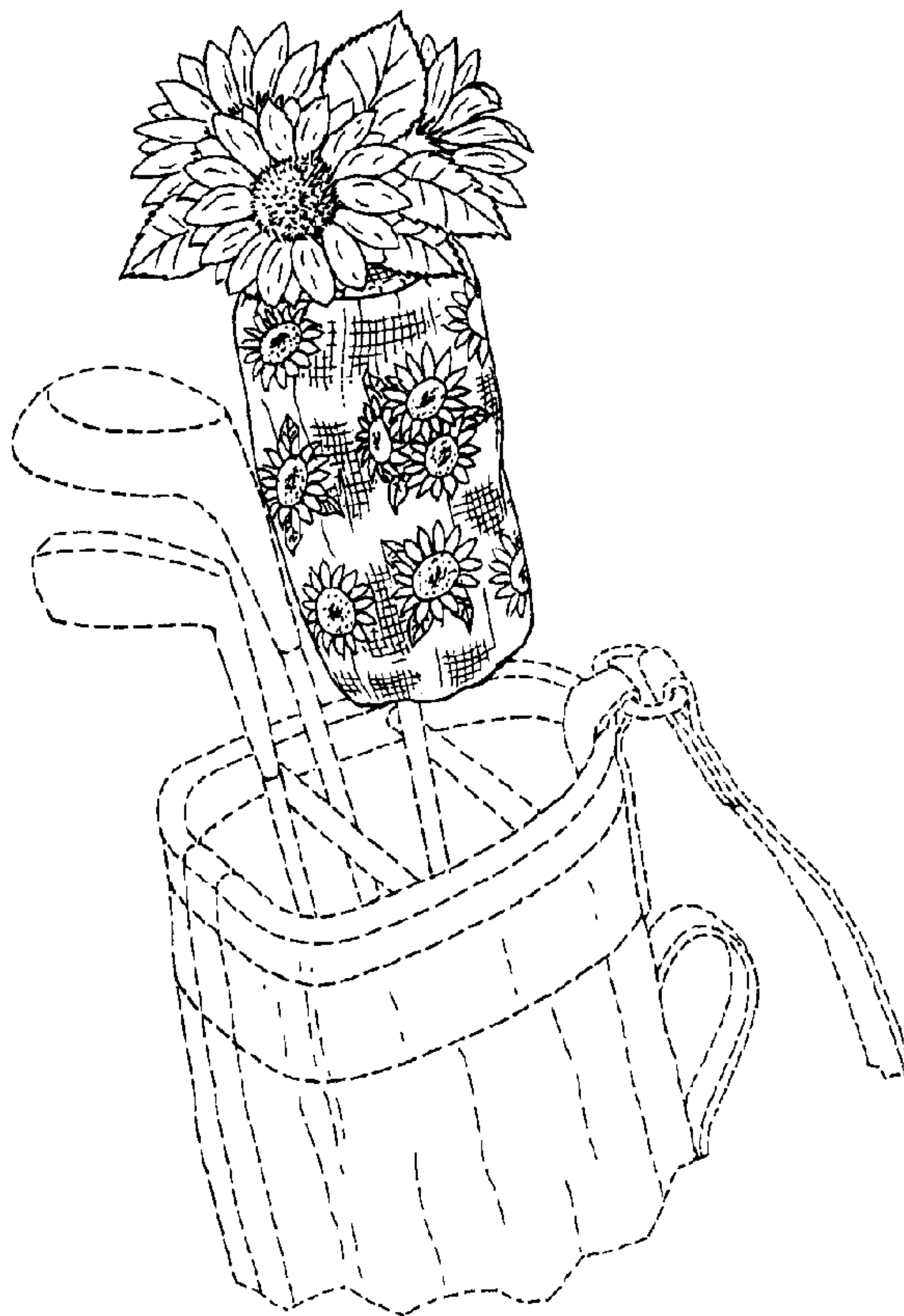
FIG. 4 is a right side view of the embodiment of the golf club cover shown in FIG. 1;

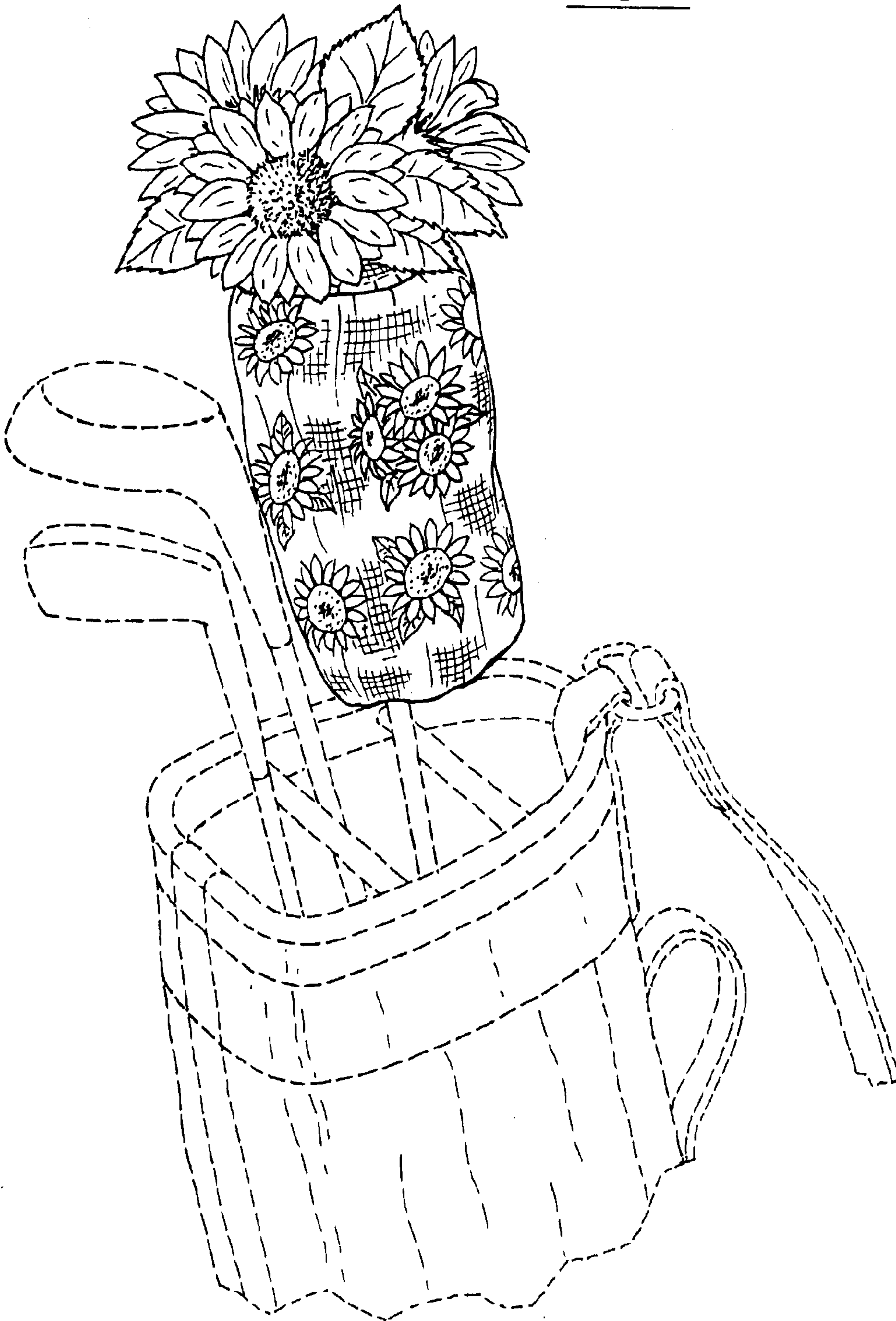

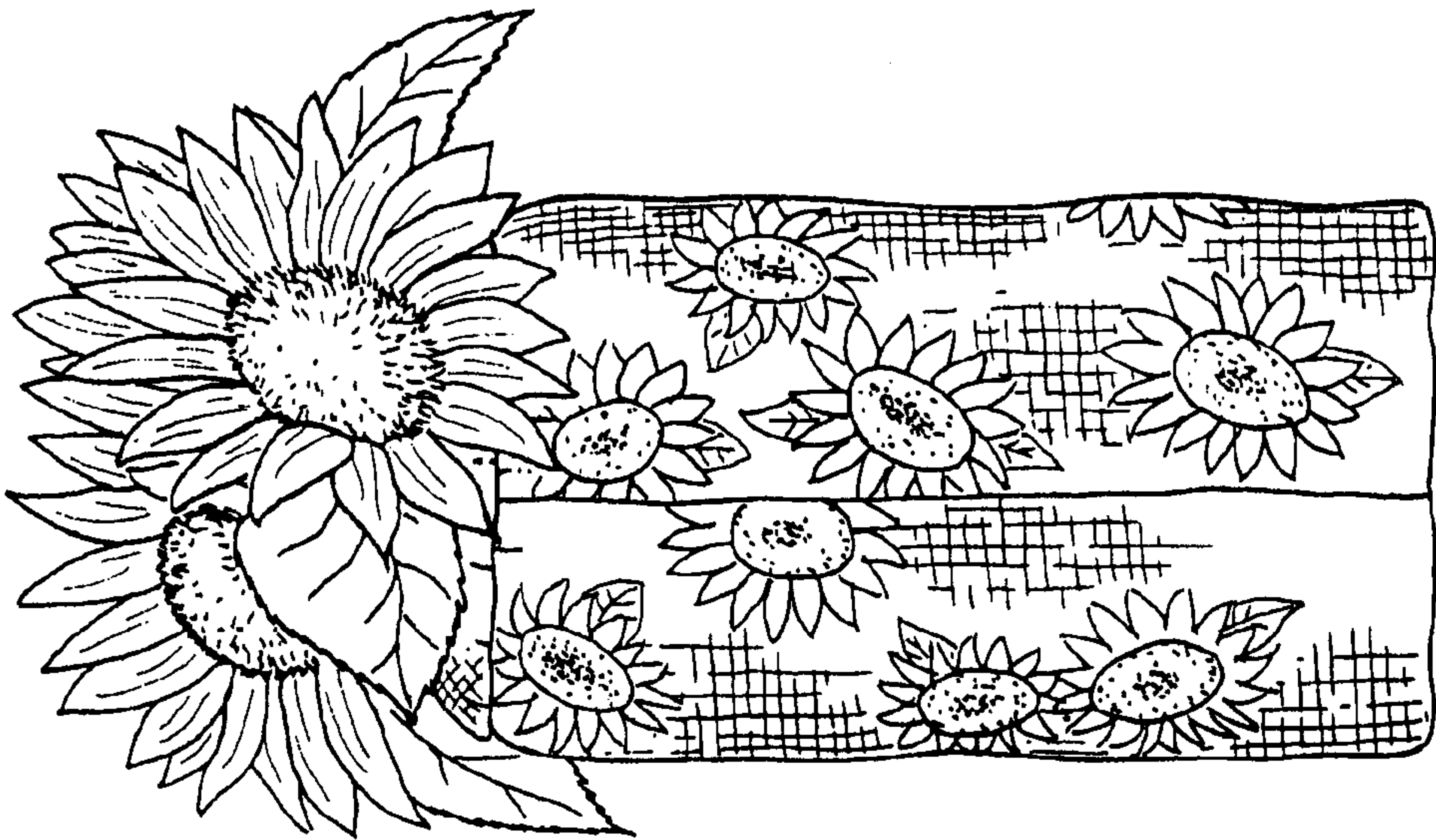

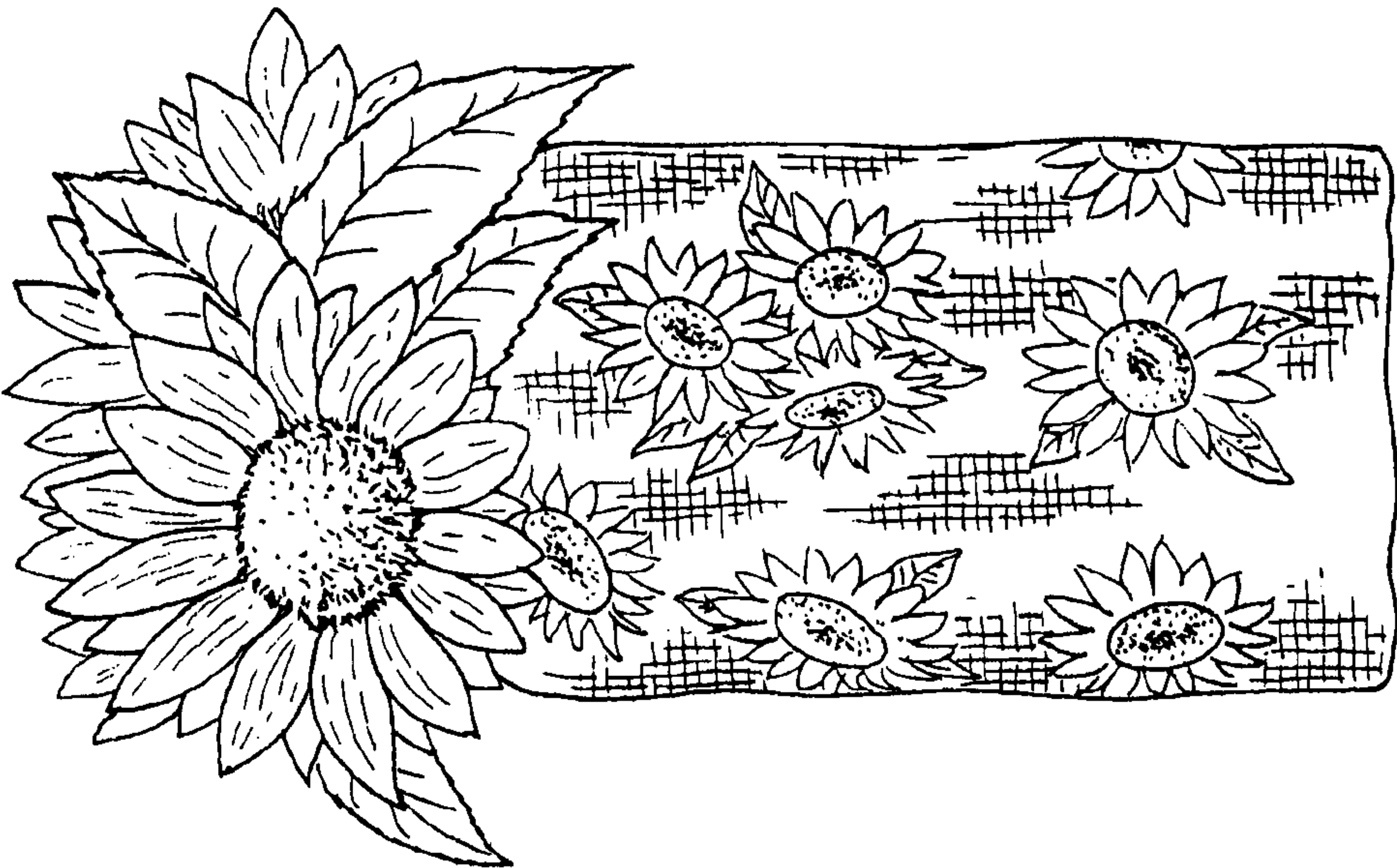

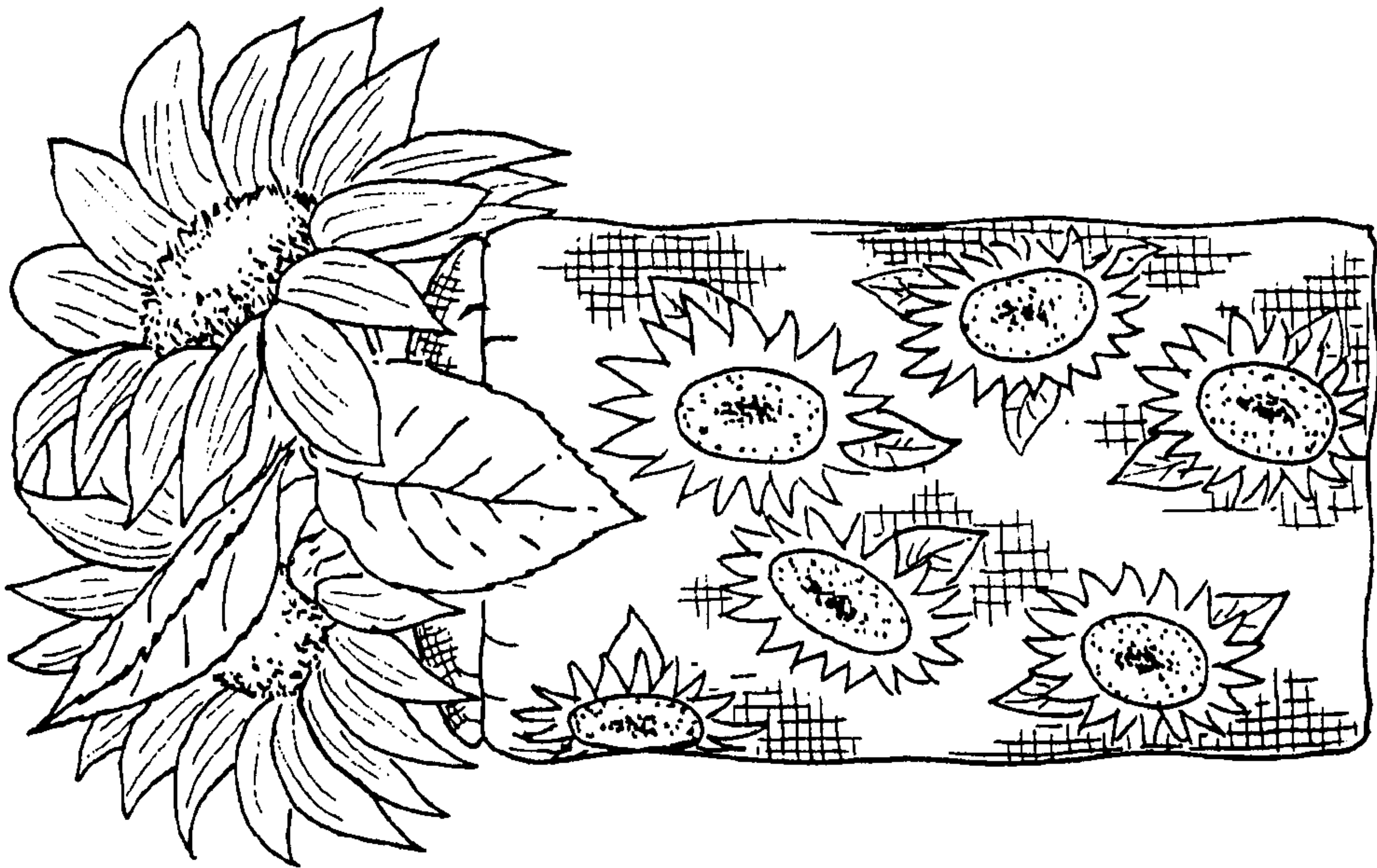

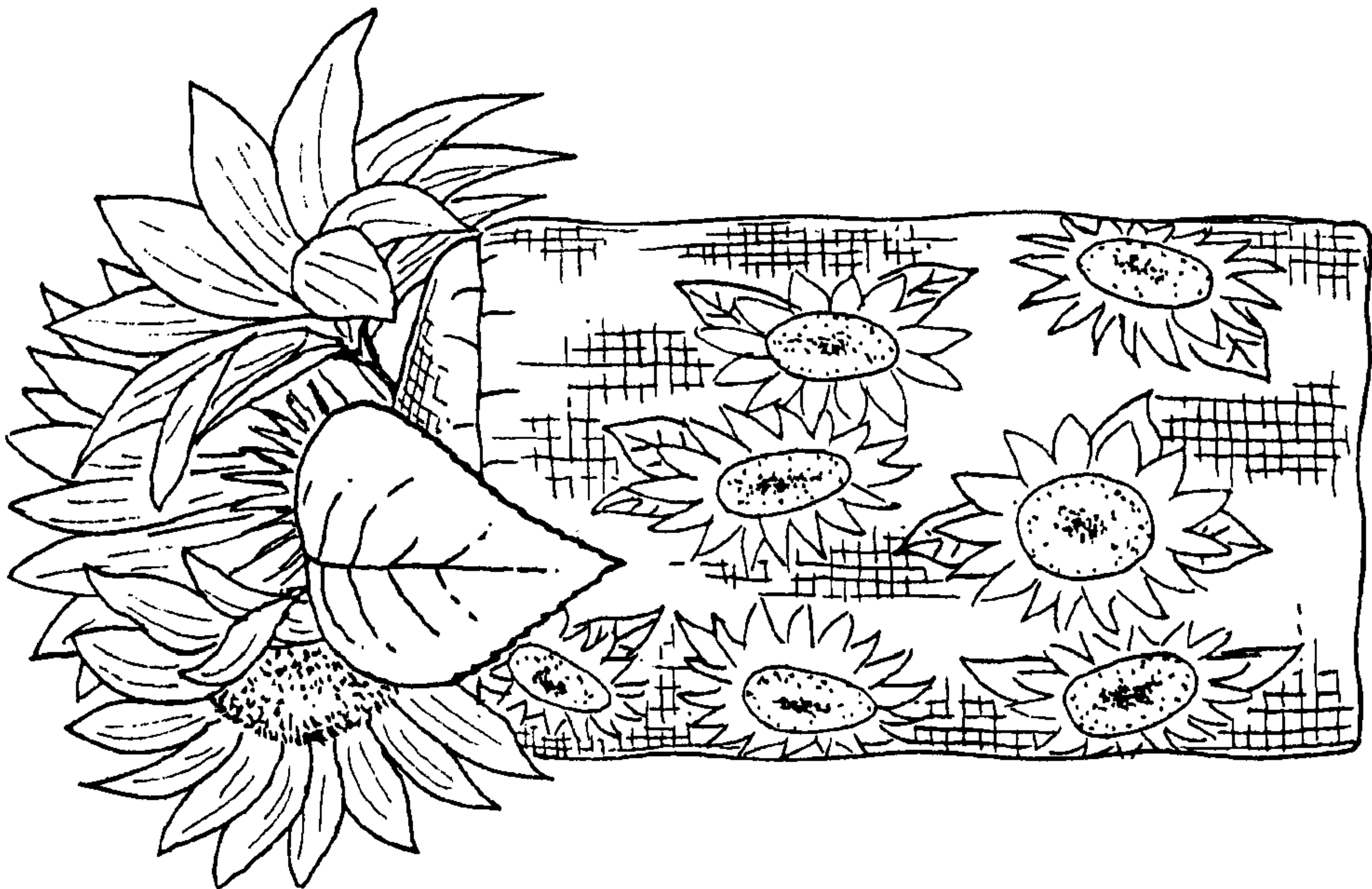

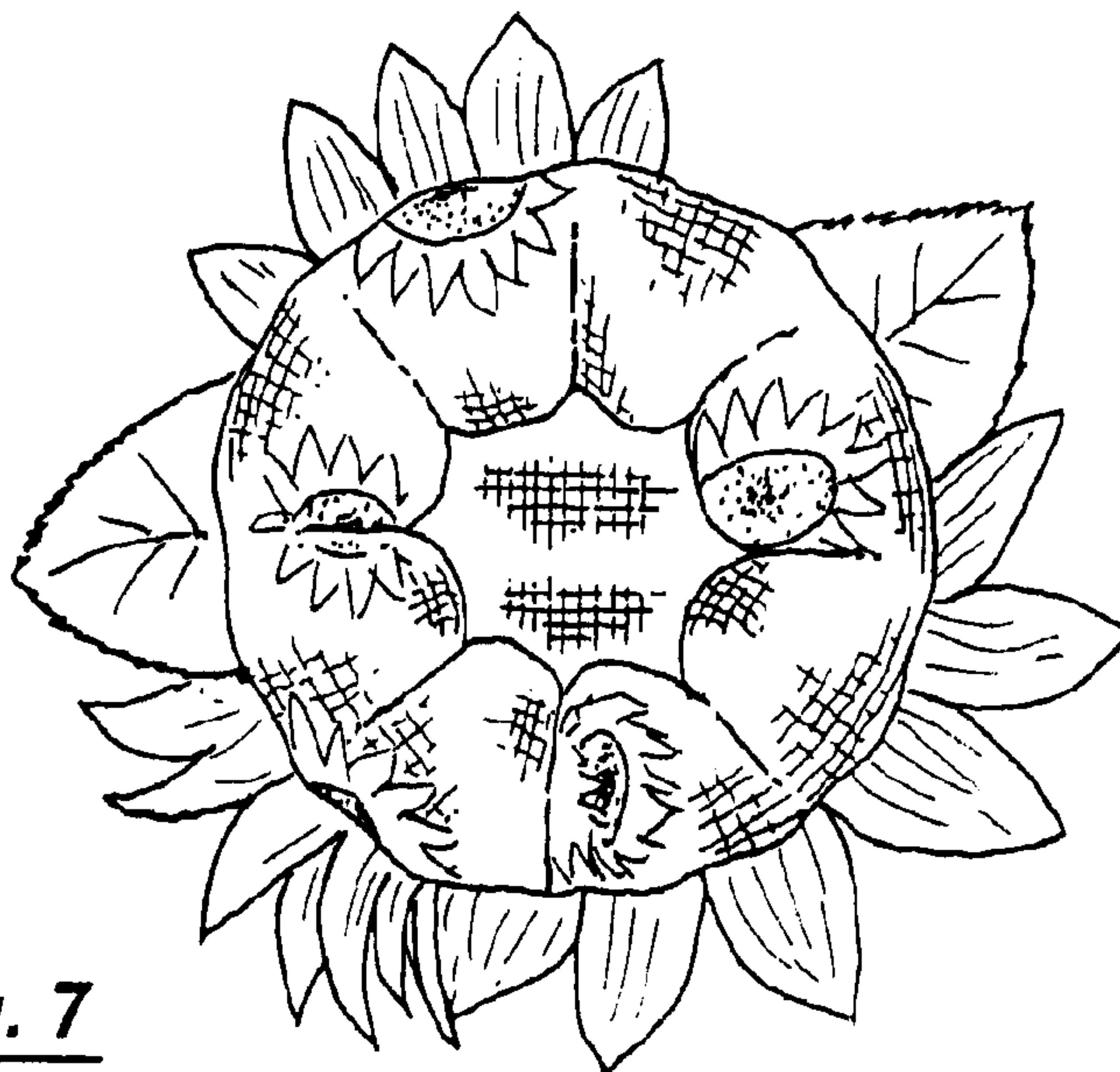
