**DESCRIPTION**

FIG. 1 is a front view of the container of the present invention;  
FIG. 2 is a right side view thereof;  
FIG. 3 is a back view thereof;  
FIG. 4 is a left side view thereof;  
FIG. 5 is the top plan view thereof;  
FIG. 6 is a bottom plan view thereof; and,  
FIG. 7 is a perspective view of the container of FIGS. 1–6, shown as part of a display.

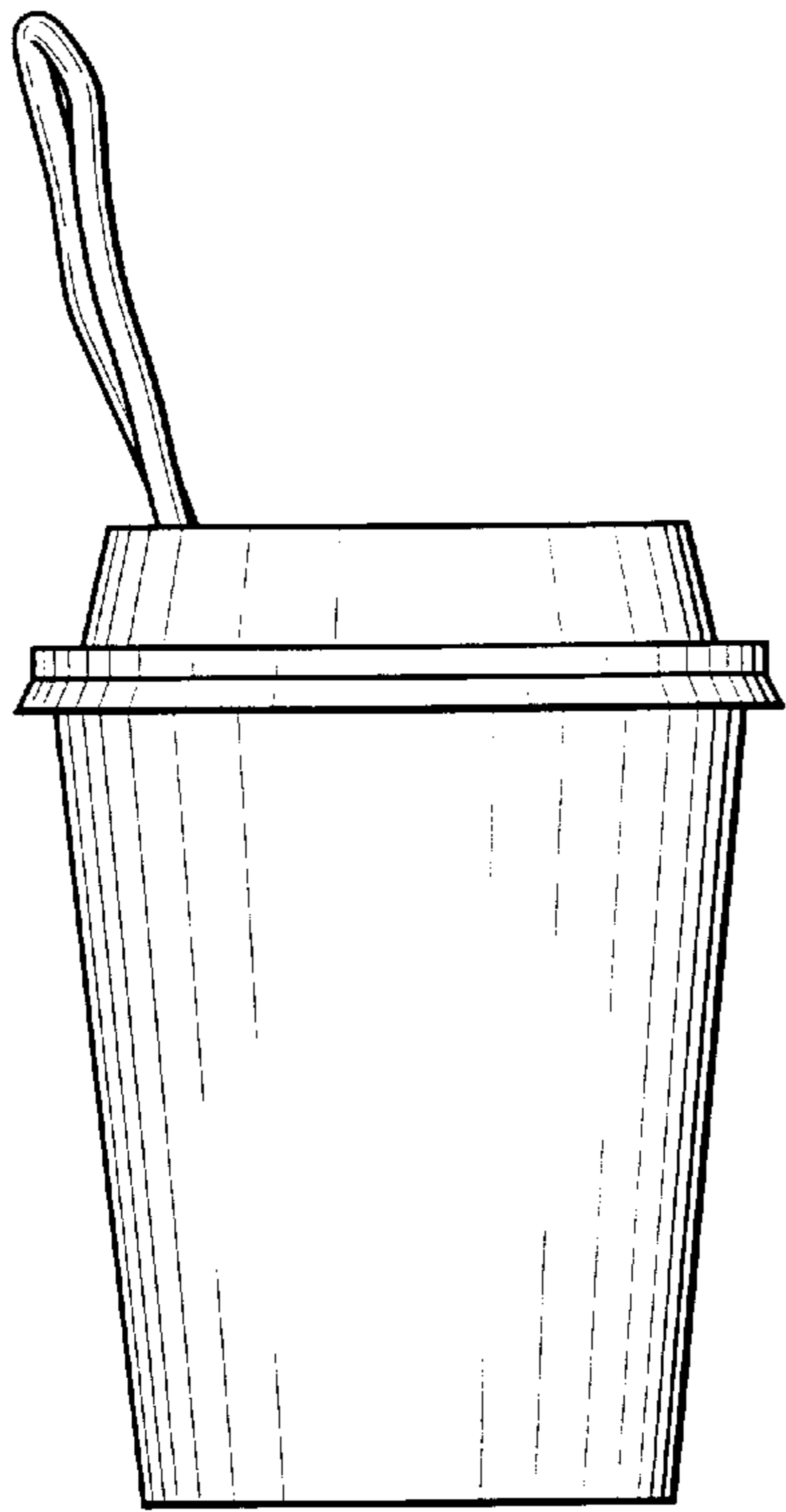

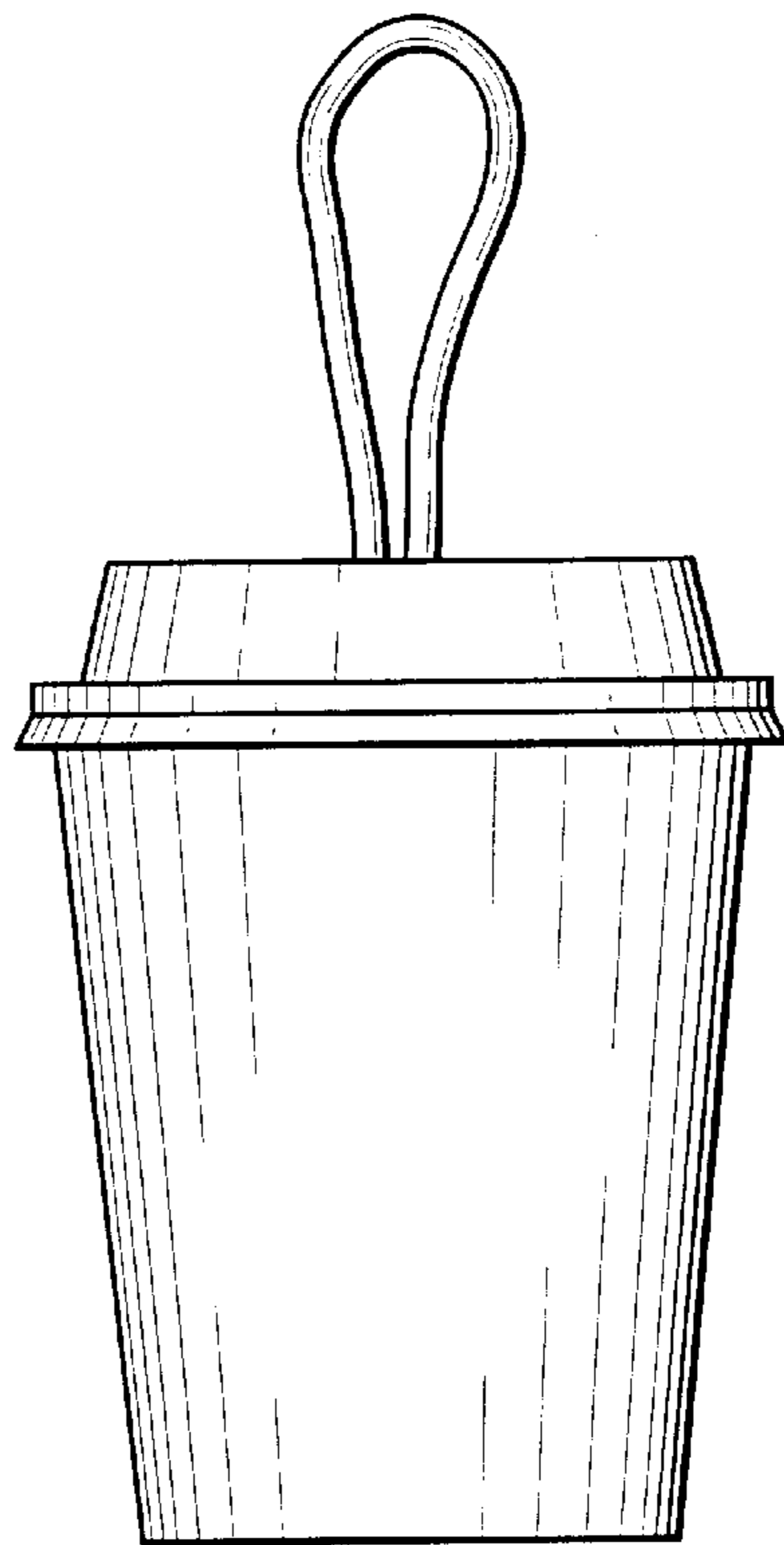

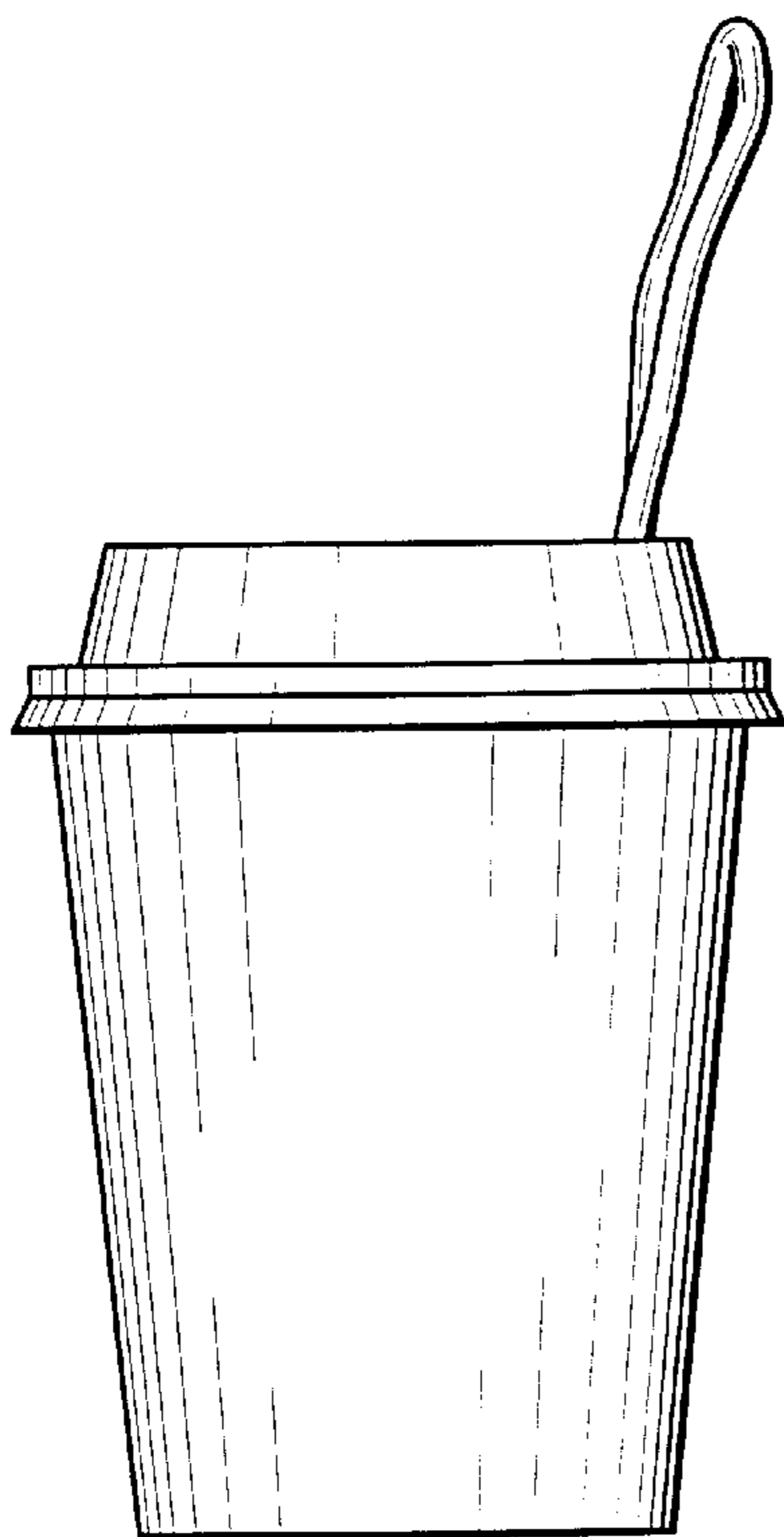

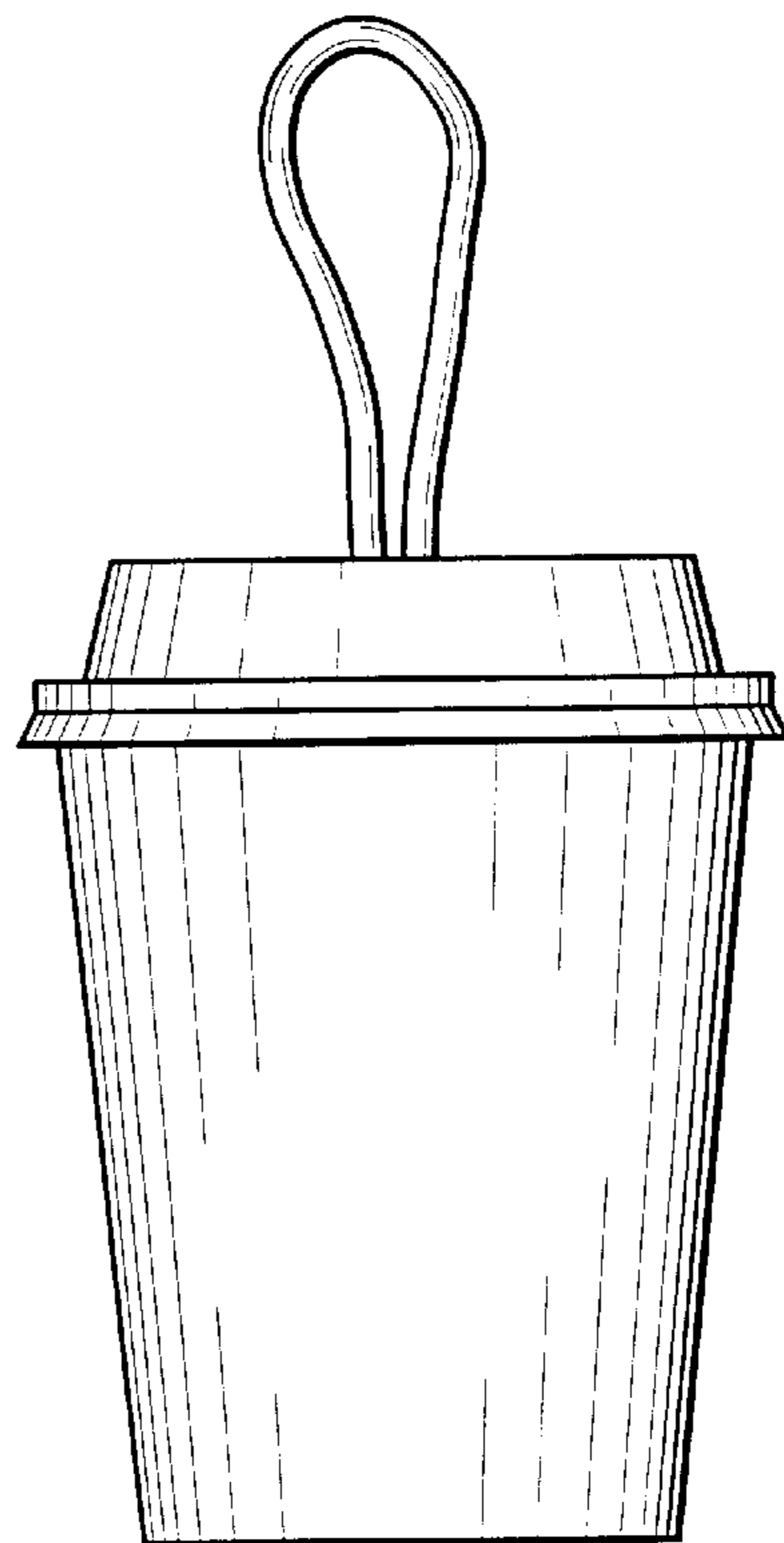

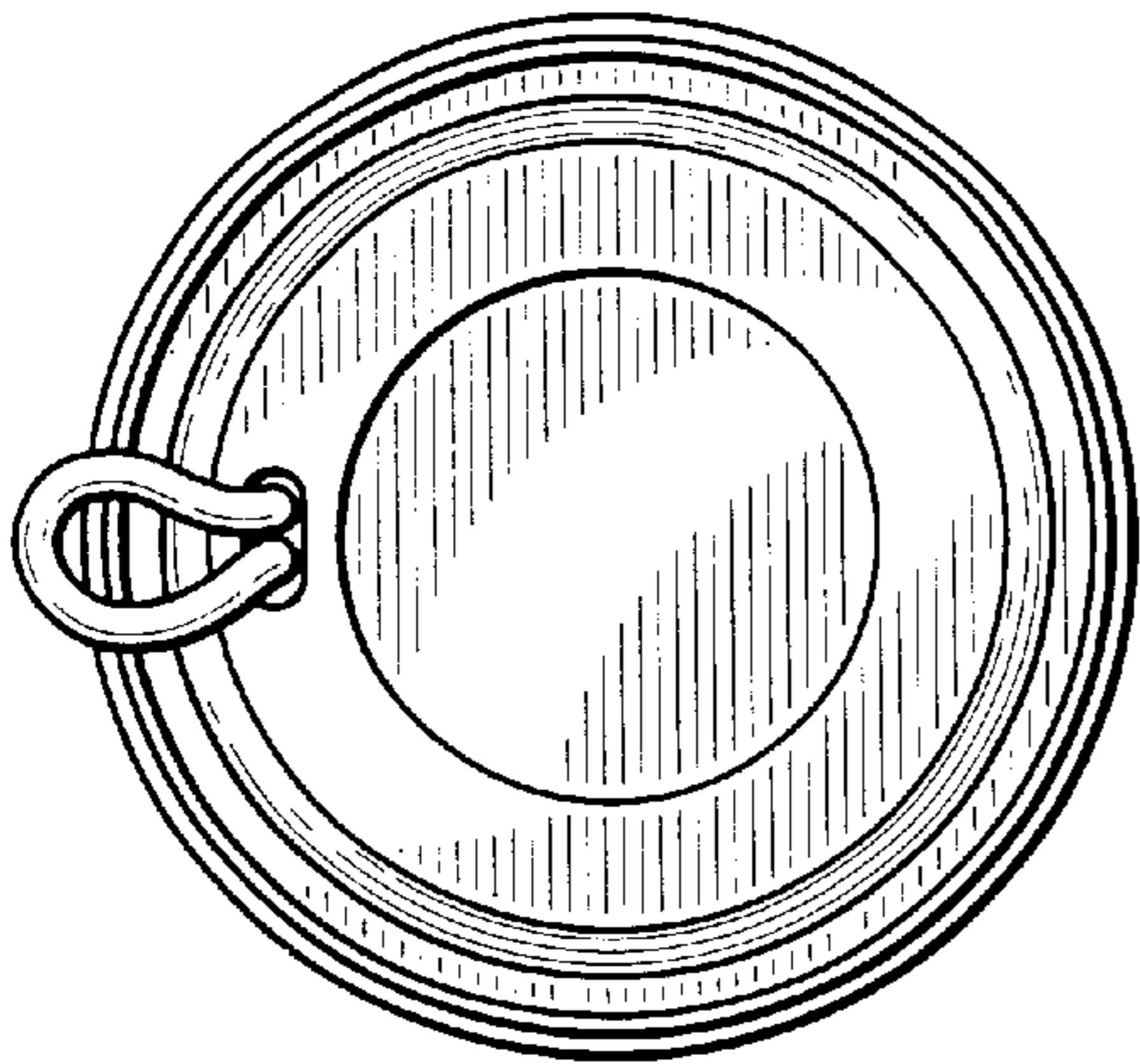

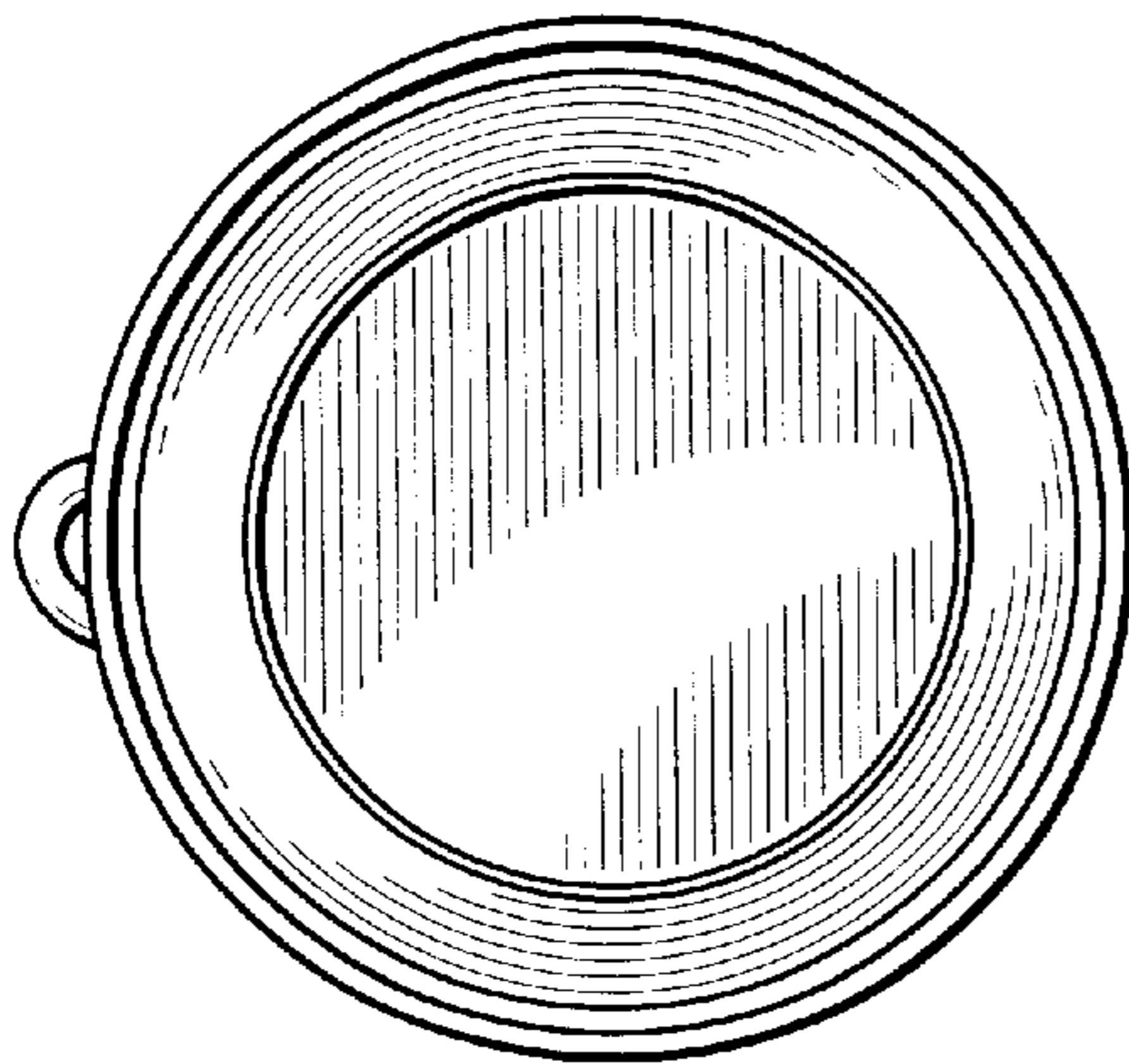
