FIG. 4 is a bottom view thereof;

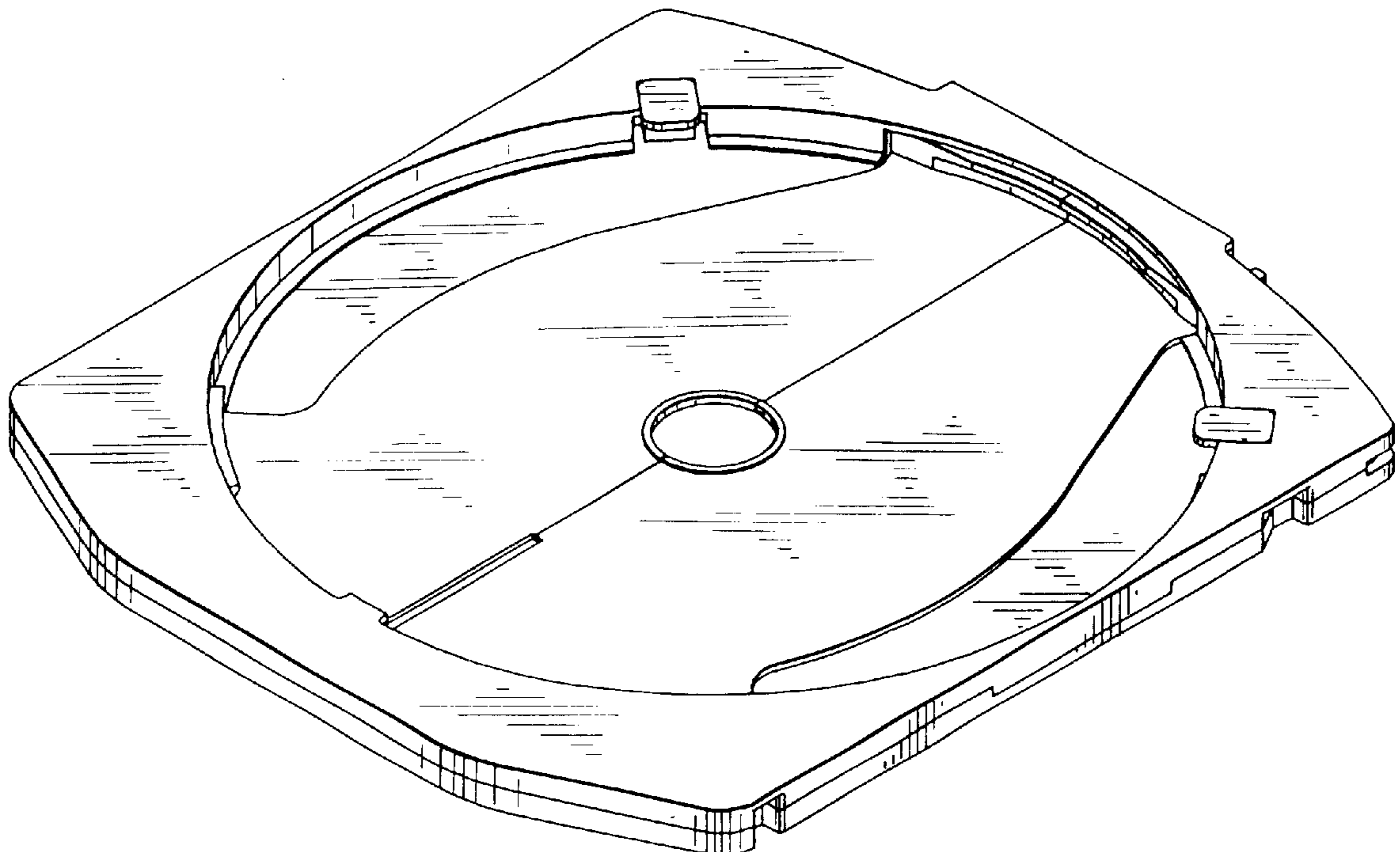
FIG. 5 is a left side view thereof;

FIG. 6 is a right side view thereof;

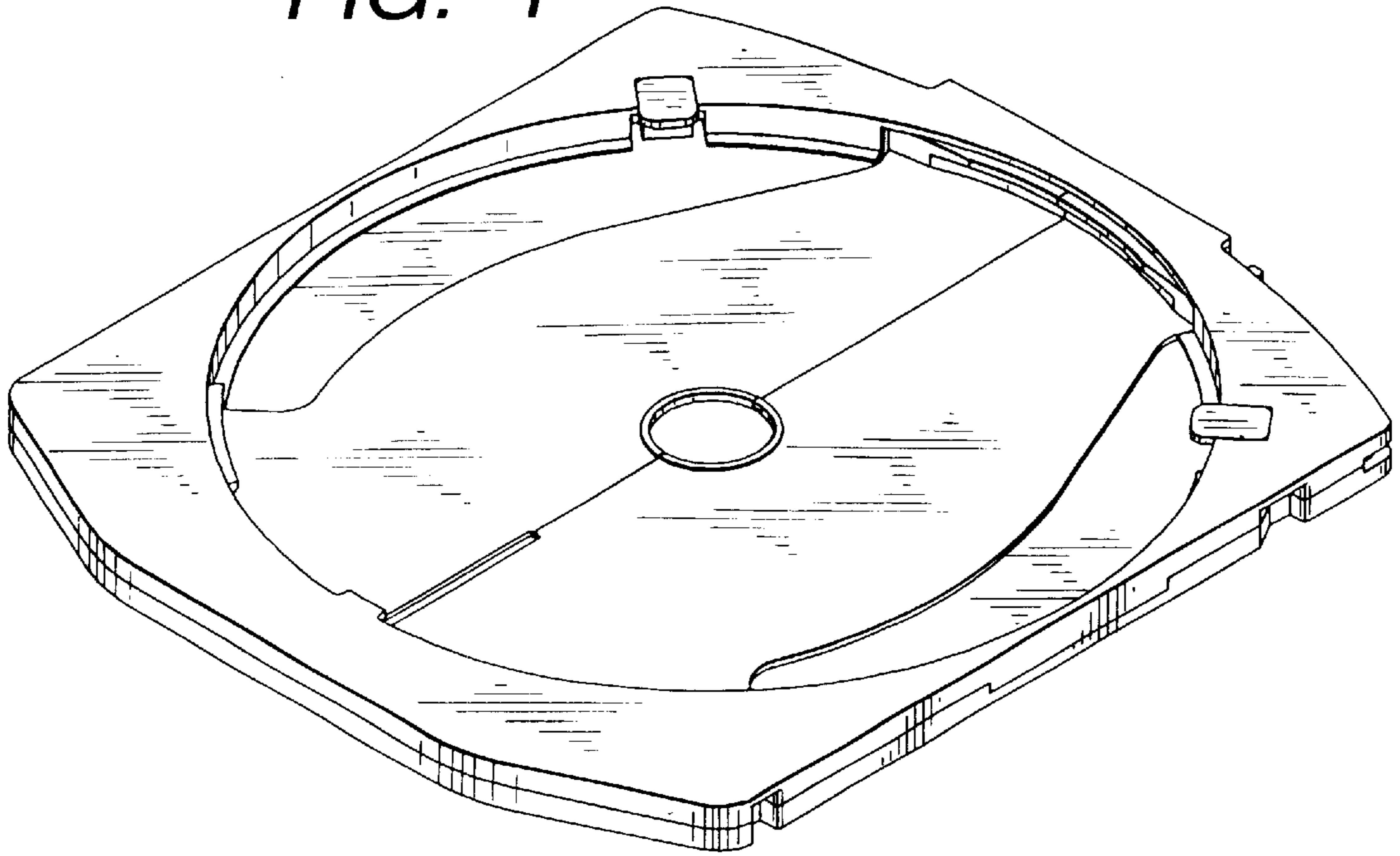
FIG. 7 is a rear view thereof; and,

FIG. 8 is a perspective view thereof, the shutter is shown in open condition, the rear view is similar to FIG. 7 except that the middle portion would be an opening.

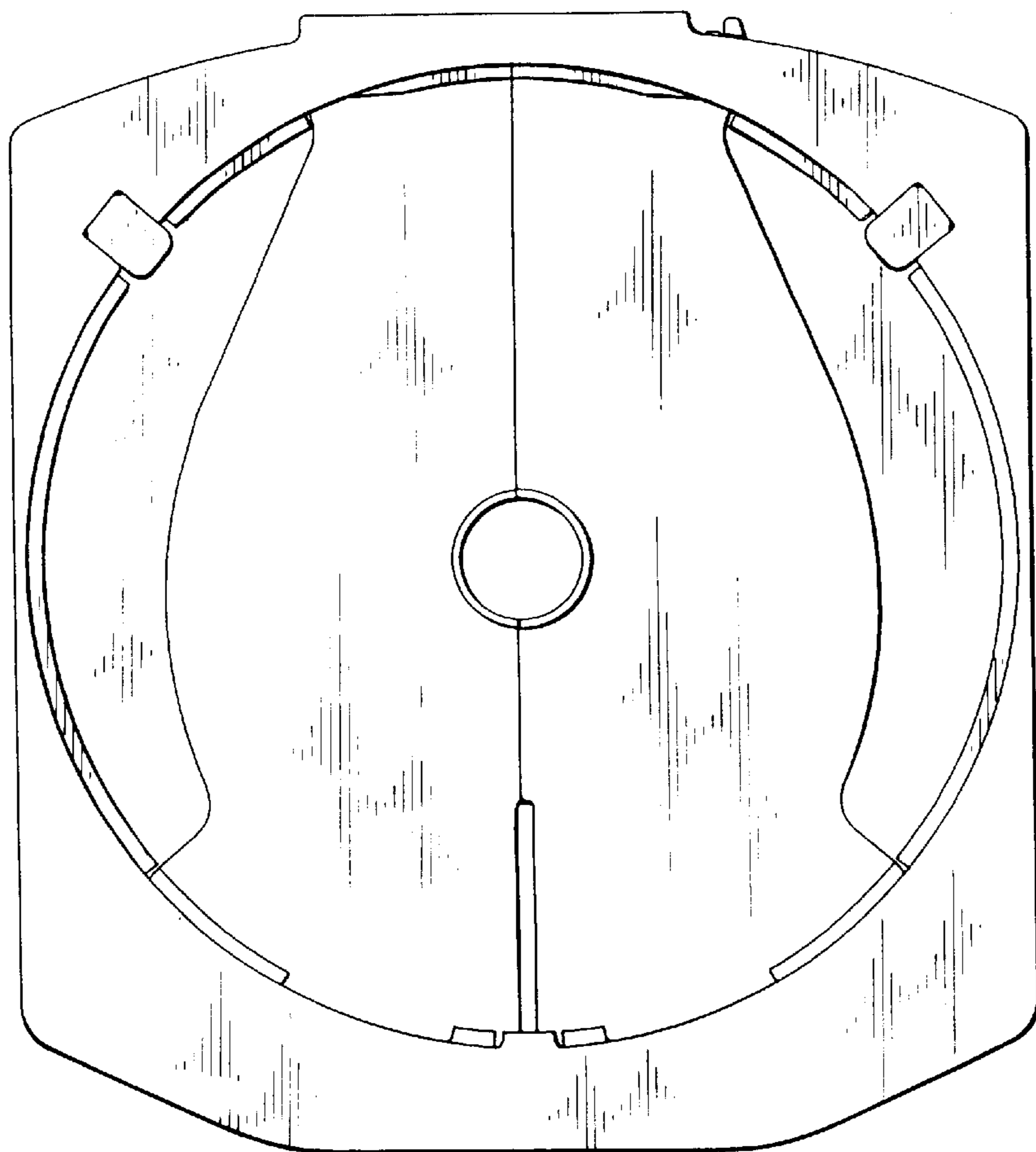

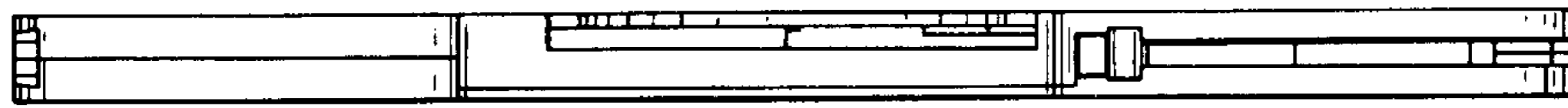

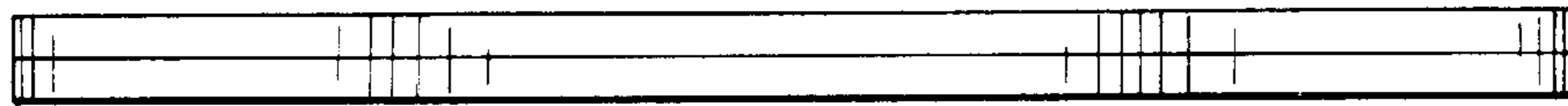

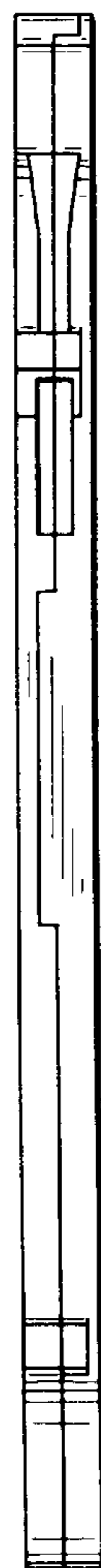

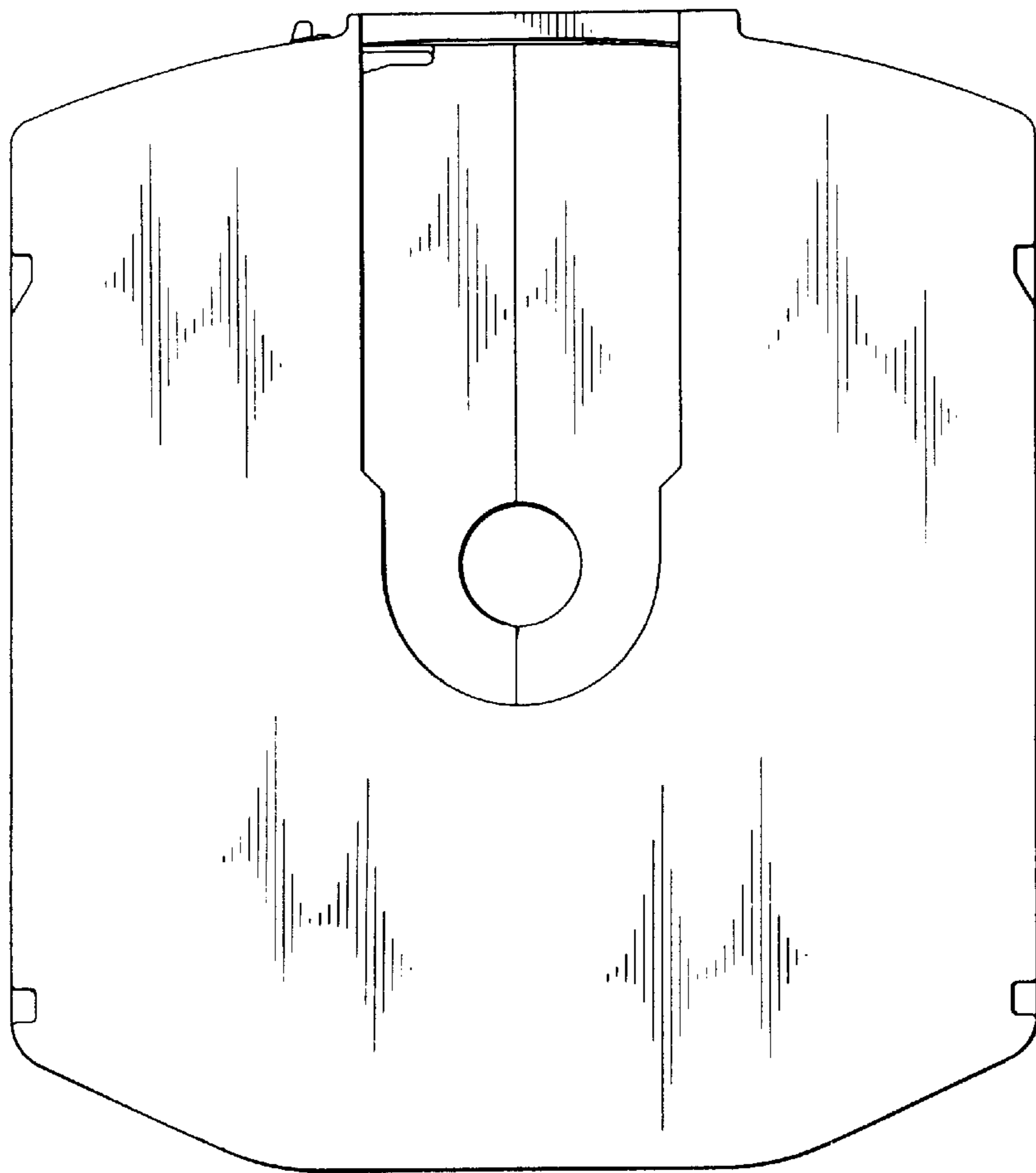
