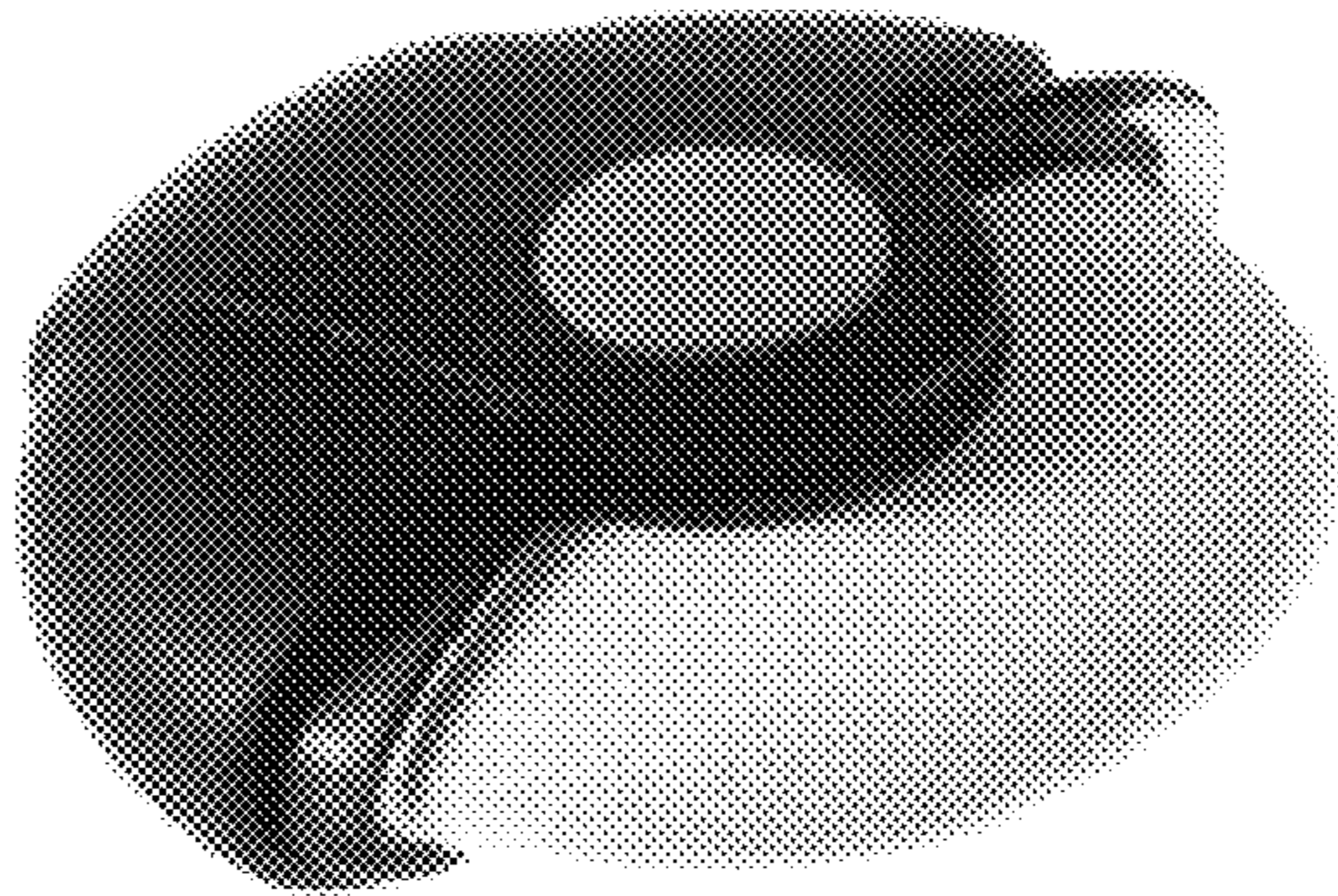
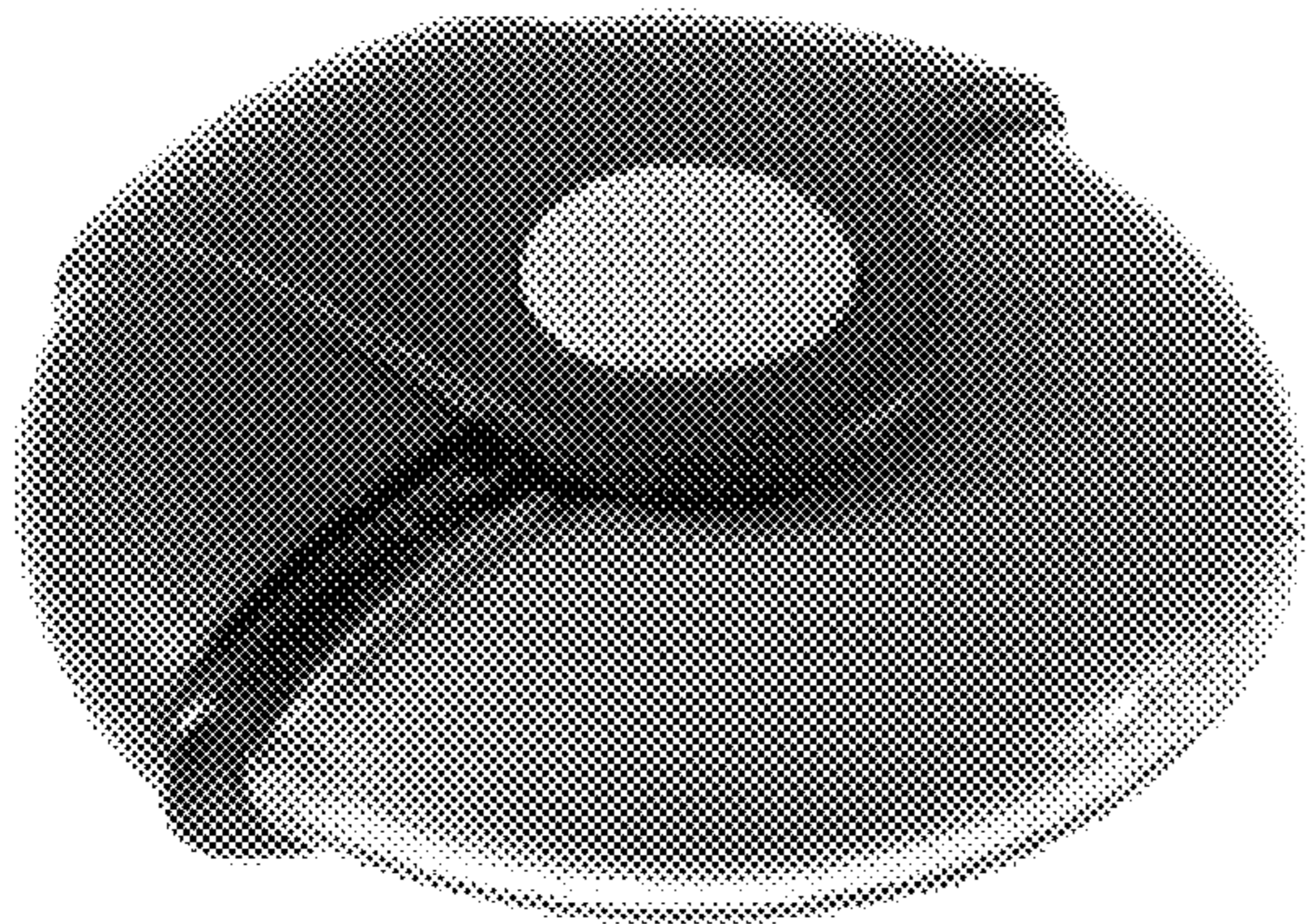
(57) **CLAIM**

**DESCRIPTION**

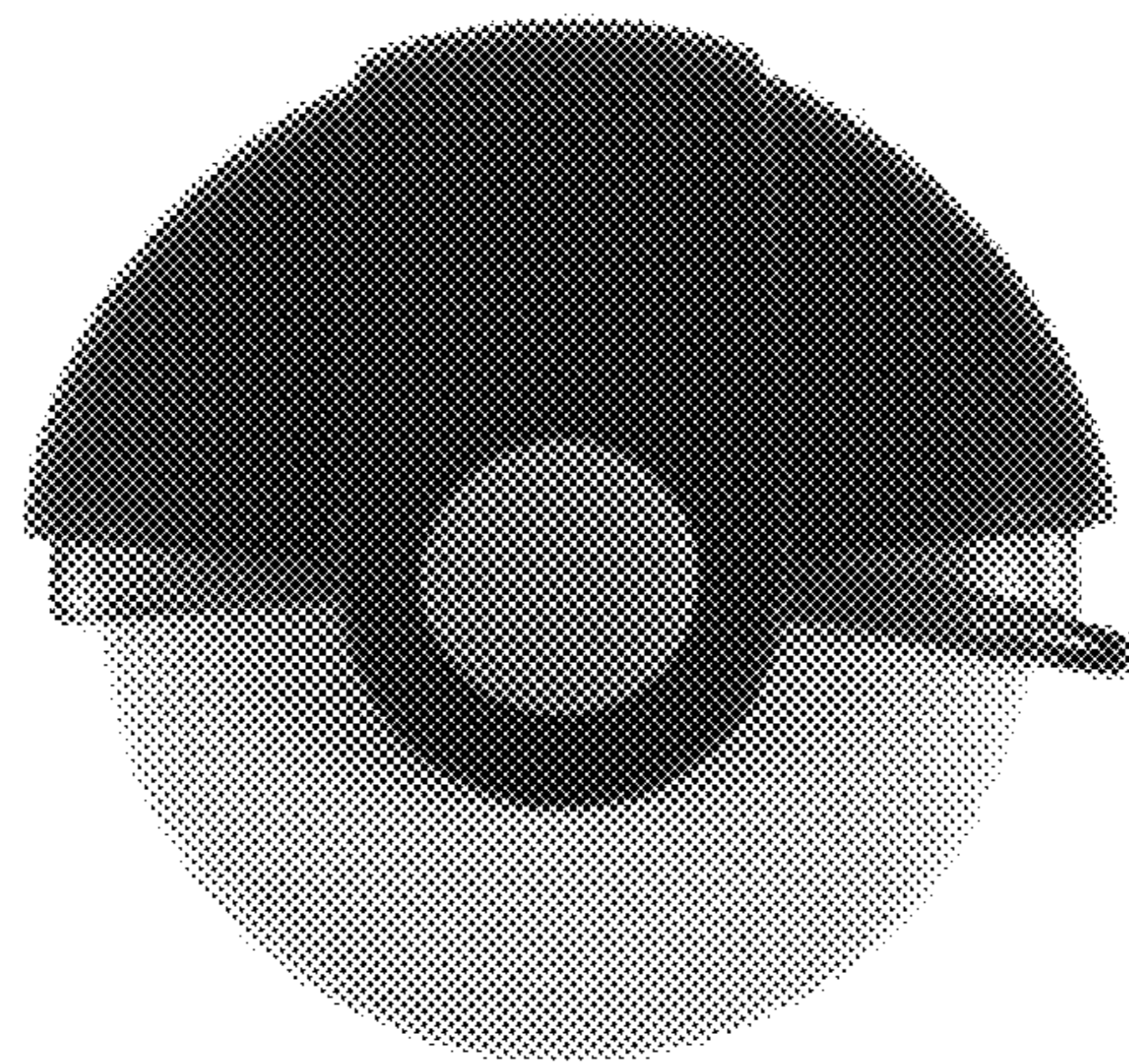
FIG. 1 is a top, front and side perspective view of an eraser, showing my new design;

 FIG. 4 is a side elevational view thereof taken from the left of FIG. 2;

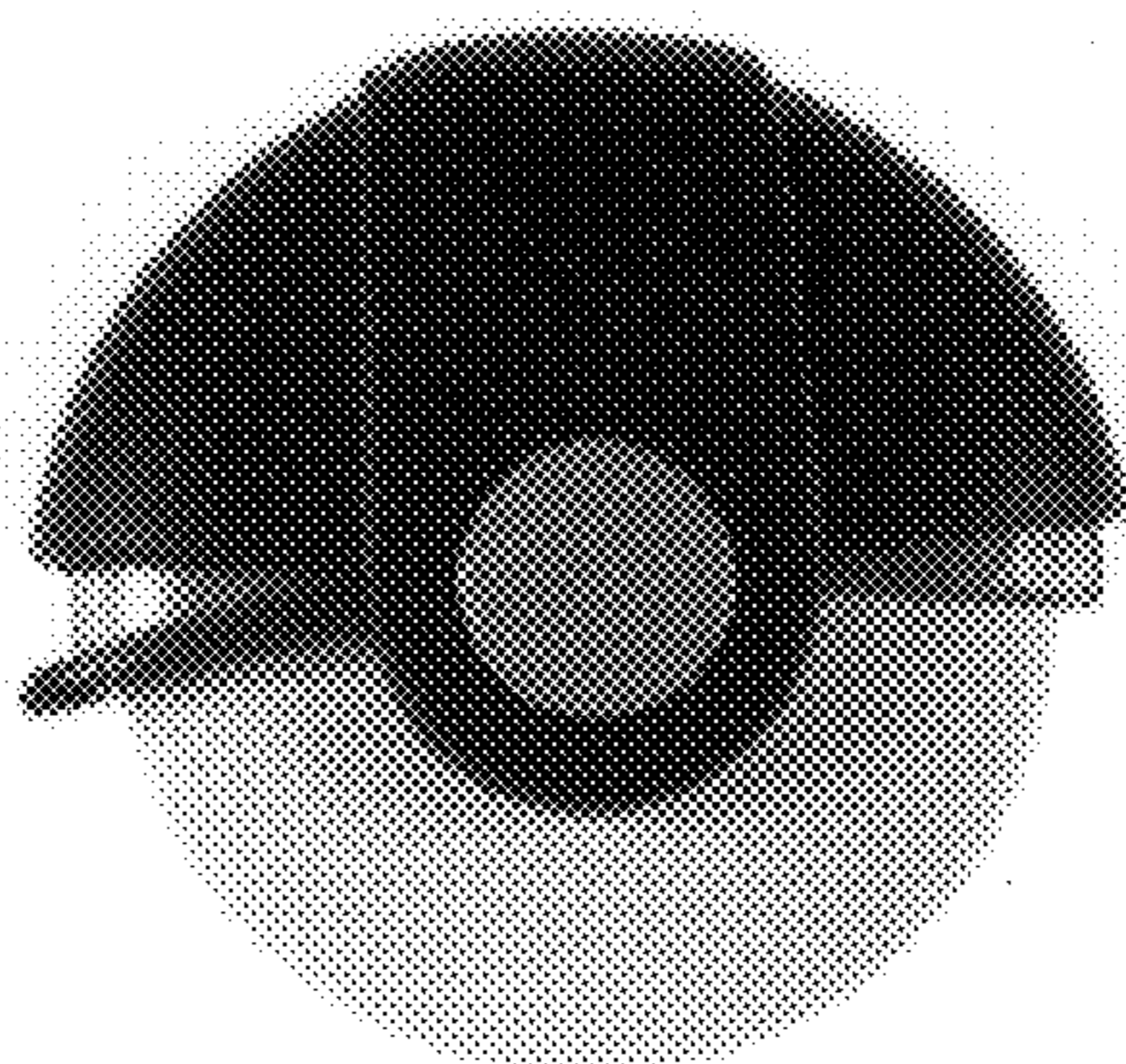

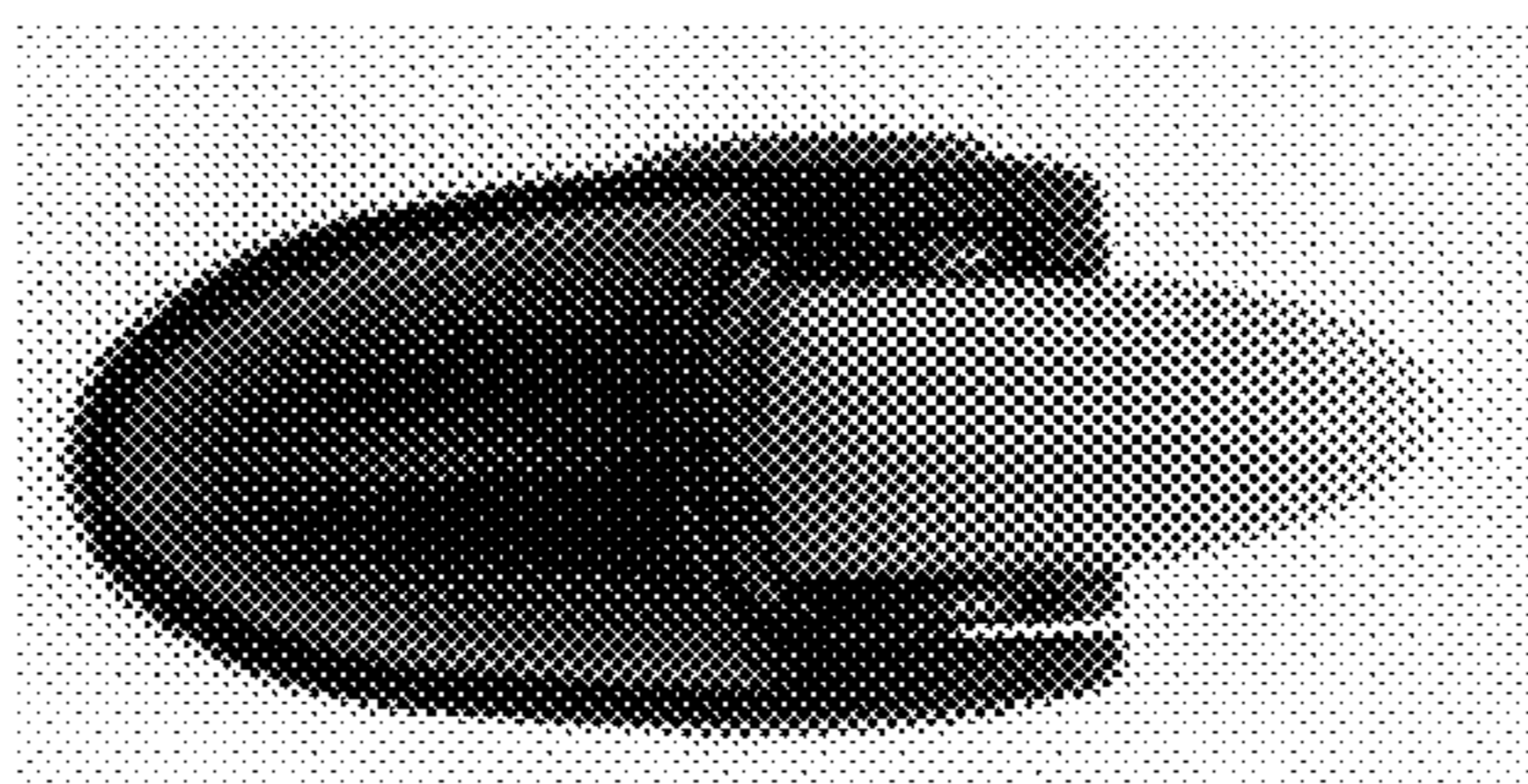
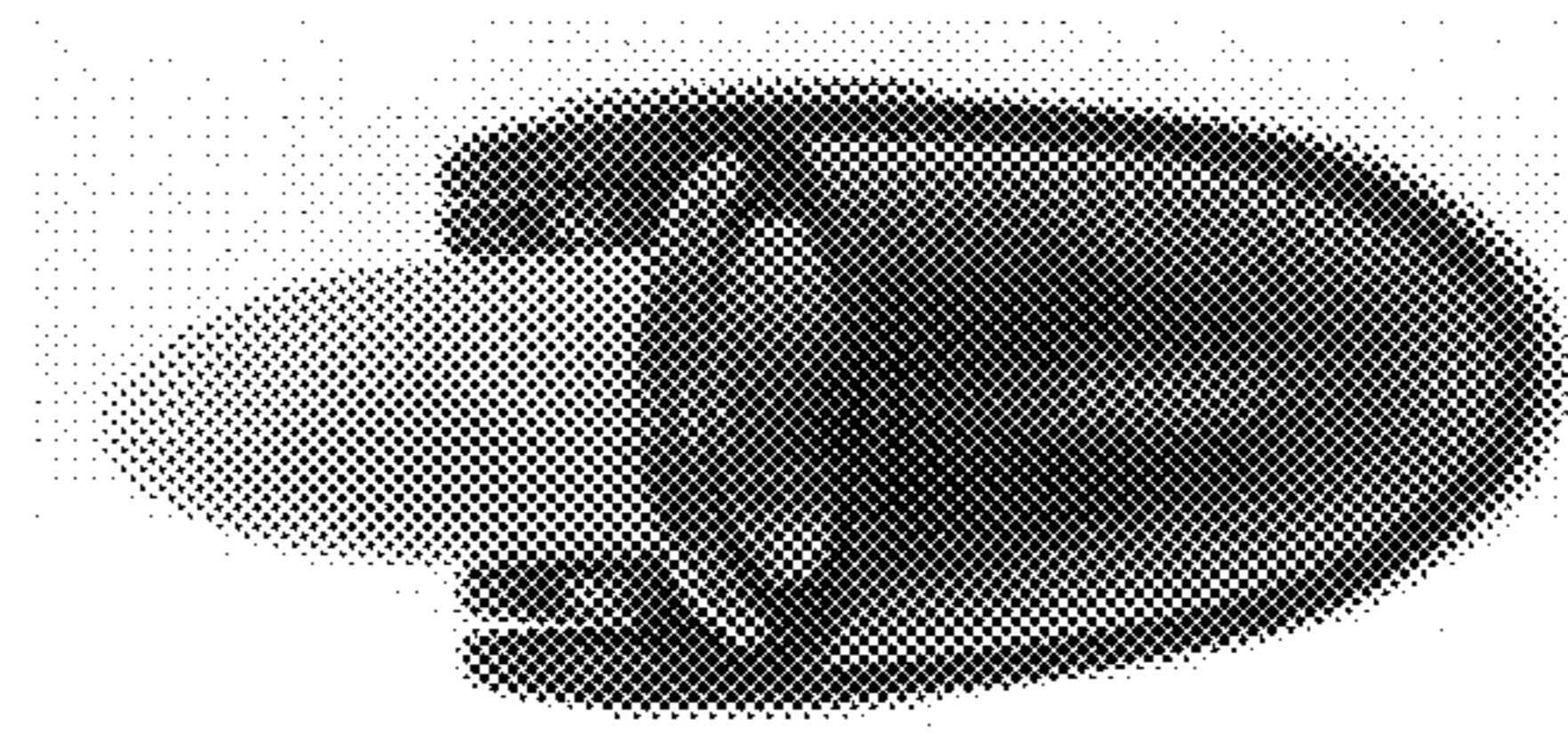
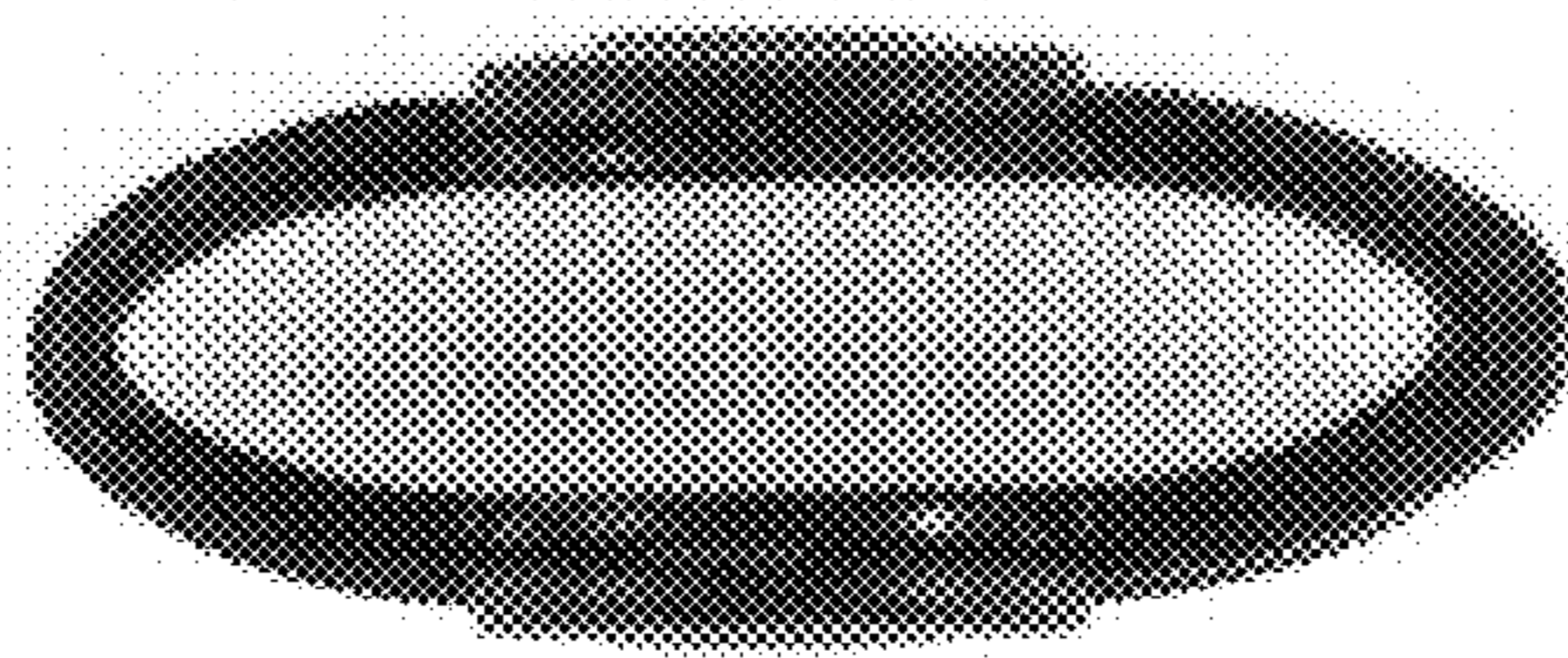


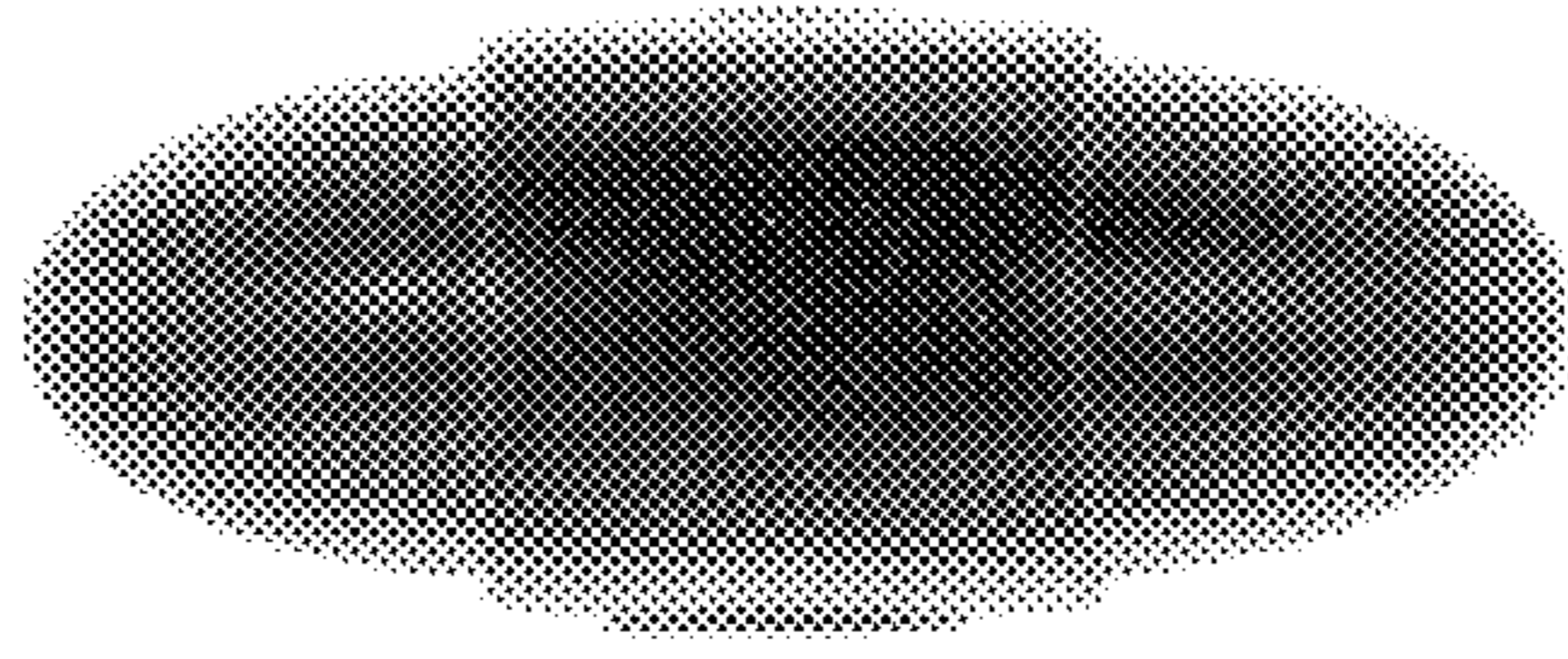

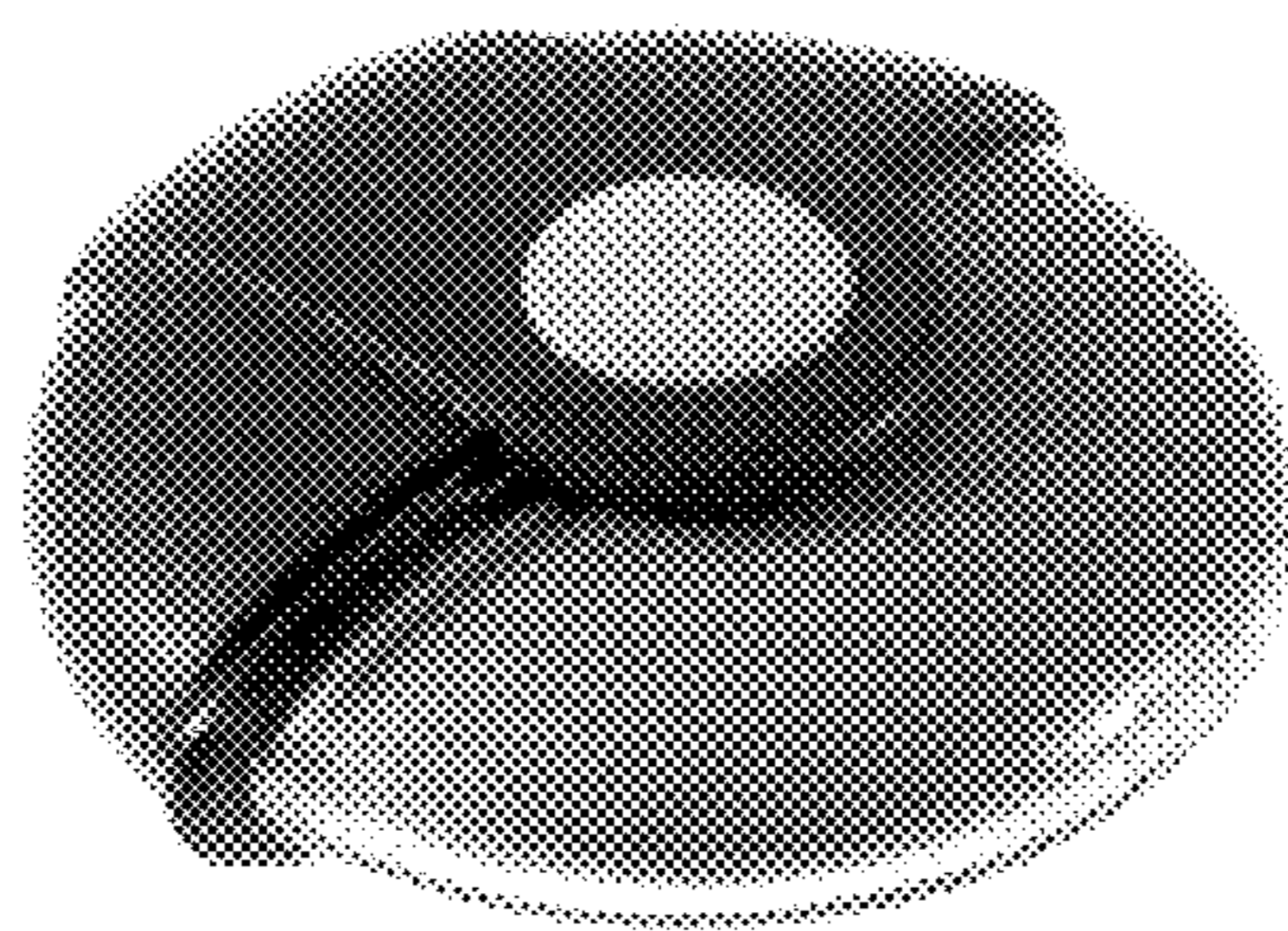
