(57) **CLAIM**

We claim the ornamental design for a golf club head, as shown and described.

**DESCRIPTION**

FIG. 1 is a side view of a golf club head of the present new design.

FIG. 2 is a bottom view of the golf club head of FIG. 1.

FIG. 3 is a rear view of the golf club head of FIG. 1; and, FIG. 4 is a top view of the golf club head of FIG. 1.

The ornamental design that is claimed is shown in solid lines in the drawings. The broken (dashed) lines shown in FIGS. 1 through 4 are included for the purpose of illustrating break lines and environmental elements only, and form no part of the claimed design.

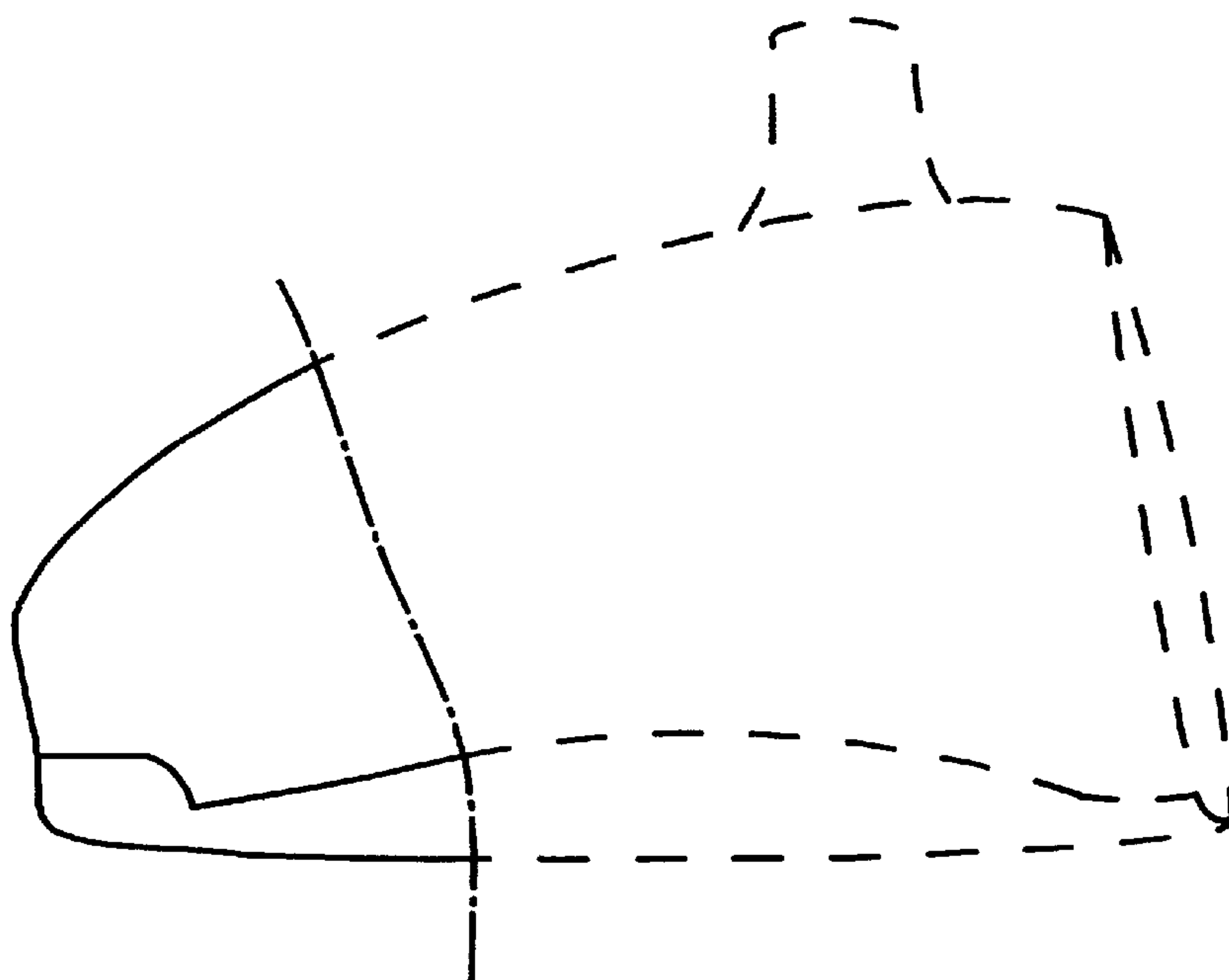

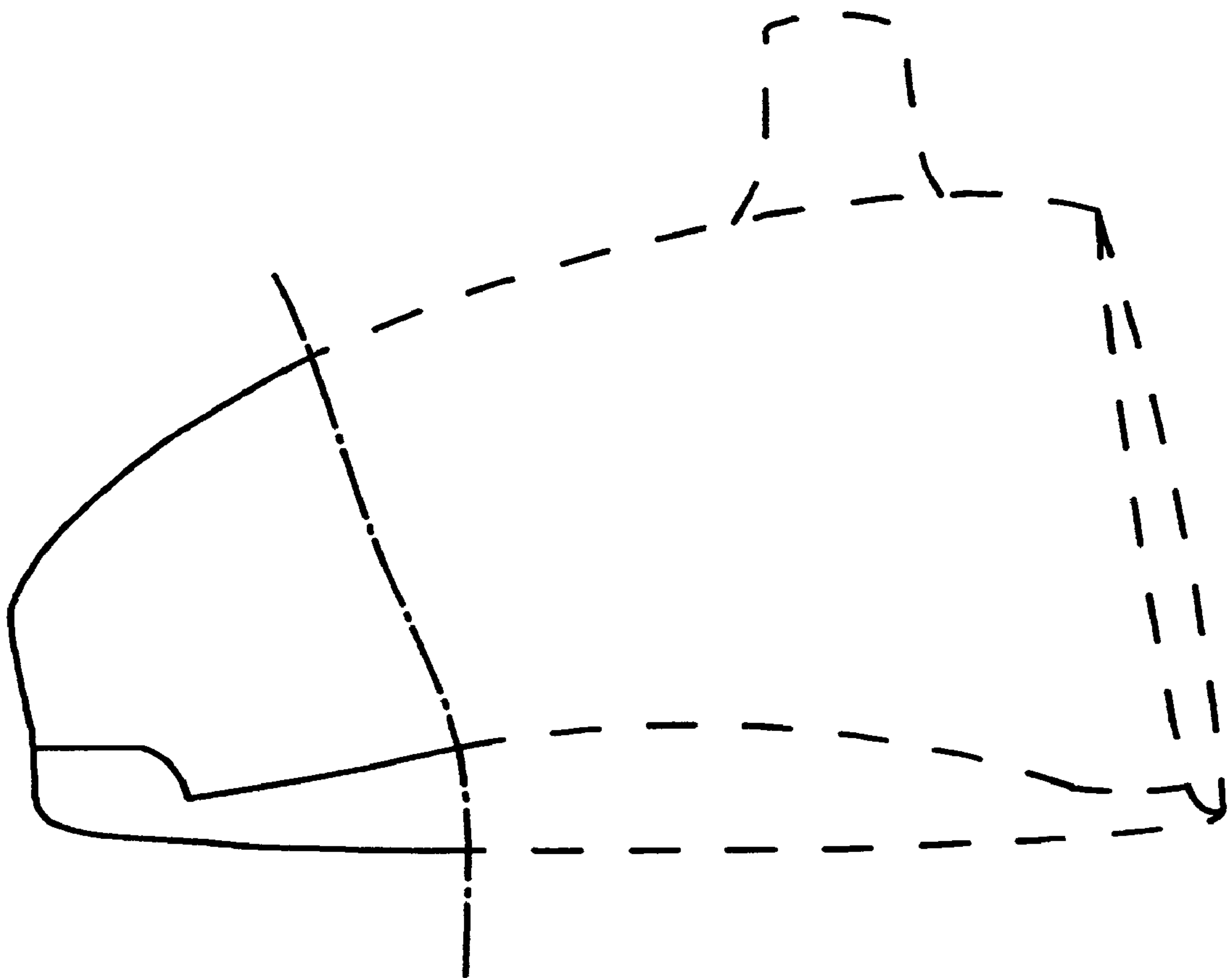

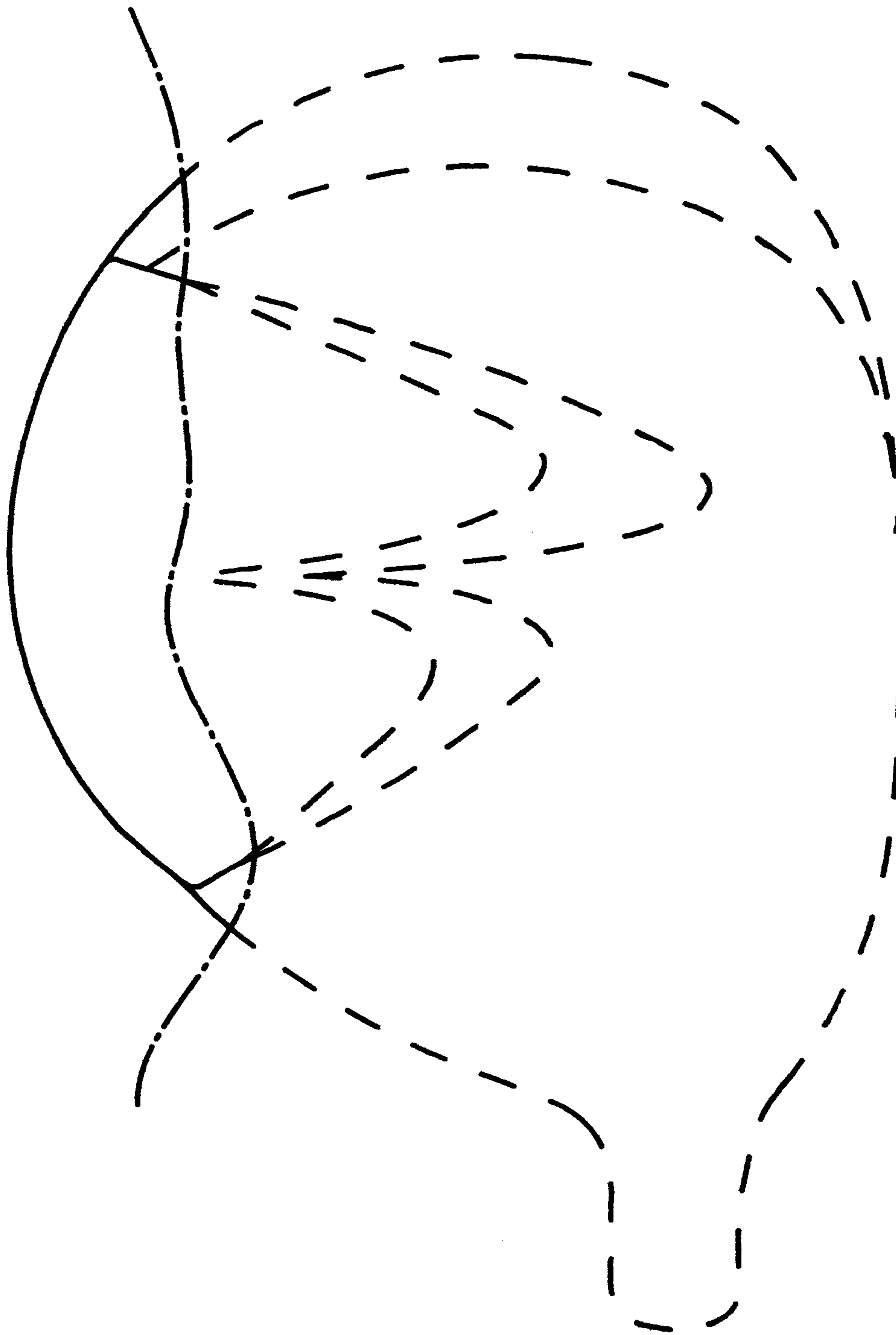

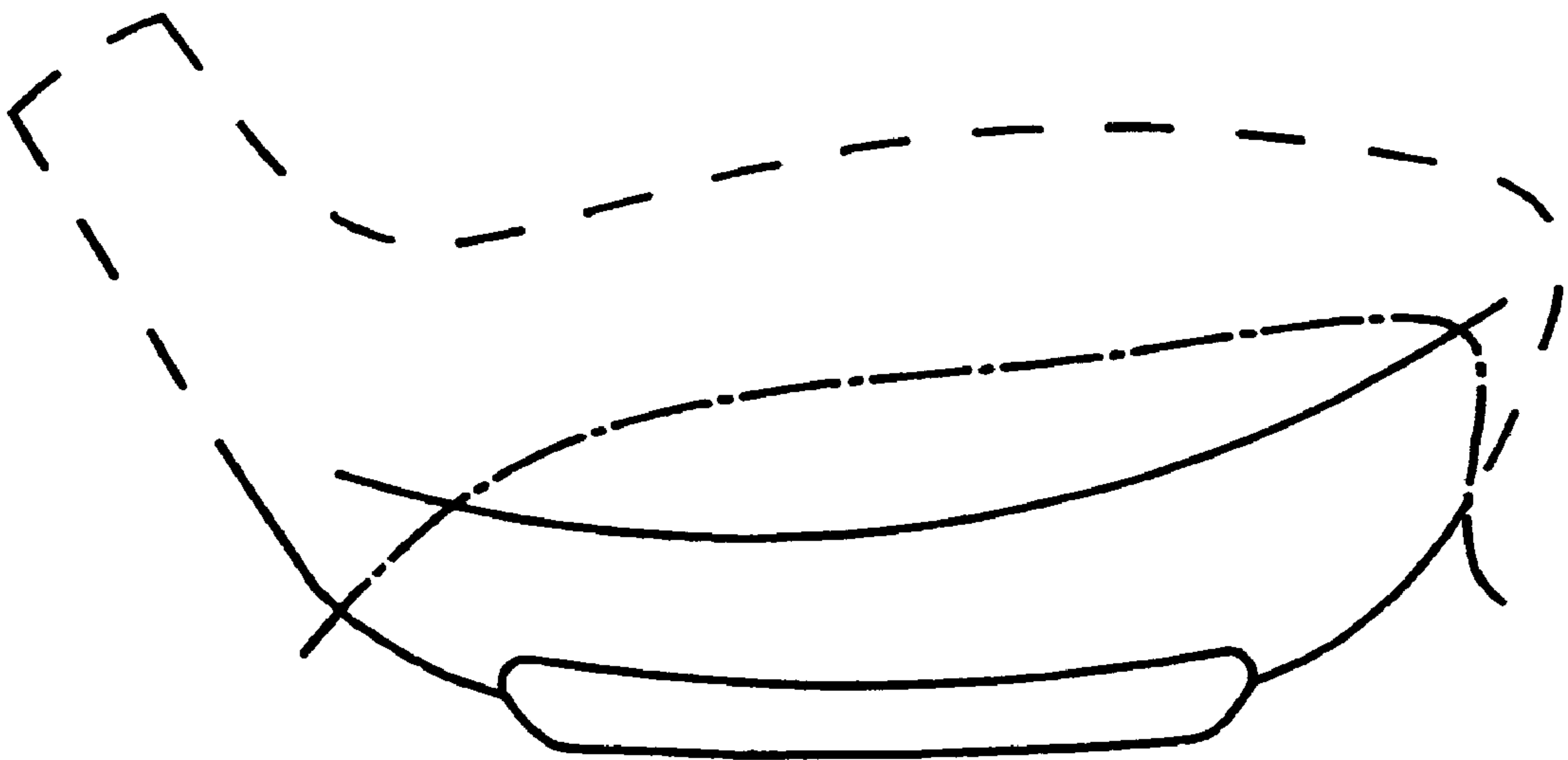
