(57) **CLAIM**

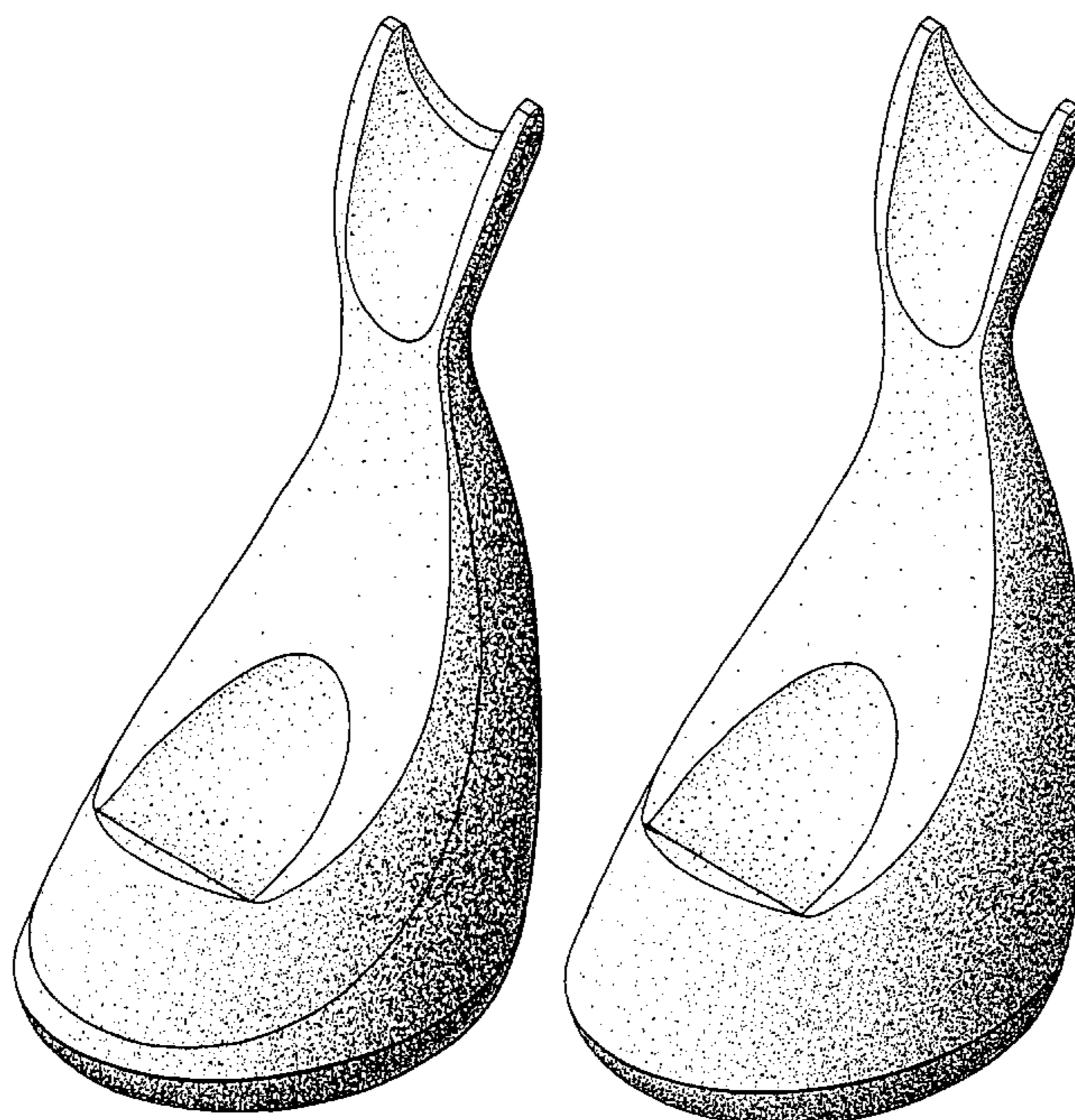
The ornamental design for a trimmer stand, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of our design for a trimmer; FIG. 2 is a right side view thereof; FIG. 3 is a front view thereof; FIG. 4 is a bottom view thereof; FIG. 5 is a left side view of the present trimmer; FIG. 6 is a top view thereof; FIG. 7 is a rear view thereof; FIG. 8 is a perspective view of an alternate embodiment of the present trimmer; FIG. 9 is a right side view thereof; FIG. 10 is a front view thereof; FIG. 11 is a bottom view thereof; FIG. 12 is a top view thereof; FIG. 13 is a left side view thereof; and, FIG. 14 is a rear view thereof.

The broken line showing of the bottom surface features in FIGS. 9-11, 13 and 14 is for illustrative purposes only and forms no part of the second embodiment of the claimed design.

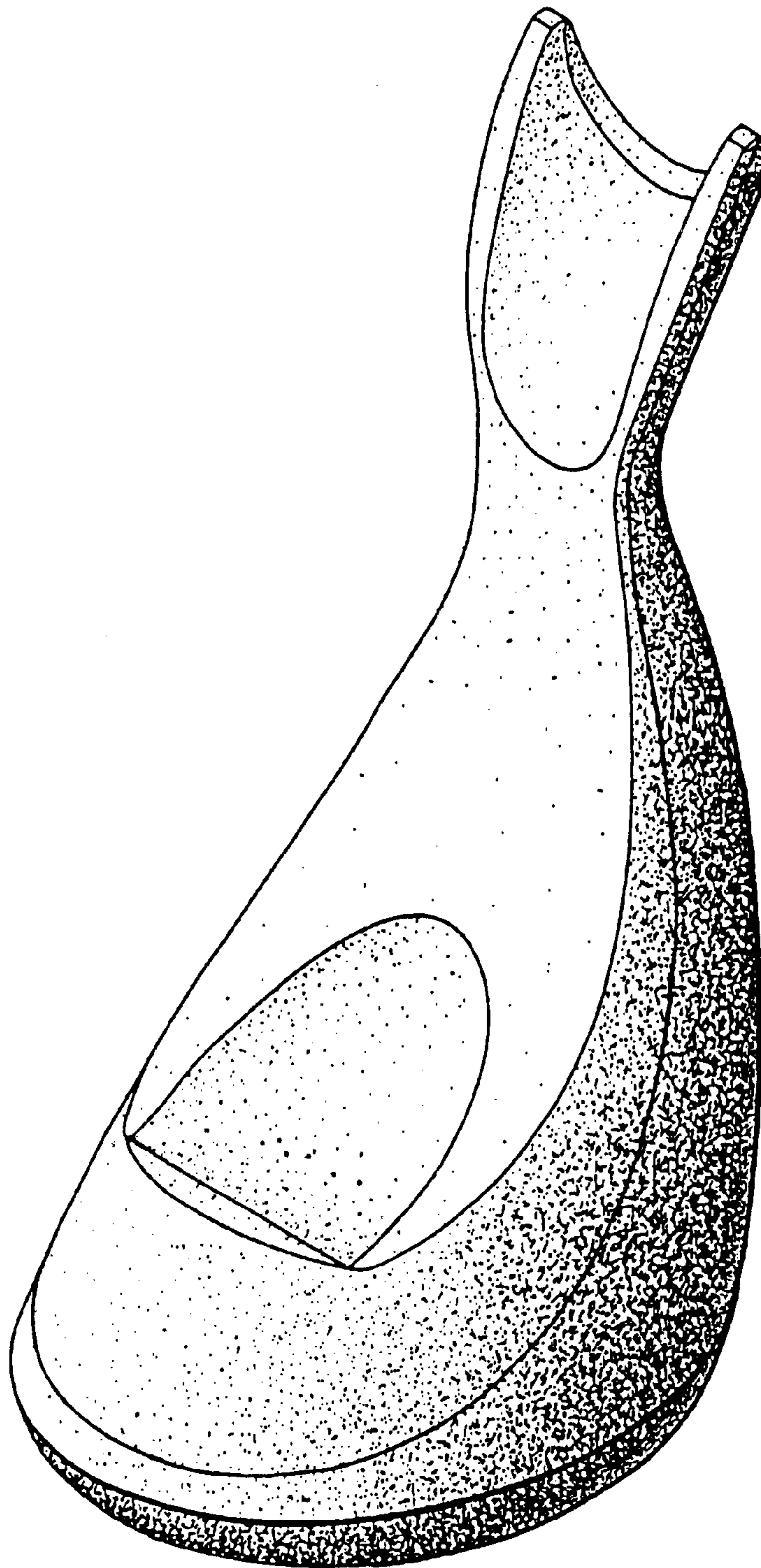

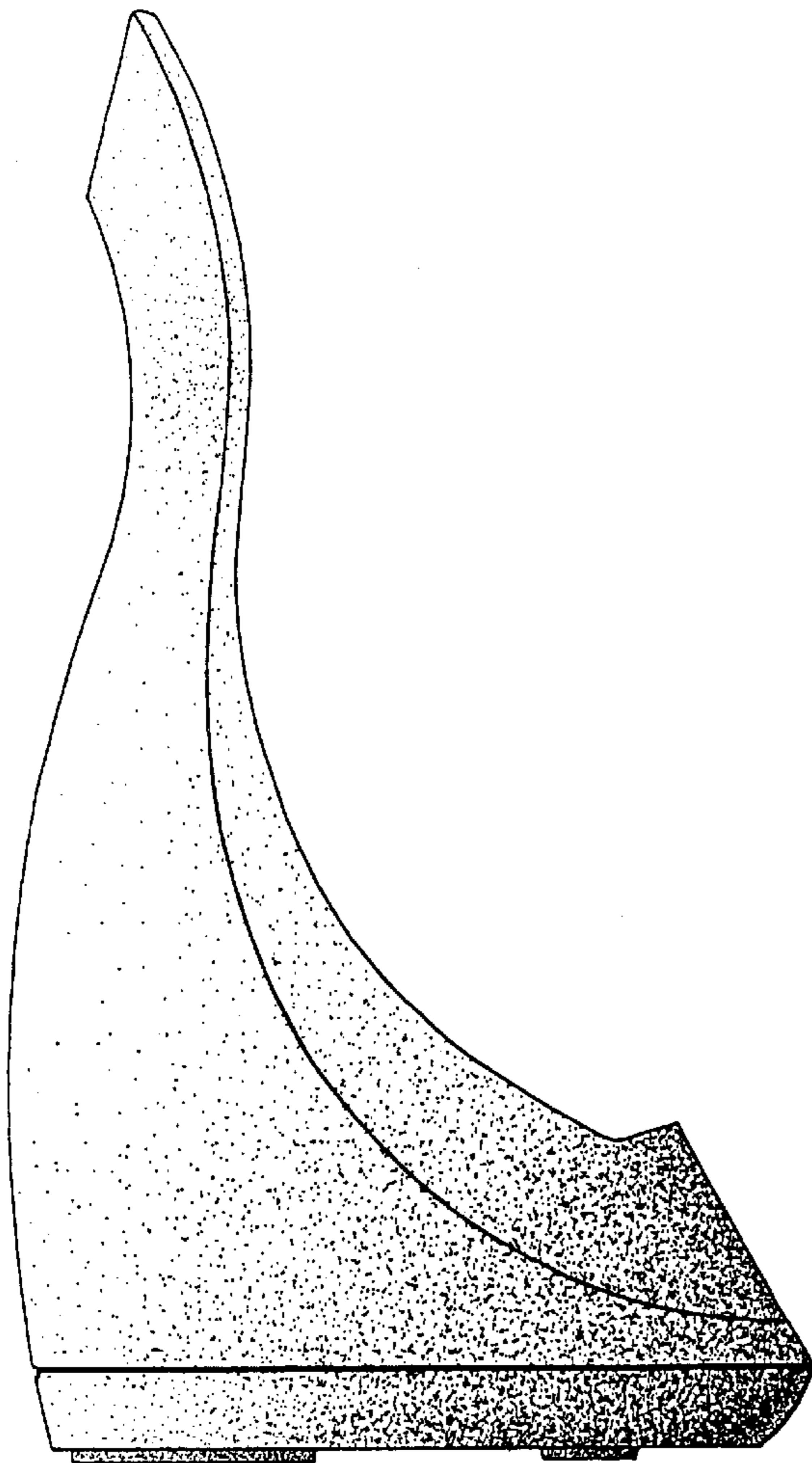

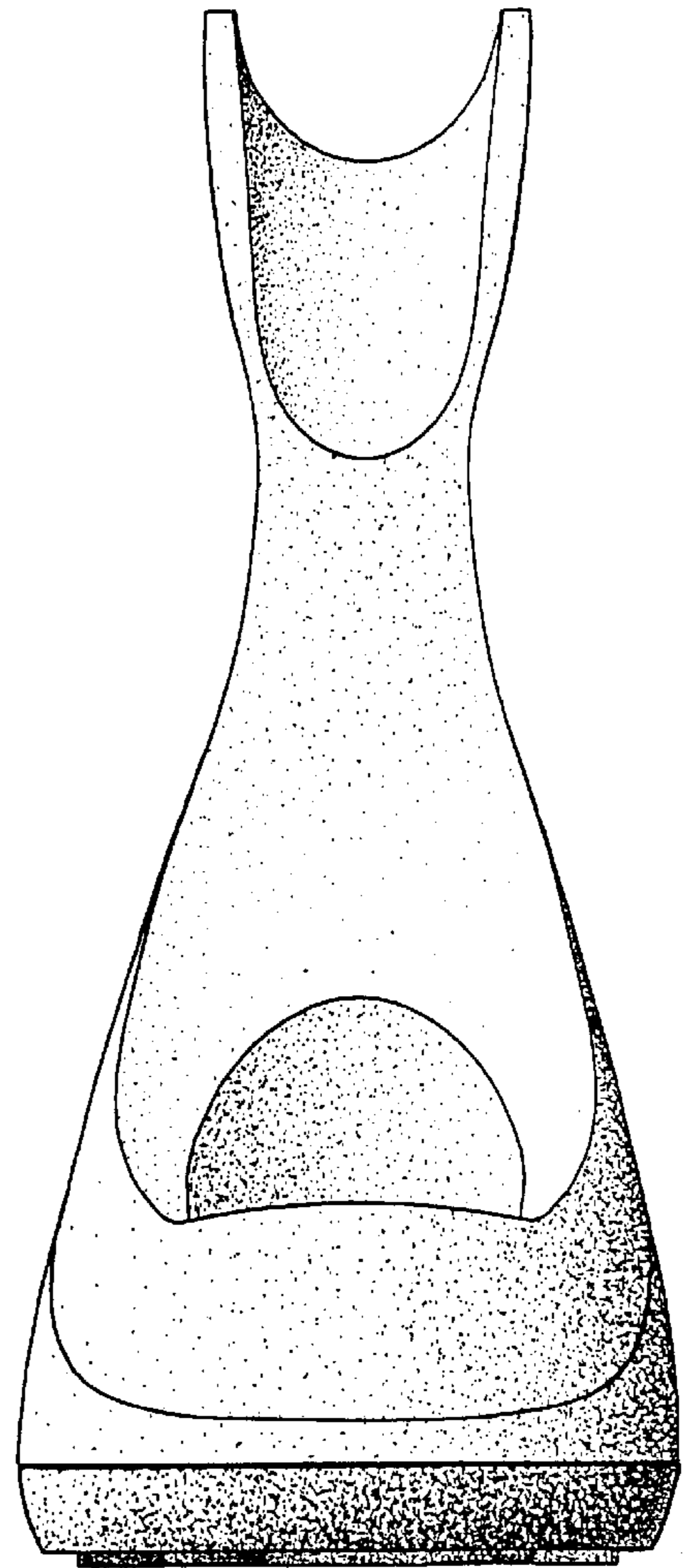

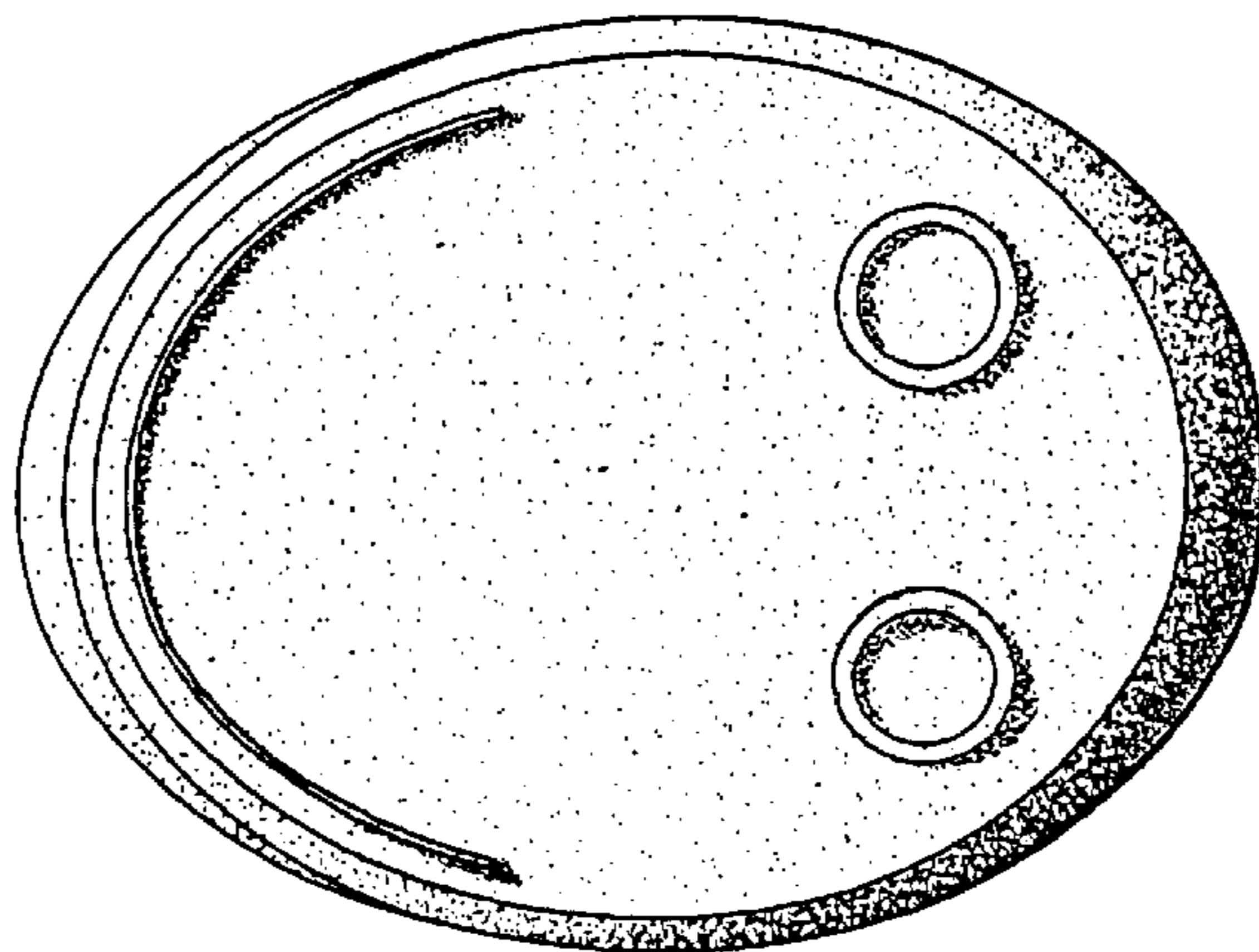

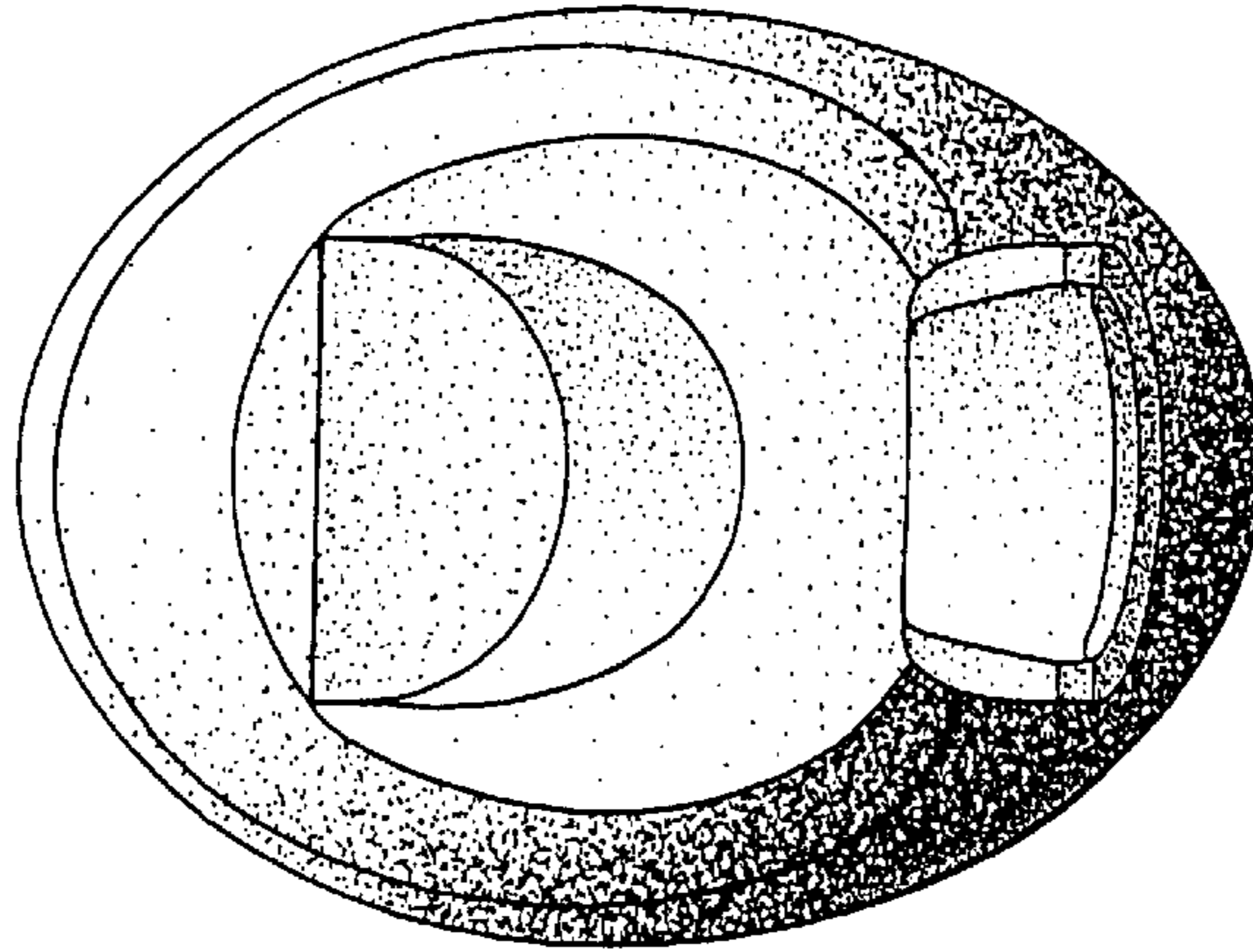

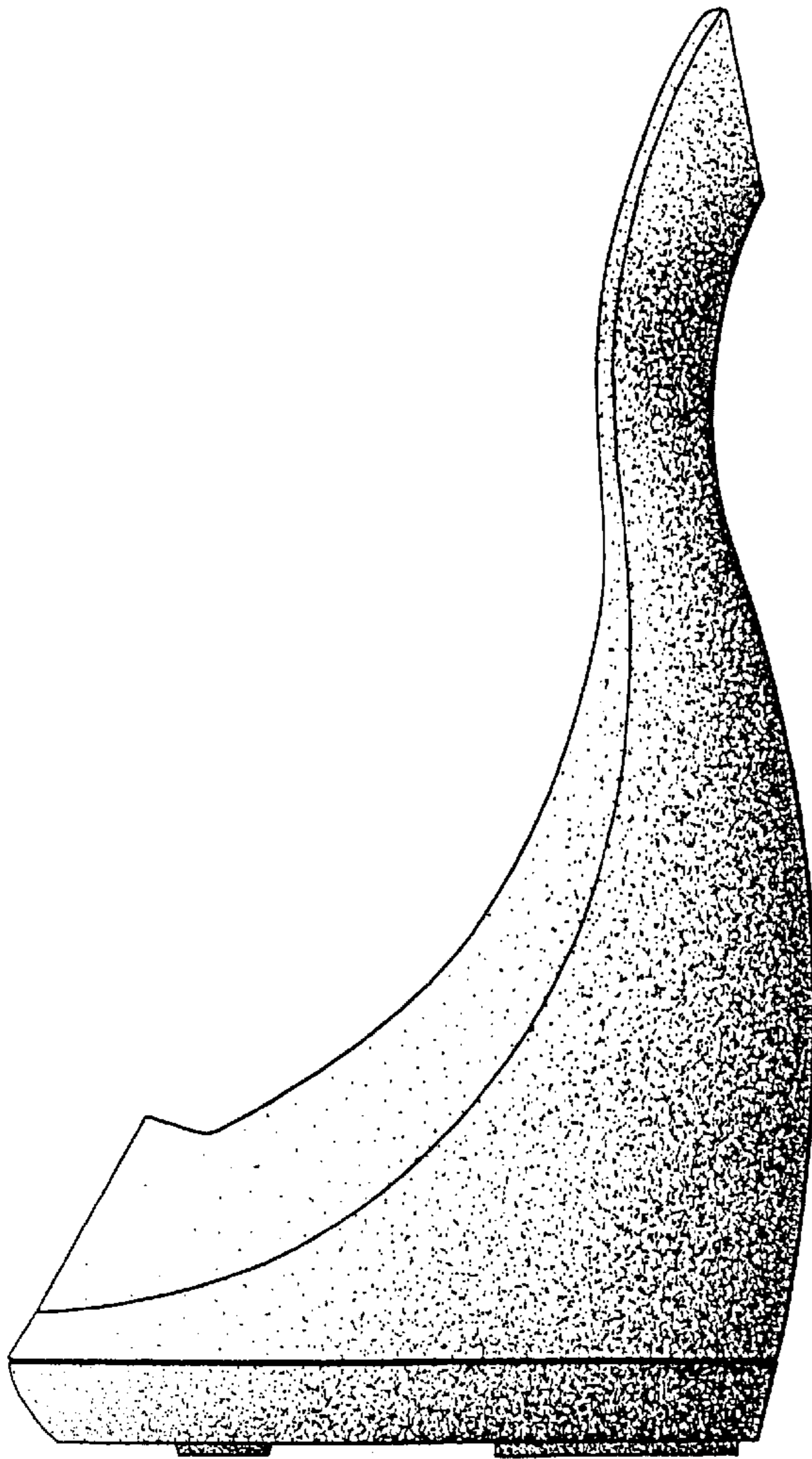

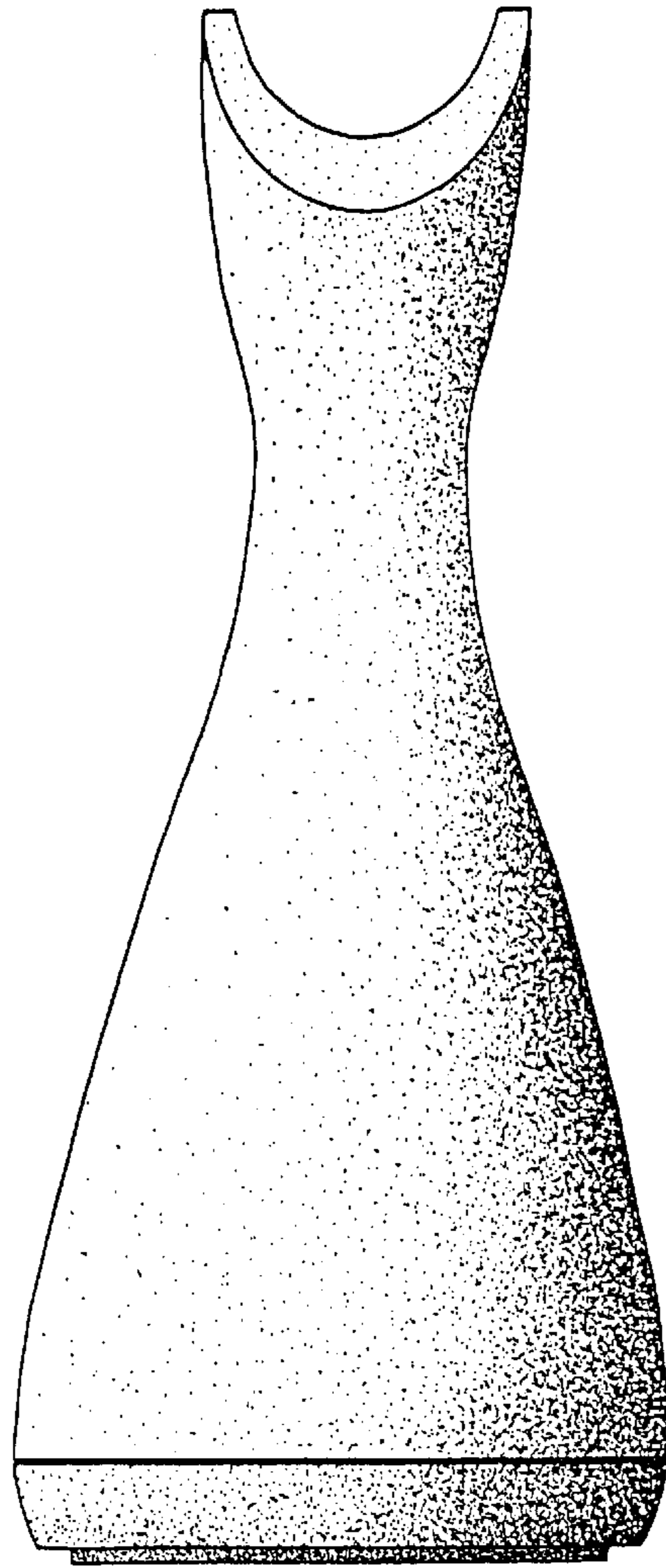

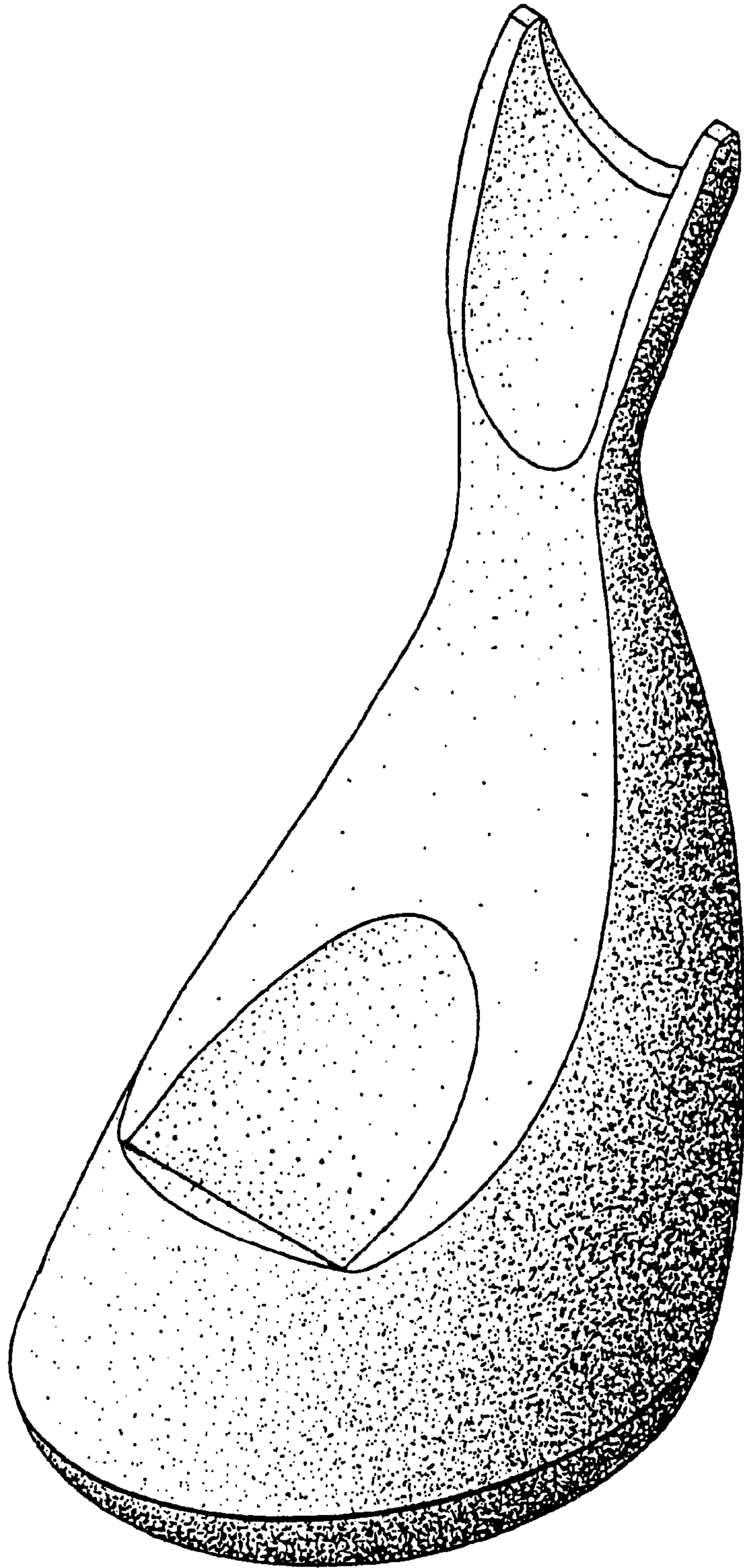

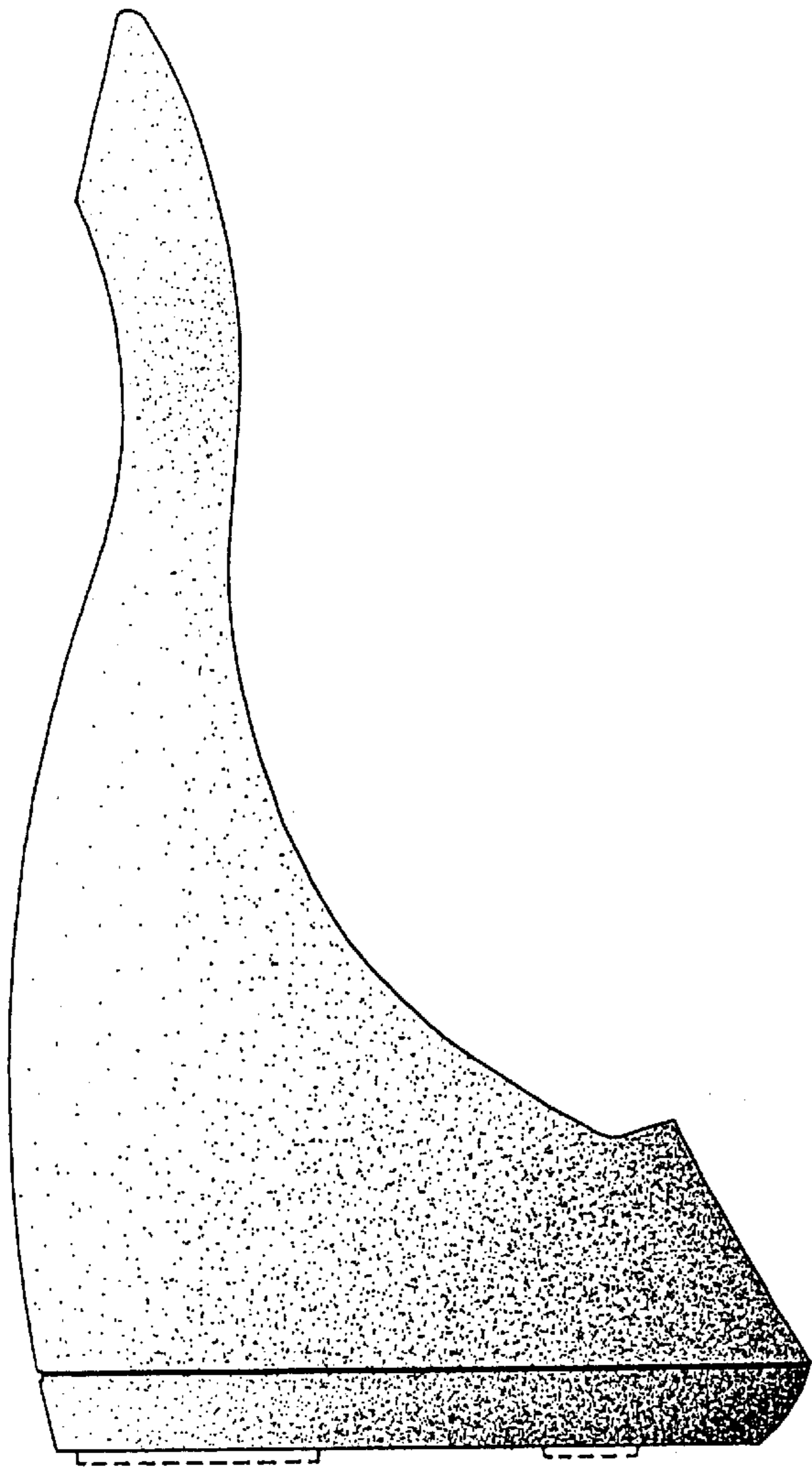

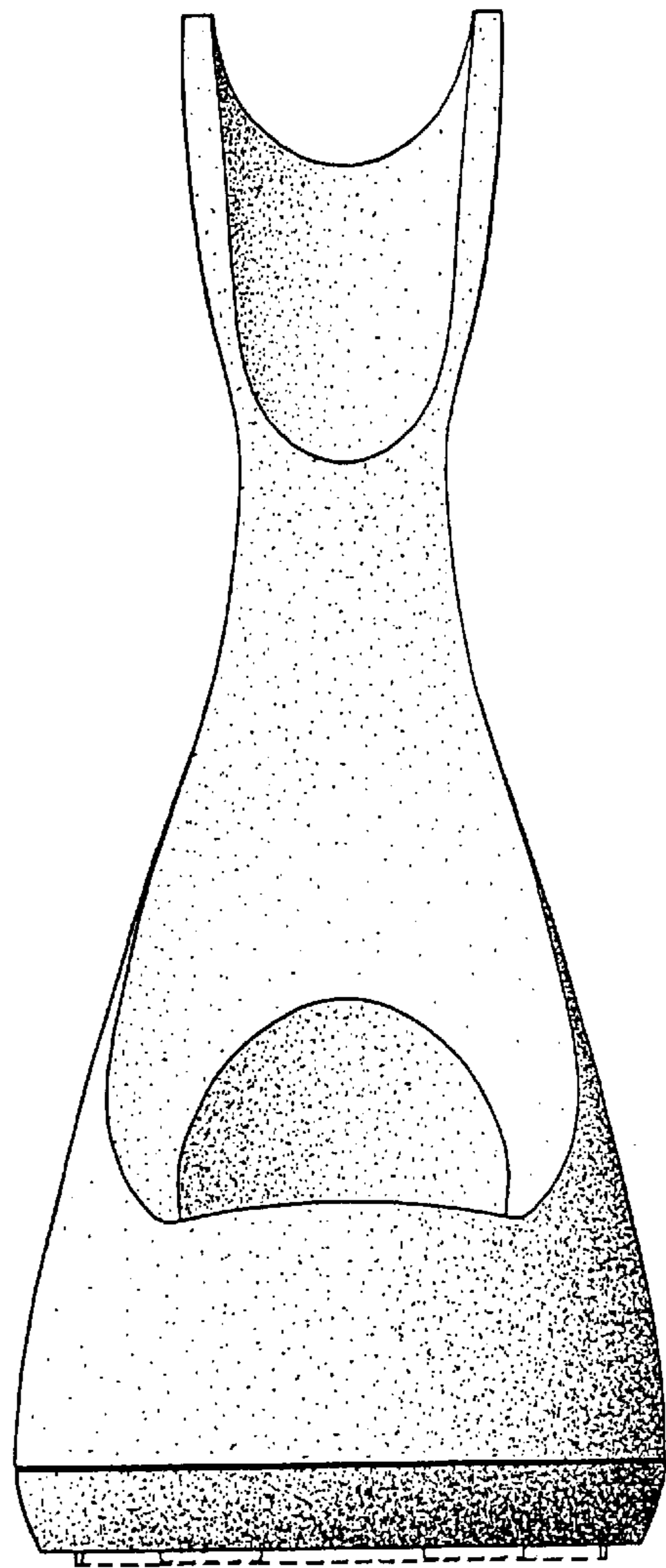

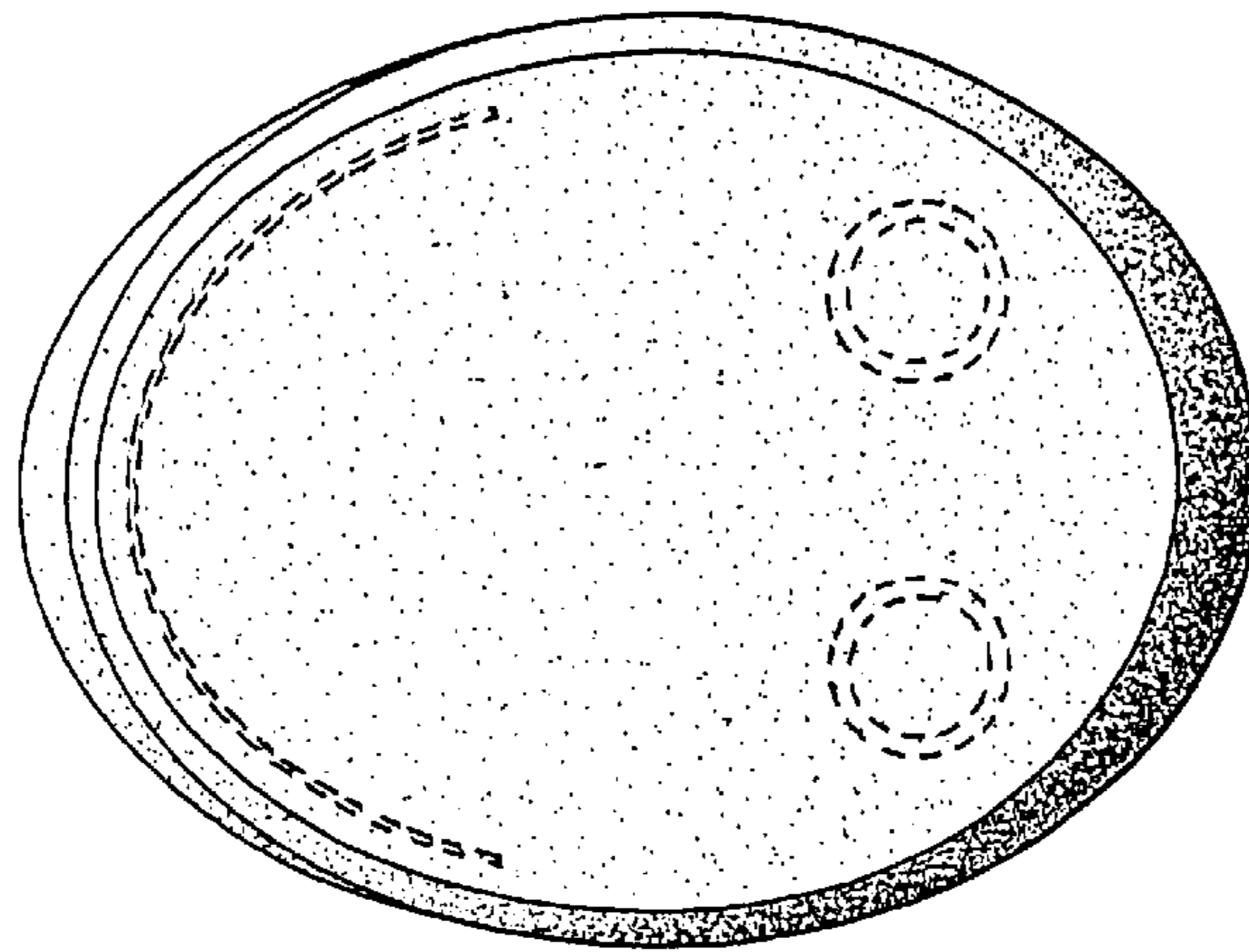

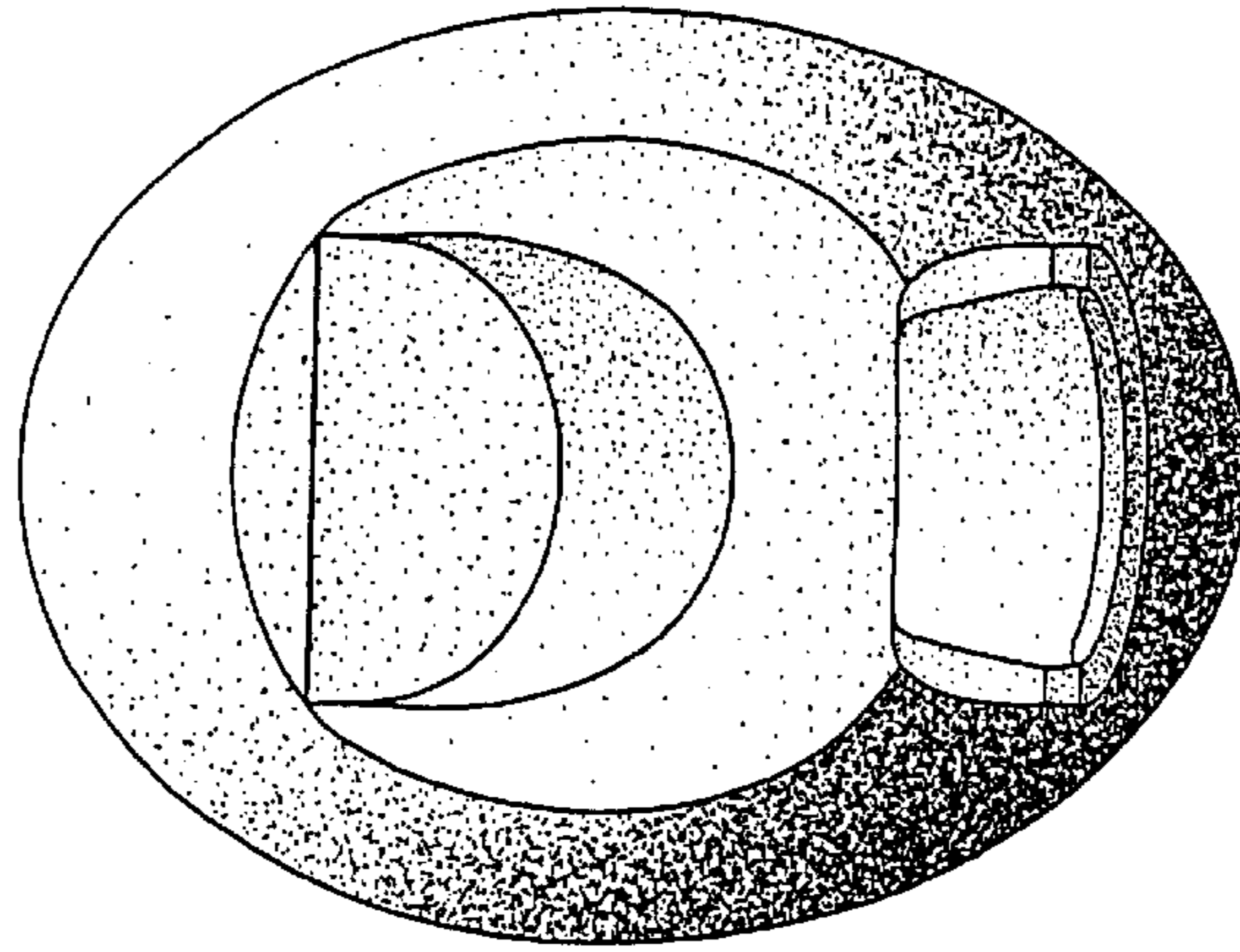

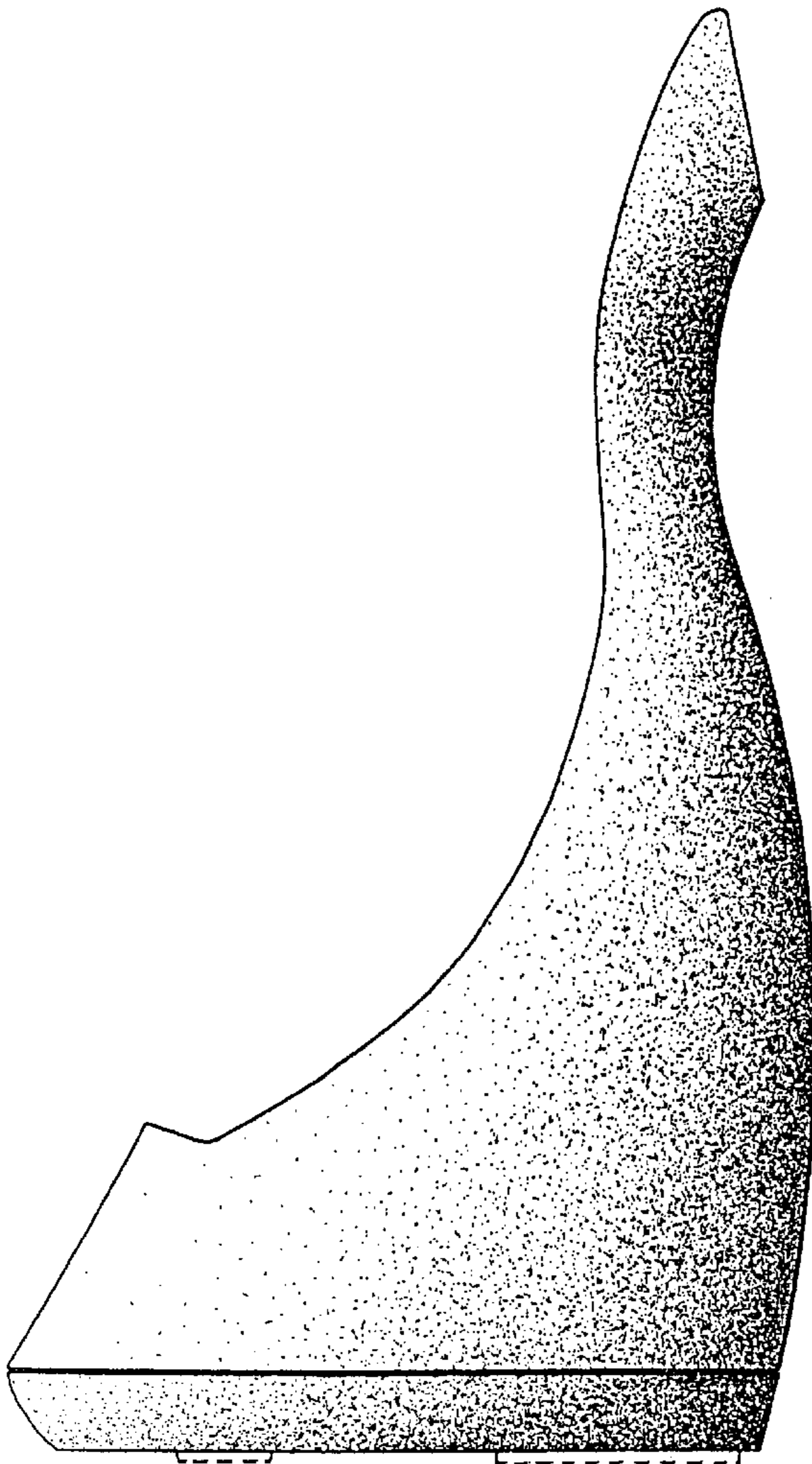

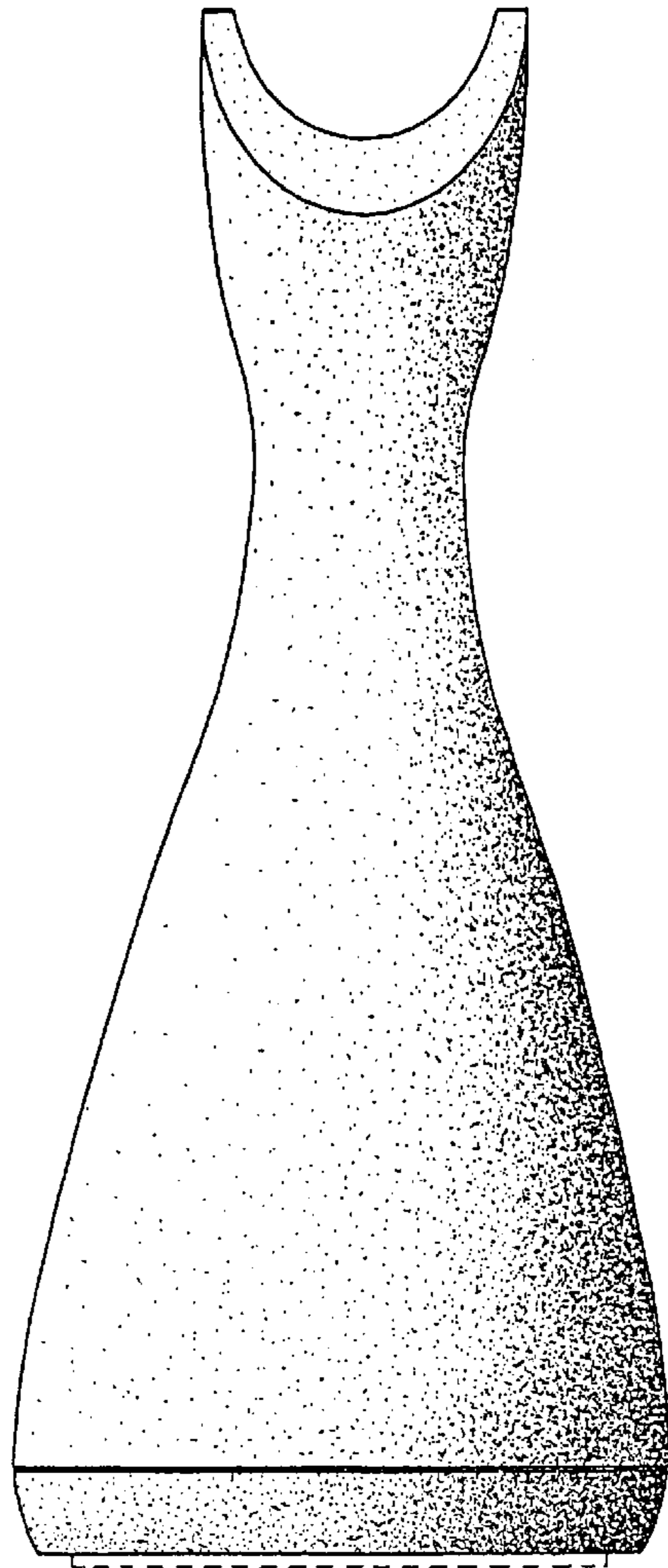
