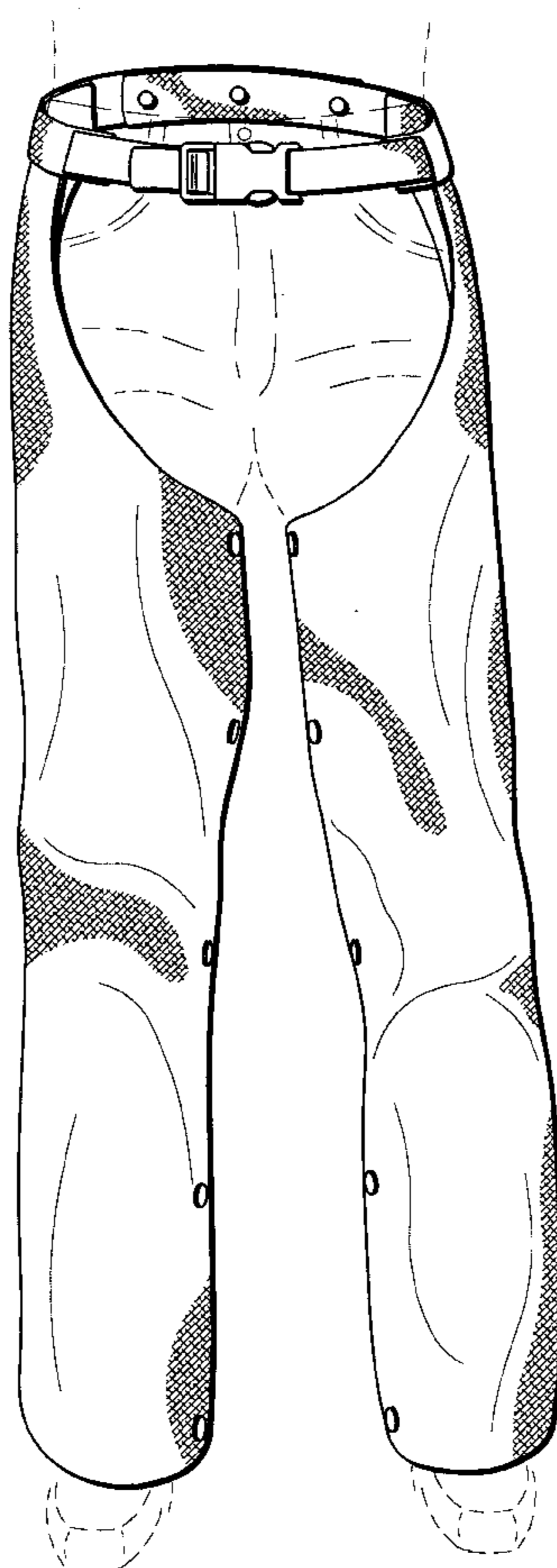
FIG. 2 is a back perspective view thereof;

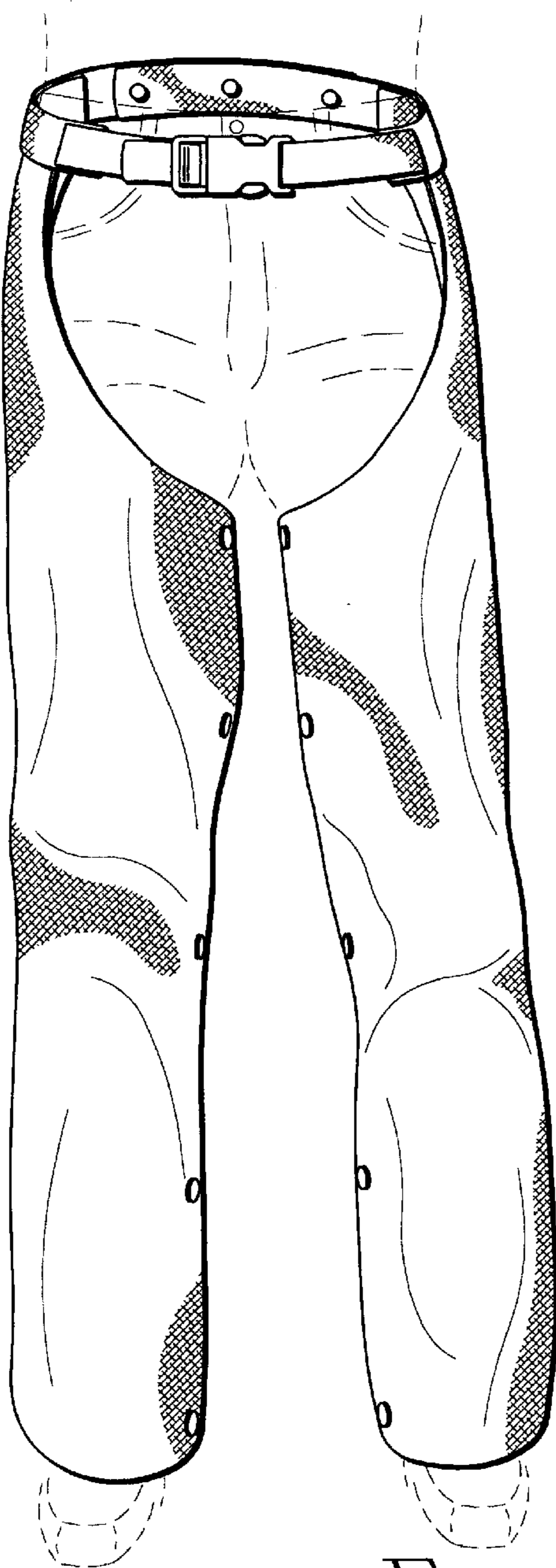

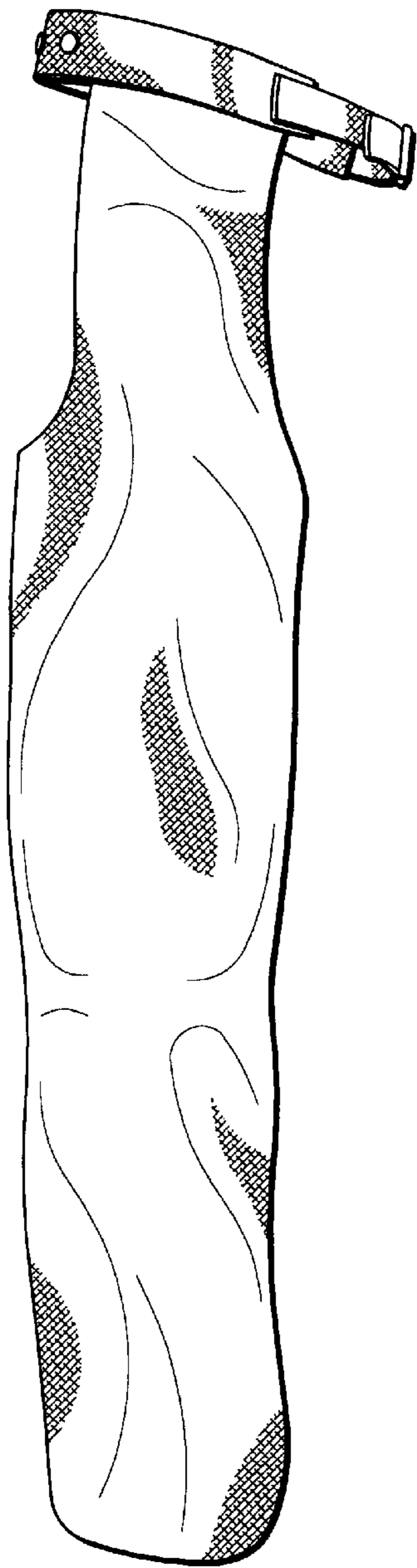

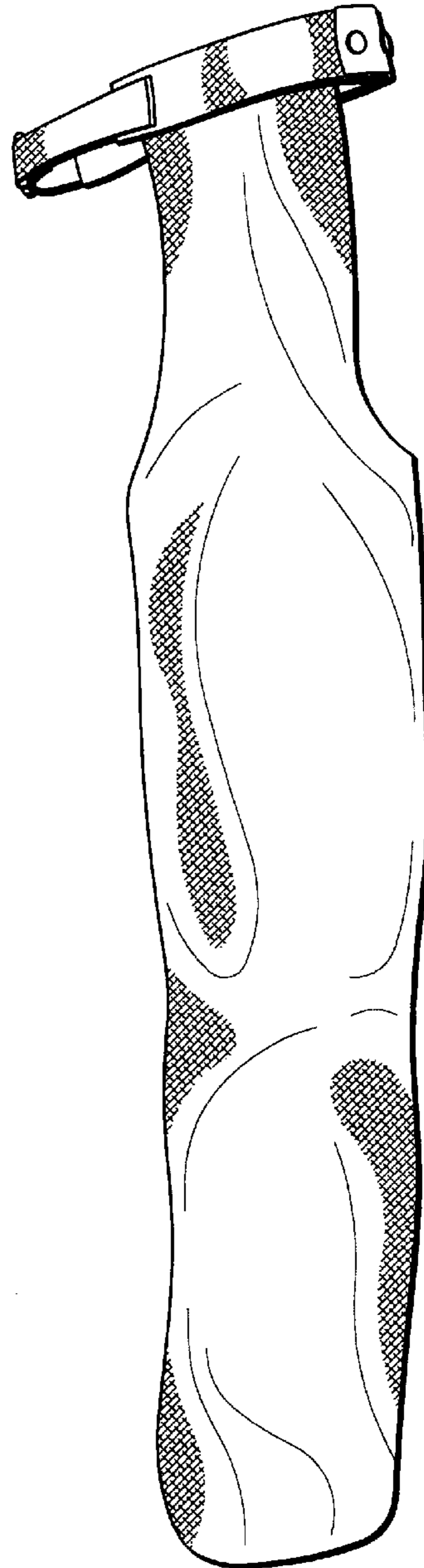

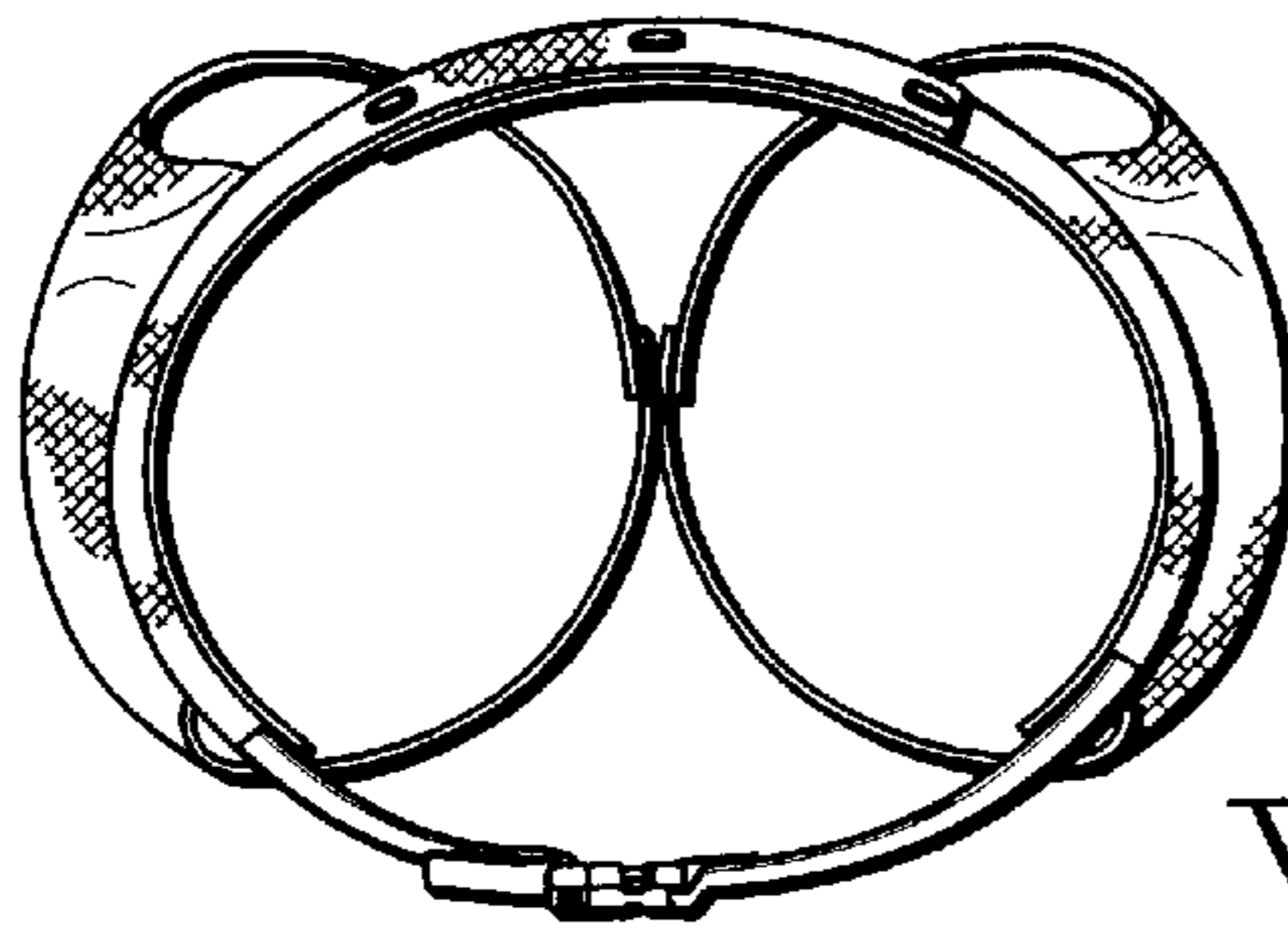
