FIG. 7 is an enlarged perspective view of the design of the present invention.

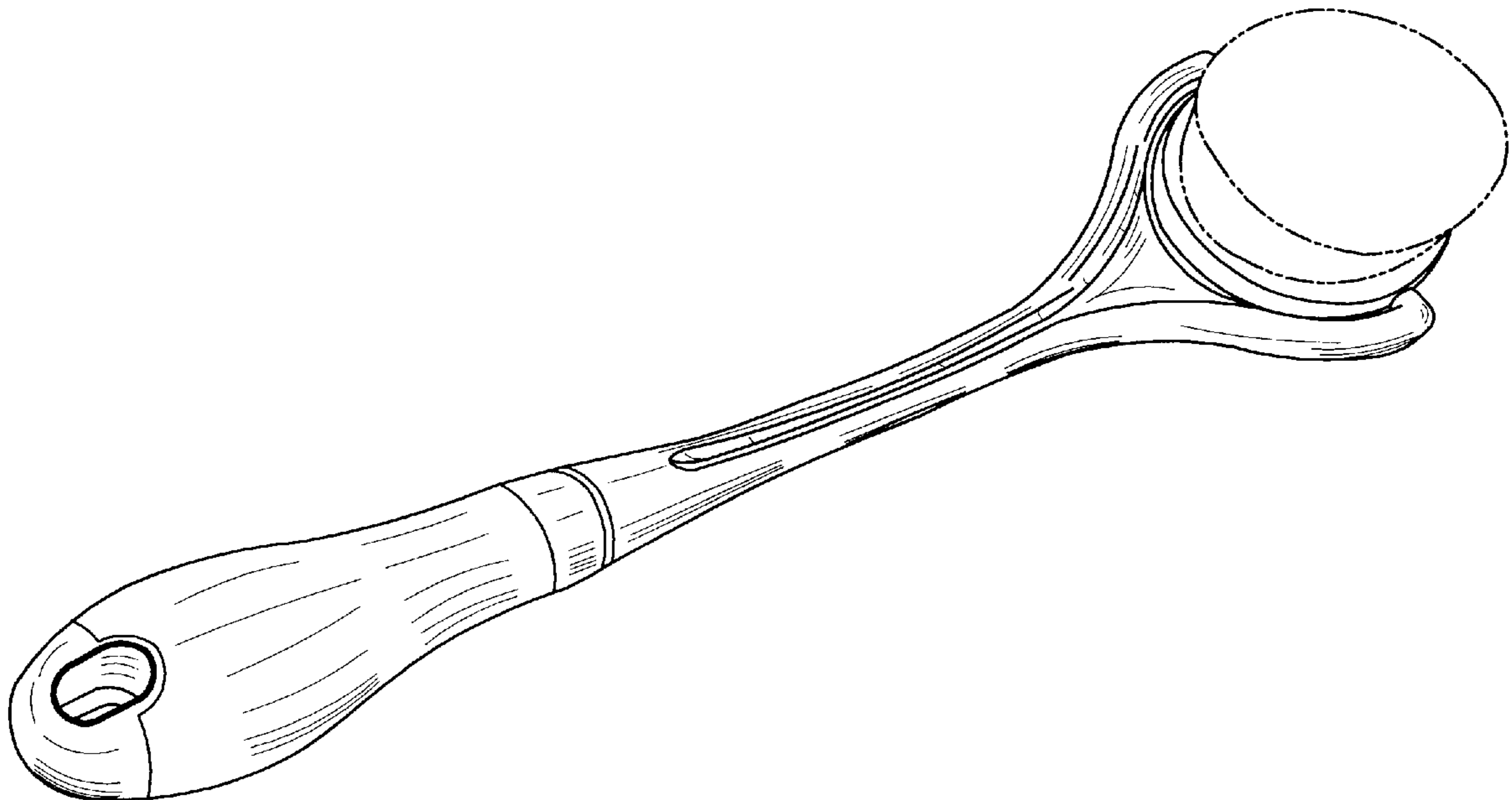
The broken line outline representing the brush element is for illustrative purposes only and forms no part of the claimed design.

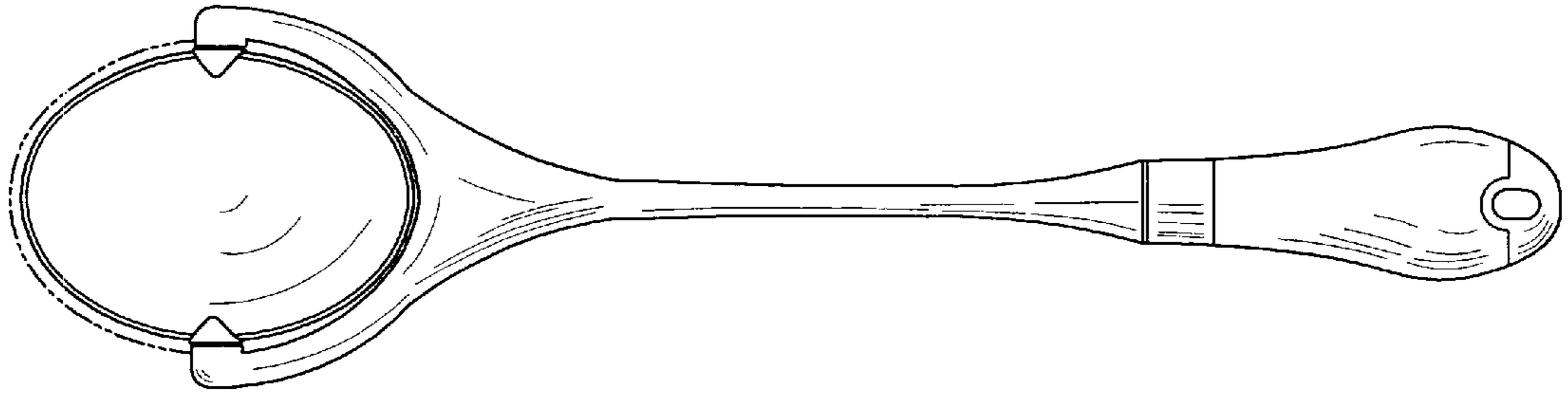

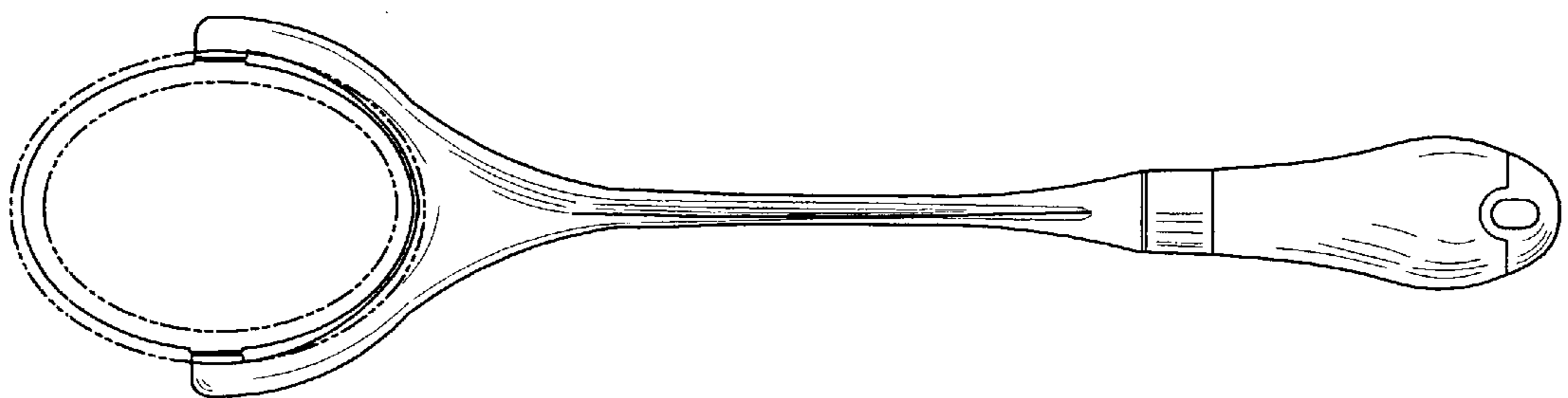

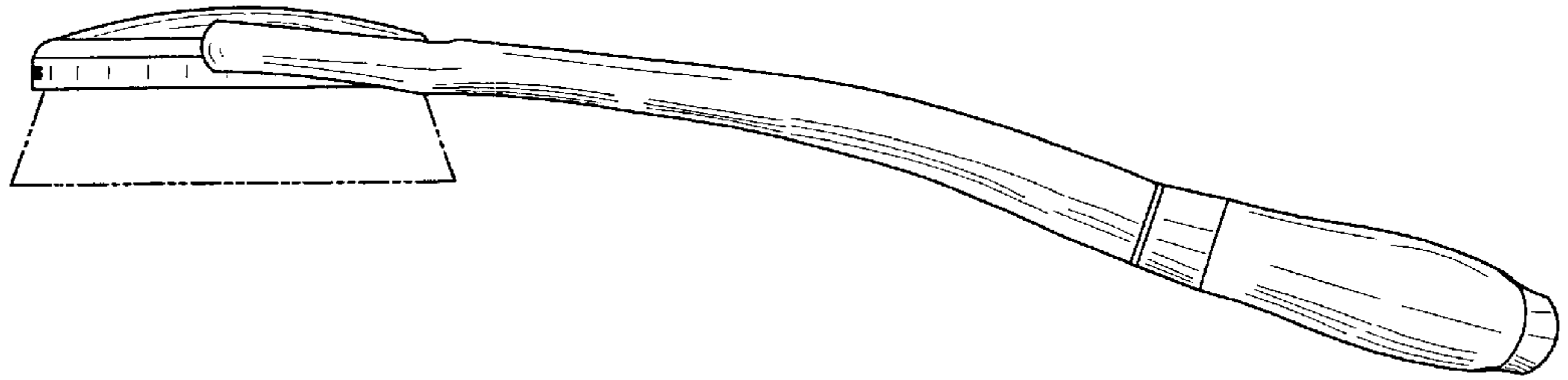

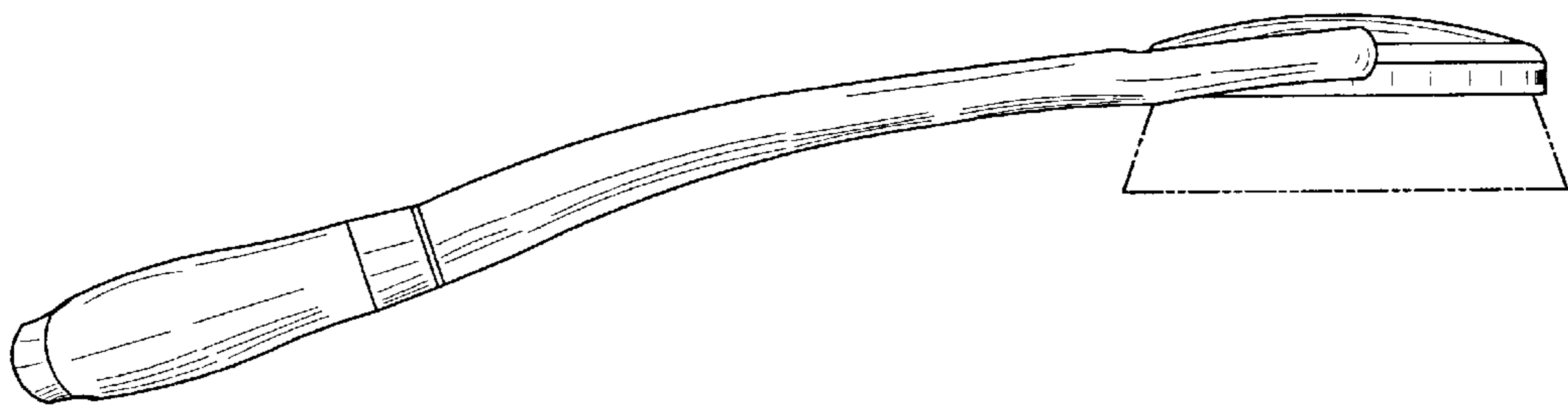

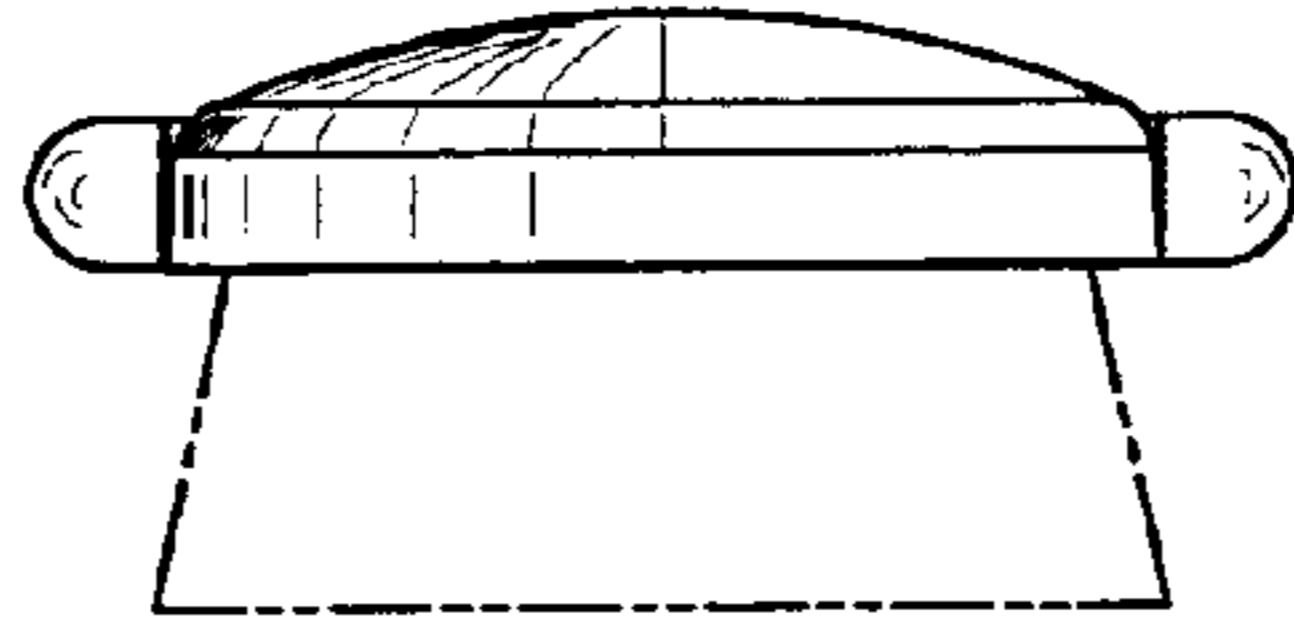

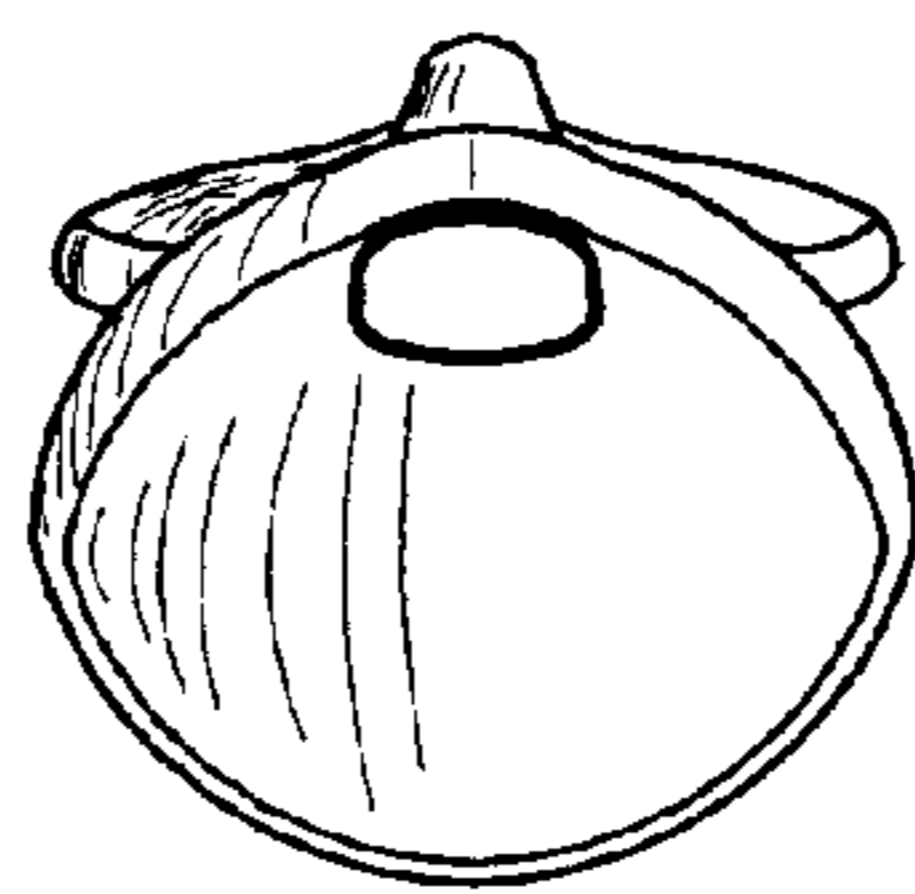

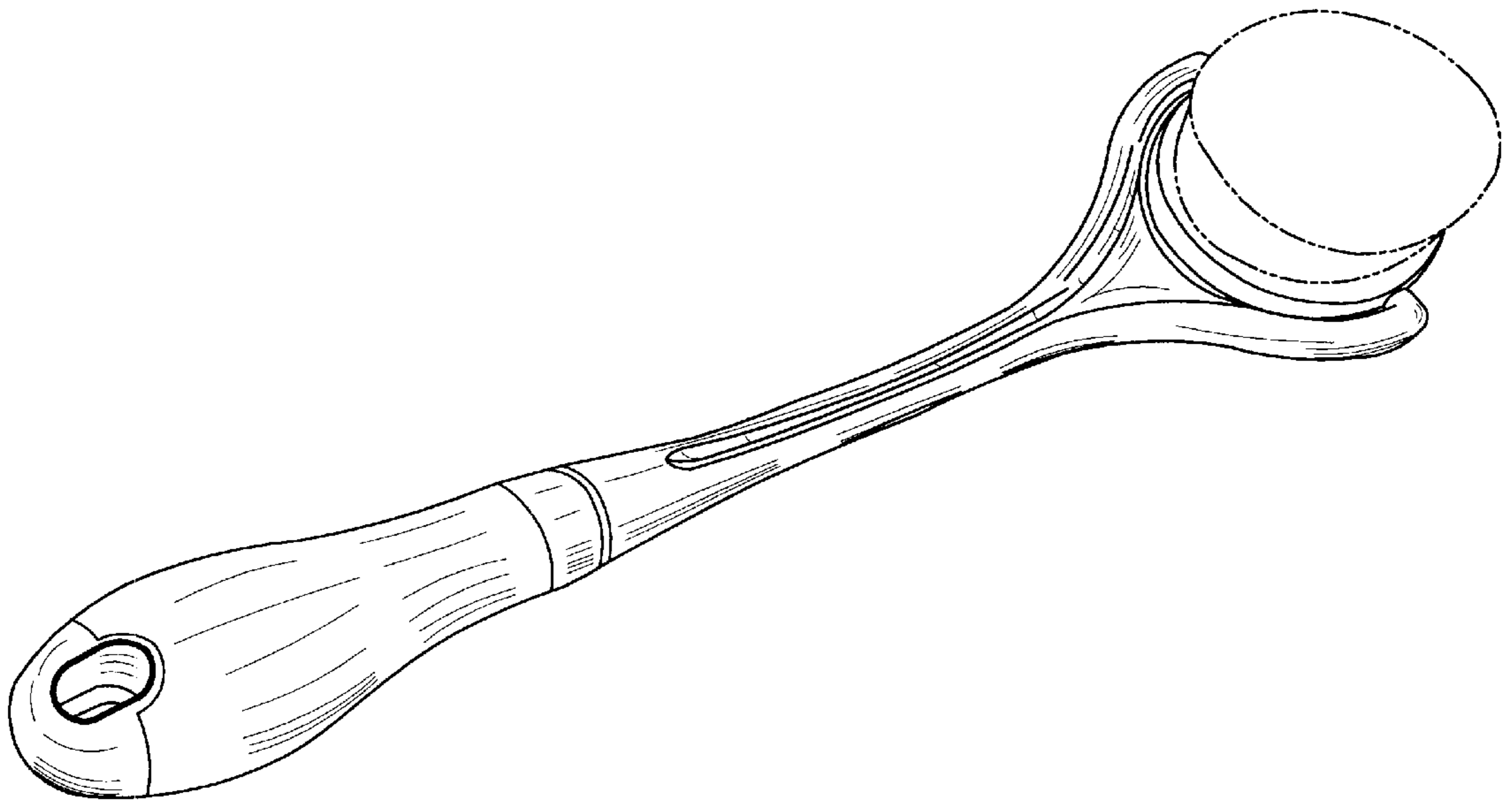
