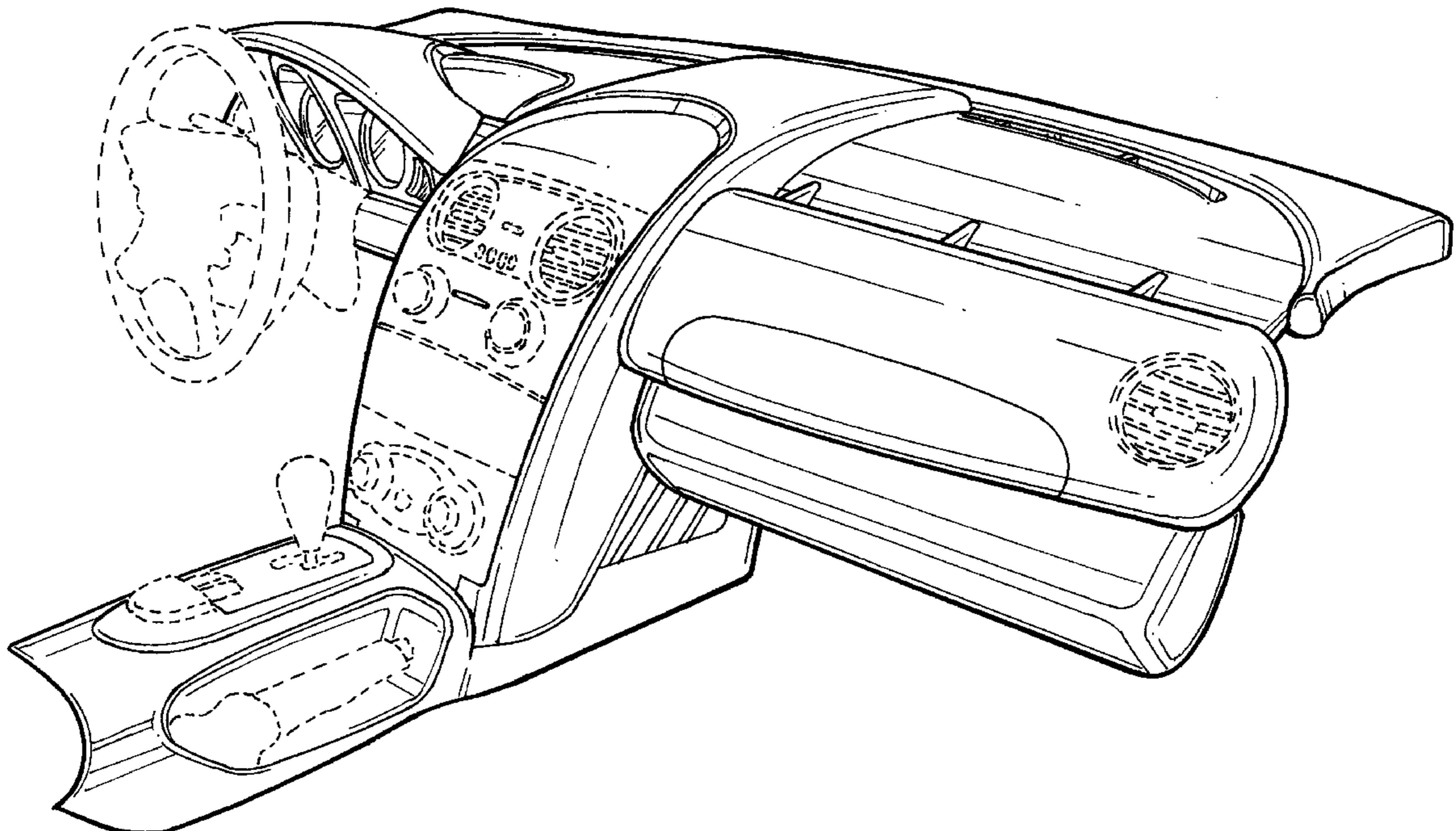
(57) **CLAIM**

The ornamental design for a surface configuration of a dashboard for a vehicle, as shown and described.

**DESCRIPTION**

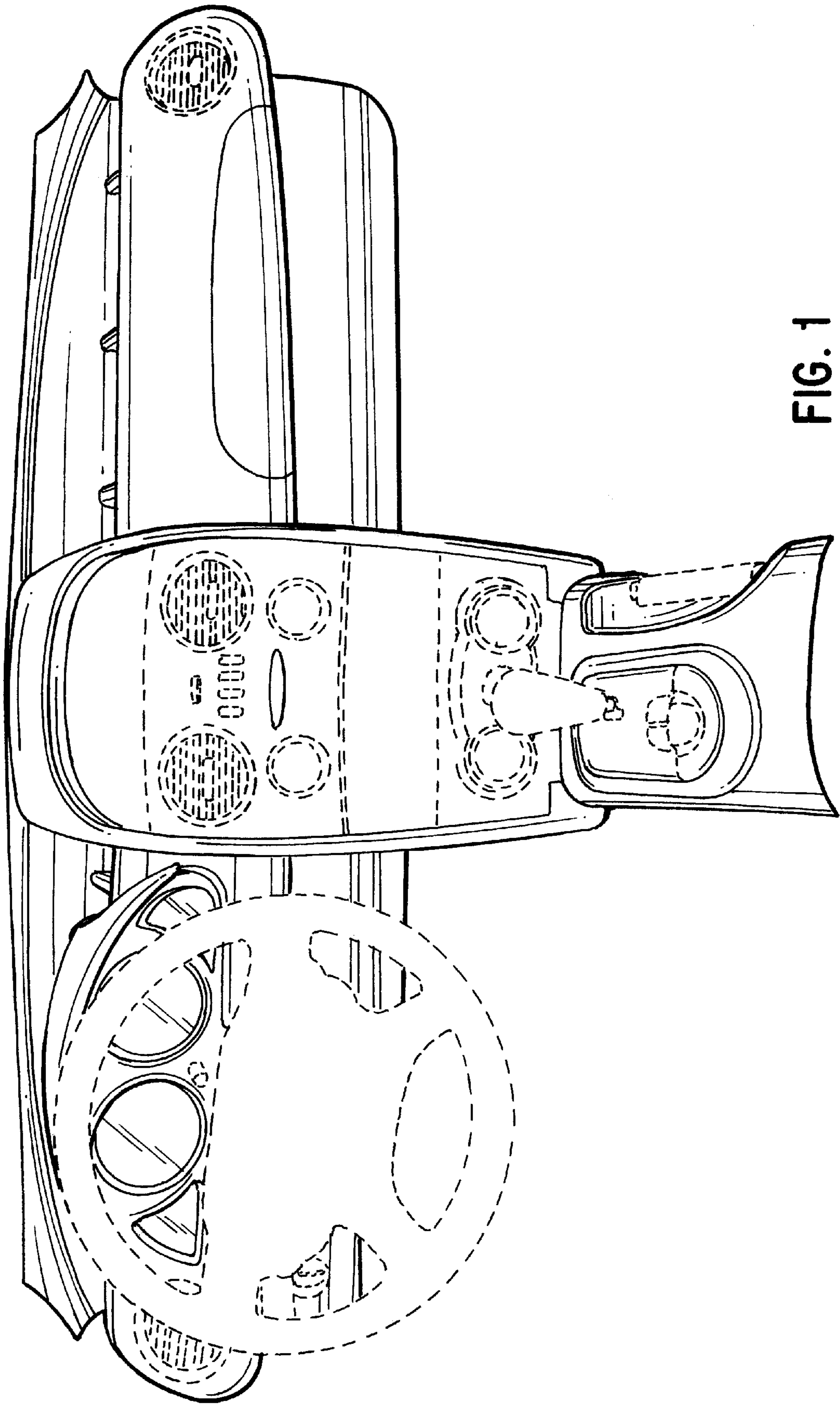

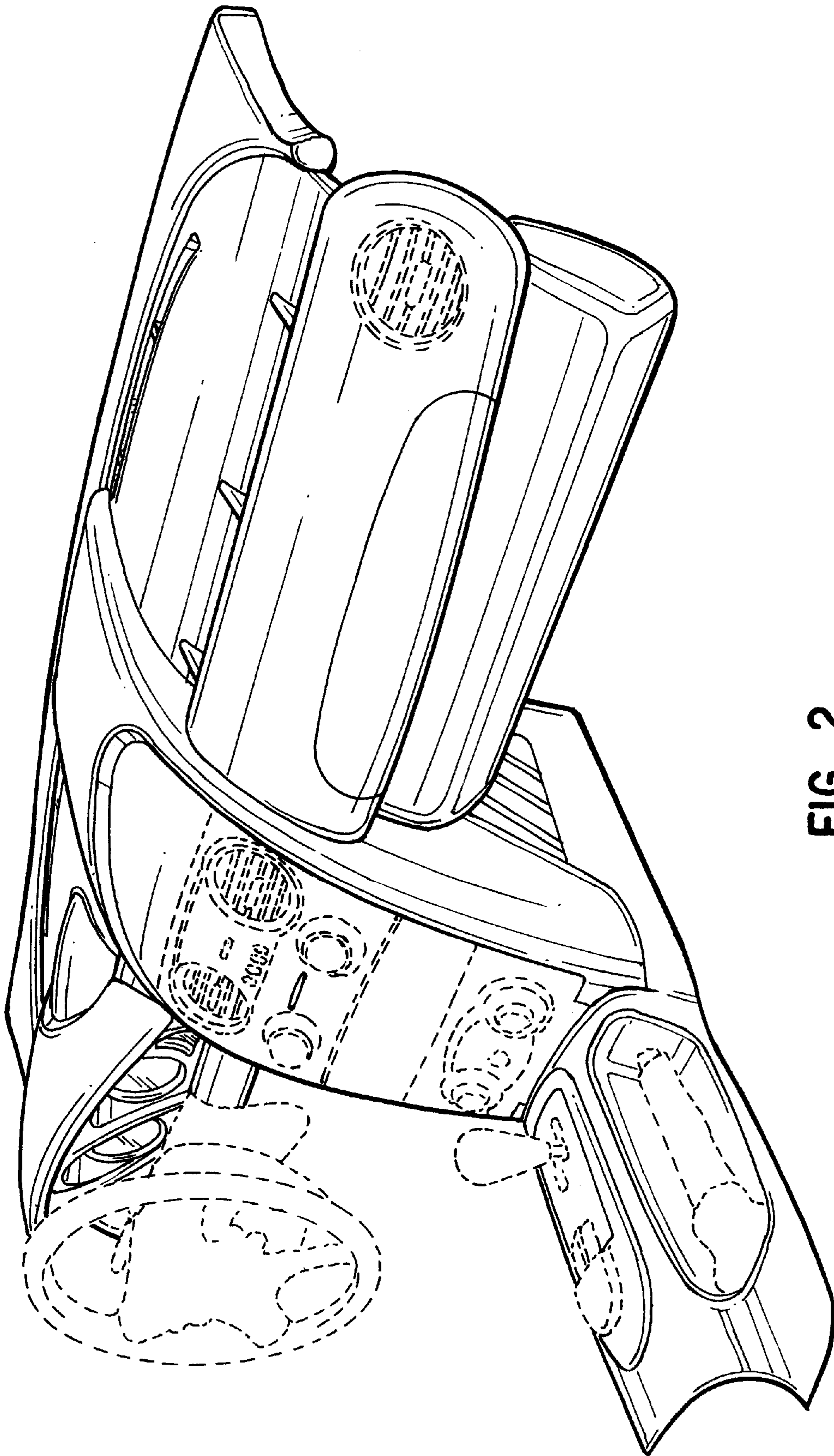

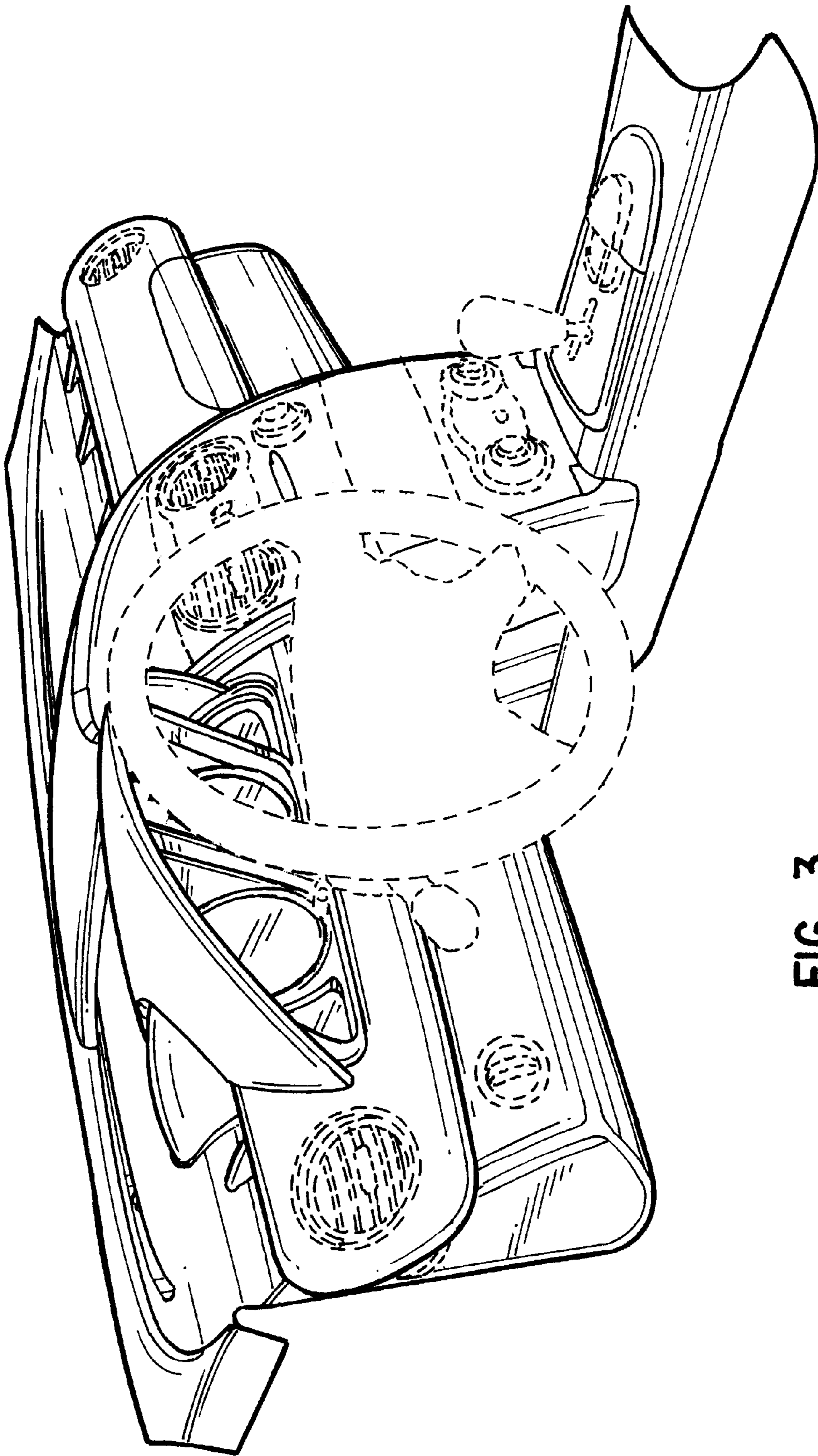


FIG. 3
