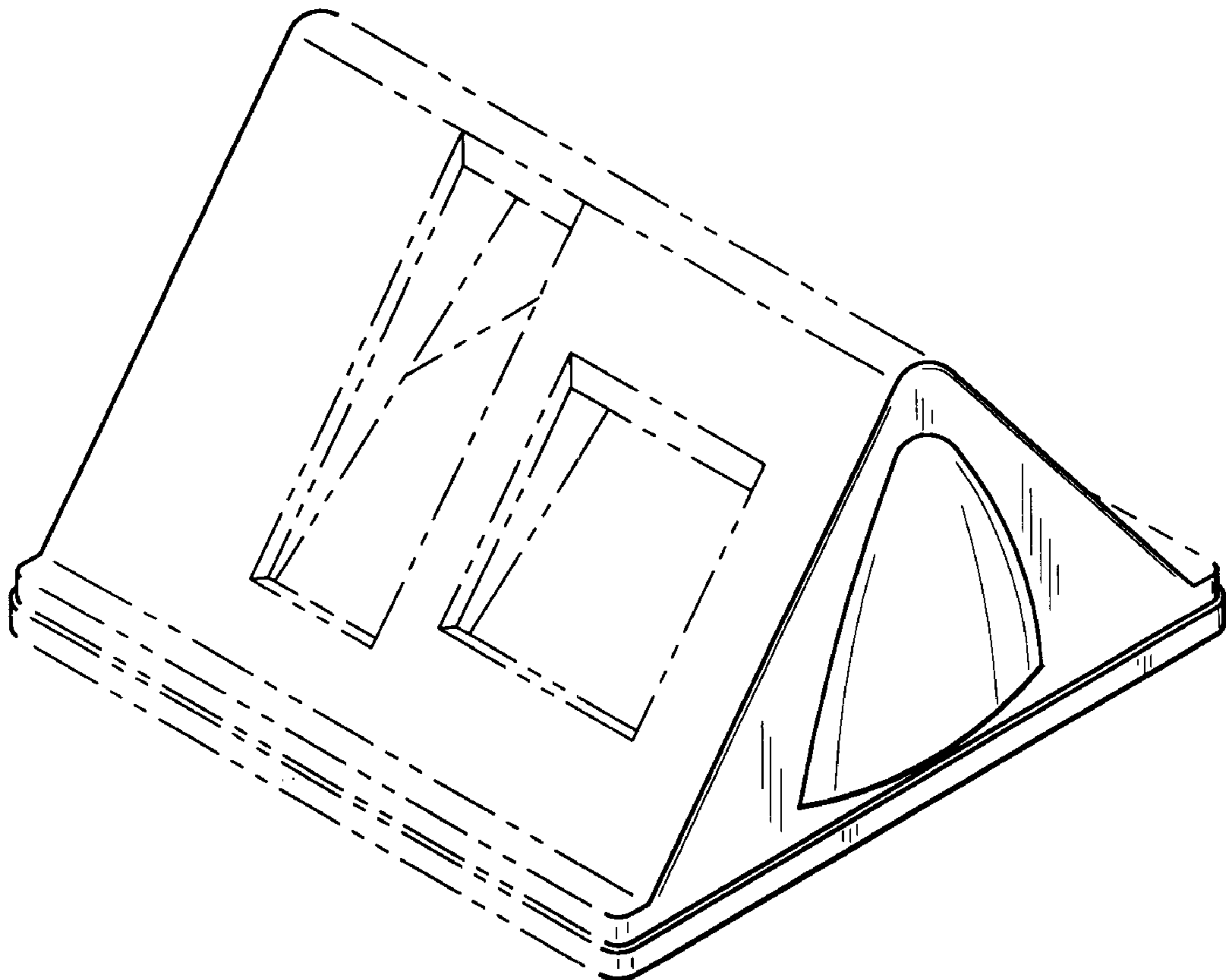
(57) **CLAIM**

The ornamental design for end caps of a connector receptacle, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of end caps of a connector receptacle showing my new design;  
 FIG. 2 is a left side elevational view thereof, the right side being the same;  
 FIG. 3 is a top plan view thereof;  
 FIG. 4 is a bottom view thereof;  
 FIG. 5 is a front elevational view thereof; and,  
 FIG. 6 is a rear elevational view thereof.  
 The broken lines in the drawings depict environmental structure, which forms no part of the claimed design.

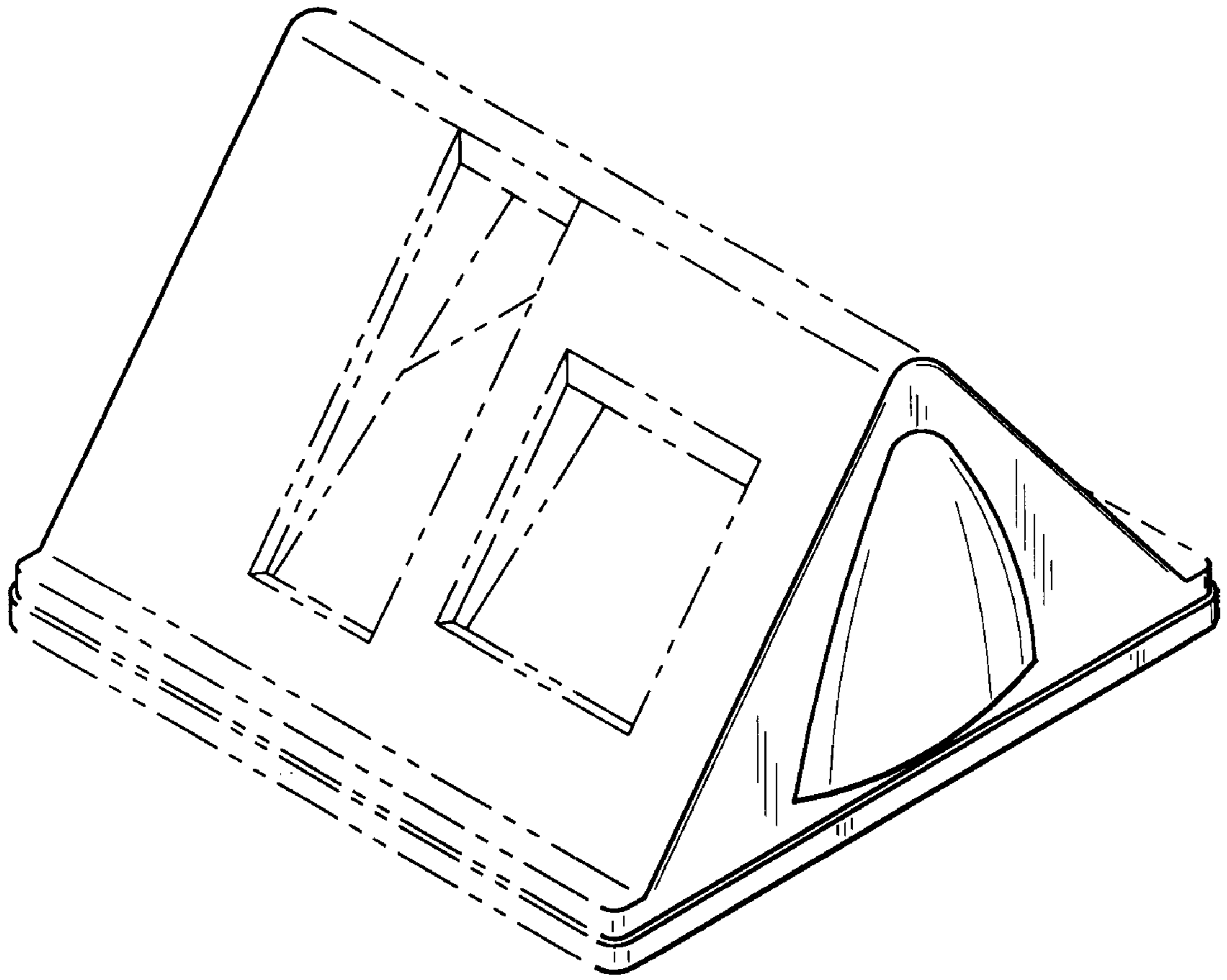

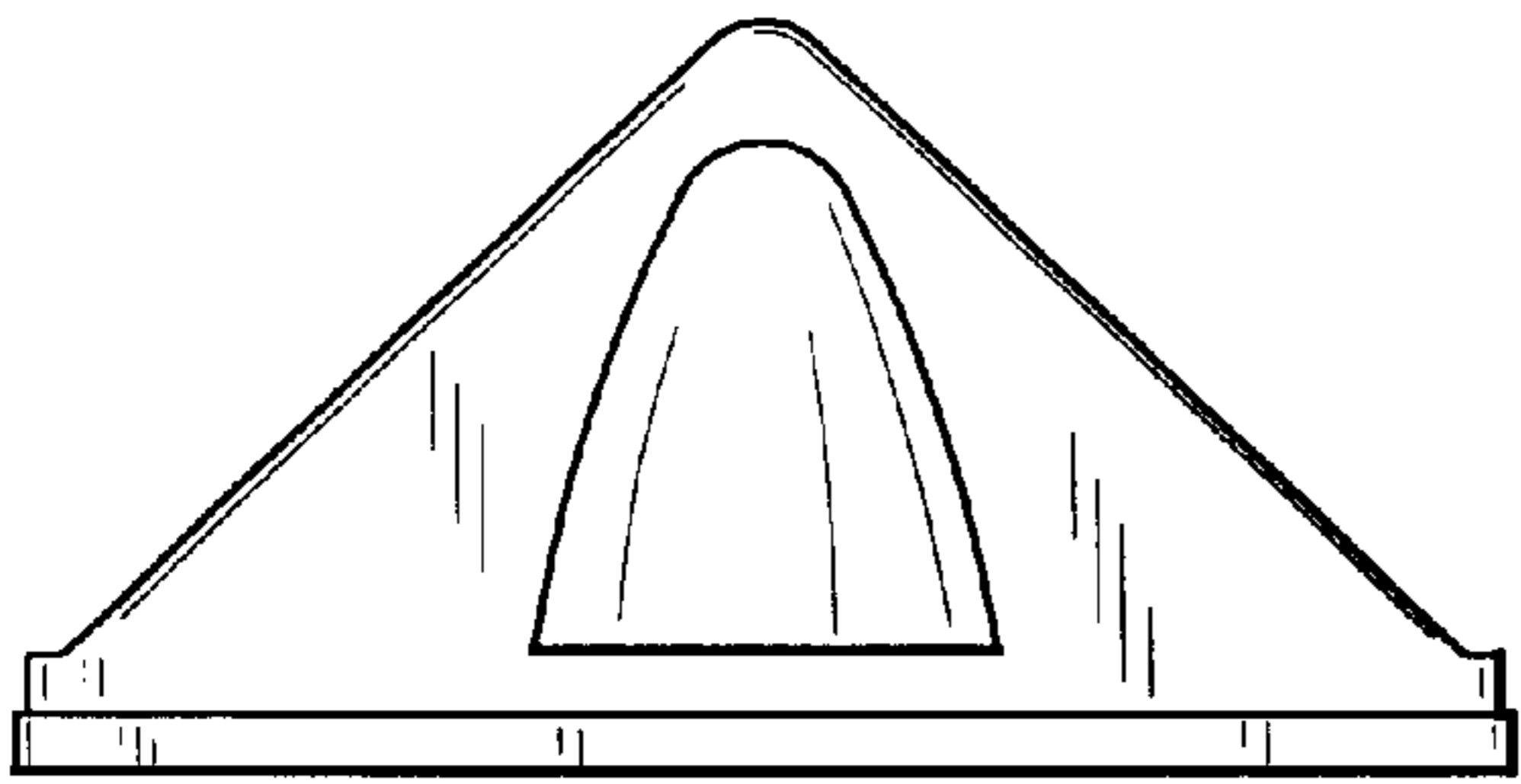

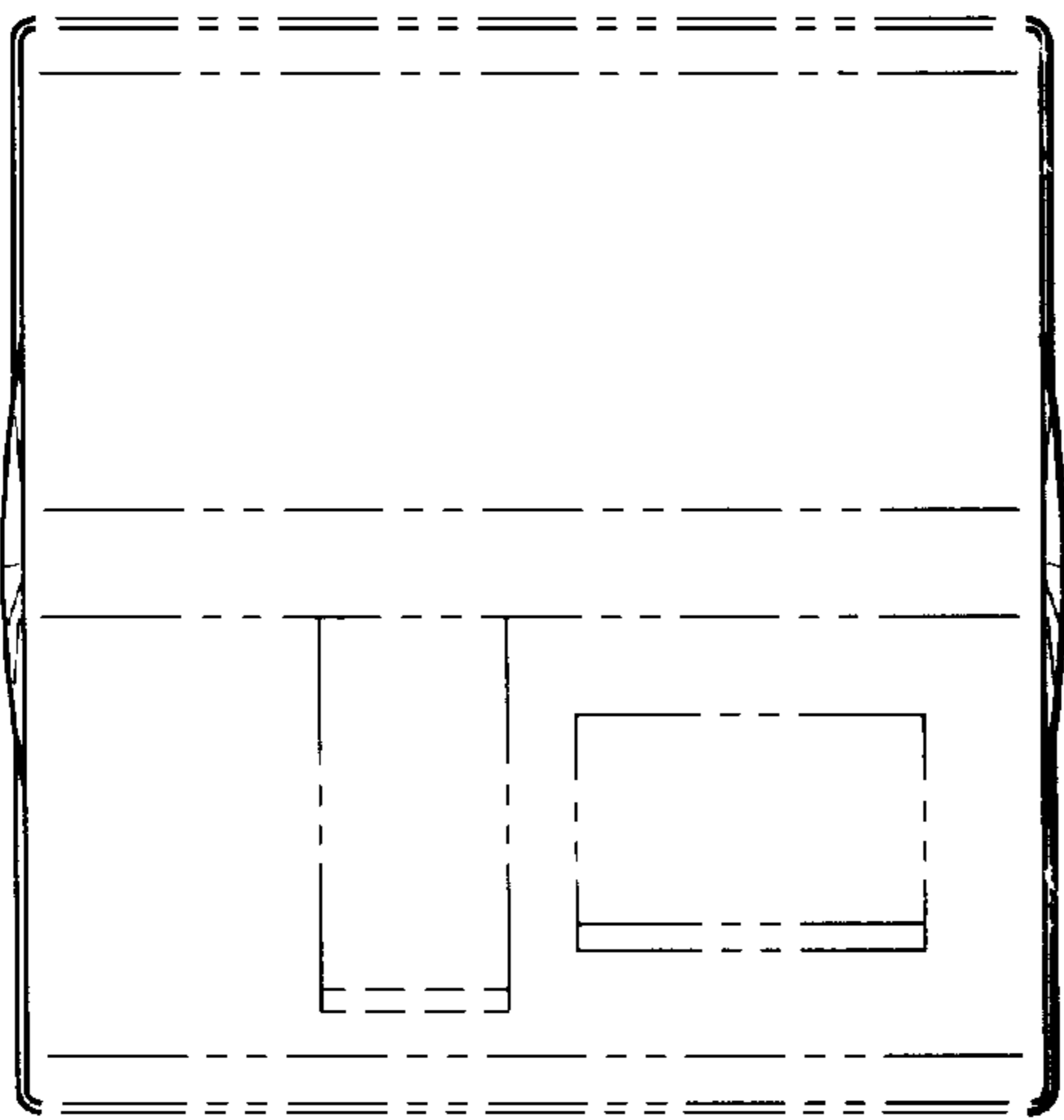

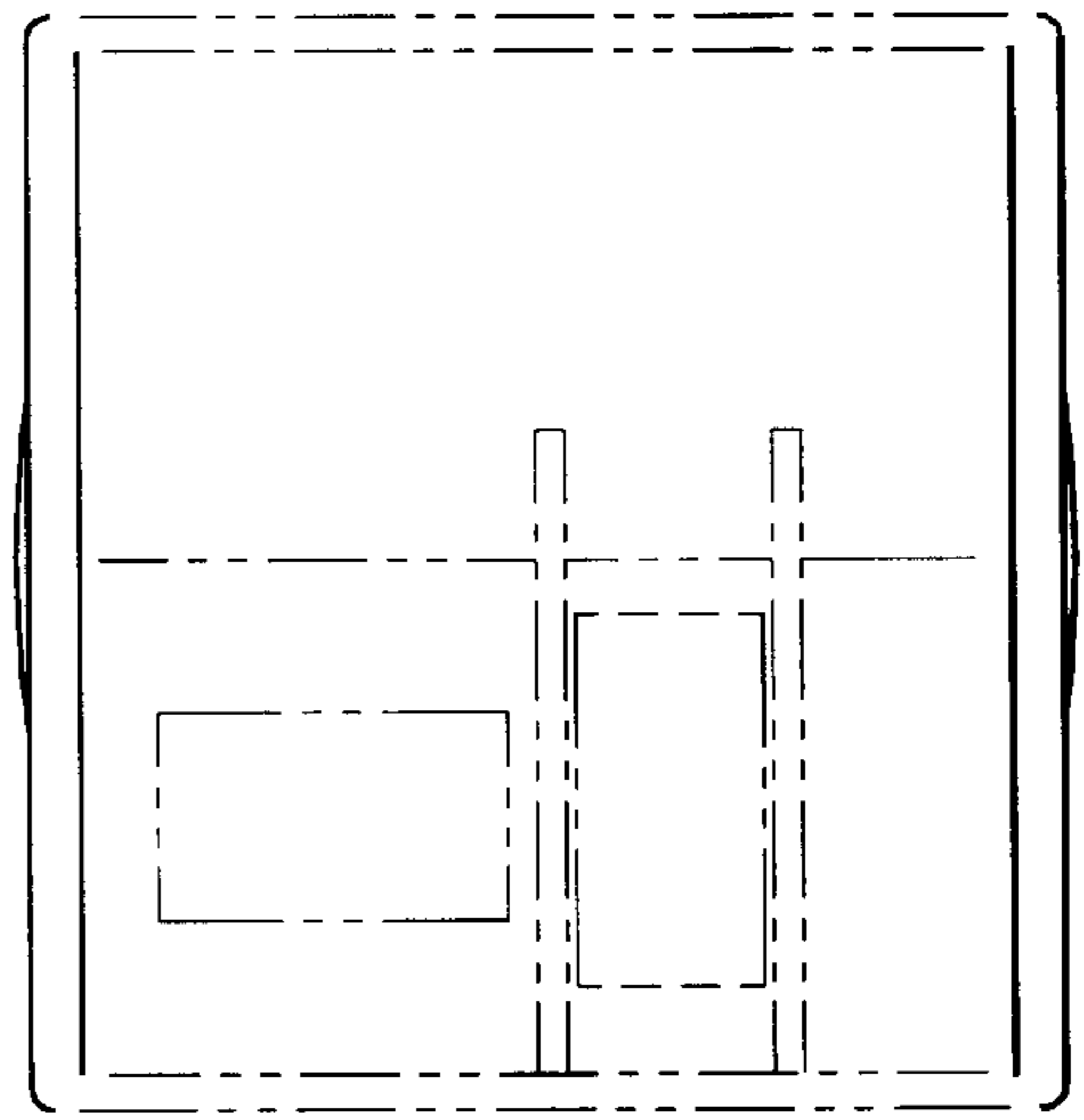

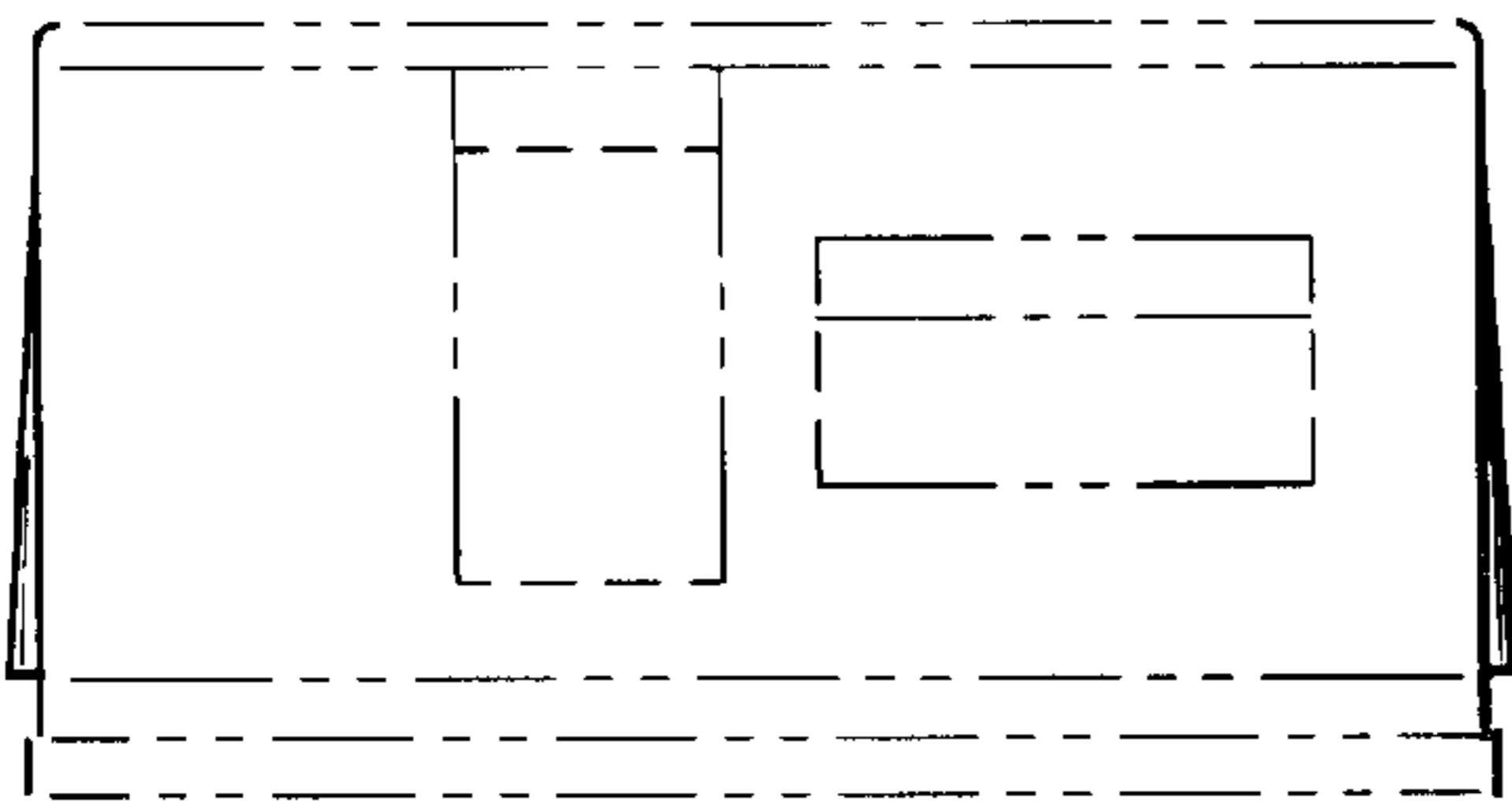
