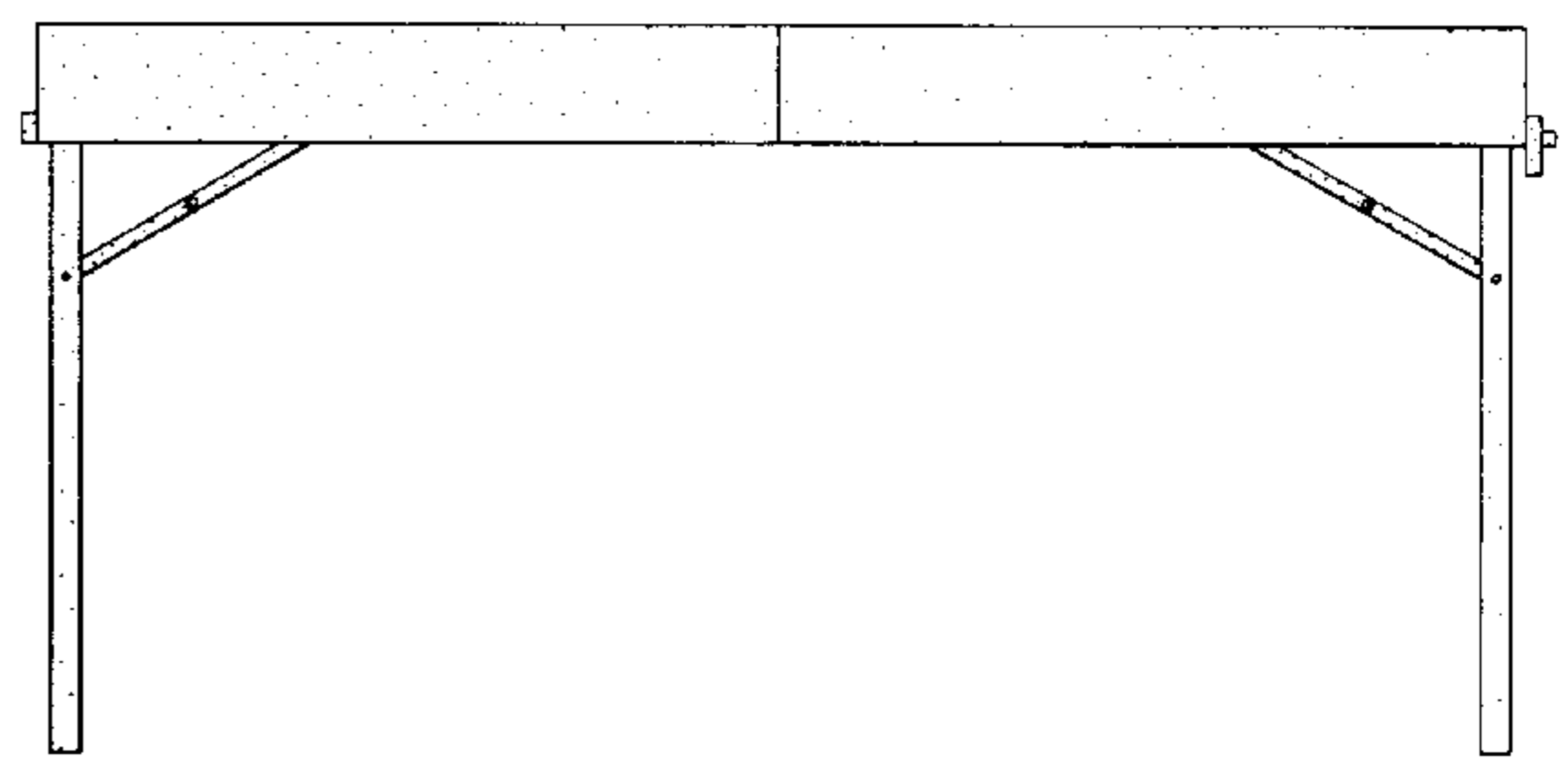
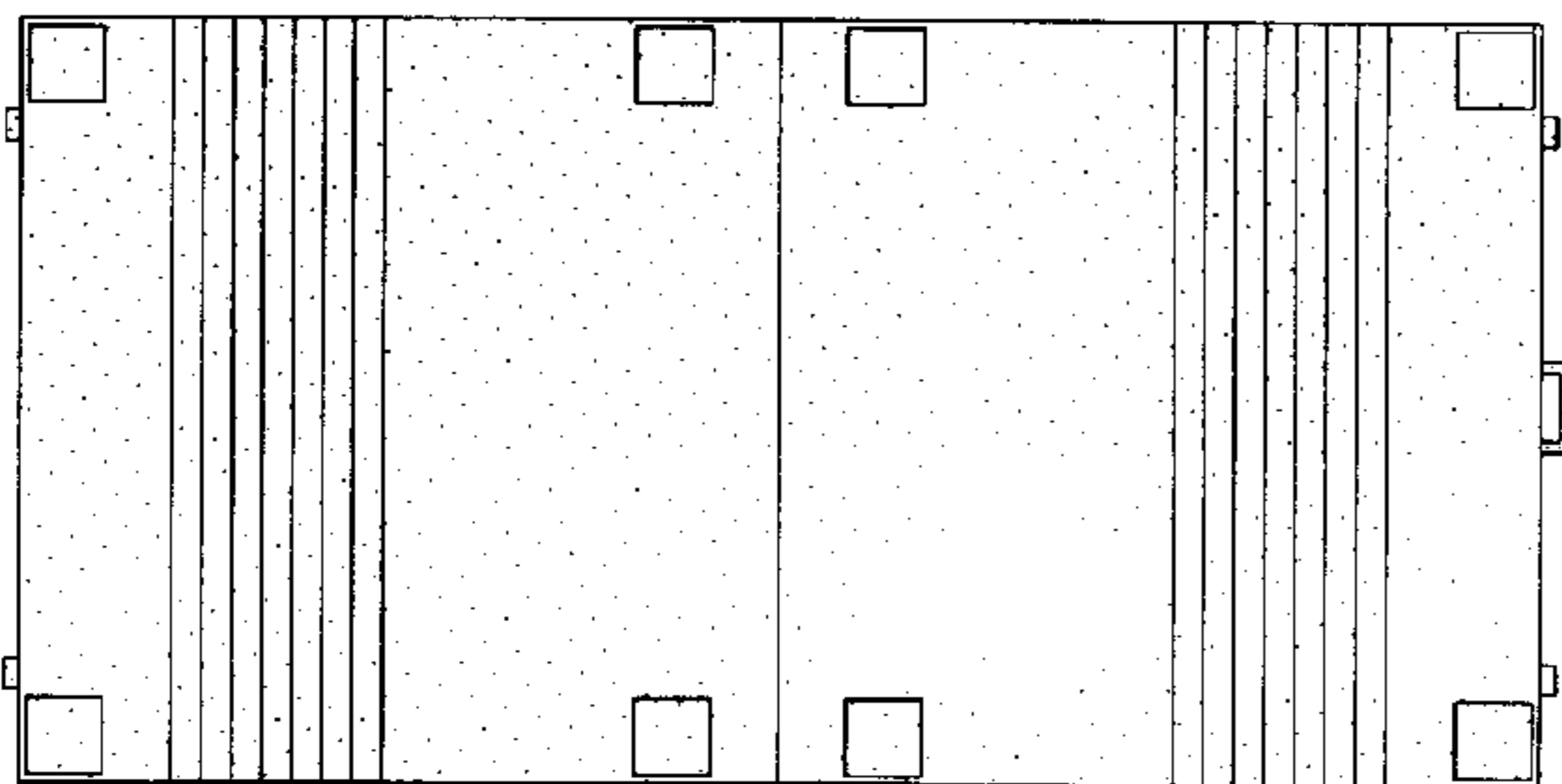
(57) **CLAIM**

The design for a portable folding table, as shown and described.

DESCRIPTION

FIG. 1 is a top plan view of a portable folding table showing my design.
 FIG. 2 is a bottom plan view thereof.
 FIG. 3 is a right side elevational view thereof.
 FIG. 4 is a left side elevational view thereof.
 FIG. 5 is a left side elevational view thereof showing the legs of the table in an extended position.
 FIG. 6 is a front elevational view thereof.
 FIG. 7 is a front elevational view of an alternate embodiment thereof showing the handle of the table in a centered position.
 FIG. 8 is a rear elevational view thereof.
 FIG. 9 is a front elevational view thereof in a folded position.
 FIG. 10 is a rear elevational view thereof in a folded position.
 FIG. 11 is a top plan view thereof in a folded position with the bottom plan view thereof being identical to the top plan view.
 FIG. 12 is a left side elevational view thereof in a folded position; and,
 FIG. 13 is a right side elevational view thereof in a folded position.

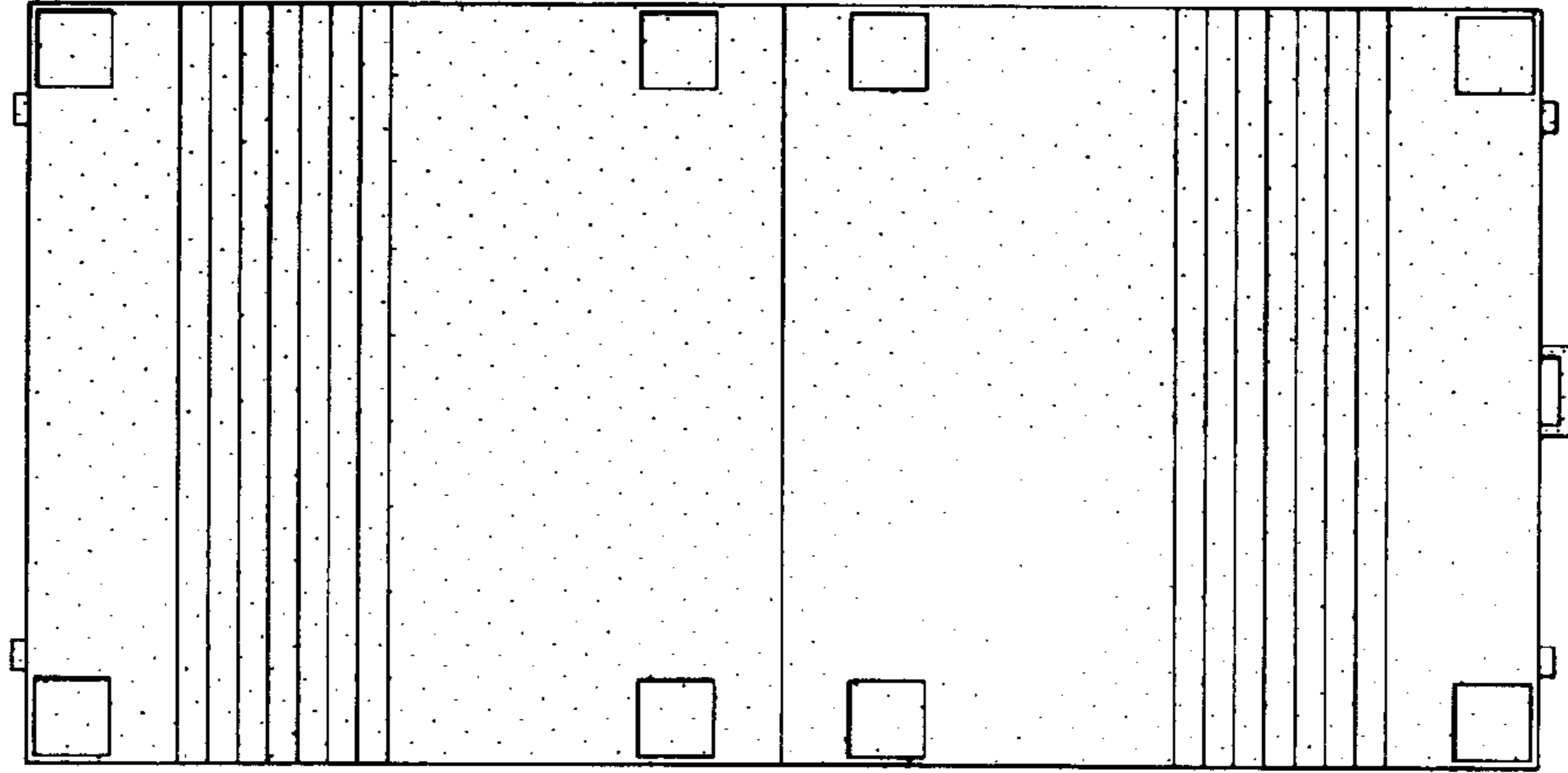

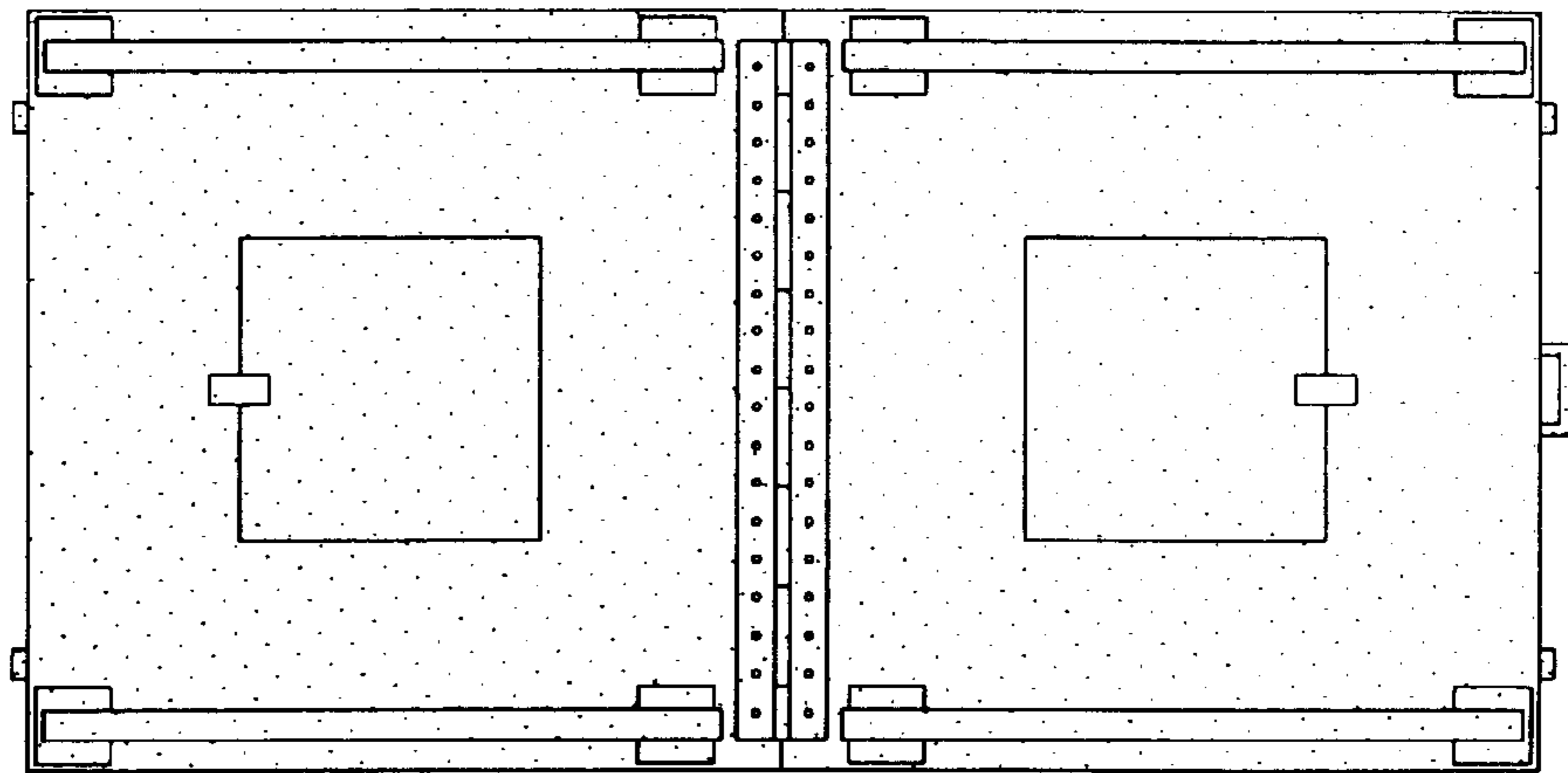

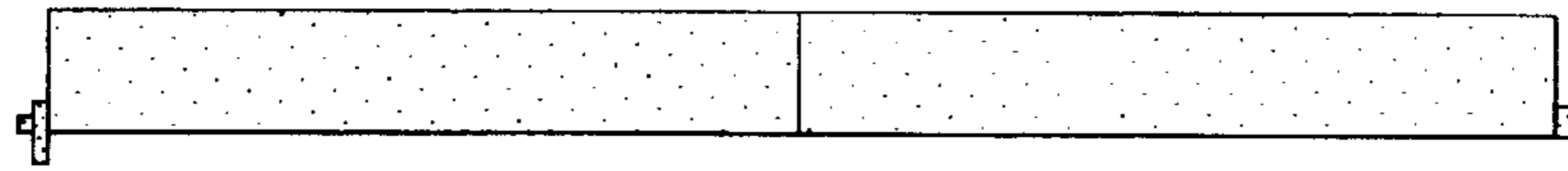

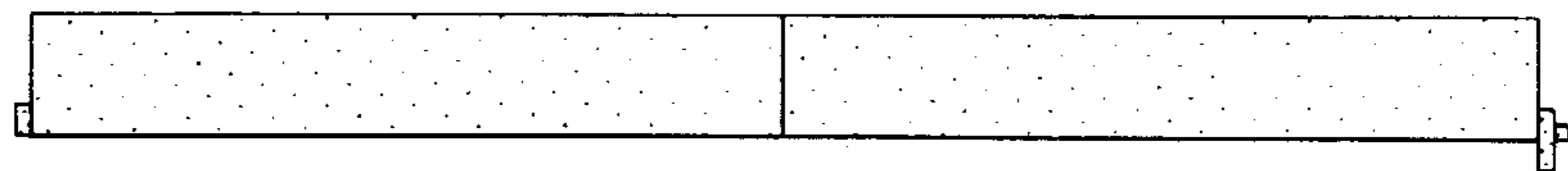

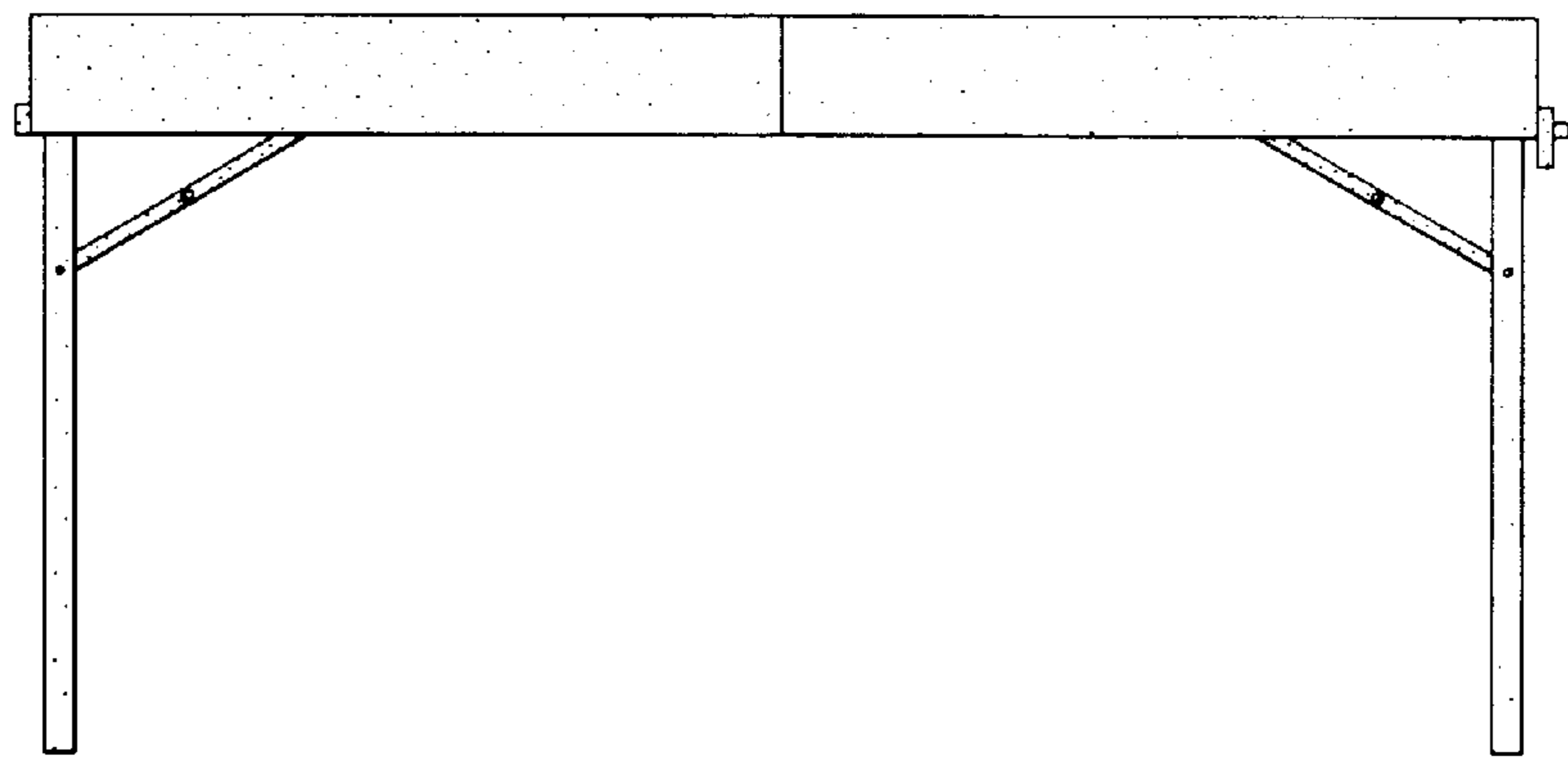

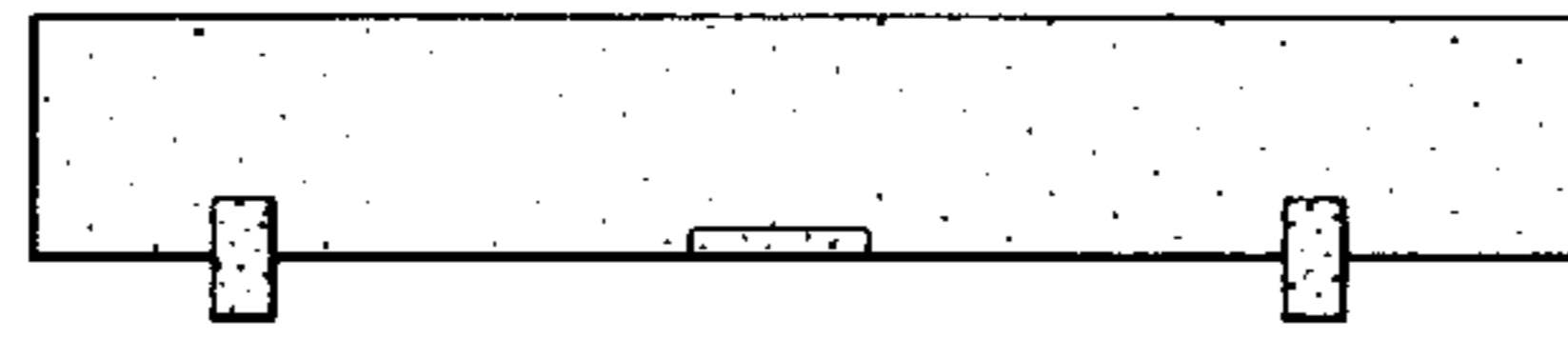

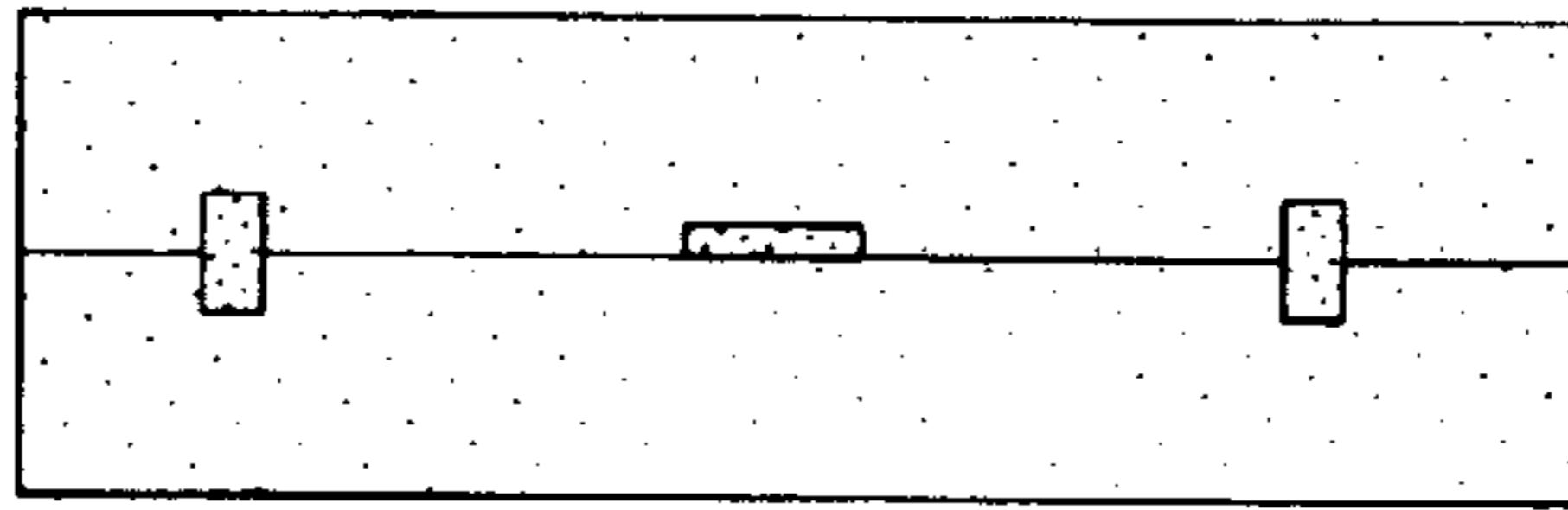

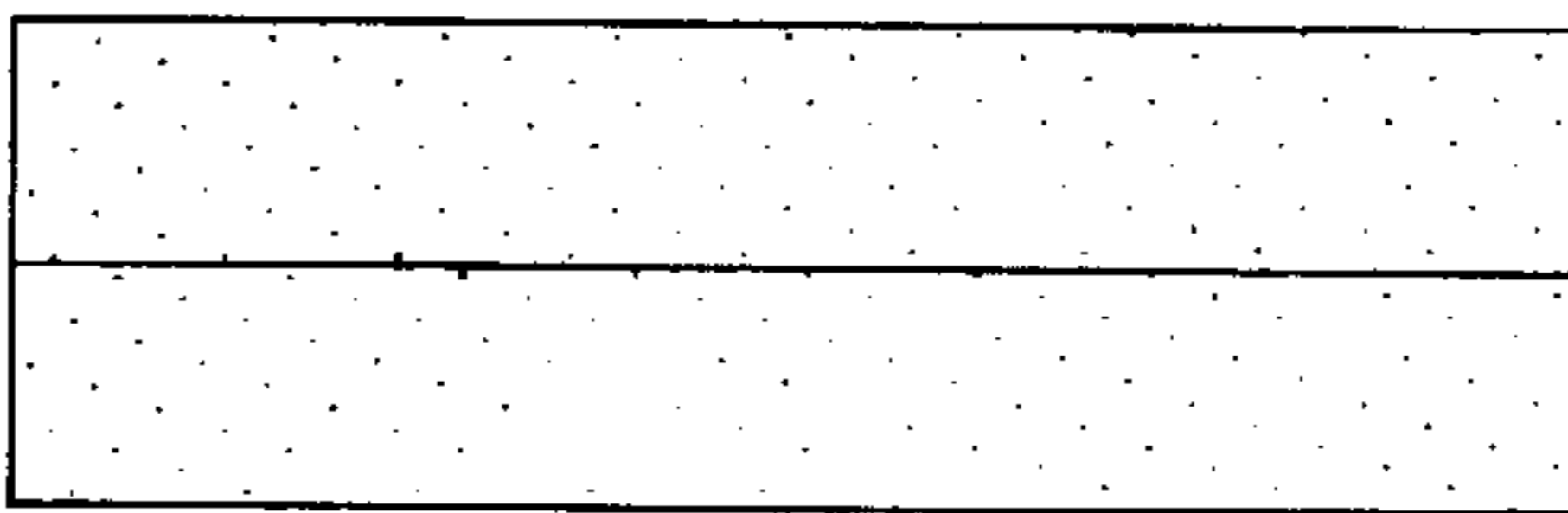

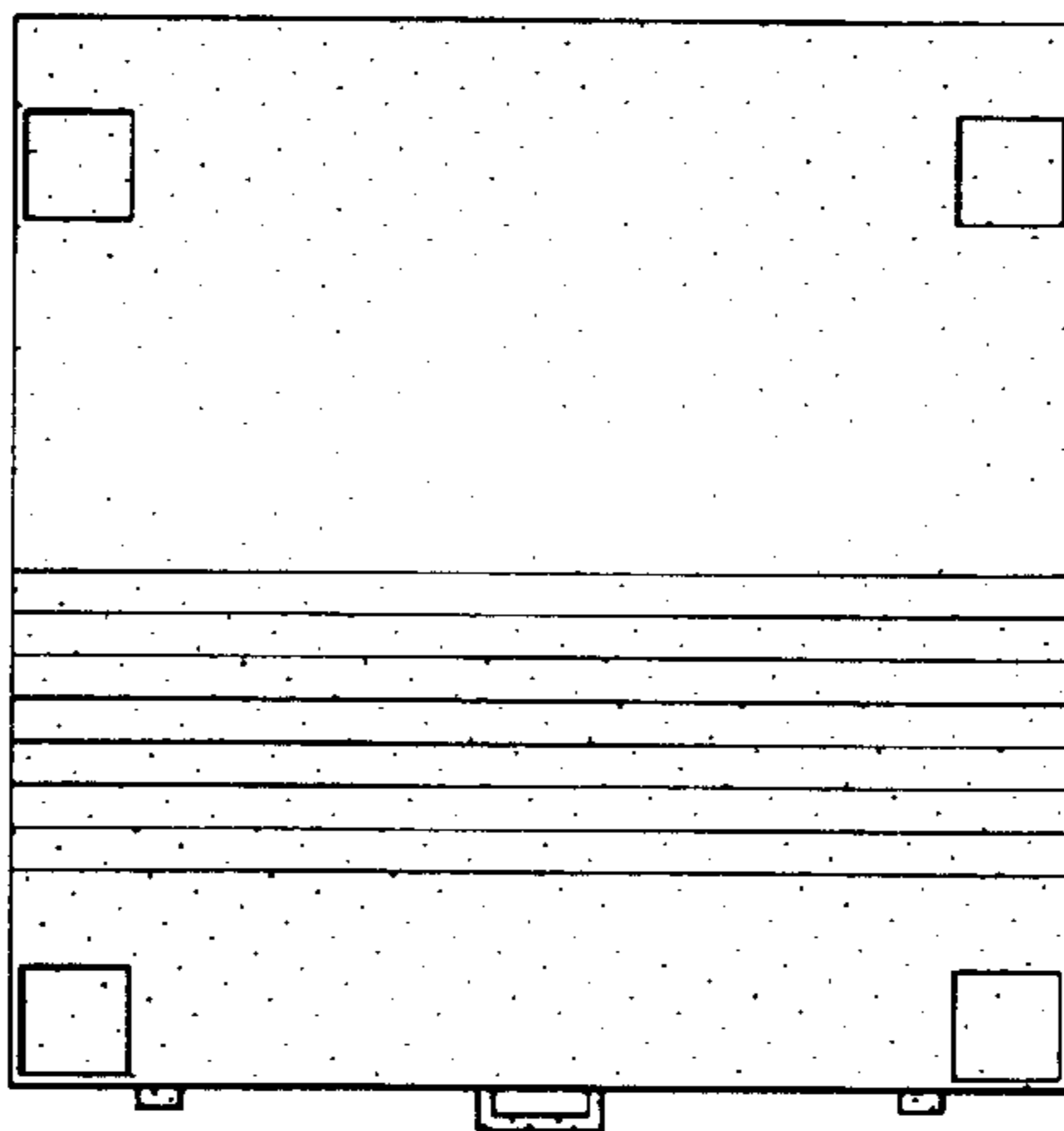

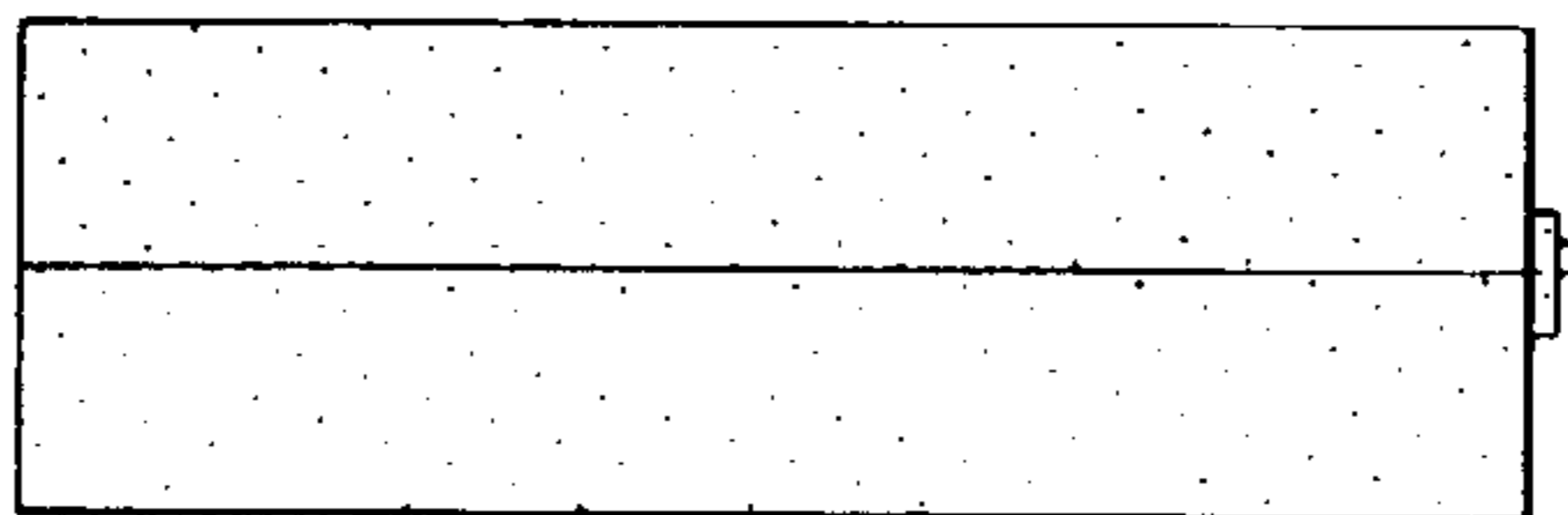
