We claim the ornamental design for a connector piece, as shown in the drawings.

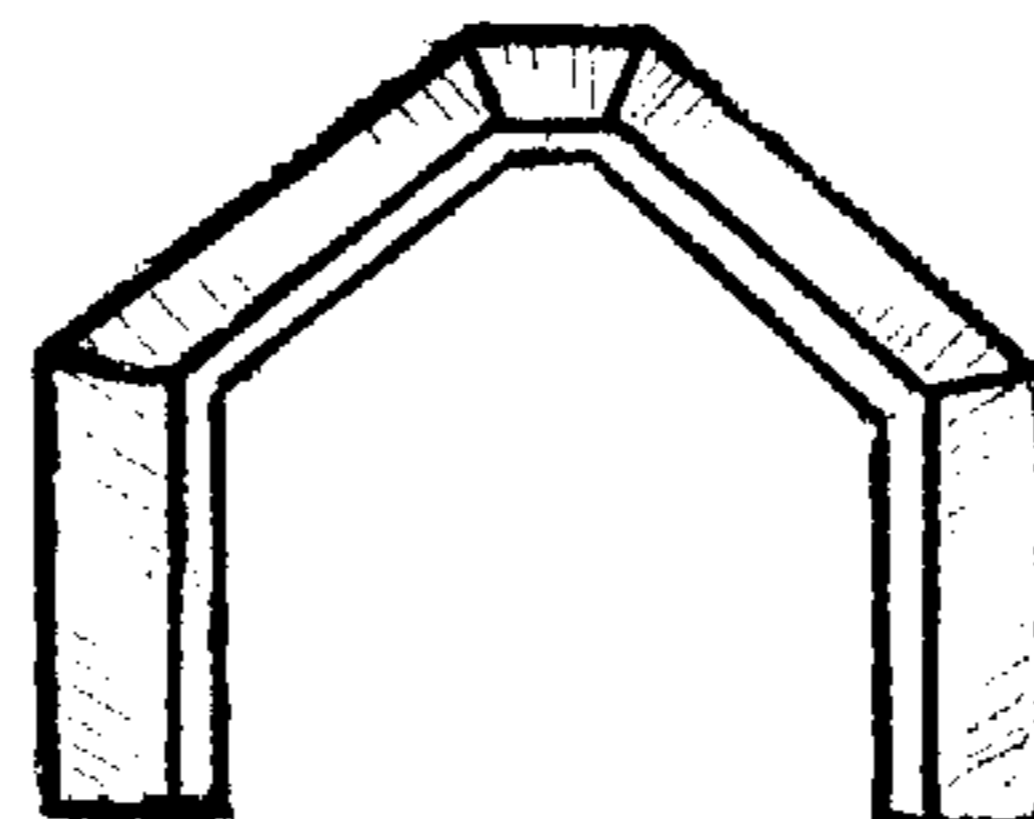
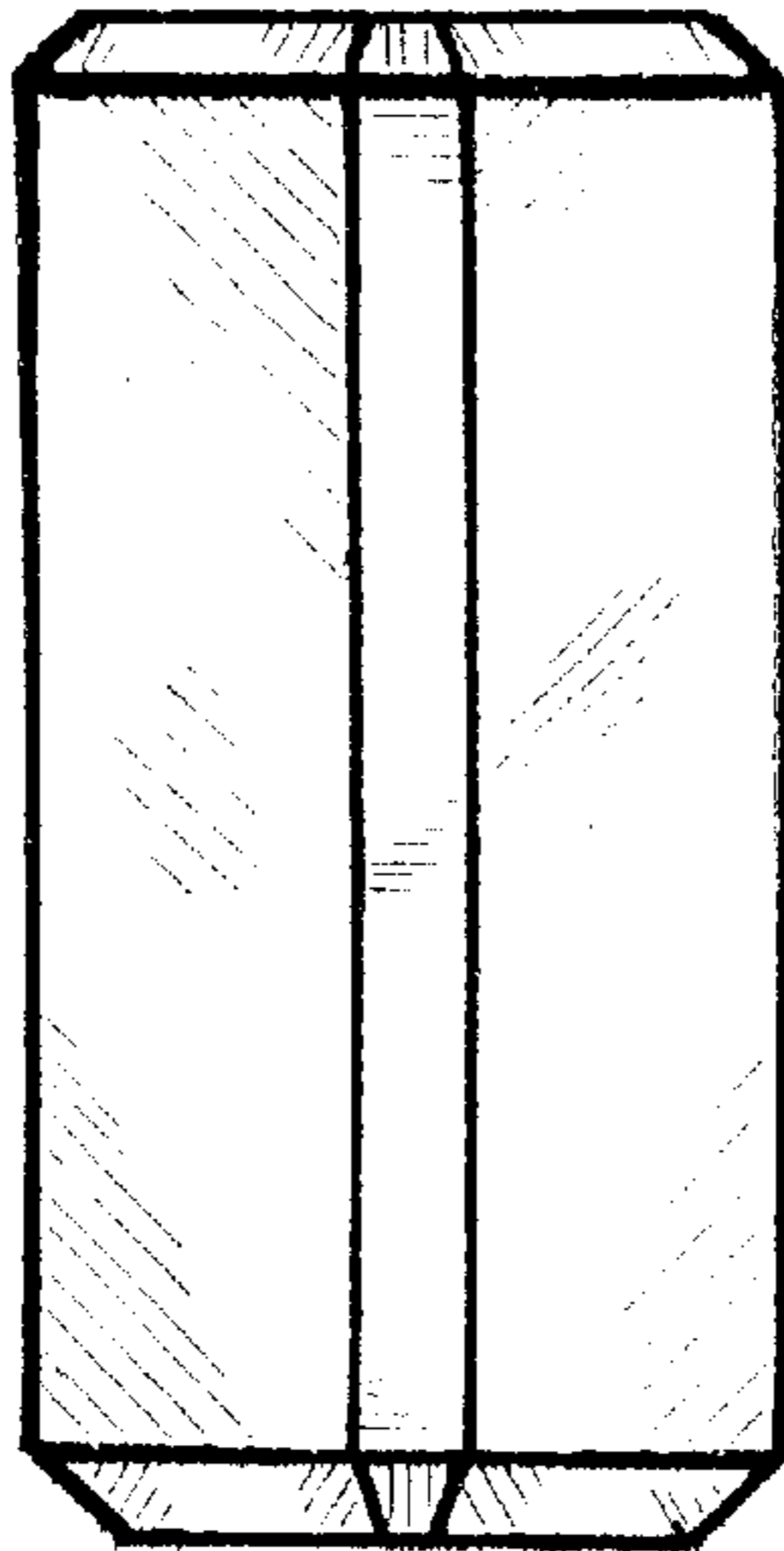
**DESCRIPTION**

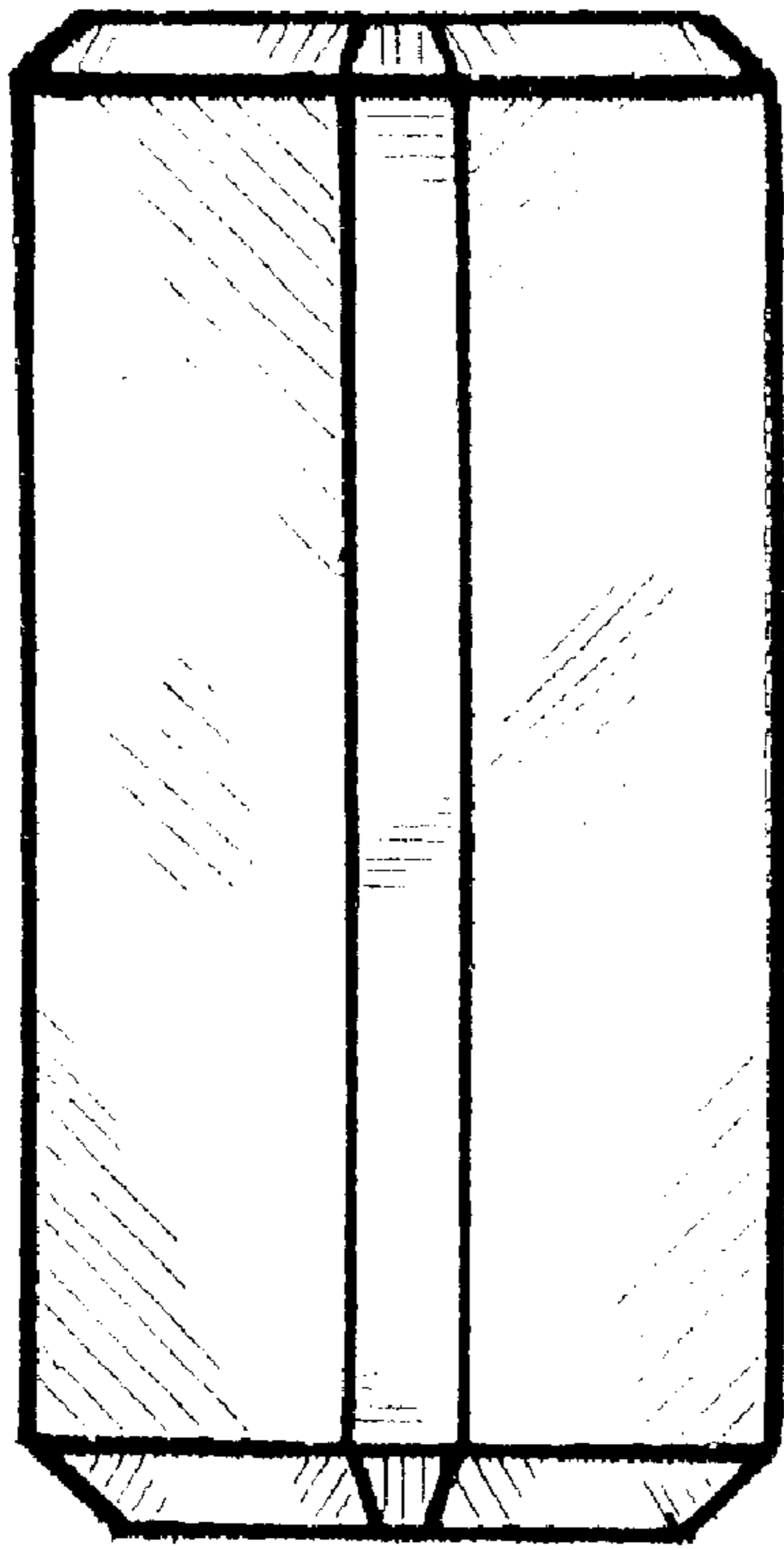

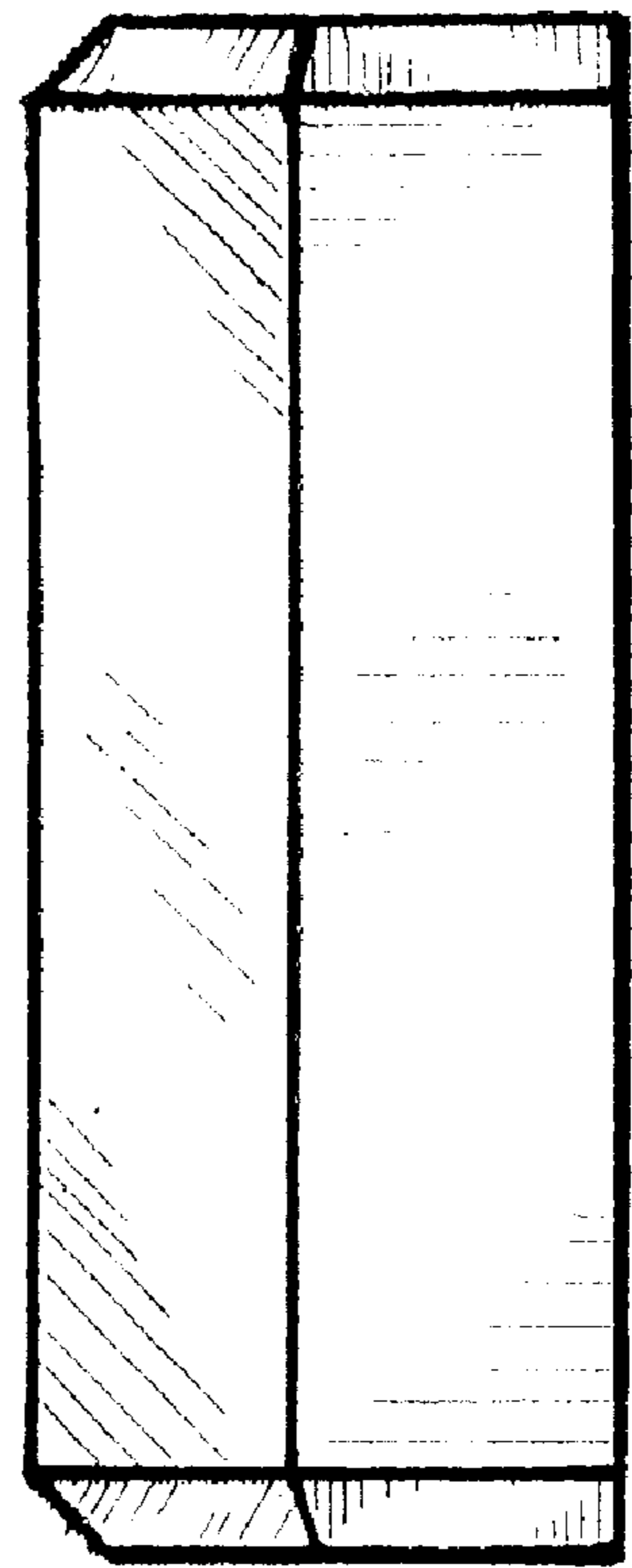

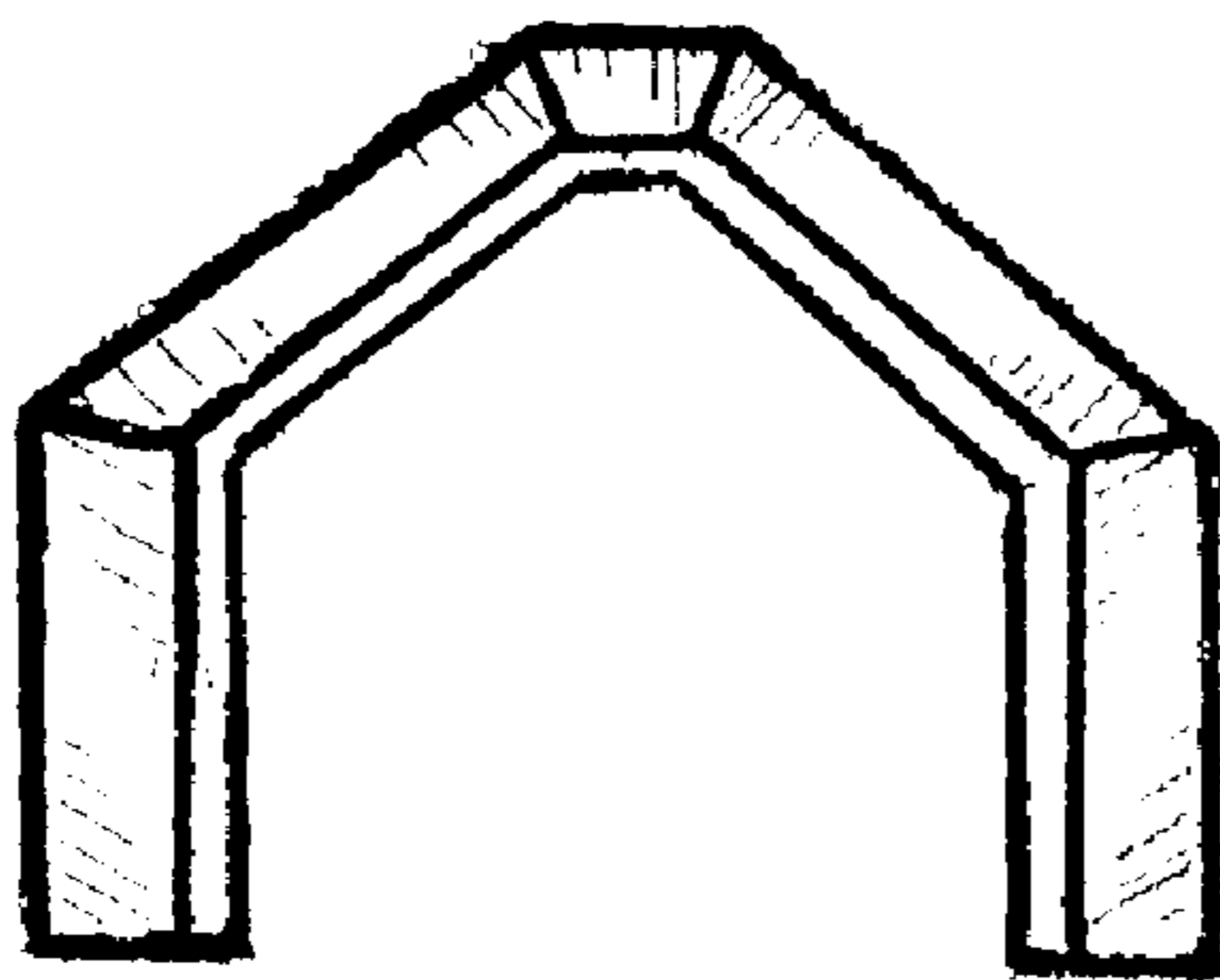
