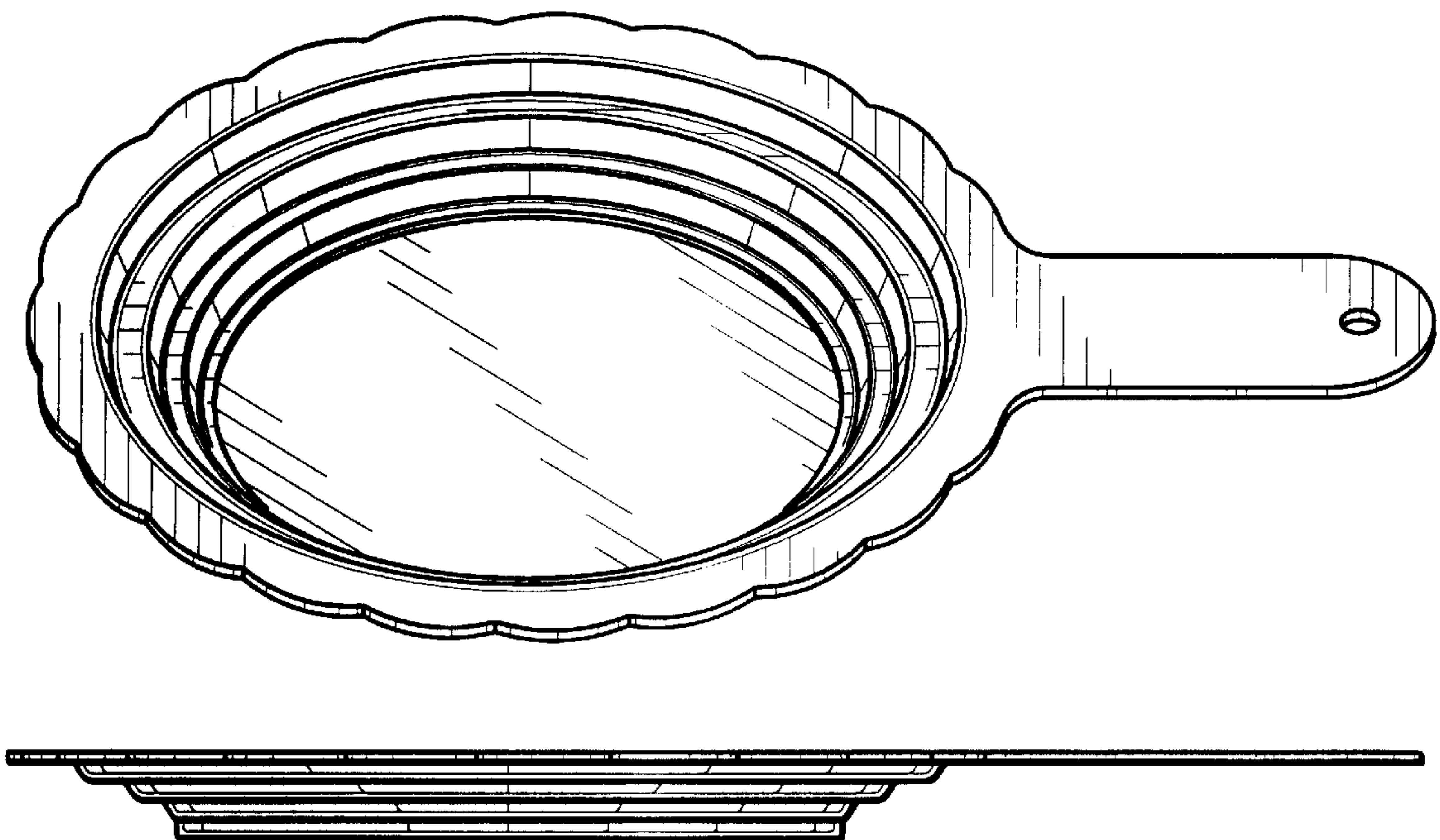
(57) **CLAIM**

The ornamental design for a pan lid with a see-through central section and with concentric elevational rings that allow for the lid to fit variable pan diameters, as shown and described.

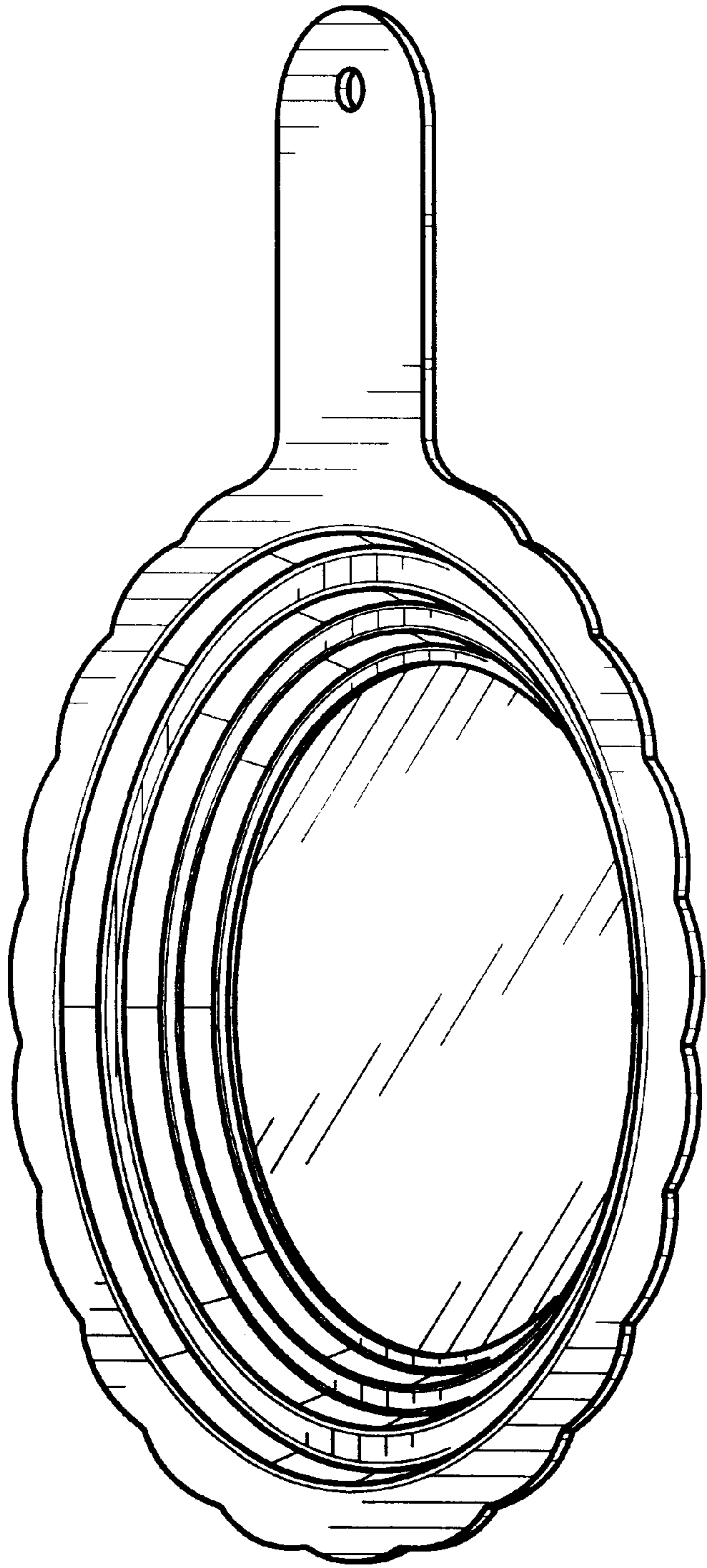

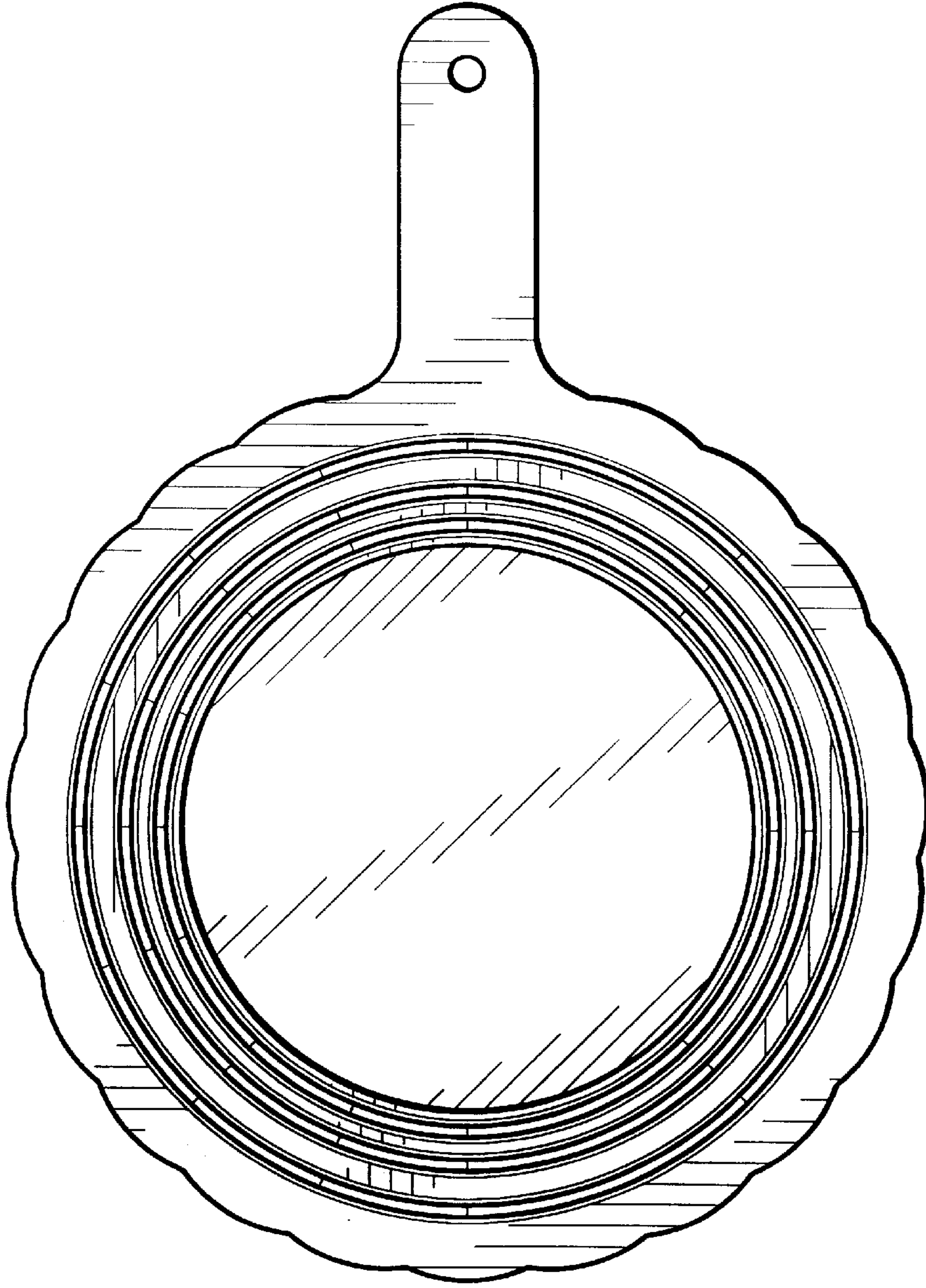

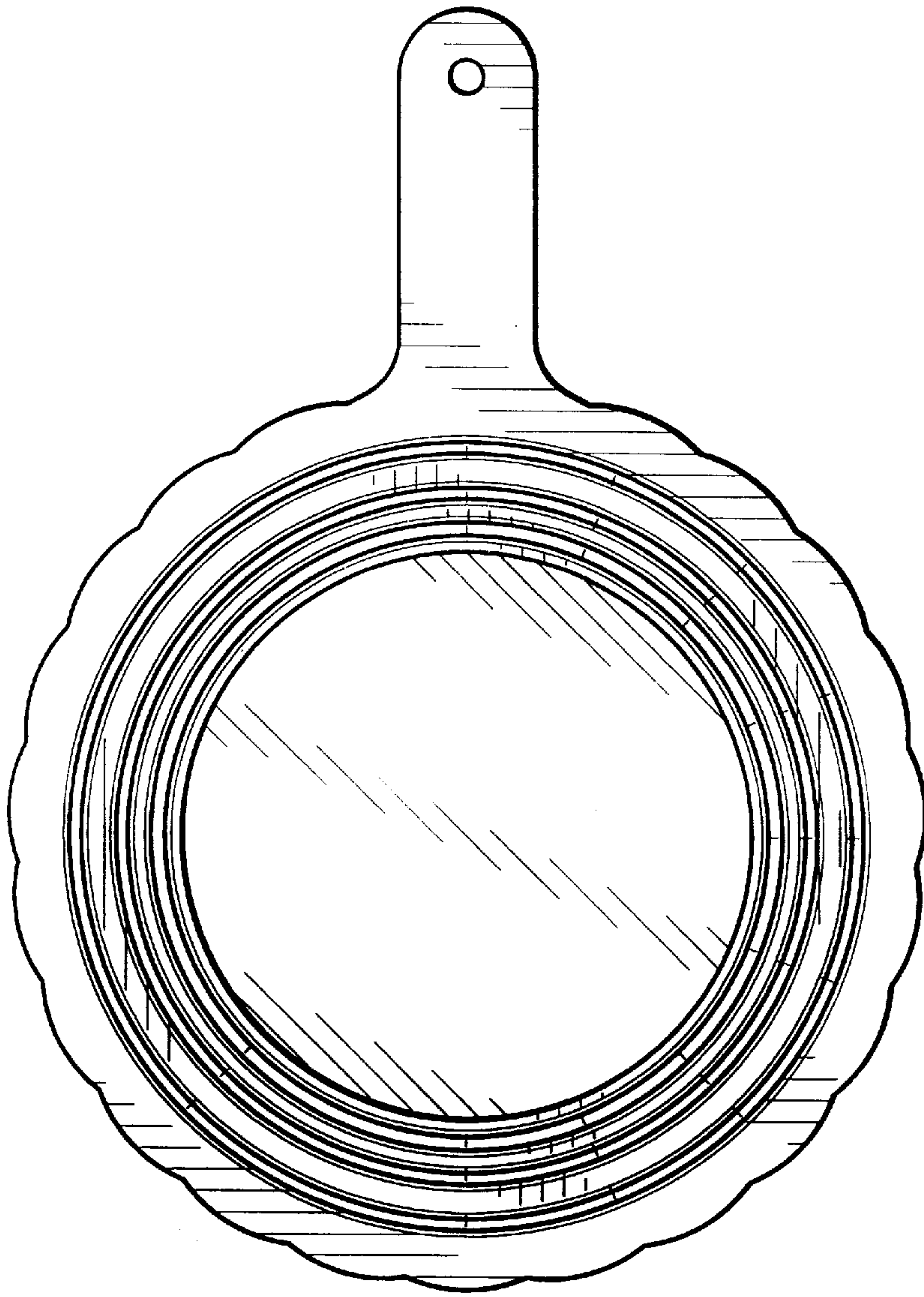

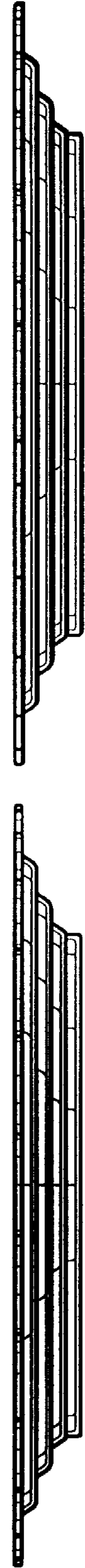
