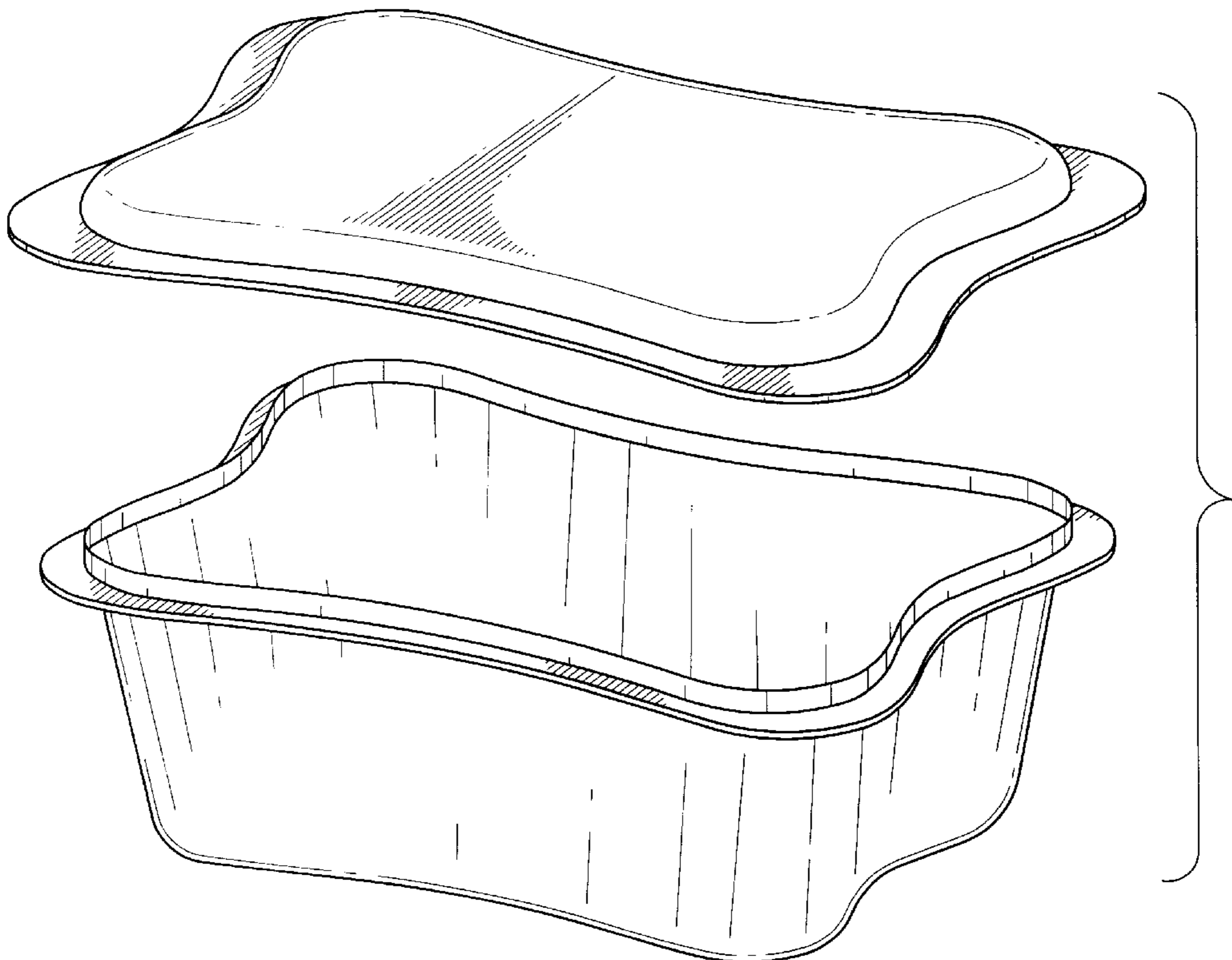
FIG. 1 is an exploded perspective view of the food container showing my new design;

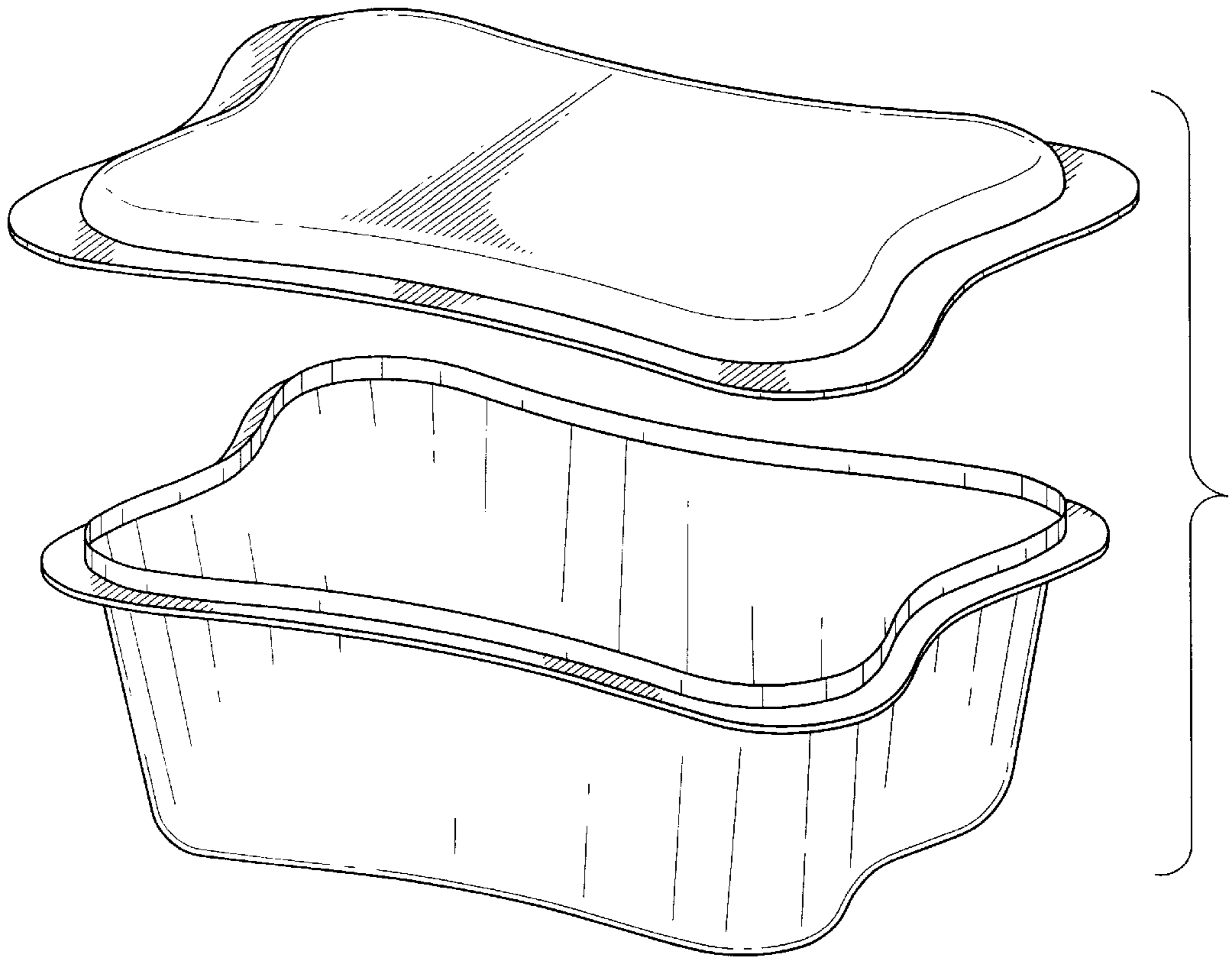

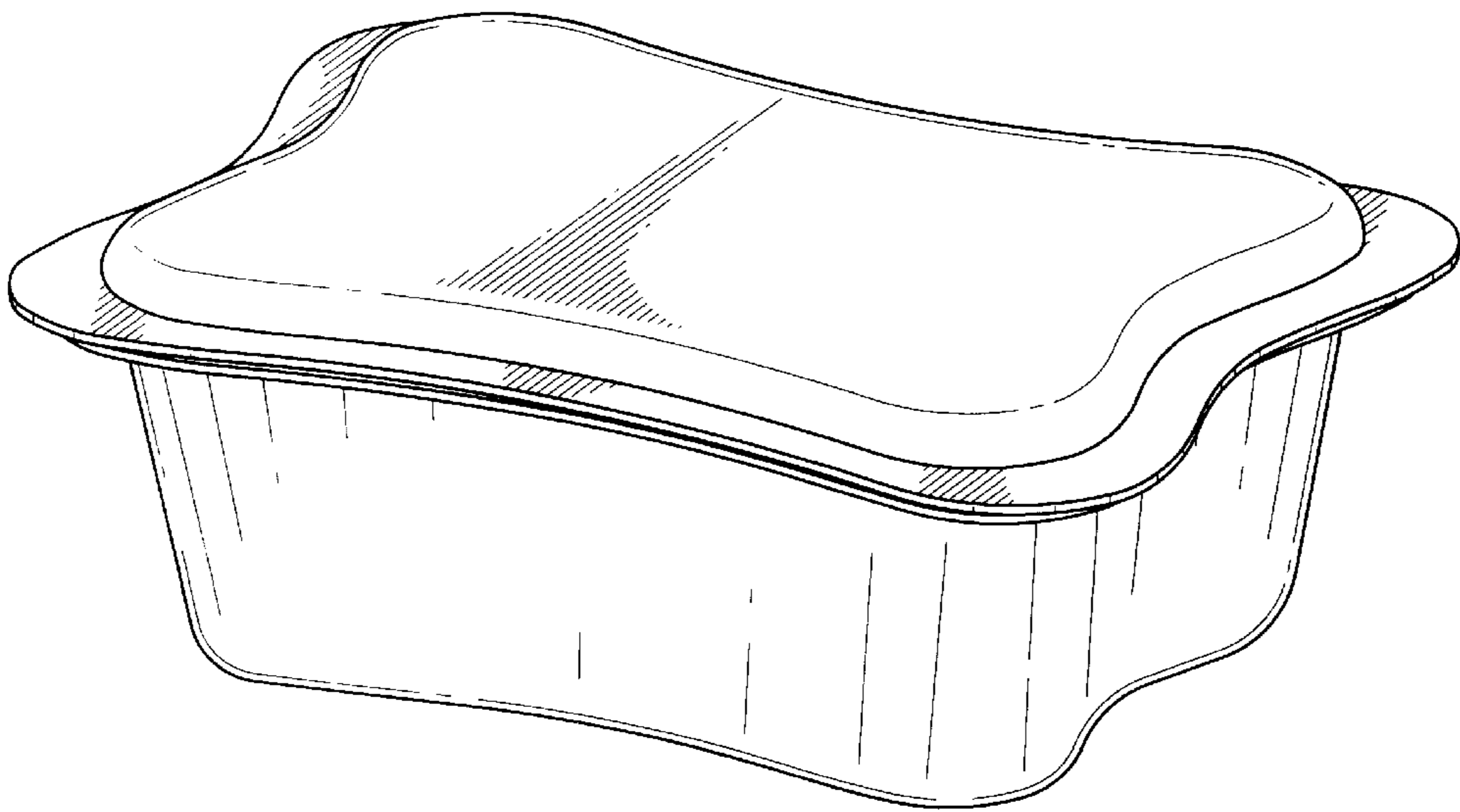

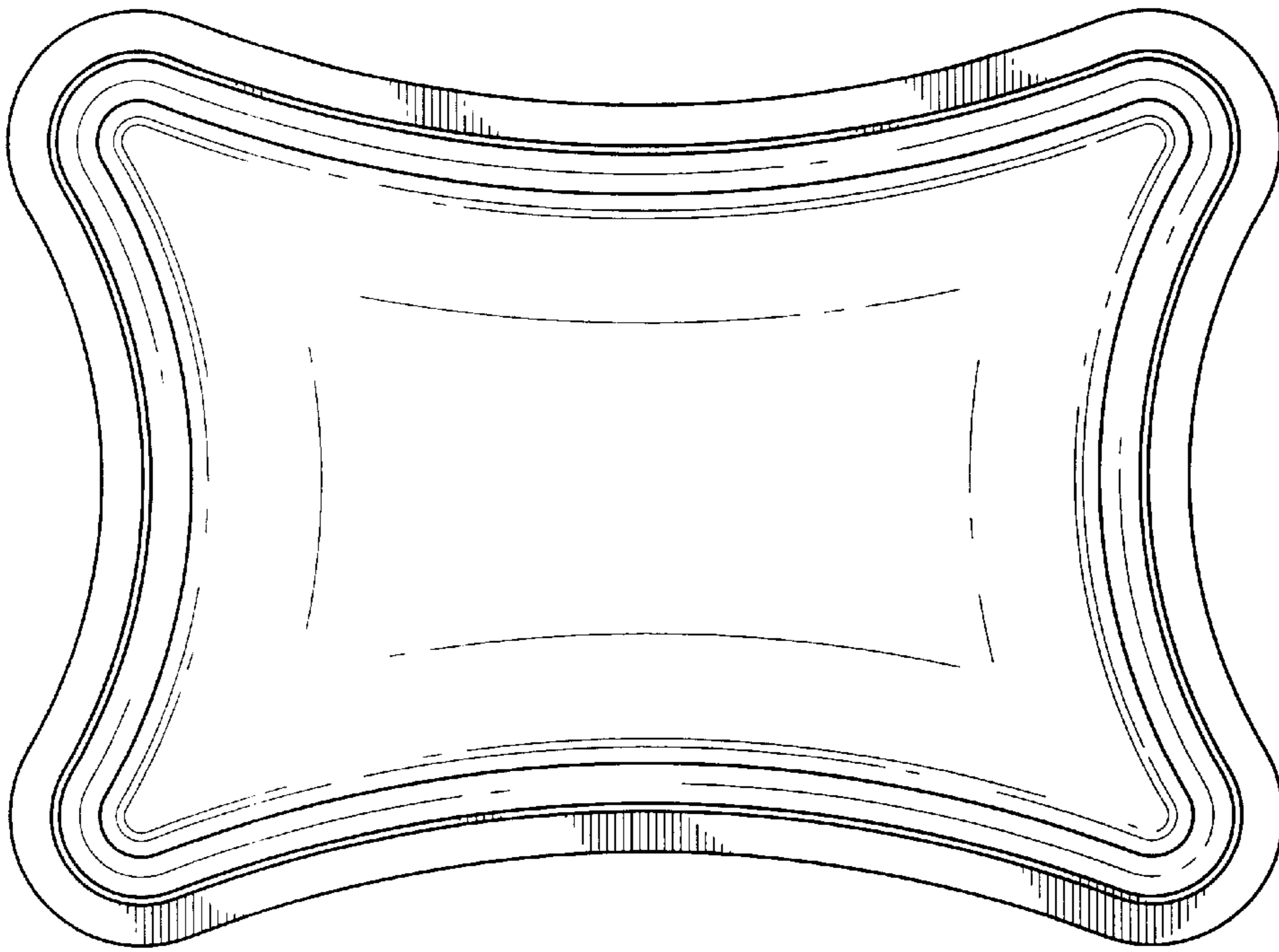

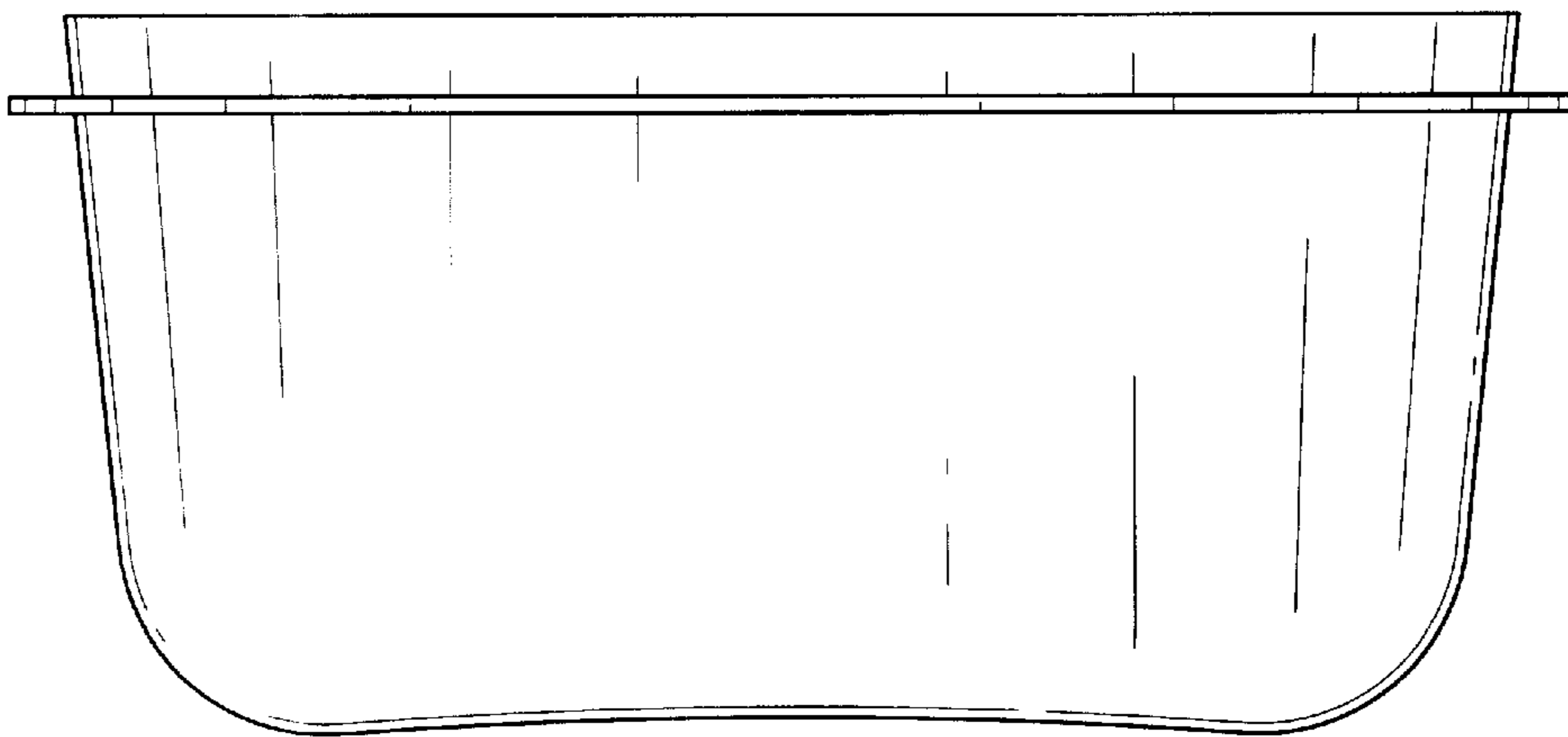

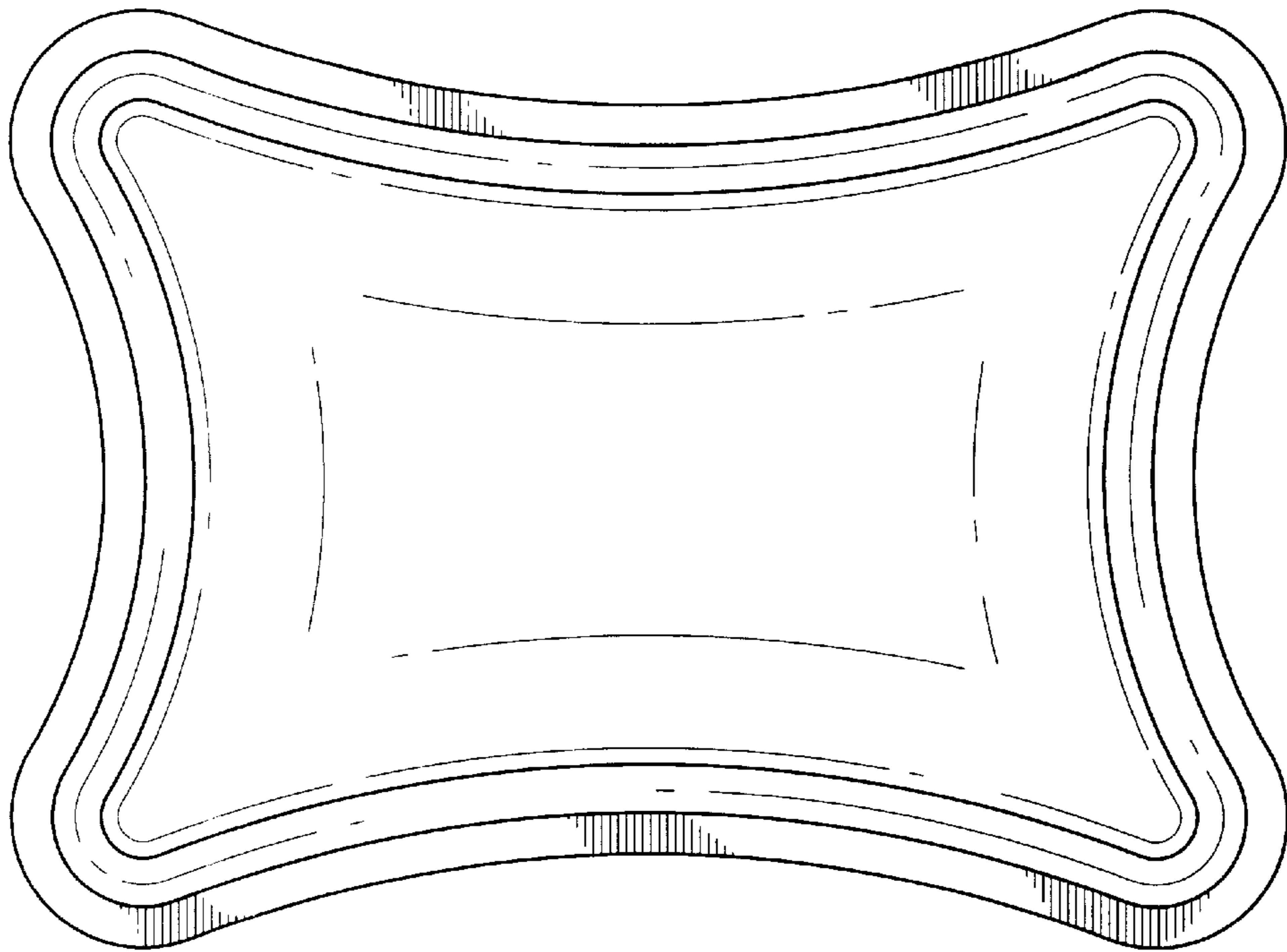

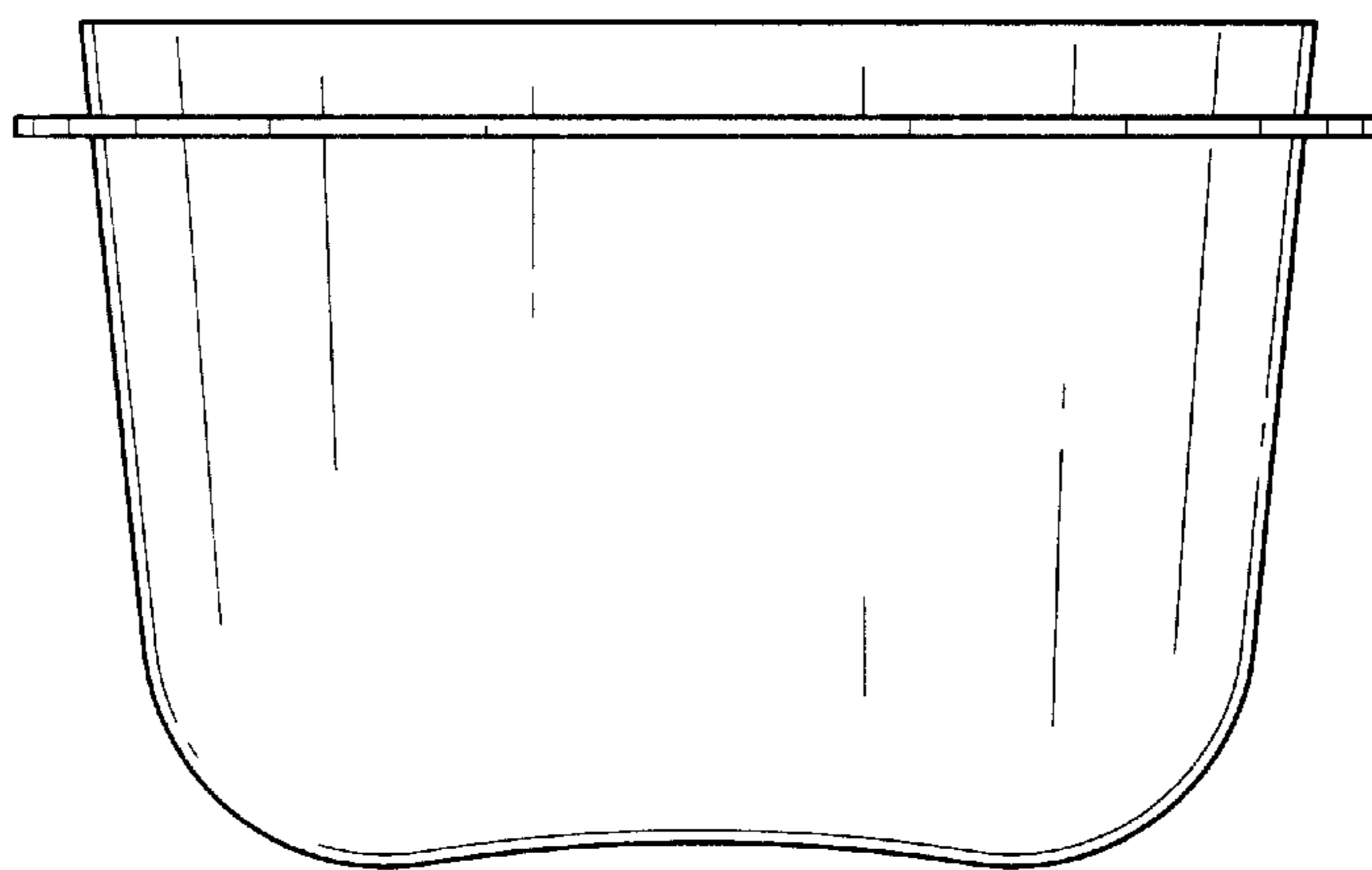

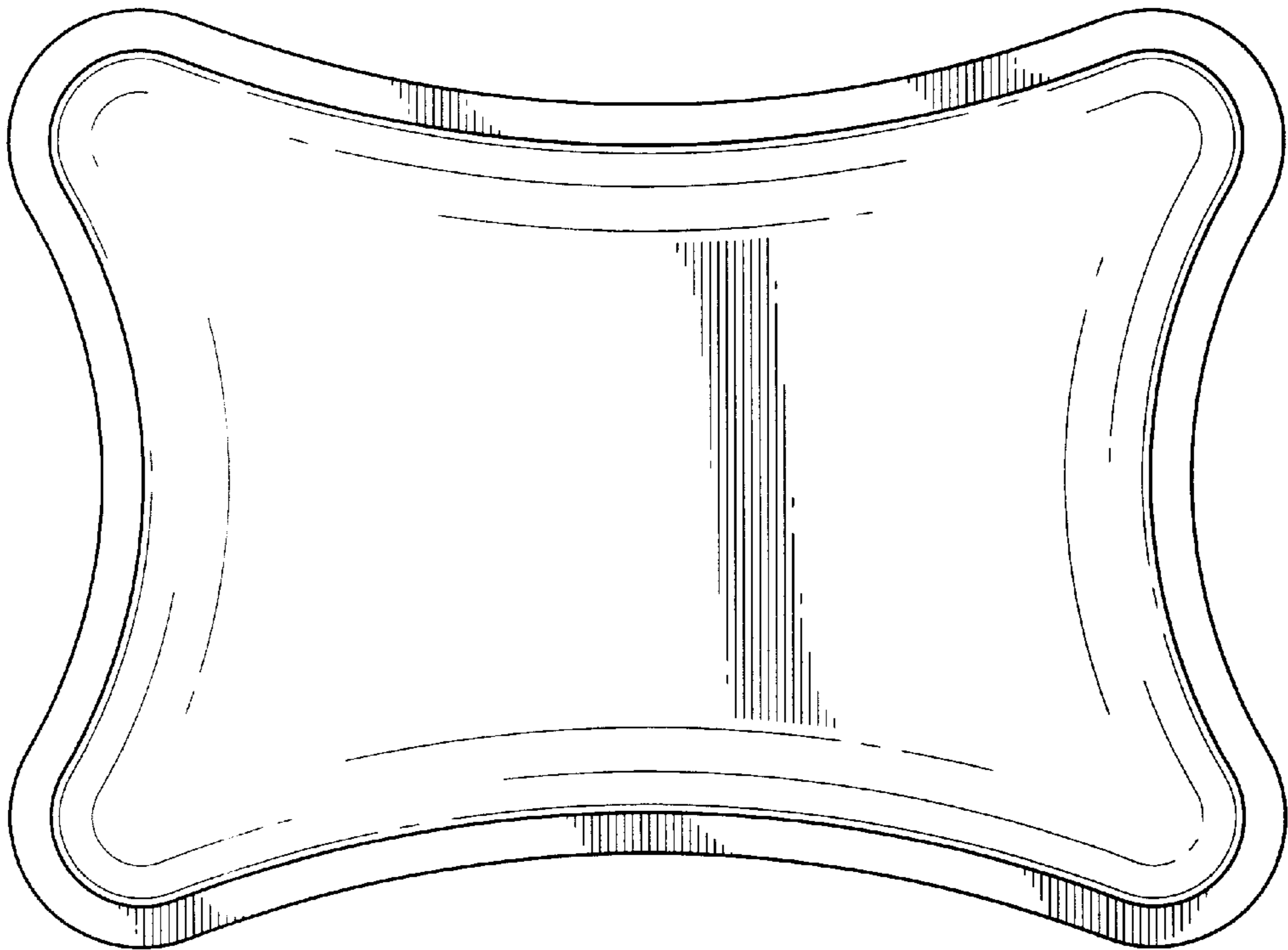

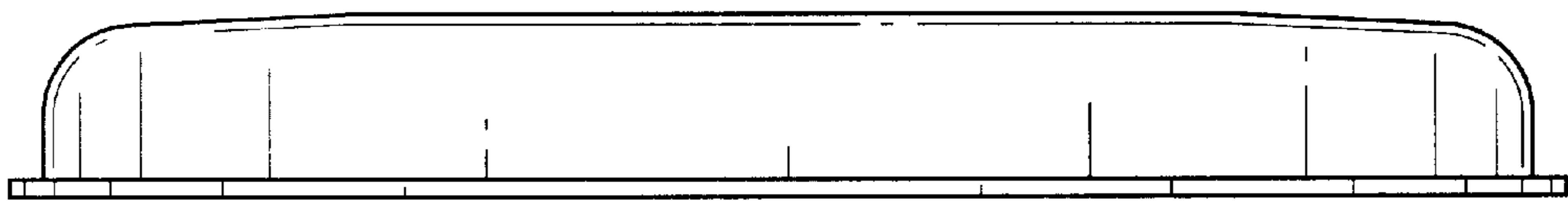

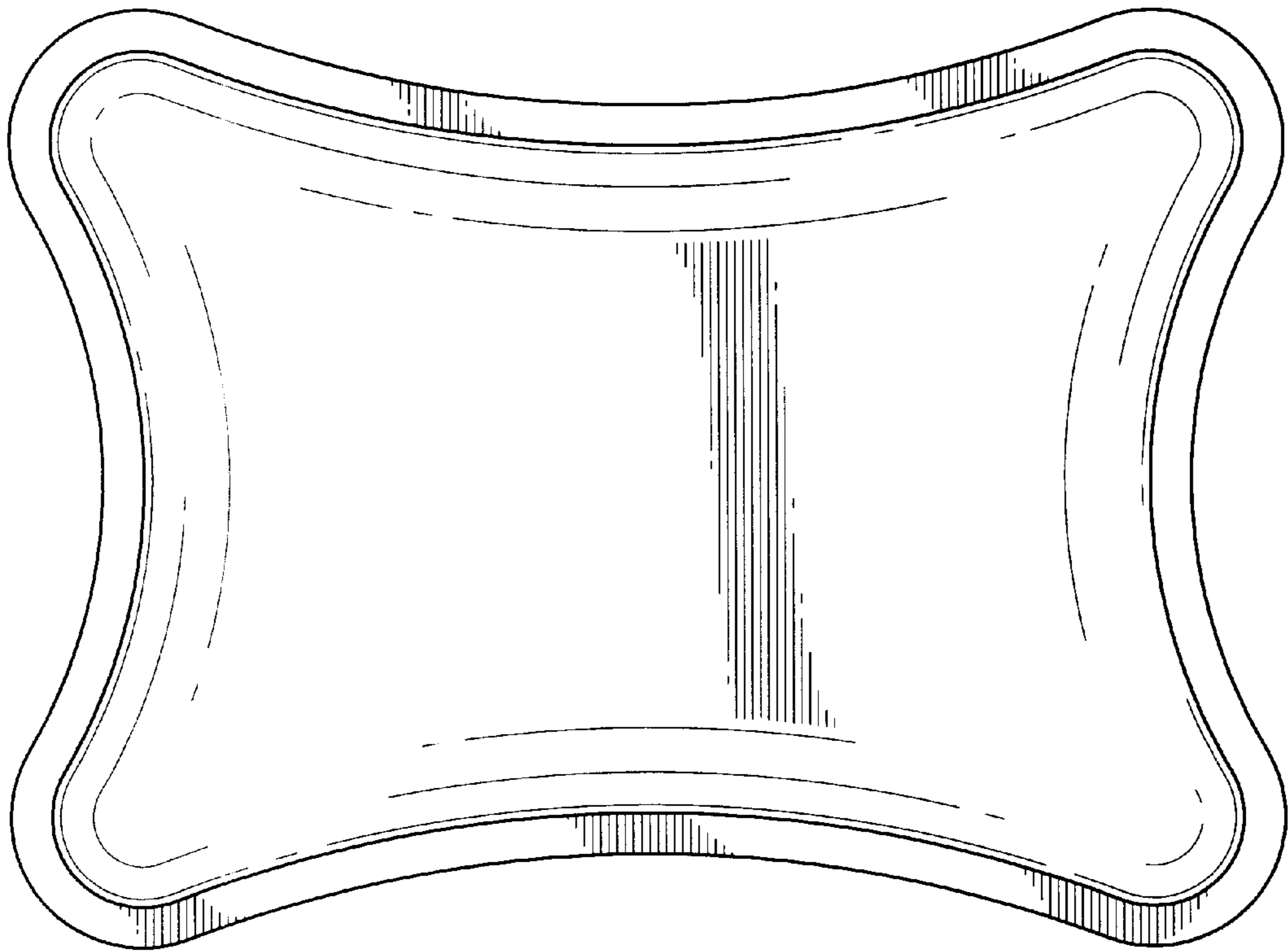

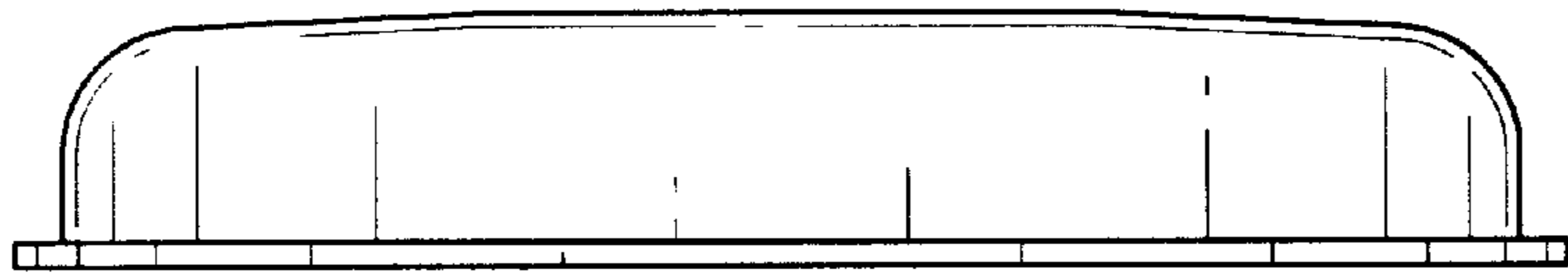
