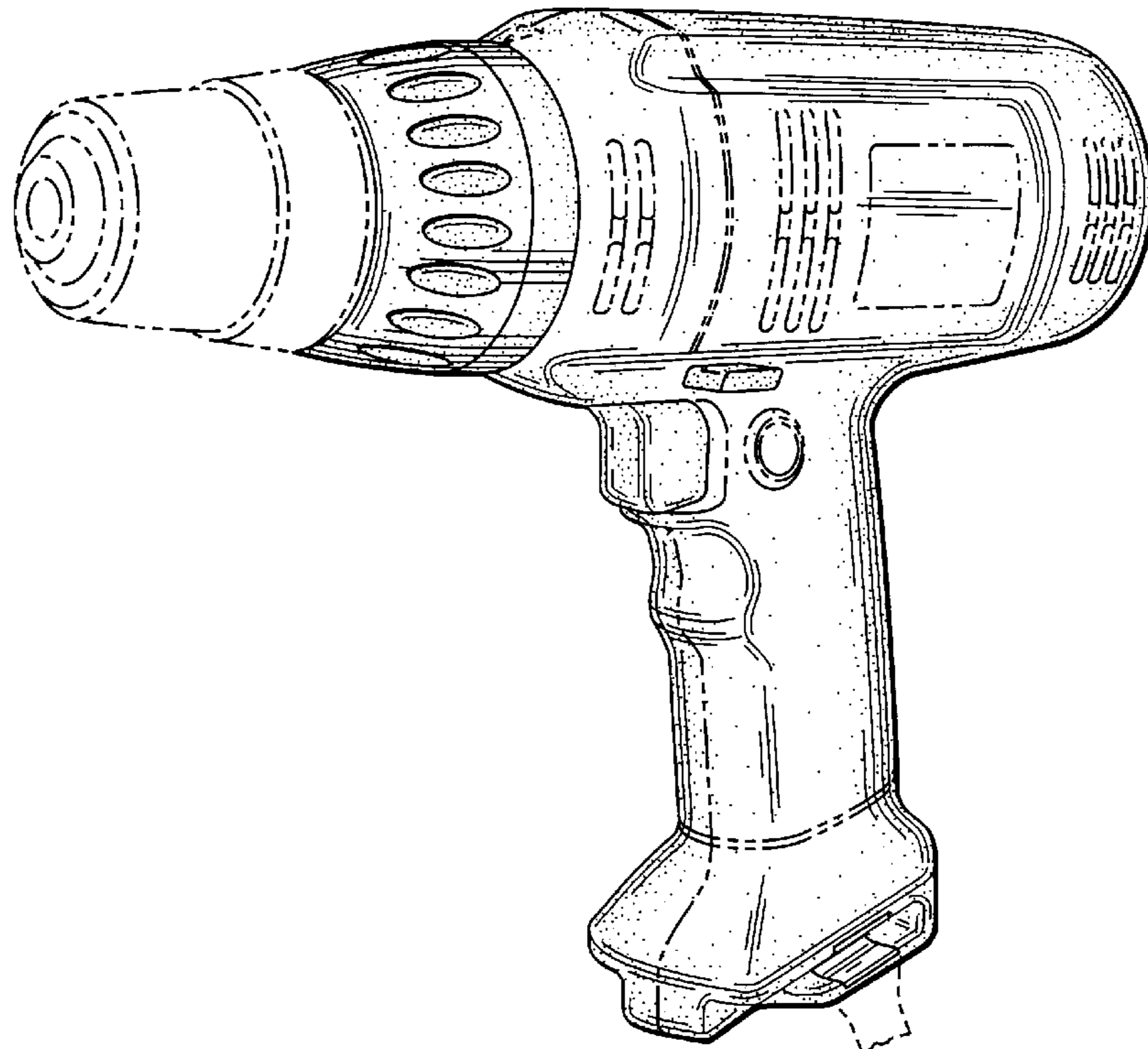
The ornamental design for an electric driver drill, as shown and described.

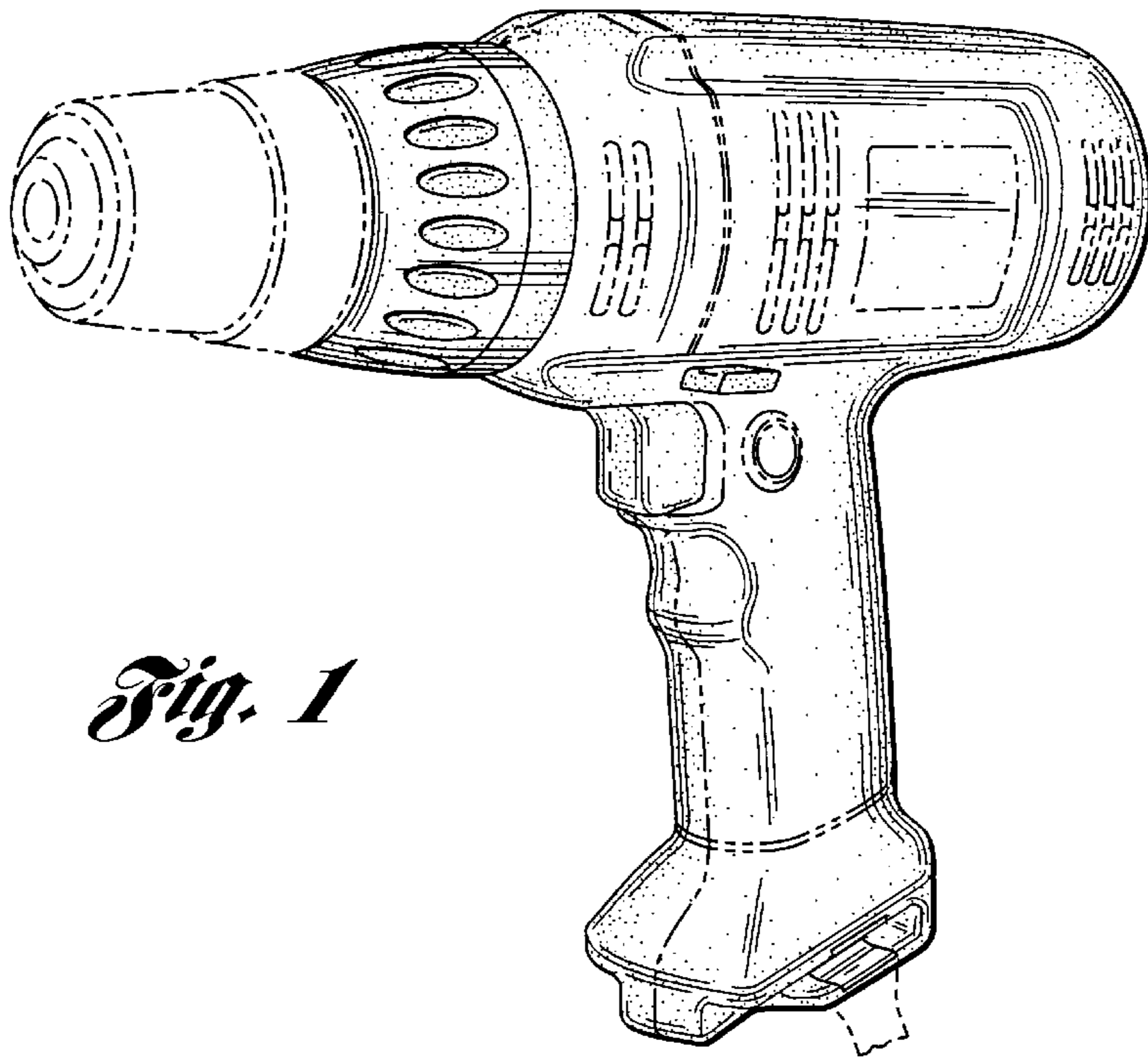
**DESCRIPTION**

 No claim is made to the portions of the drill illustrated in phantom outline.

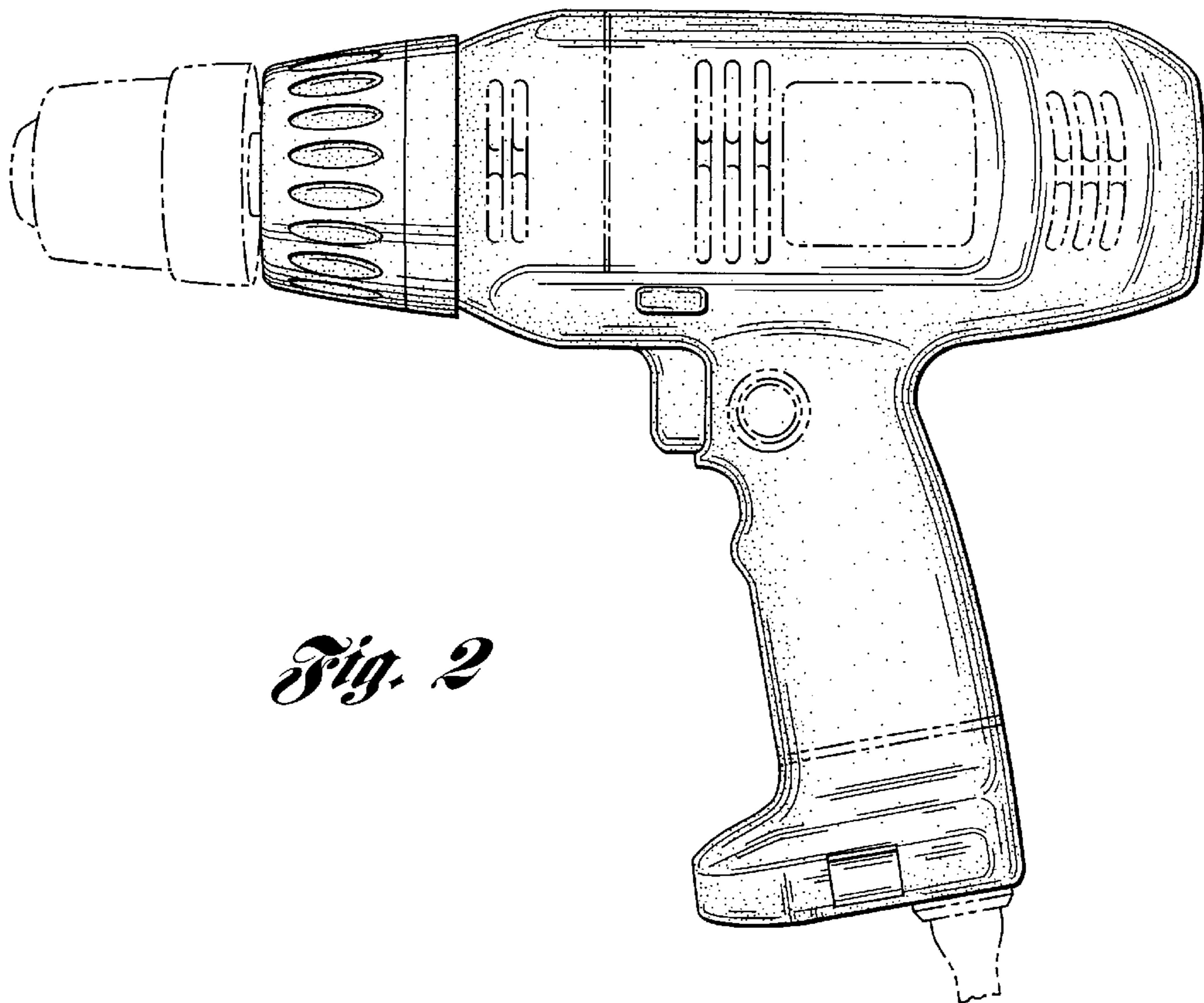

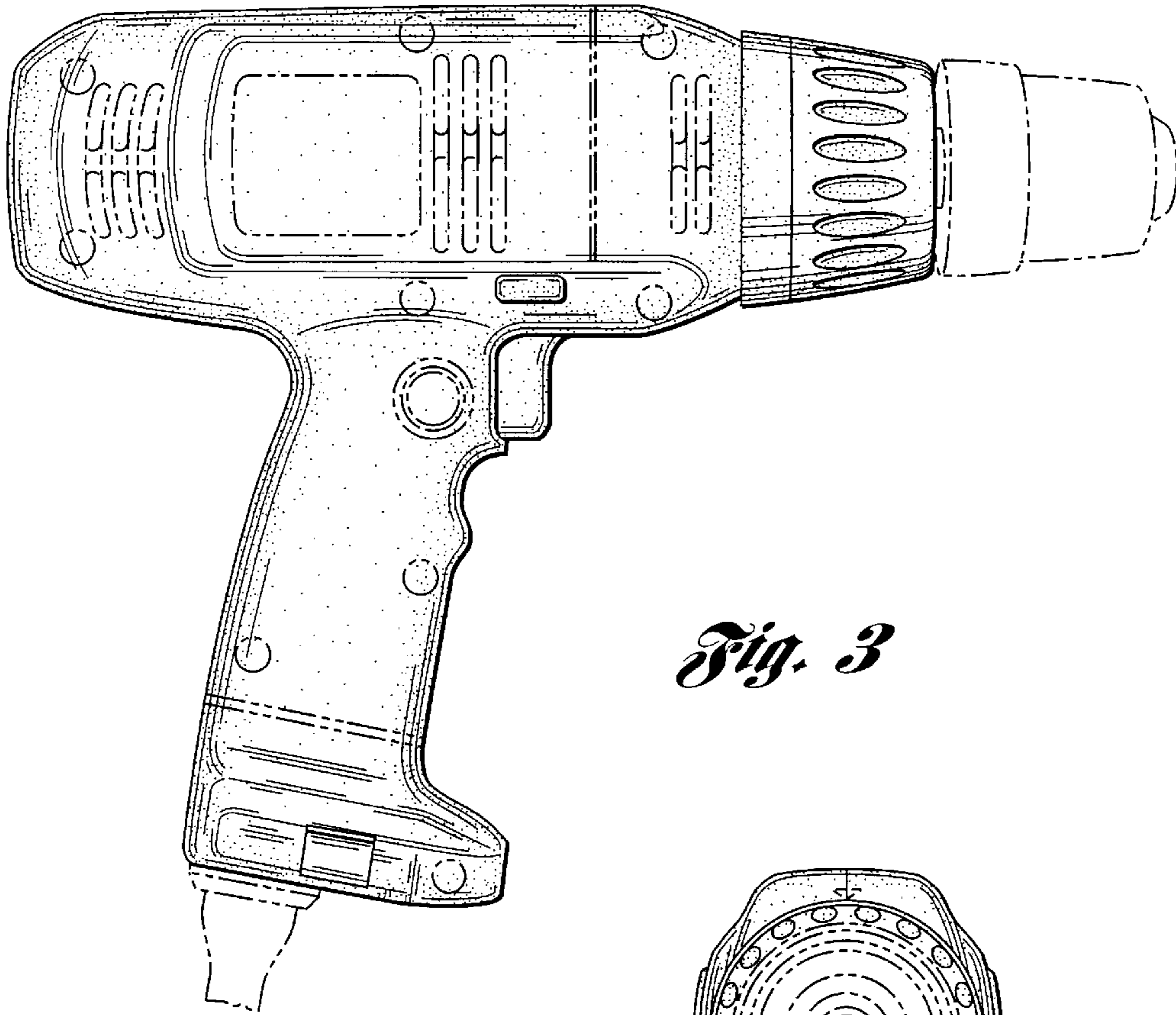




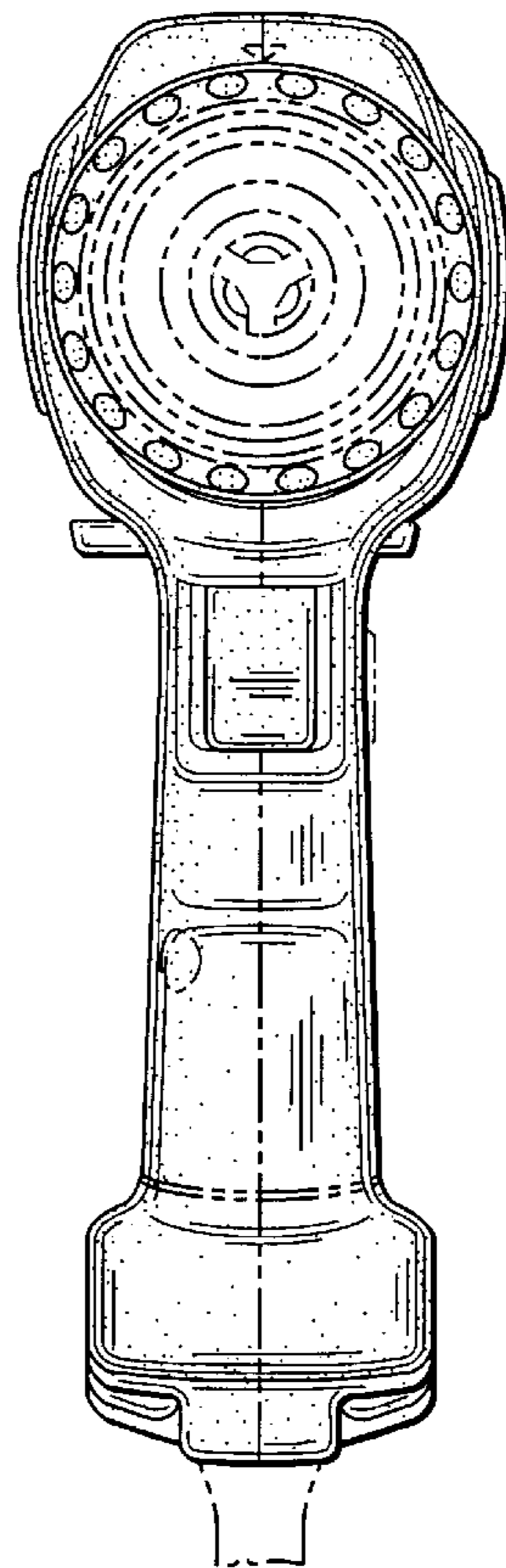

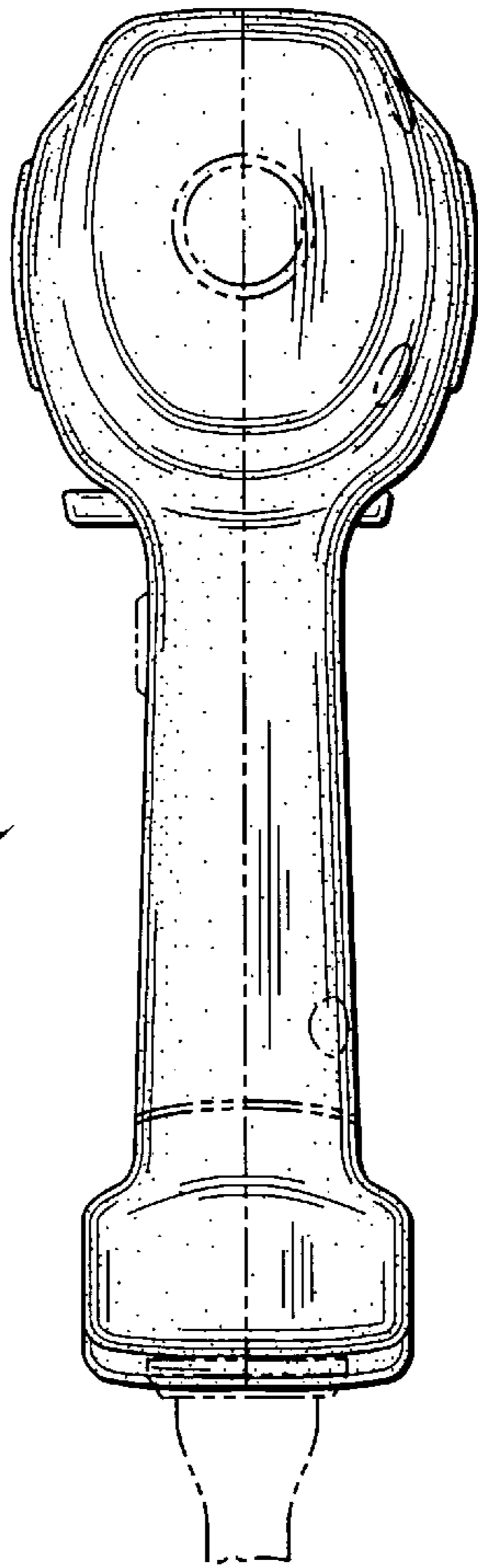

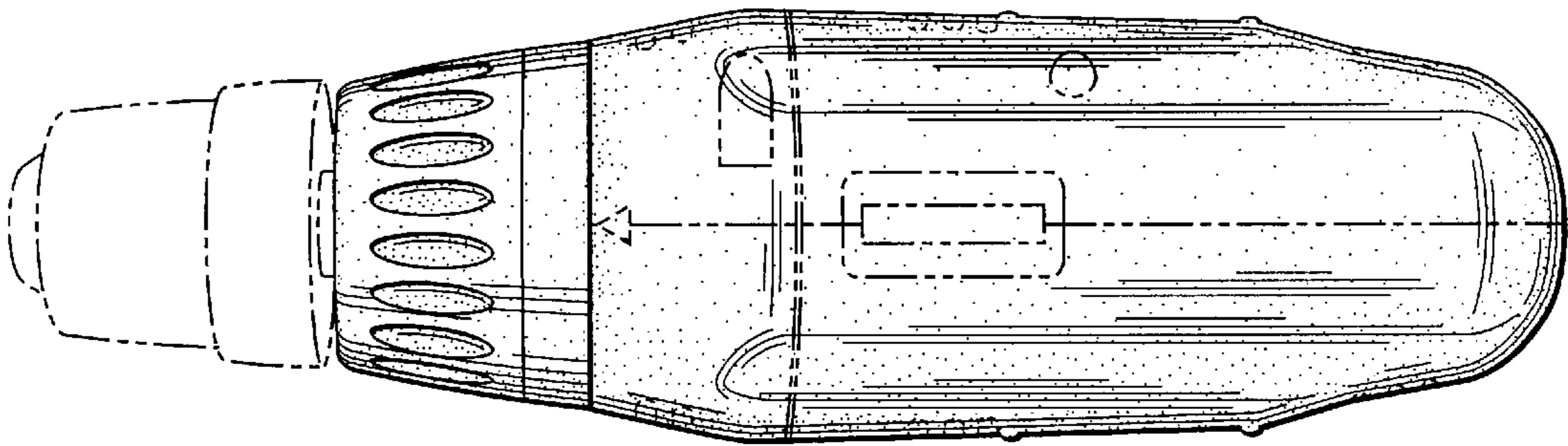
