(57) **CLAIM**

The ornamental design for a drawbar for trailer hitches, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the drawbar for trailer hitches showing our new design;

FIG. 2 is a left side elevational view thereof;

FIG. 3 is a top plan view thereof;

FIG. 4 is a right side elevational view thereof;

FIG. 5 is a bottom plan view thereof;

FIG. 6 is a rear elevational view thereof;

FIG. 7 is a front elevational view thereof;

FIG. 8 is a perspective view of a second embodiment with a shorter angled intermediate portion between the shank portion and the ball mount portion;

FIG. 9 is a right side elevational view of FIG. 8;

FIG. 10 is a top plan view of FIG. 8;

FIG. 11 is a left side elevation of FIG. 8;

FIG. 12 is a bottom plan view of FIG. 8;

FIG. 13 is a front elevational view of FIG. 8;

FIG. 14 is a rear elevational view of FIG. 8;

FIG. 15 is a perspective view of a third embodiment with the angled portion between the shank portion and the ball mount portion shorter than the intermediate portion of FIG. 1 and FIG. 8;

FIG. 16 is a left side elevational view of FIG. 15;

FIG. 17 is a top plan view of FIG. 15;

FIG. 18 is a bottom plan view of FIG. 15;

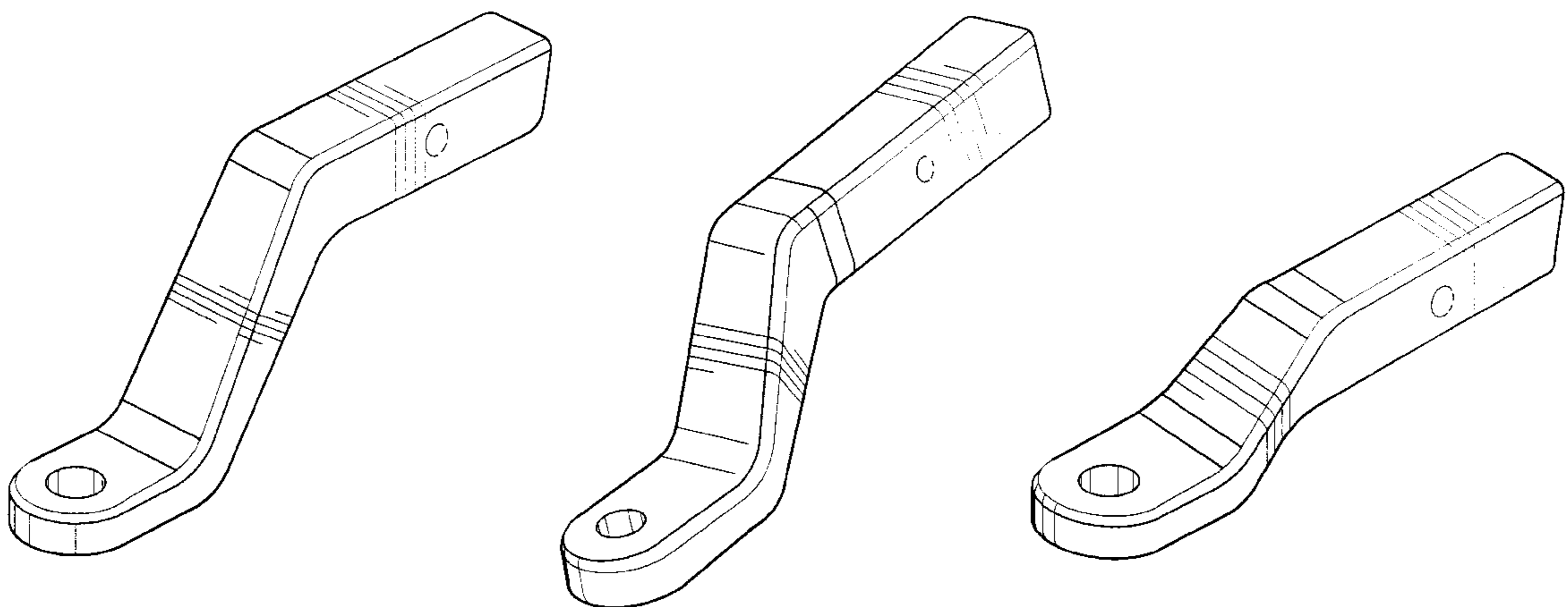
FIG. 19 is a right side elevational view of FIG. 15;

FIG. 20 is a front elevational view of FIG. 15; and,

FIG. 21 is a rear elevational view of FIG. 15.

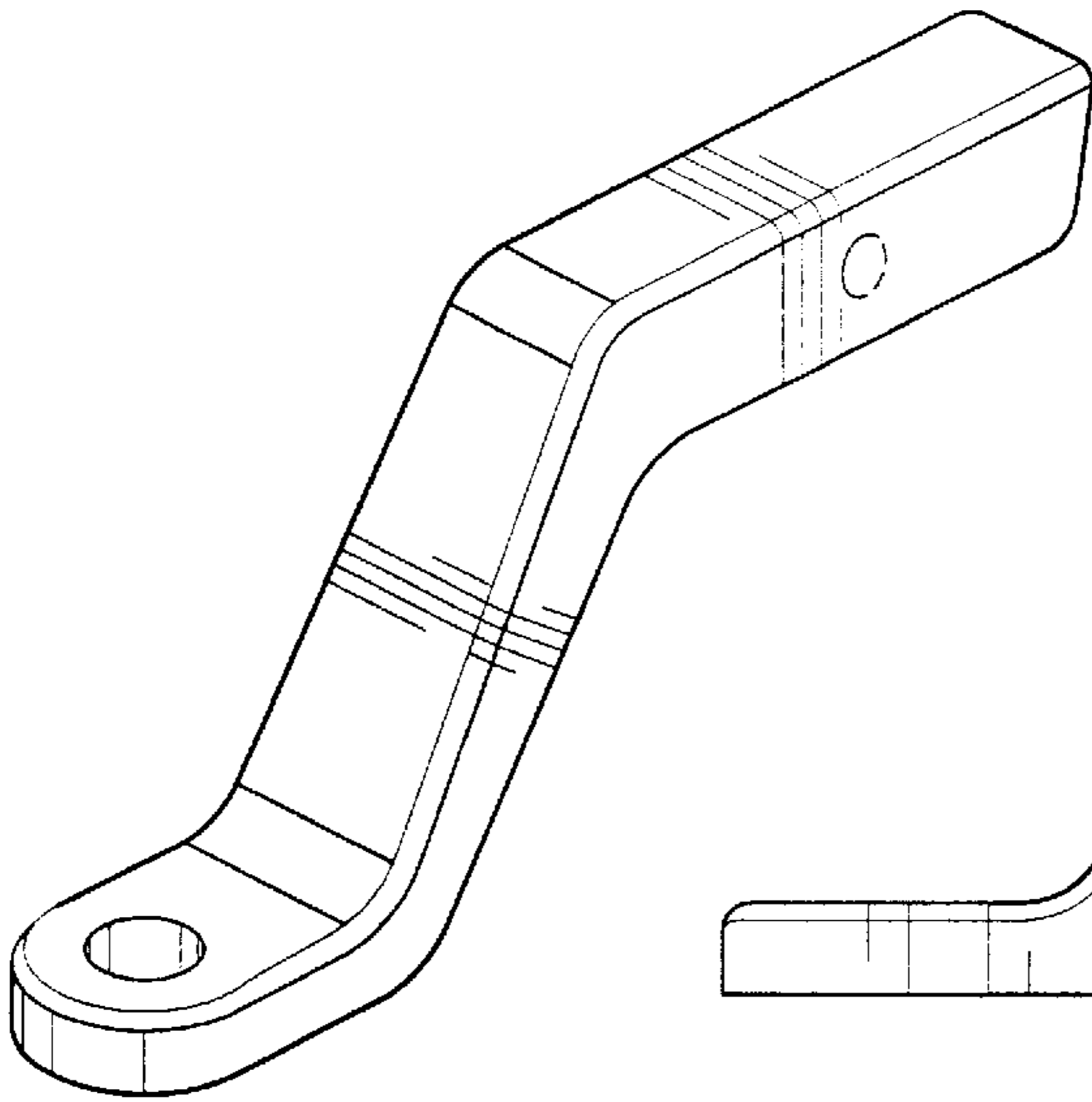

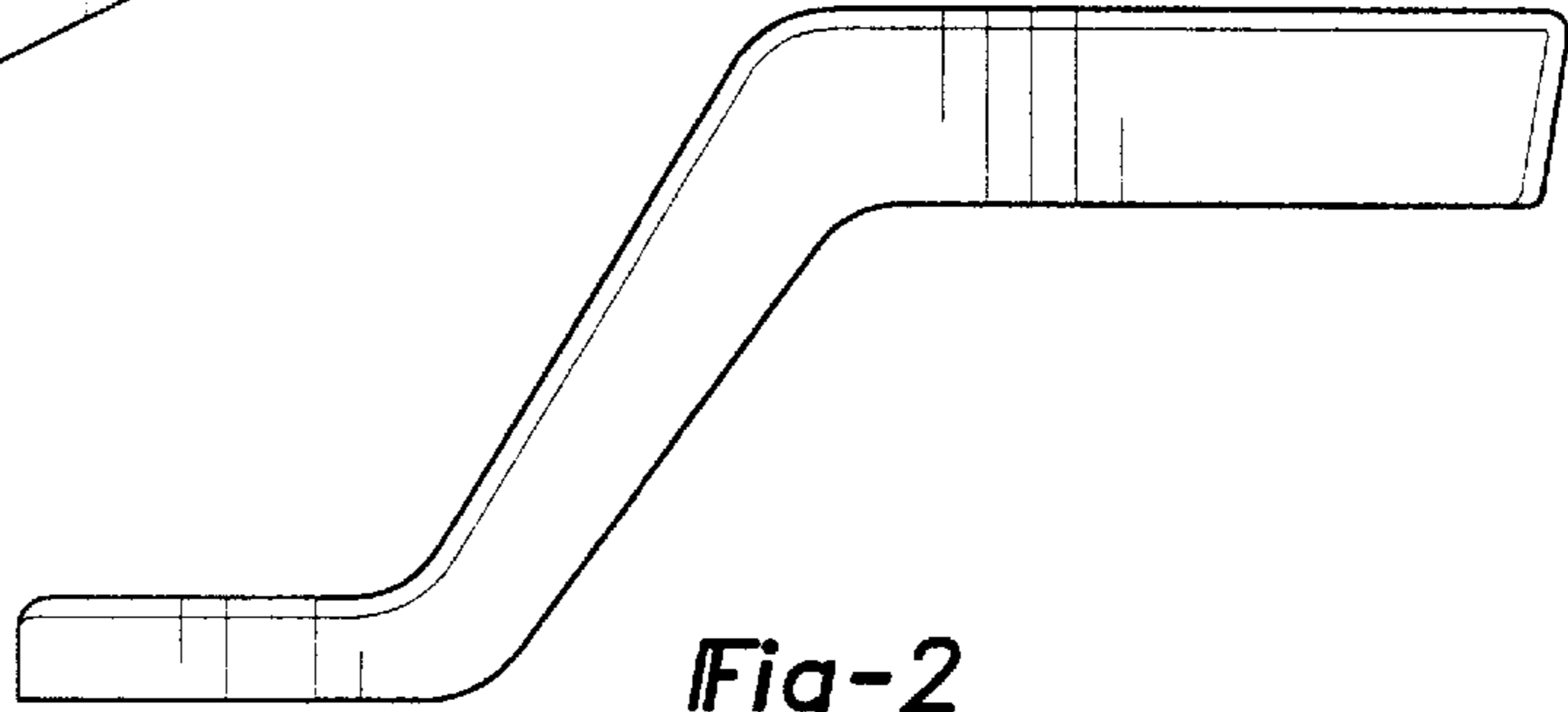

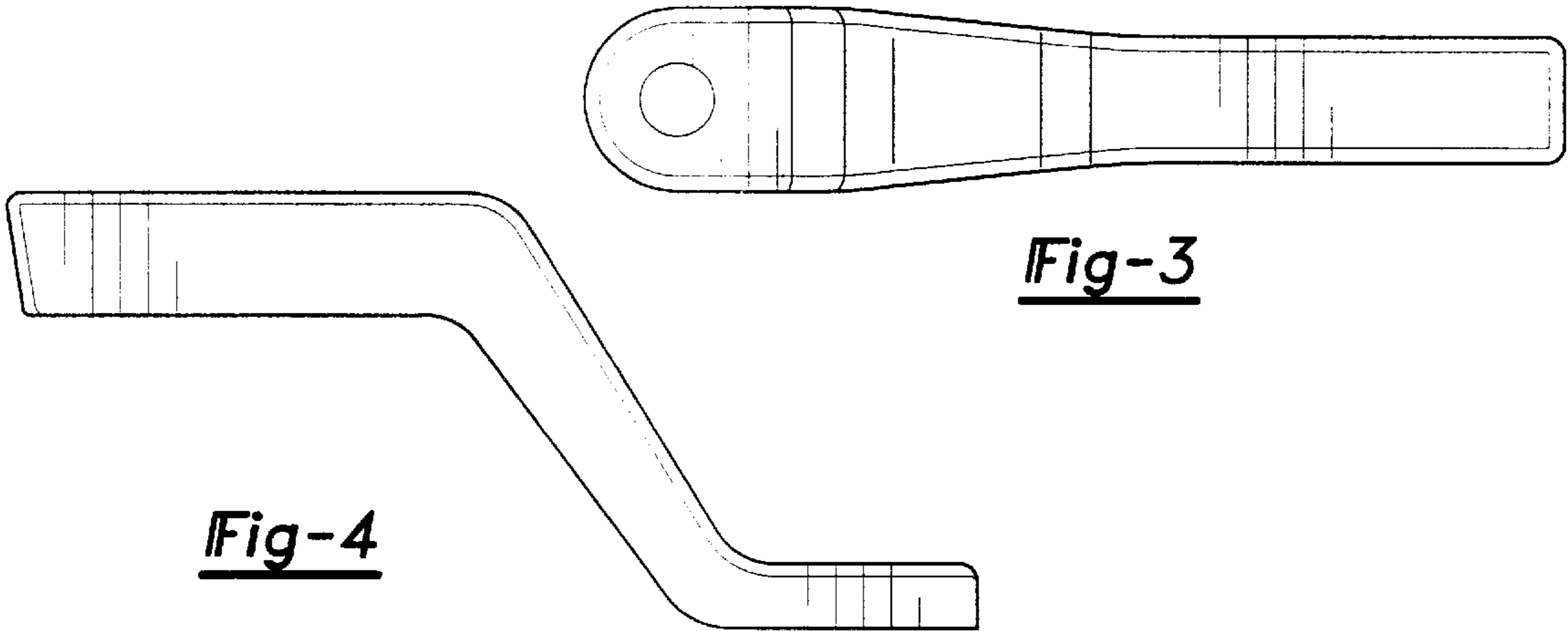

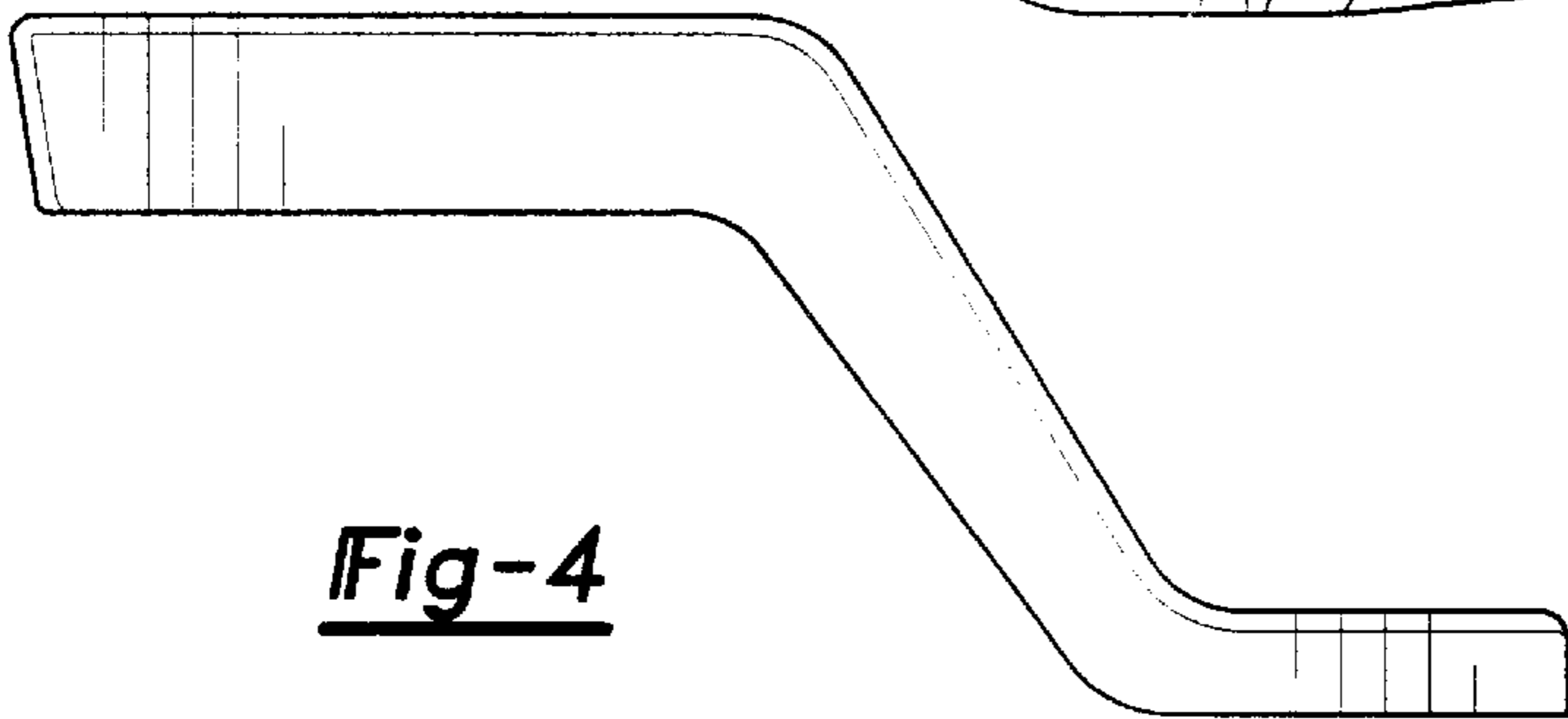

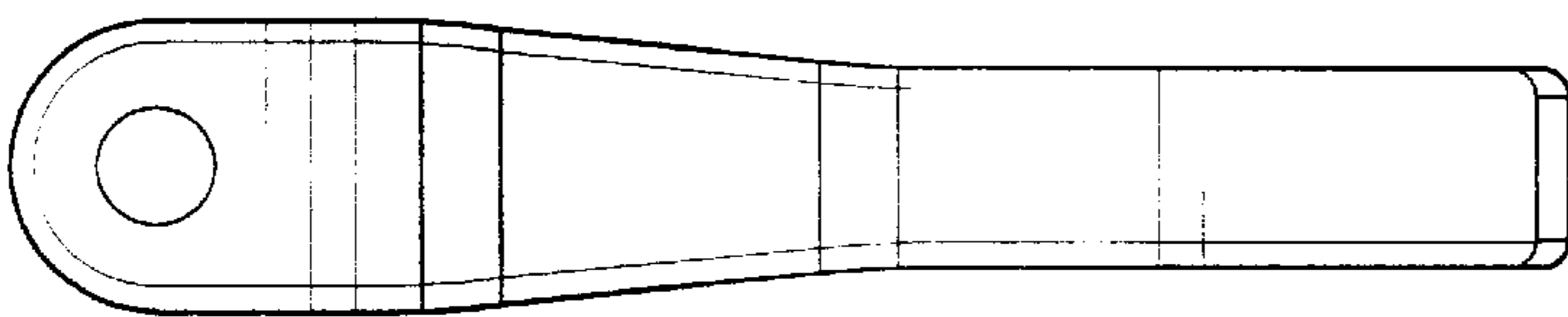

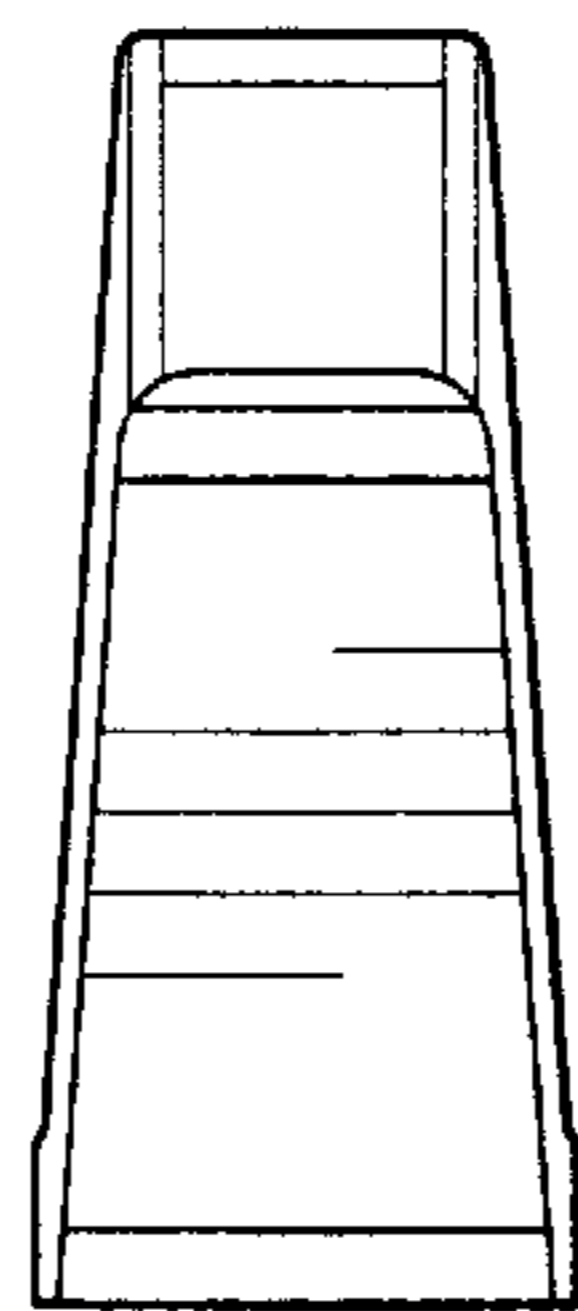

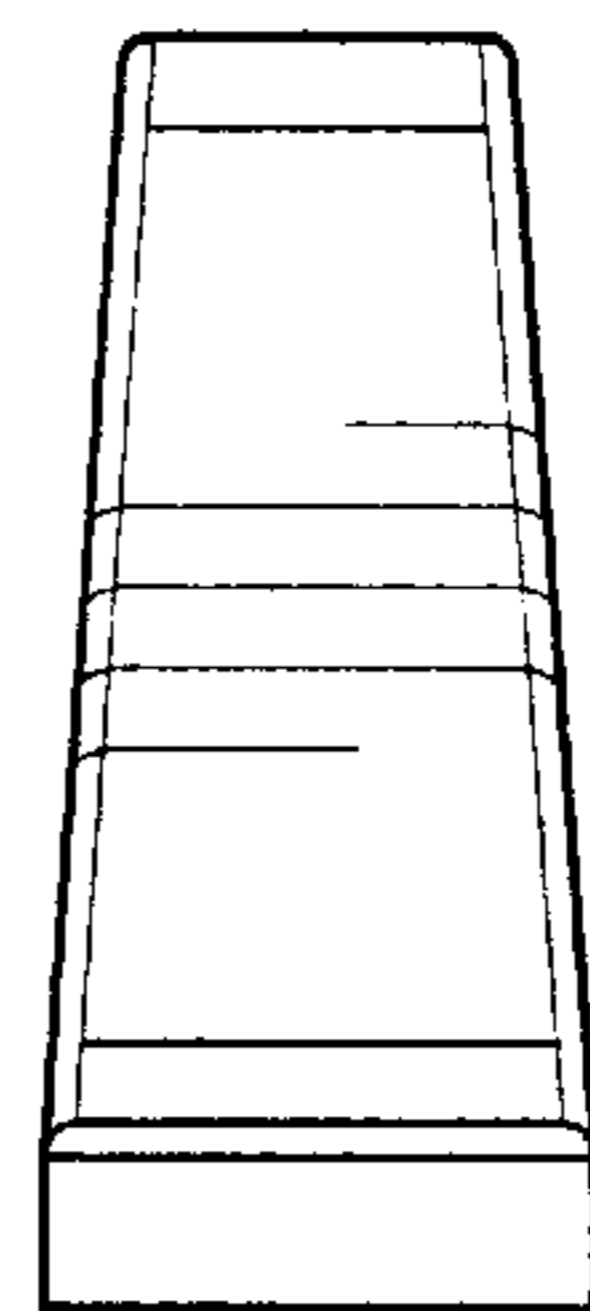
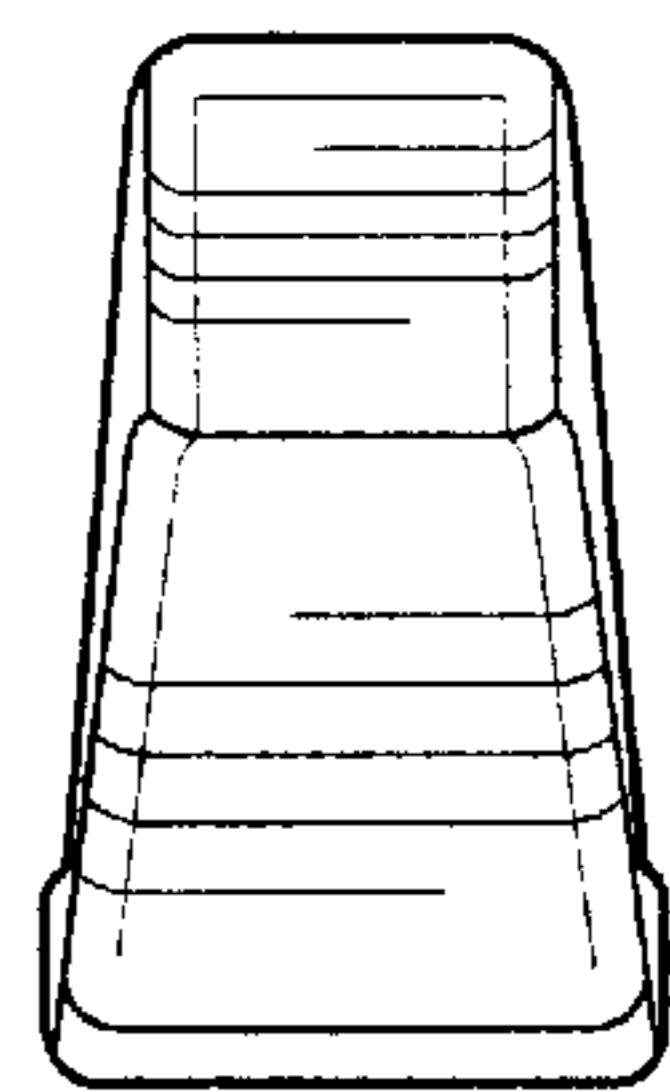
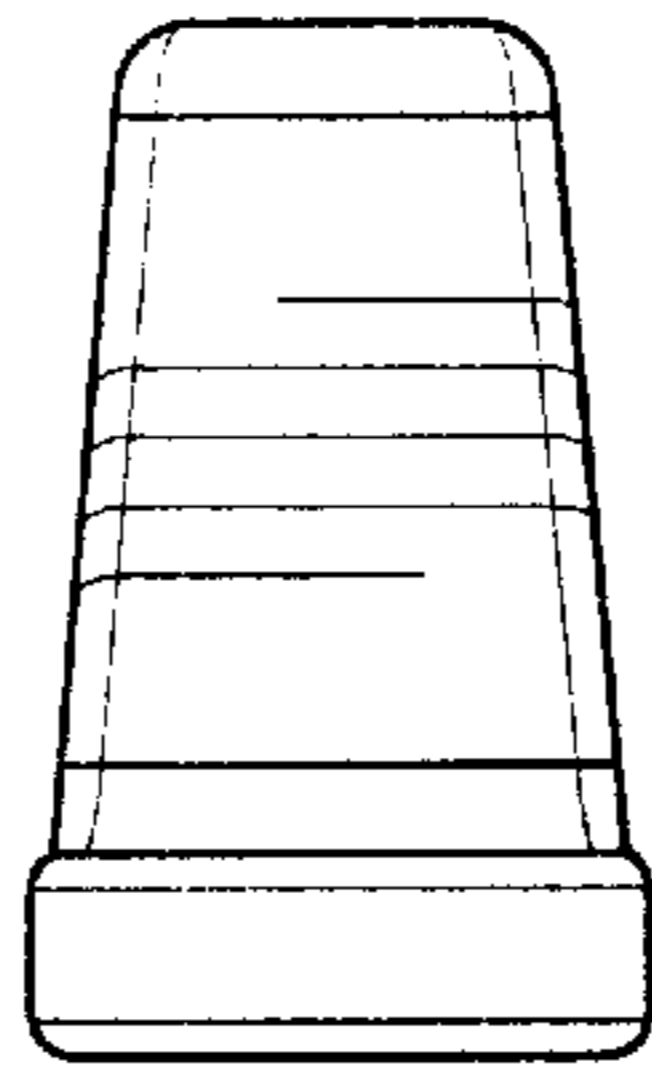
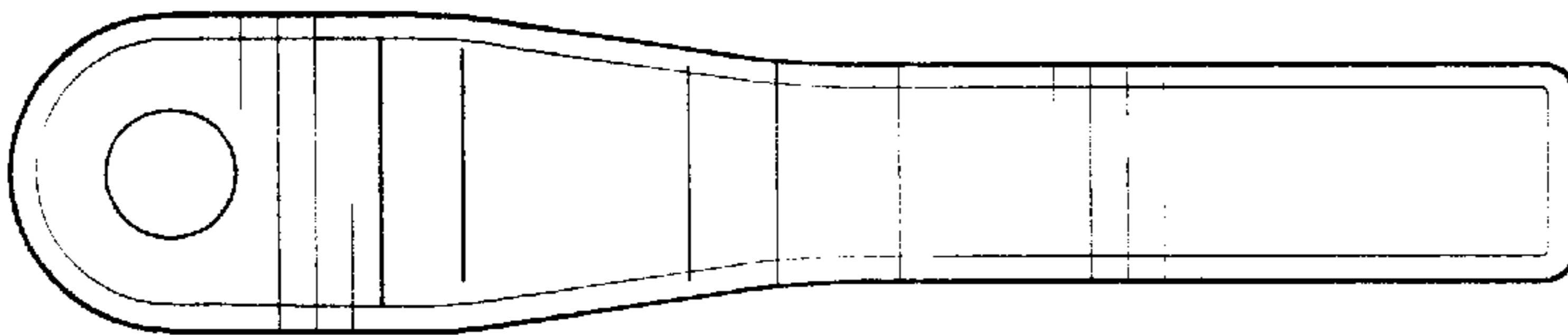
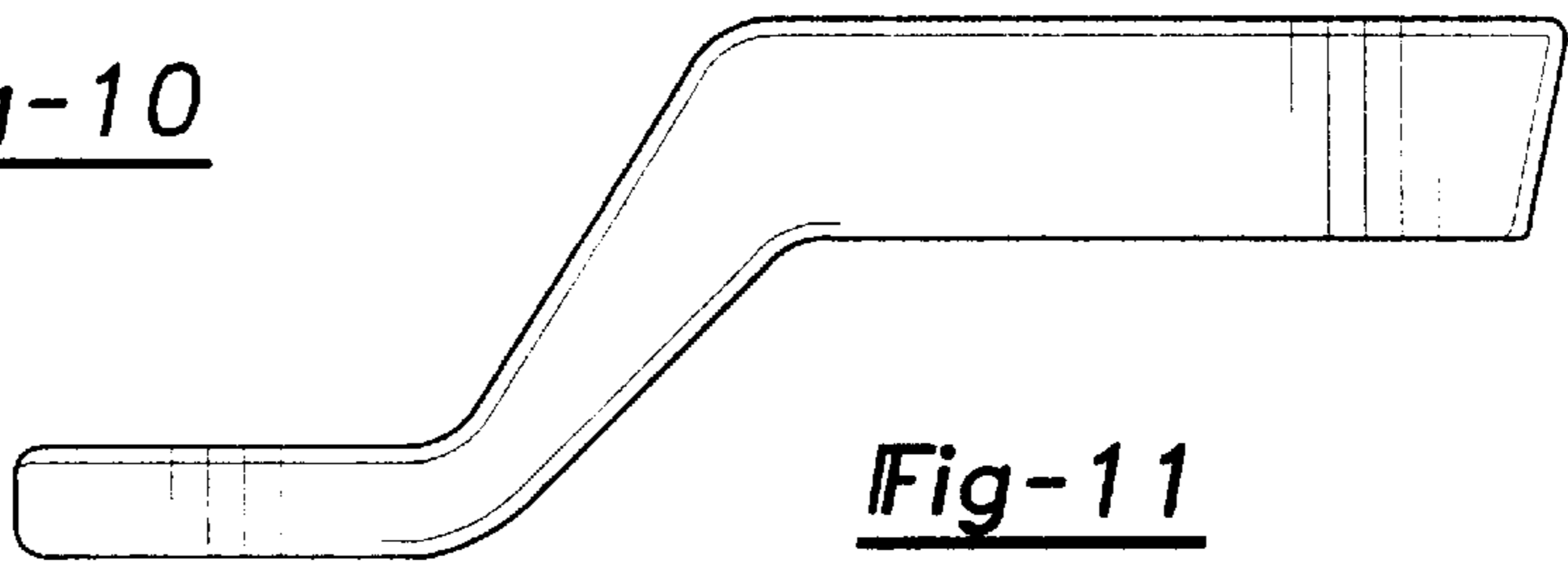
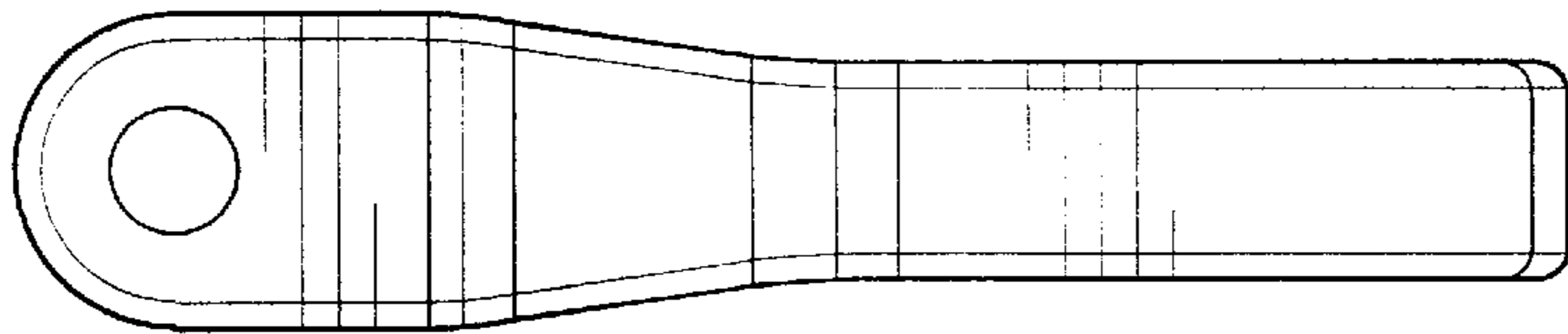
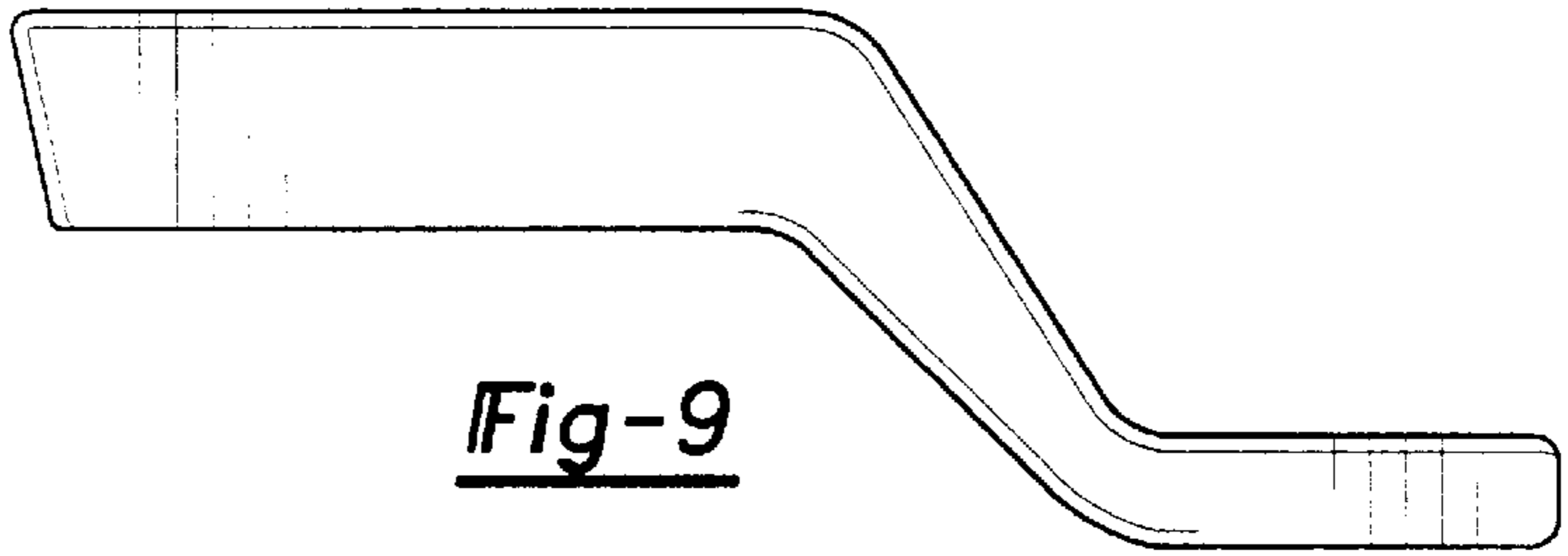
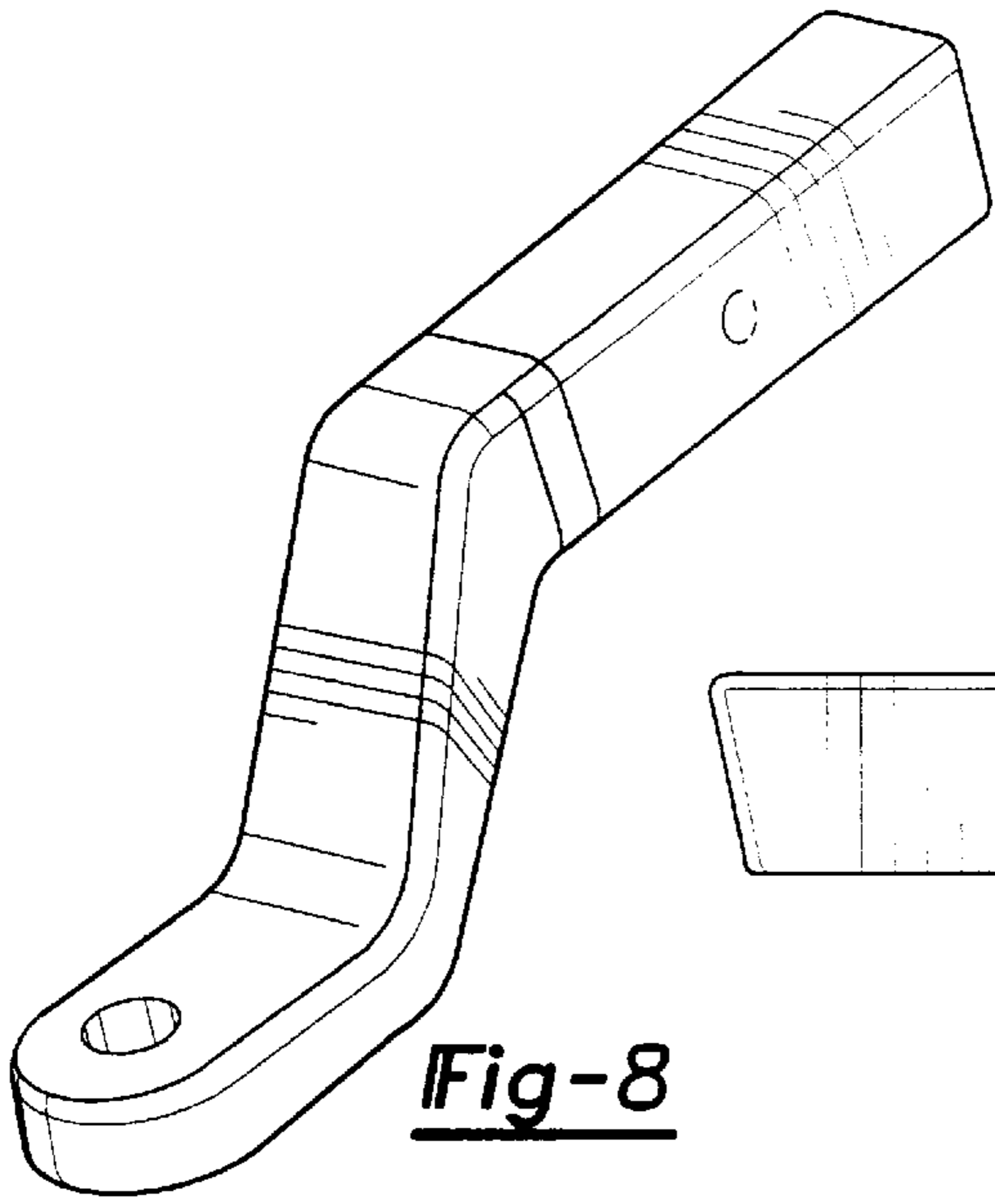

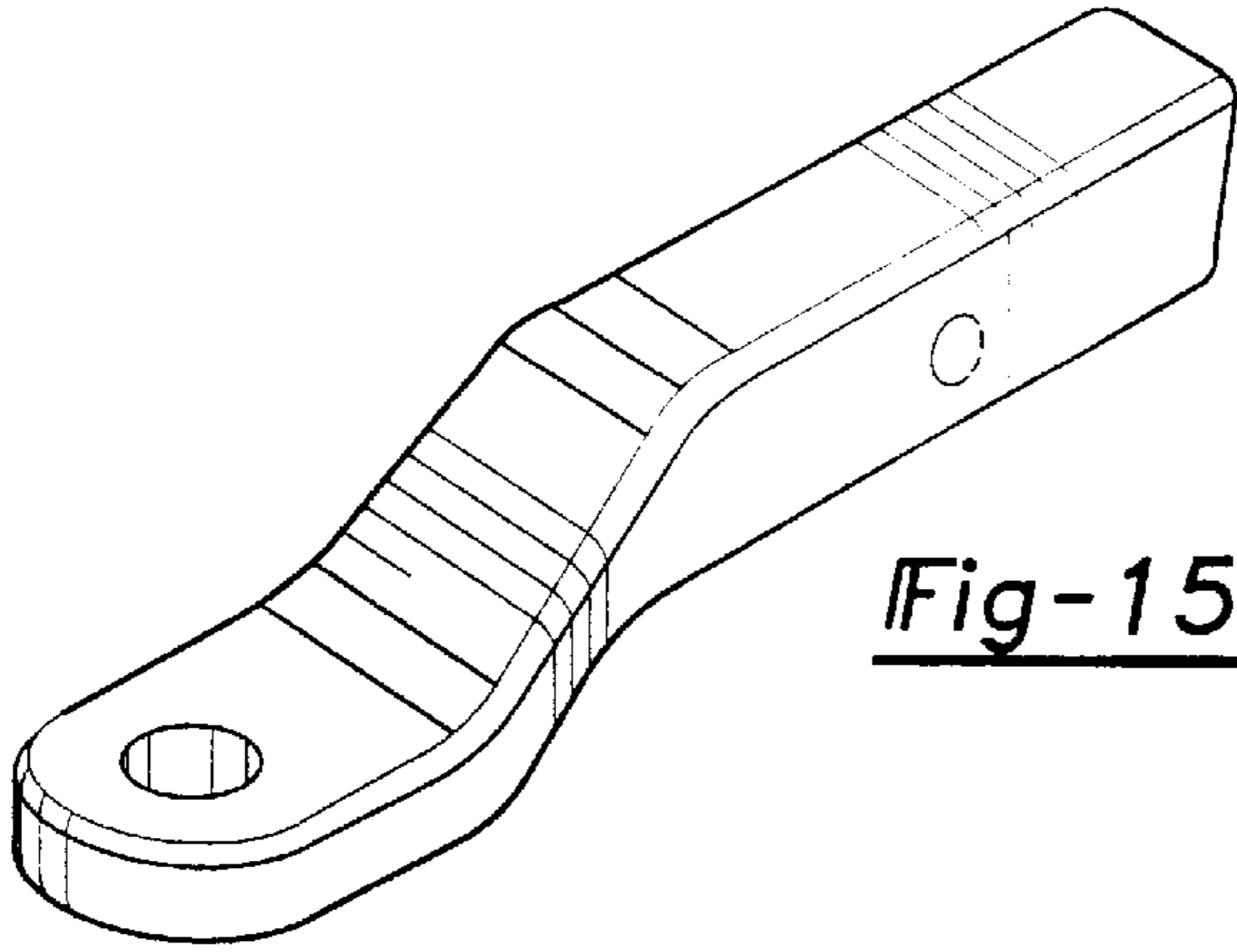

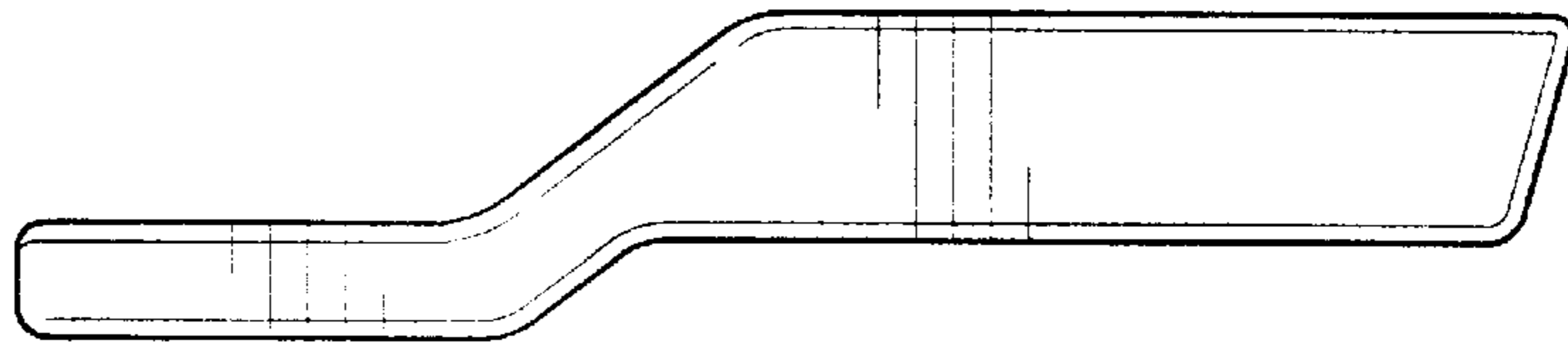

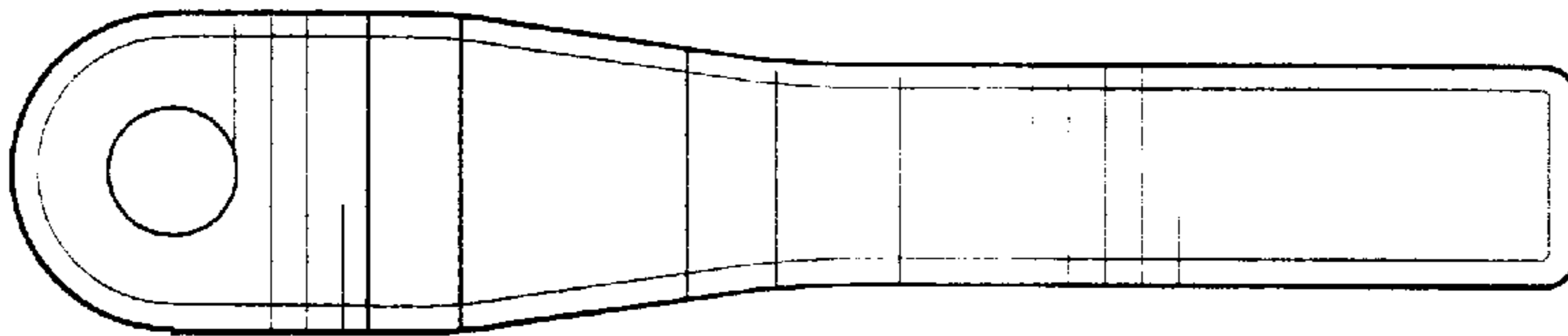

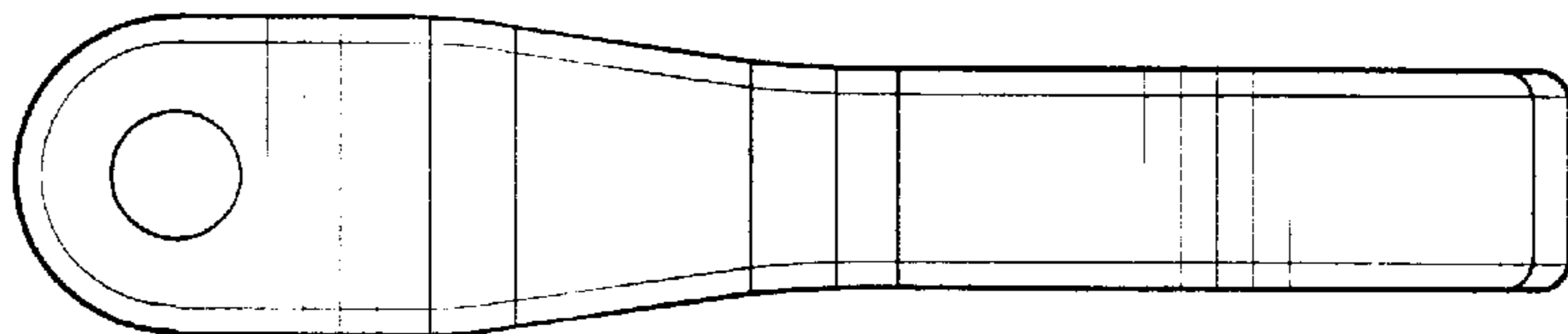

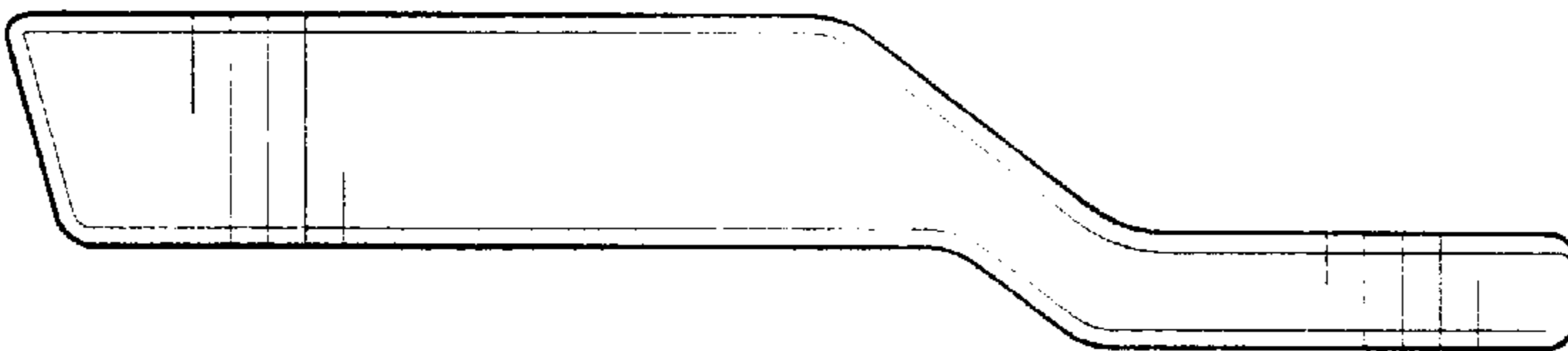

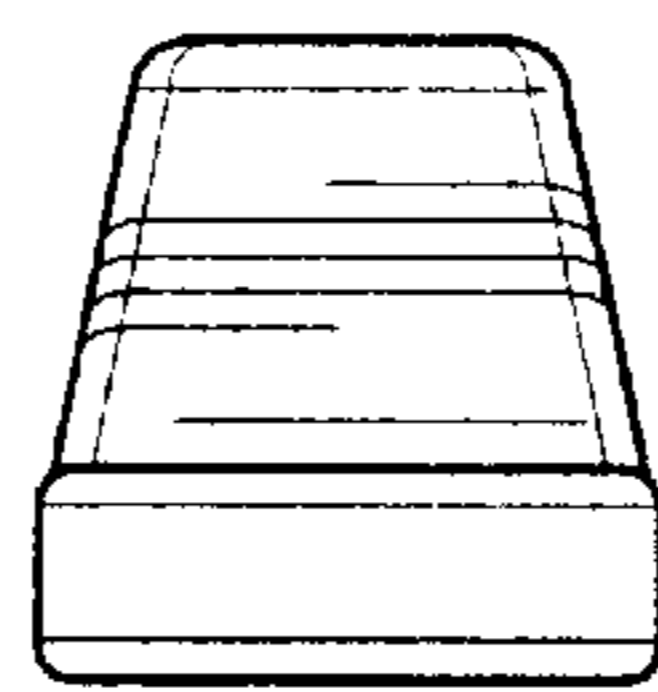

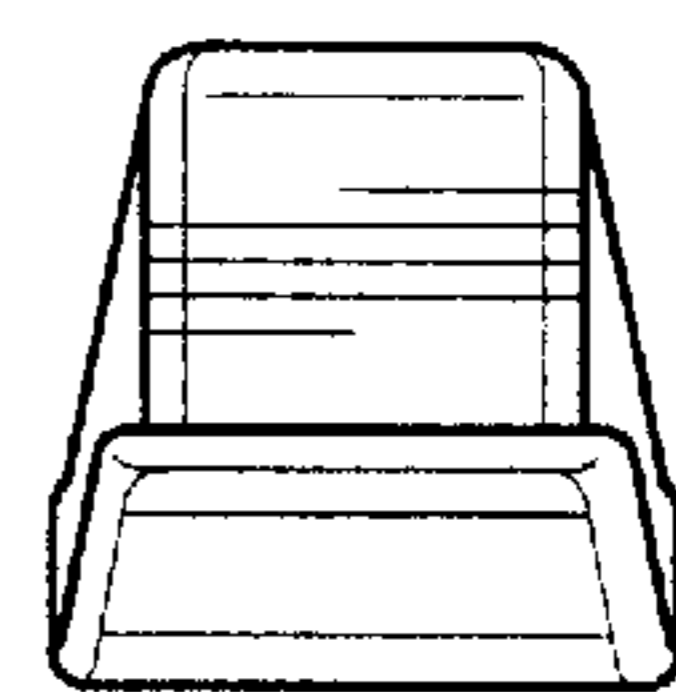
