FIG. 4 is a front view of FIG. 1;

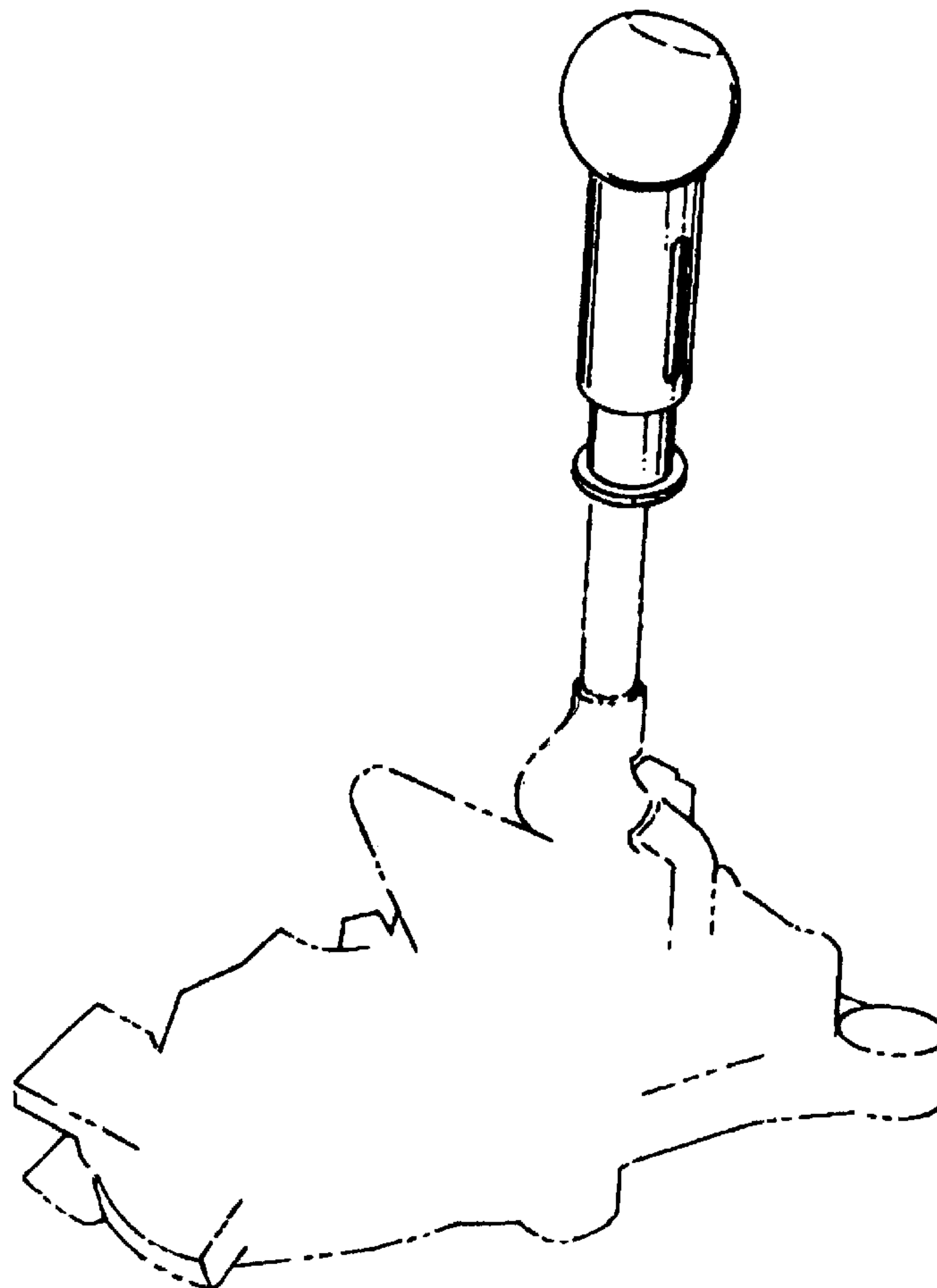
FIG. 5 is a back view of FIG. 1;

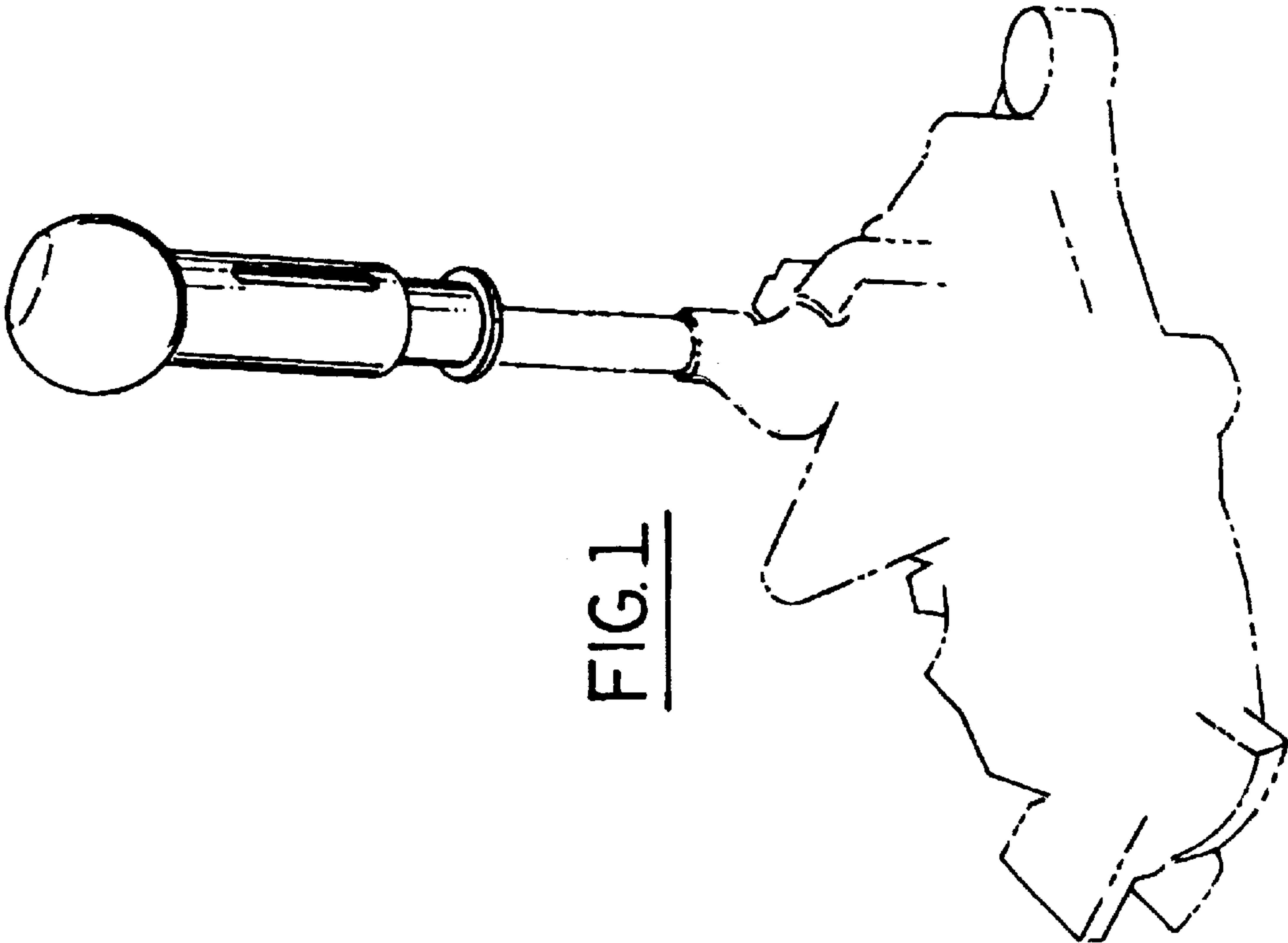

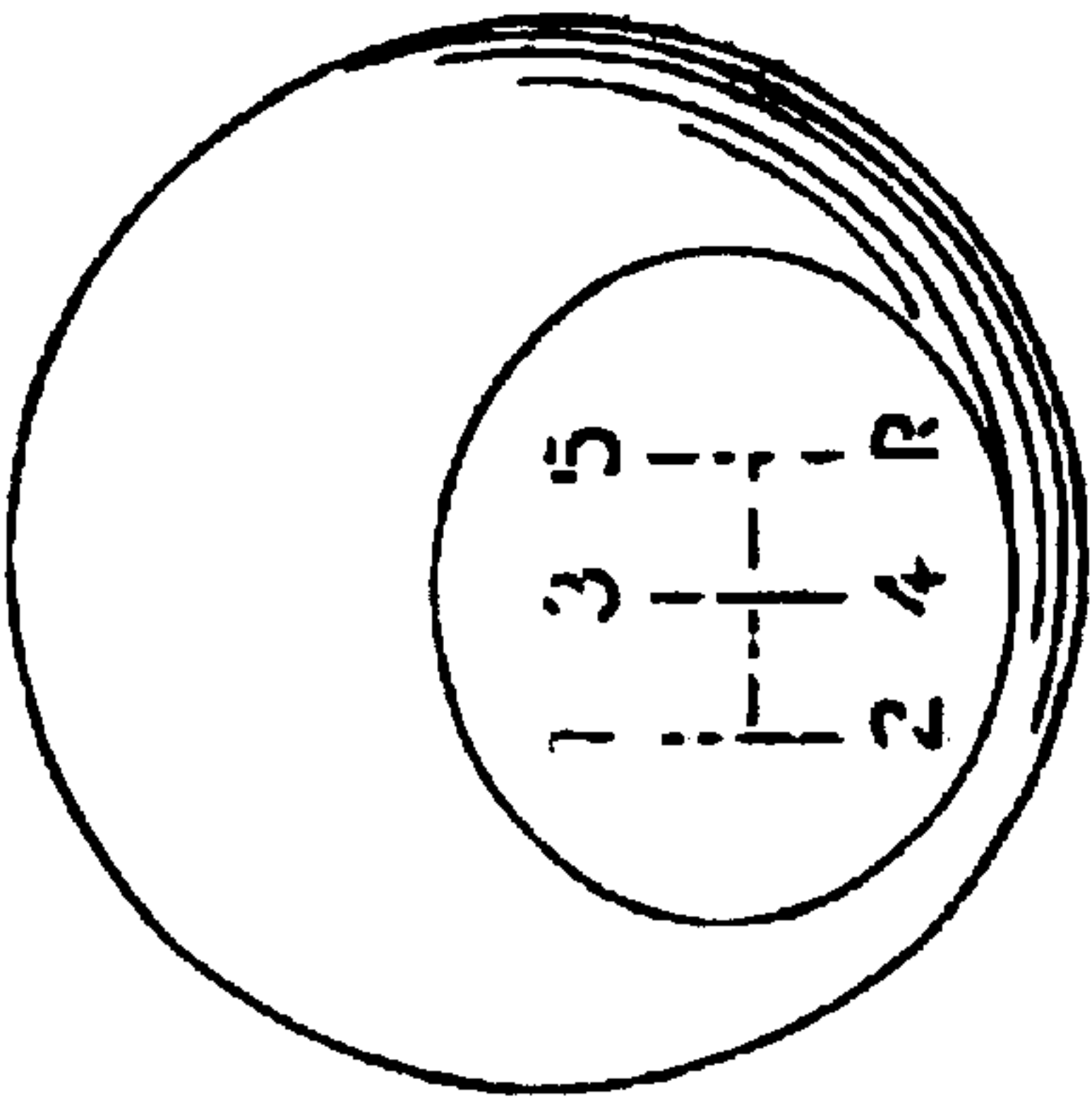

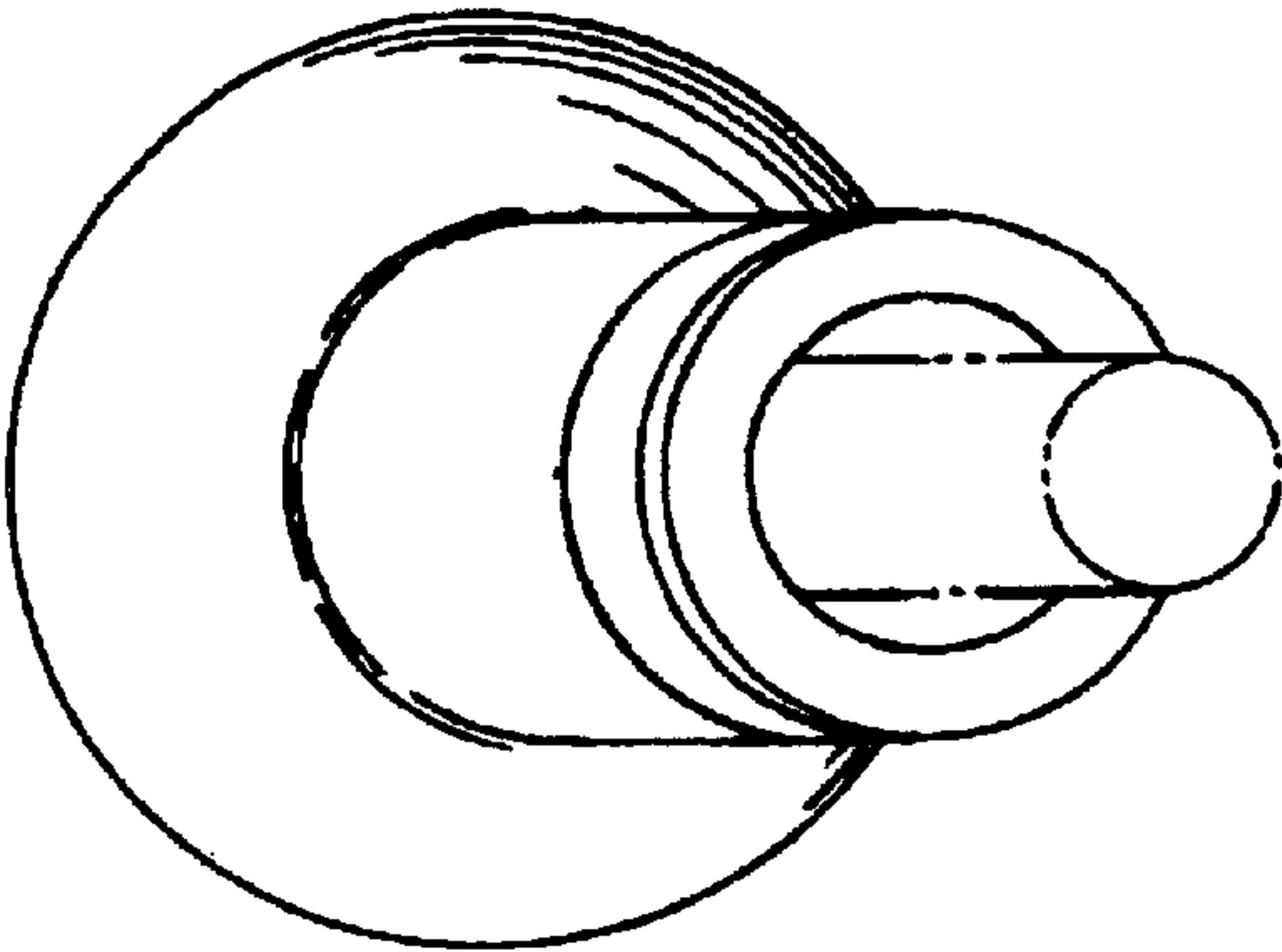

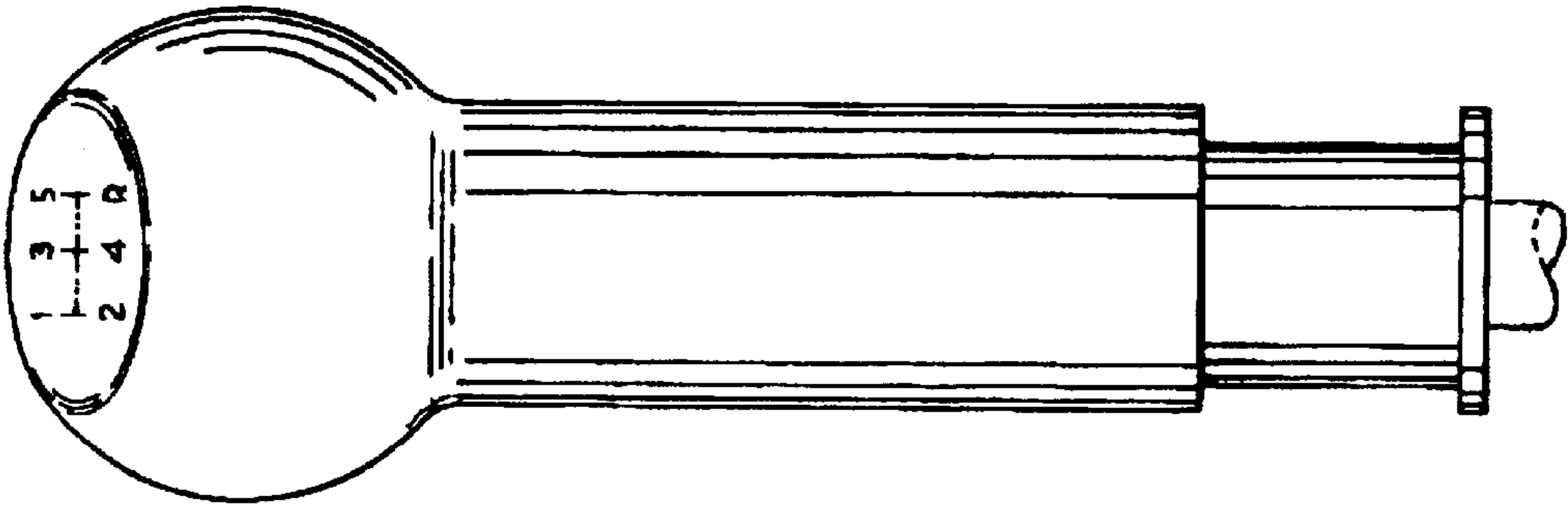

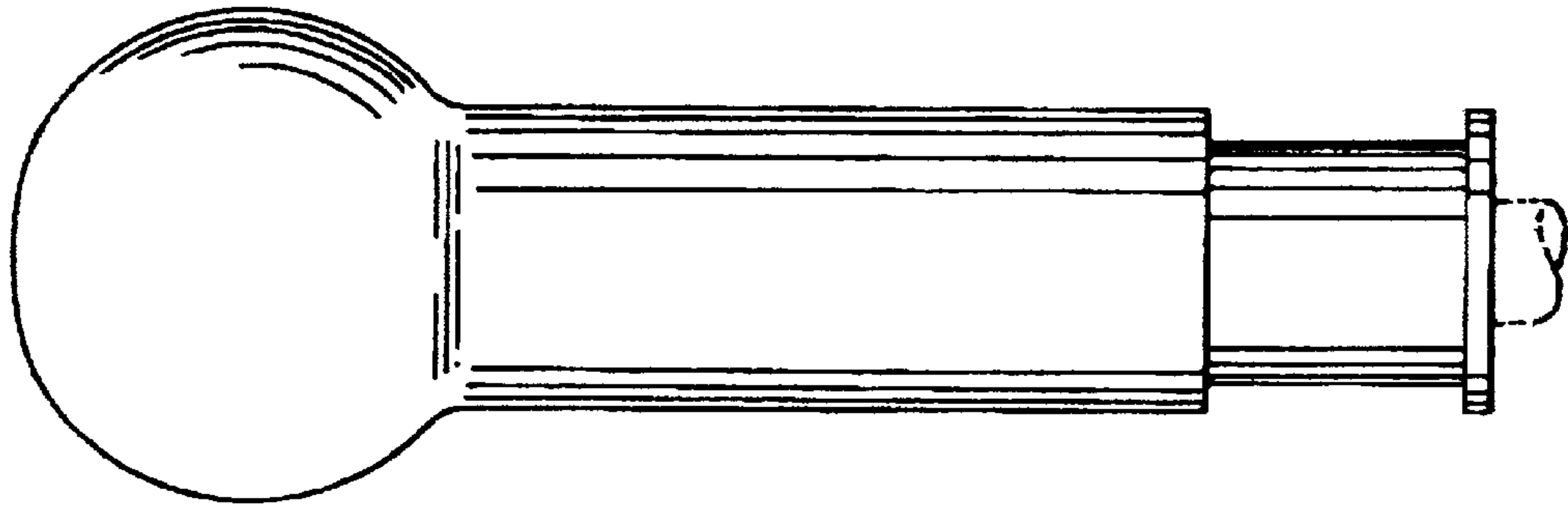

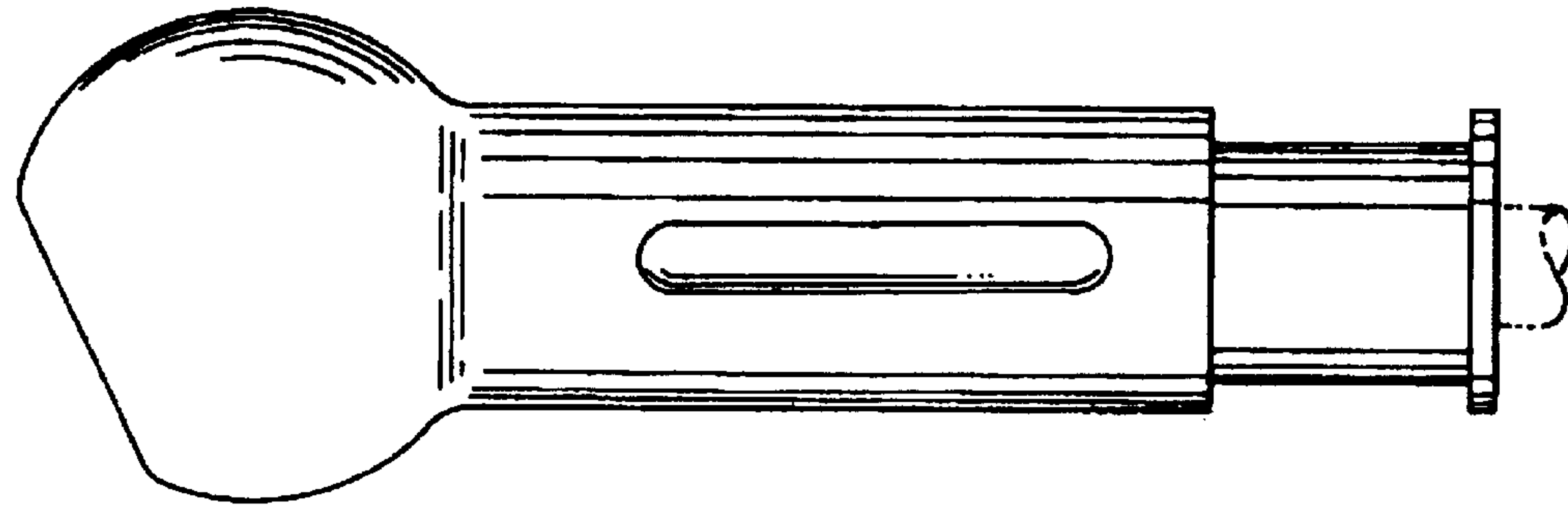

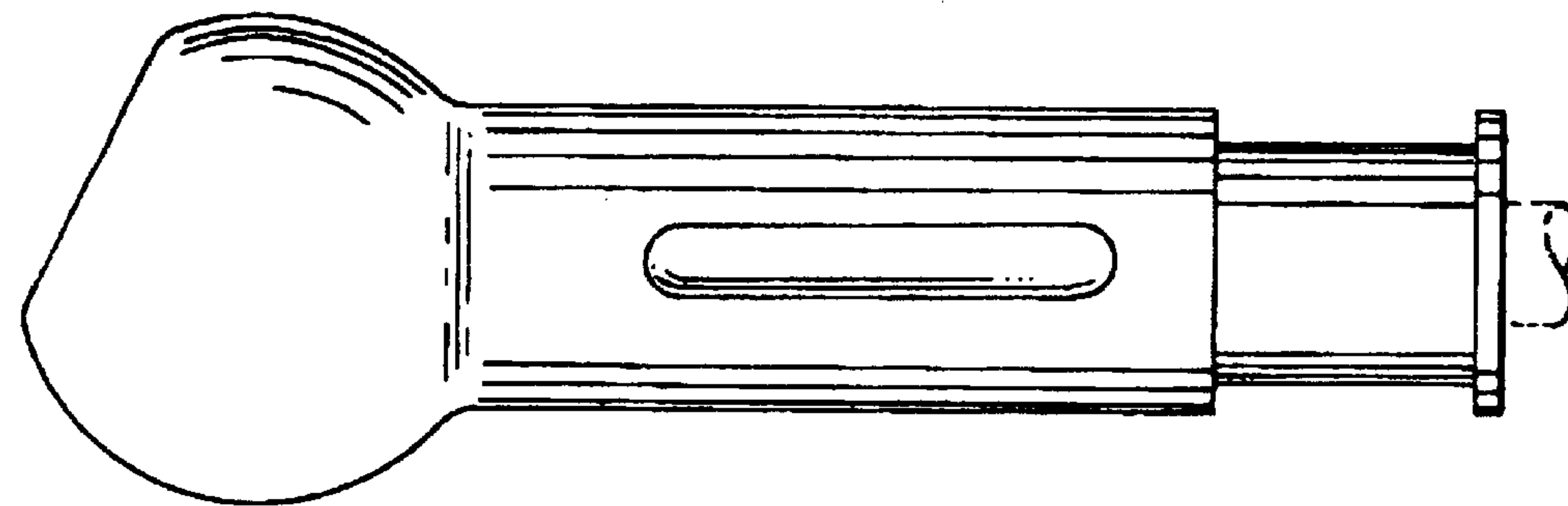
