(57) **CLAIM**

We claim the ornamental design for an ear mount for a personal audio component, as shown and described.

**DESCRIPTION**

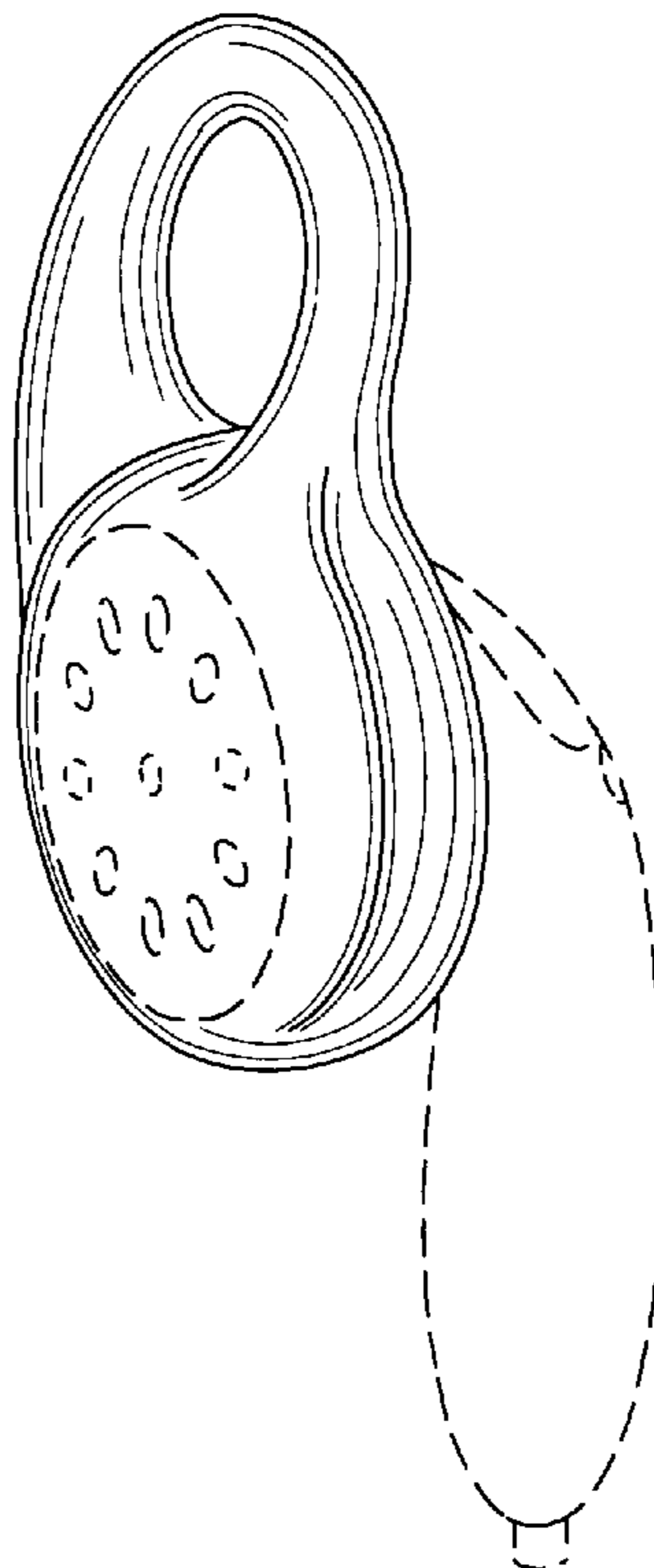


FIG. 1A FIG. 1B

FIG. 1A is a front, right side perspective view of an ear mount for a personal audio component showing our new design;

FIG. 1B is a back, right side perspective view thereof;

FIG. 2 is a front elevation view thereof;

FIG. 3 is a left side elevational view thereof;

FIG. 4 is a right side elevational view thereof;

FIG. 5 is a top elevational view thereof;

FIG. 6 is a bottom elevational view thereof; and,

FIG. 7 is a back elevation view thereof.

The broken lines showing a personal audio component with ports, recesses, and a cable extending therefrom are for illustrative purpose only and form no part of the claimed design.

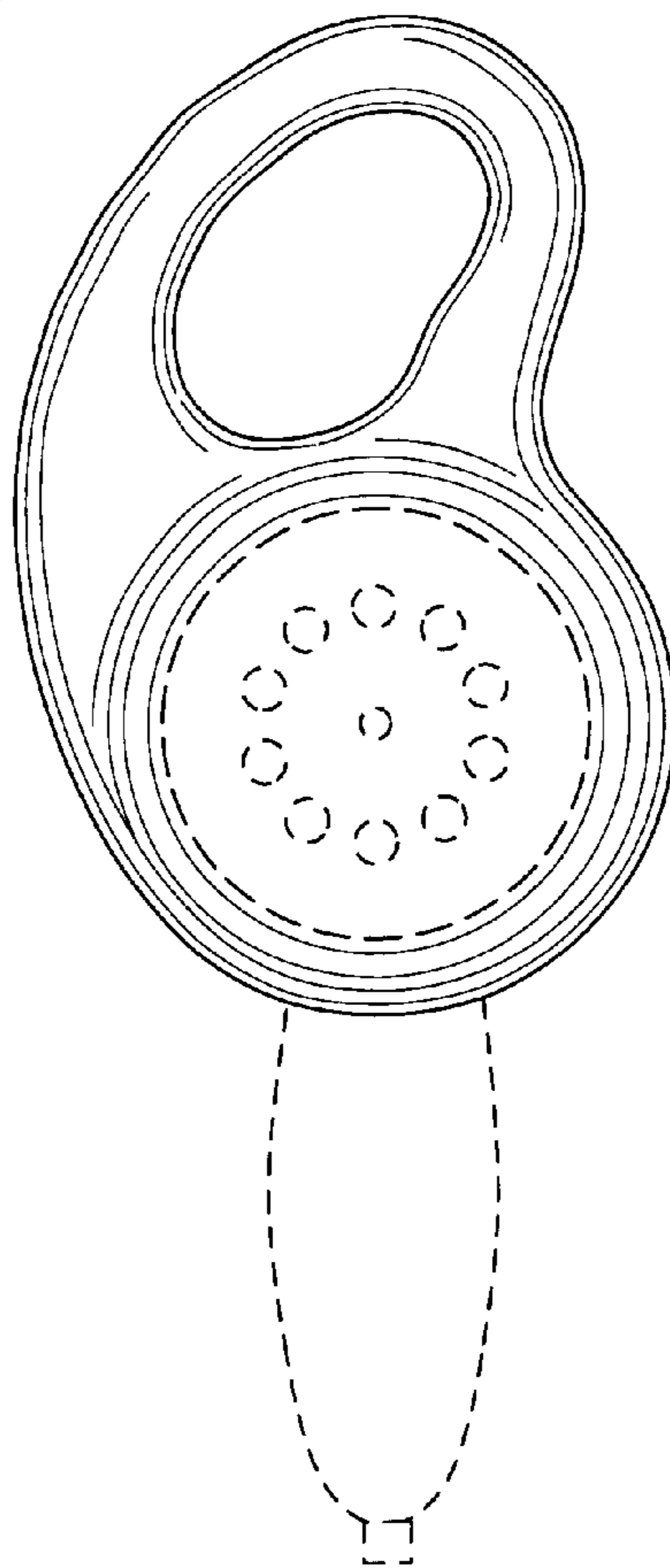
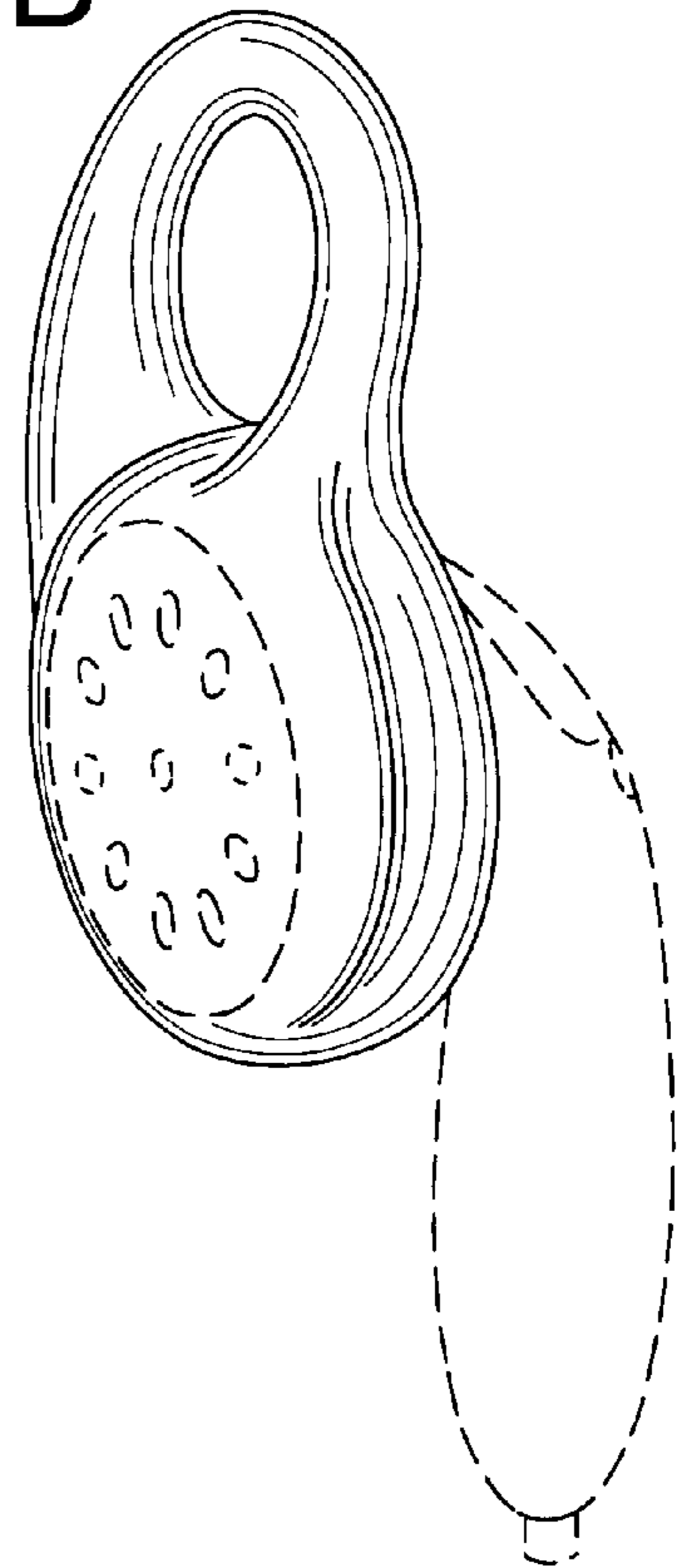
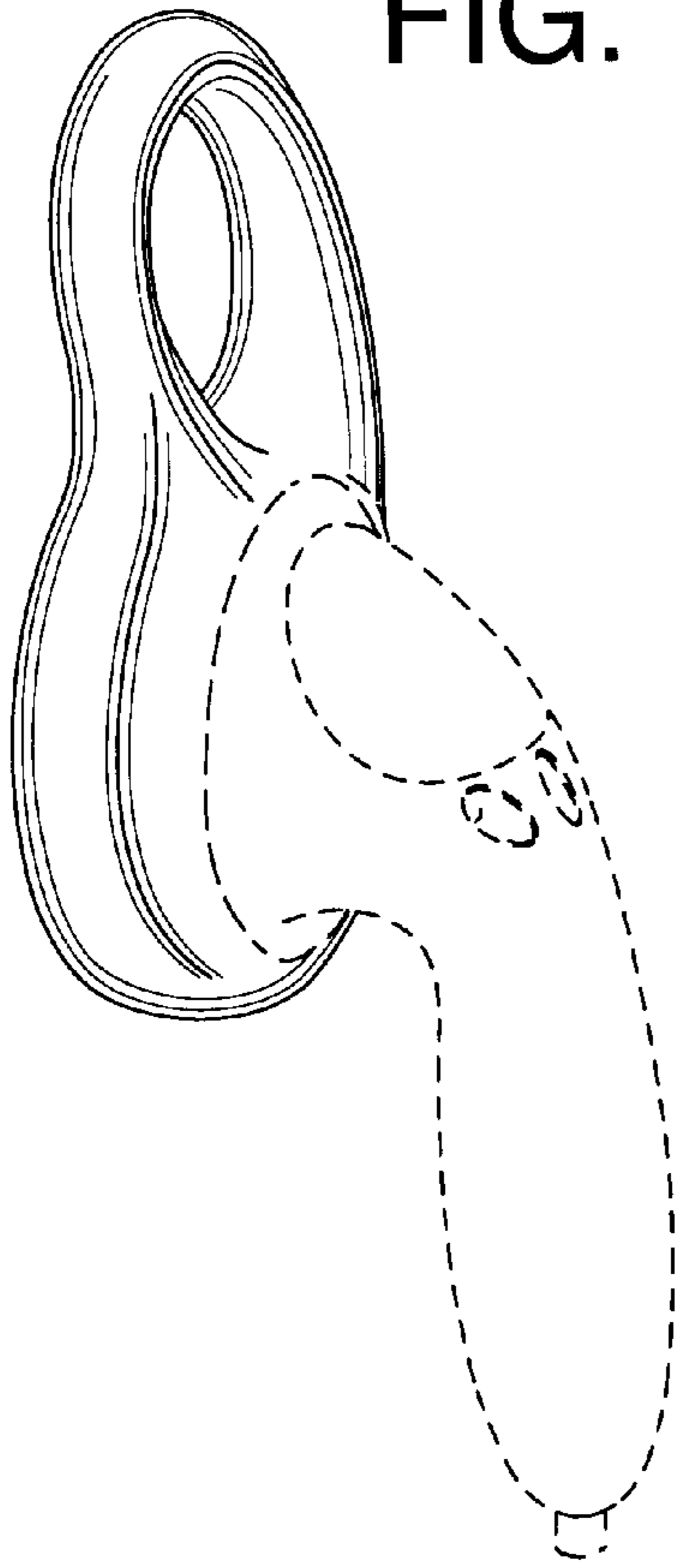

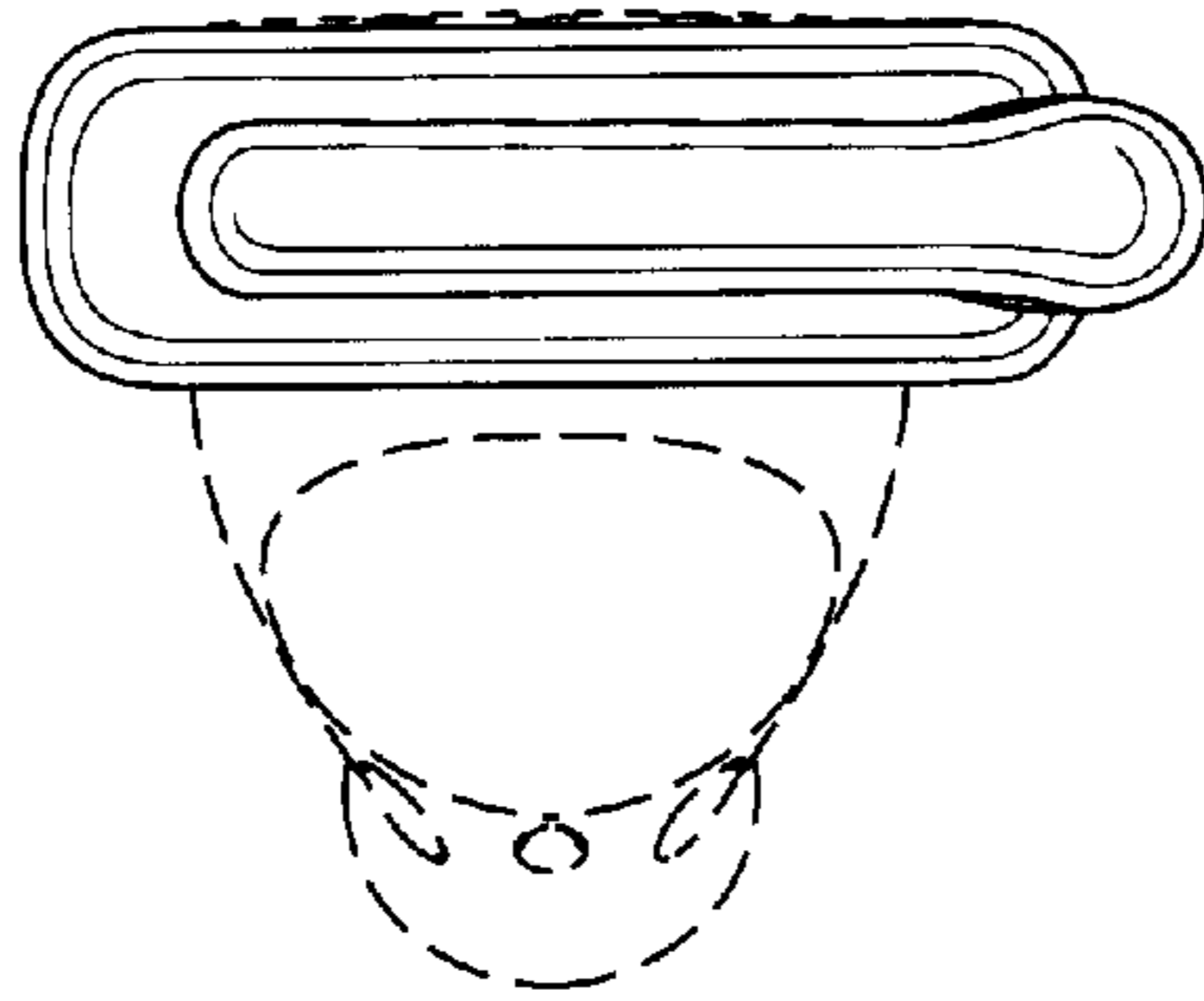

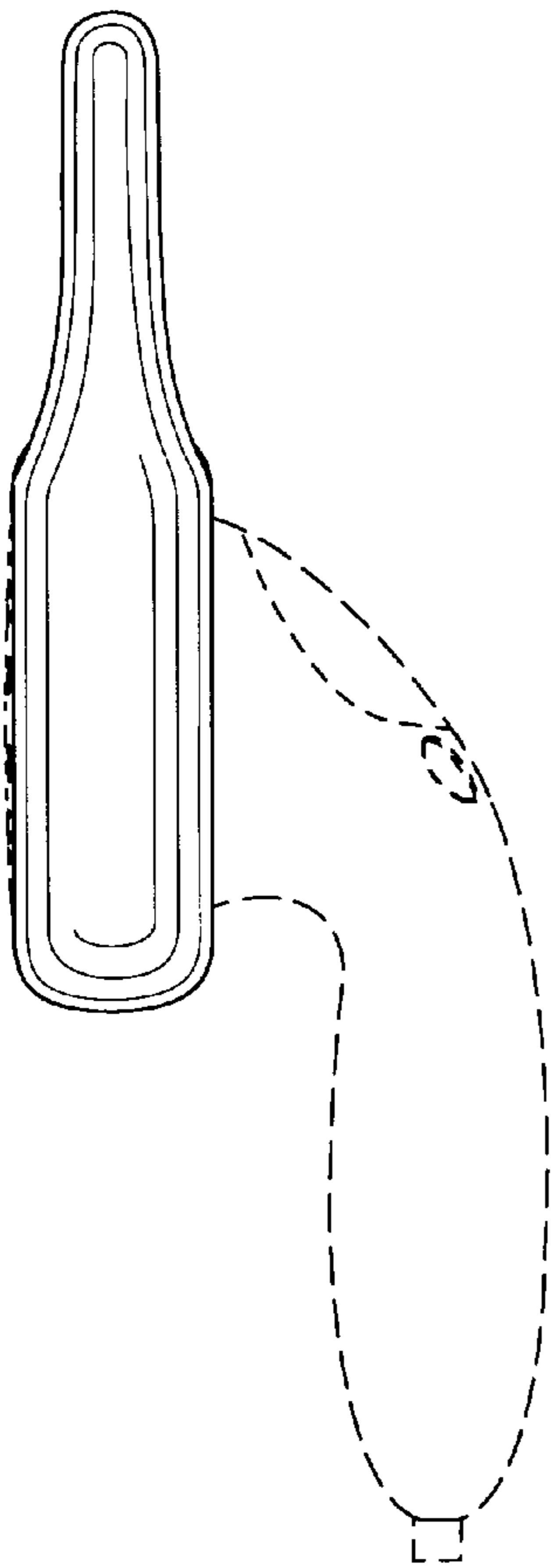

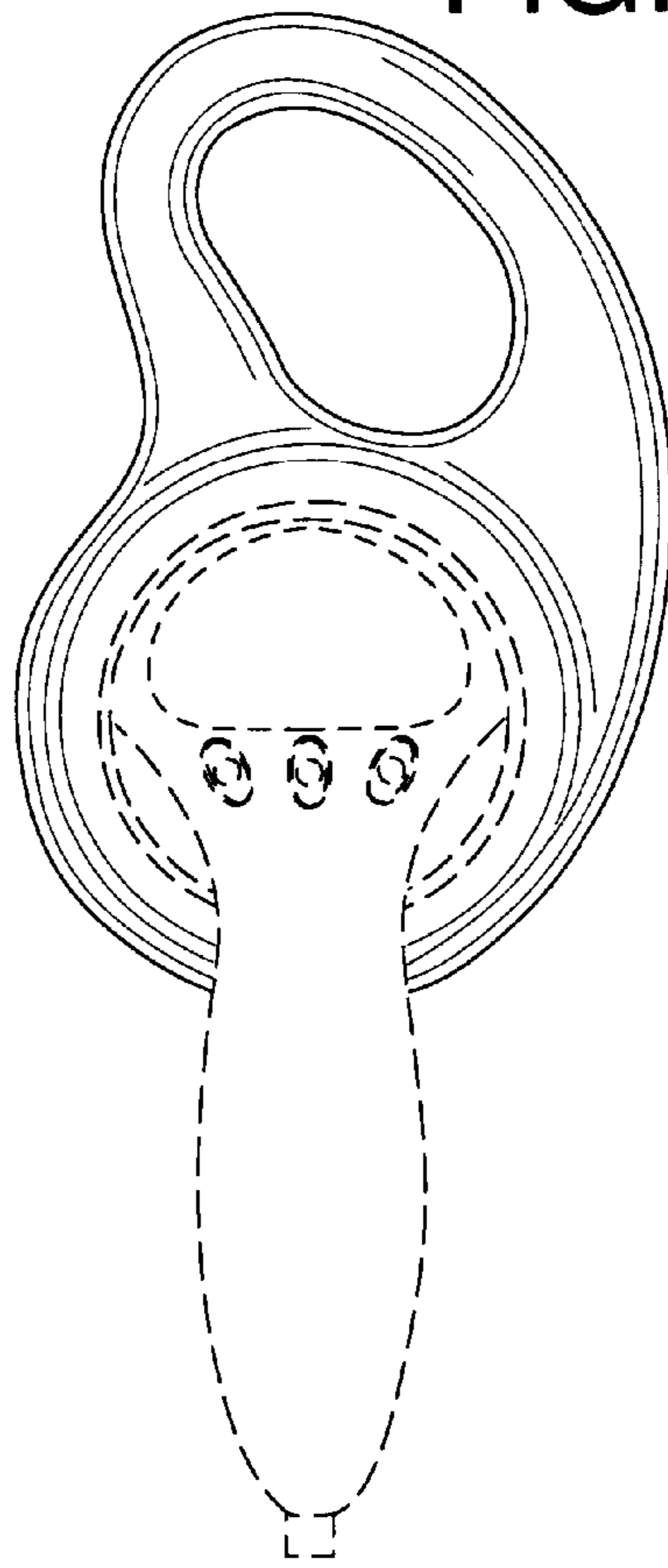

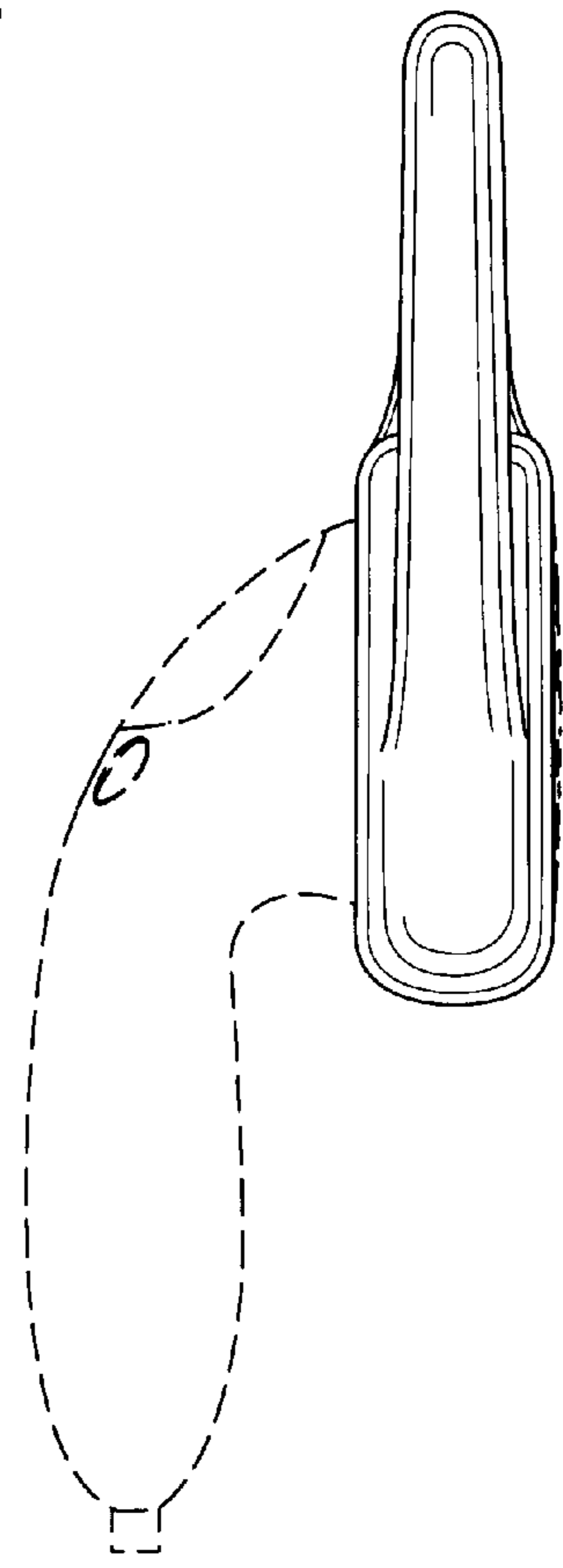
