(57) **CLAIM**

We claim the ornamental design for a headset signal converter pod, as shown and described.

DESCRIPTION

FIG. 1 is view of a headset signal converter pod of the design shown as typically used with a headset, a personal computer,

and connections thereto shown in dotted lines that form no part of the claimed invention;

FIG. 2 is a perspective view of the headset signal converter pod of the design as seen from the front and one side;

FIG. 3 is a top plan view thereof;

FIG. 4 is a front elevation view thereof;

FIG. 5 is a side elevation view as seen from right to left of the view shown in FIG. 3;

FIG. 6 is a side elevation view as seen from left to right of the view shown in FIG. 3;

FIG. 7 is a rear elevation view thereof;

FIG. 8 is a bottom plan view thereof;

FIG. 9 is view of a second embodiment of the headset signal converter pod of the design shown as typically used with a headset, a personal computer, and connections thereto shown in dotted lines that form no part of the claimed invention;

FIG. 10 is a perspective view of the headset signal converter pod of the design as seen from the front and one side;

FIG. 11 is a top plan view thereof;

FIG. 12 is a front elevation view thereof;

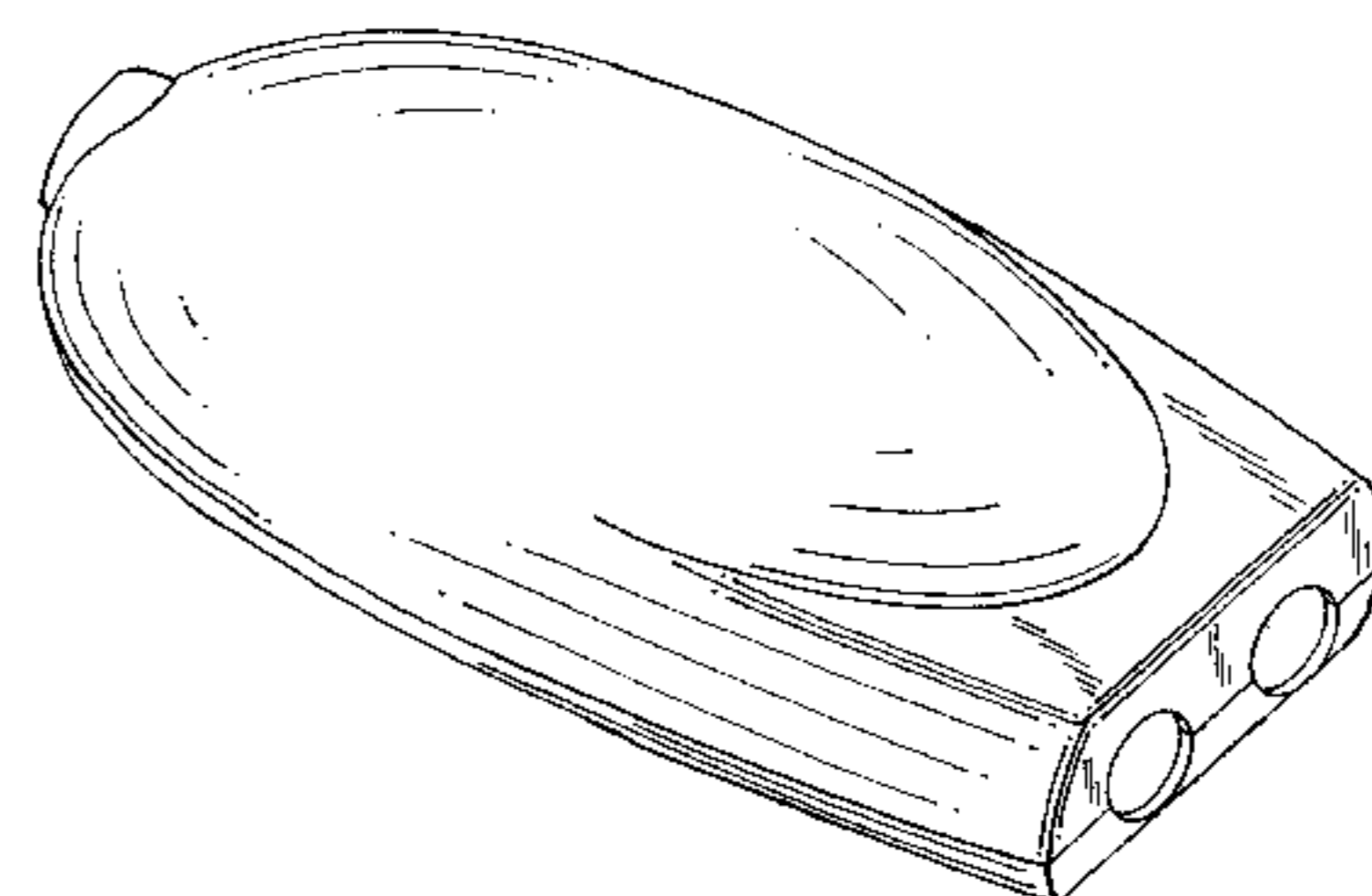
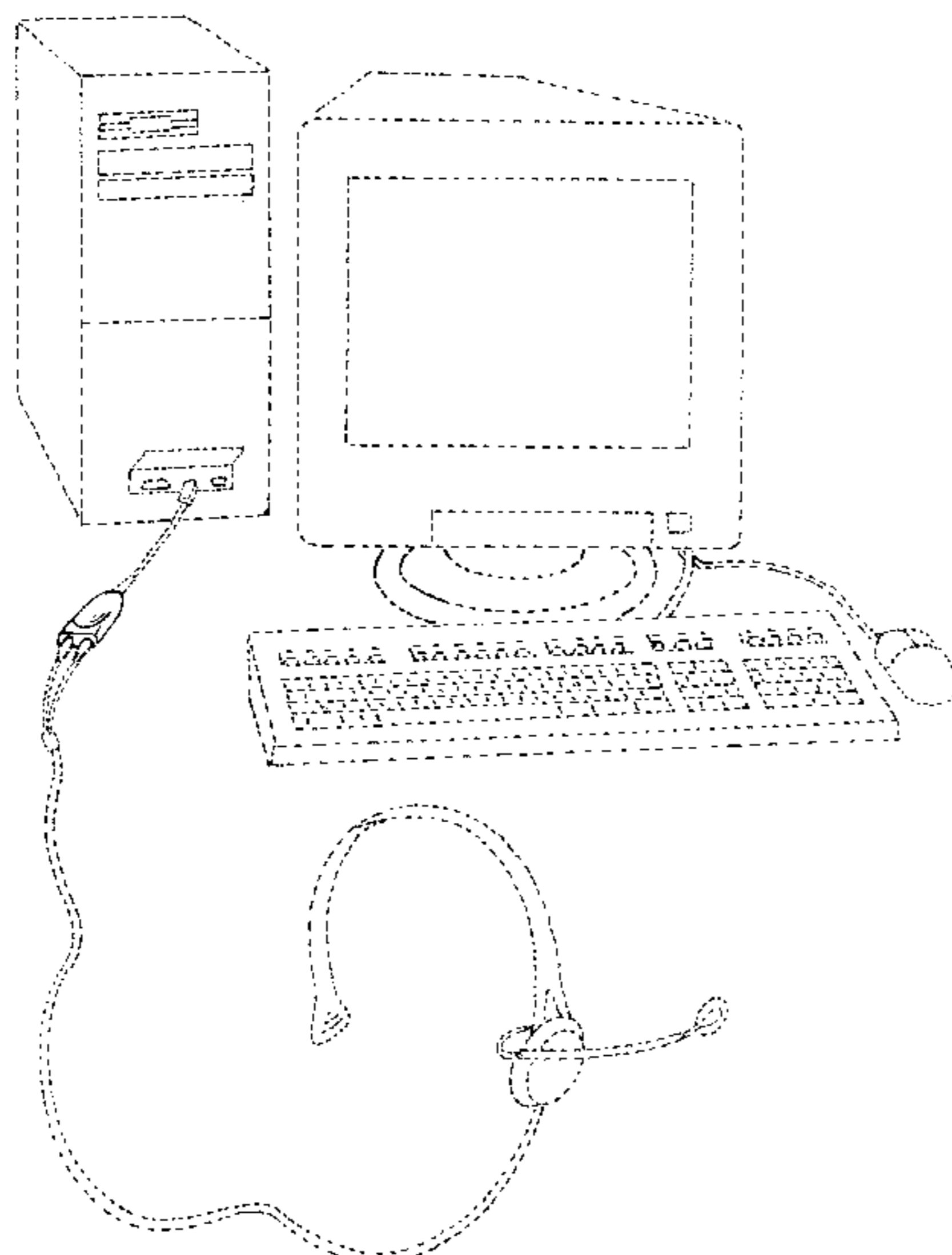
FIG. 13 is a side elevation view as seen from right to left of the view shown in FIG. 11;

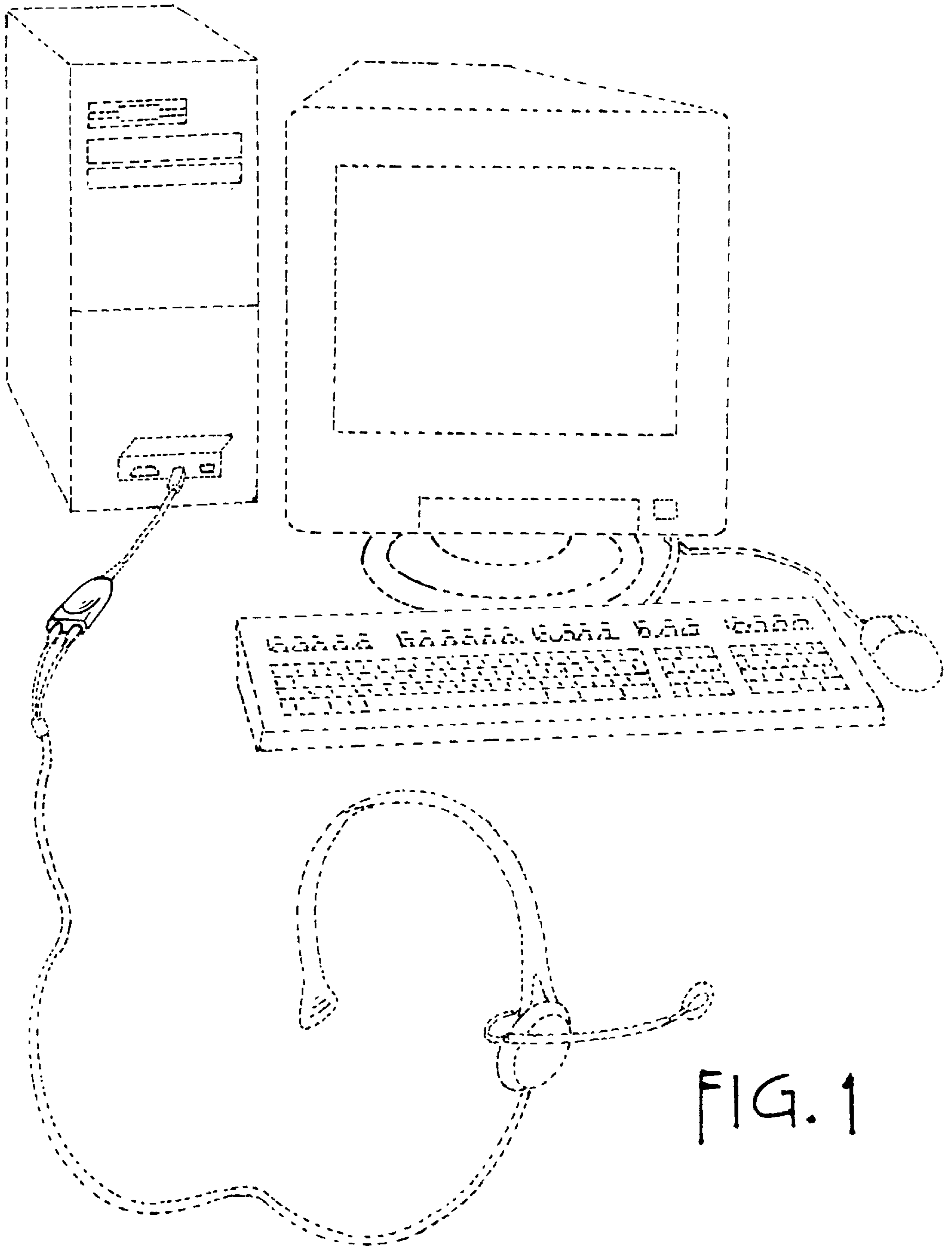

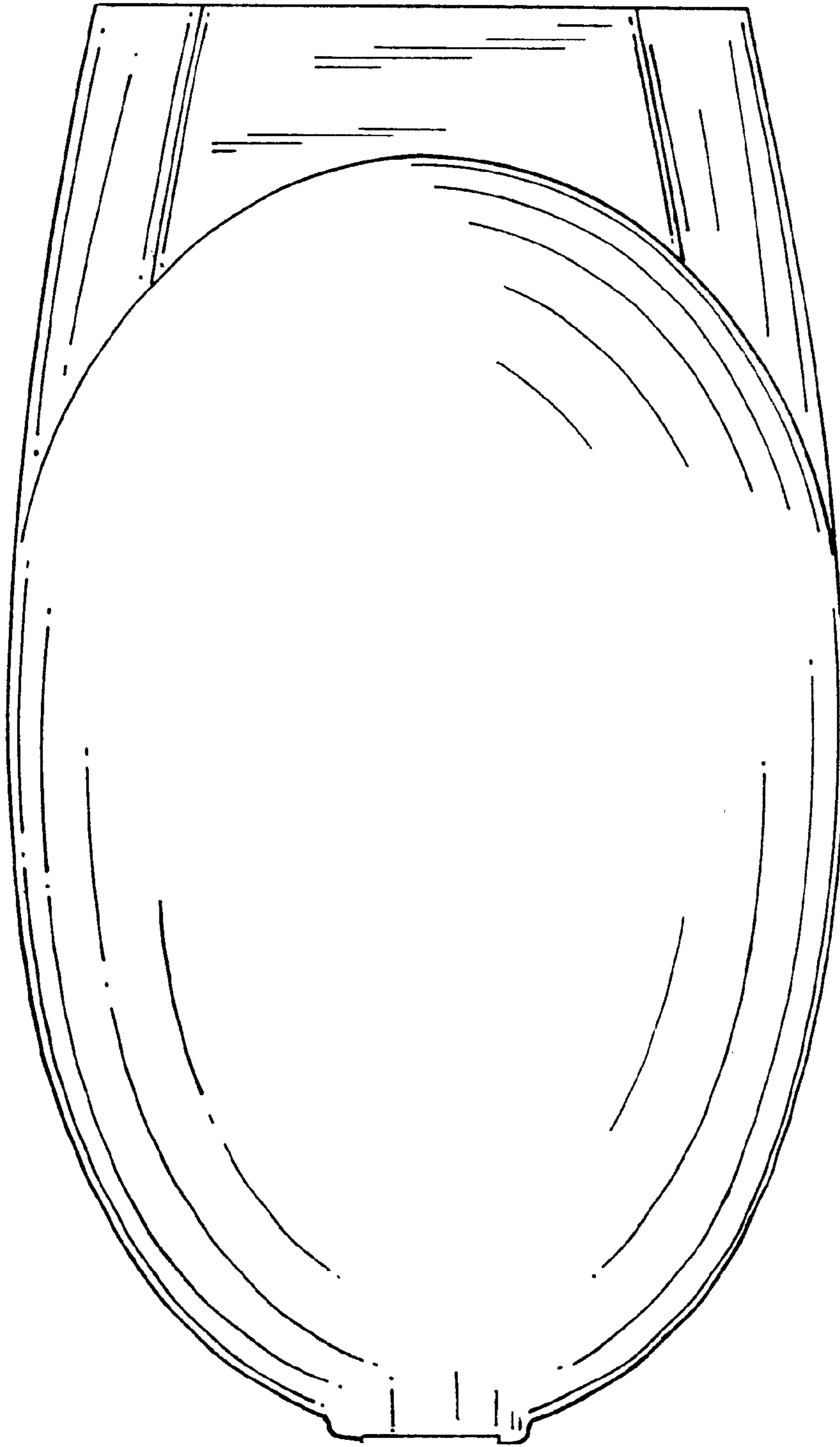

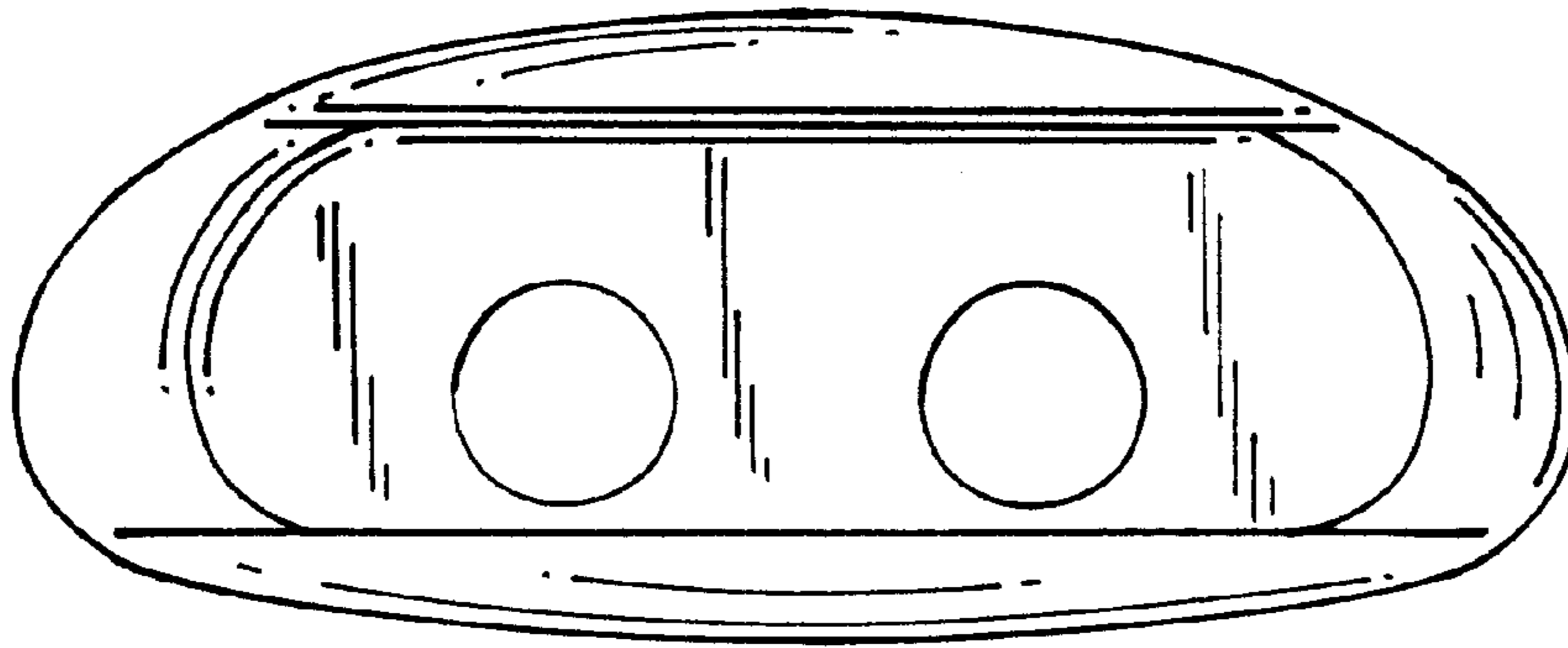

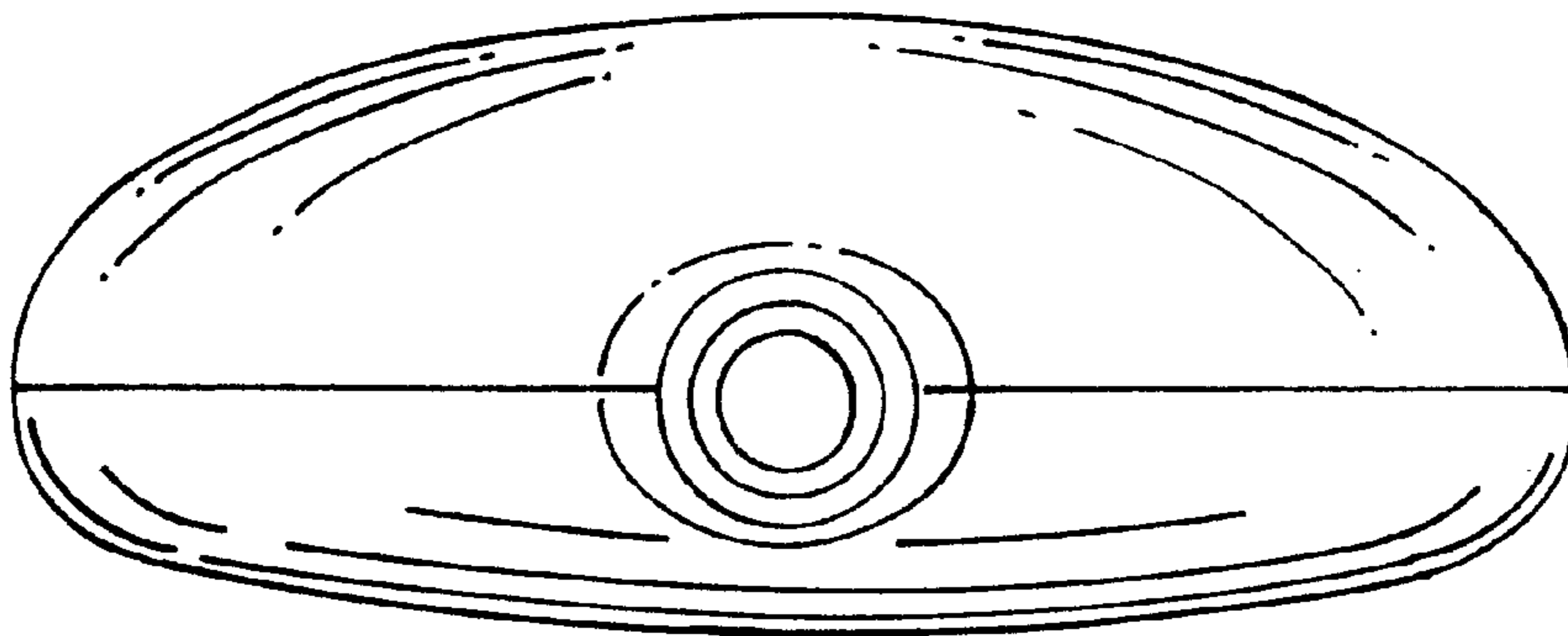

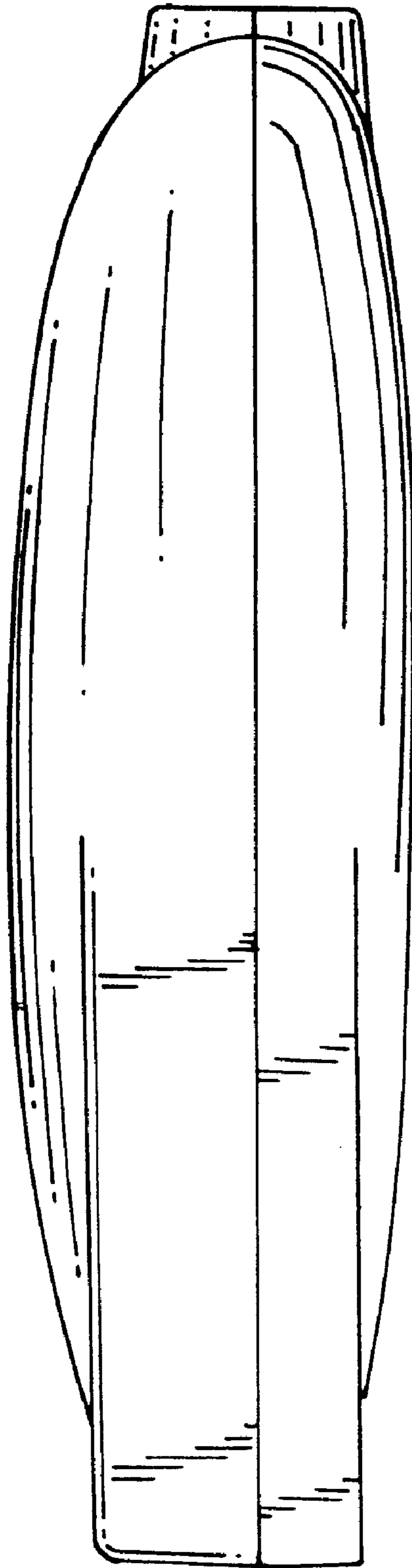

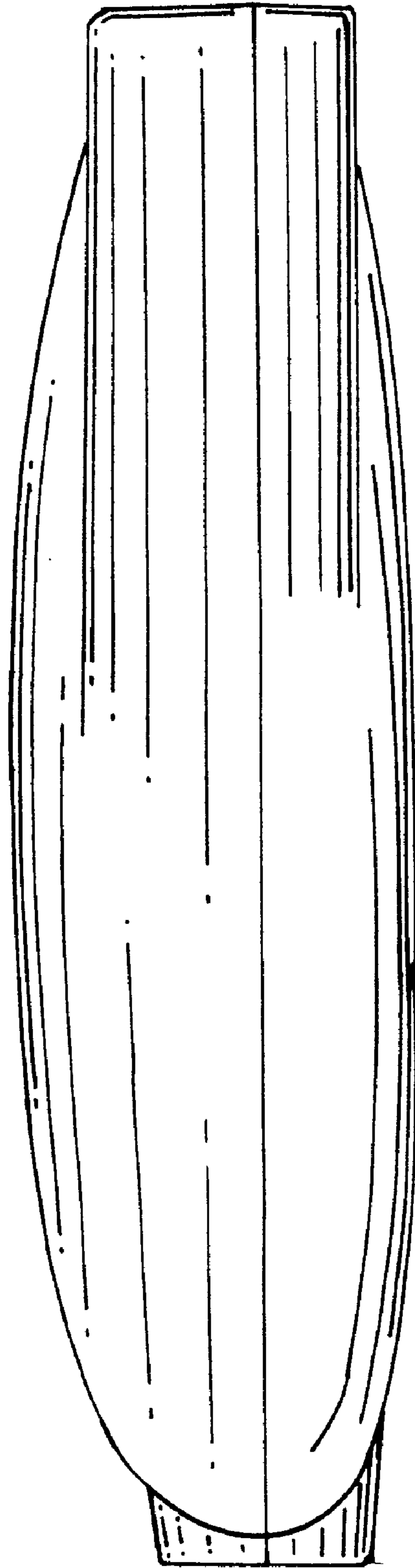

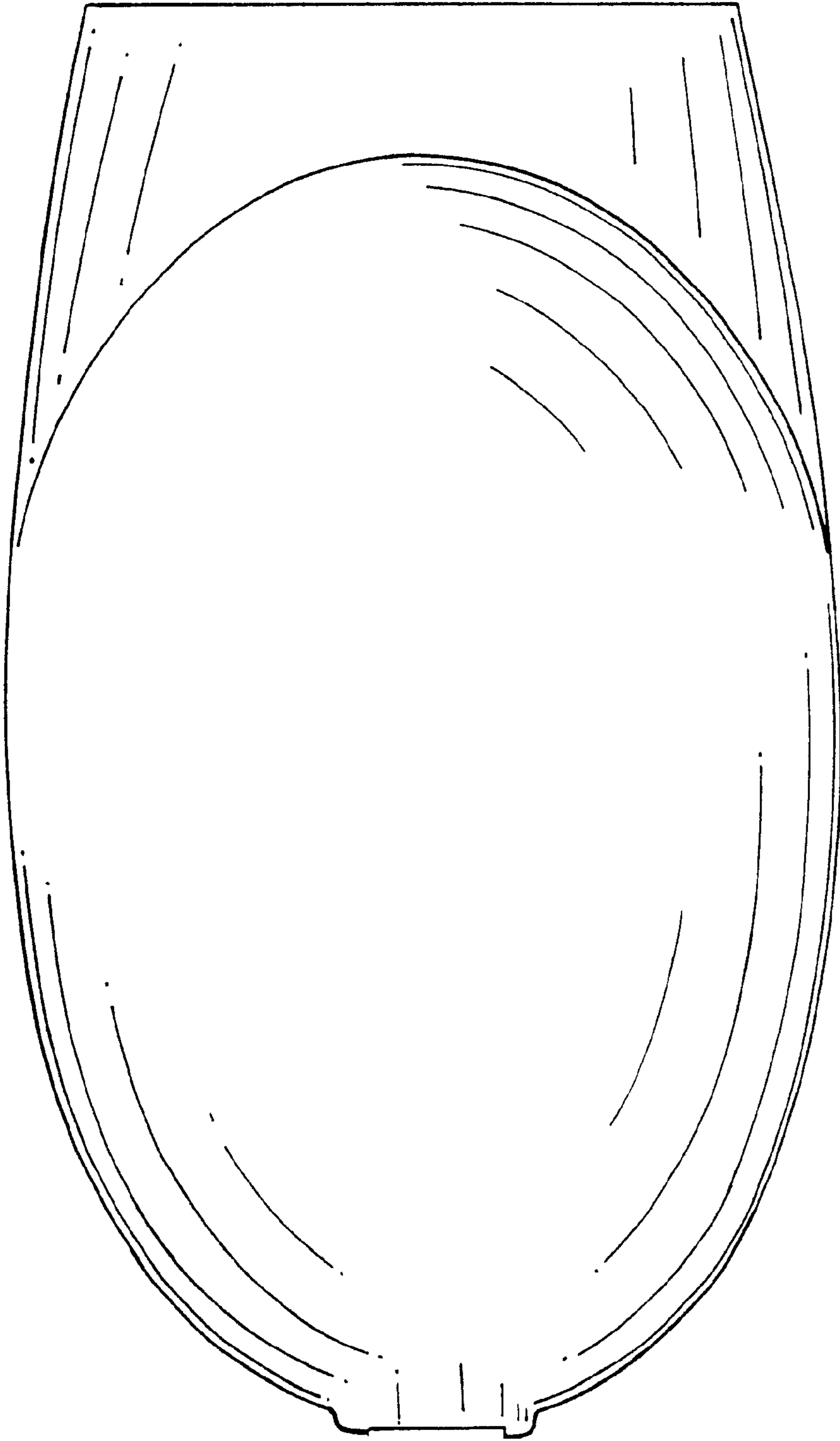

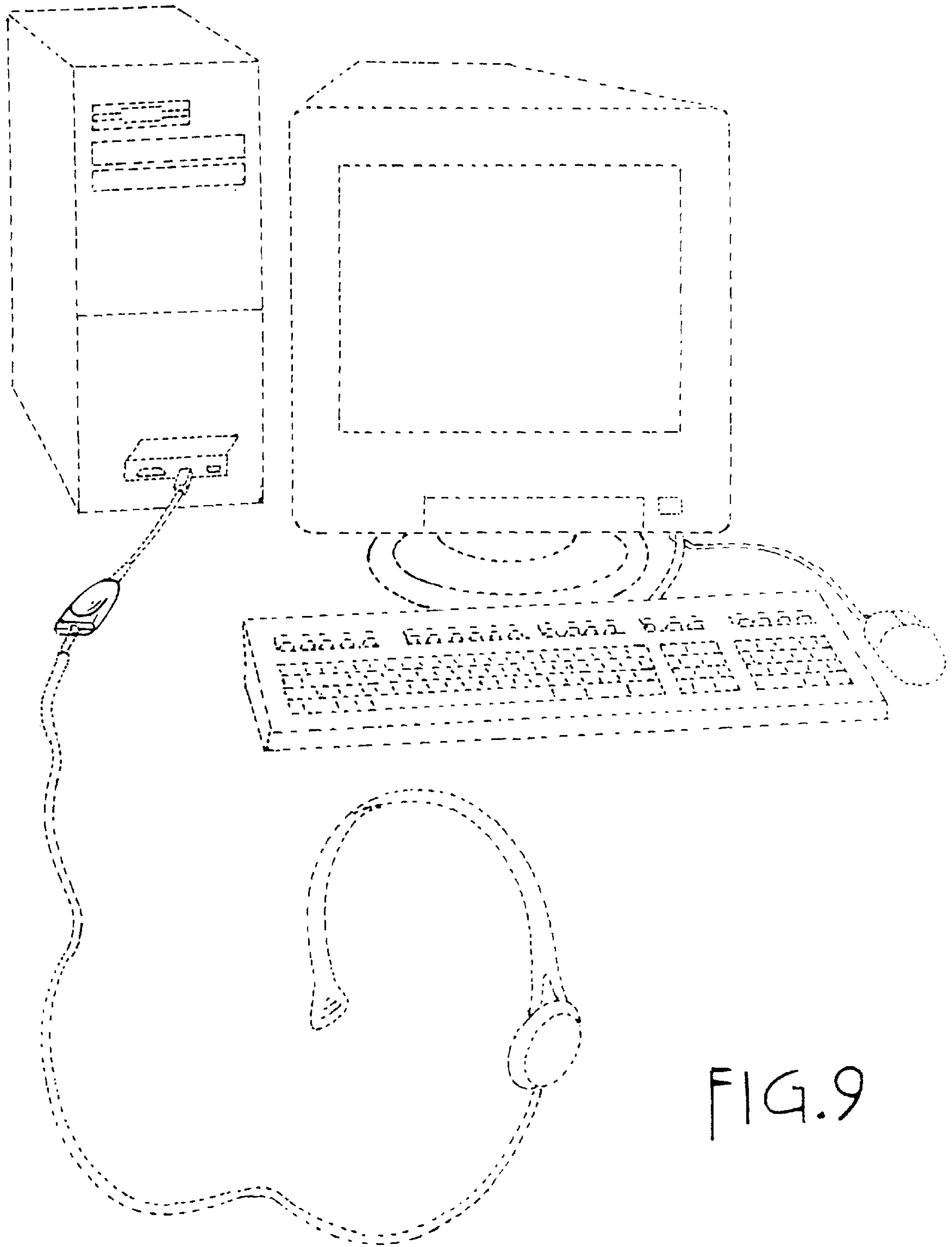

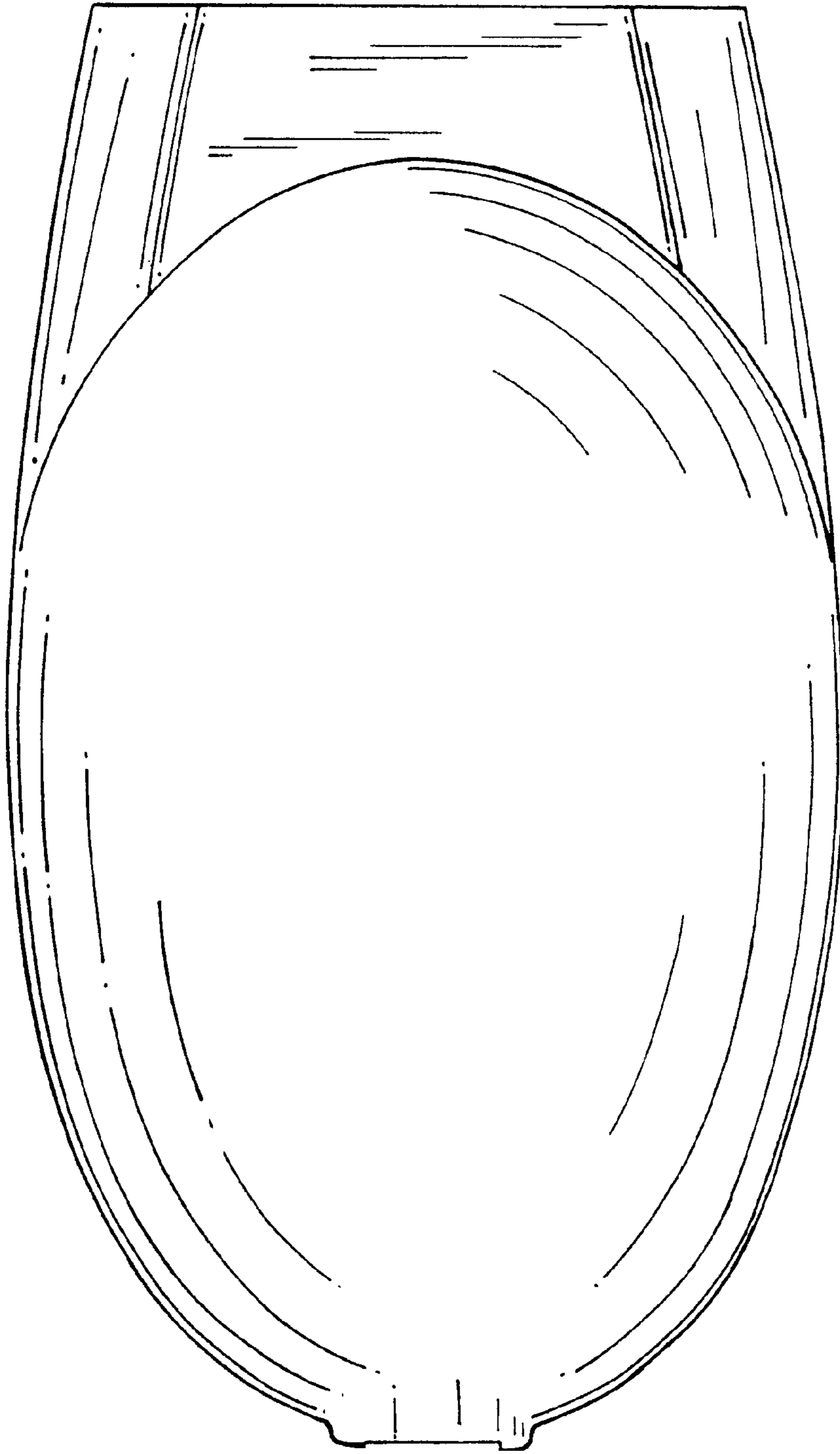

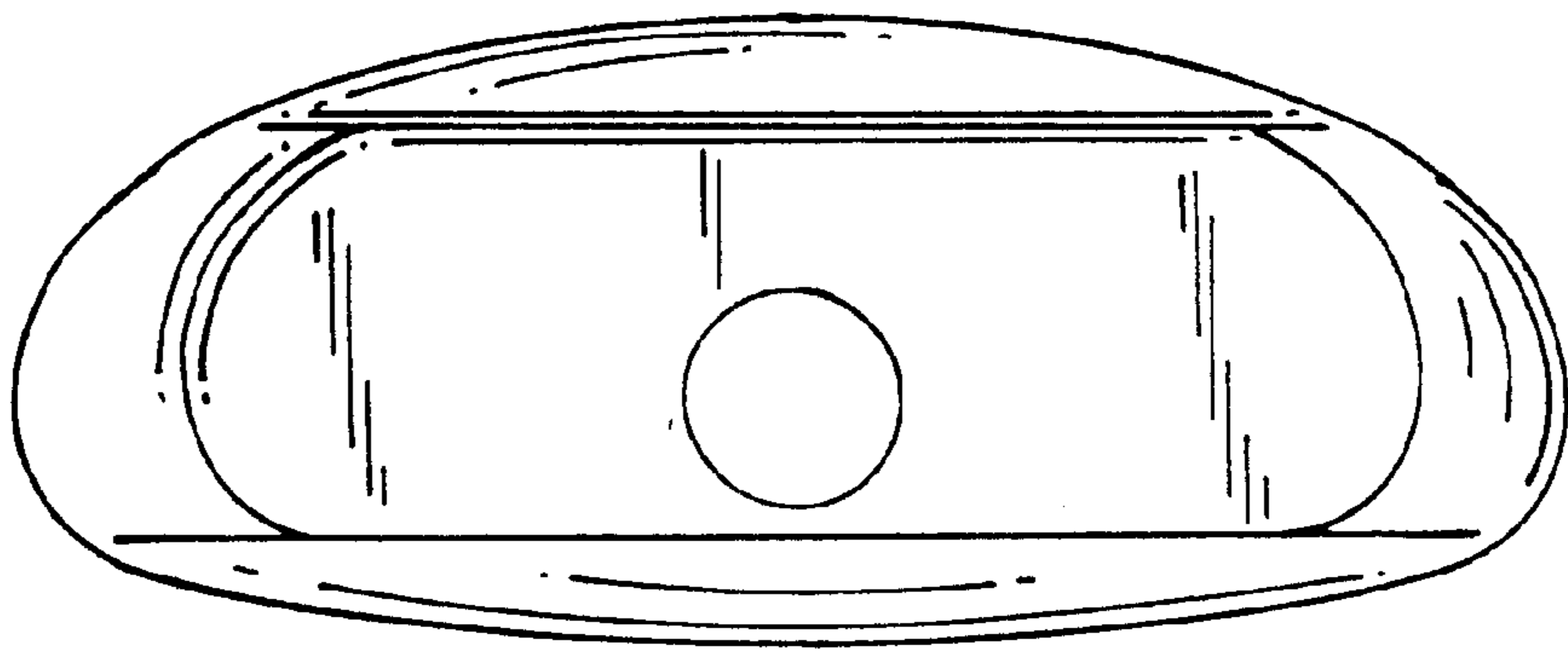

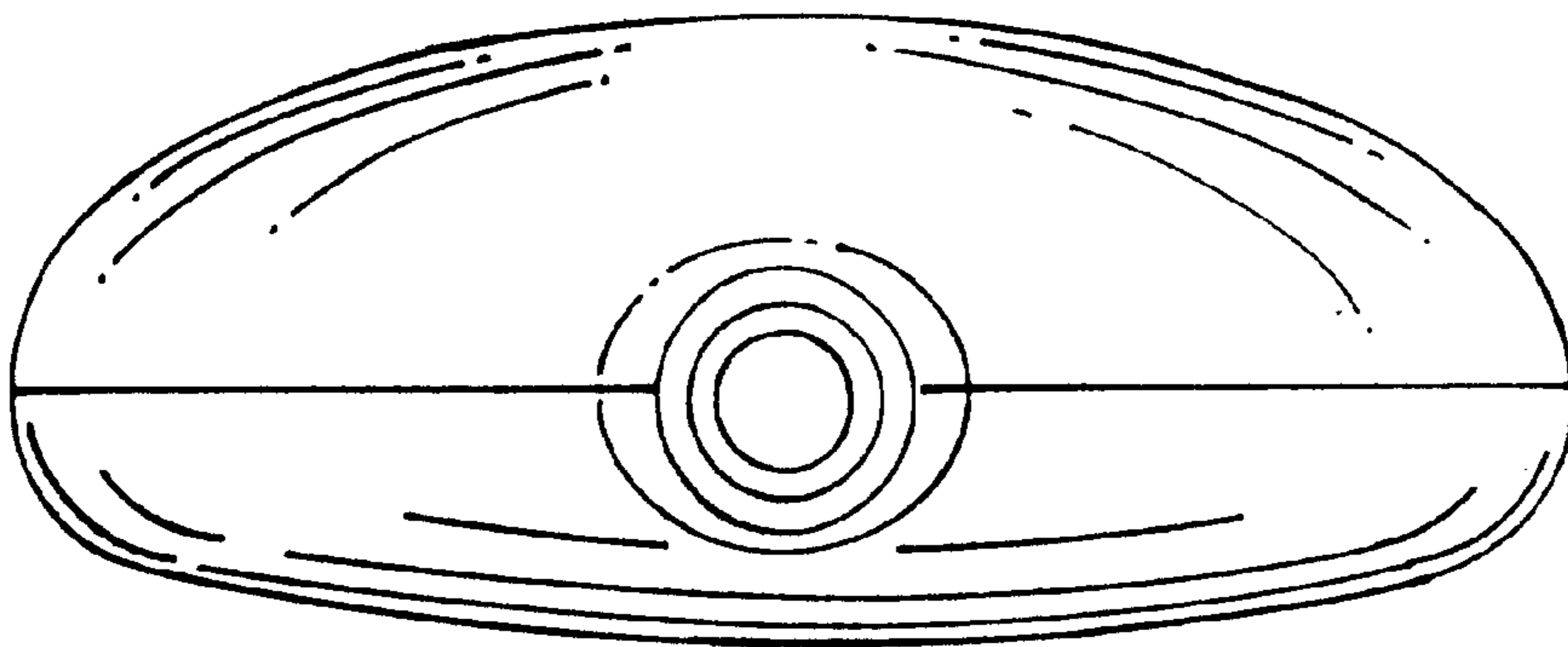

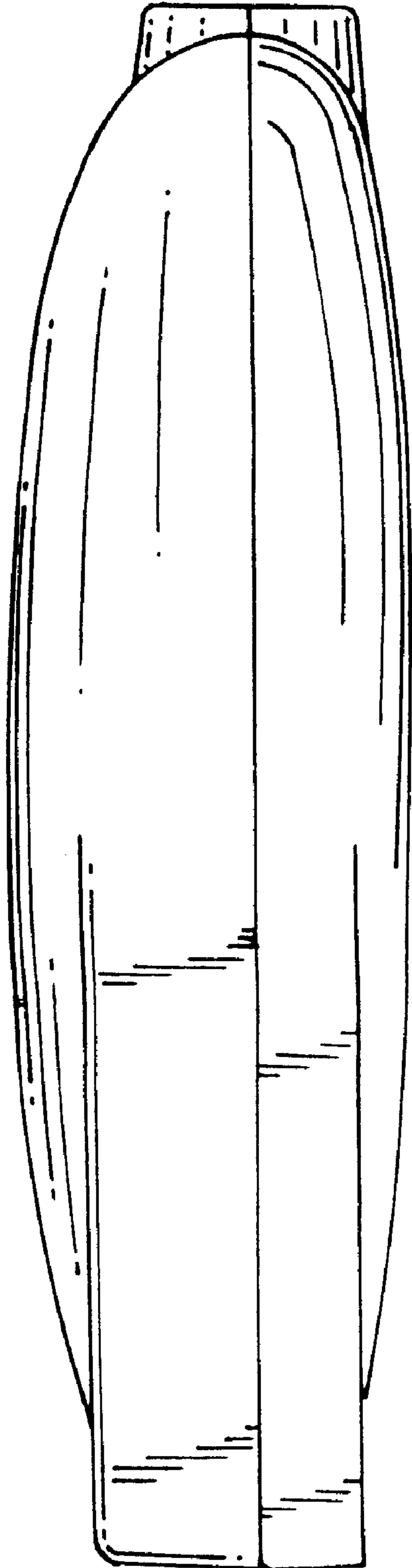

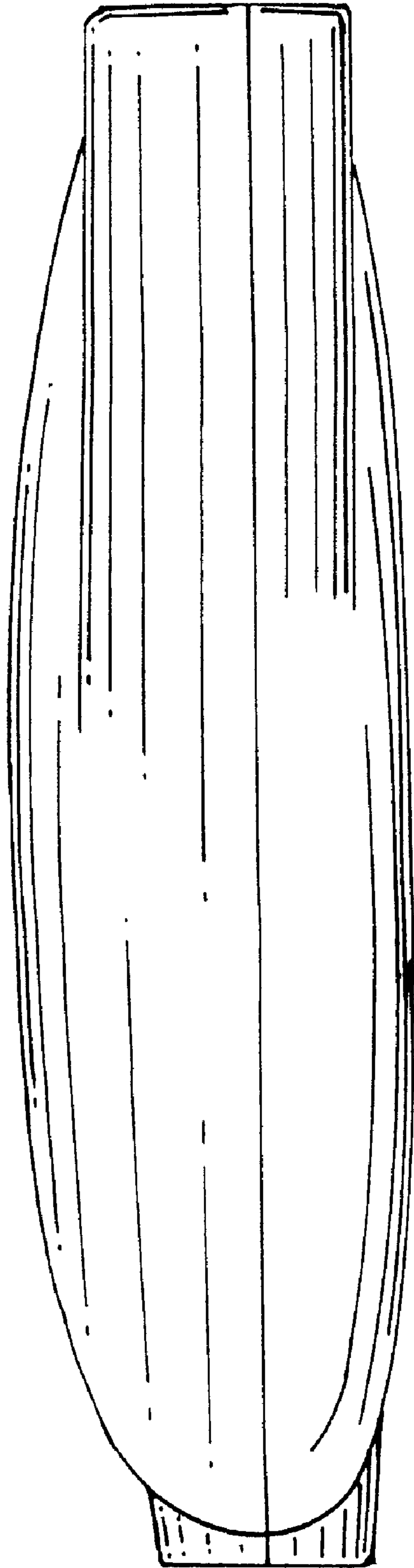

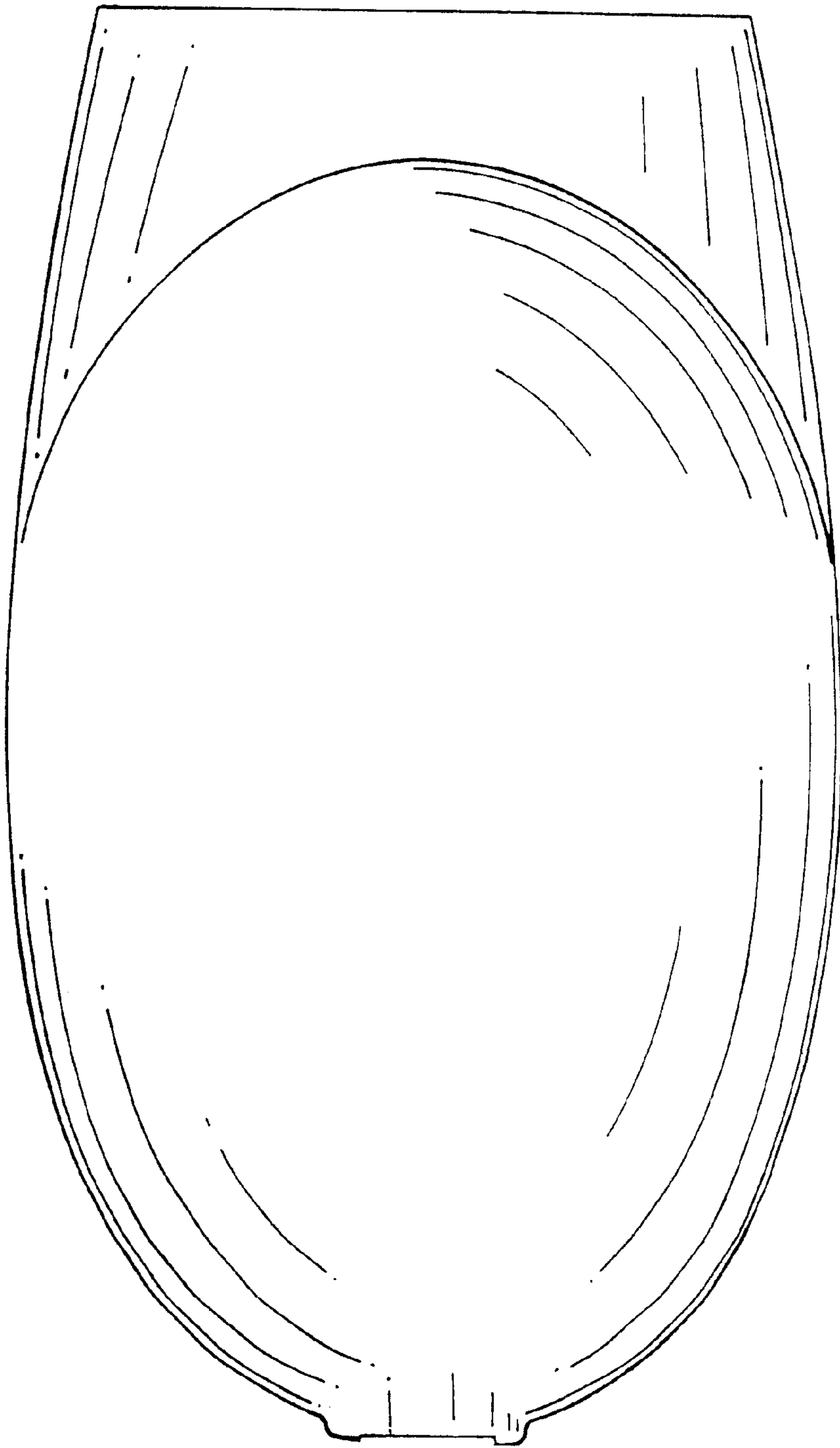
