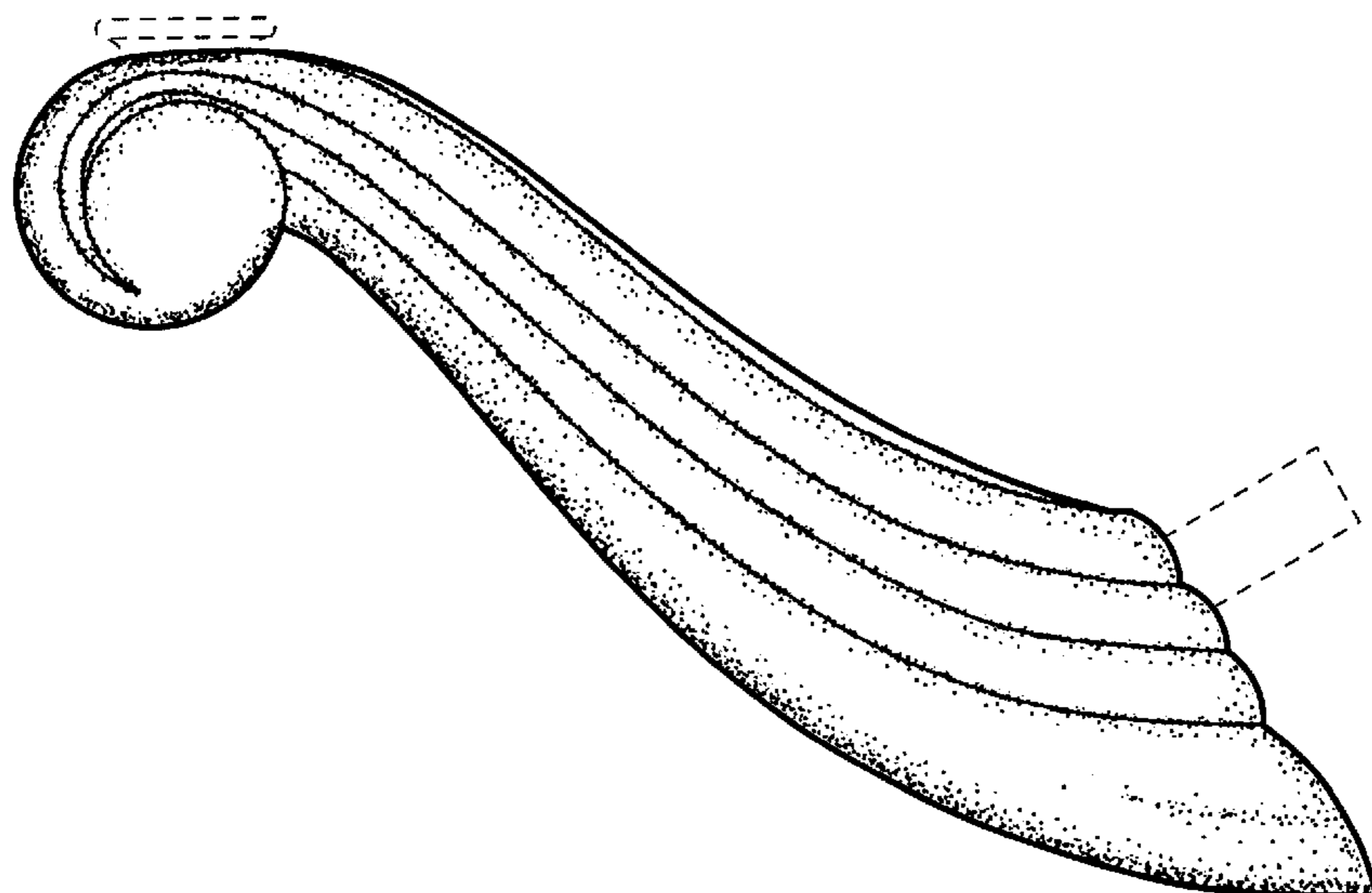
The ornamental design for a arm for a light fixture, as shown and described.

DESCRIPTION

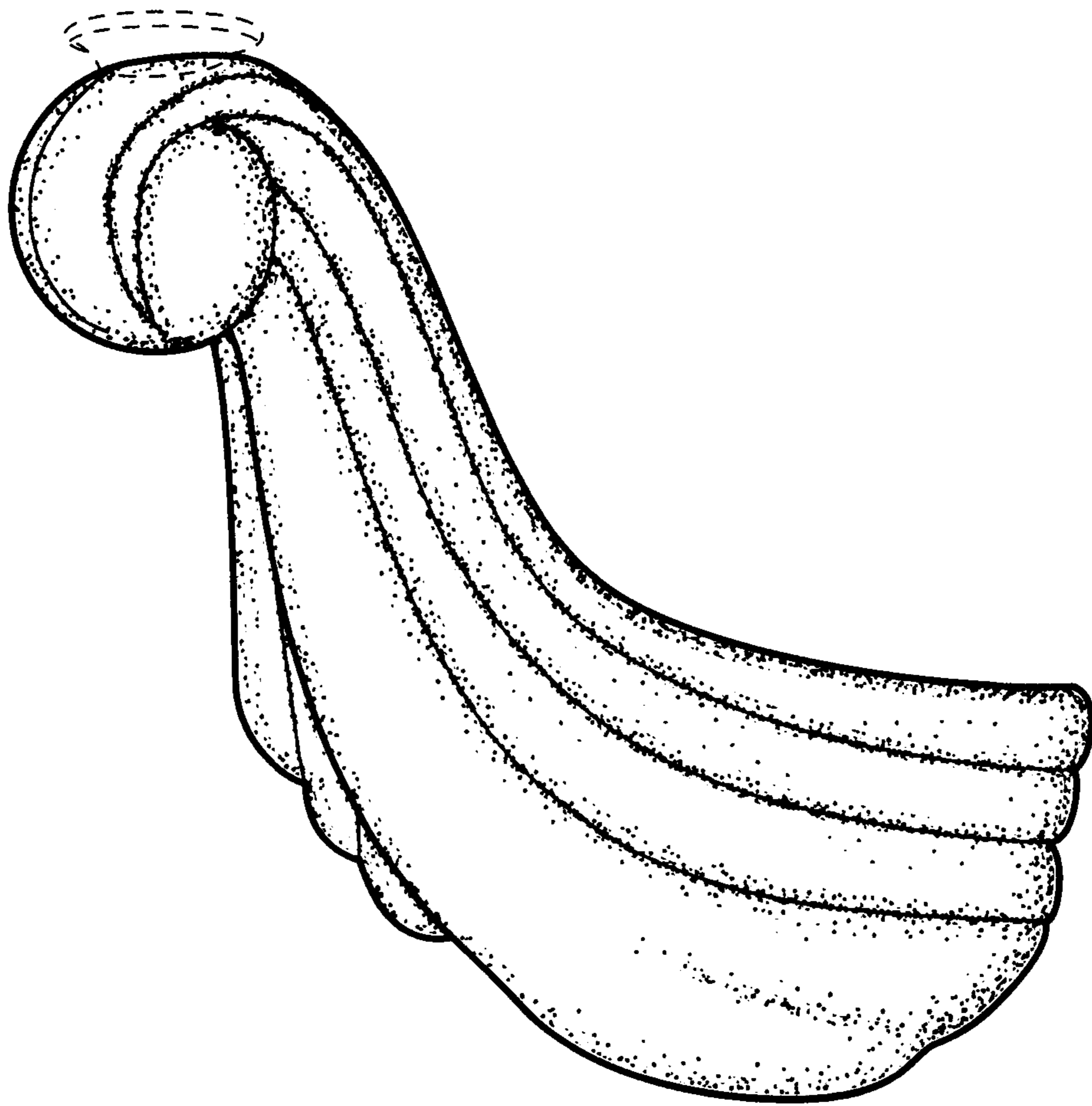

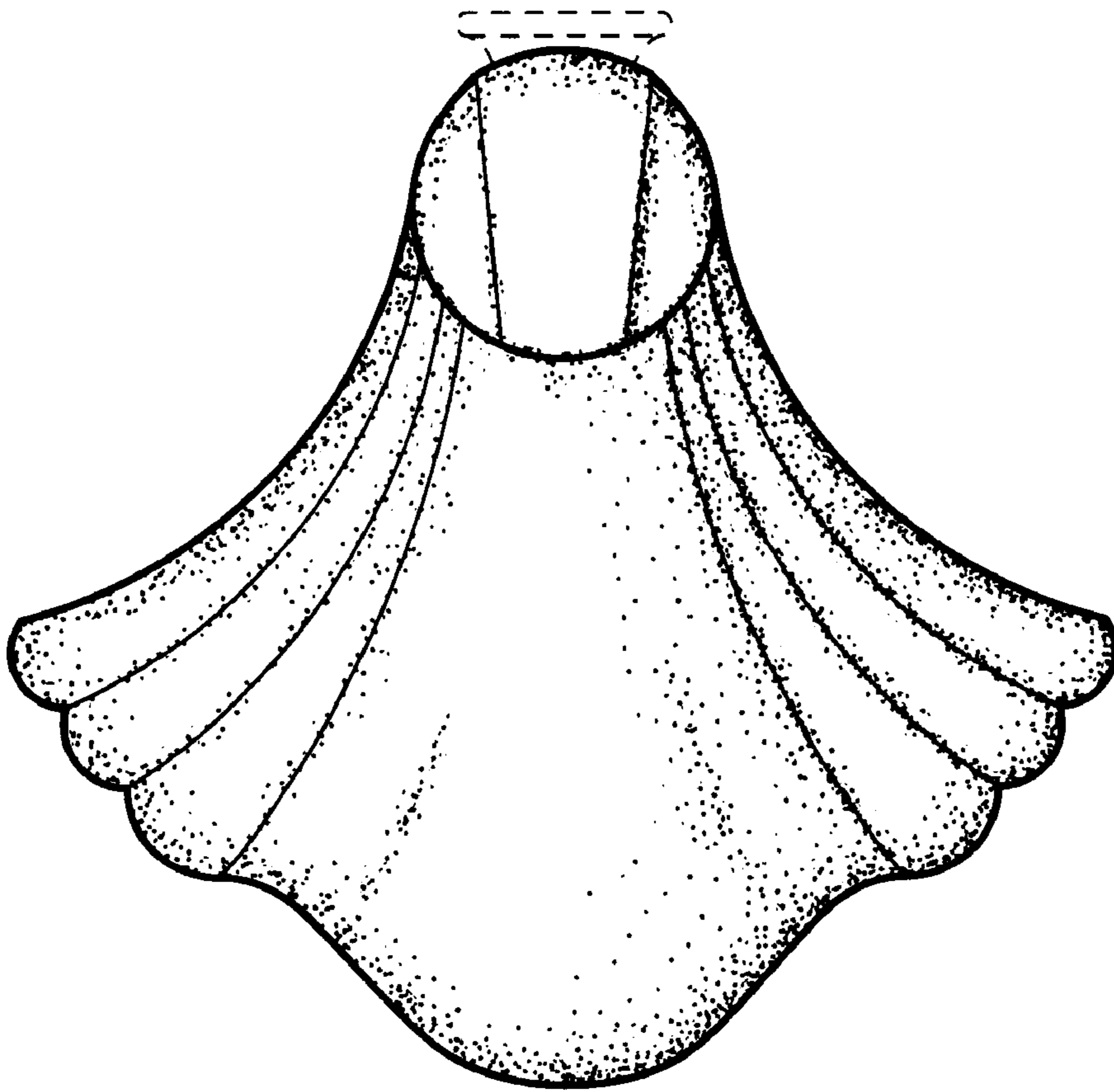

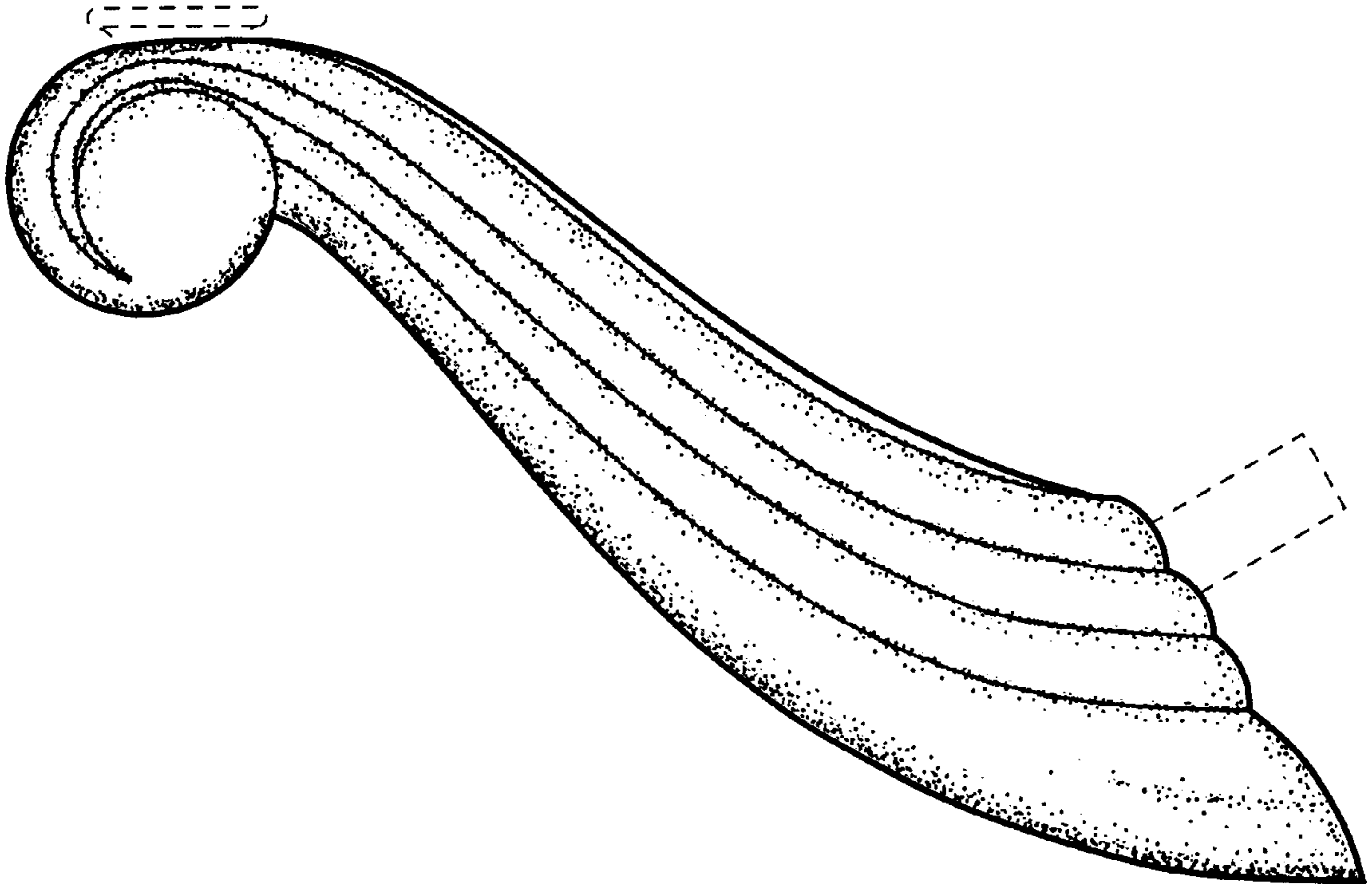

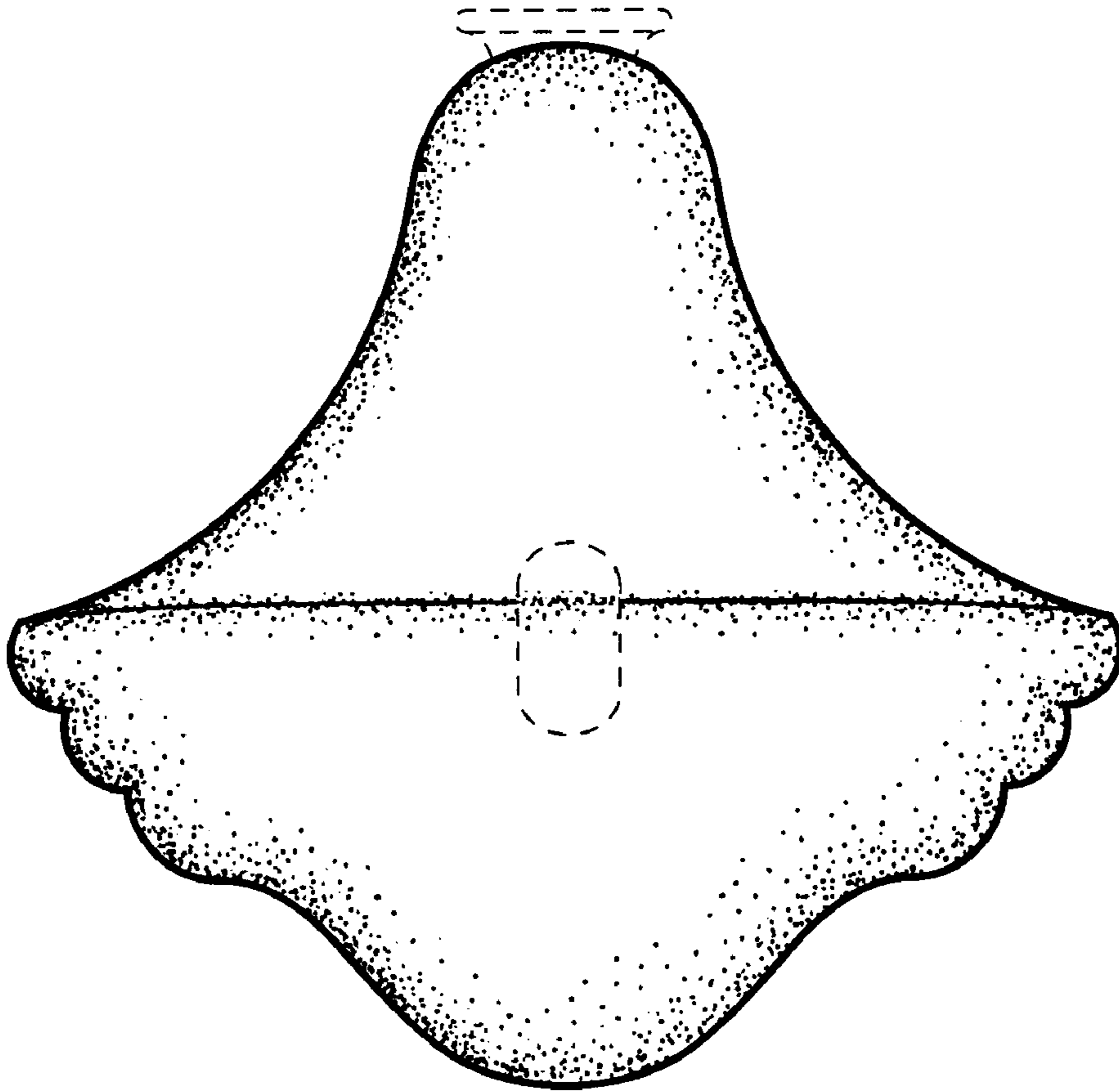

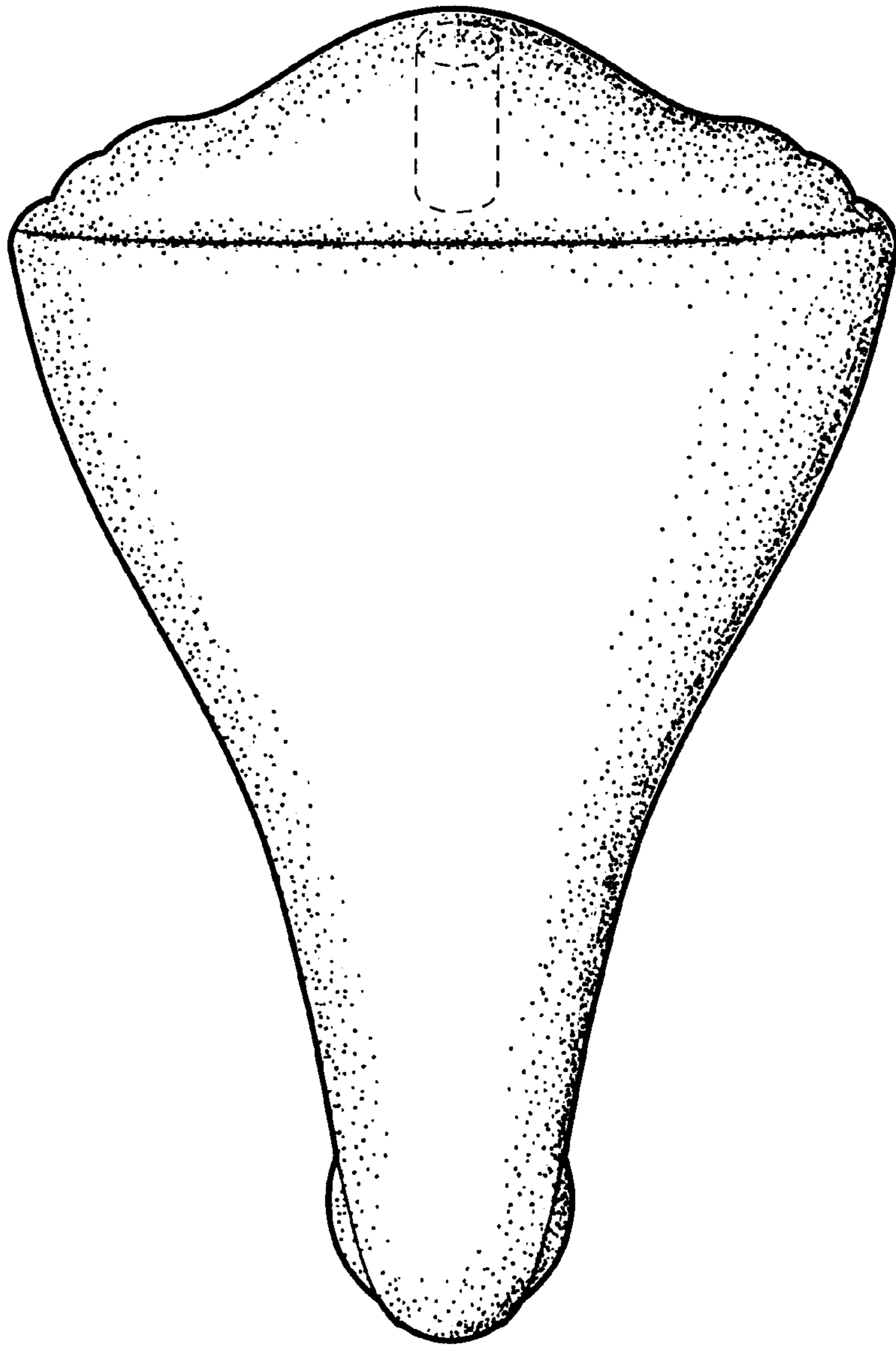

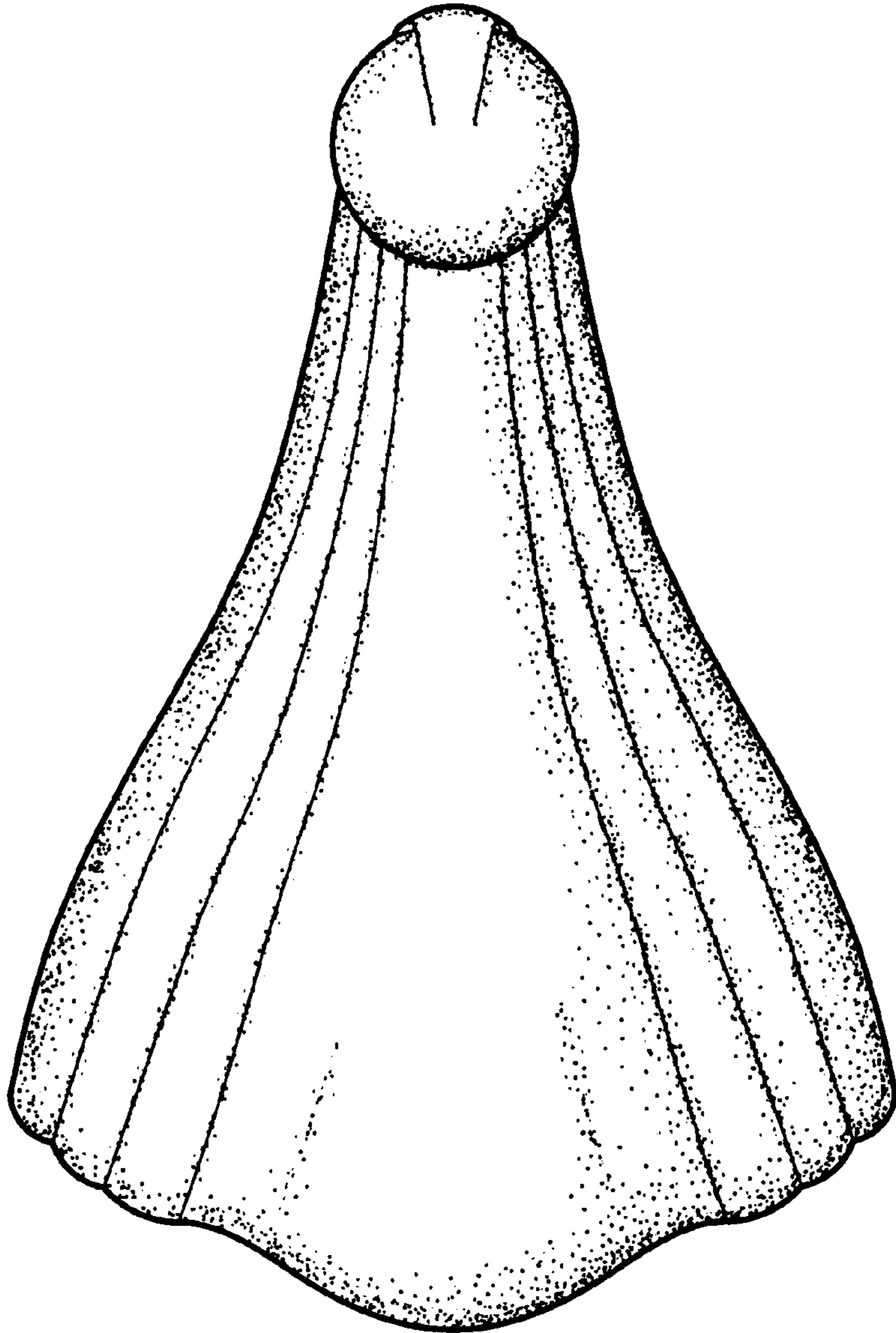
