(57) **CLAIM**

The ornamental design for a single holding device, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a first embodiment of a single holding device;

FIG. 2 is a front view of the holding device shown in FIG. 1;

FIG. 3 is a rear side view of the holding device shown in FIG. 1;

FIG. 4 is a right side view of the holding device shown in FIG. 1, the left side view being a mirror thereof;

FIG. 5 is a top view of the holding device shown in FIG. 1;

FIG. 6 is a bottom view of the holding device shown in FIG. 1;

FIG. 7 is a perspective view of a second embodiment of a single holding device;

FIG. 8 is a front view of the holding device shown in FIG. 7;

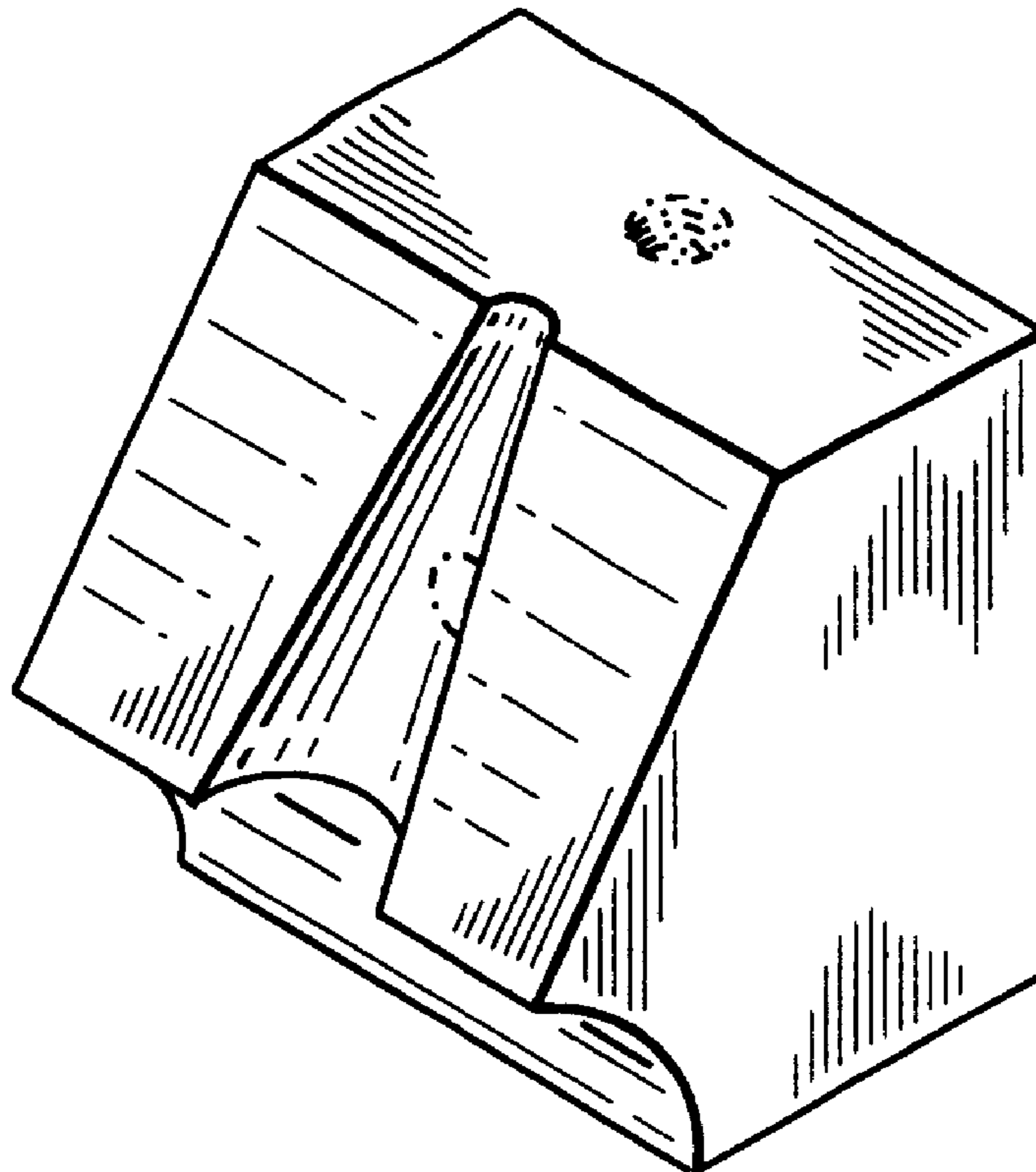
FIG. 9 is a right side view of the holding device shown in FIG. 7, the left side view being a mirror thereof;

FIG. 10 is a top view of the holding device shown in FIG. 7; and,

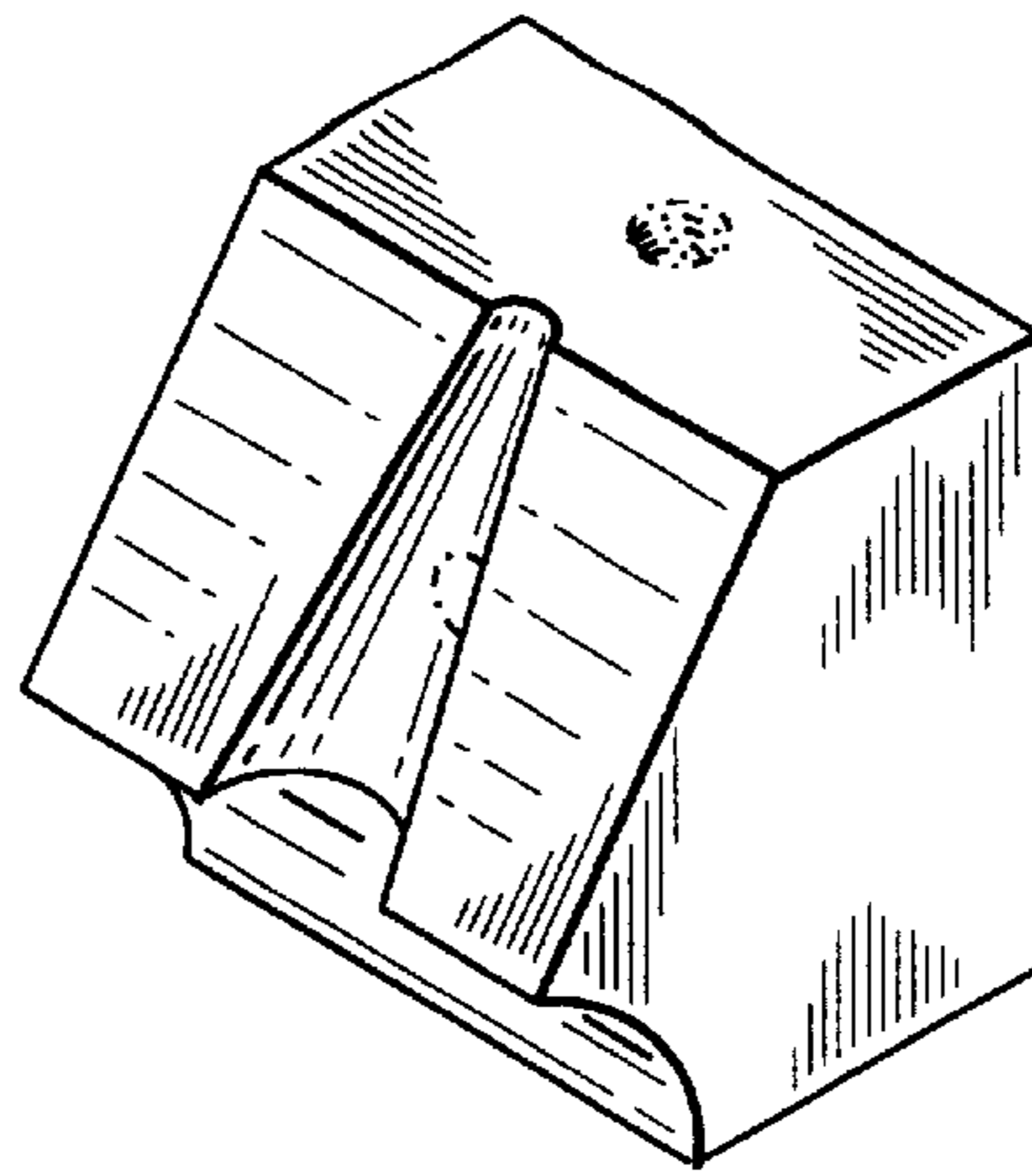

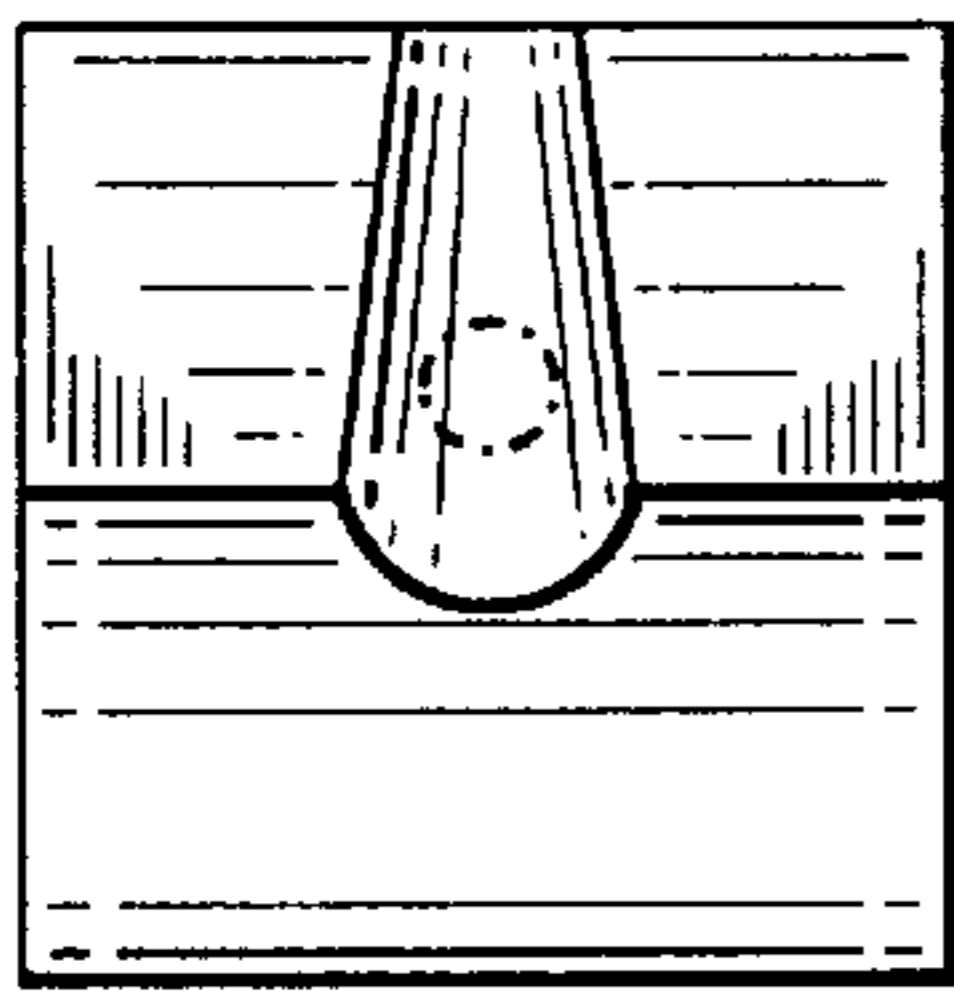

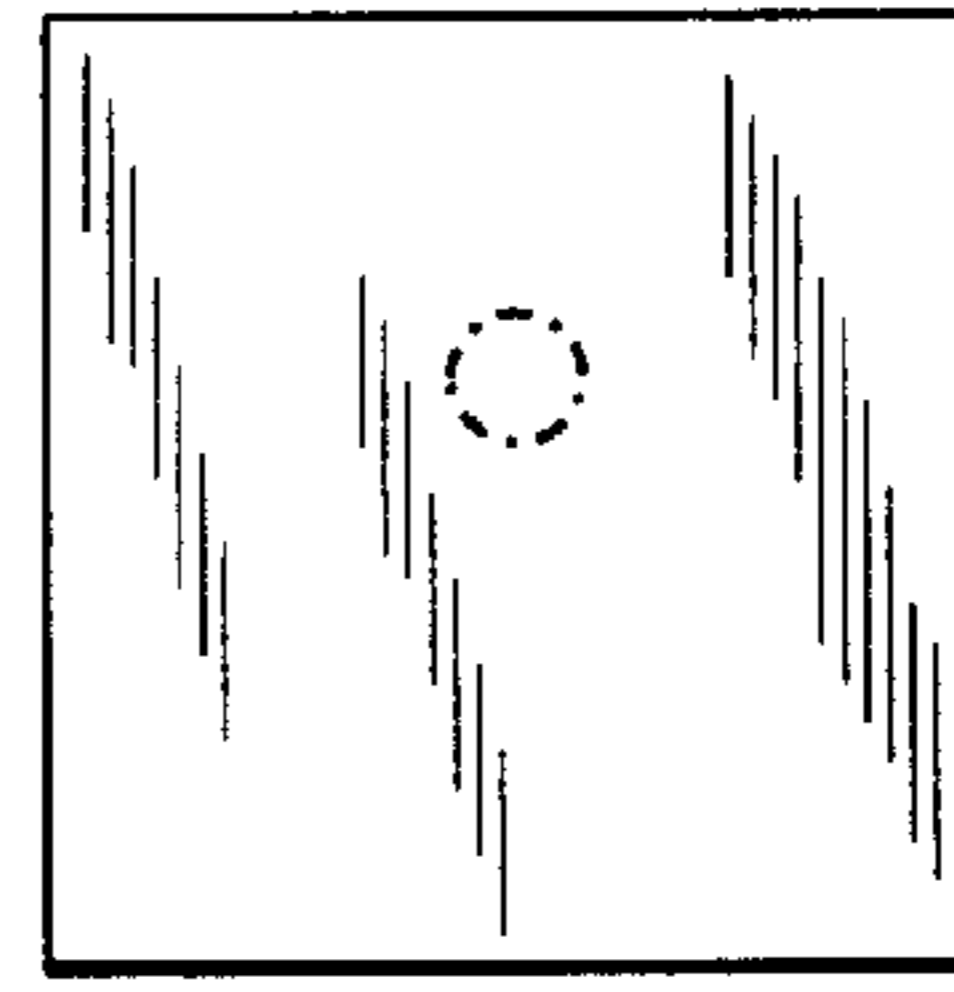

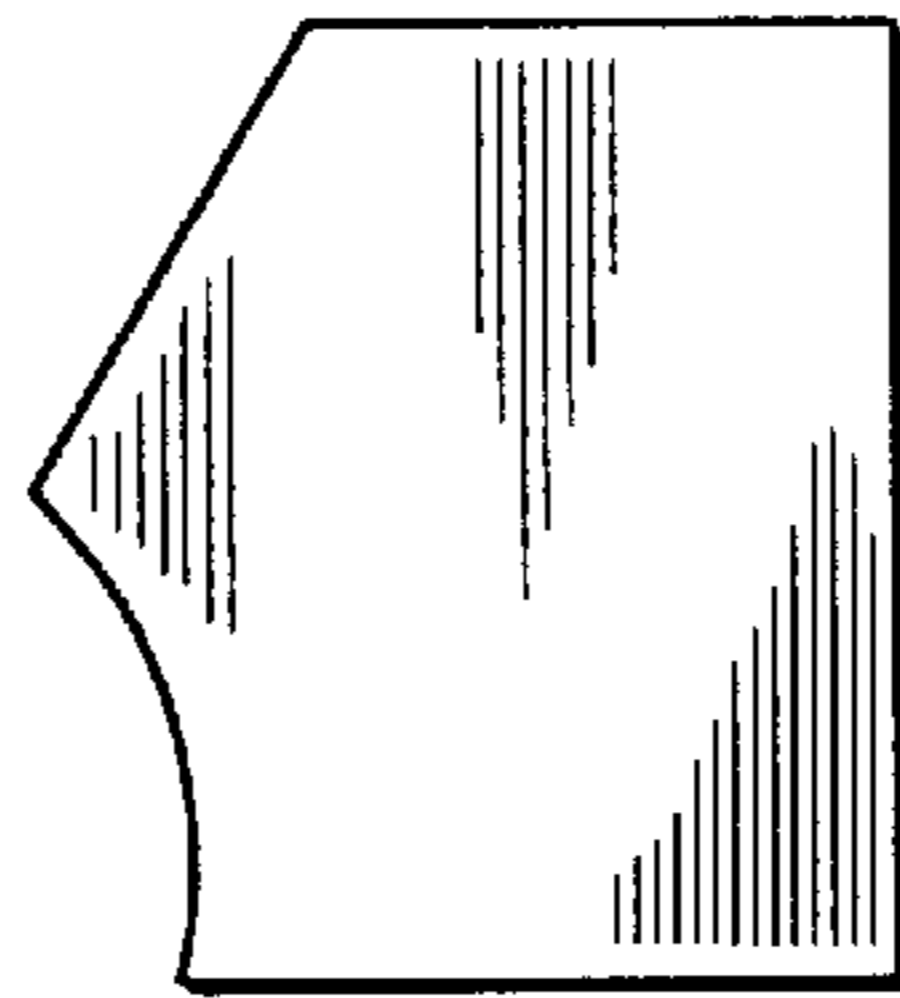

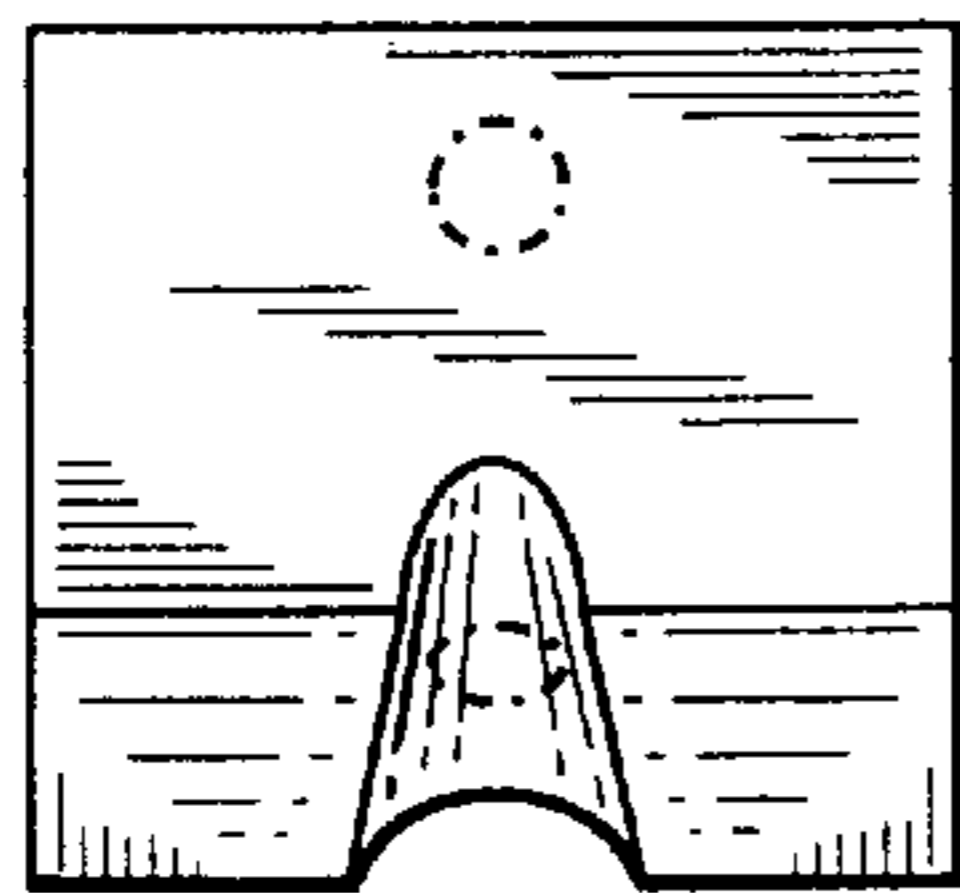

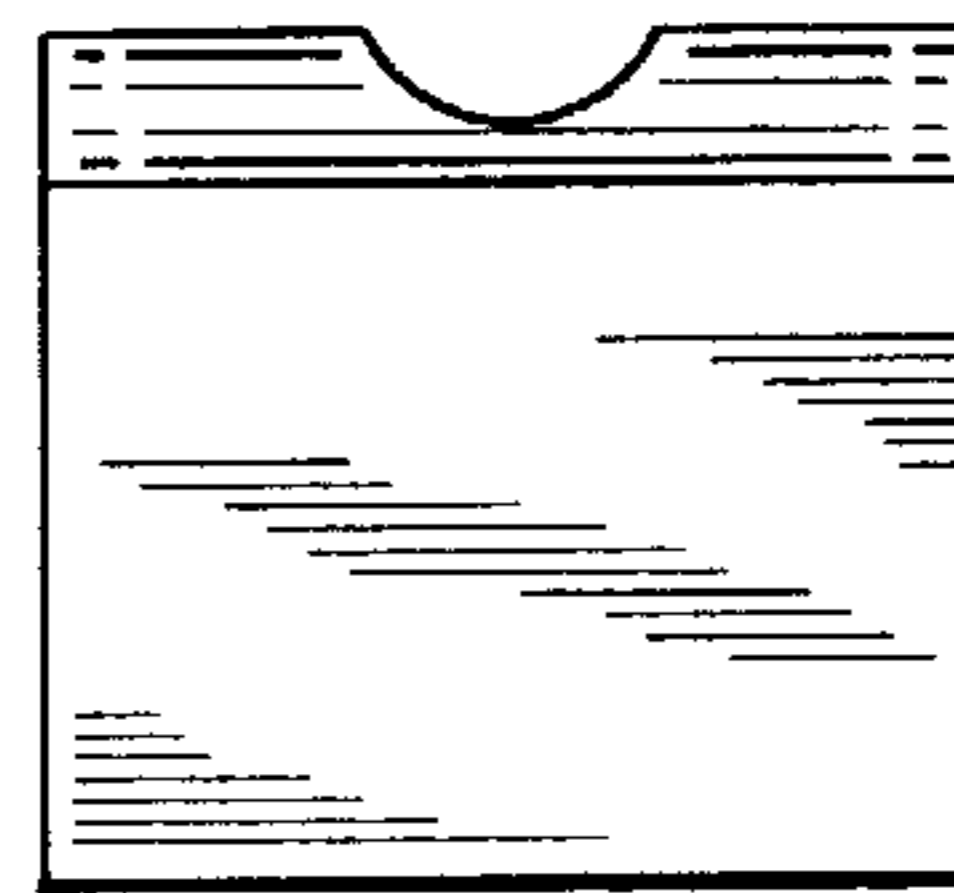

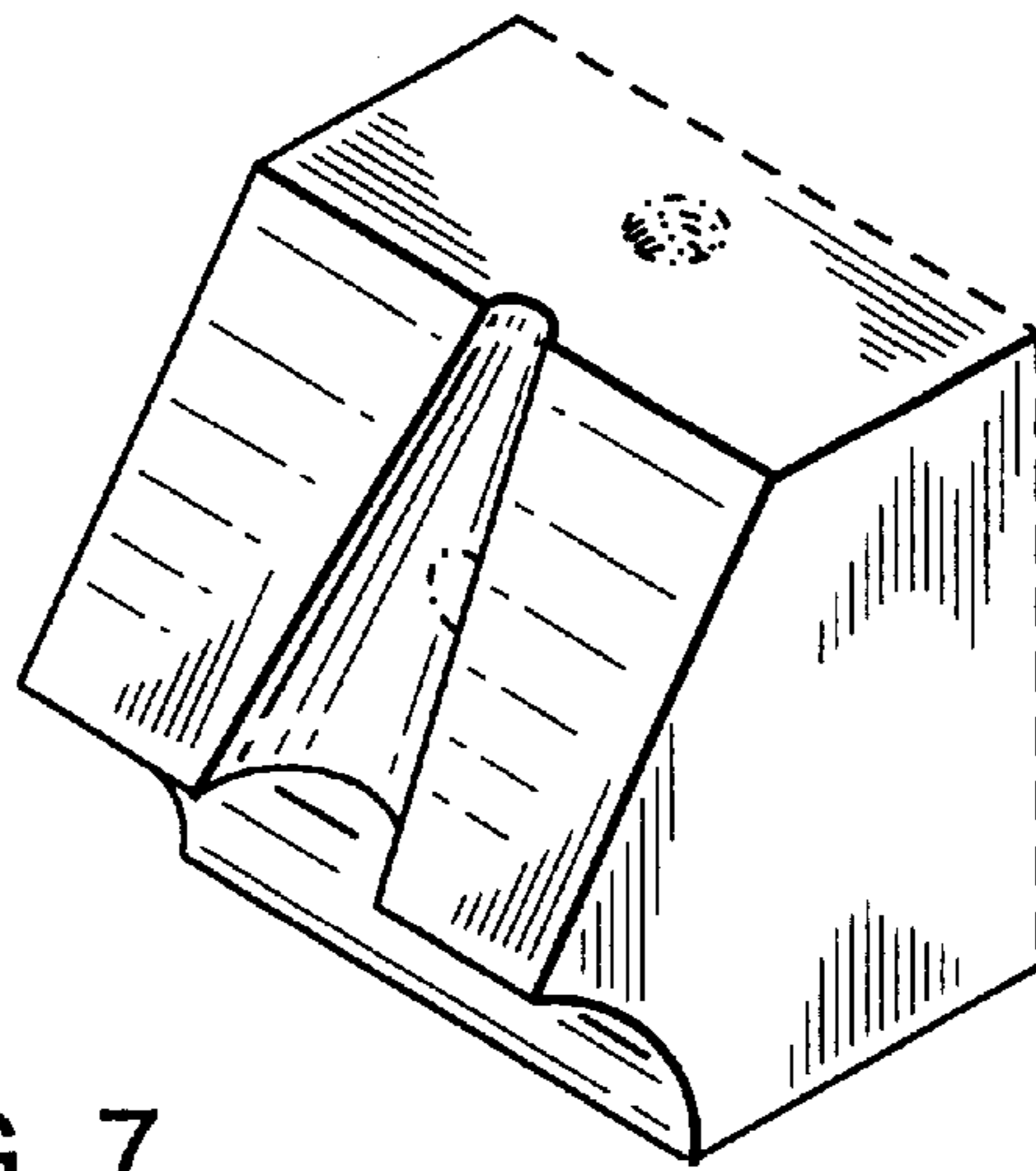

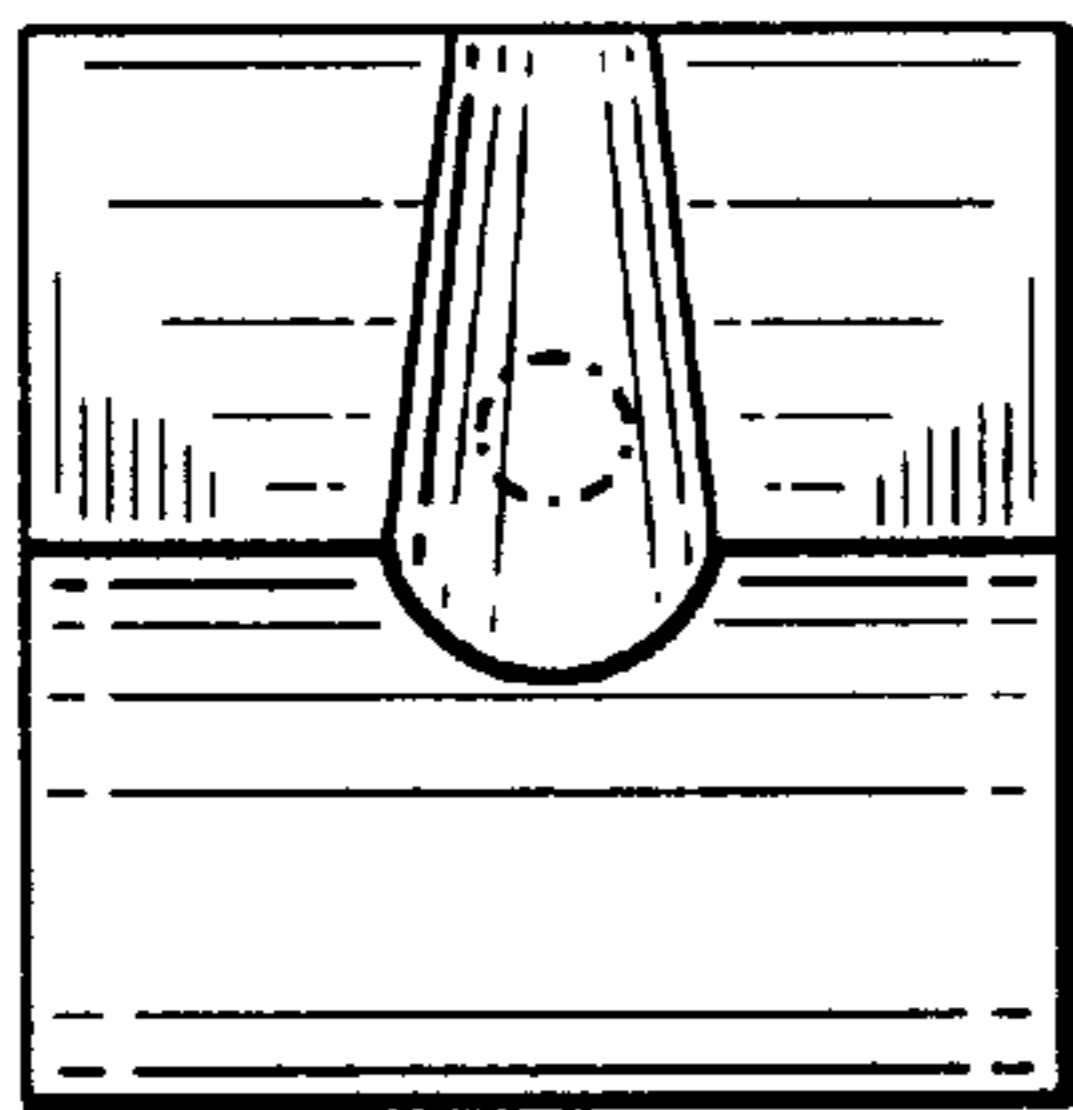

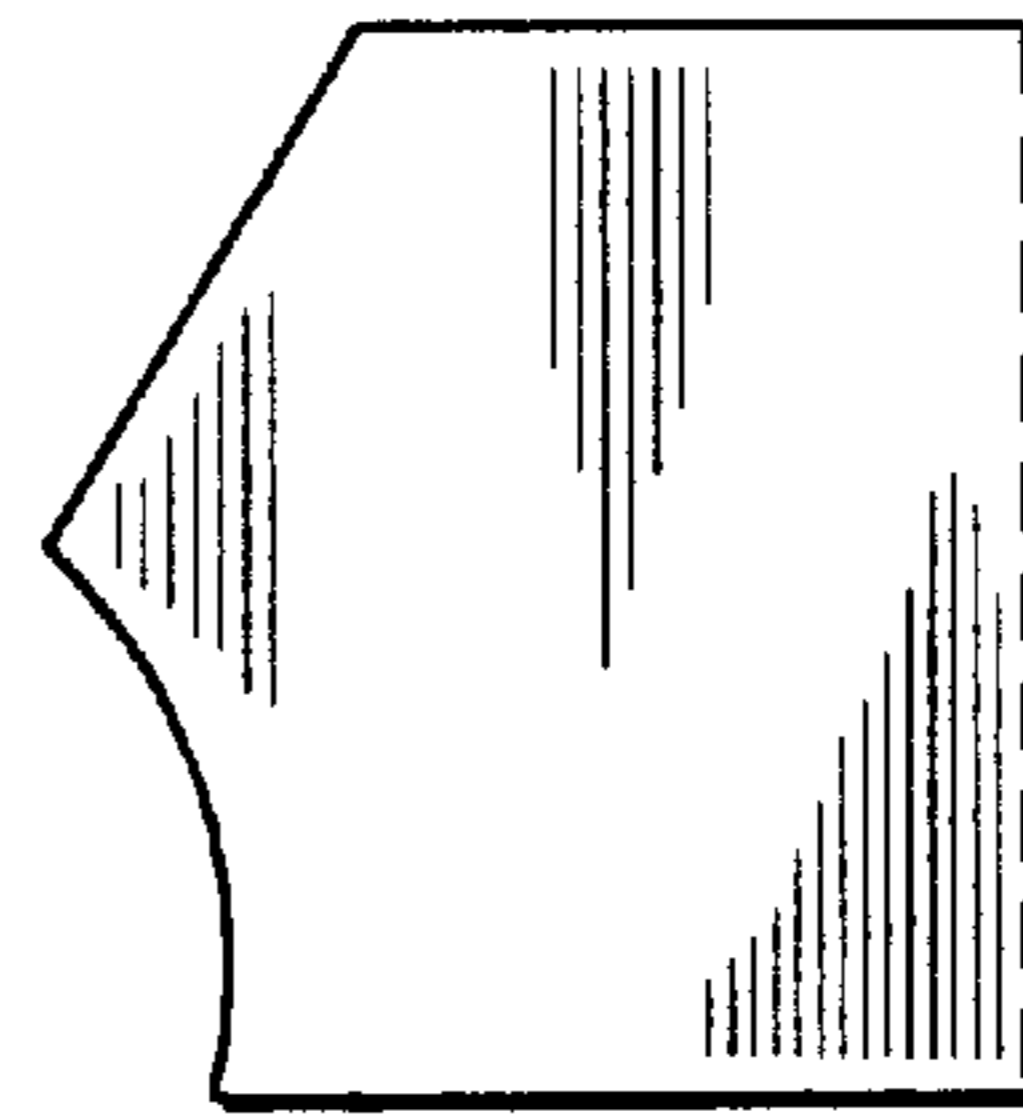

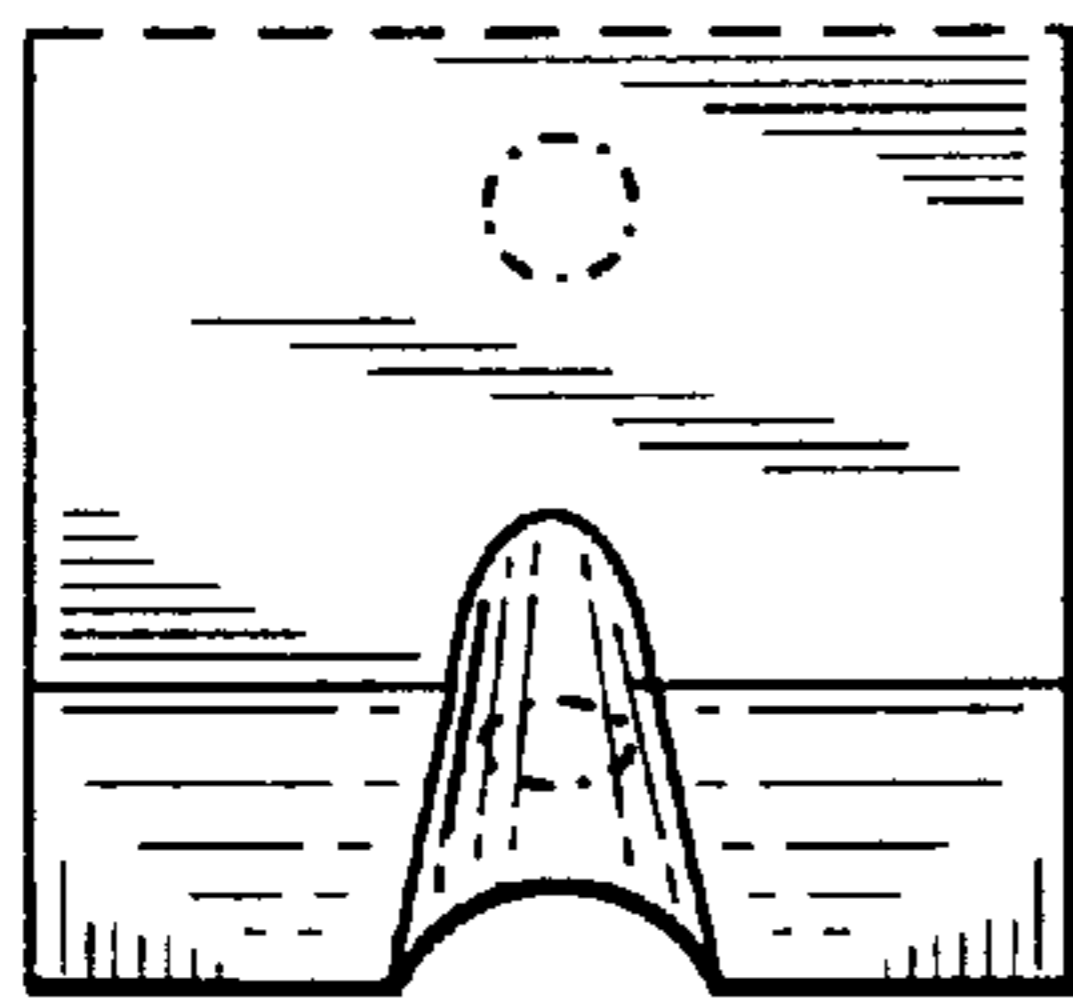

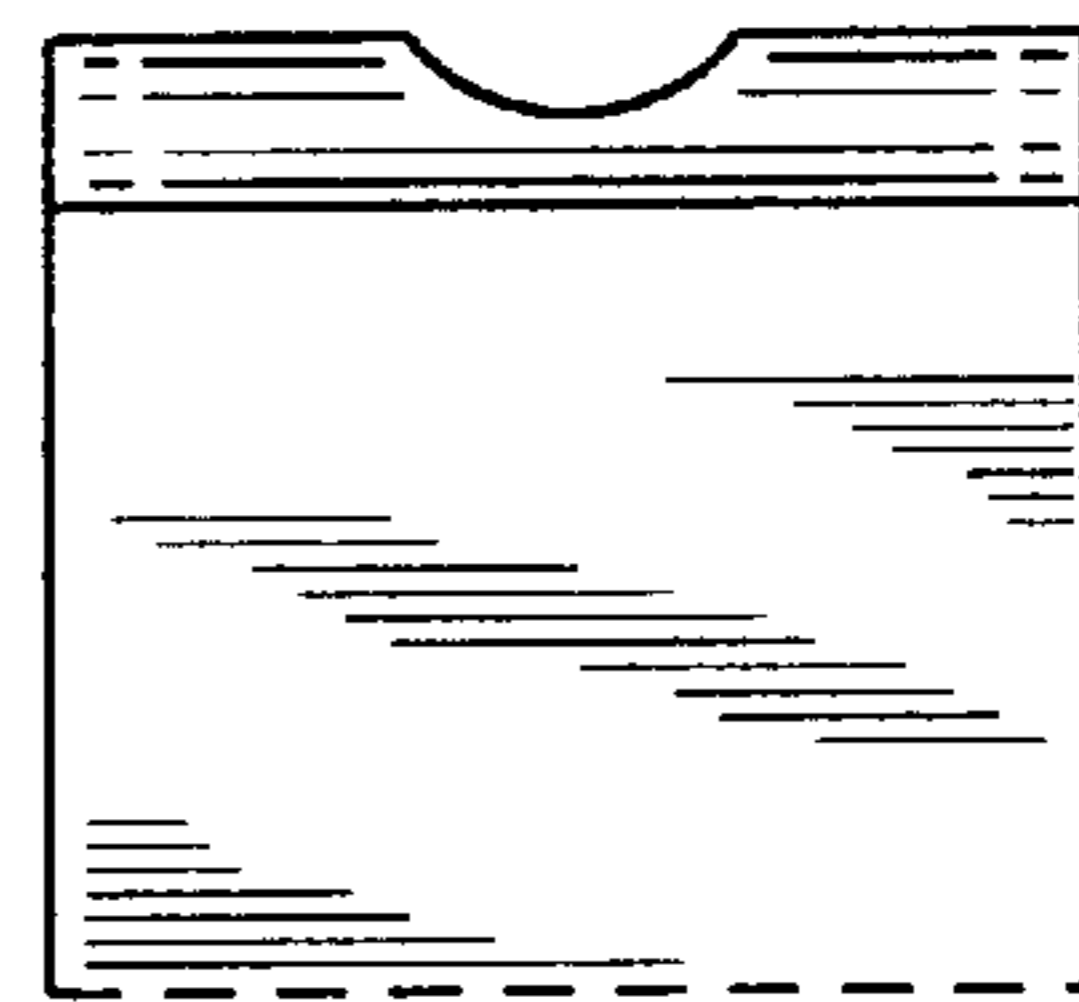
