**DESCRIPTION**

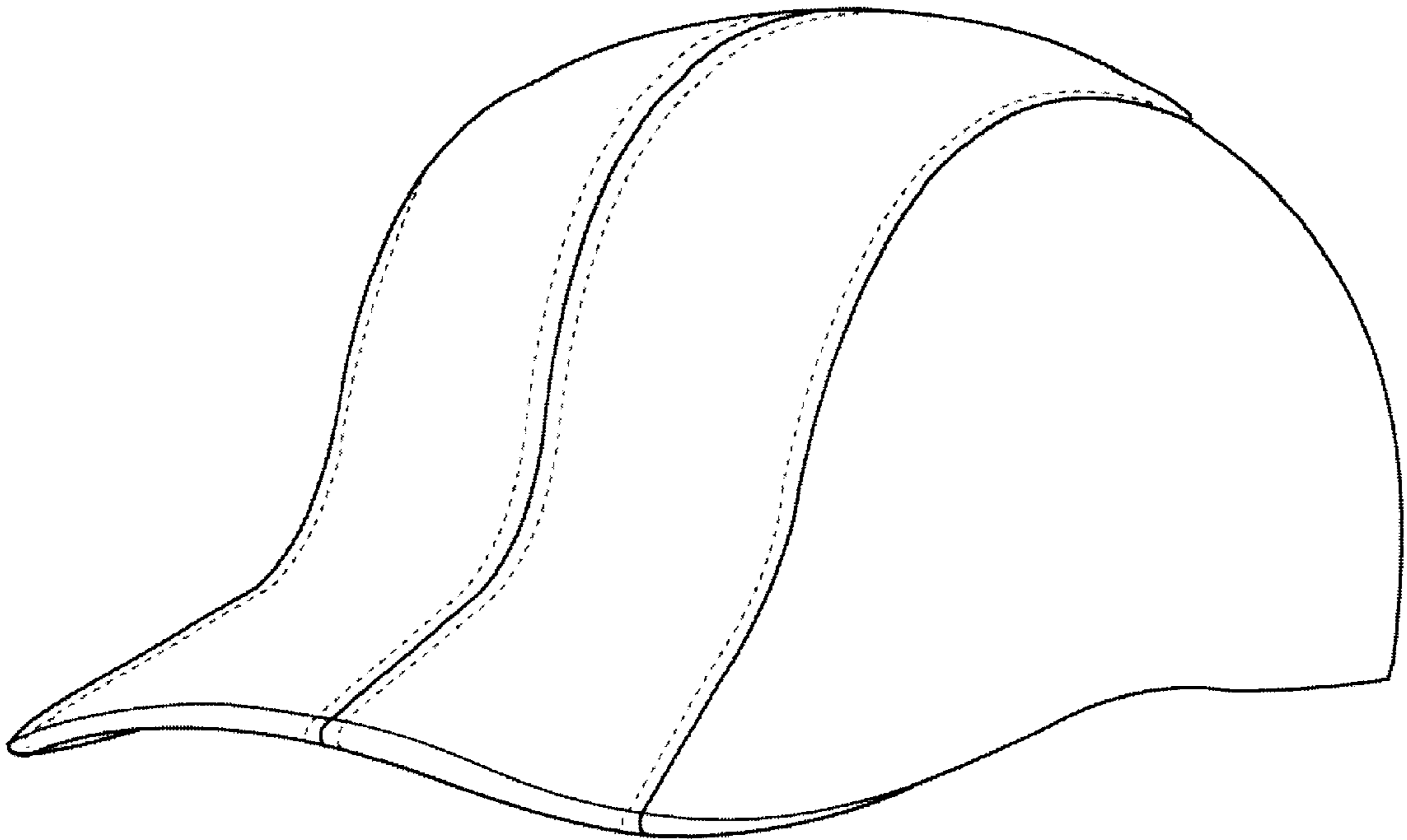

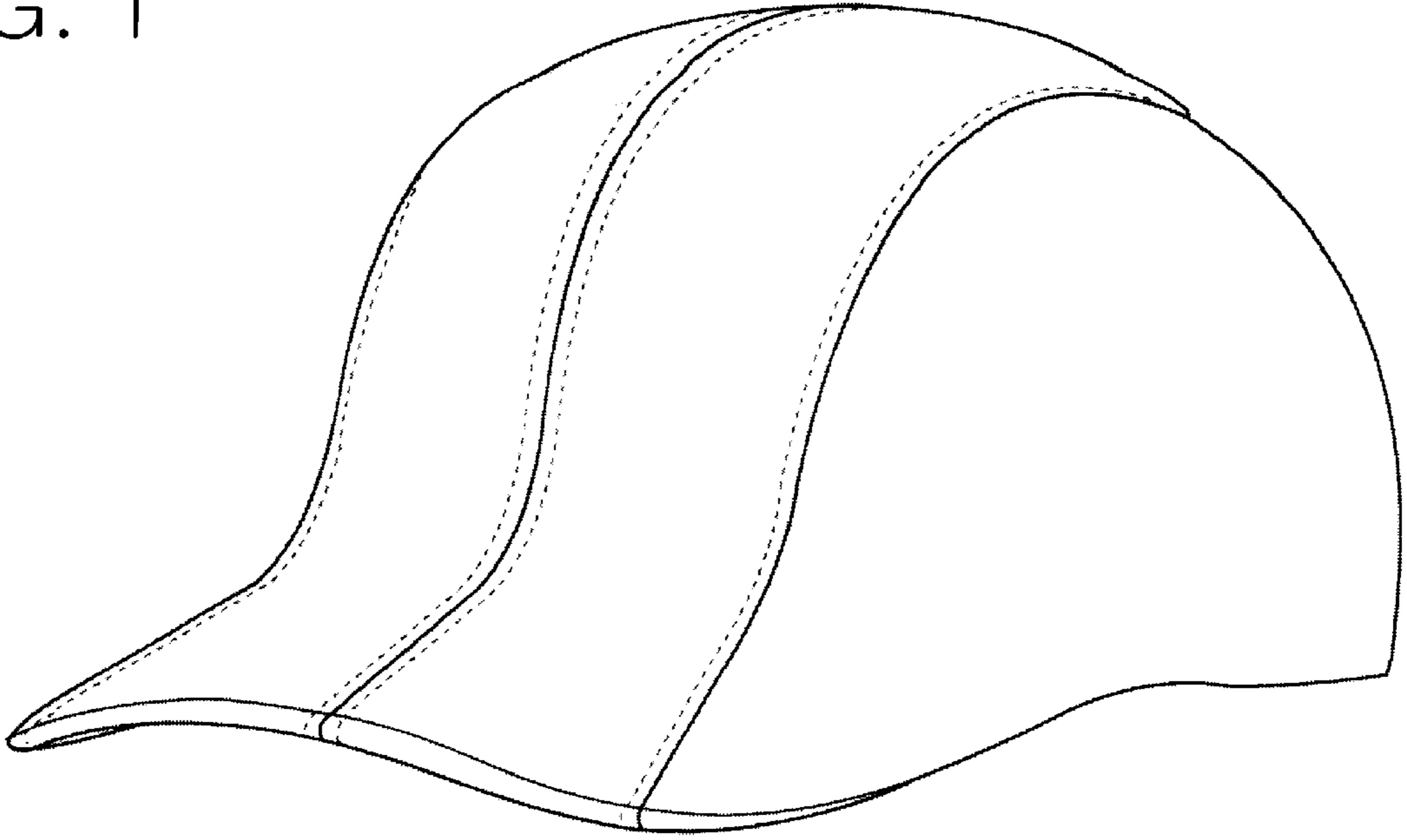

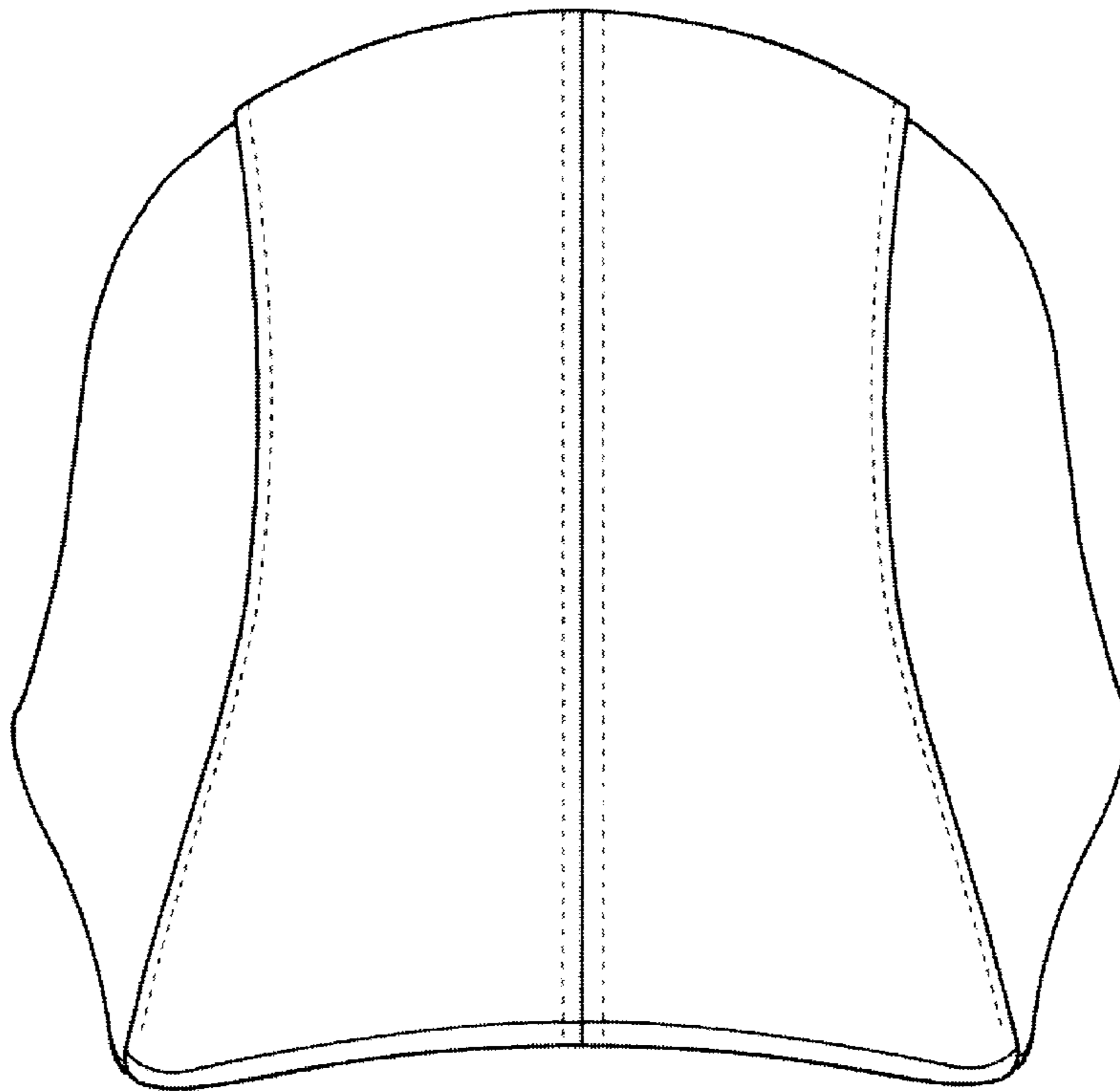

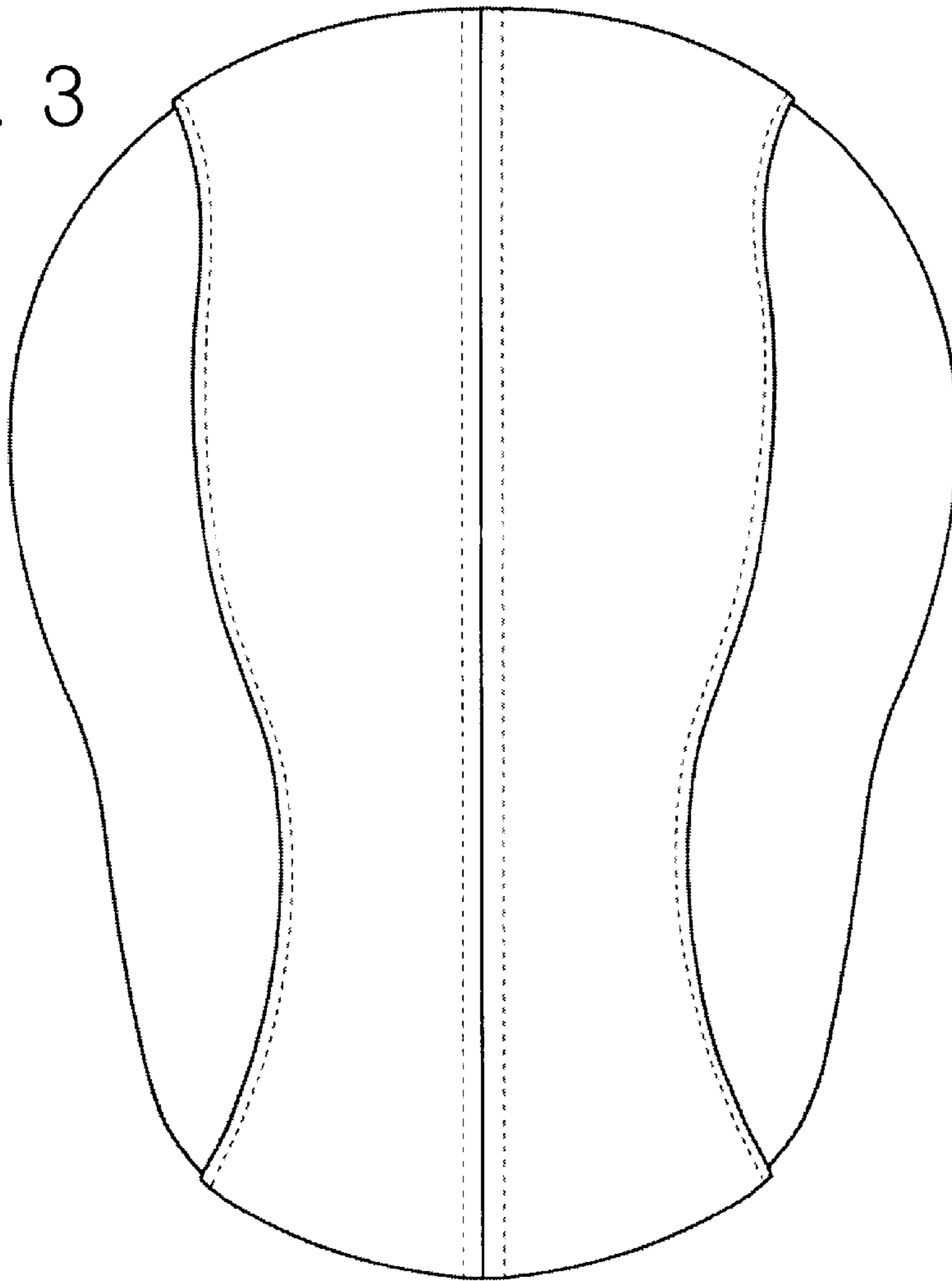

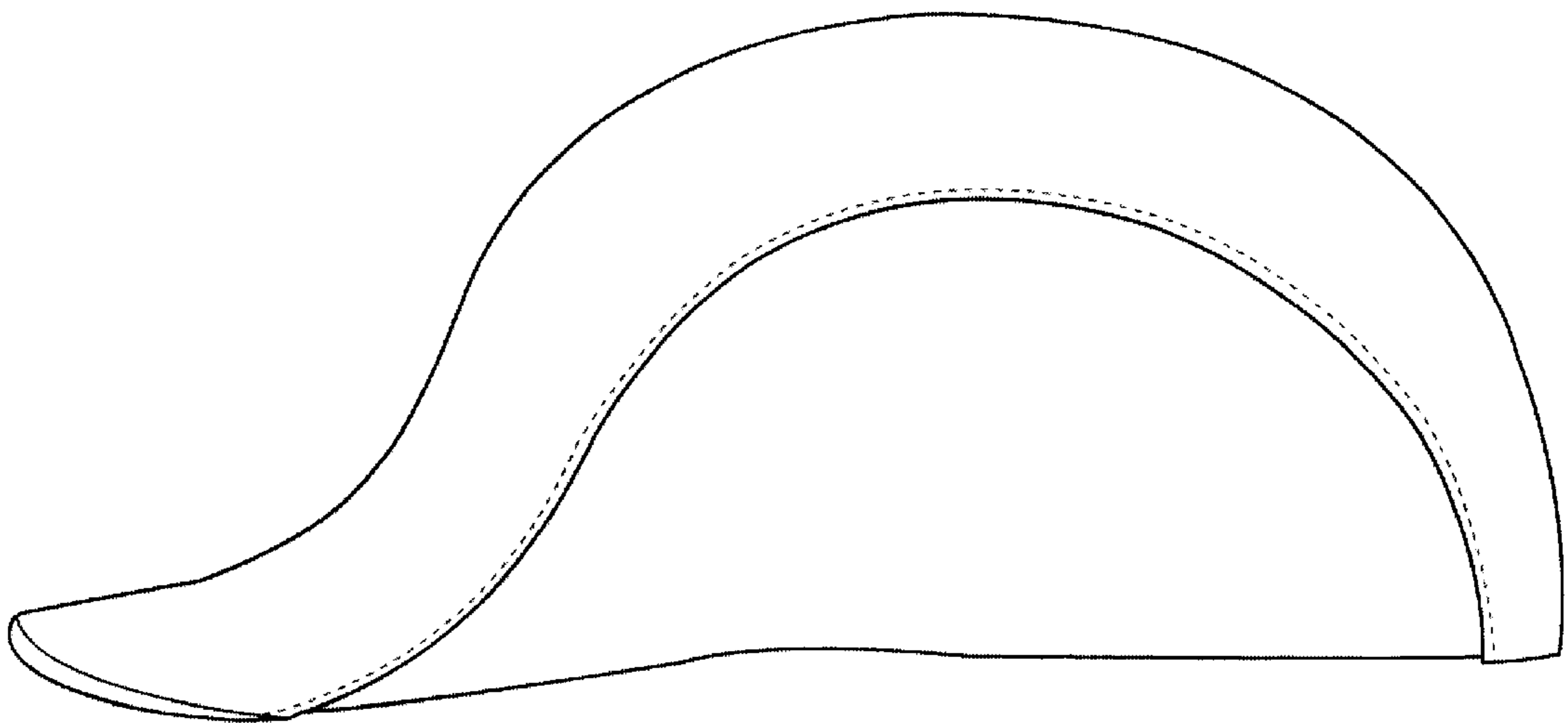

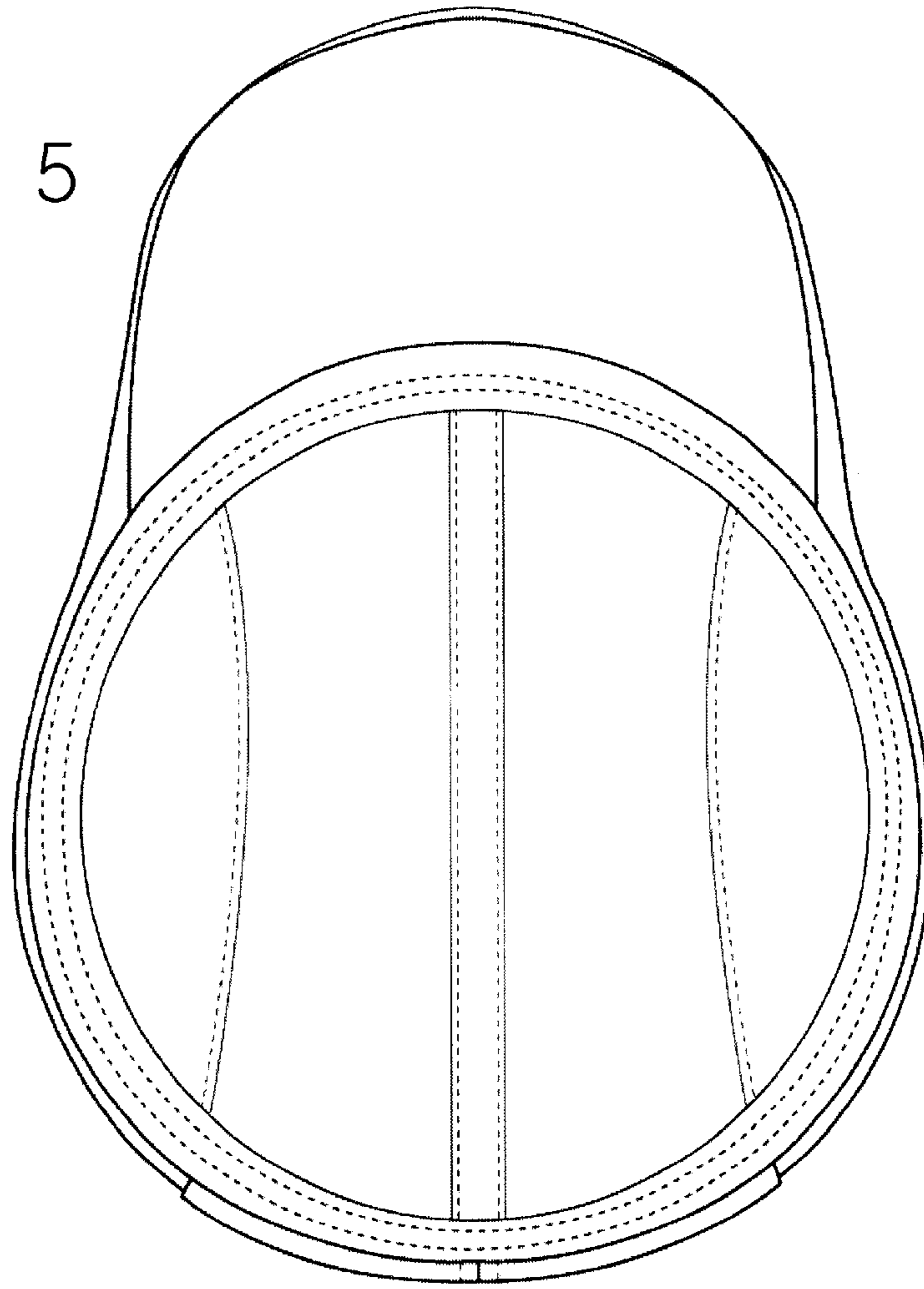
