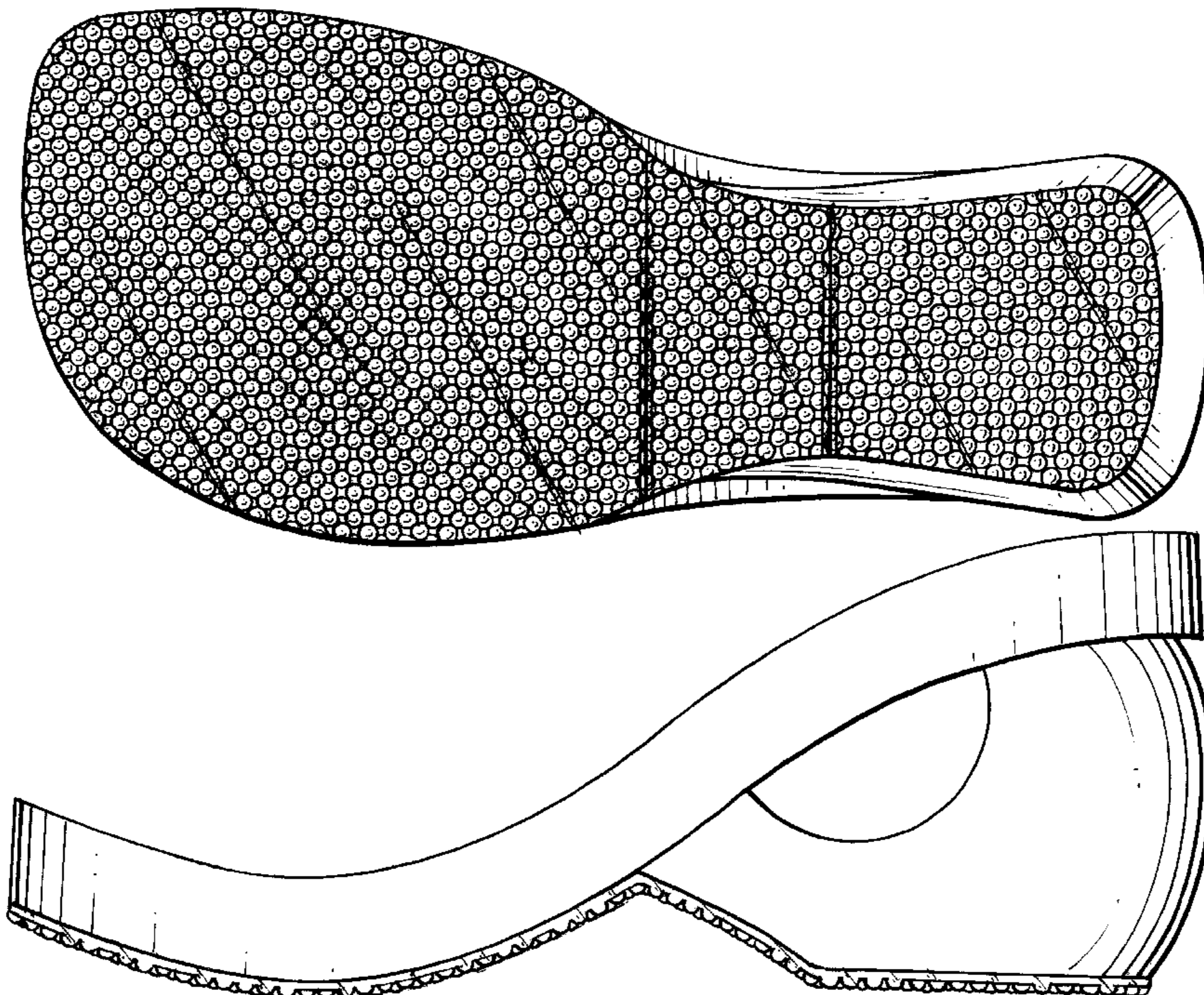

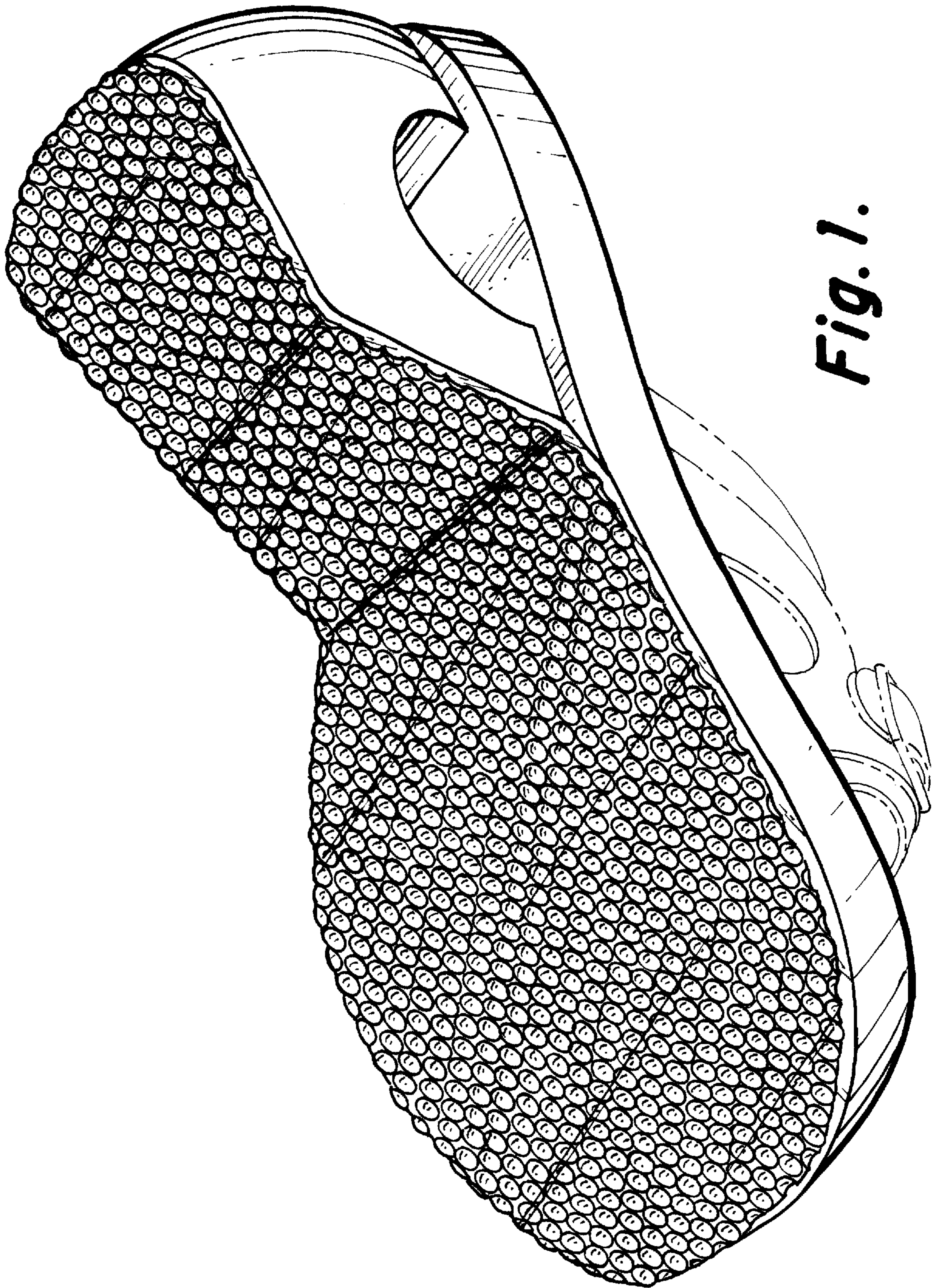

**DESCRIPTION**

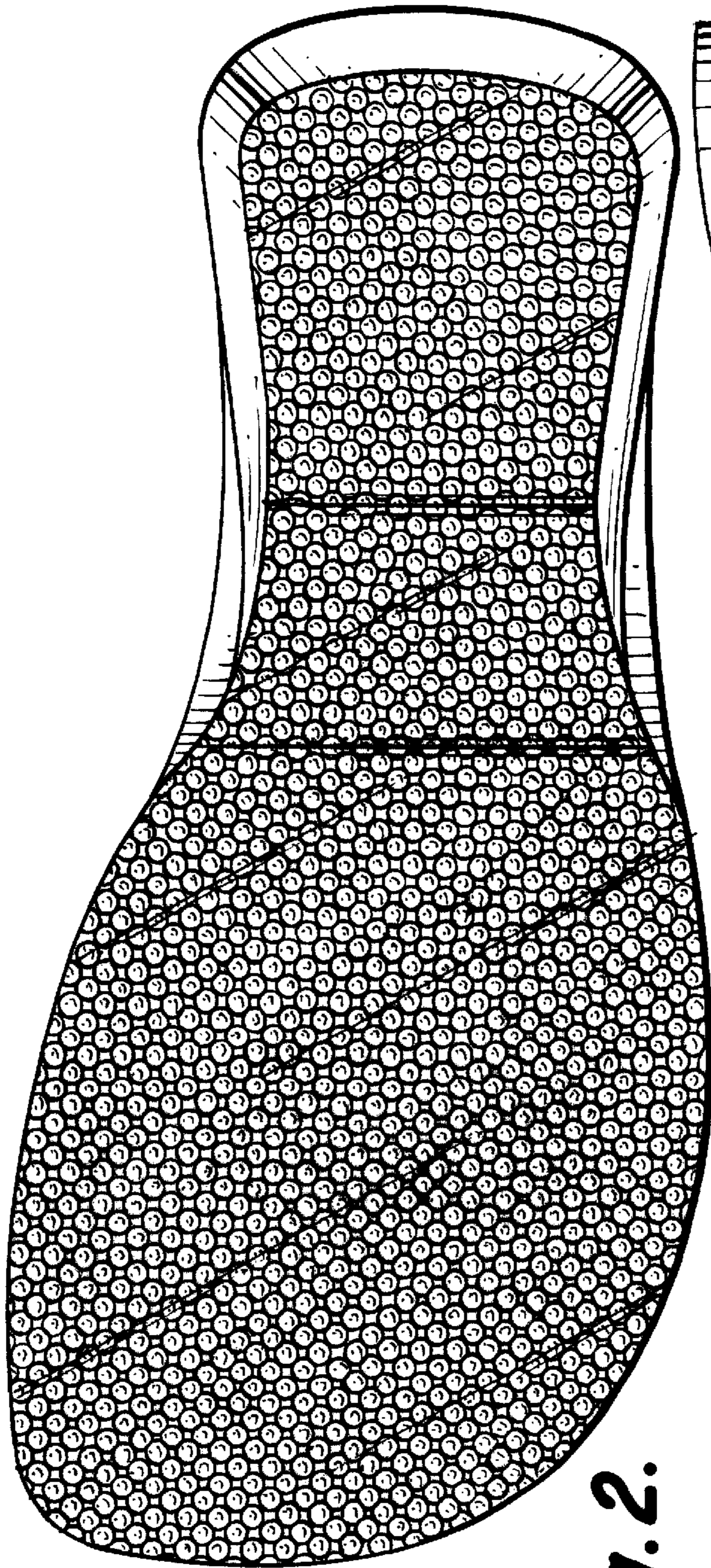
FIG. 1 is a perspective view of a shoe bottom showing my new design;

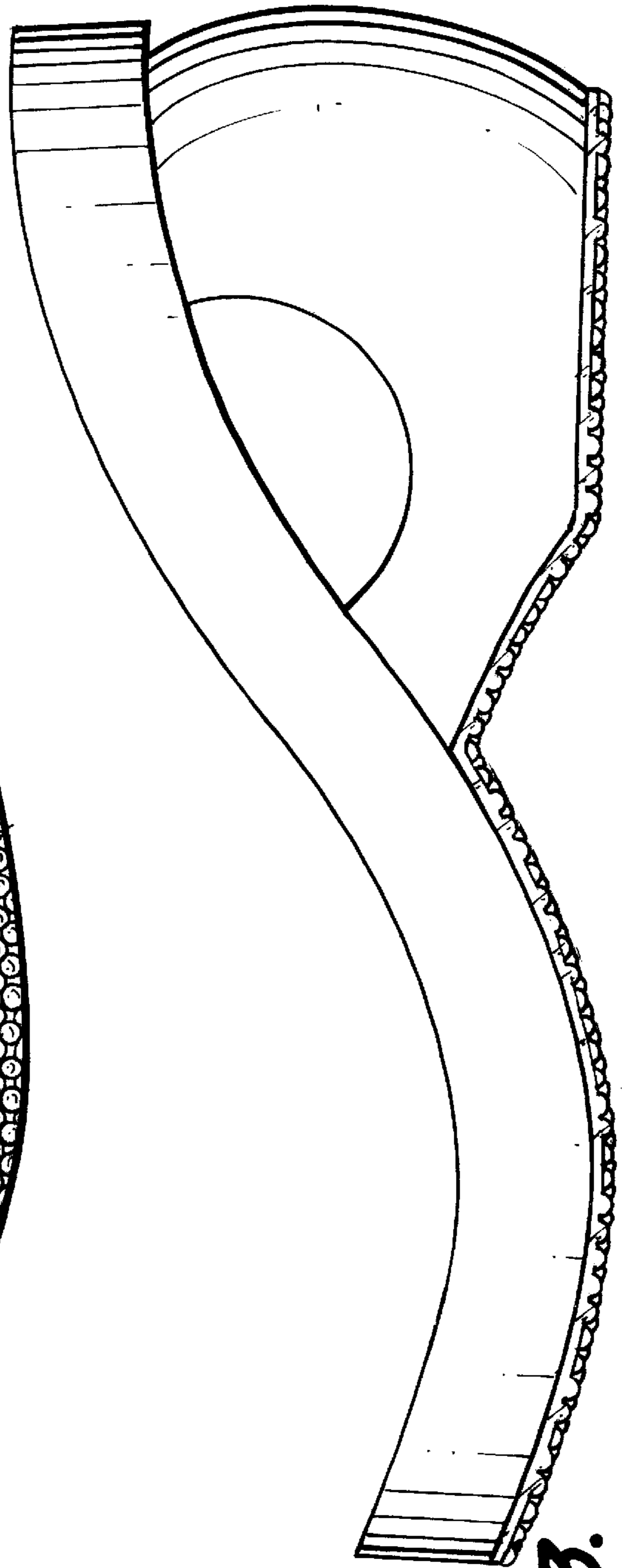




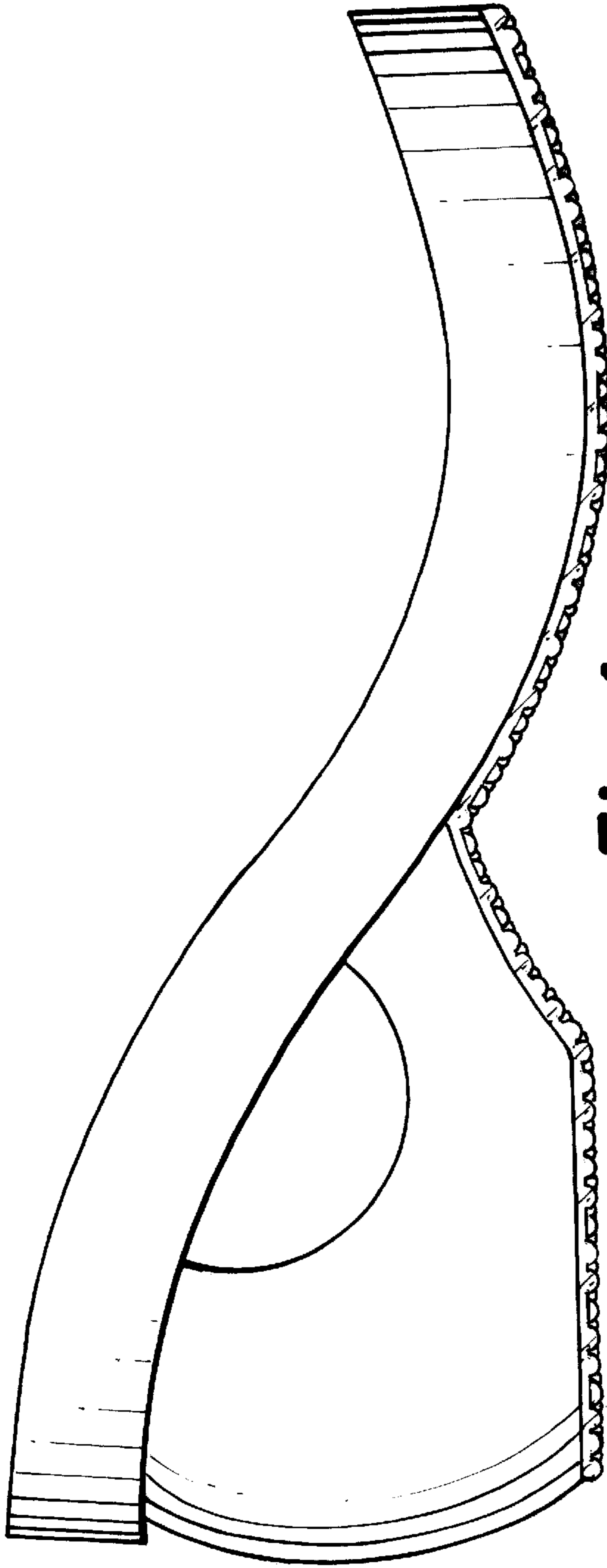

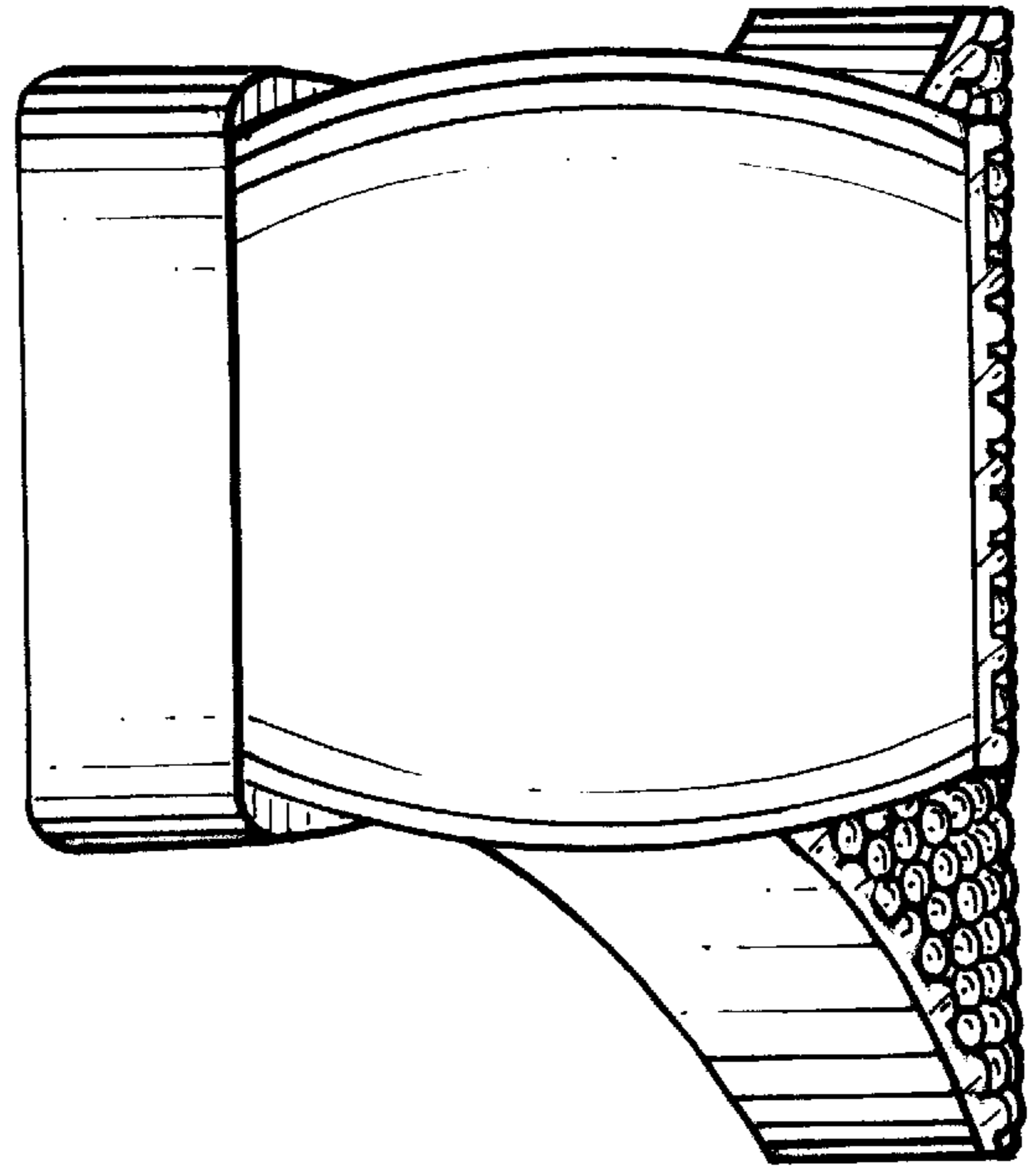

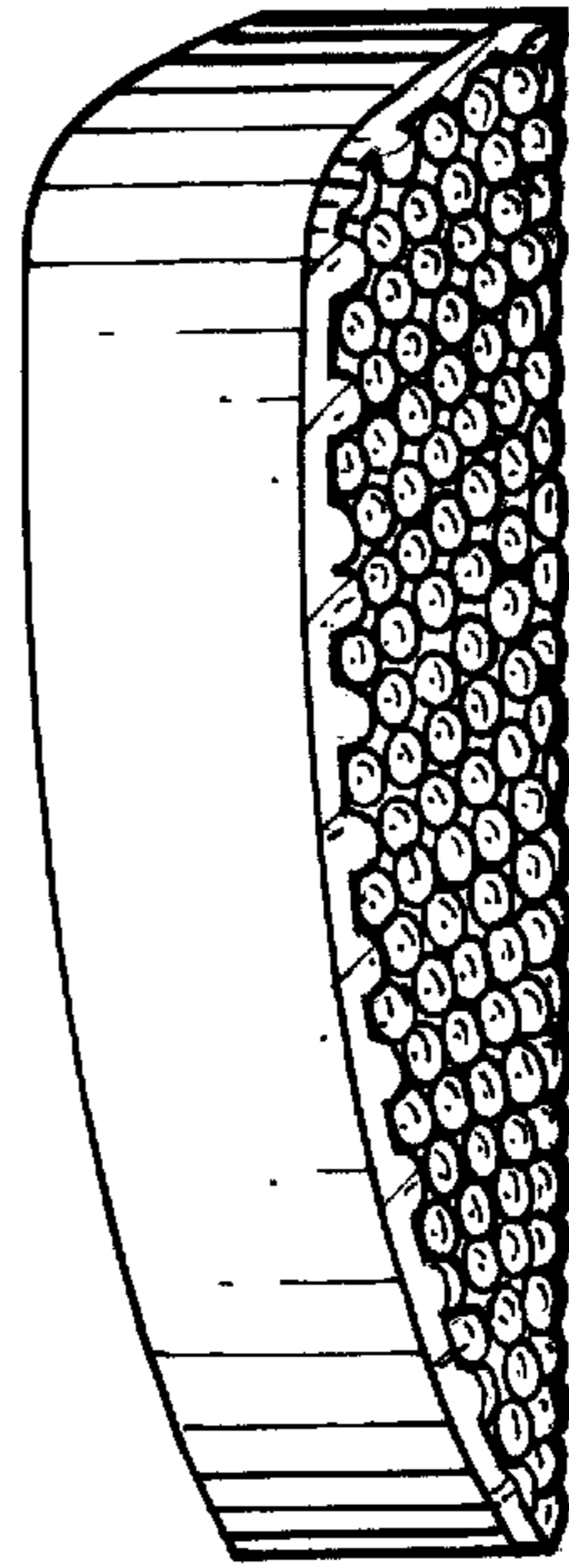
