DESCRIPTION

FIG. 1 is a front elevational view of a heart shape bag with extended petal arms in an unknotted state, the rear elevational view being a mirror image thereof;

FIG. 2 is a right side elevational view of the bag of FIG. 1 the left side elevational view being a mirror image thereof;

FIG. 3 is the bottom perspective view of the bag of FIG. 1 in an unknotted state;

FIG. 4 is the top perspective view of the bag of FIG. 1 in an unknotted state;

FIG. 5 is the bottom plan view of the bag of FIG. 1

FIG. 6 is the front elevational view of FIG. 1 in a knotted state, the rear elevational view being a mirror image thereof;

FIG. 7 is the right side elevational view of the bag of FIG. 1 in a knotted state, the left elevational view being a mirror image thereof;

FIG. 8 is a right side elevational view of a heart shape bag with extended petal arms in an embodiment now showing the bag without a gusset. The front and rear elevational views of this embodiment are the same as in FIG. 1 and FIG. 6; and,

FIG. 9 is a bottom plan view of the bag of FIG. 8.

Any broken lines are to show the environment only and are not part of the claim design.

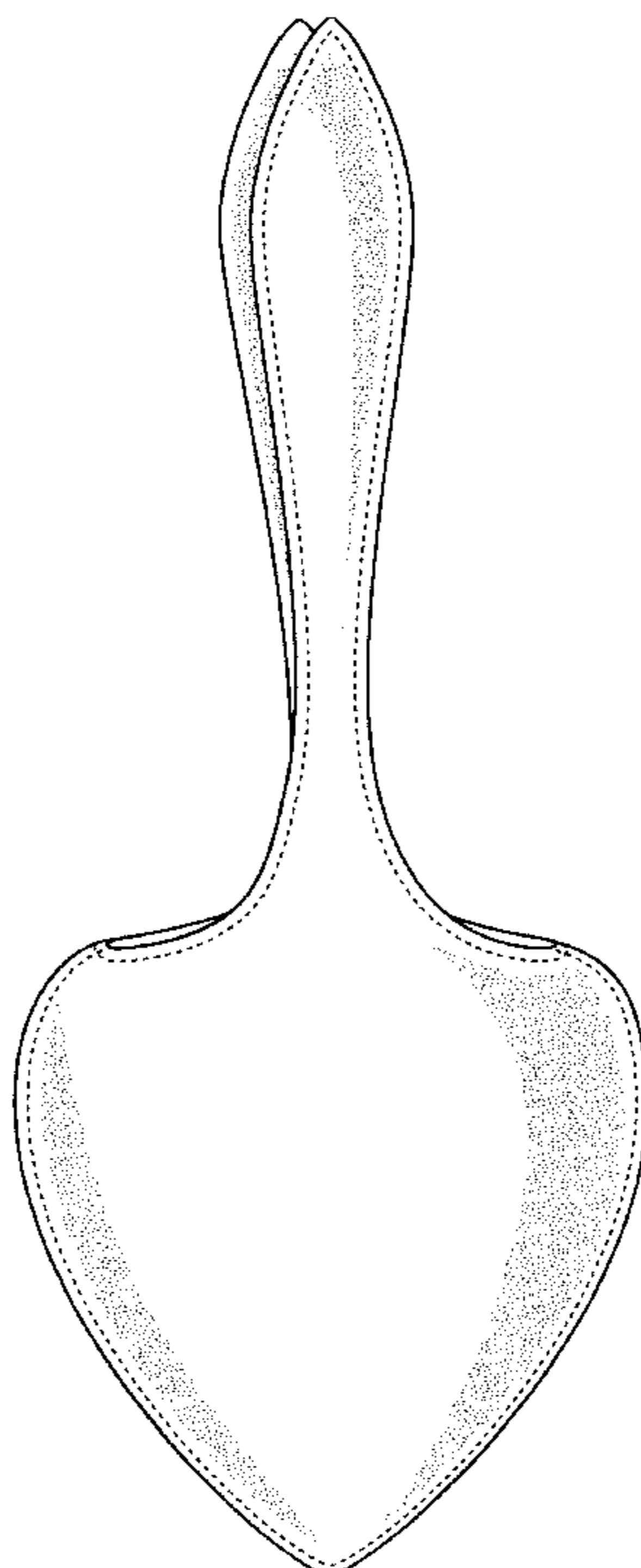

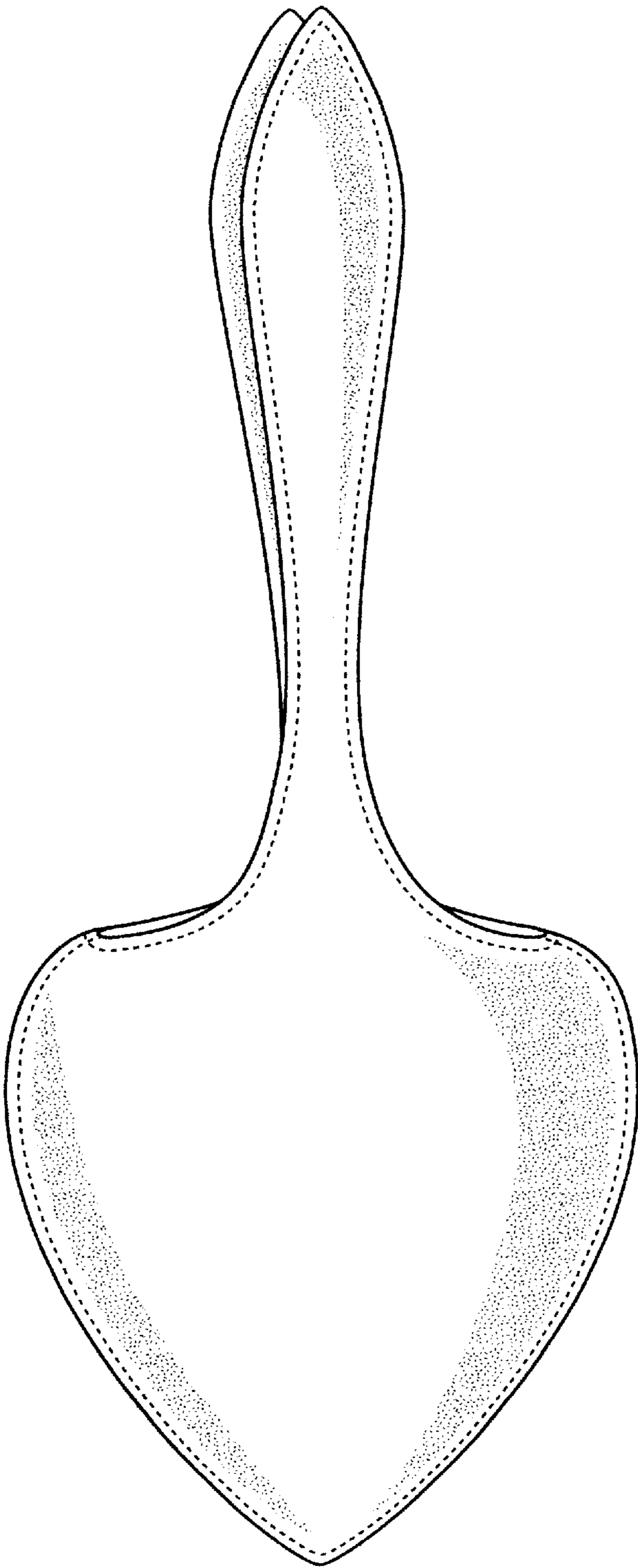

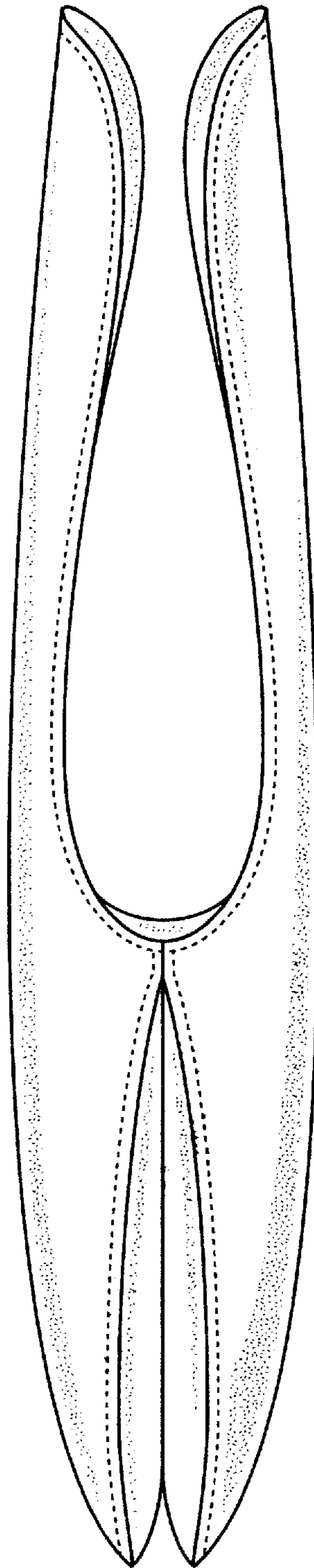

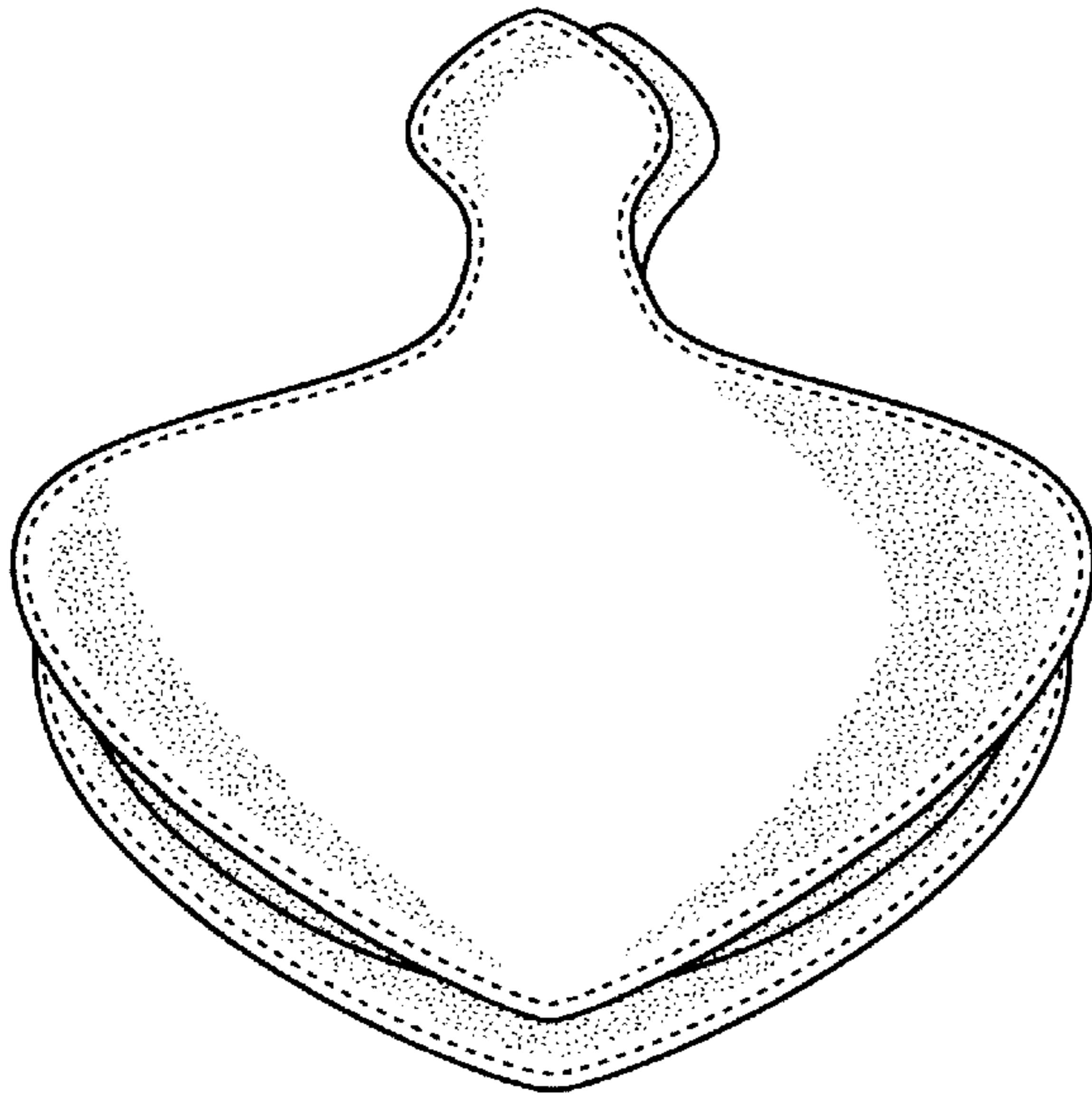

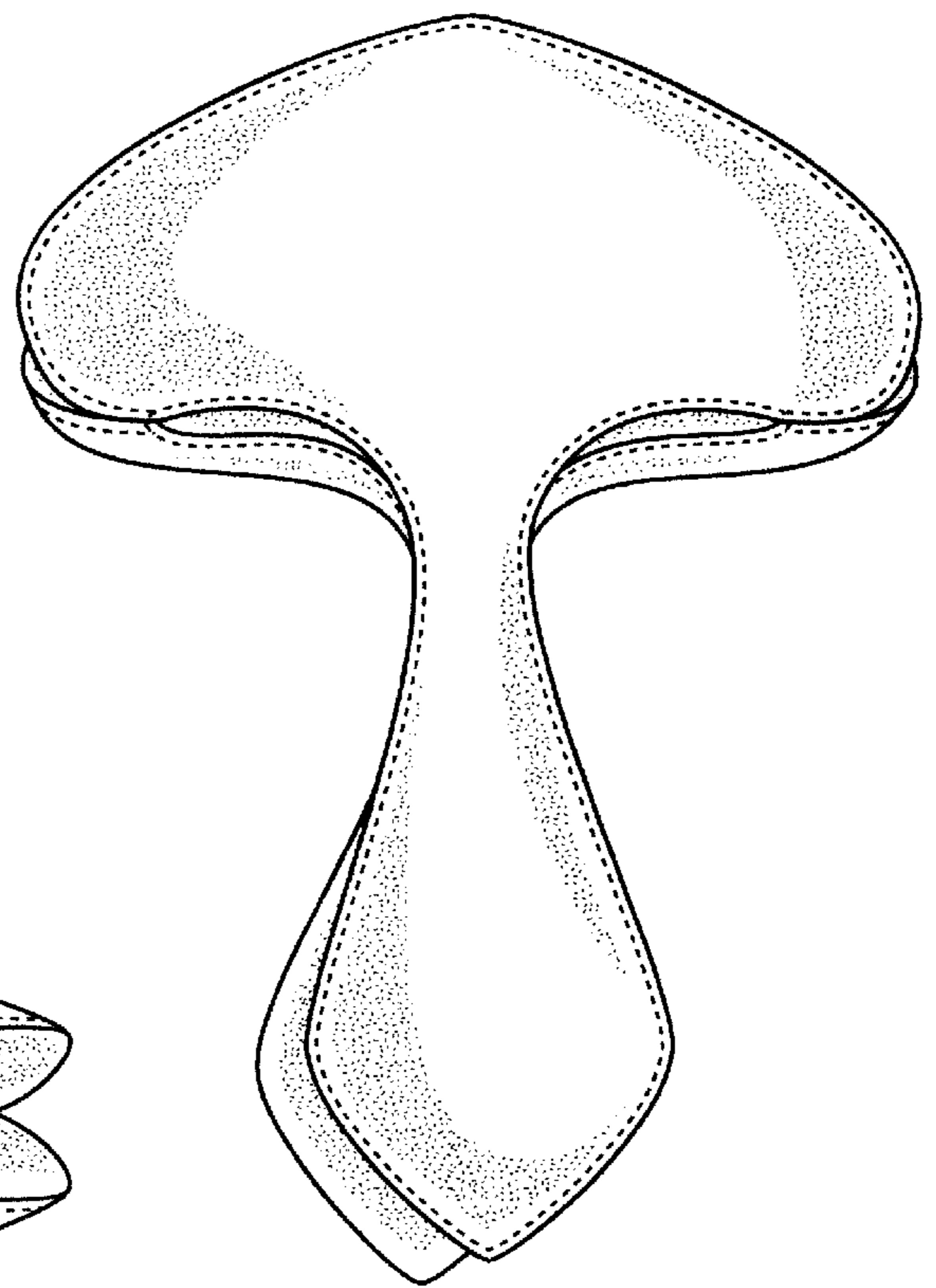

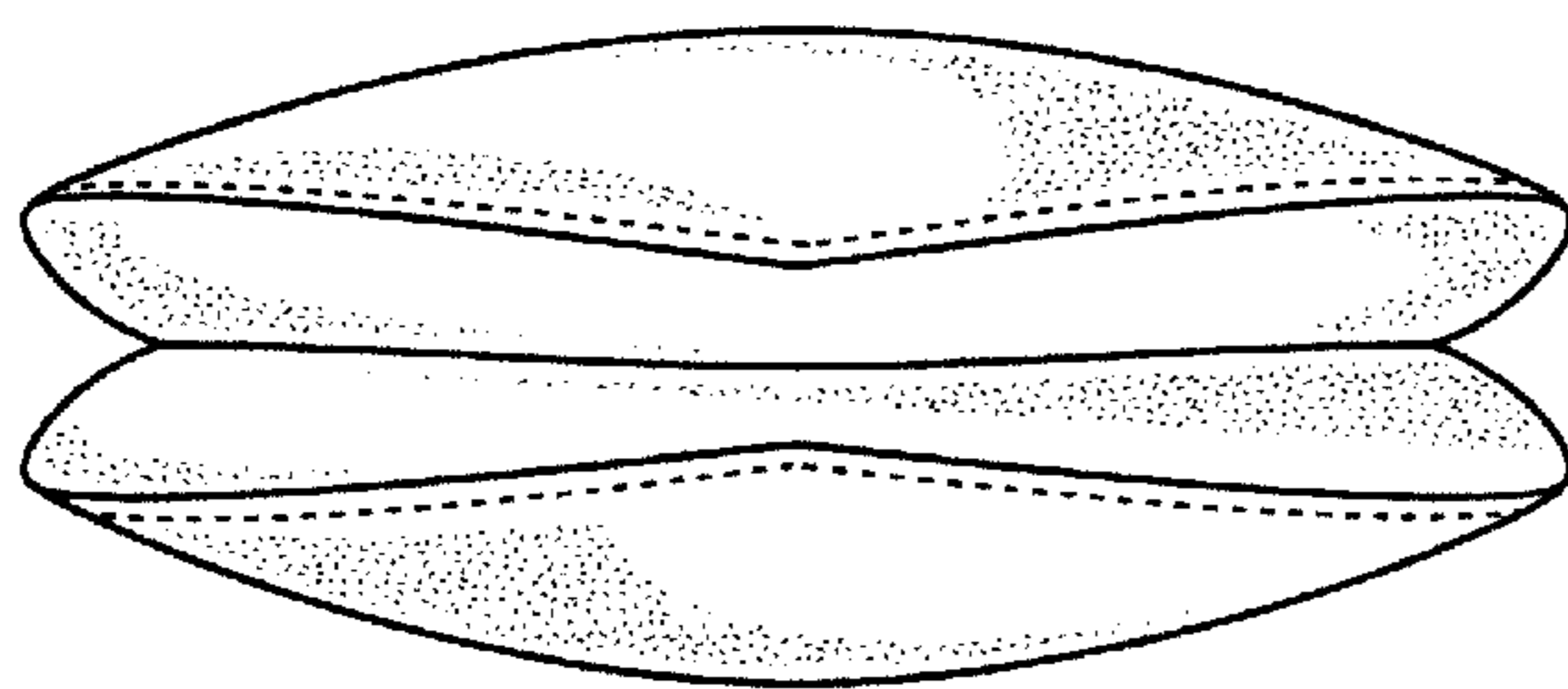

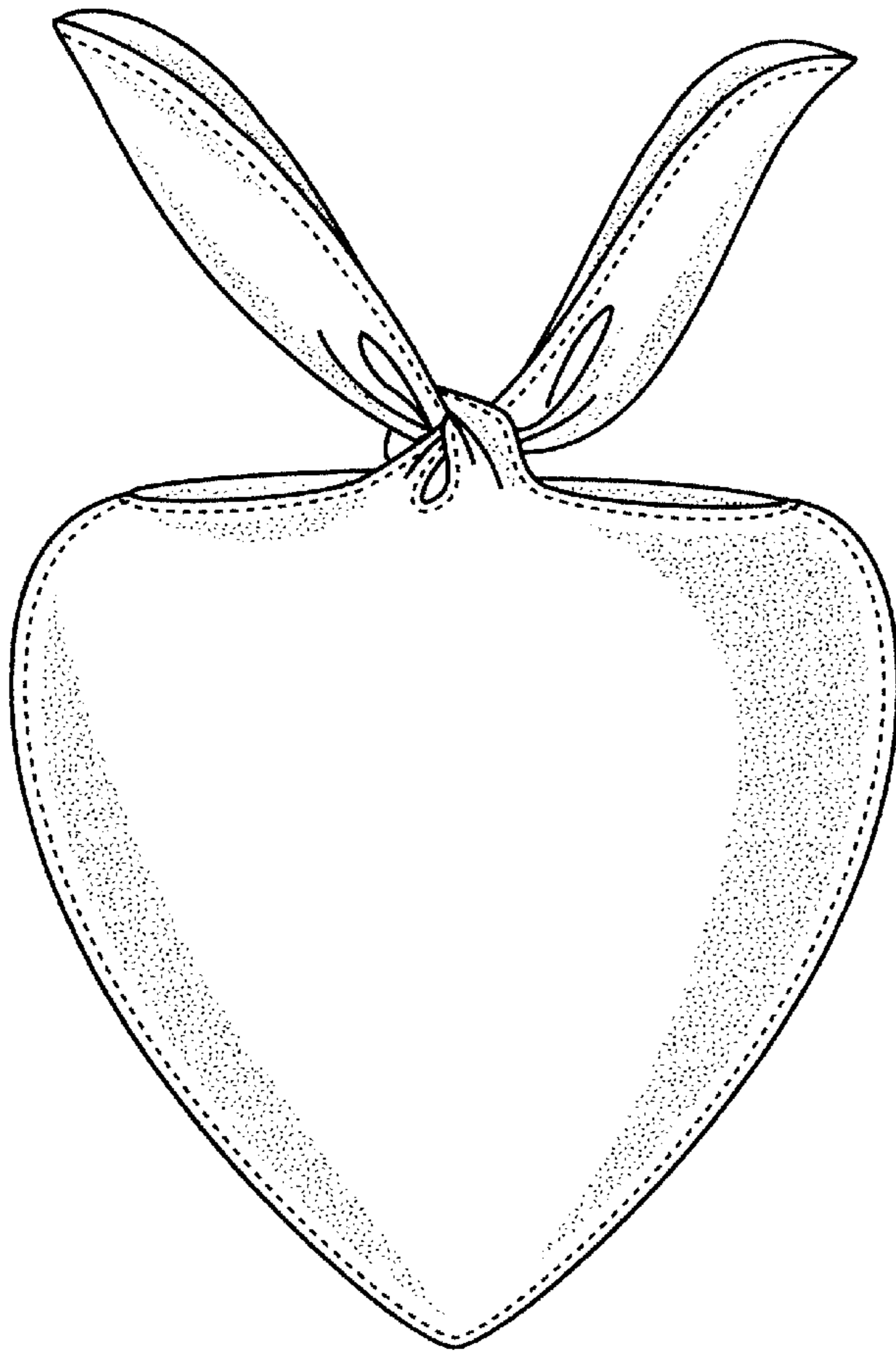

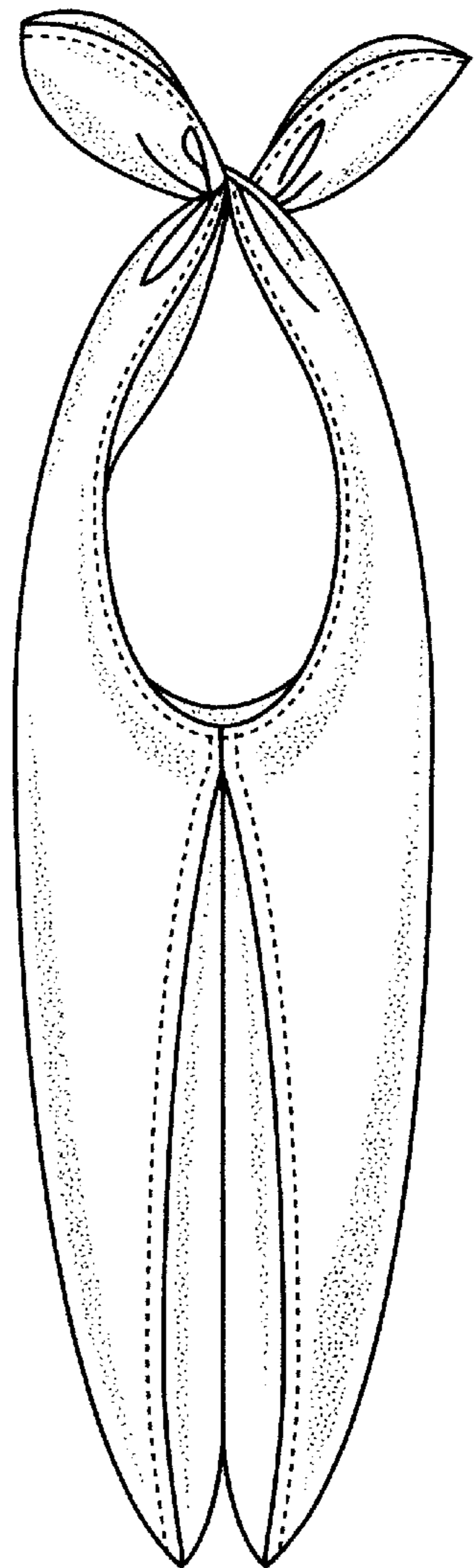

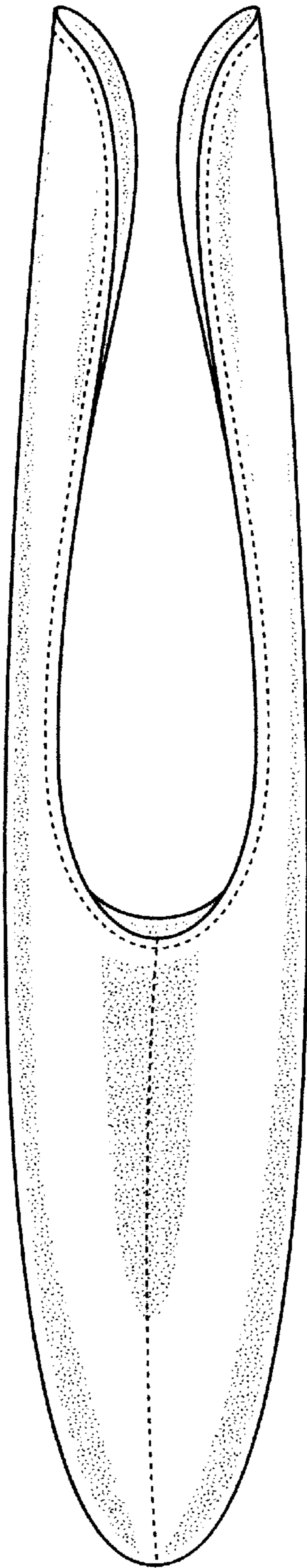

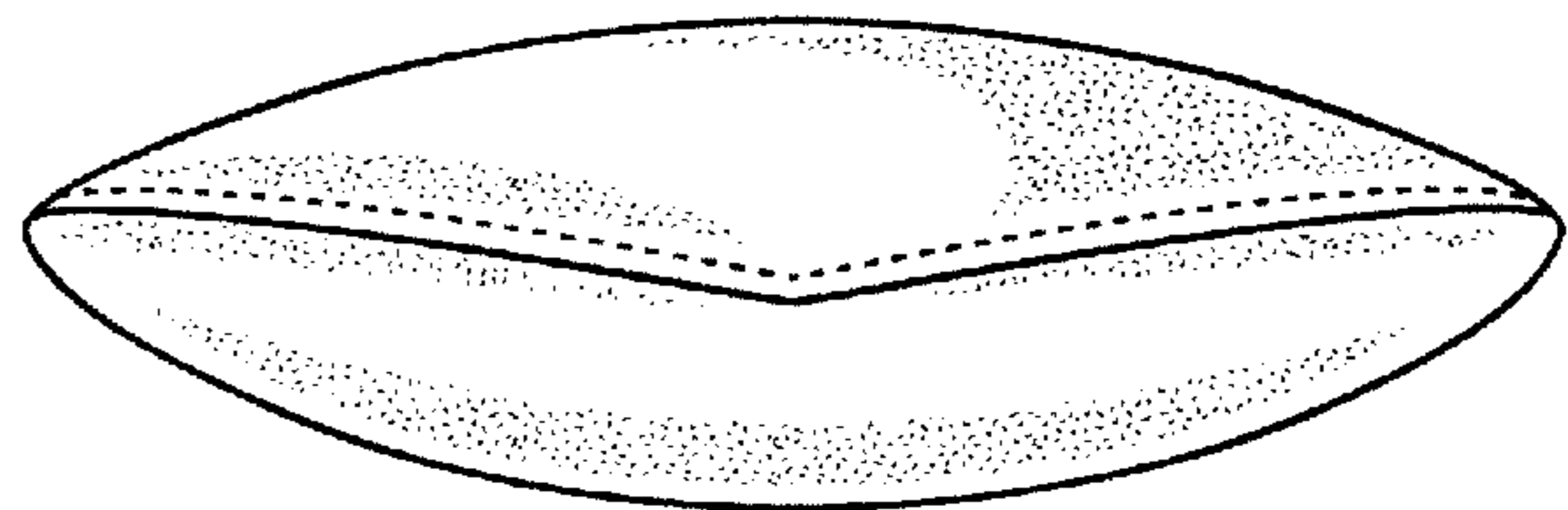
