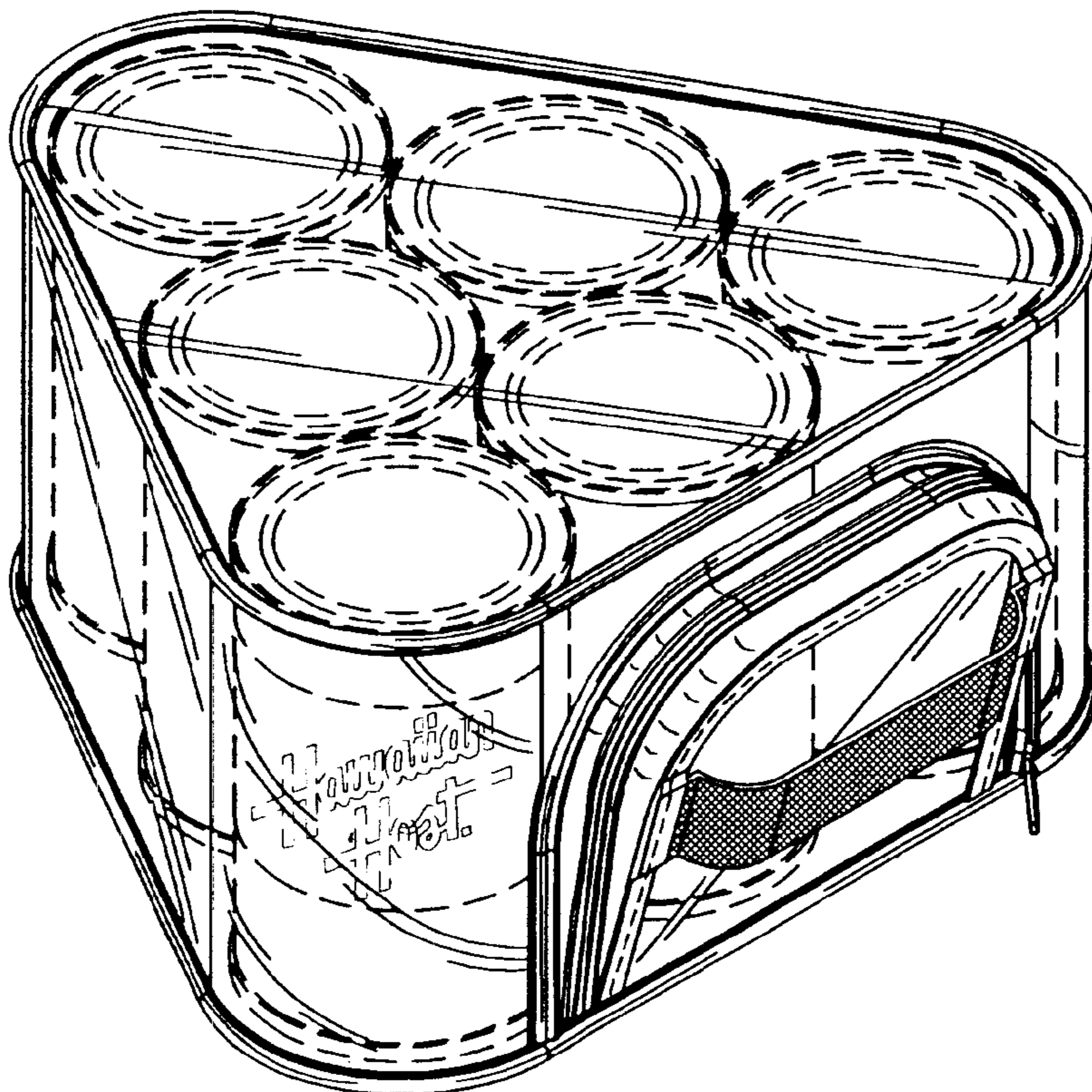
(57) **CLAIM**

I claim the ornamental design for a transparent carrying case for cans, as shown and described.

**DESCRIPTION**

FIG. 1 is a right front perspective view of the transparent carrying case for cans of the present invention; FIG. 2 is a left front perspective view of the transparent carrying case for cans of the present invention; FIG. 3 is a top plan view thereof; FIG. 4 is a bottom plan view thereof; FIG. 5 is a first side elevational view; FIG. 6 is a second side elevational view; FIG. 7 is a third side plan view; and, FIG. 8 is a plan view showing the first and second sides. The broken lines showing the cans and illustrations and text on the cans are for illustrative purposes only and form no part of the claimed design.

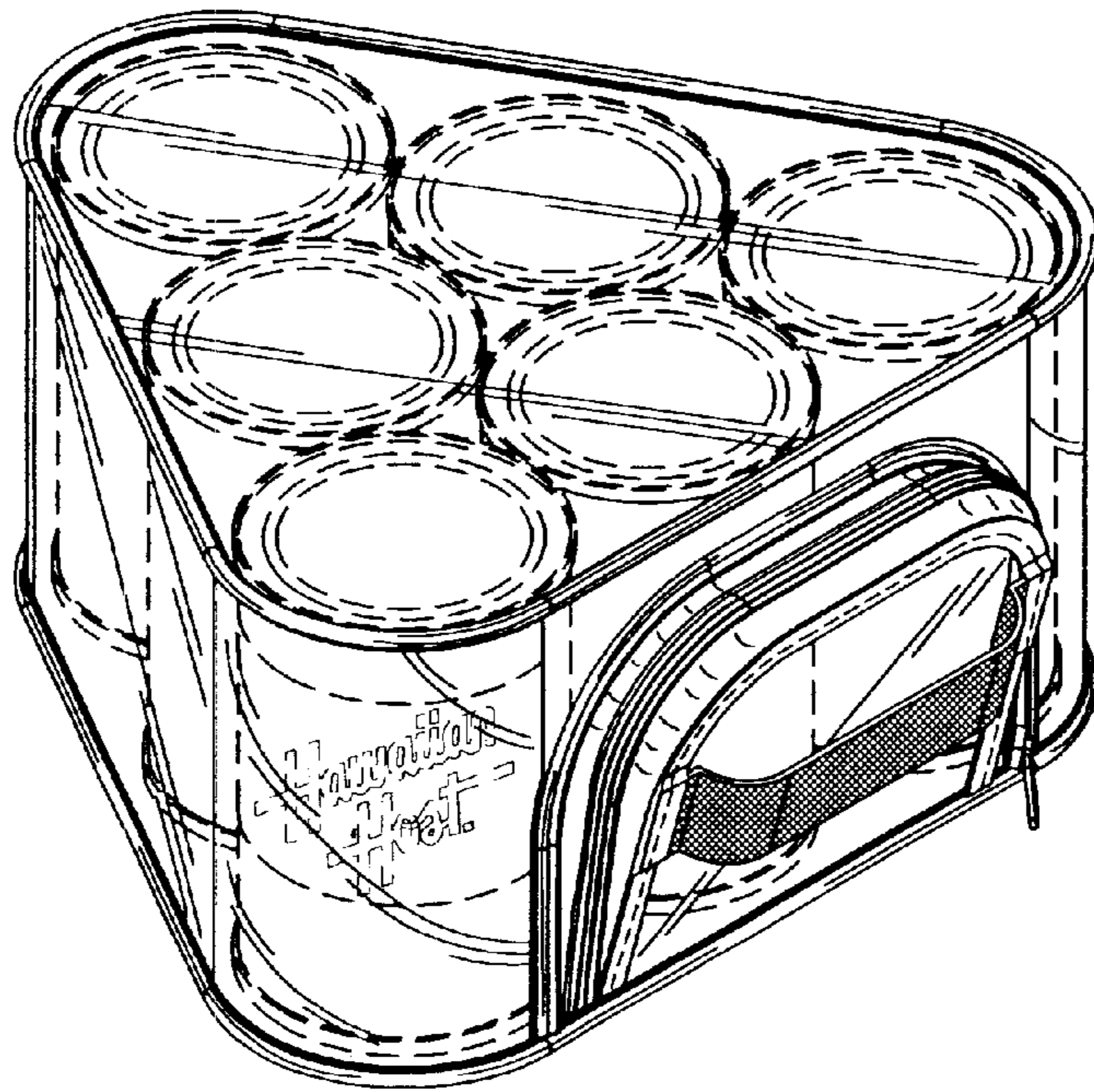

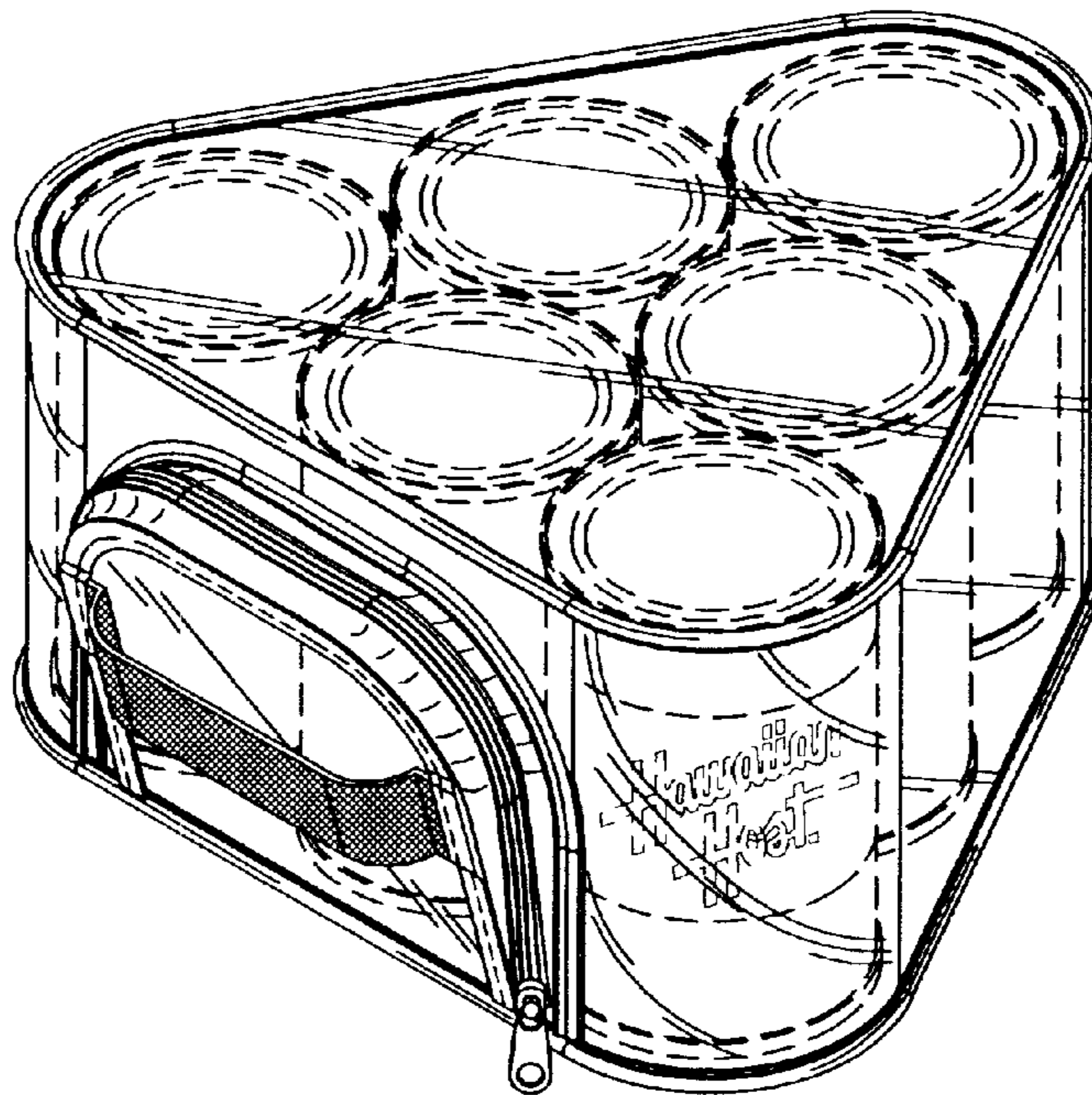

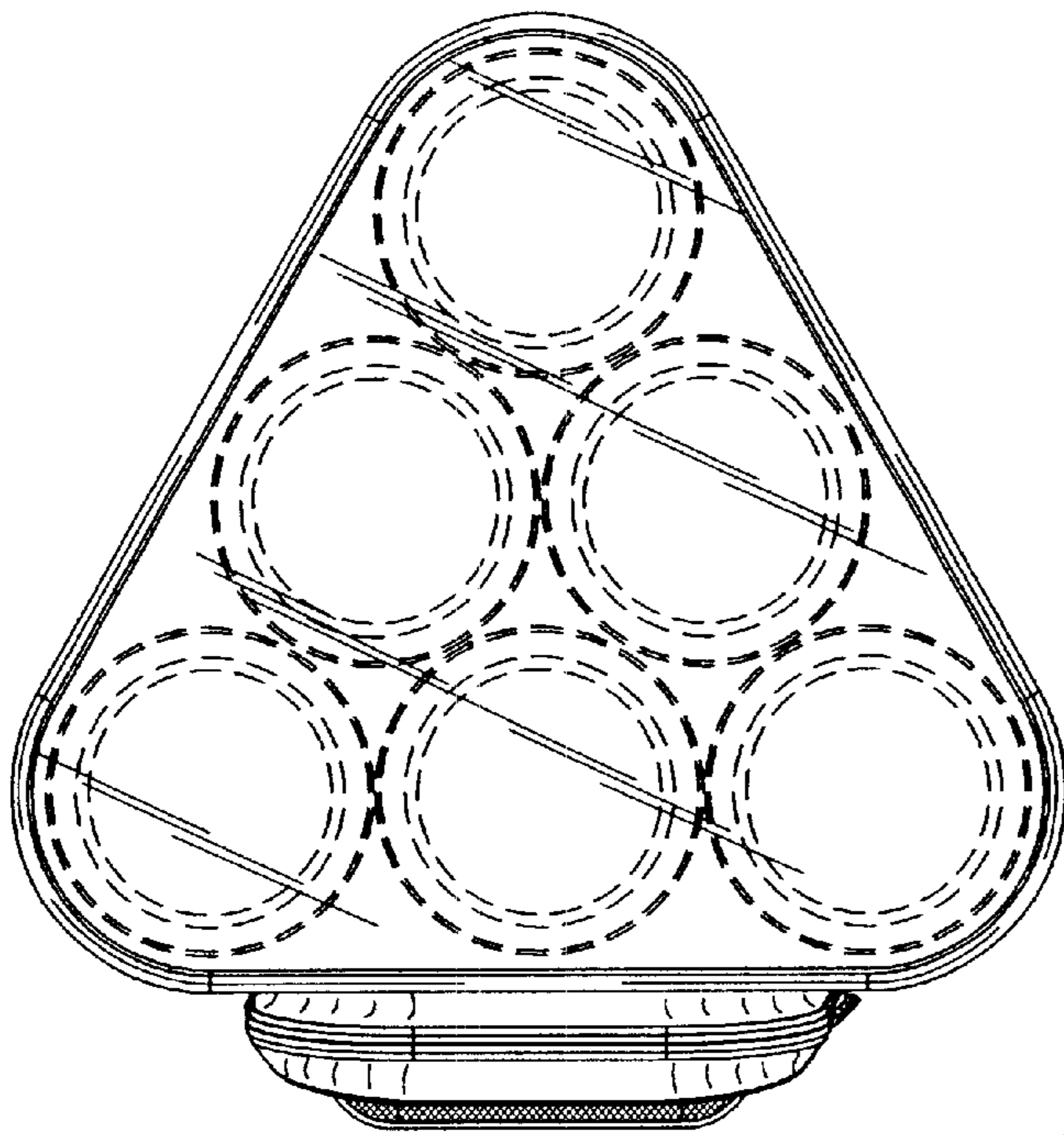

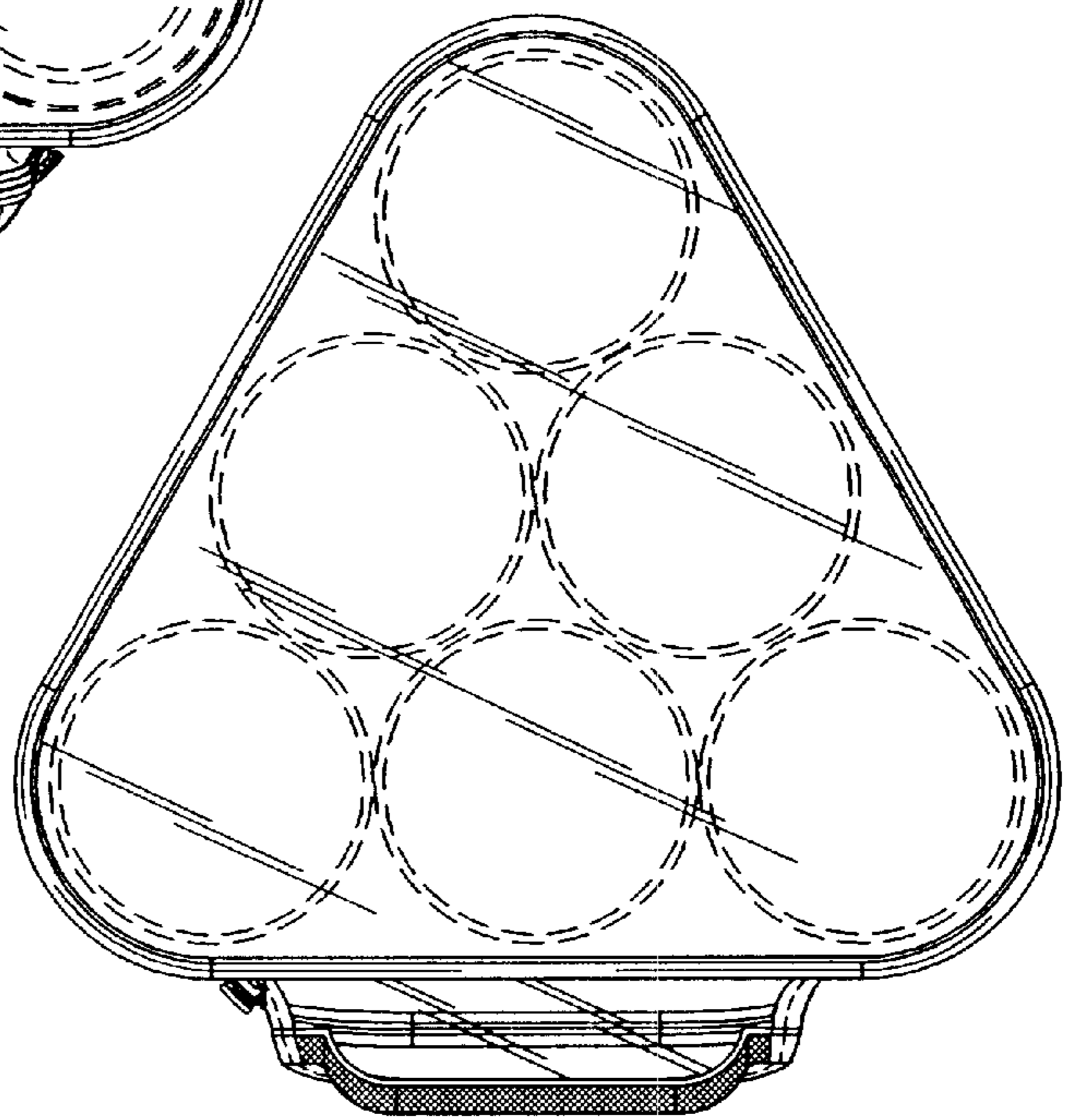

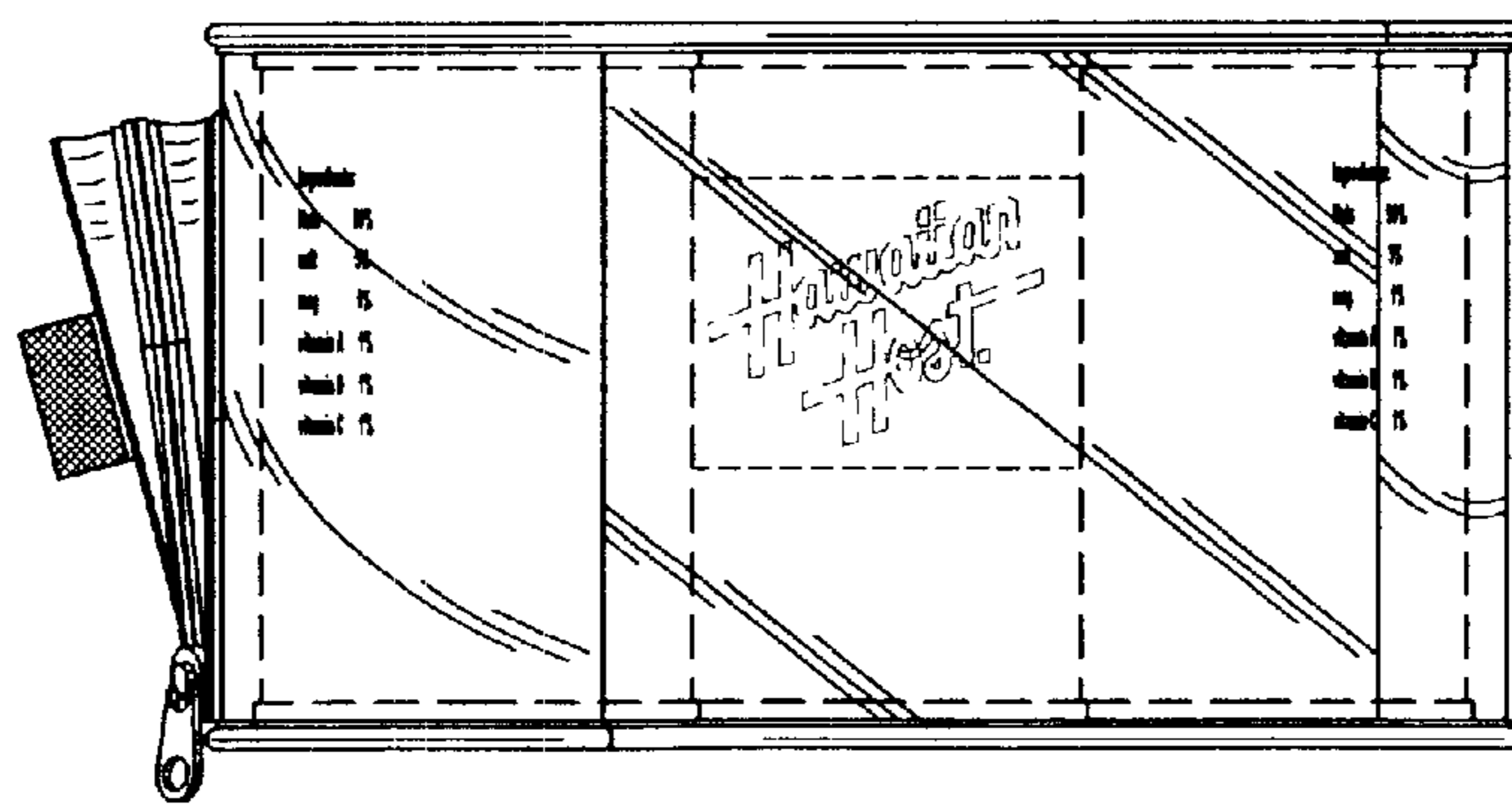

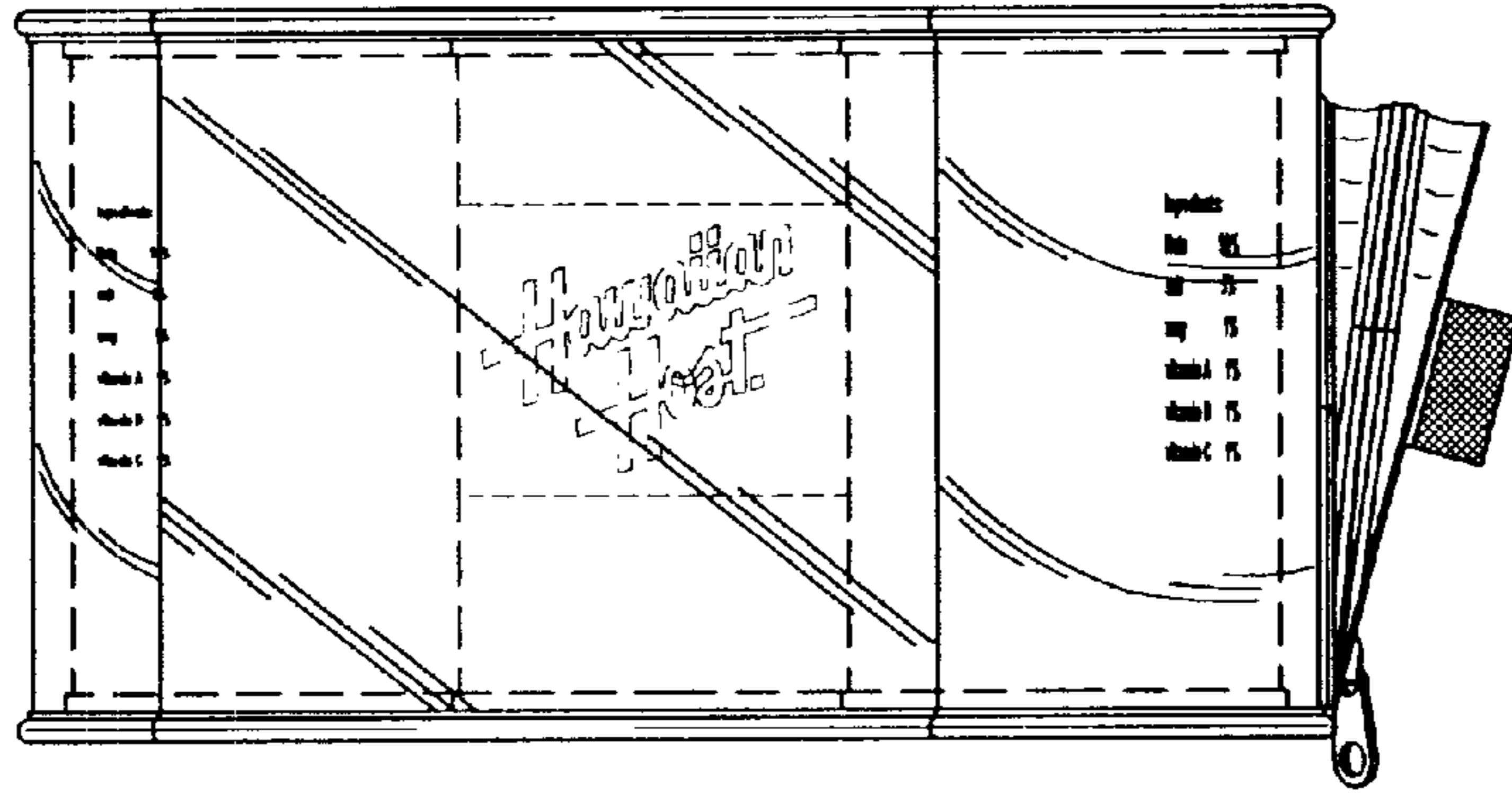

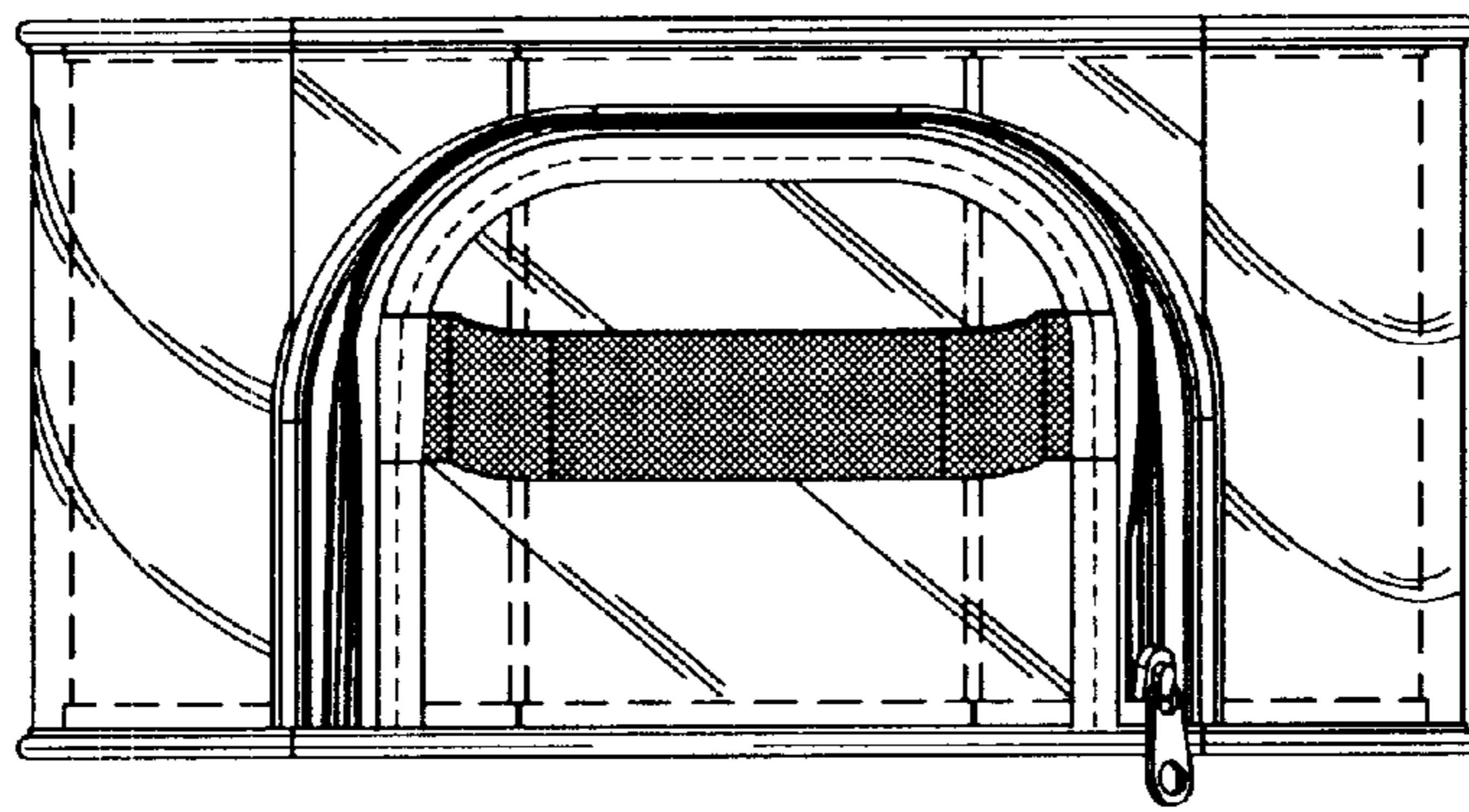

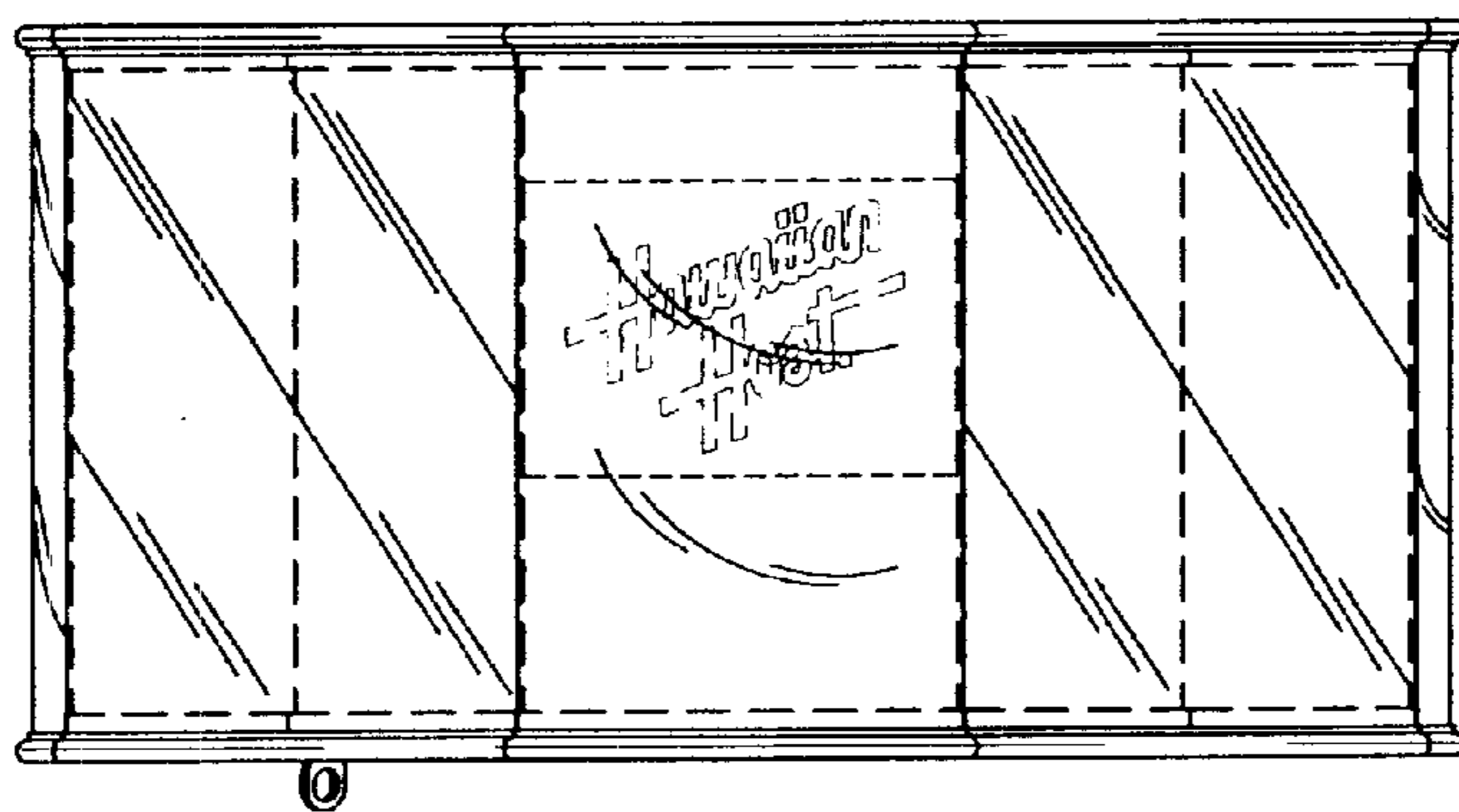
