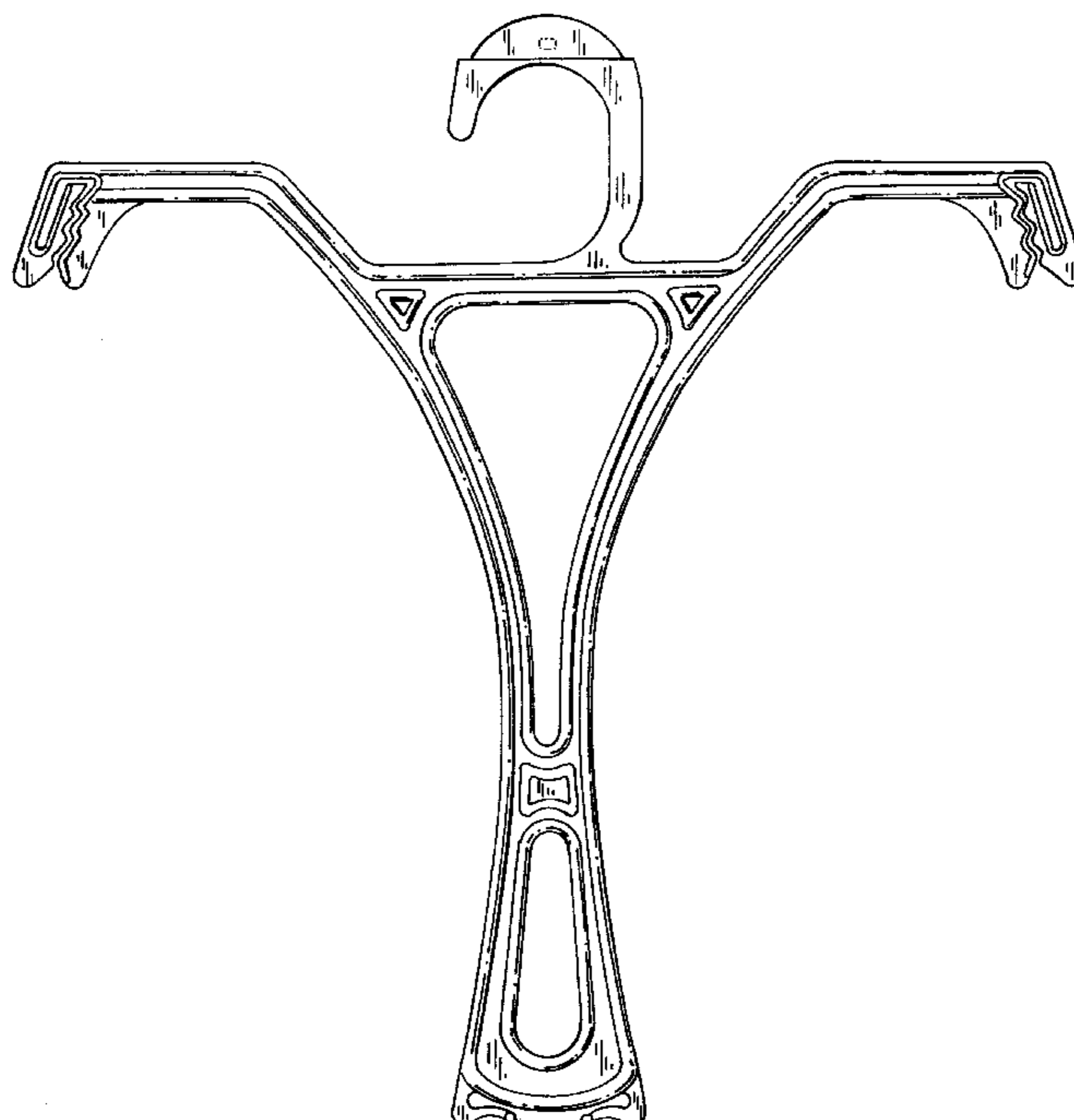
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front elevation view of my design; FIG. 2 is a rear elevation view of FIG. 1; FIG. 3 is a left end elevation view of FIG. 1; FIG. 4 is a right end elevation view of FIG. 1; FIG. 5 is a top plan view of FIG. 1; FIG. 6 is bottom plan view of FIG. 1; and, FIG. 7 is a front elevation view of a second embodiment of my design. 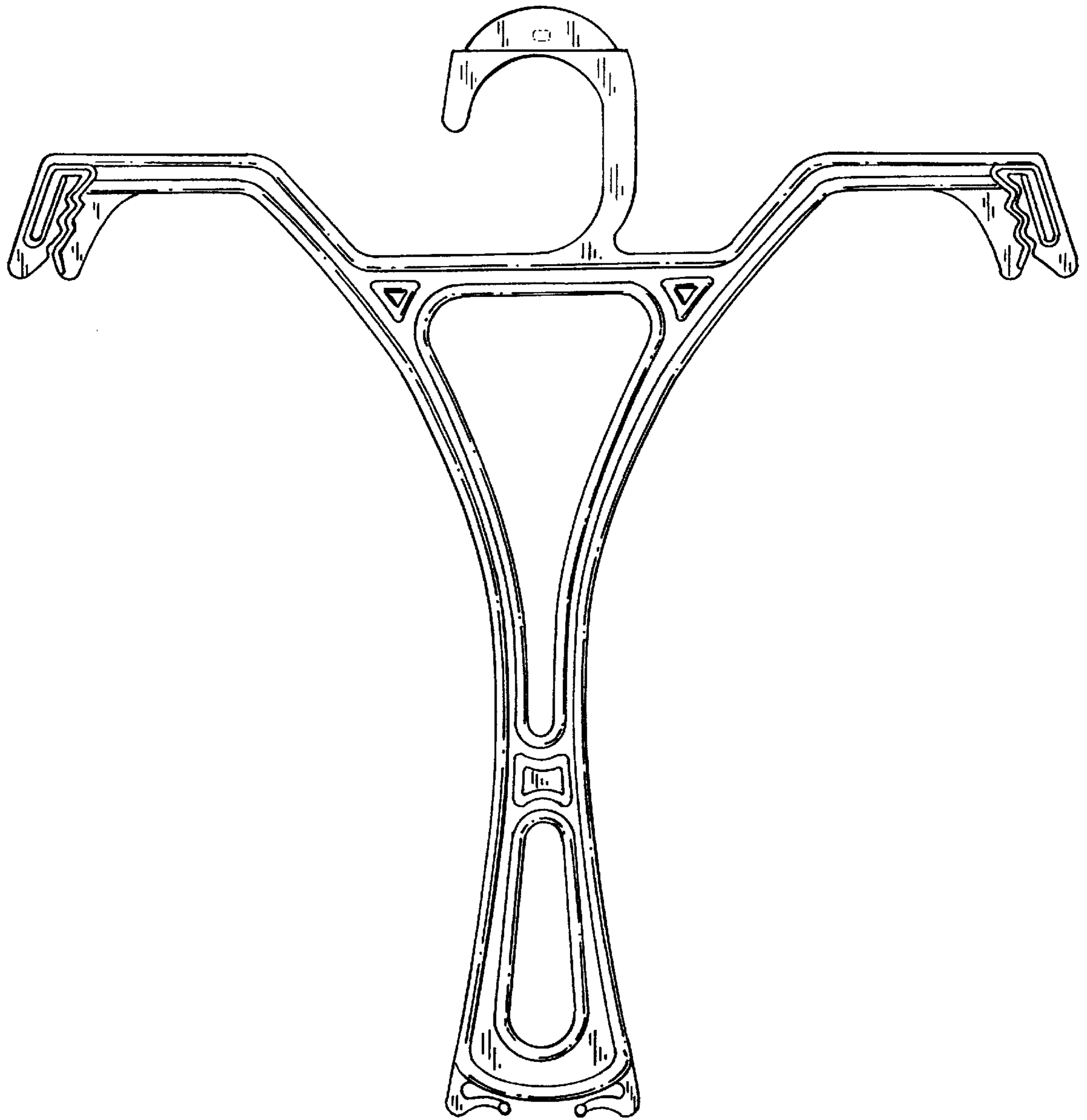

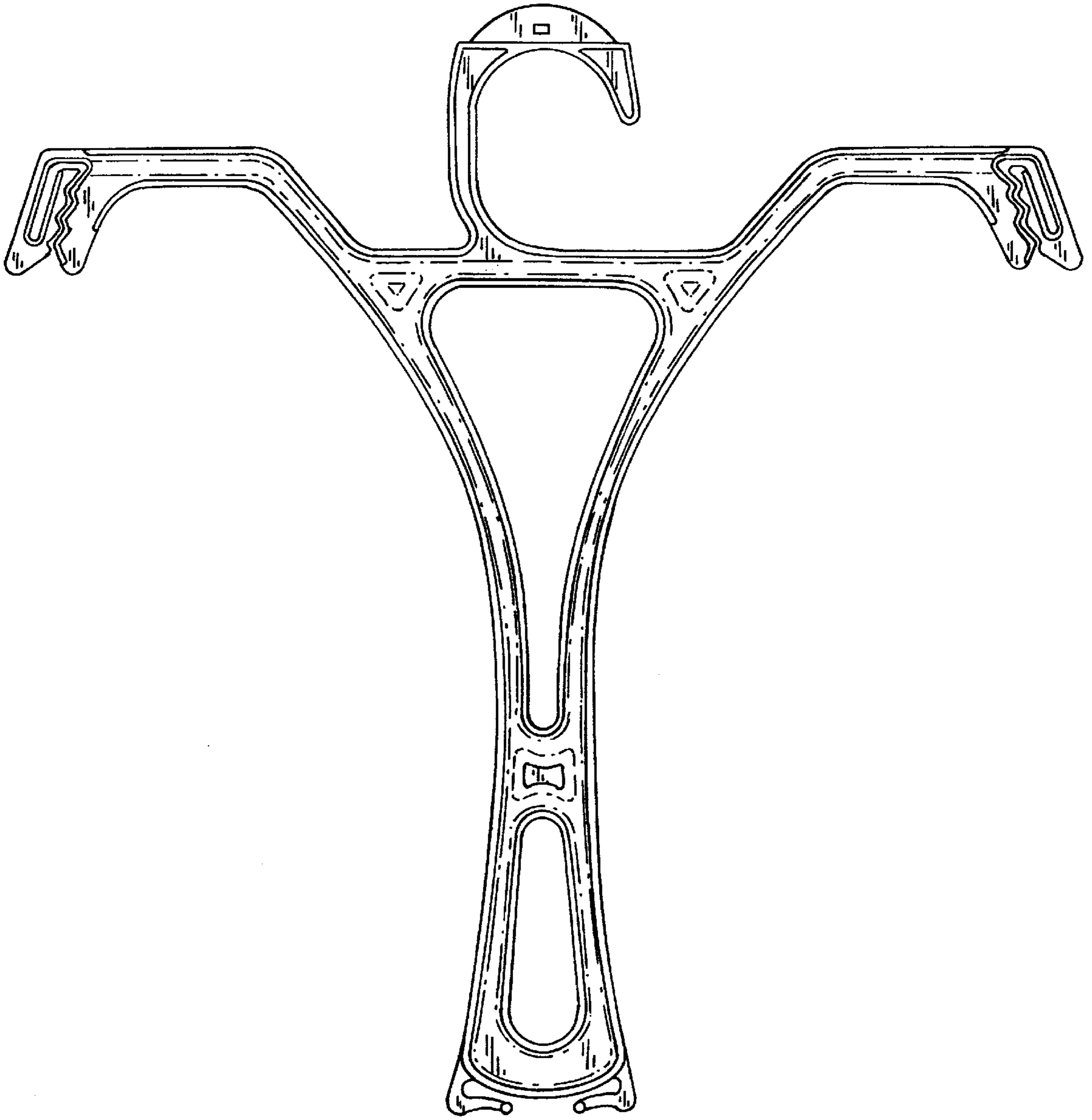

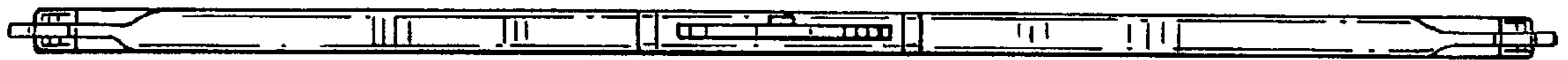

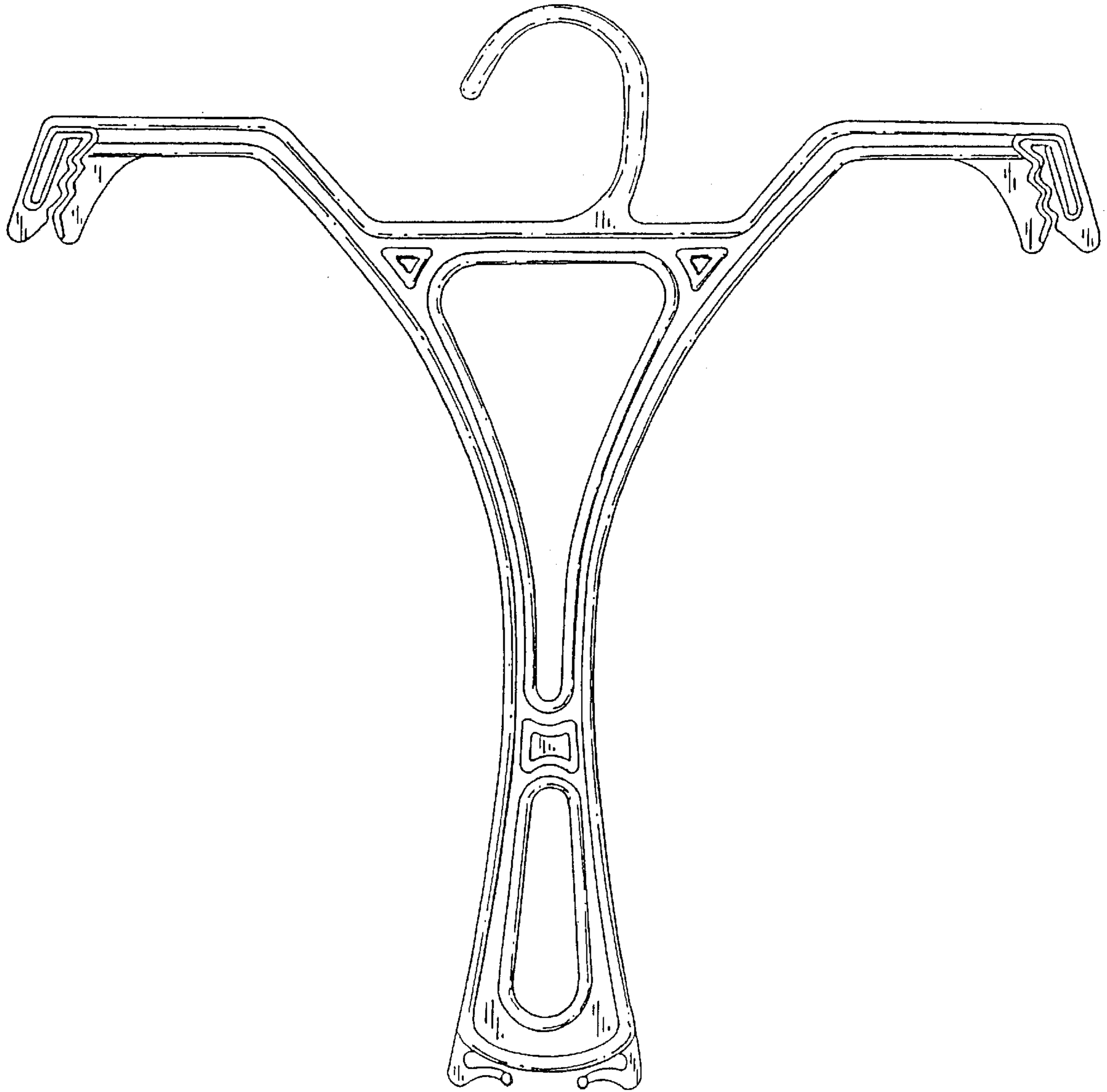
