(57) **CLAIM**

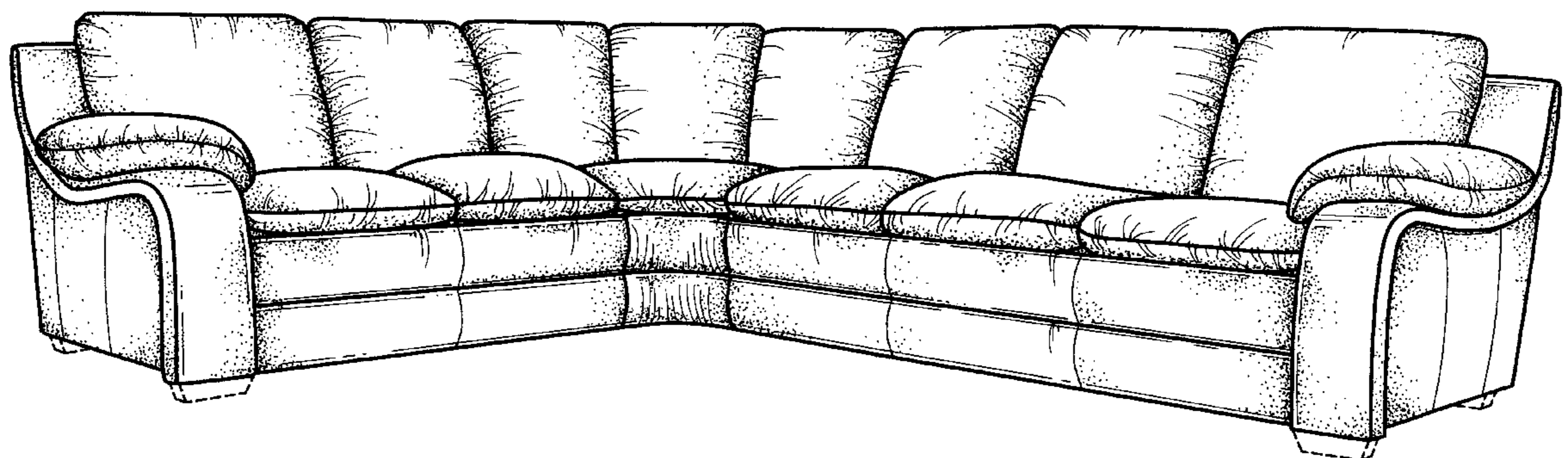
The ornamental design for a sofa, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a sofa showing my new design;
 FIG. 2 is a partial, rear perspective view of the embodiment of FIG. 1;
 FIG. 3 is a left elevation view of the embodiment of FIG. 1;
 FIG. 4 is a right elevation view of the embodiment of FIG. 1;
 FIG. 5 is a rear elevation view of the embodiment of FIG. 1;
 FIG. 6 is a left elevation view of a second embodiment of the sofa depicted in FIG. 1;
 FIG. 7 is a right elevation view of the embodiment of FIG. 6; and,
 FIG. 8 is a rear elevation view of the embodiment of FIG. 6.

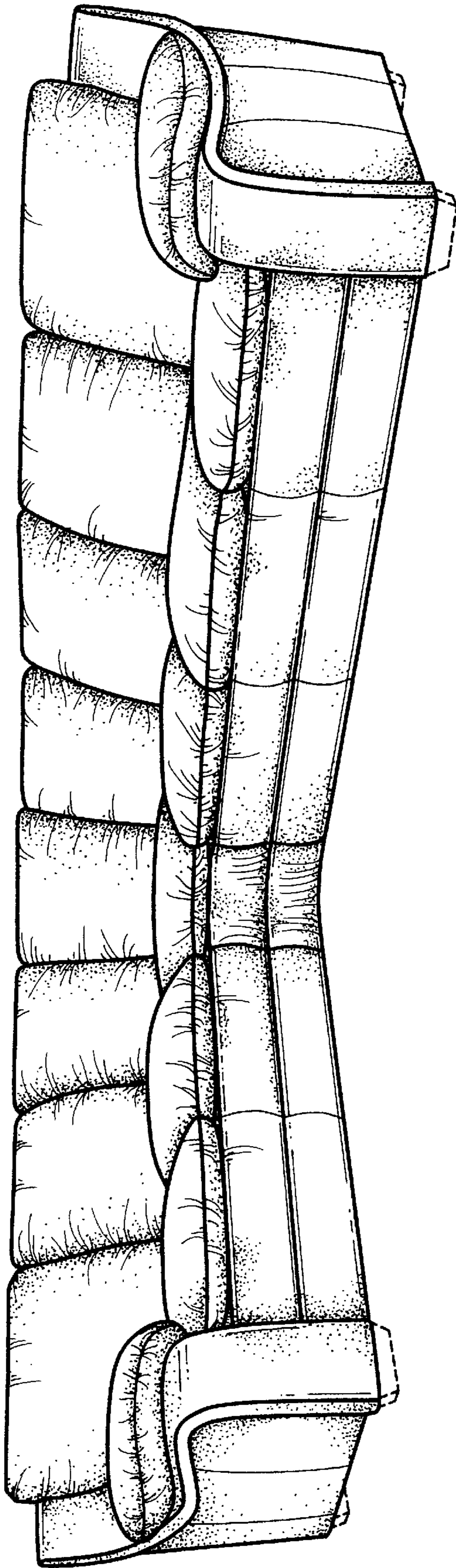

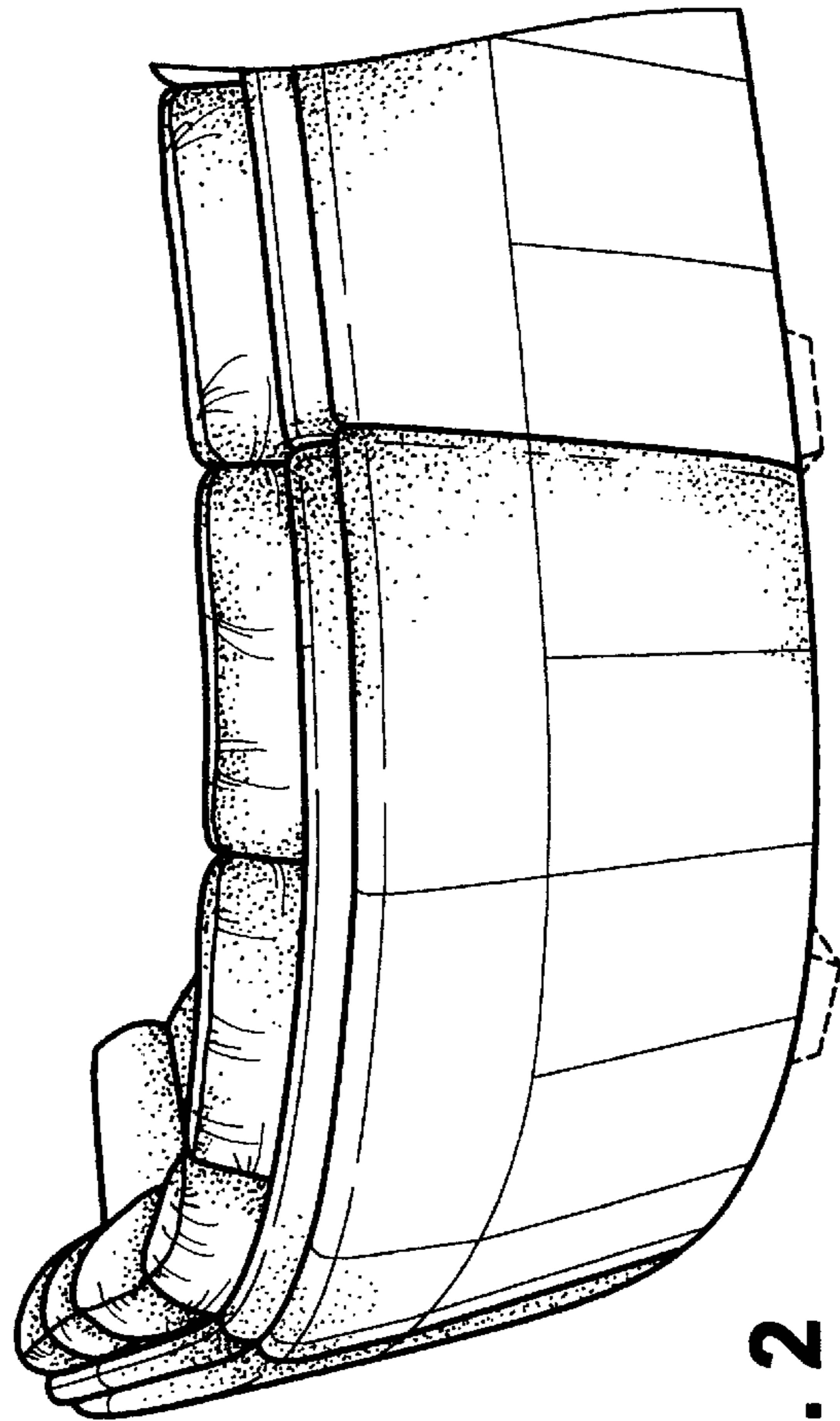

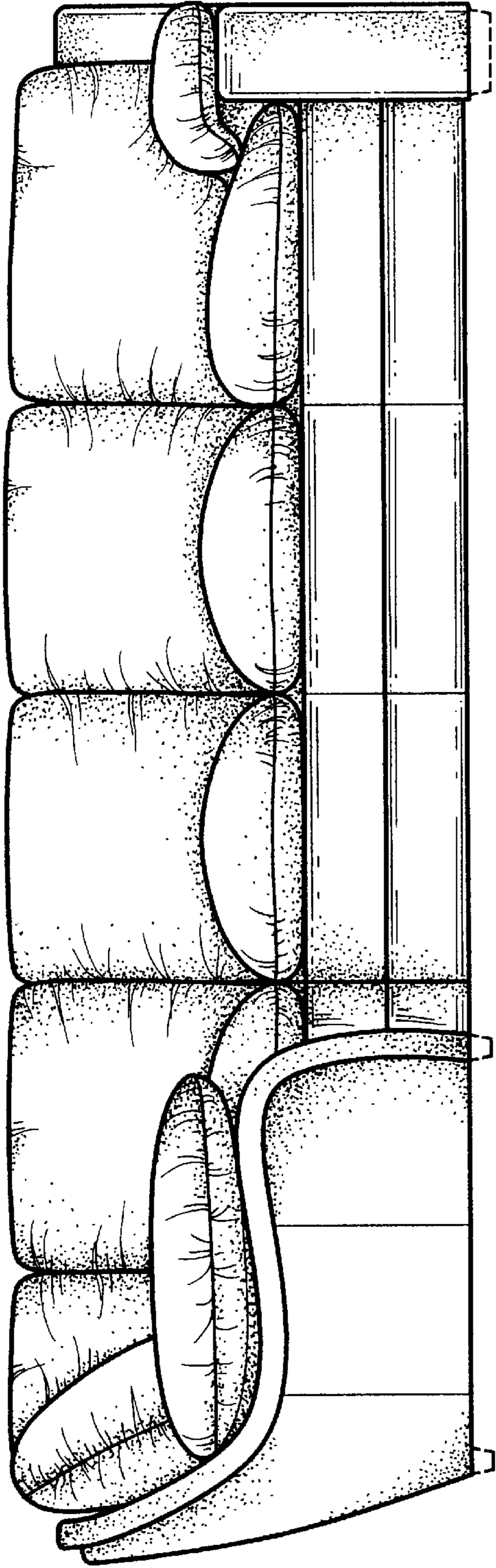

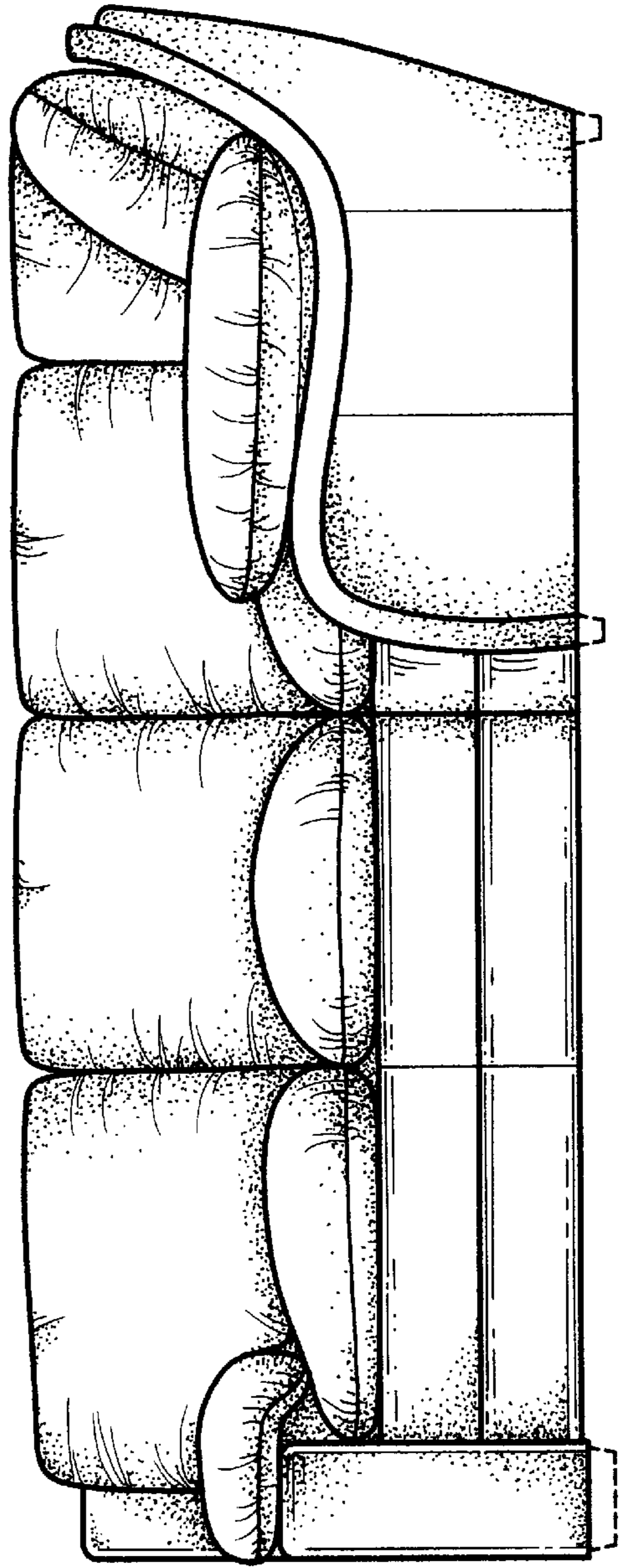

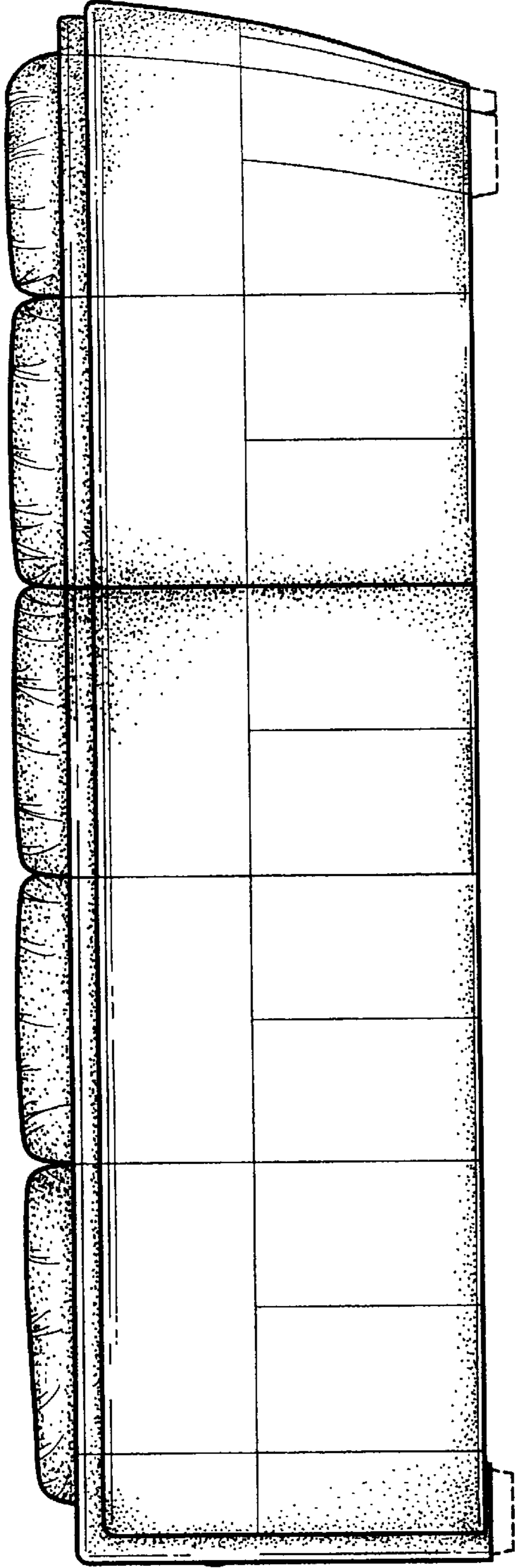

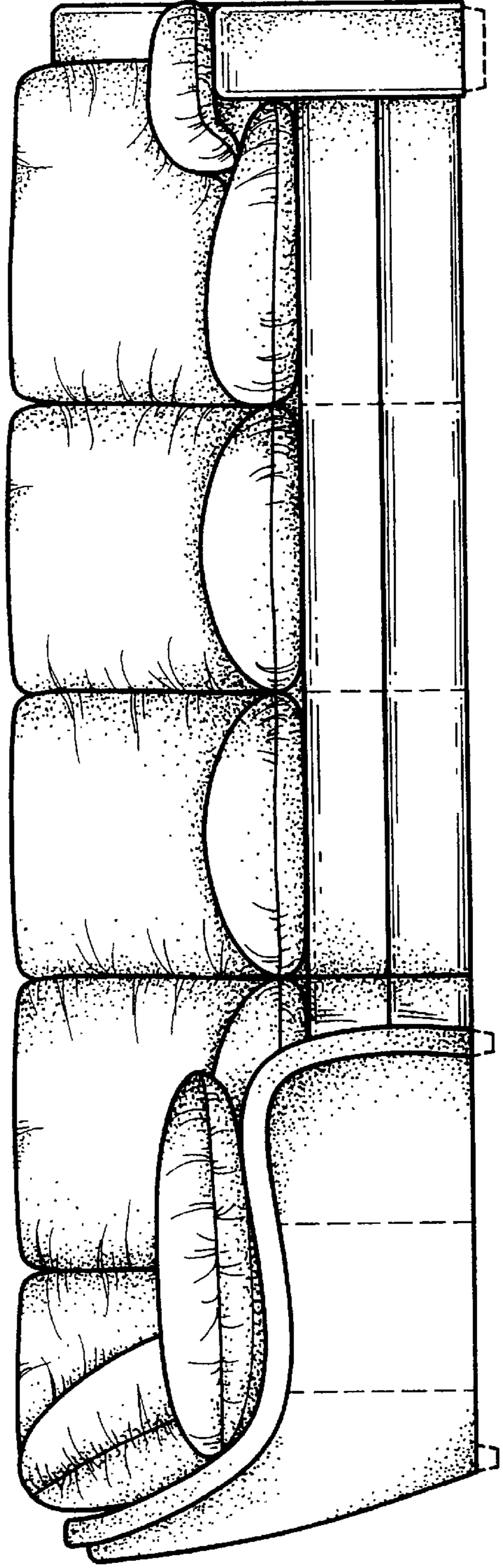

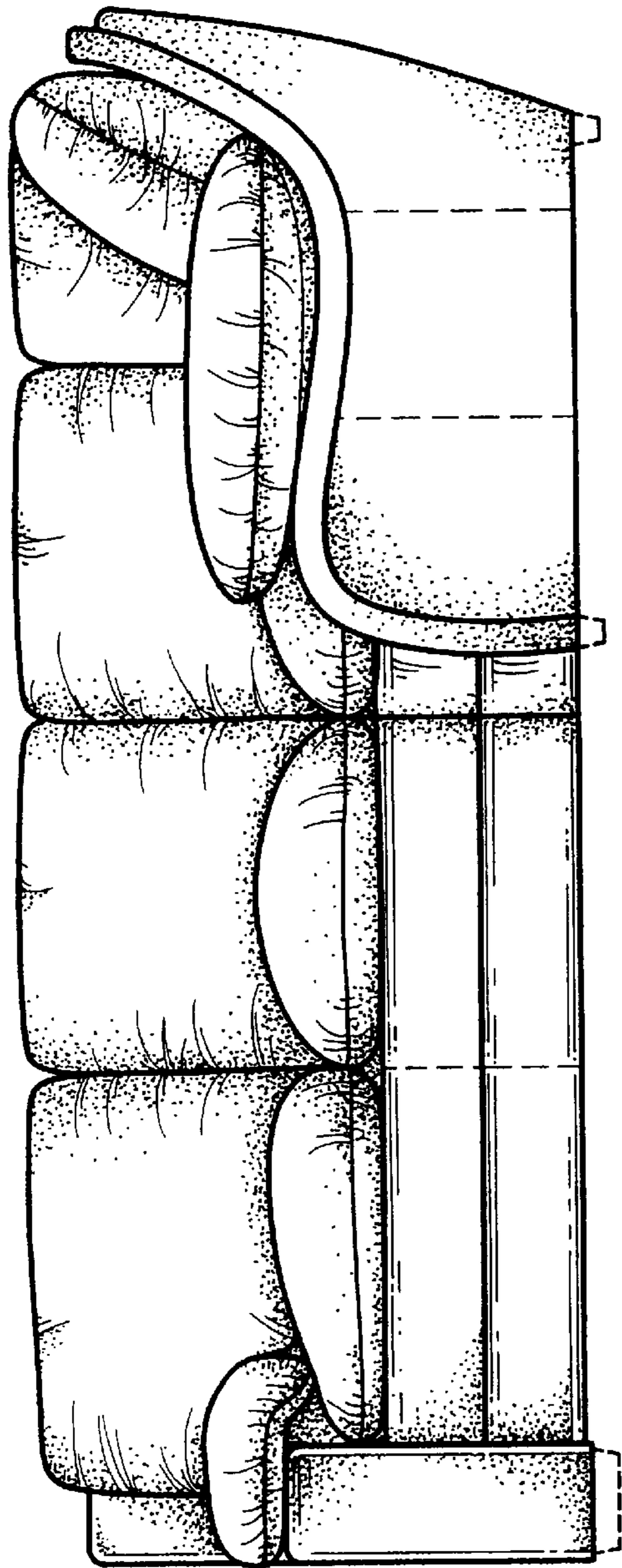

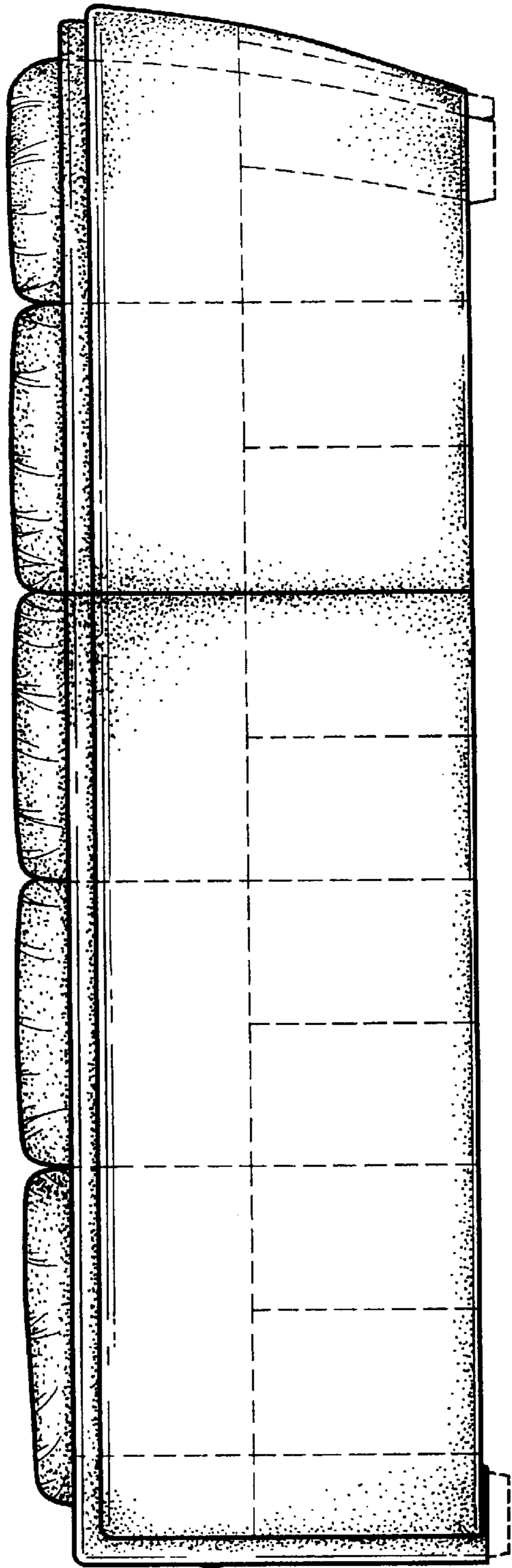
