The ornamental design for a table, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a table showing my new design;

FIG. 2 is a side elevational view, the opposite side being a mirror image thereof;

FIG. 3 is a side elevational view, the opposite side being a mirror image thereof; and,

FIG. 4 is a top view thereof.

The views of the table not shown form no part of the claimed design. The dashed lines depicting pedestal base represent environmental elements only and form no part of the claimed design.
