(57) **CLAIM**

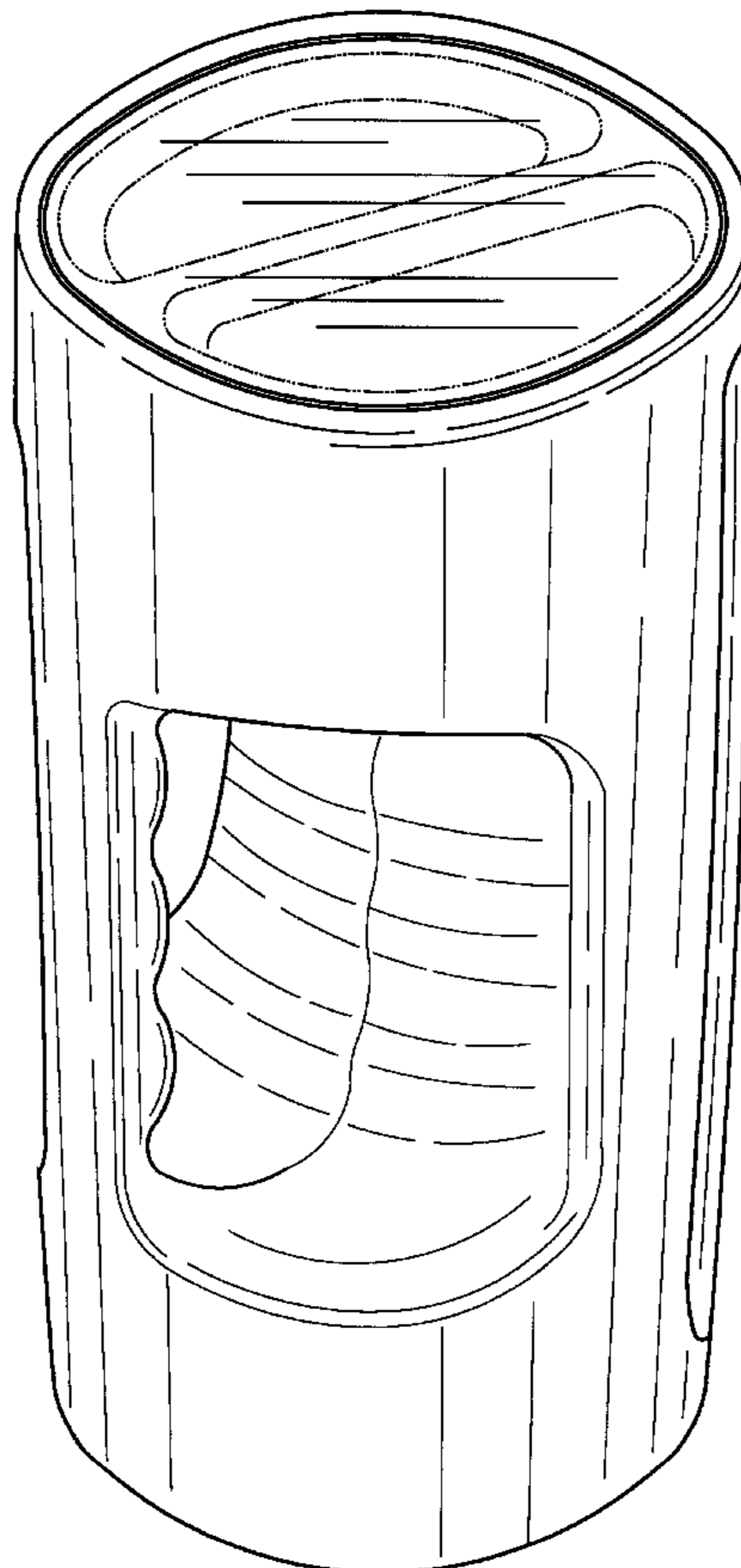
The ornamental design for a mug container, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a frosty mug container showing my new design having a first lid embodiment; FIG. 2 is a front elevational view thereof; FIG. 3 is a right side elevational view thereof, the left side being substantially a mirror image thereof; FIG. 4 is a rear elevational view thereof; FIG. 5 is a top plan view thereof; and, FIG. 6 is a bottom view thereof.

The broken lines in the drawings are for illustrative purposes only and form no part of the claimed design.

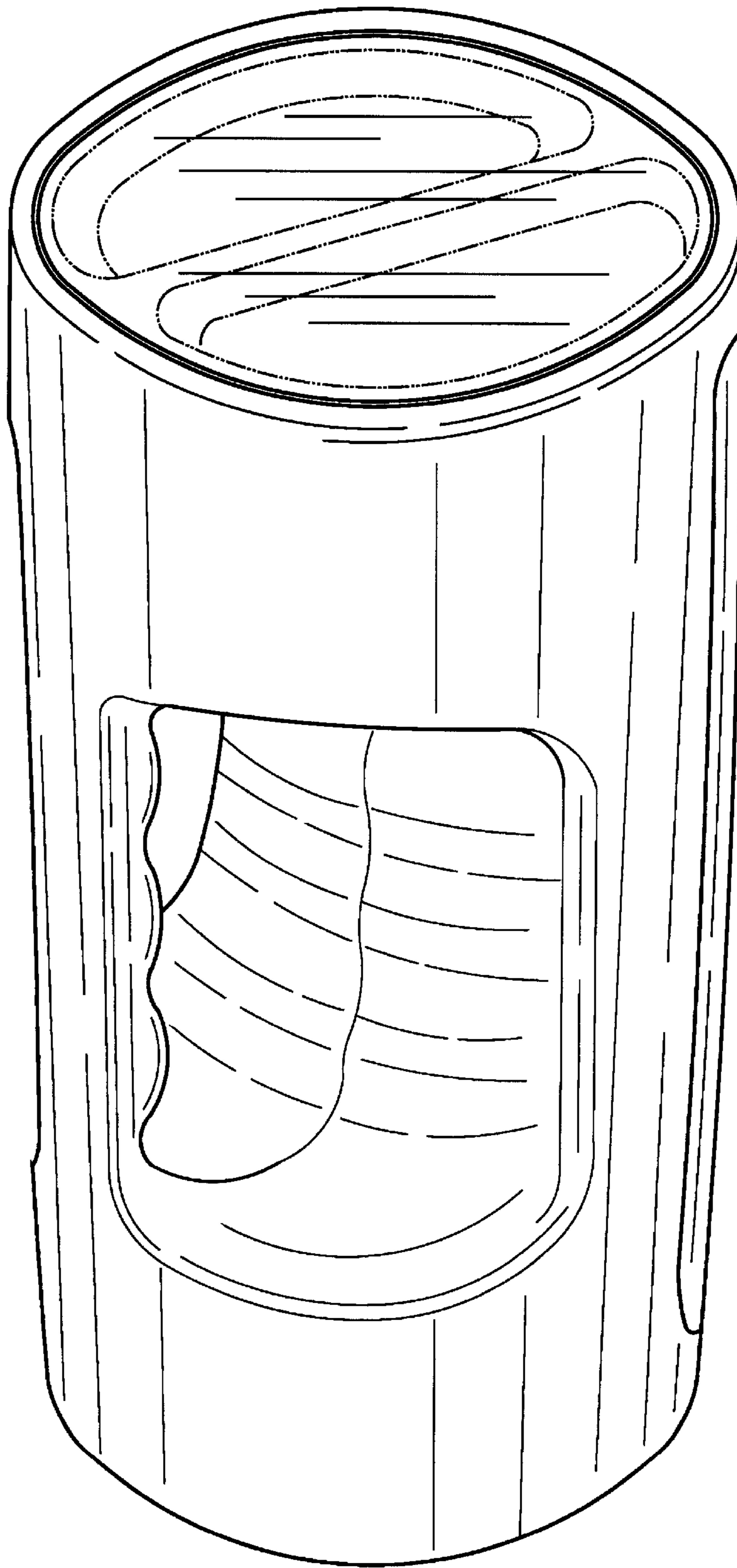

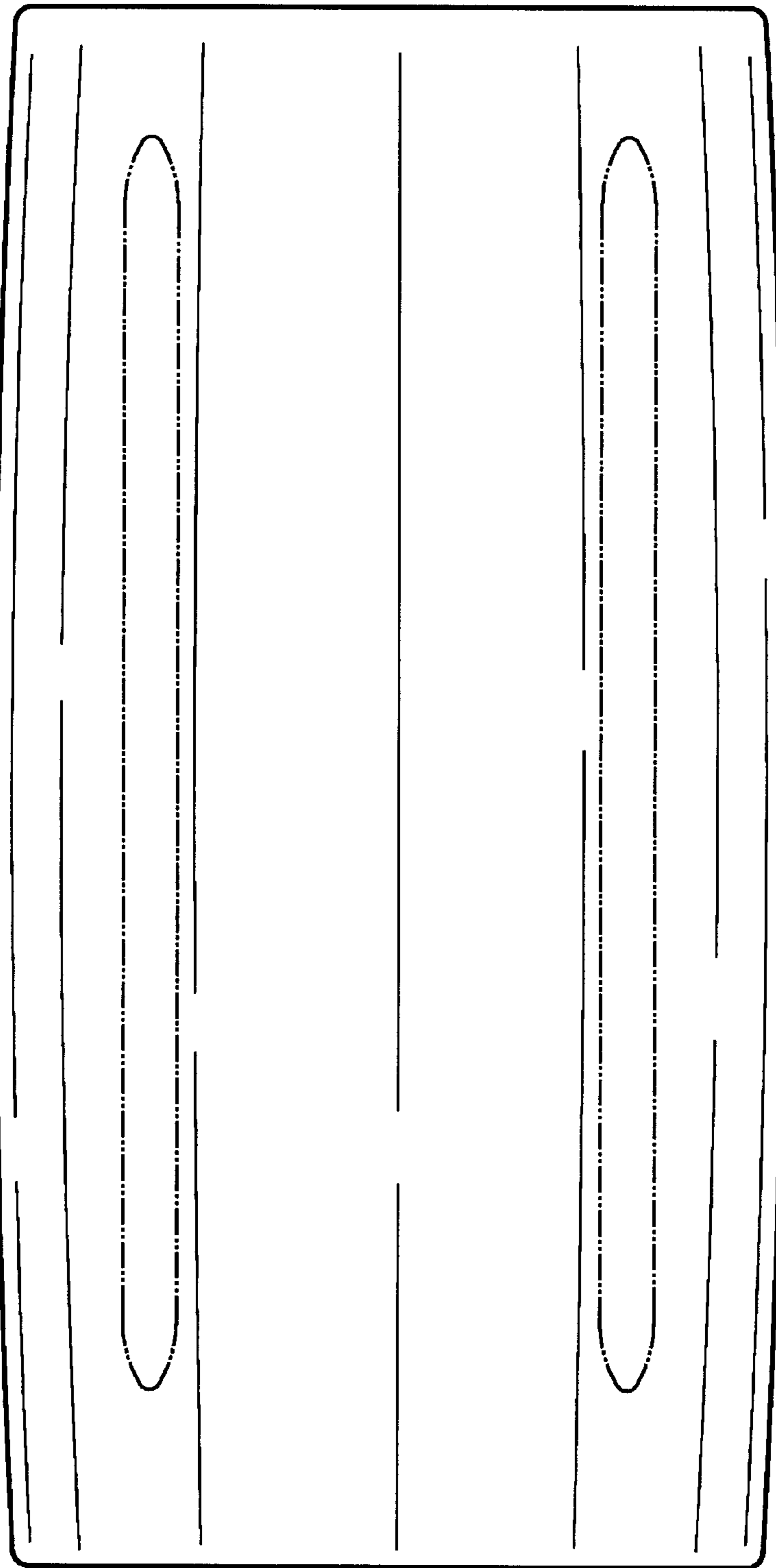

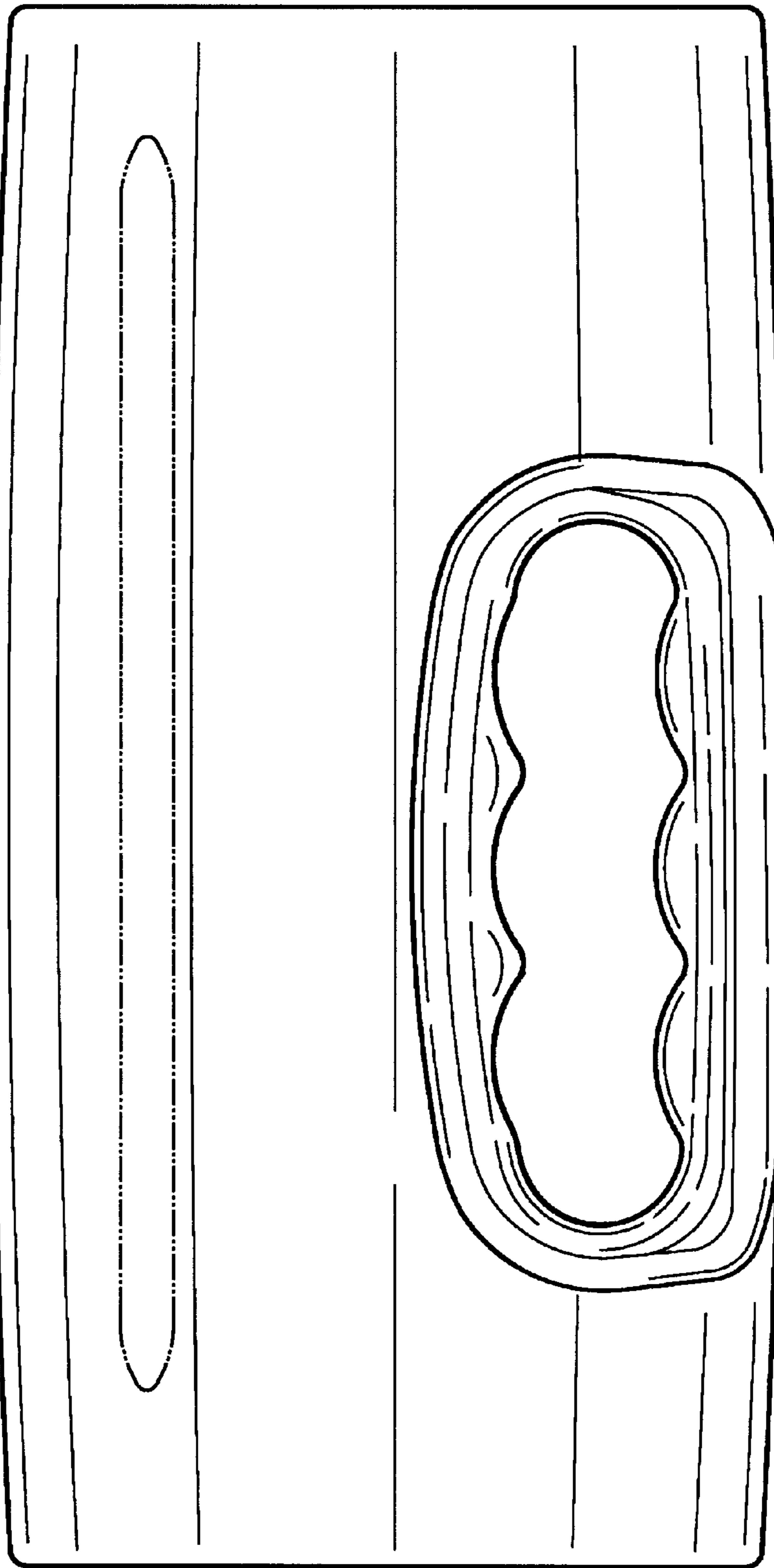

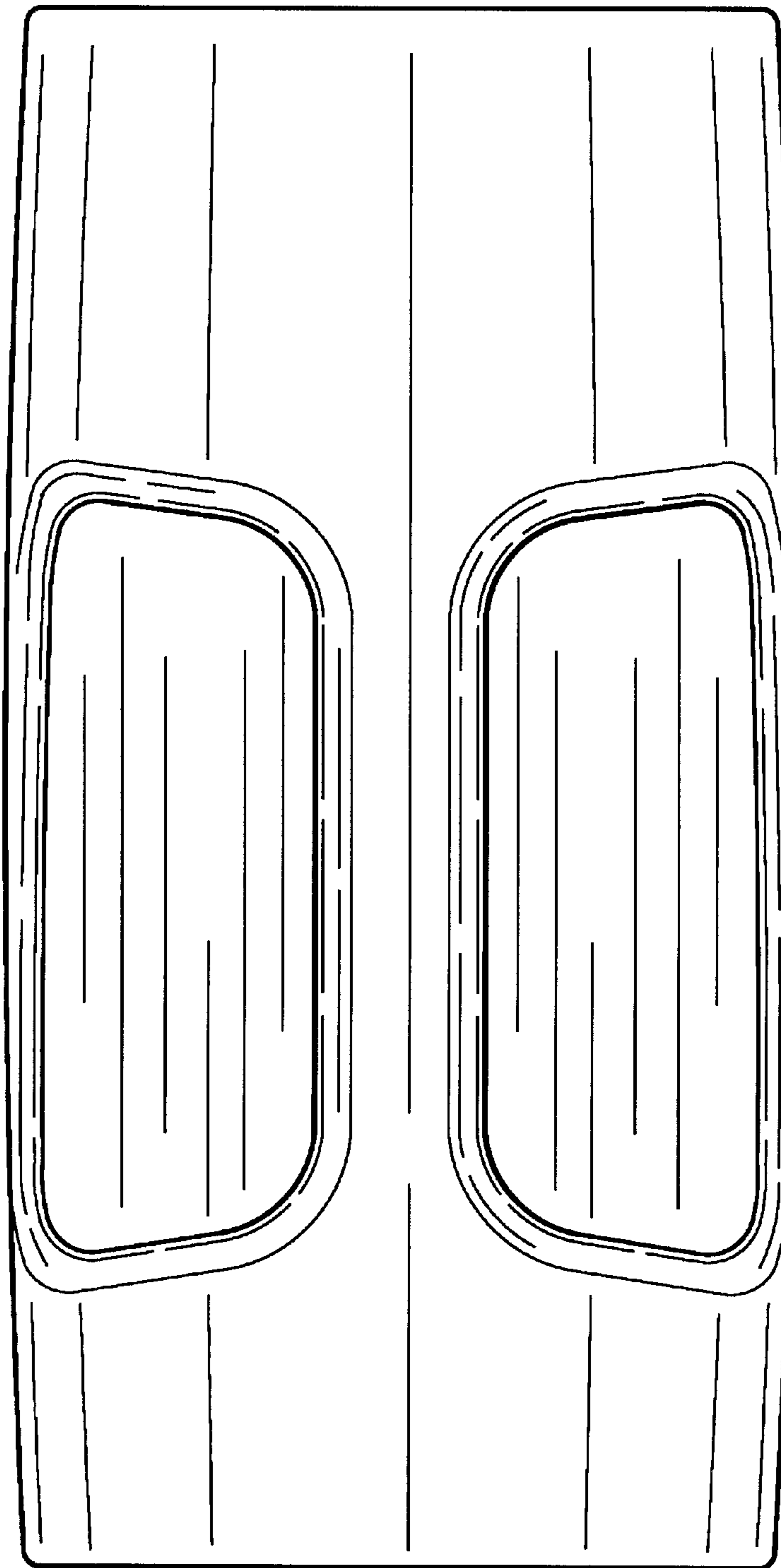

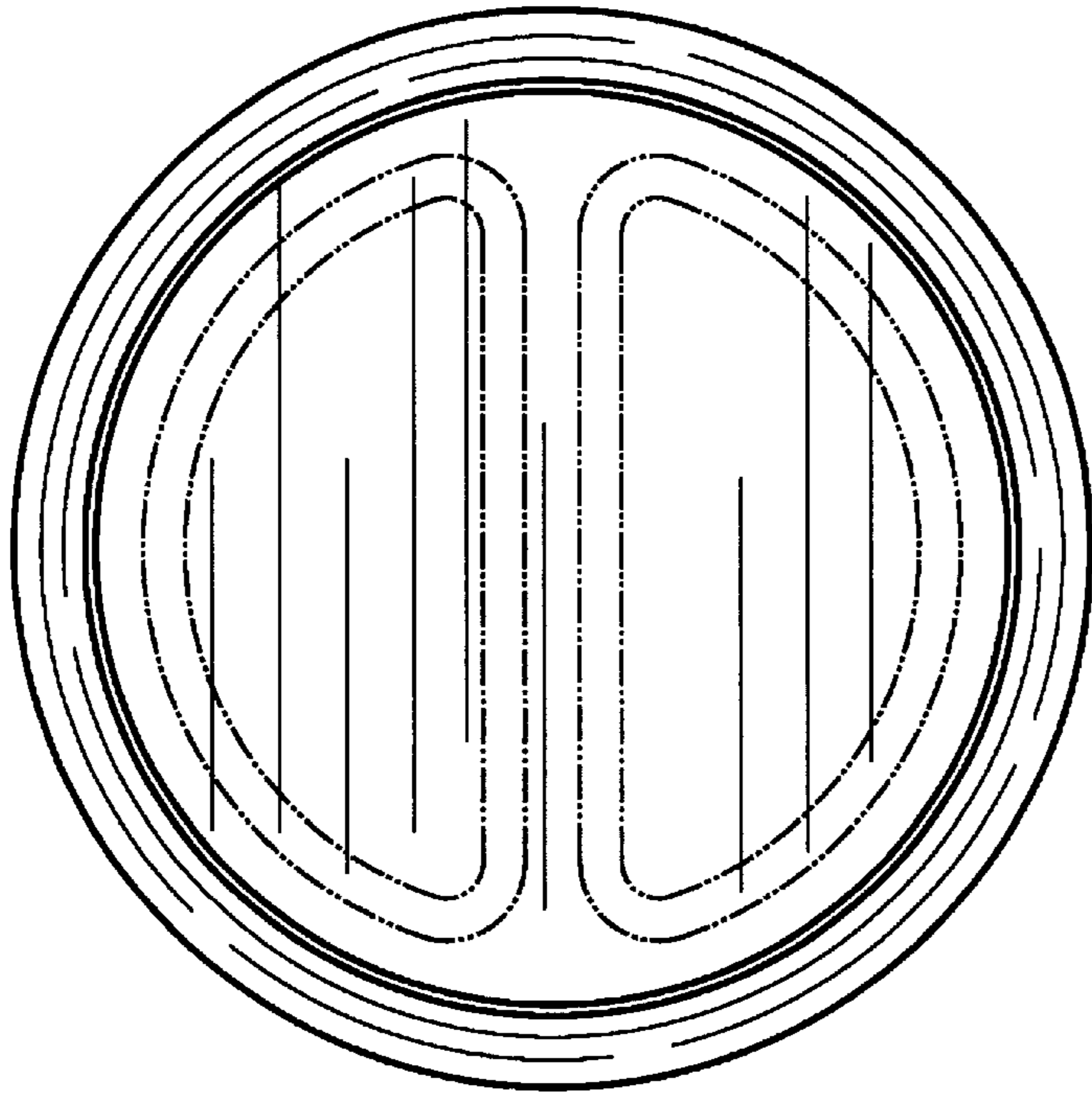

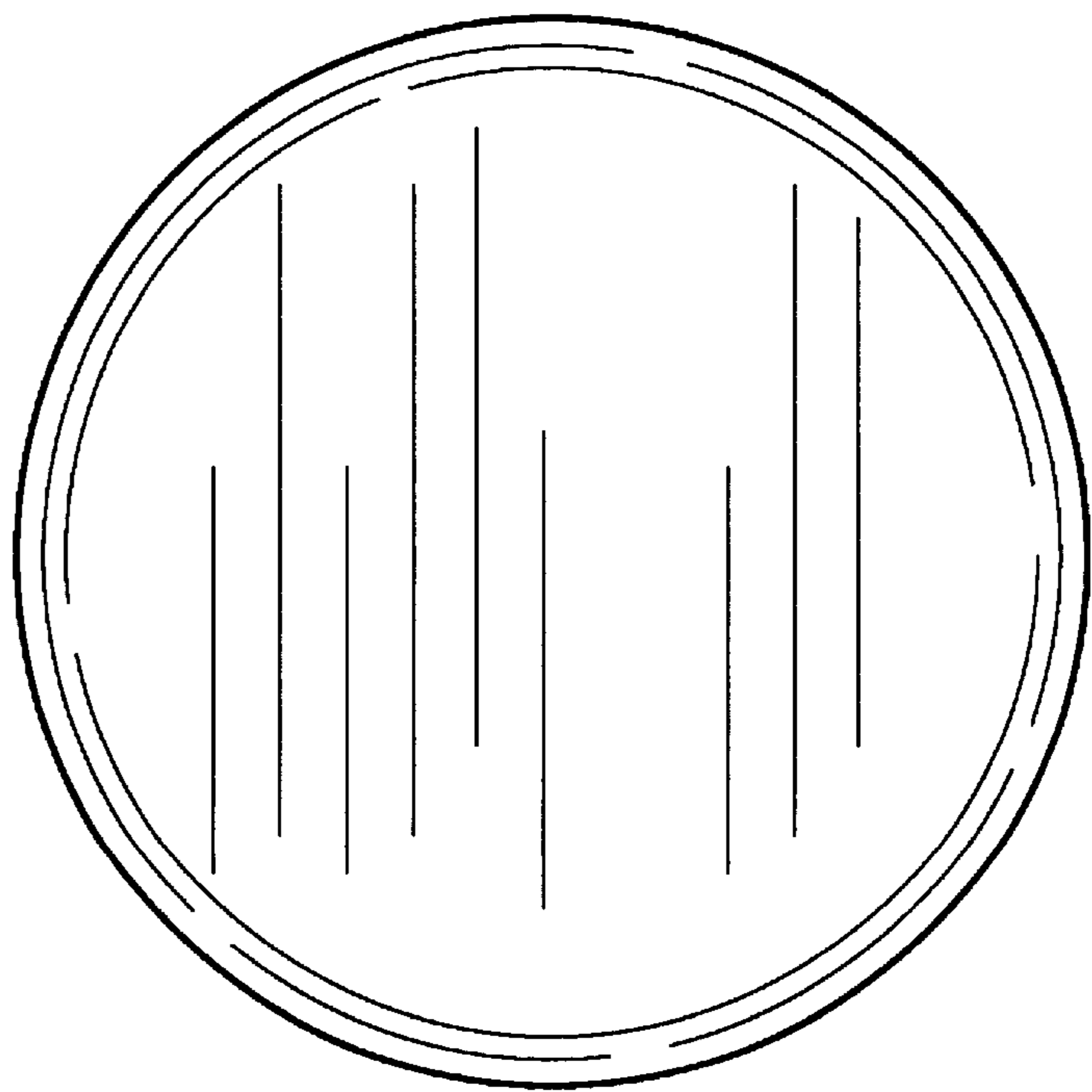
