(57) **CLAIM**

The ornamental design for a bottle, substantially as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view from above and one side of a bottle in accordance with our new design; FIG. 2 is a right side elevational view thereof, the left side elevational view being a mirror image thereof; FIG. 3 is a top plan view thereof; FIG. 4 is a front elevational view thereof; and, FIG. 5 is a bottom plan view thereof.

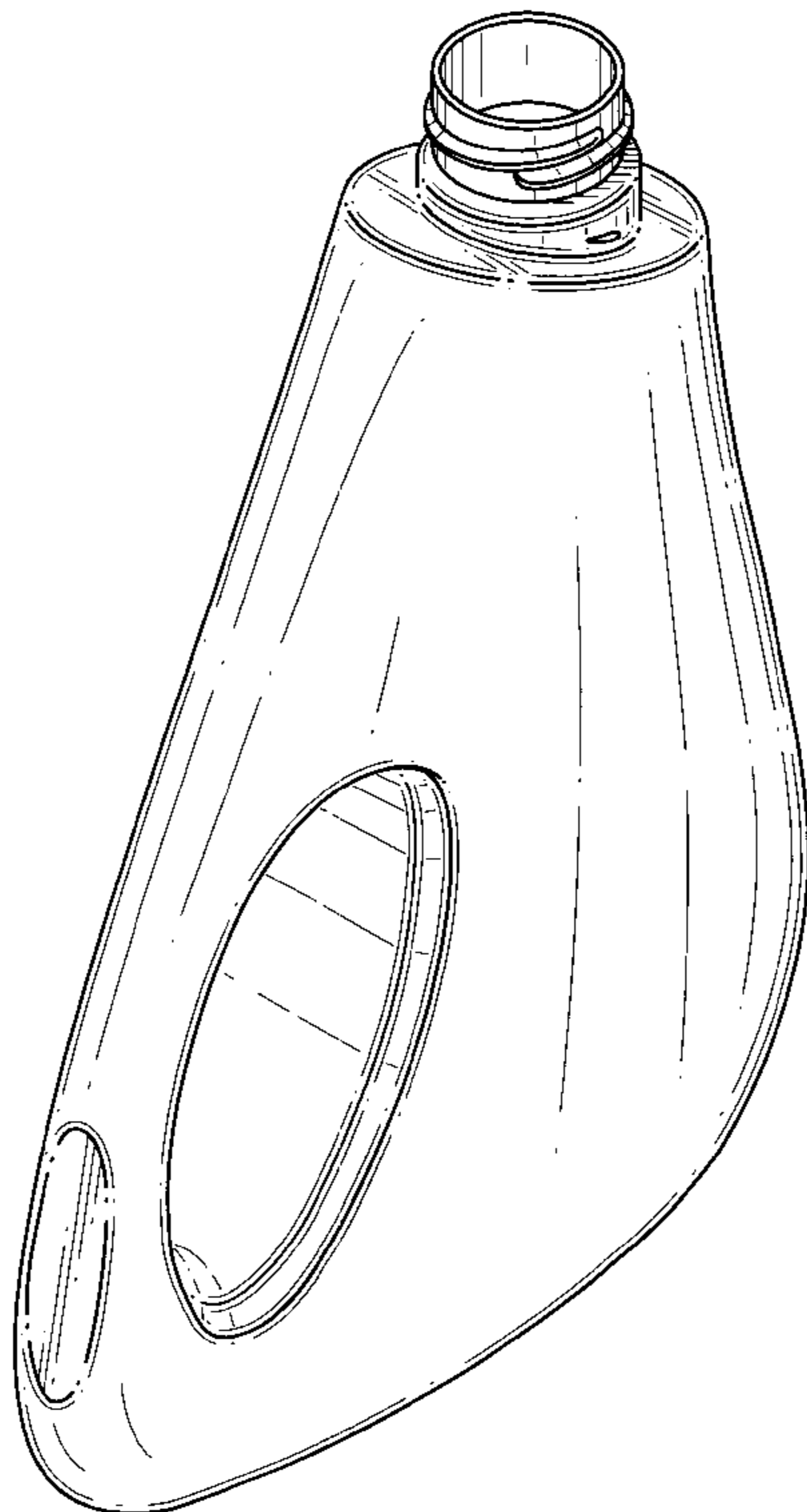
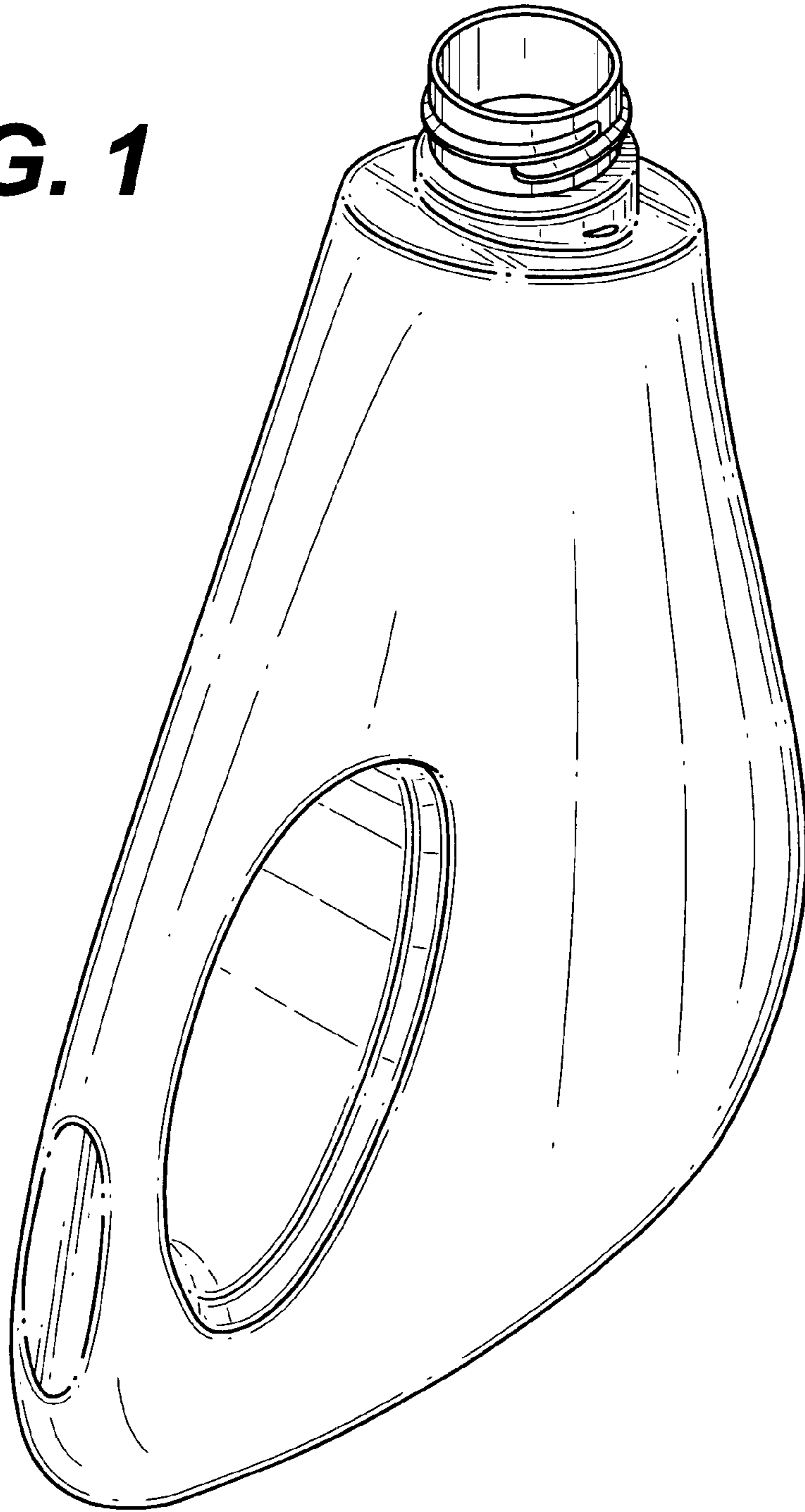

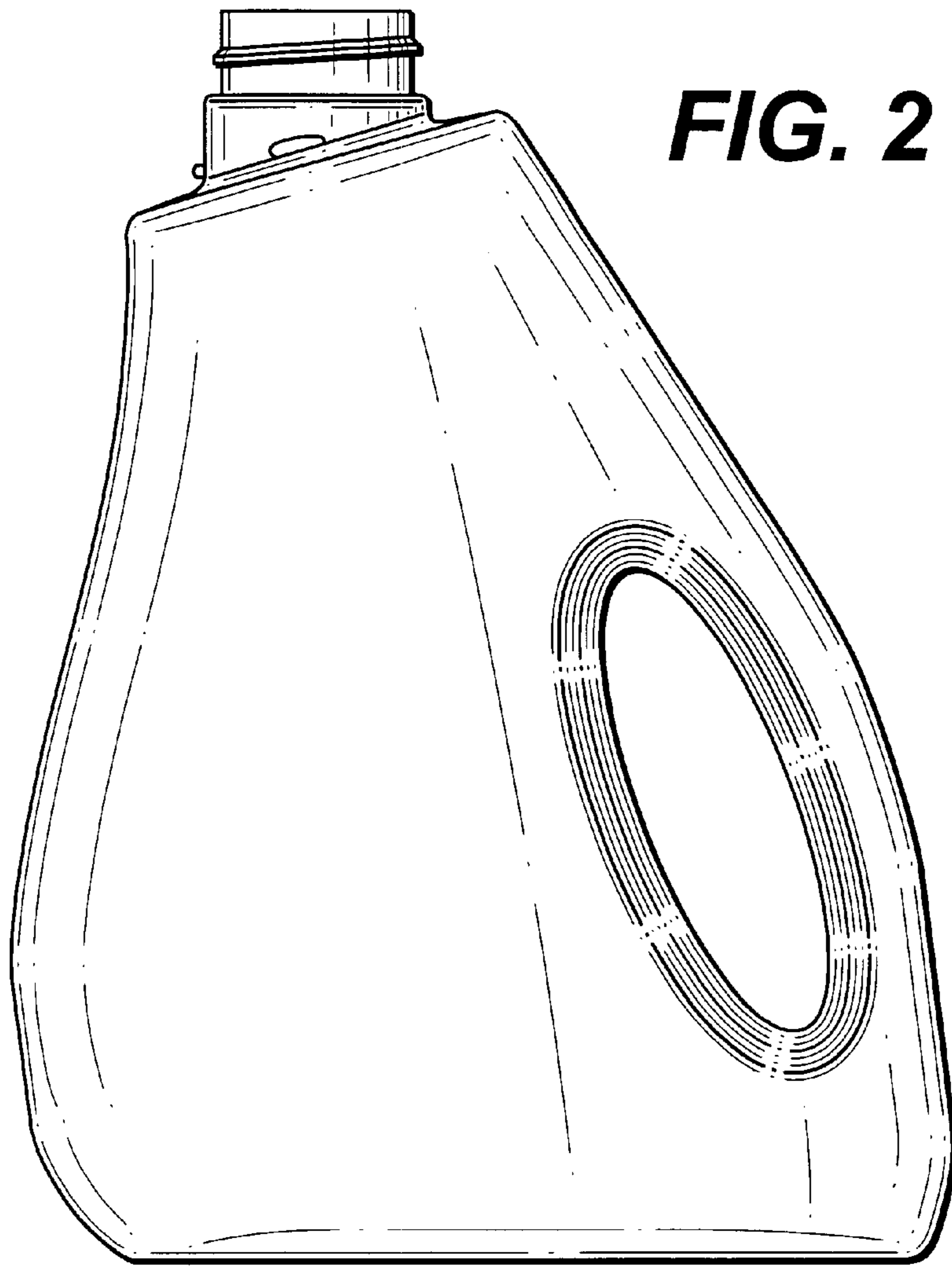

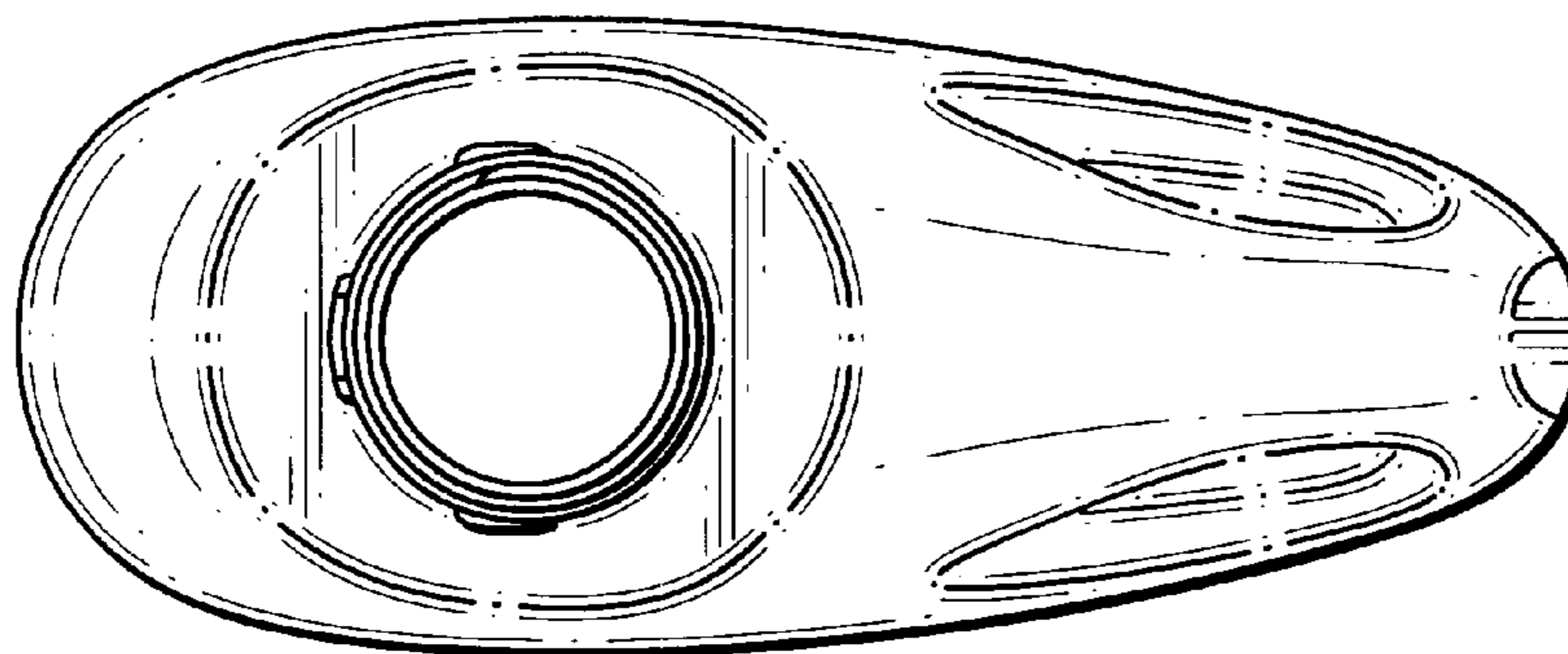

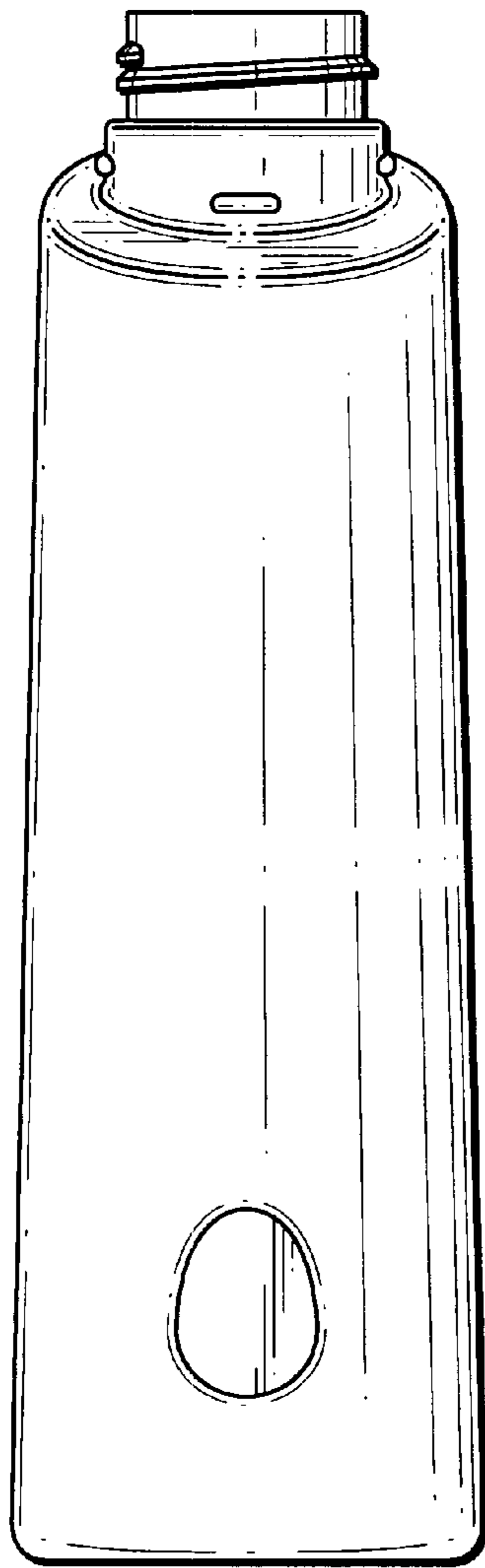
