(57) **CLAIM**

The ornamental design for vehicle floor mat, as shown and described.

DESCRIPTION

FIG. 1 is a top plan view of a first embodiment of a

driver-side vehicle floor mat incorporating the design of my new invention;

FIG. 2 is a front elevational view thereof;

FIG. 3 is a right side elevational view thereof;

FIG. 4 is a rear elevational view thereof;

FIG. 5 is a left side elevational view thereof;

FIG. 6 is a bottom plan view thereof;

FIGS. 7 and 8 are cross-sectional views taken along lines 7—7 and 8—8, respectively, of FIG 1, depicting the contour of the top surface thereof;

FIG. 9 is a top plan view of a first embodiment of a passenger-side vehicle floor mat incorporating the design of my new invention.

The front elevational view of the first embodiment of the passenger-side vehicle floor mat is a mirror image of FIG. 2;

The right side elevational view of the first embodiment of the passenger-side vehicle floor mat is a mirror image of FIG. 5;

The rear elevational view of the first embodiment of the passenger-side vehicle floor mat is a mirror image of FIG. 4;

The left side elevational view of the first embodiment of the passenger-side vehicle floor mat is a mirror image of FIG. 3;

The bottom plan view of the first embodiment of the passenger-side vehicle floor mat is a mirror image of FIG. 6;

FIG. 10 is a cross-sectional view of the first embodiment of the passenger-side vehicle floor mat taken along line 10—10 of FIG. 9, and is a mirror image of FIG. 7;

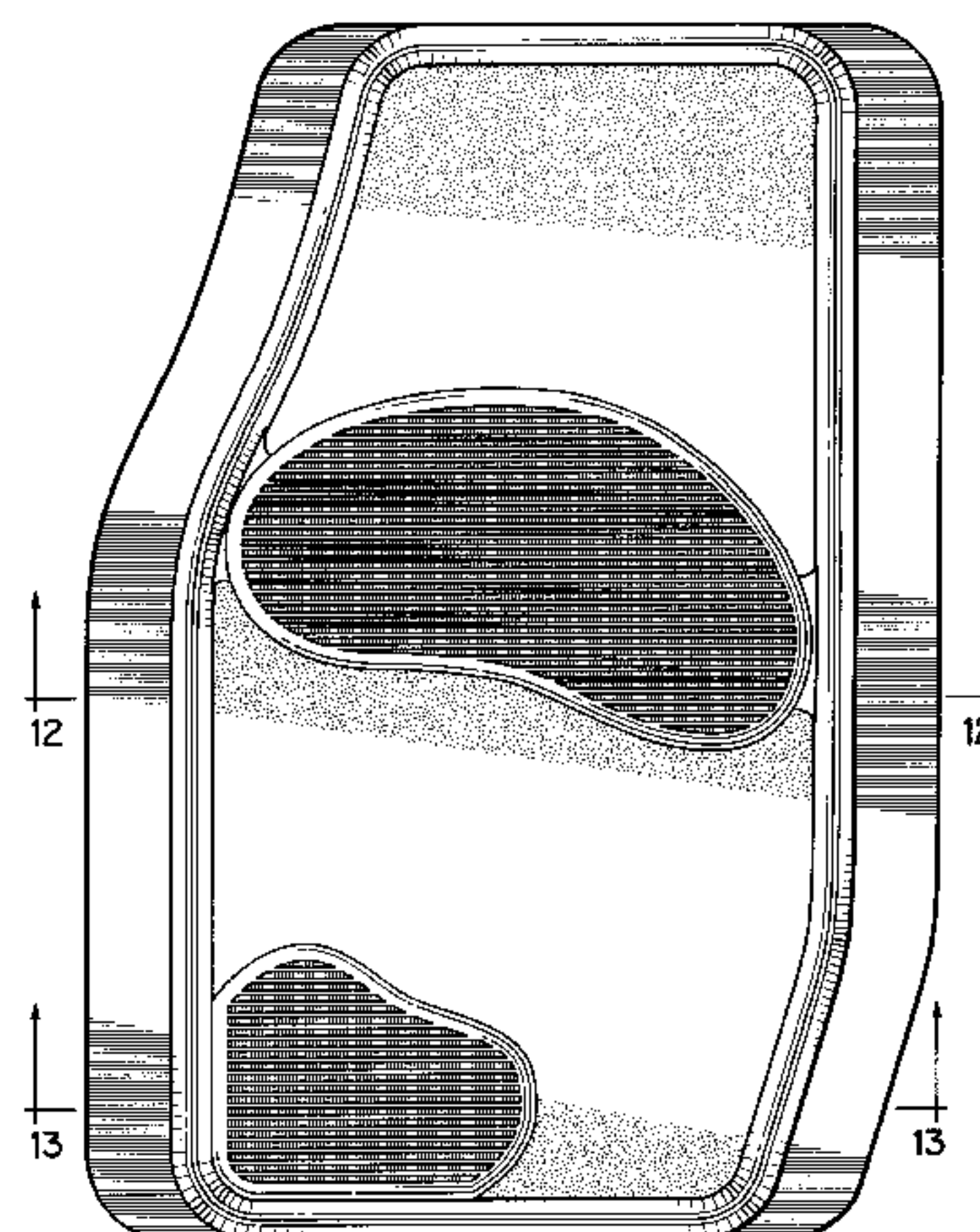
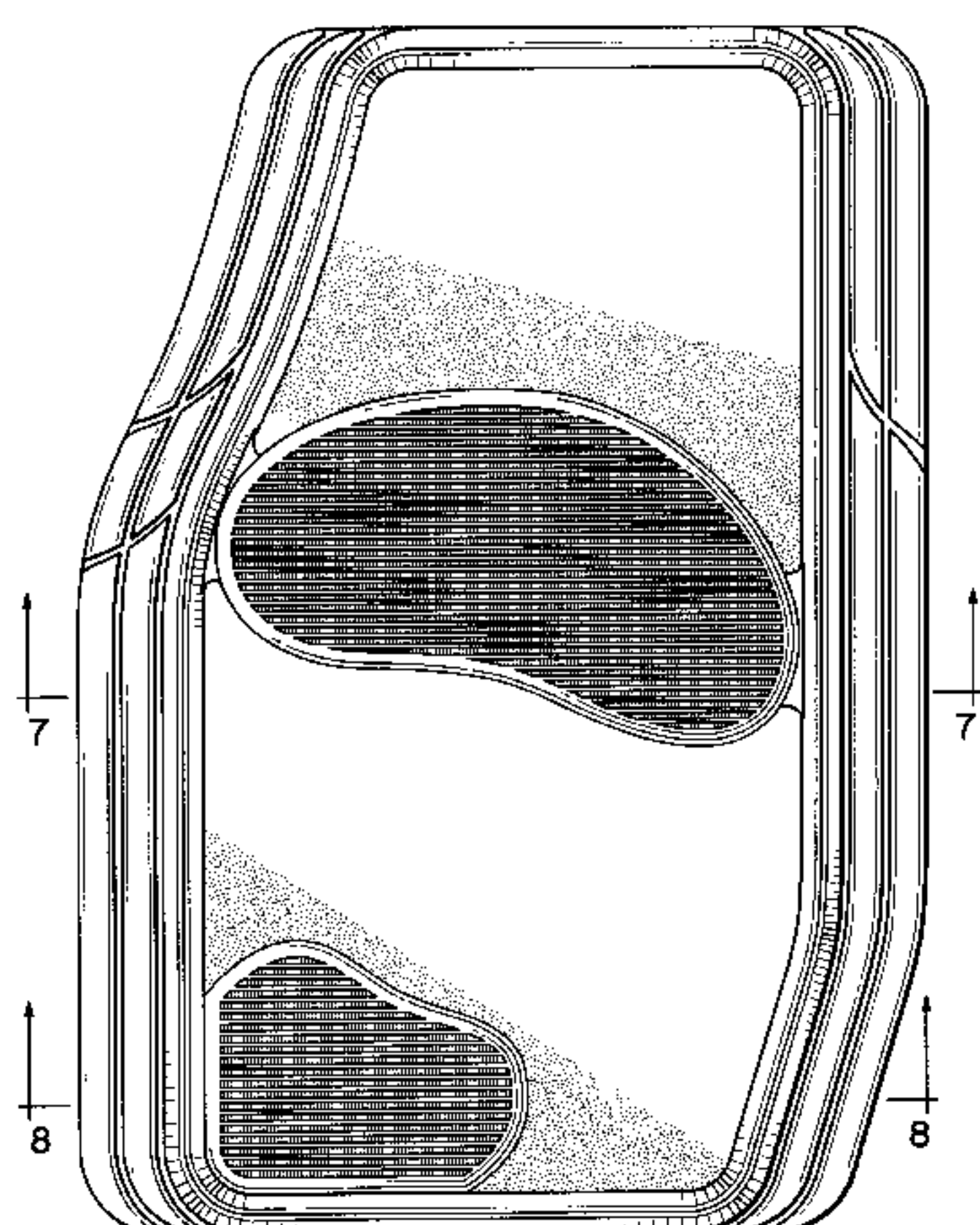
FIG. 11 is a top plan view of a second embodiment of a driver-side vehicle floor mat incorporating the design of my new invention;

FIGS. 12 and 13 are cross-sectional views of the second embodiment of the driver-side vehicle floor mat taken along lines 12—12 and 13—13, respectively, of FIG 11;

FIGS. 14, 15, 16, and 17, respectively, are front elevational, right side elevational, rear elevational, and left side elevational views of the second embodiment of the driver-side vehicle floor mat;

The bottom plan view of the second embodiment of the driver-side vehicle floor mat is identical to FIG. 6;

FIG. 18 is a top plan view of a second embodiment of a passenger-side vehicle floor mat incorporating the design of my new invention; and,



The front elevational view of the second embodiment of the passenger-side vehicle floor mat is a mirror image of FIG. **14**;

The right side elevational view of the second embodiment of the passenger-side vehicle floor mat is a mirror image of FIG. **17**;

The rear elevational view of the second embodiment of the passenger-side vehicle floor mat is a mirror image of FIG. **16**;

The left side elevational view of the second embodiment of the passenger-side vehicle floor mat is a mirror image of FIG. **15**;

The bottom plan view of the second embodiment of the passenger-side vehicle floor mat is a mirror image of FIG. **6**; FIG. **19** is a cross-sectional view of the second embodiment of the passenger-side vehicle floor mat taken along line **19—19** of FIG. **18**, and is a mirror image of FIG. **12**;

The stippled shading shown on the body of the MAT is understood to represent surface shading, and does not indicate a pattern.

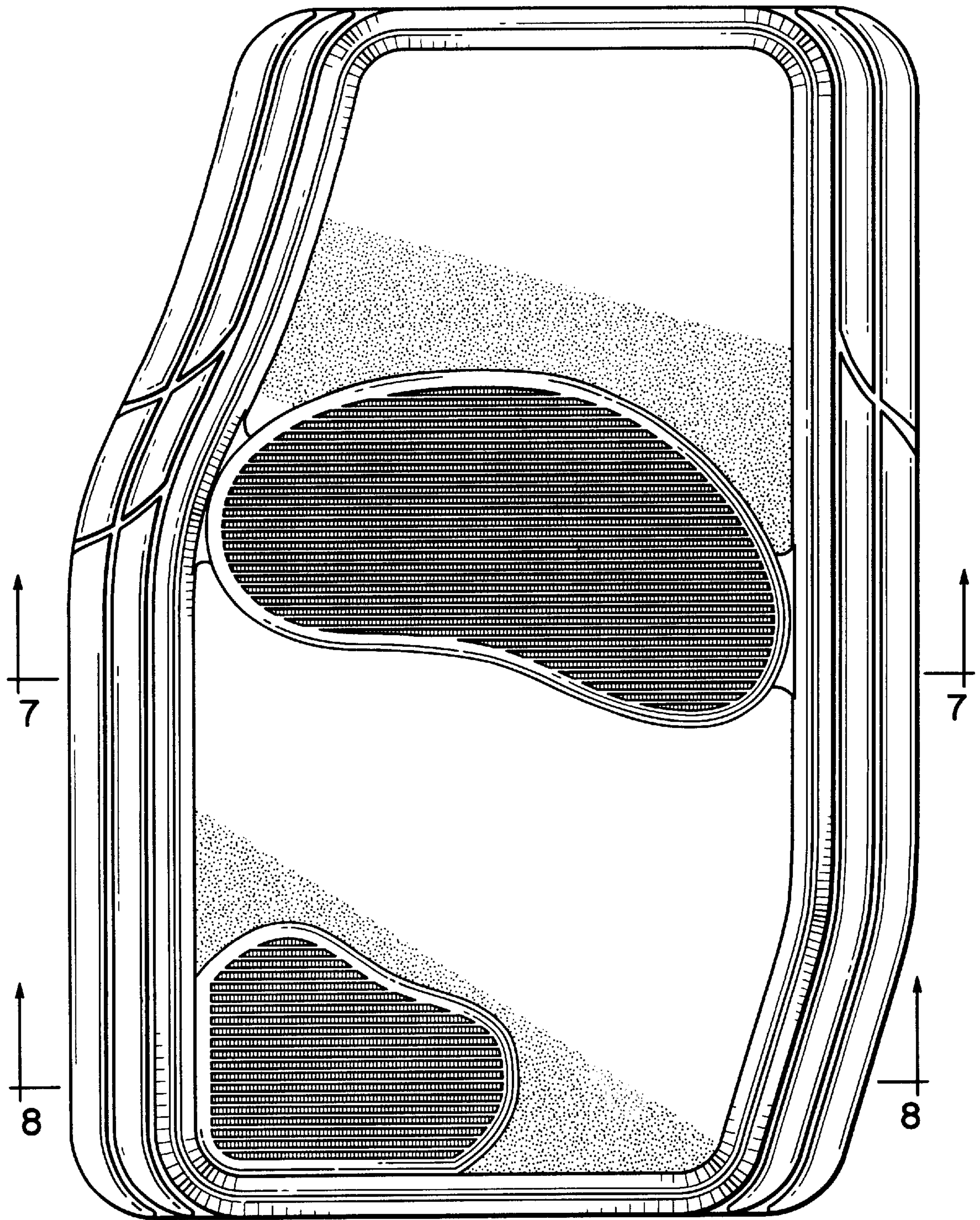

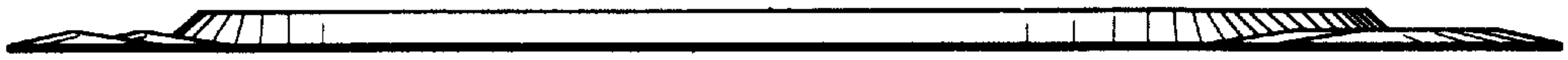

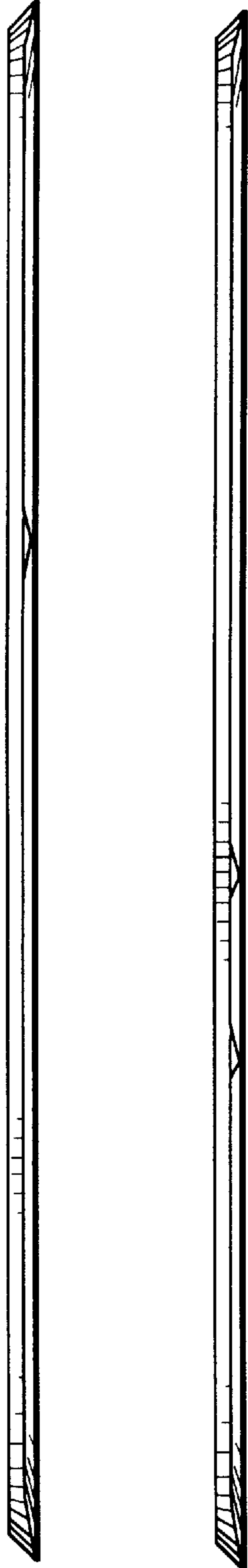


FIG. 3 FIG. 5

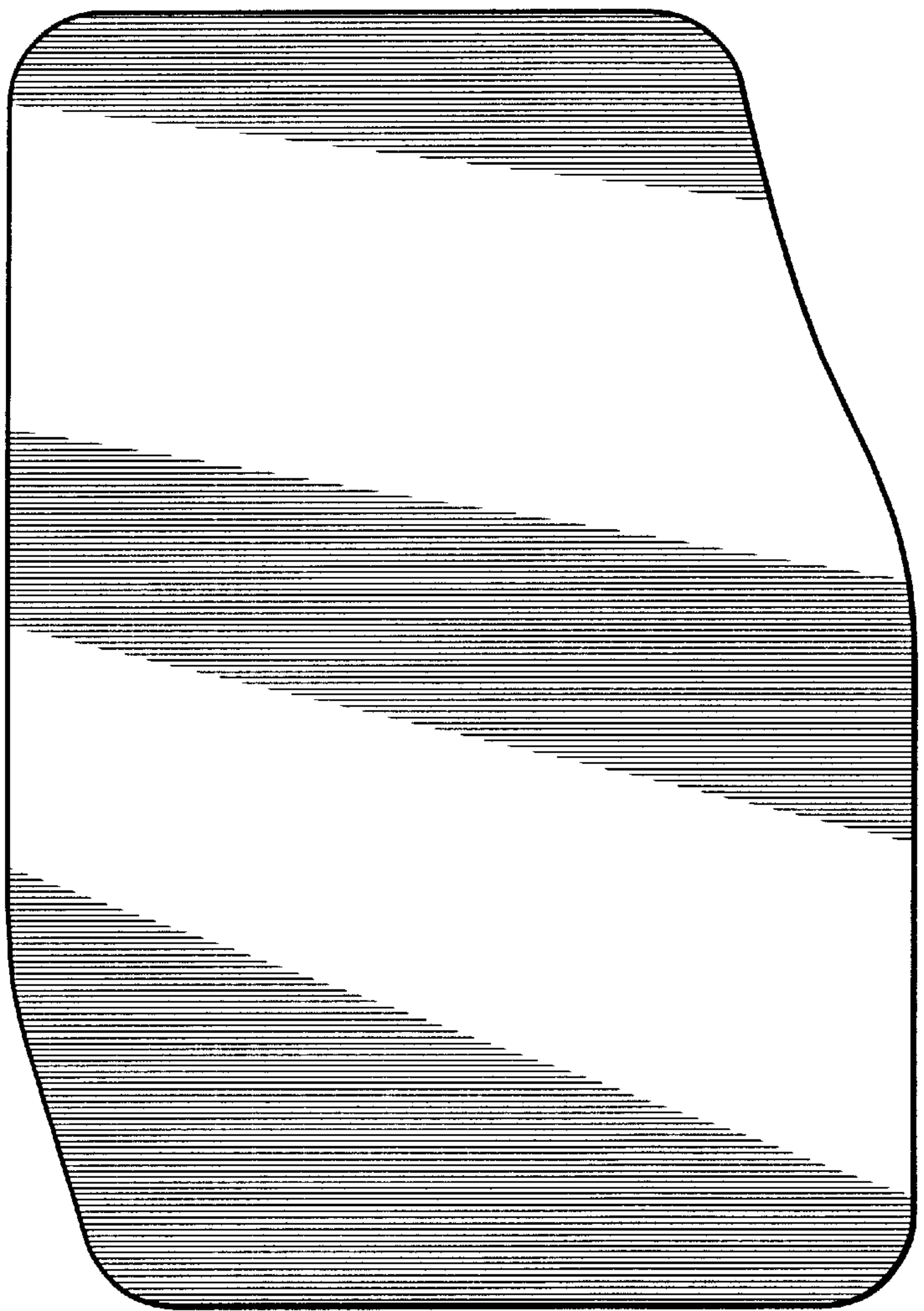

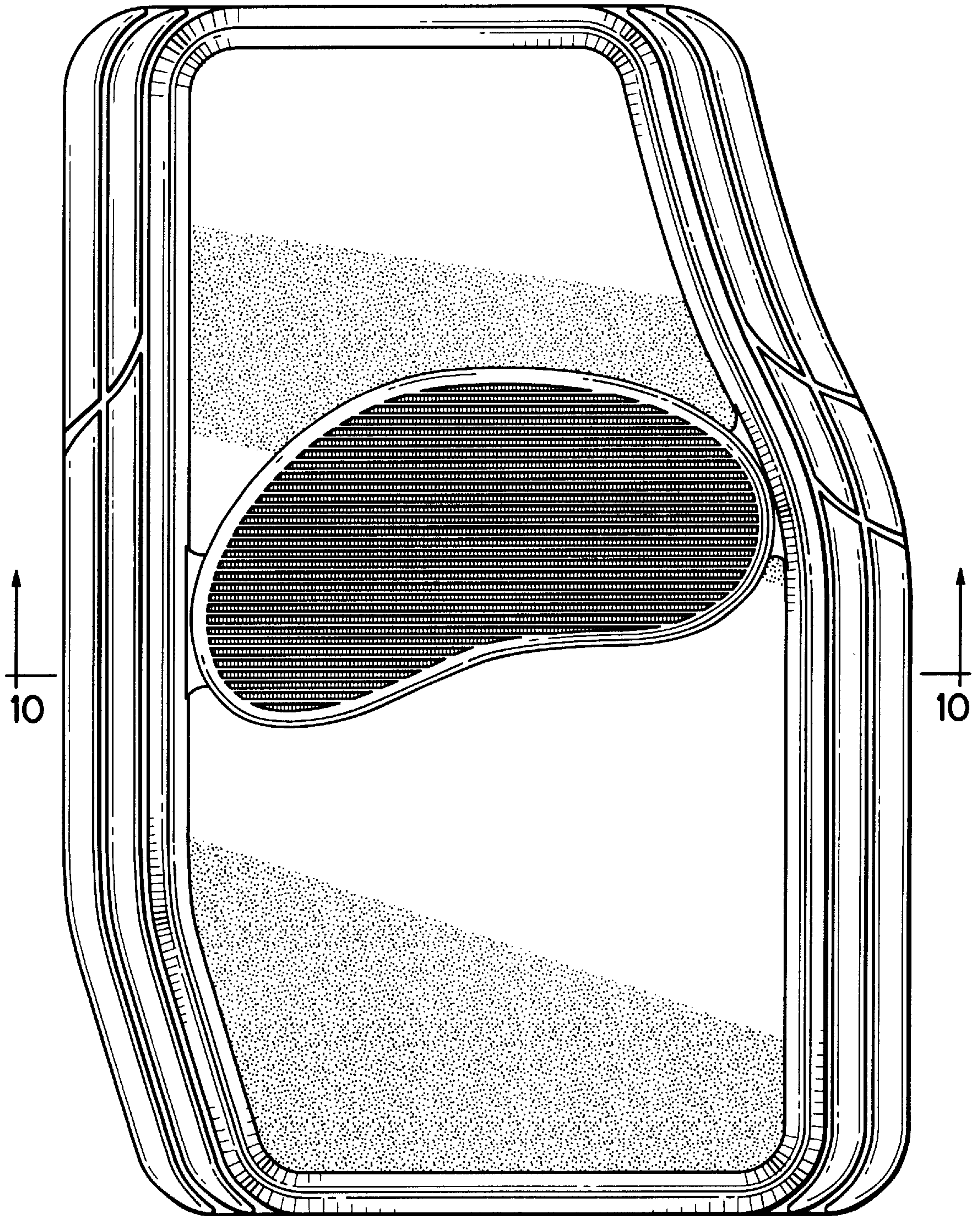

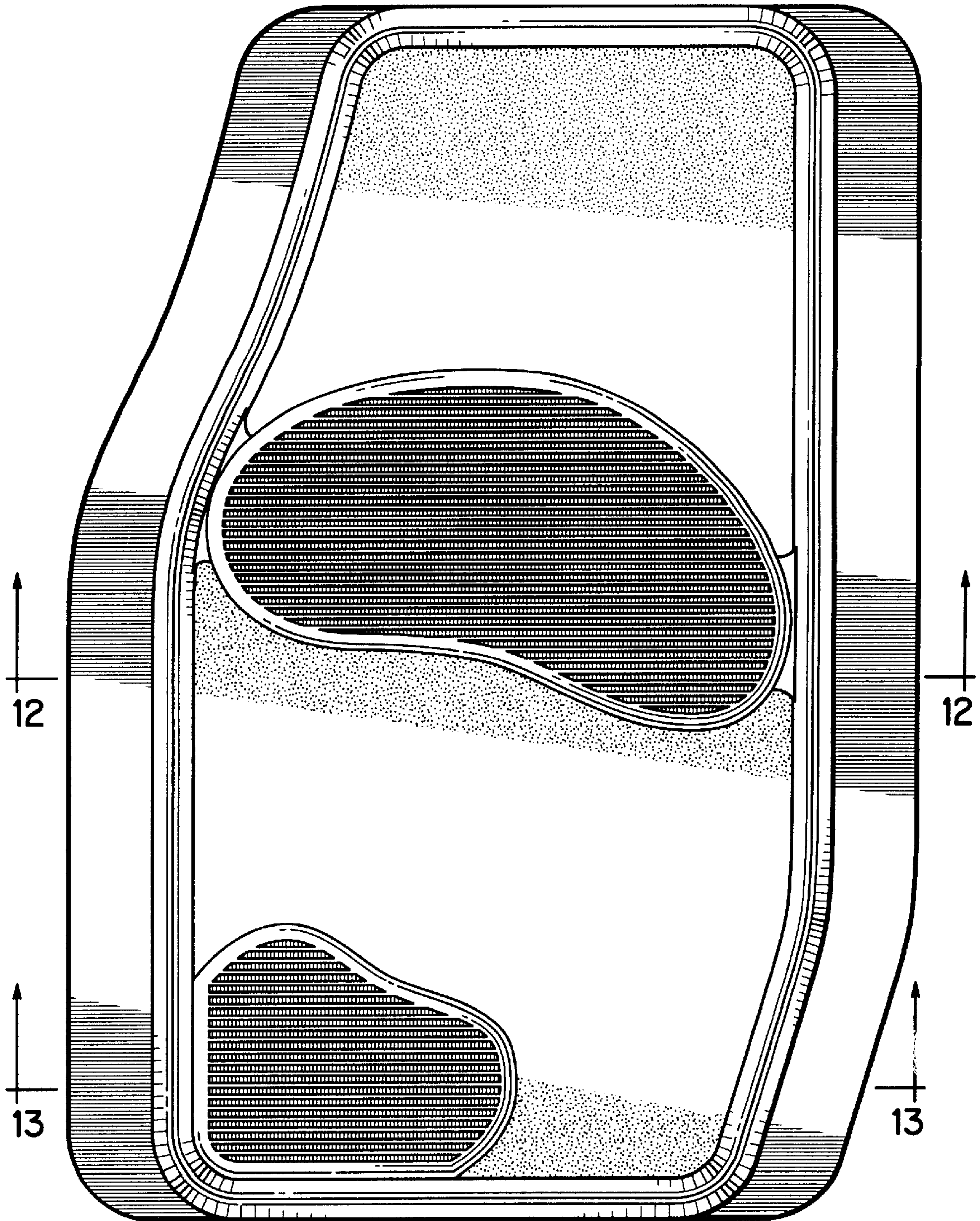

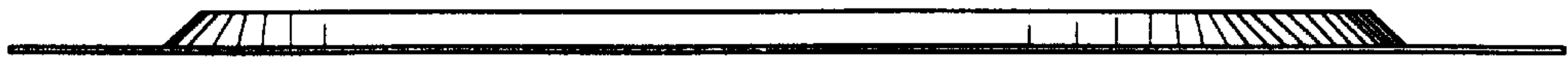

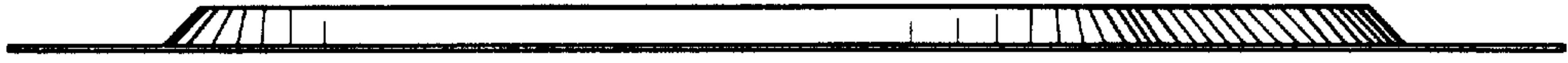

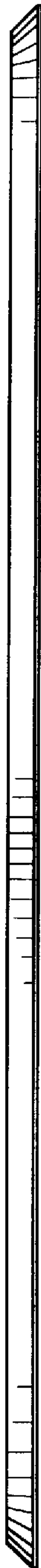

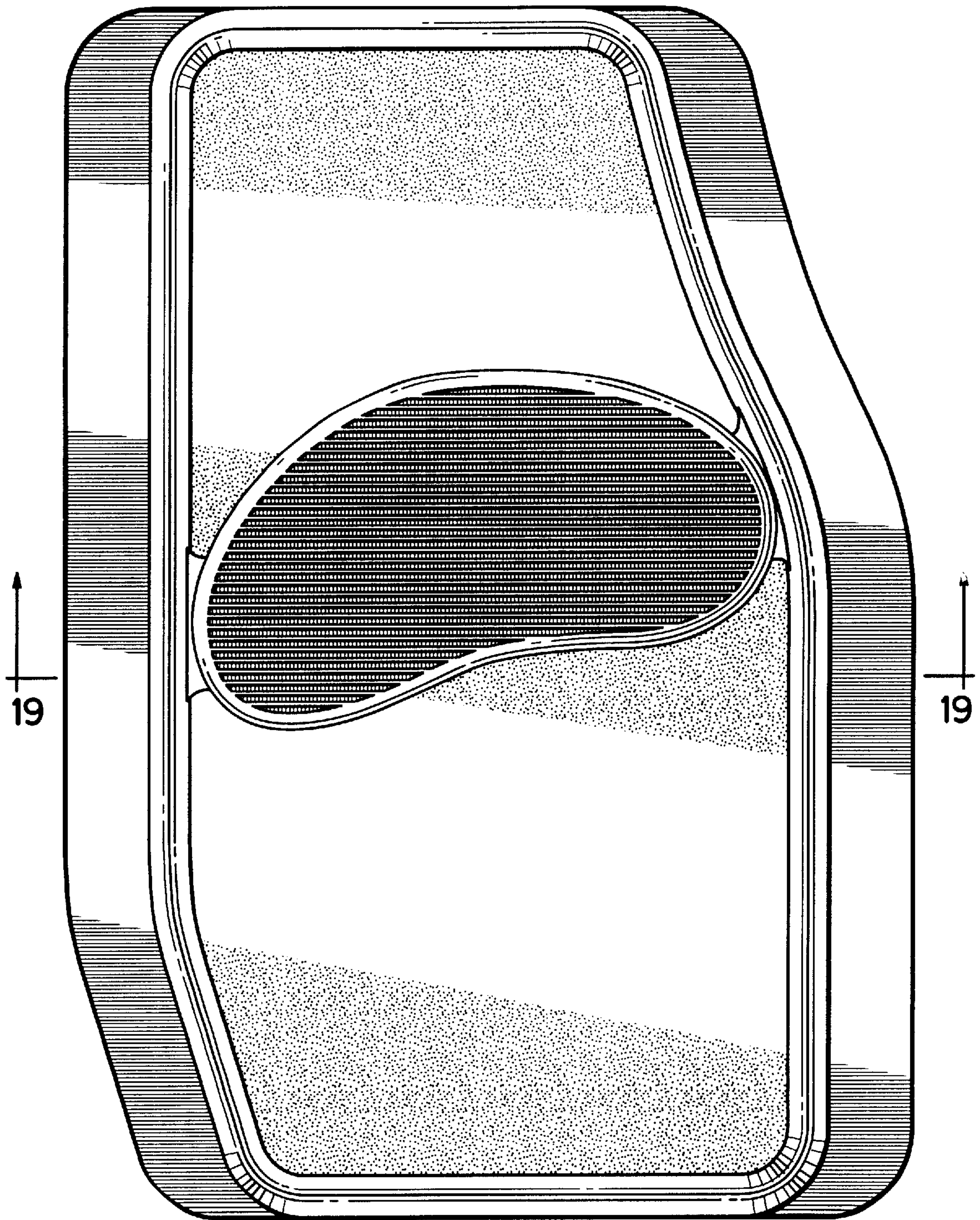
