(57) **CLAIM**

The ornamental design for a memo and pen holder, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a first embodiment of the memo and pen holder of the present invention showing my new design;

FIG. 2 is a right side elevational view of the memo and pen holder of FIG. 1, the left side elevational view being a mirror image thereof;

FIG. 3 is a bottom plan view of the memo and pen holder of FIG. 1;

FIG. 4 is a top plan view of the memo and pen holder of FIG. 1;

FIG. 5 is a front elevational view of the memo and pen holder of FIG. 1;

FIG. 6 is a perspective view of a second embodiment of the memo and pen holder of the present invention showing my new design;

FIG. 7 is a right side elevational view of the memo and pen holder of FIG. 6, the left side elevational view being a mirror image thereof;

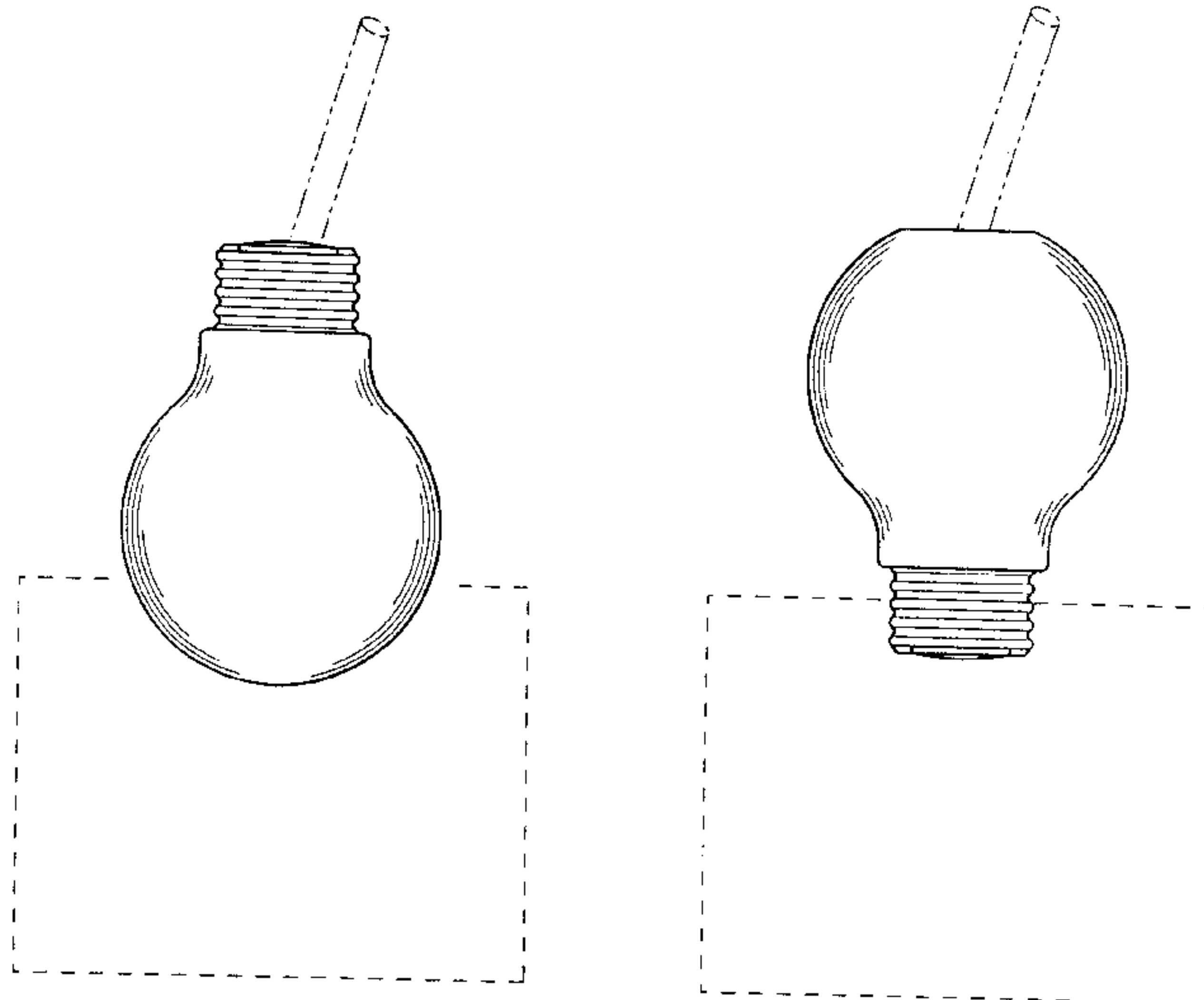
FIG. 8 is a bottom plan view of the memo and pen holder of FIG. 6;

FIG. 9 is a top plan view of the memo and pen holder of FIG. 6; and,

FIG. 10 is a front elevational view of the memo and pen holder of FIG. 6.

The rear elevational view of each embodiment is unornamental and forms no part of the claimed design. Subject matter shown in dashed lines in FIGS. 5 and 10 represents an environment in which the invention may be used, but forms no part of the claimed design.

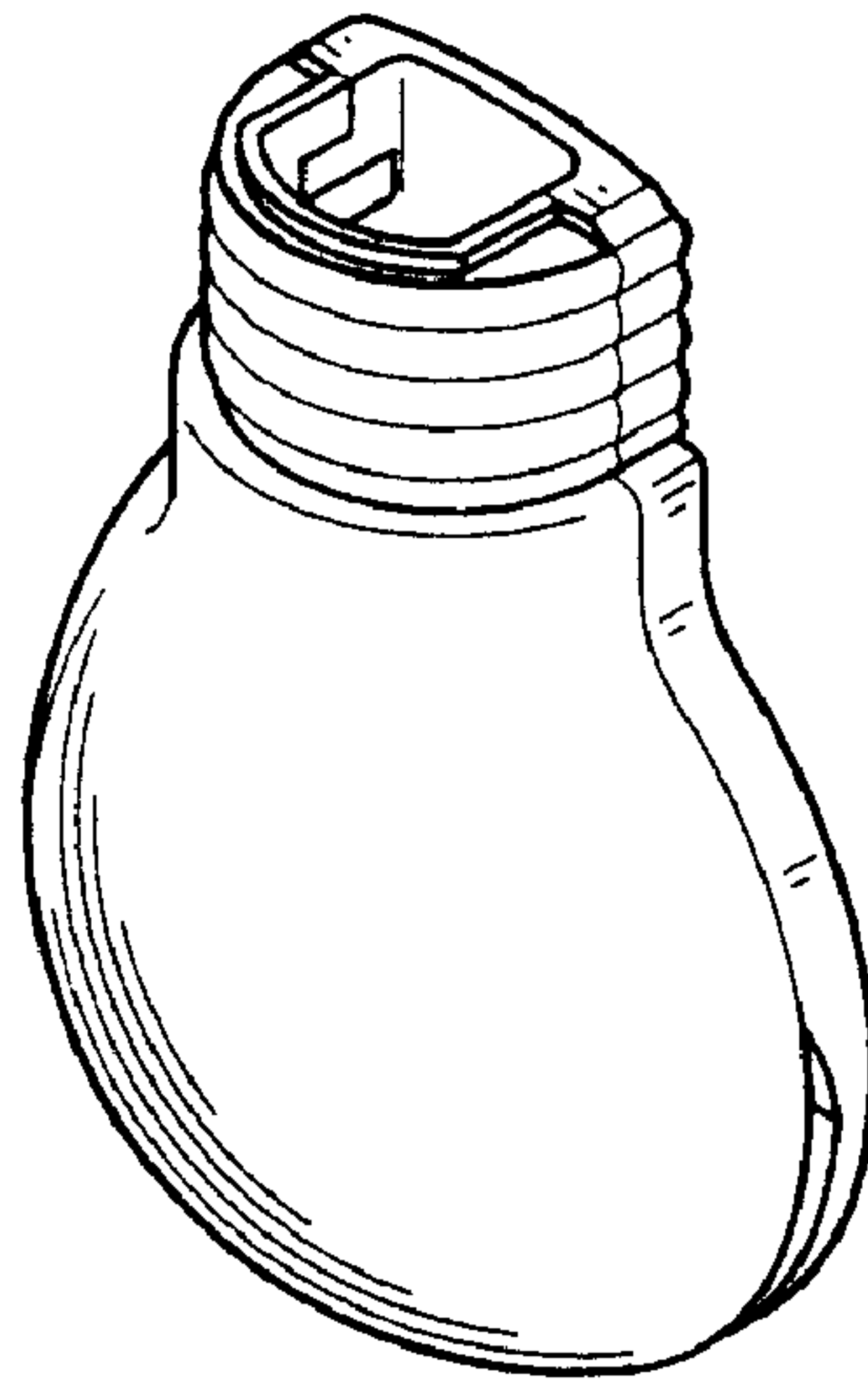

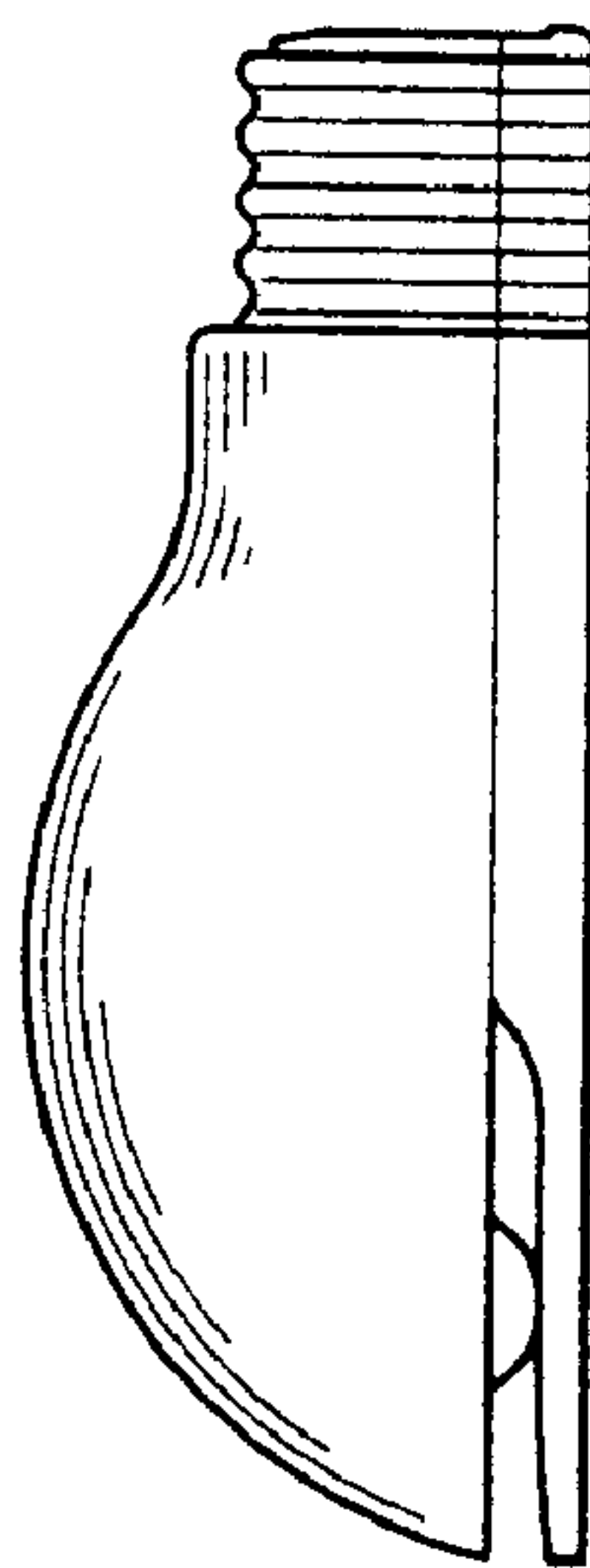

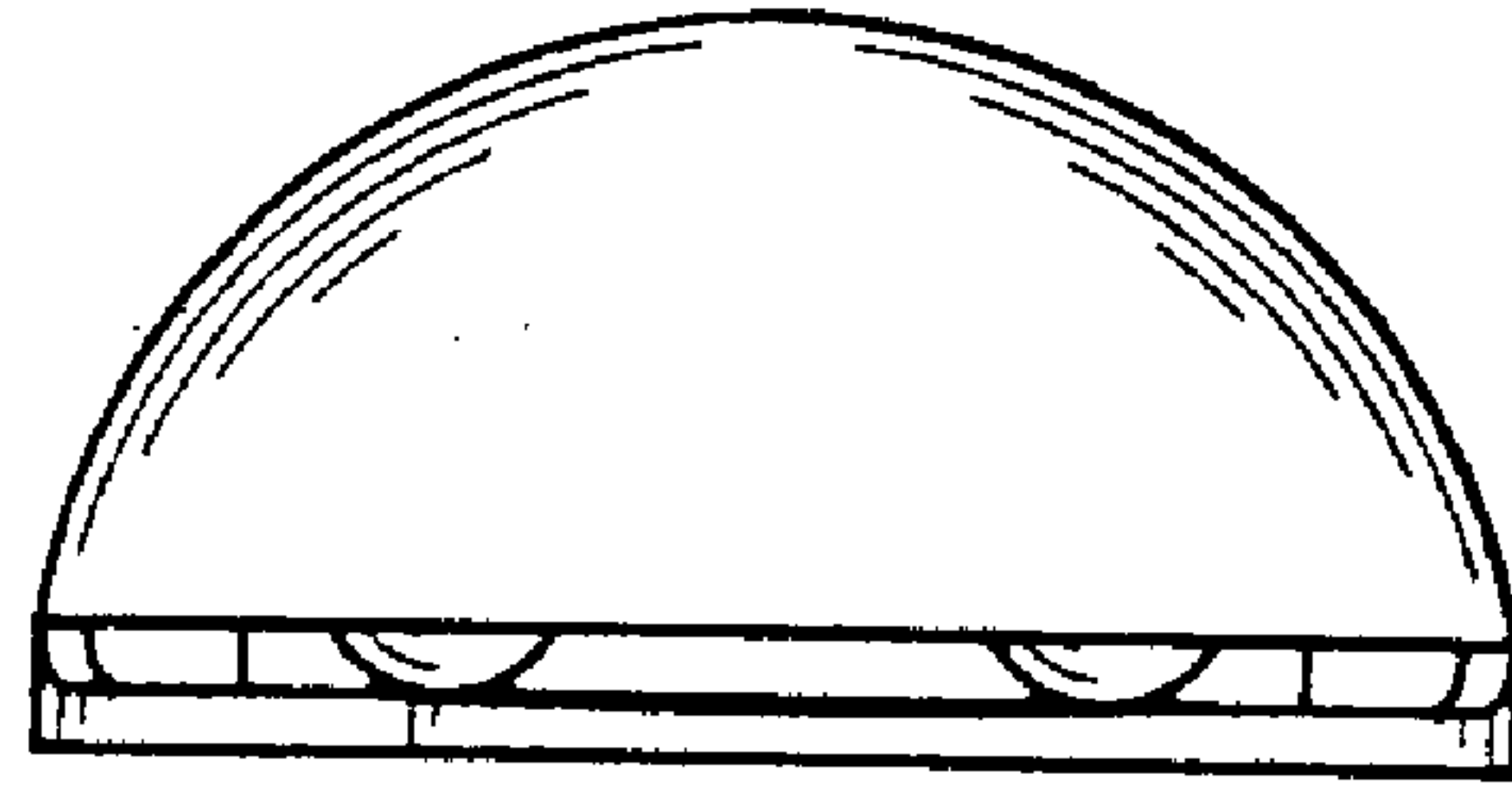

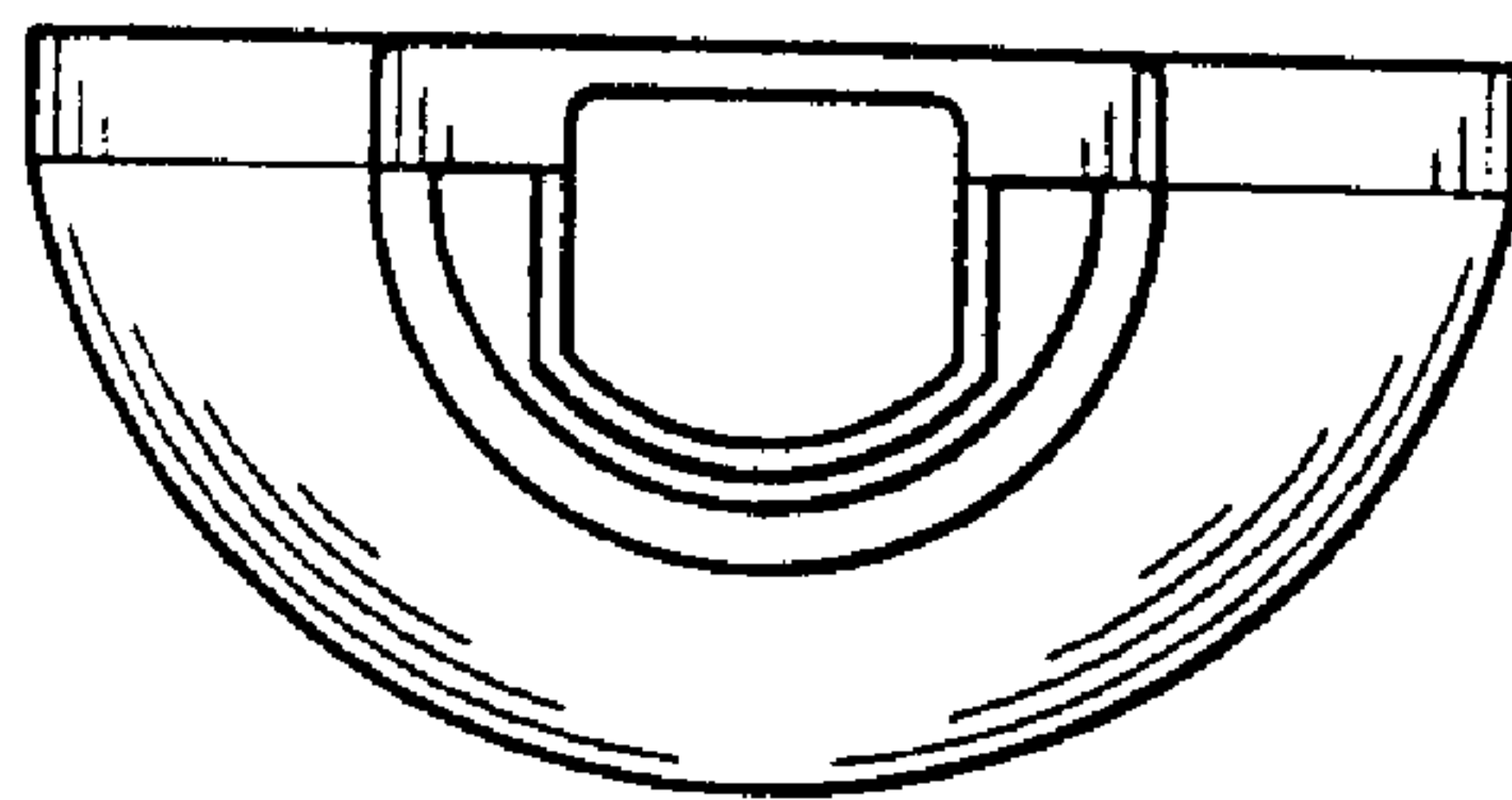

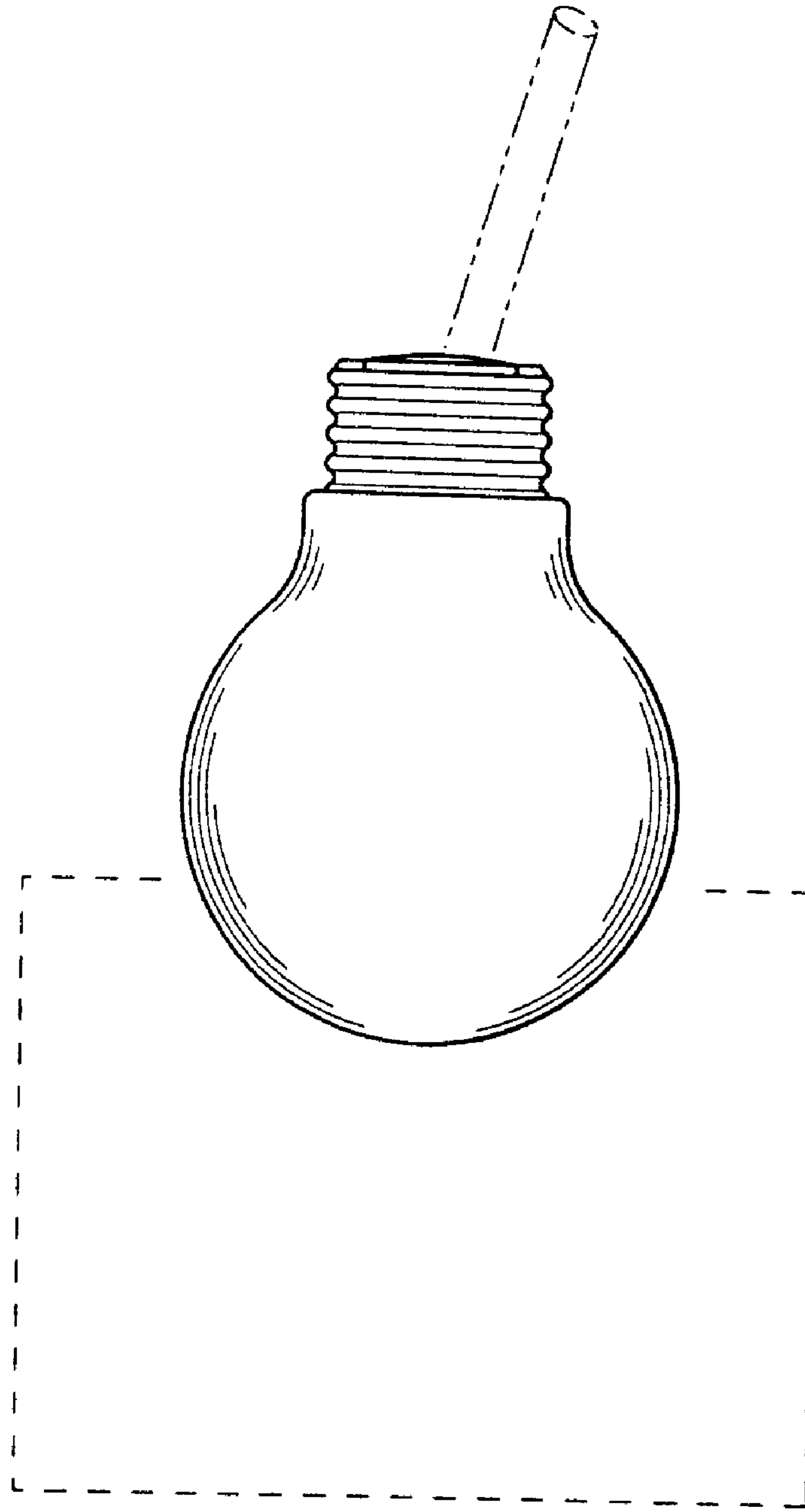

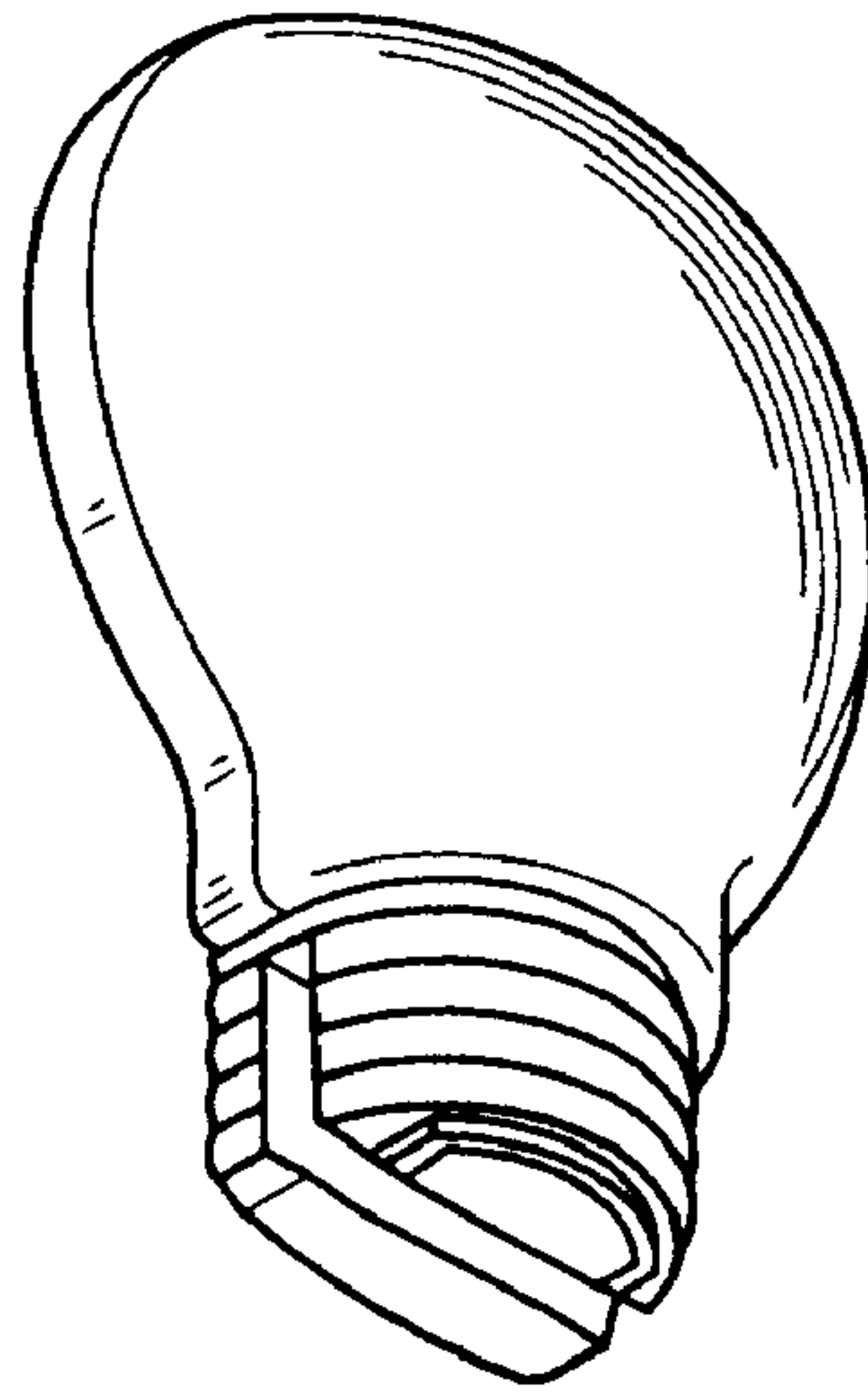

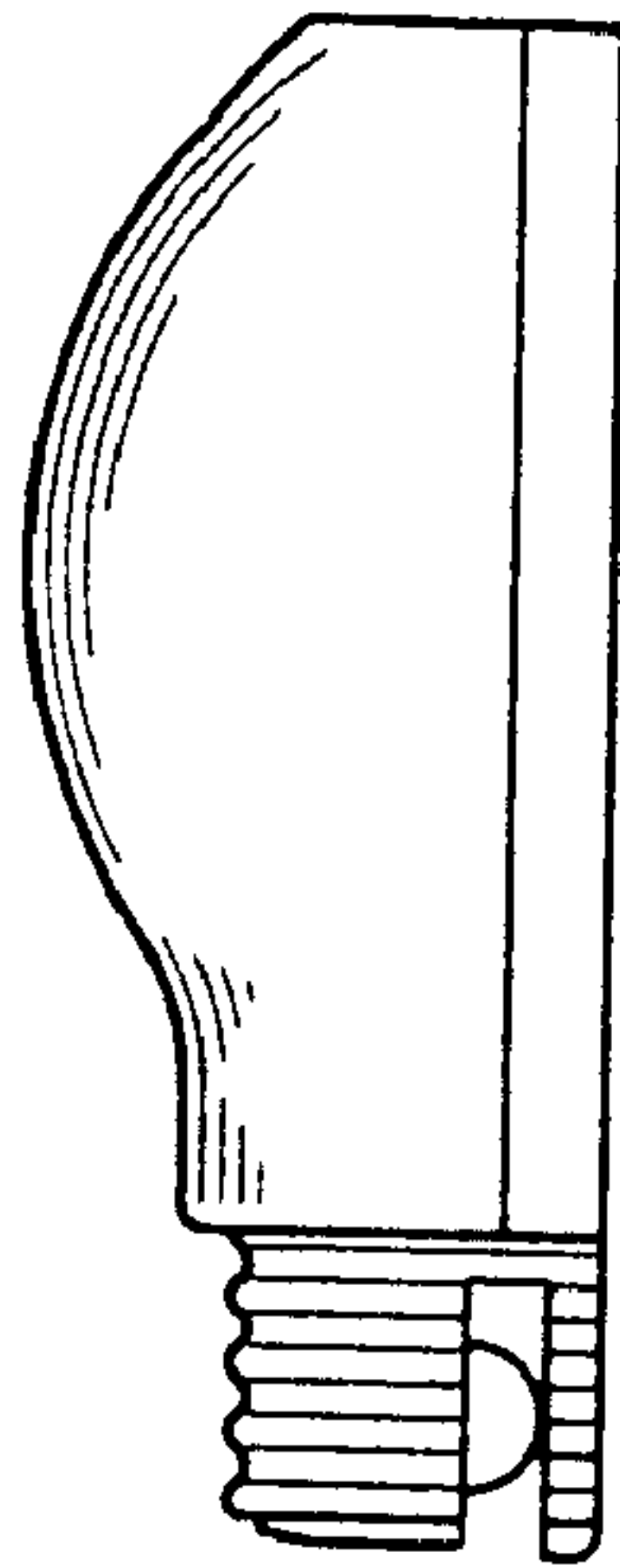

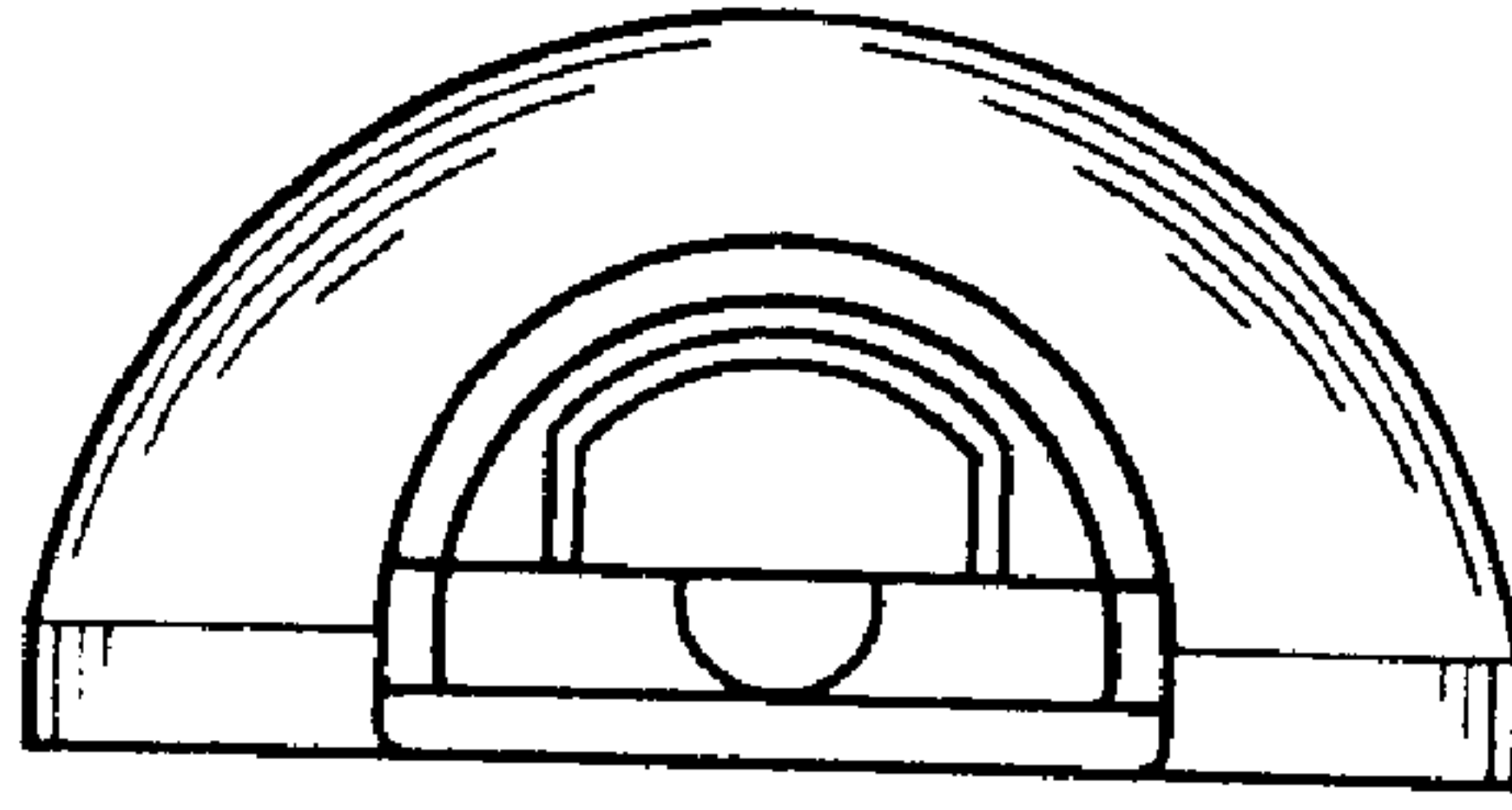

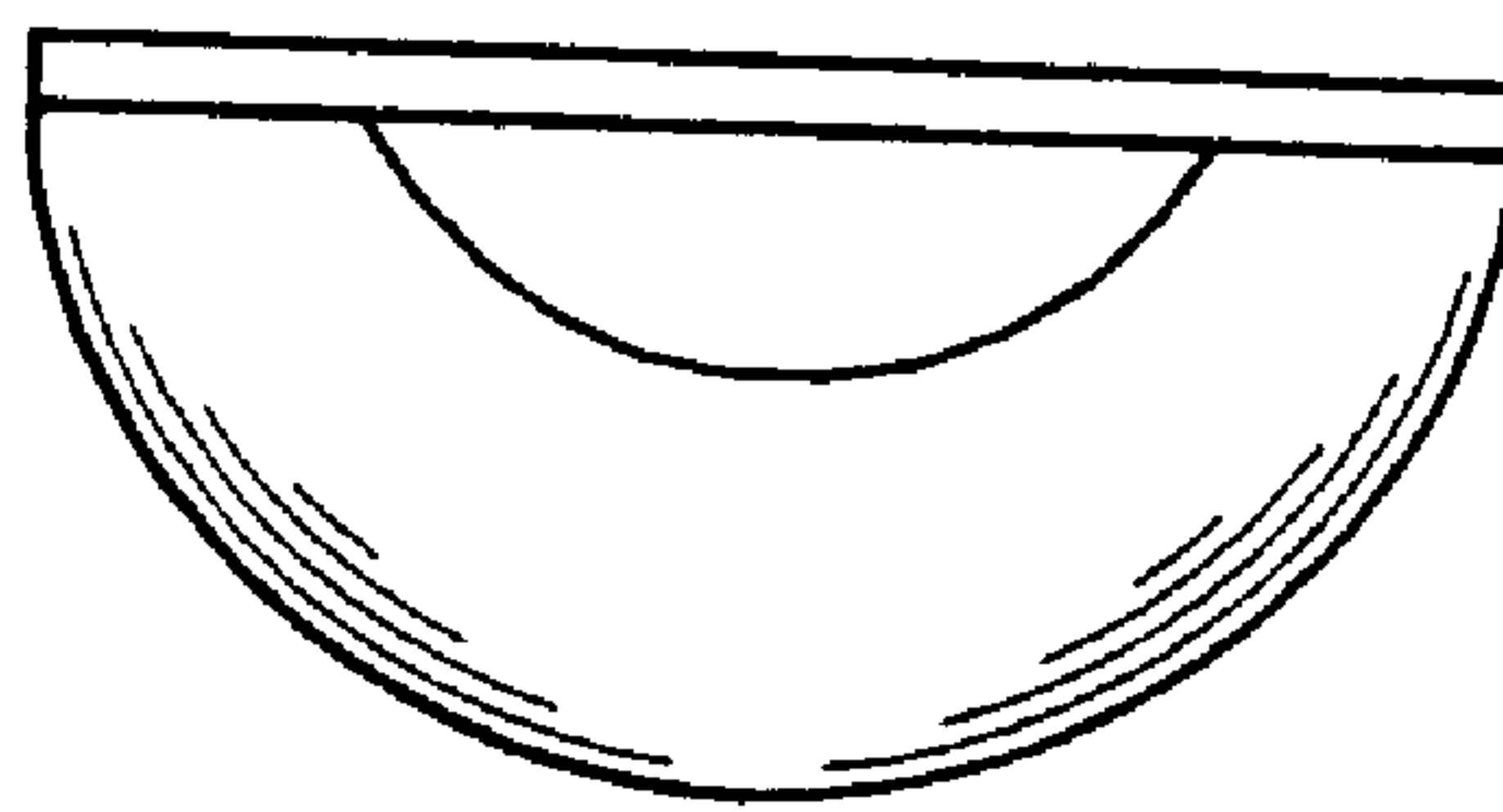

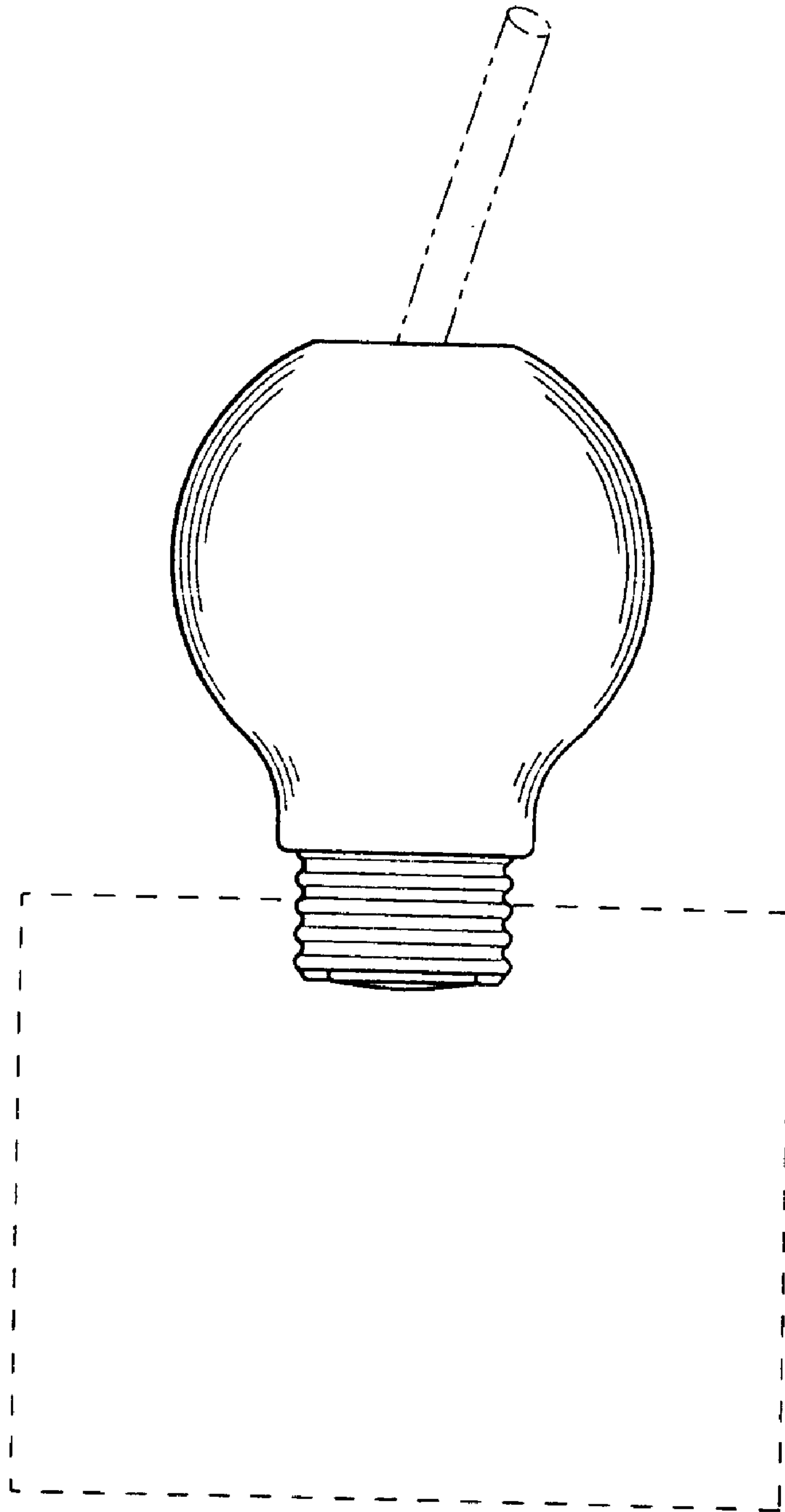
