**DESCRIPTION**

showing my new design, the bold broken lines representing  
environment and forming no part of the claimed design;

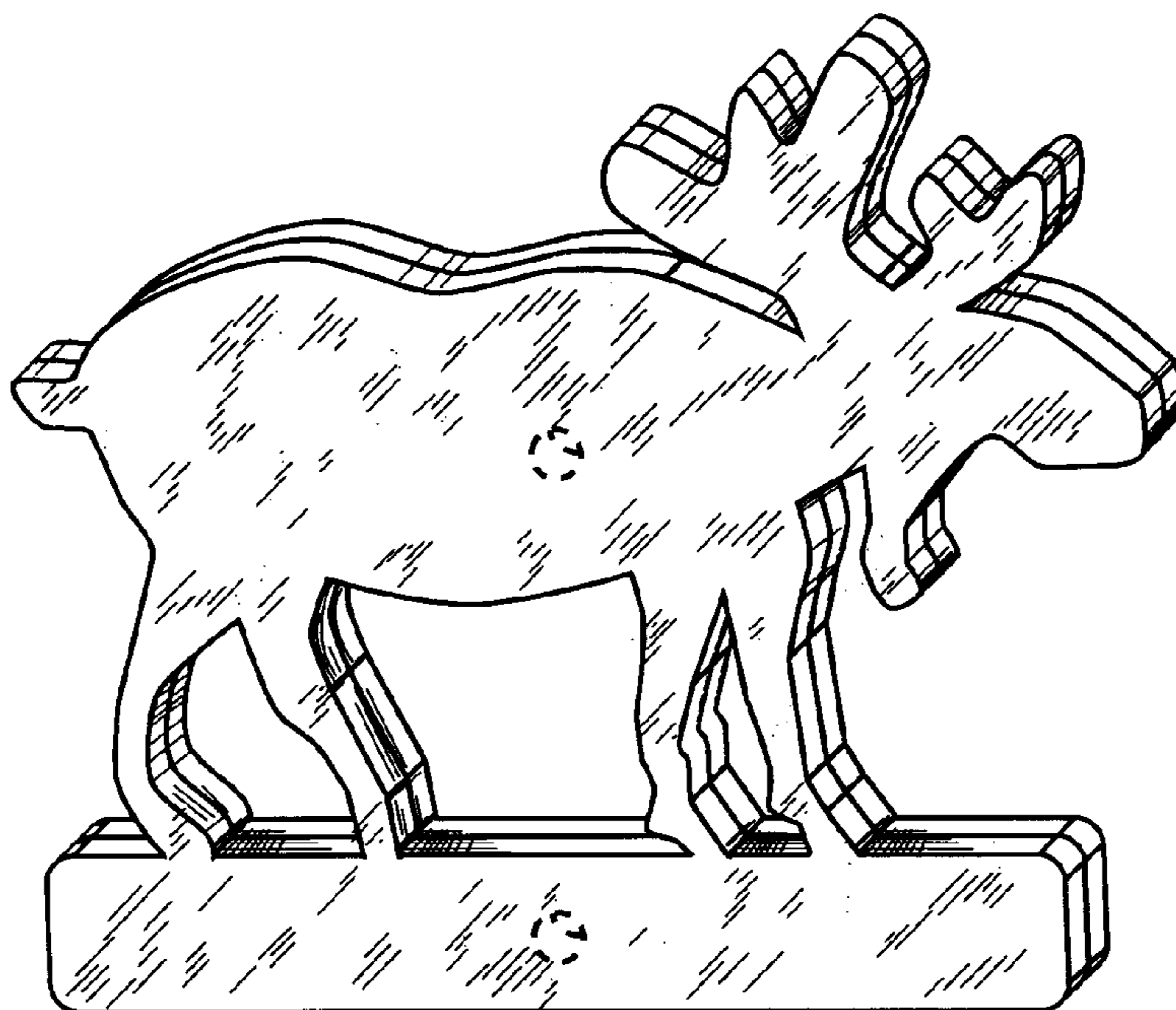

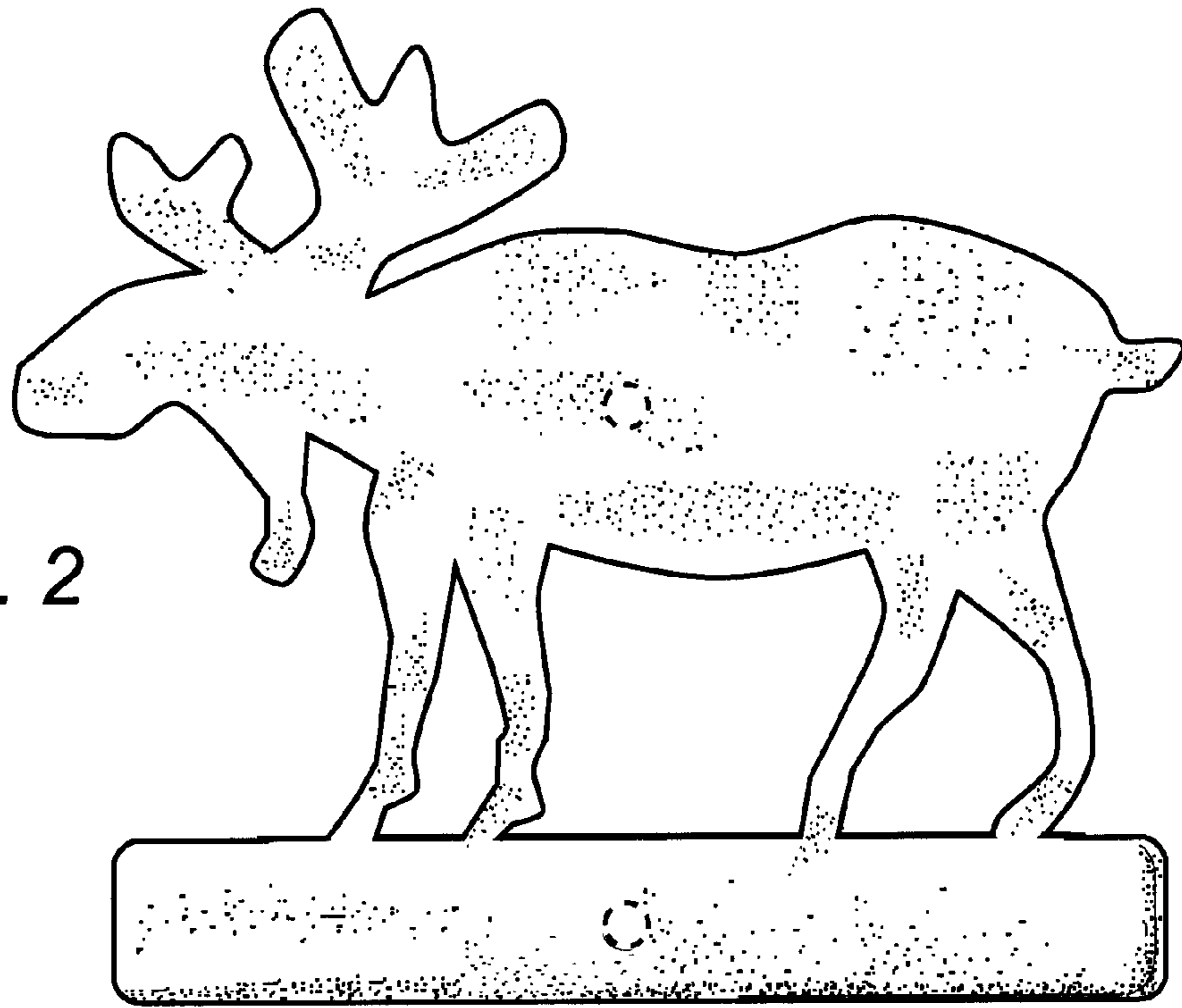
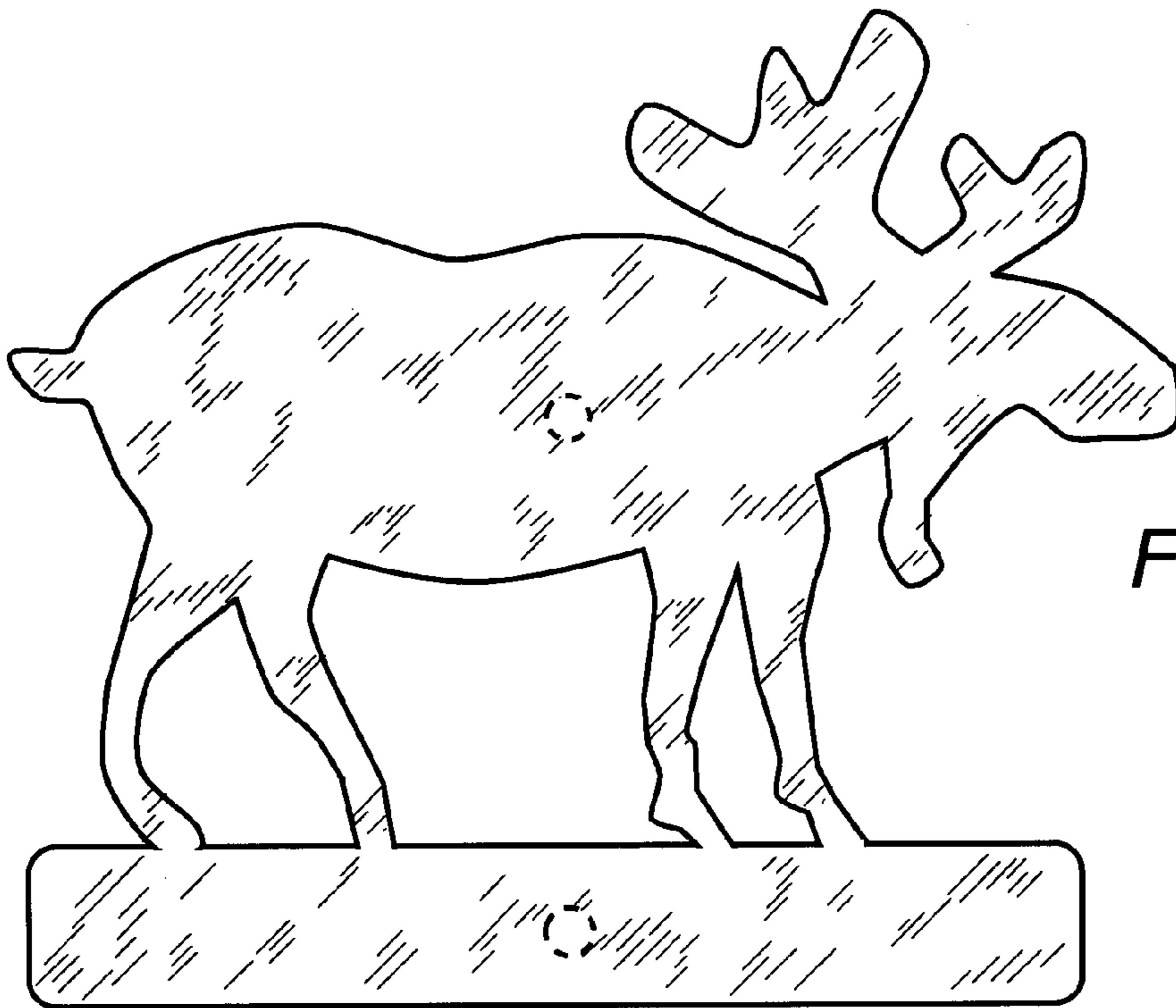

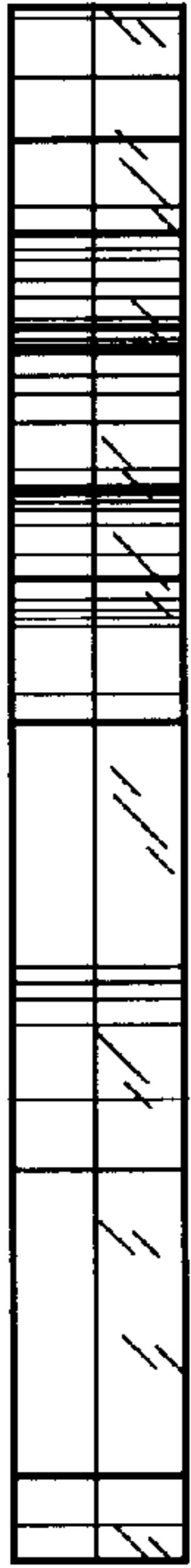

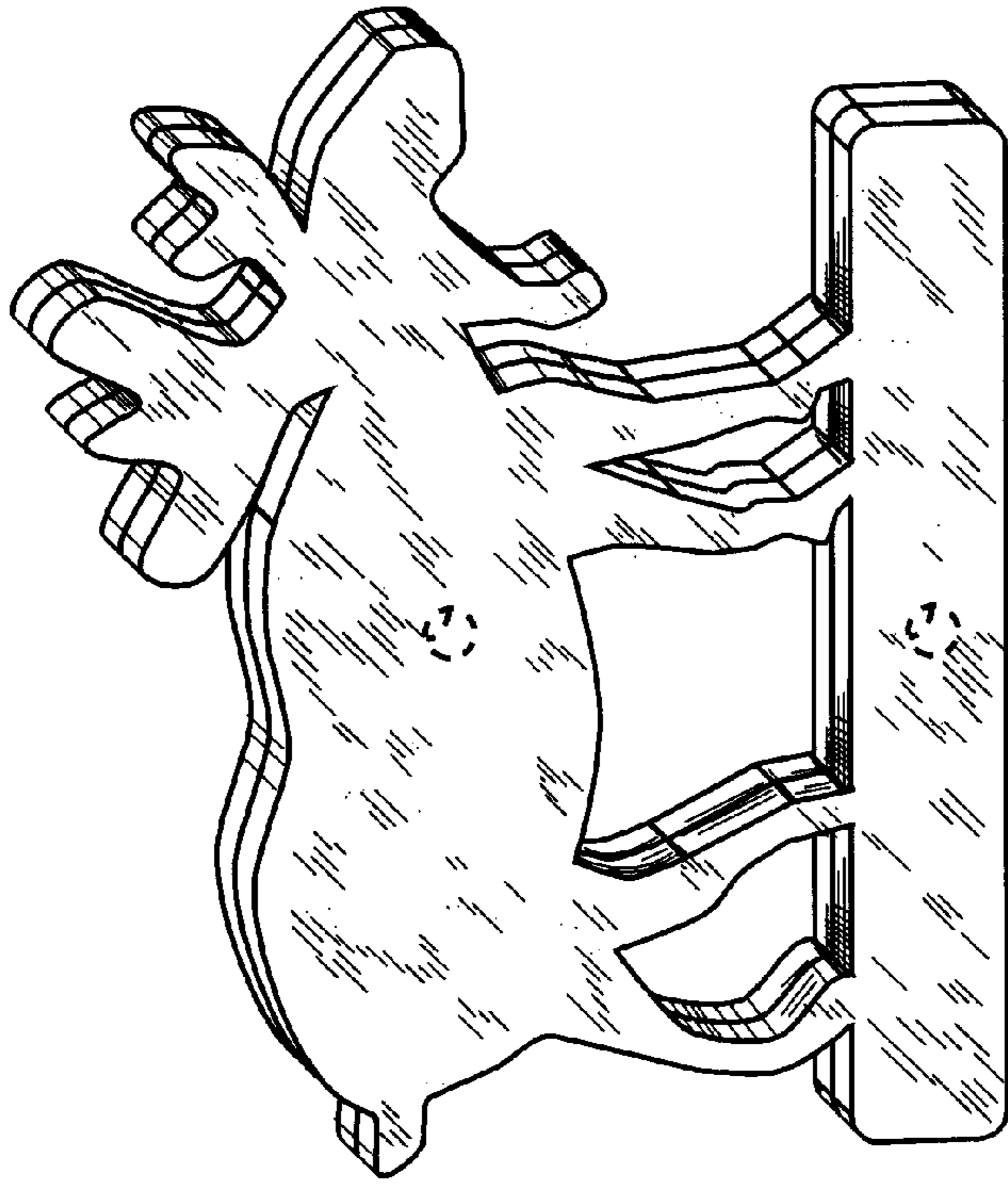

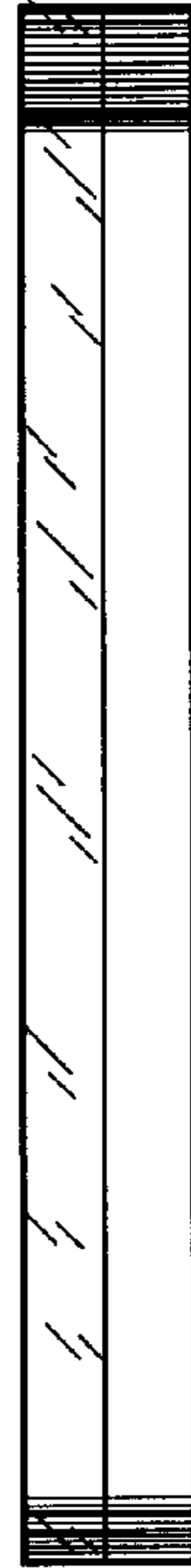
