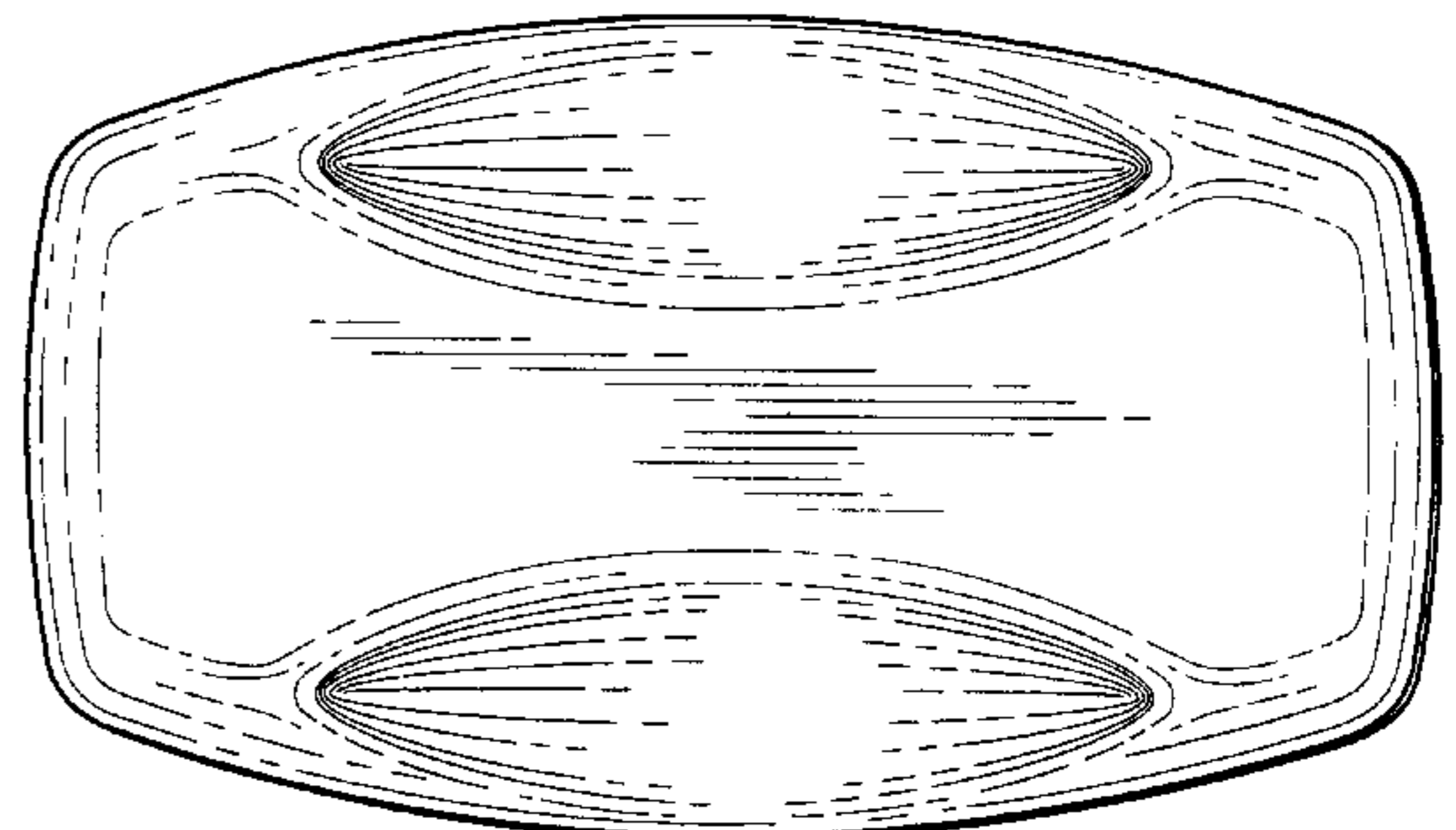
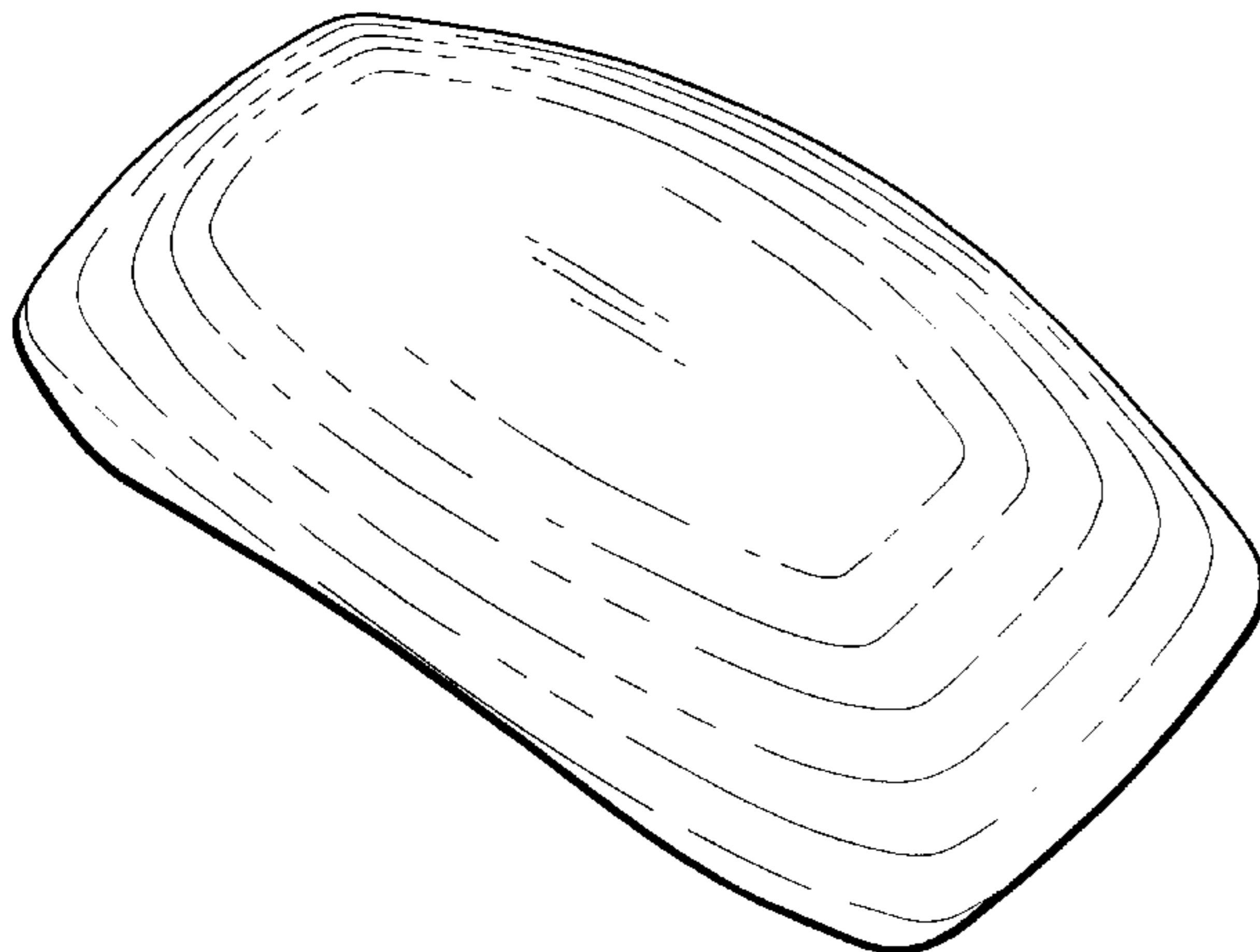
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a perspective view from the top of a soap bar showing my new design;

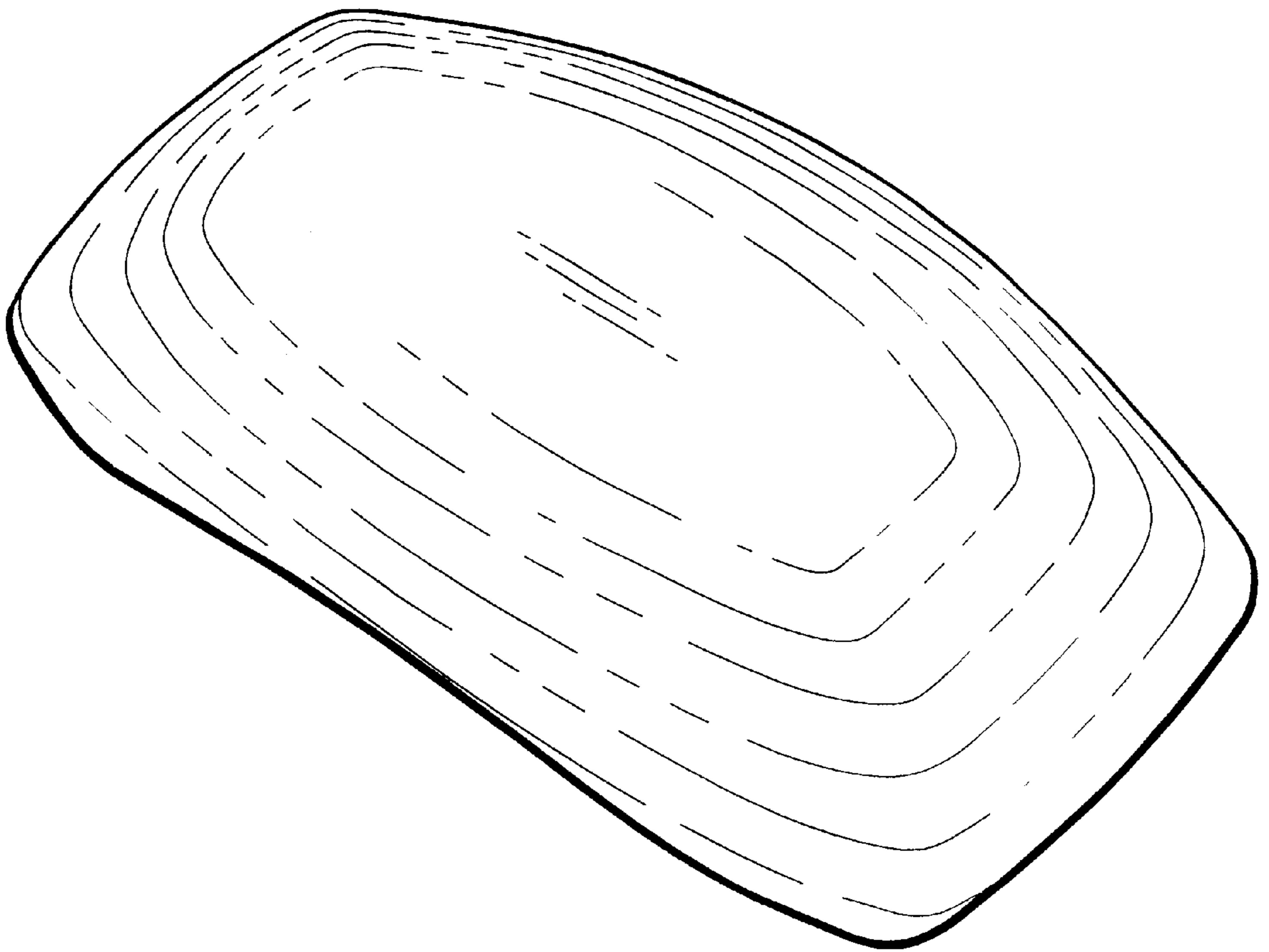

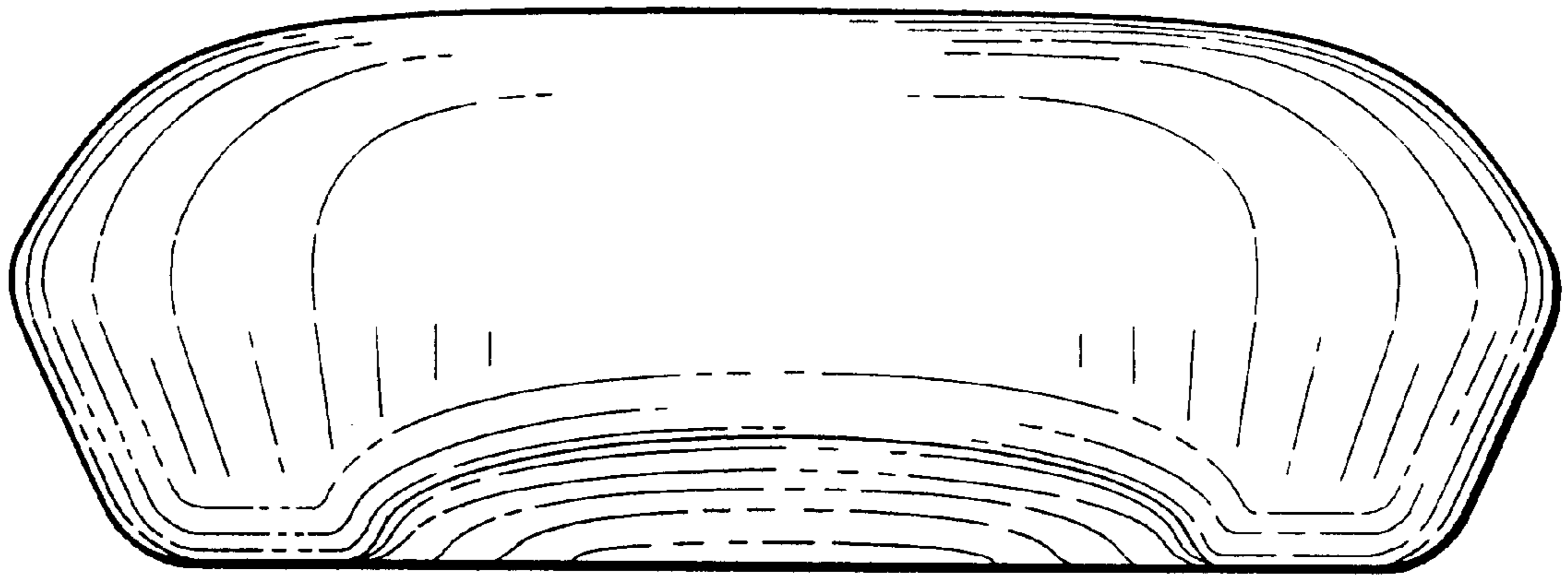

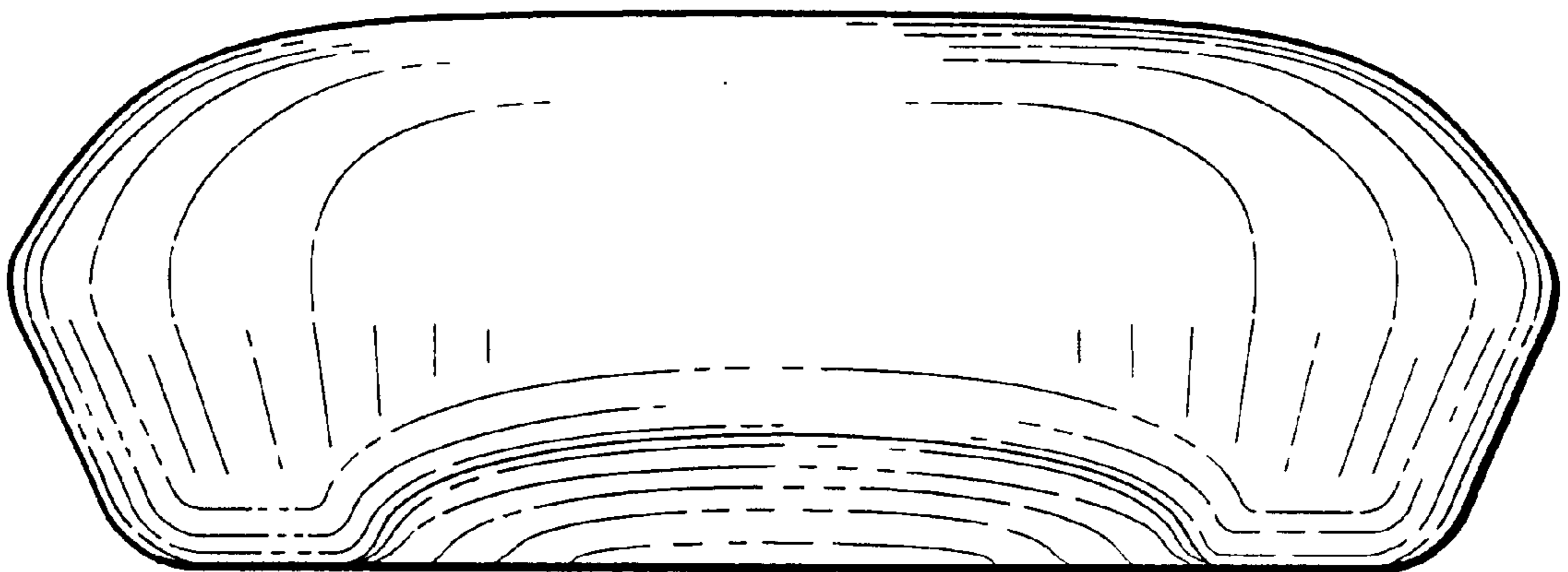

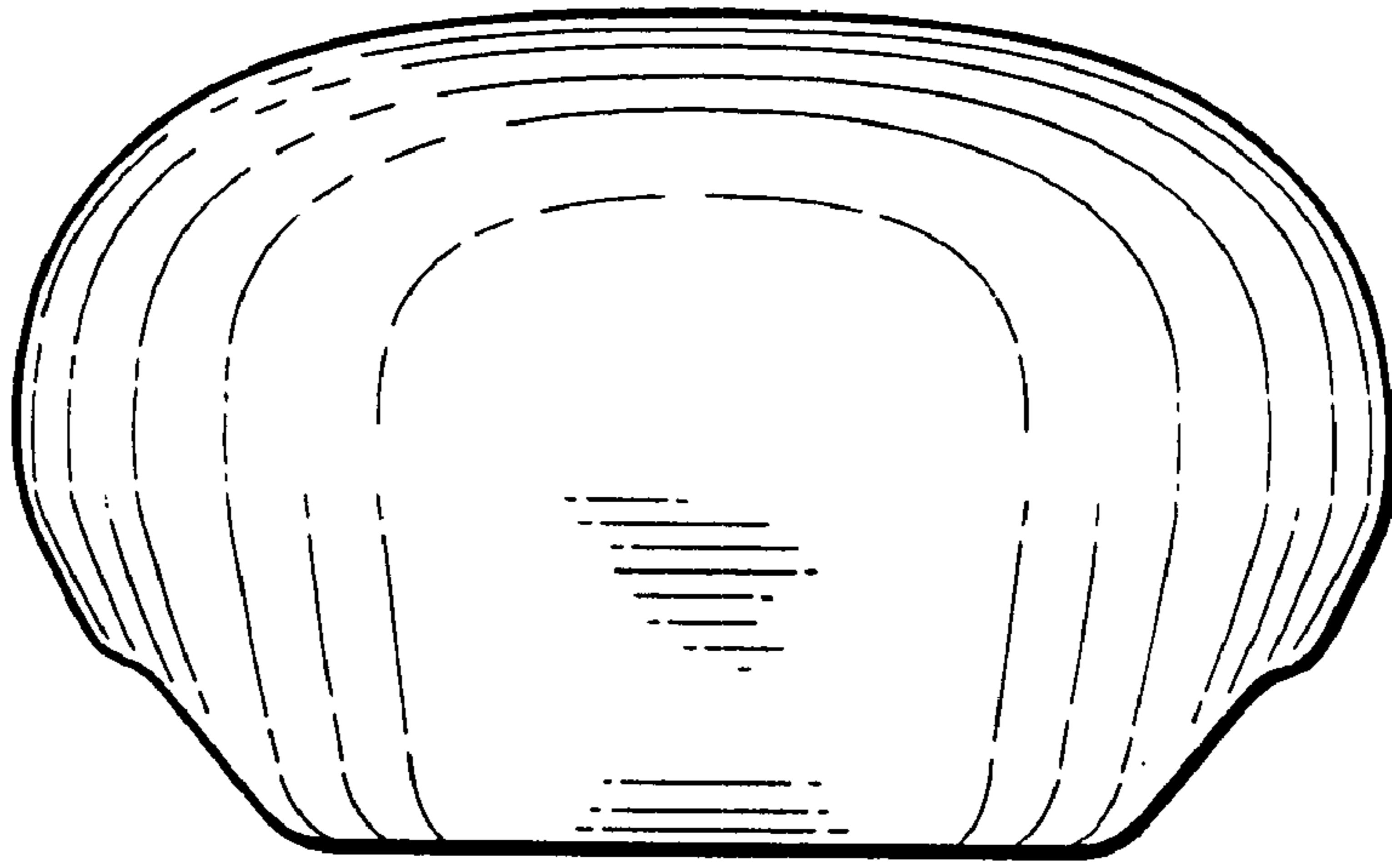

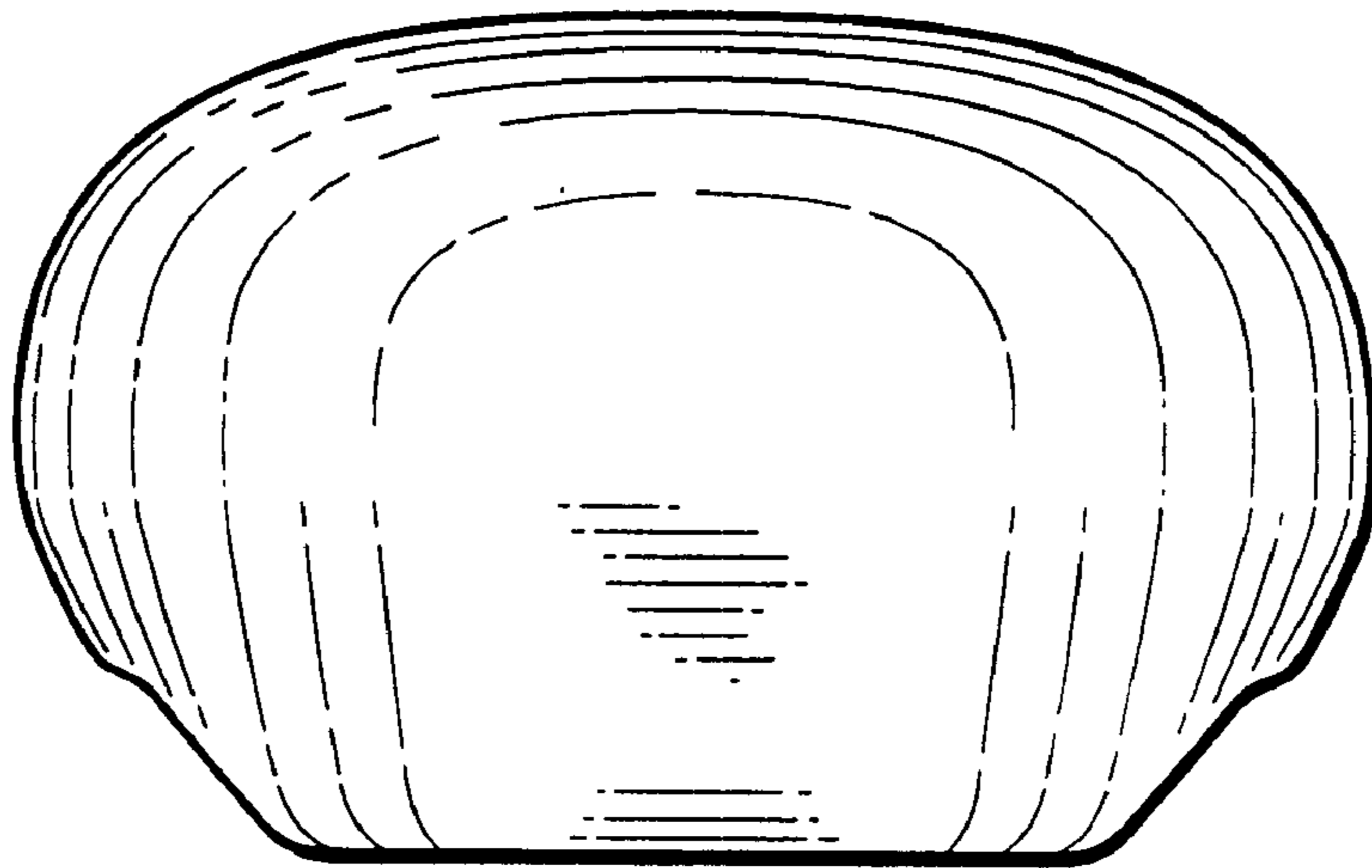

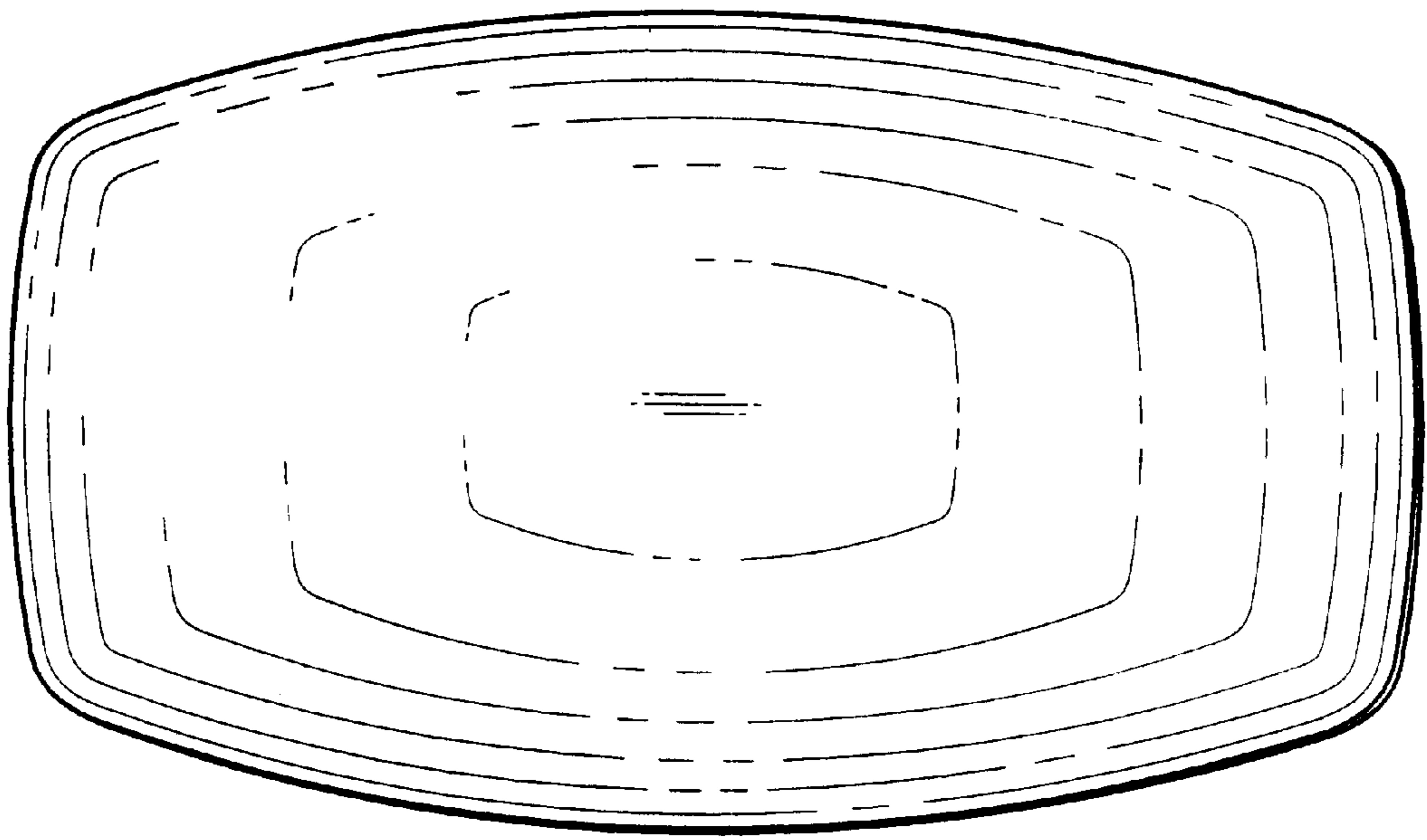

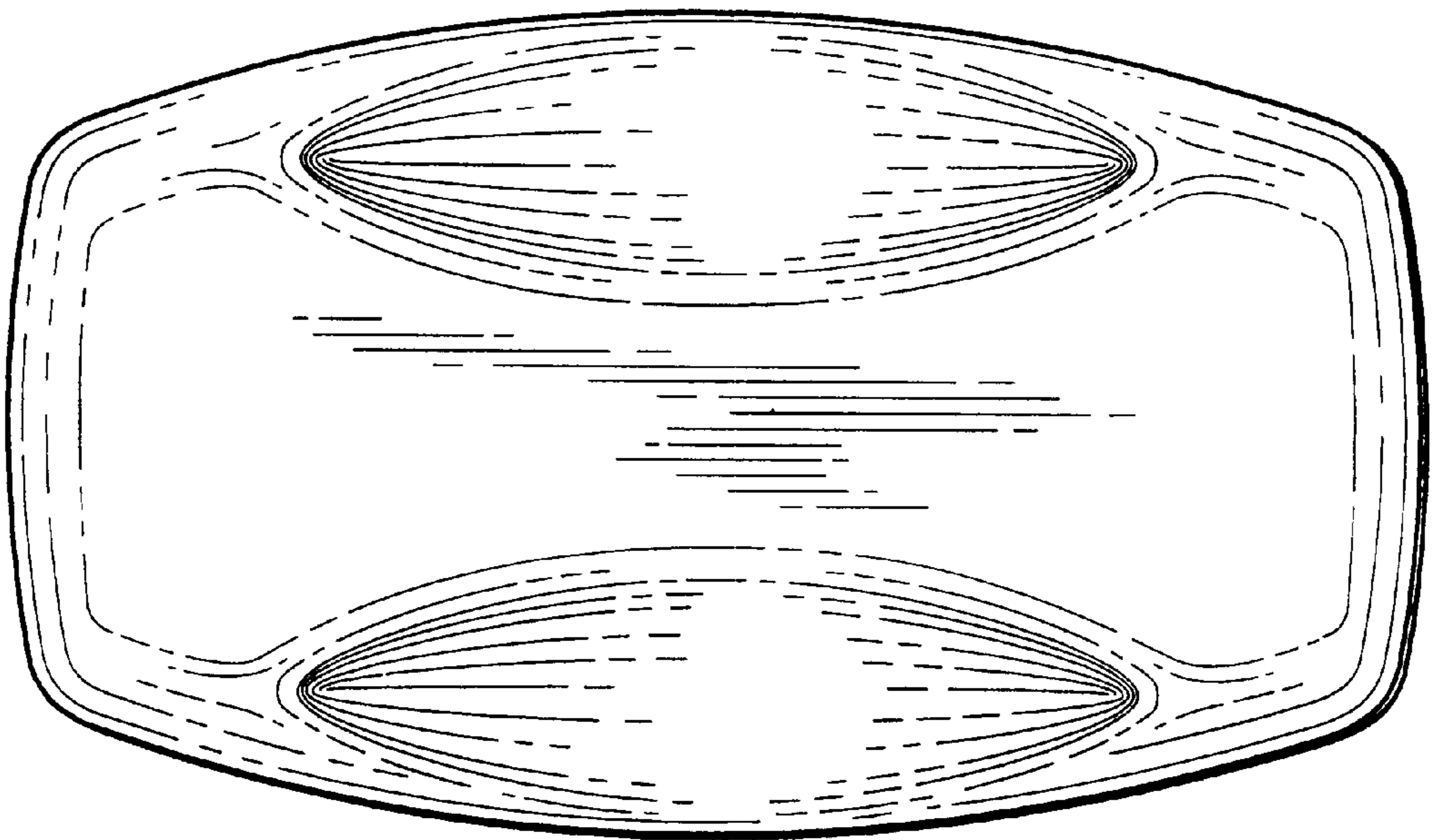
