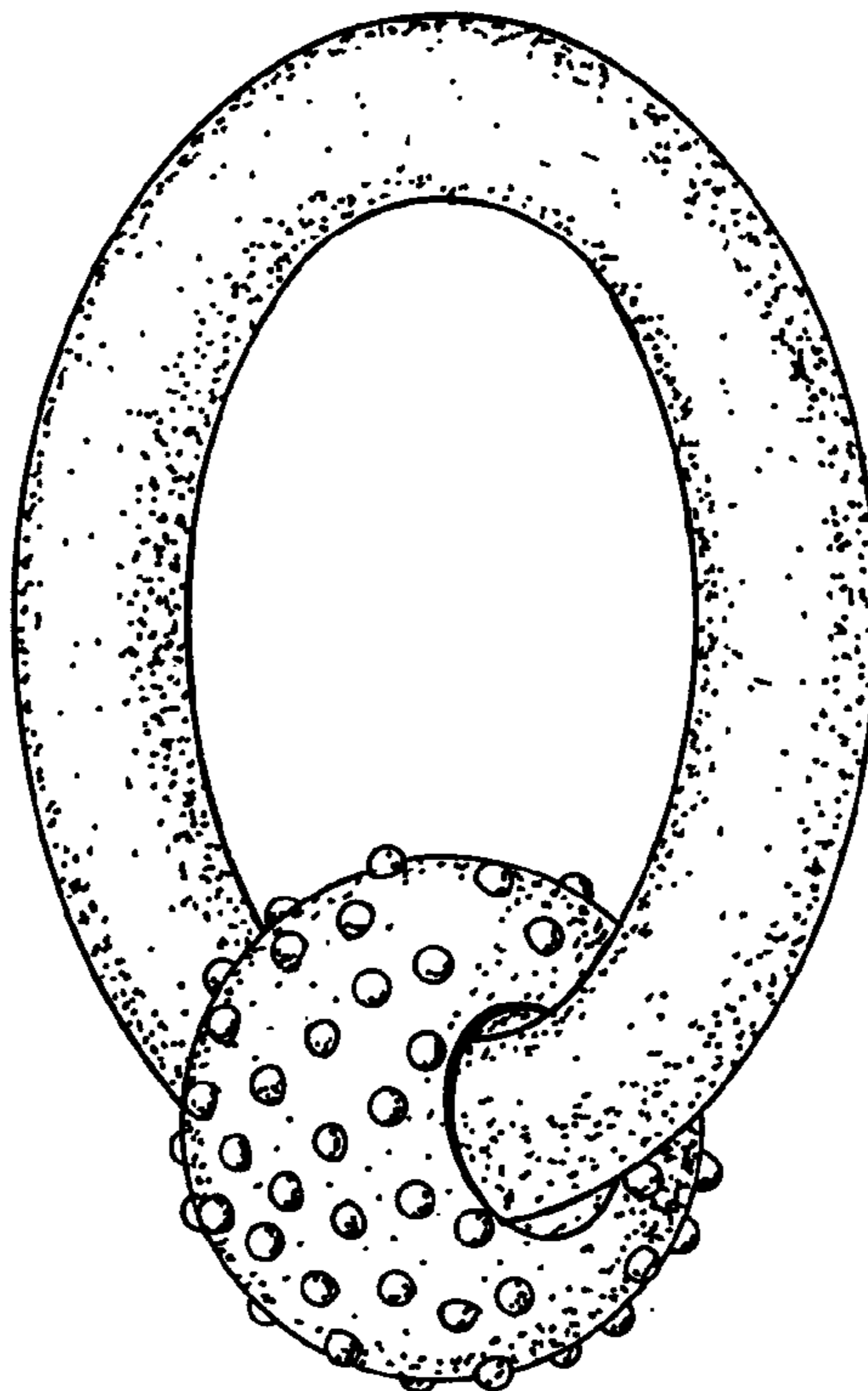
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front perspective view of my new animal toy; FIG. 2 is front elevation, the rear elevation being identical thereto; FIG. 3 is a left side elevation, the right side elevation being identical thereto; FIG. 4 is a top plan view; and, FIG. 5 is a bottom plan view.

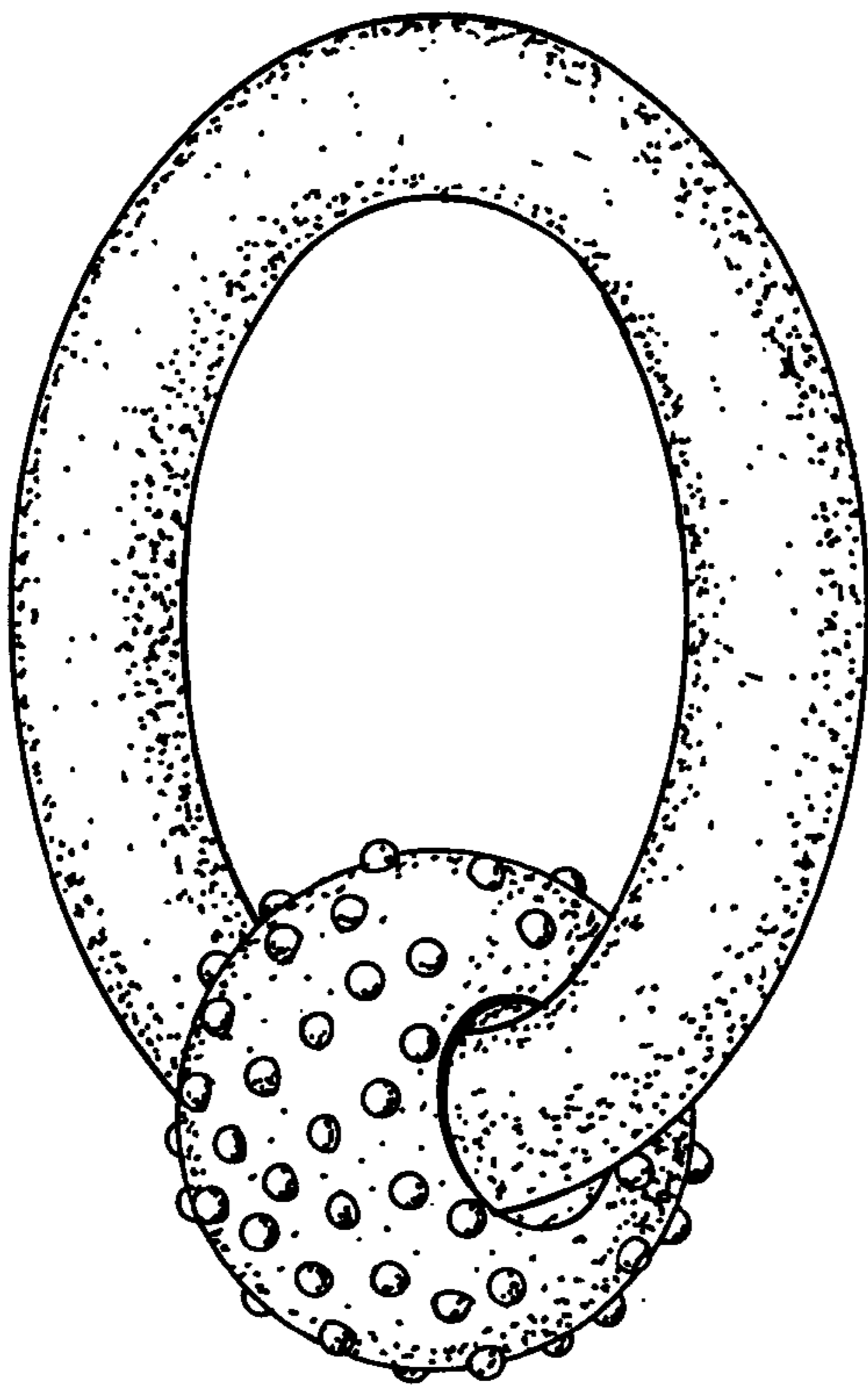
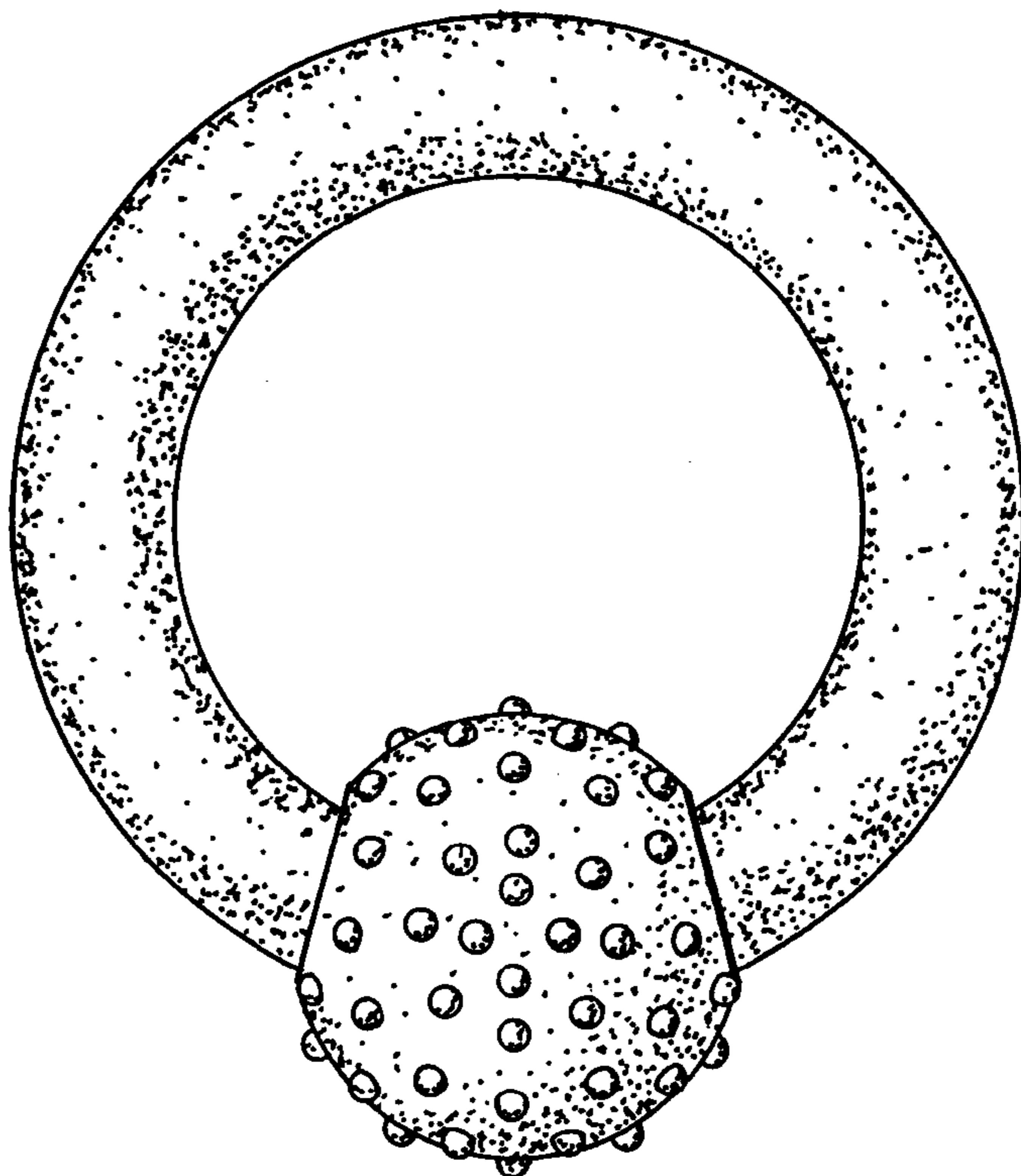

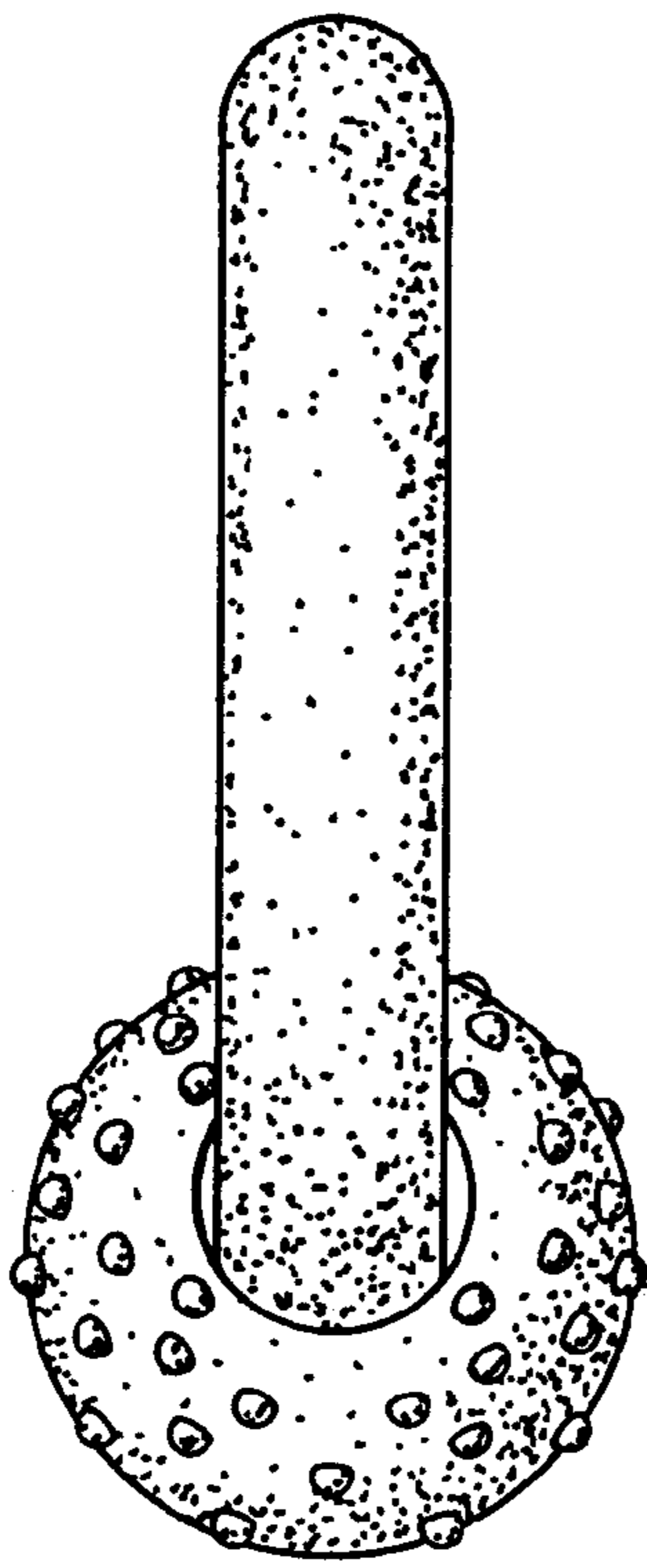

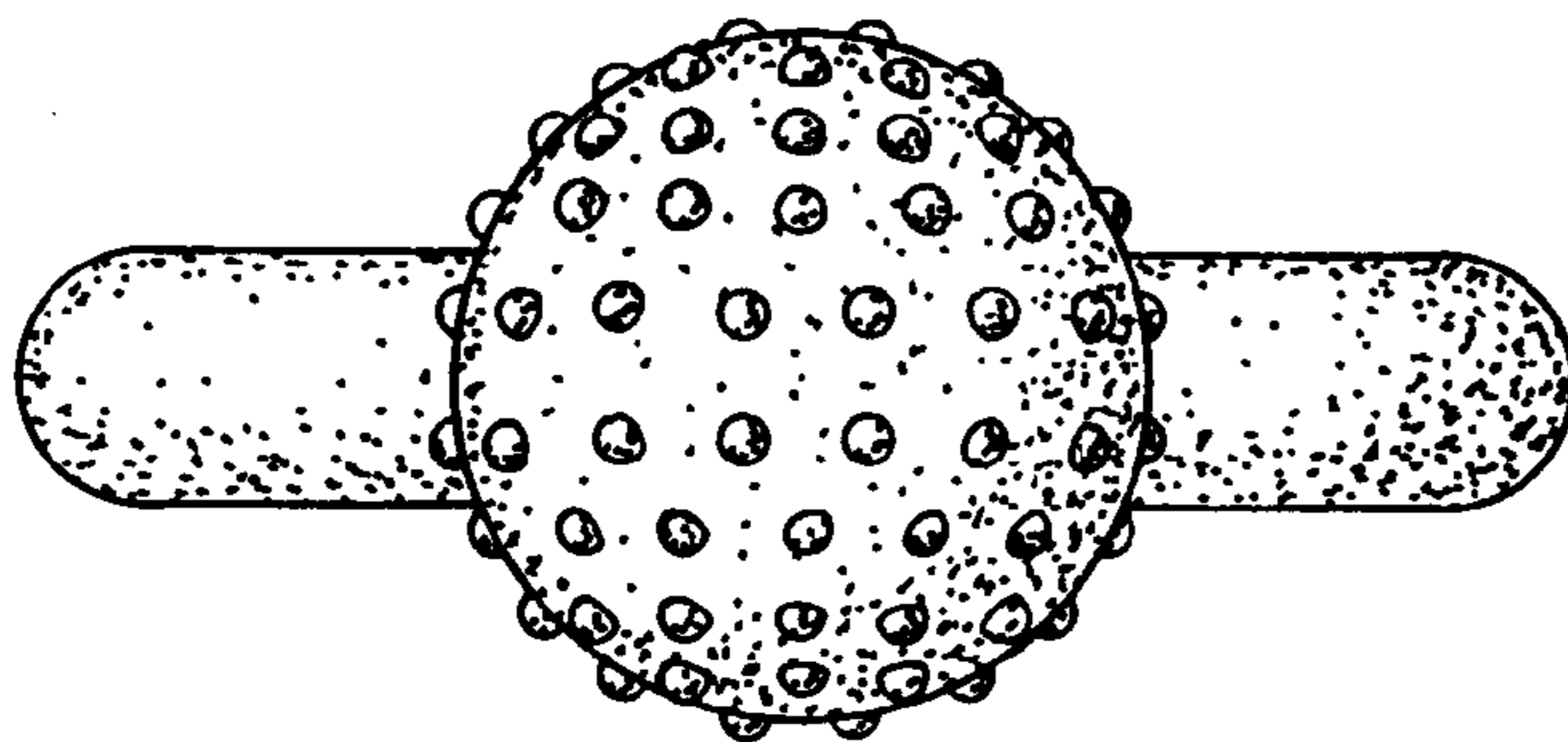
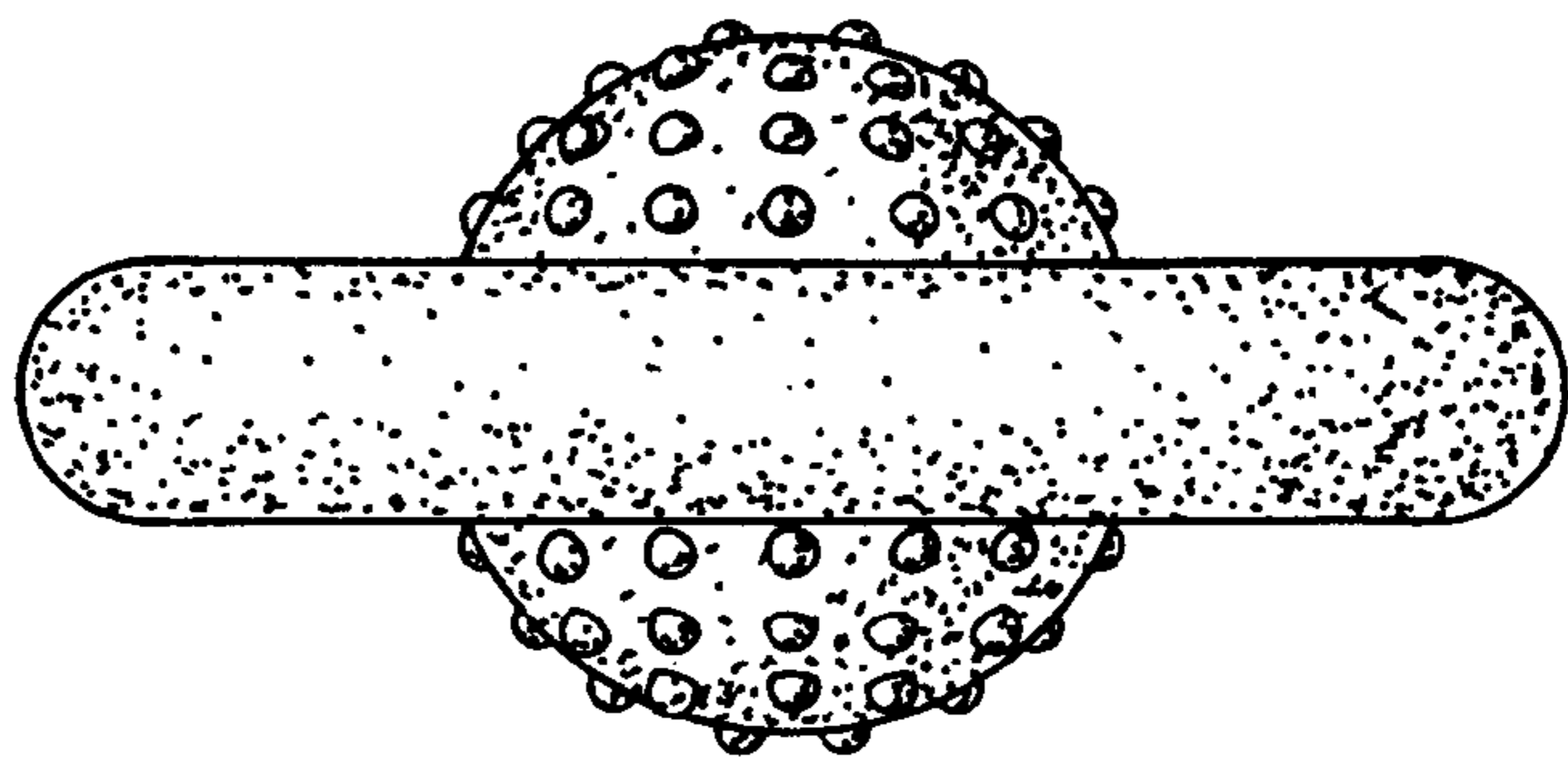
