FIG. 1 is a left side perspective view of a vacuum cleaner taken from the front and above, showing our new design;

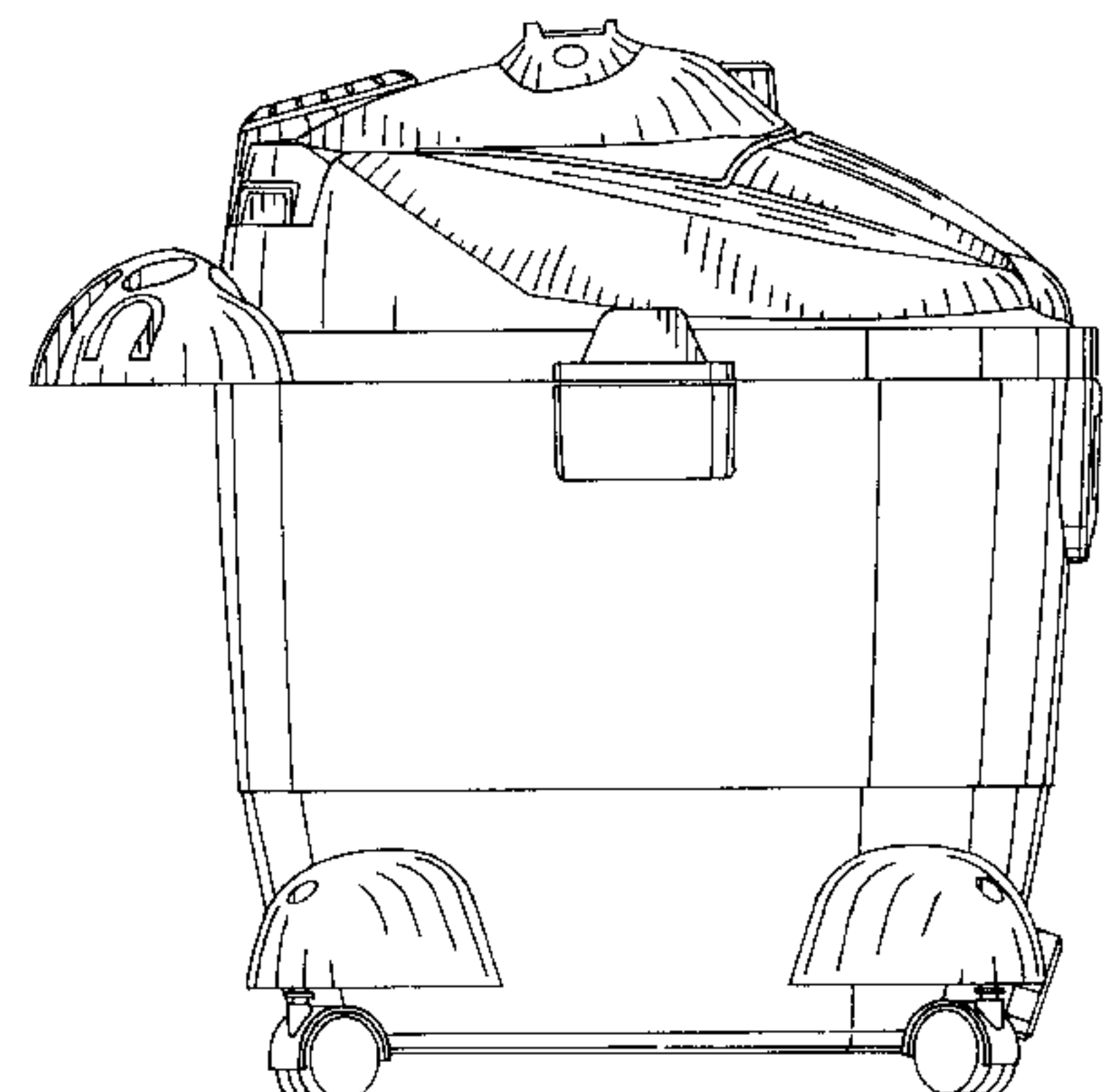
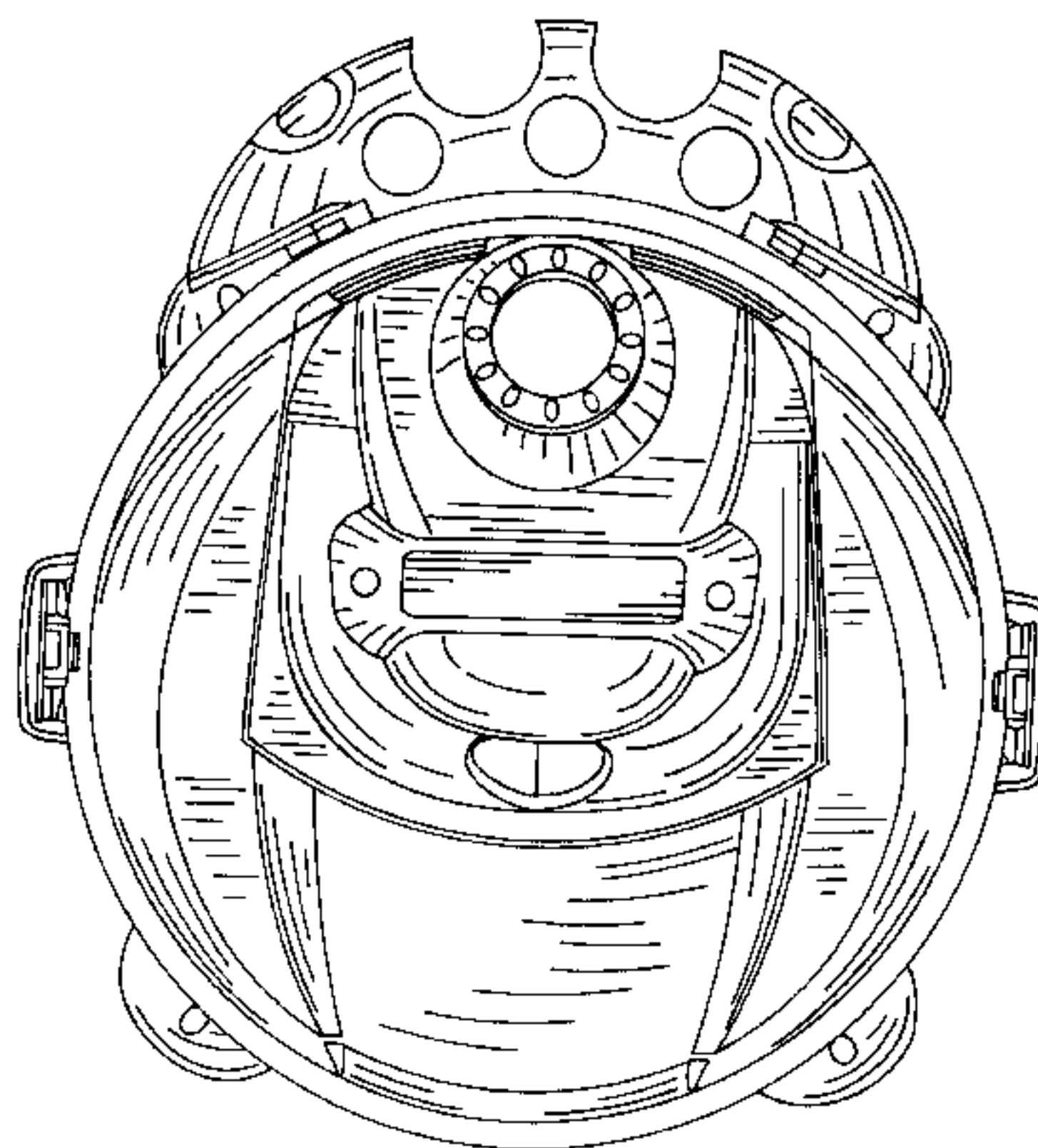
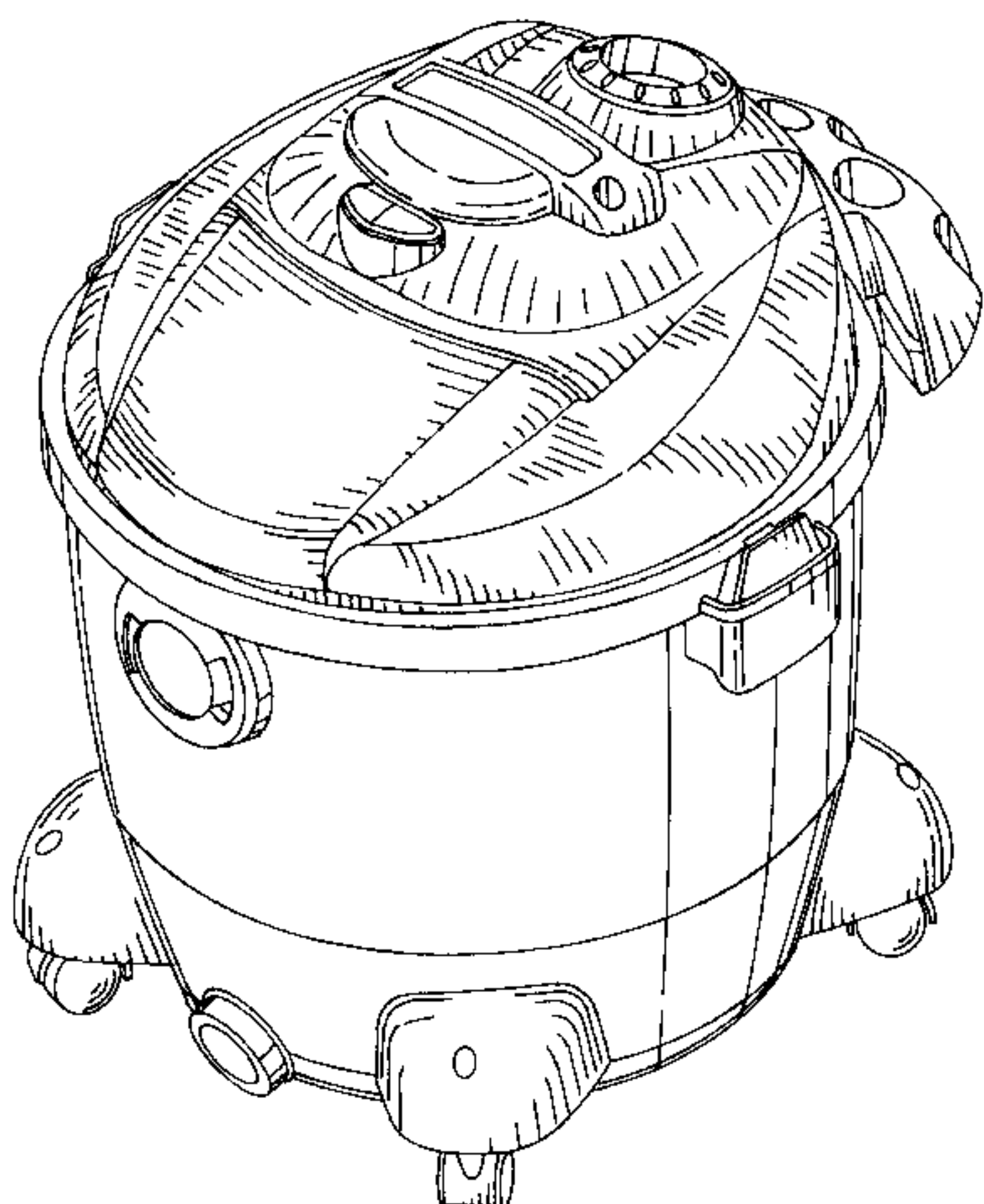
FIG. 2 is a top plan view thereof;

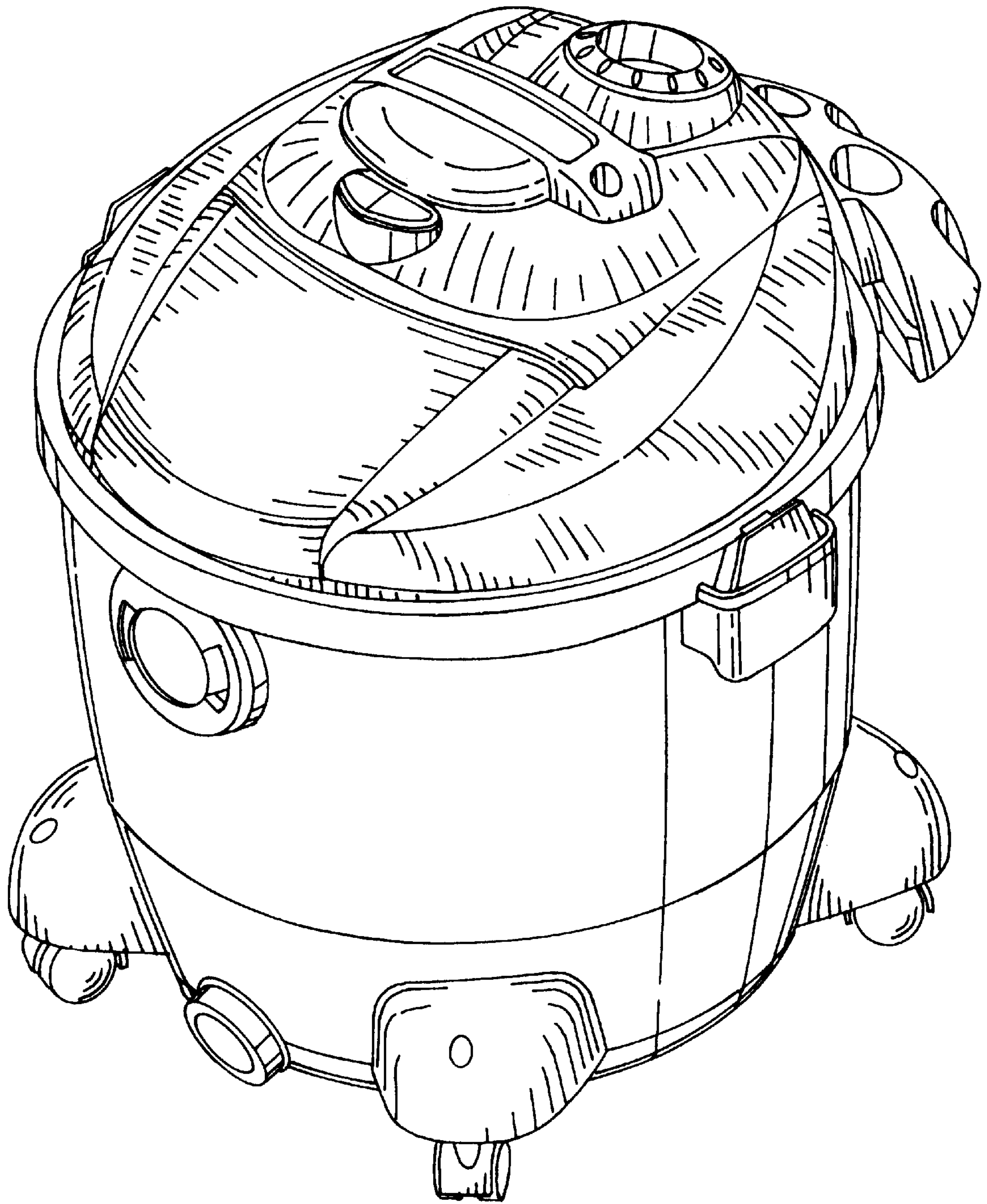

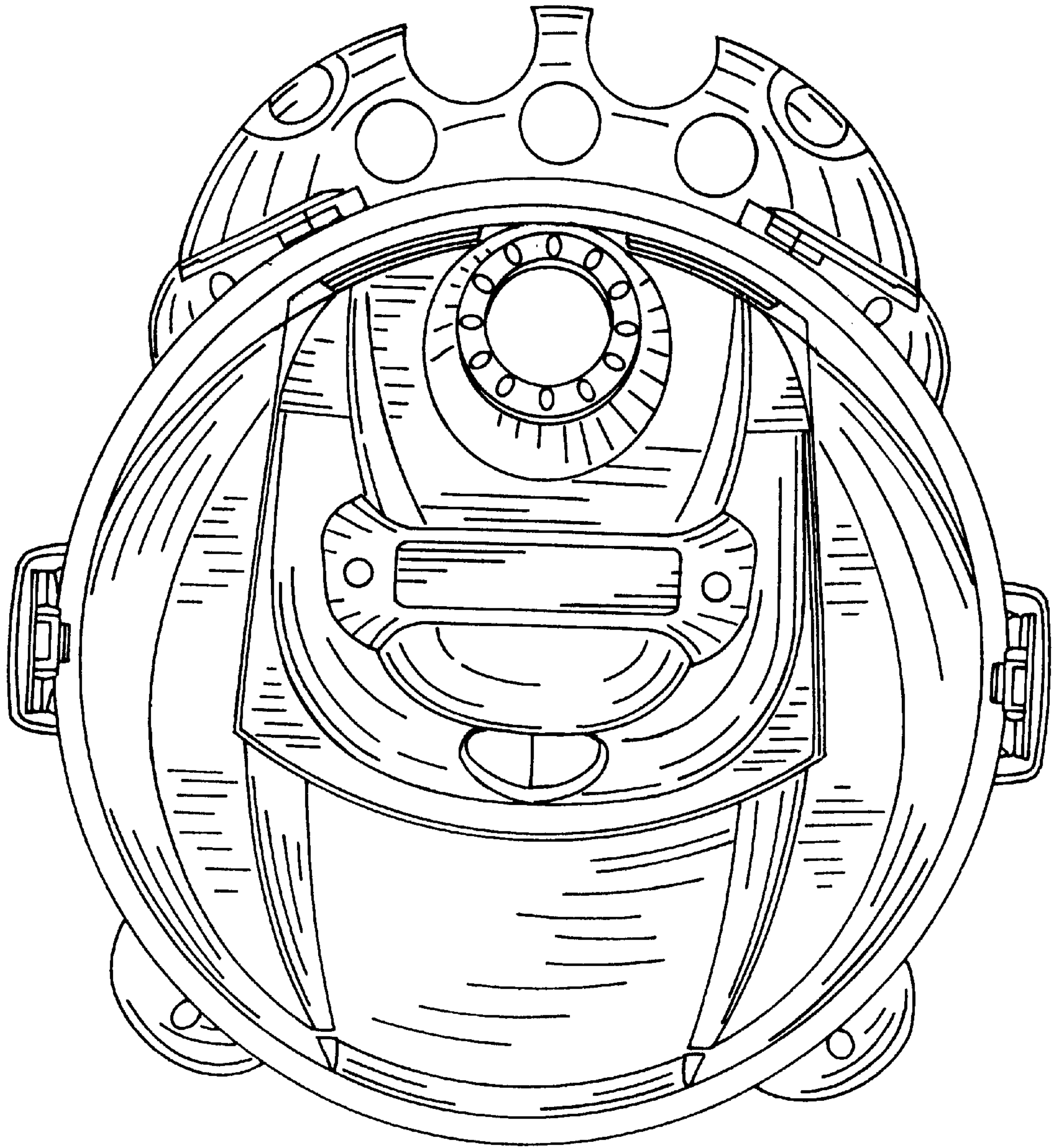

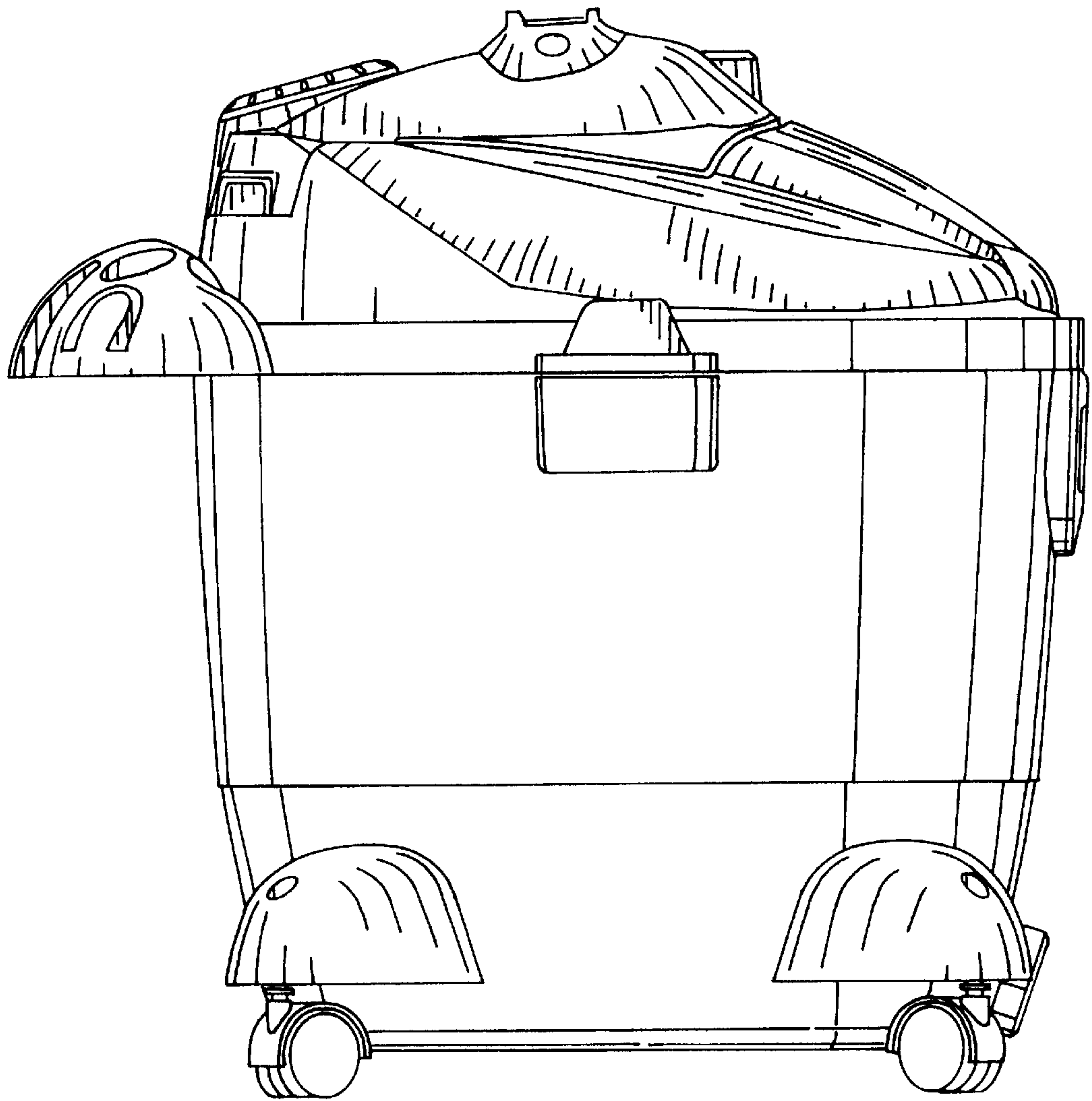

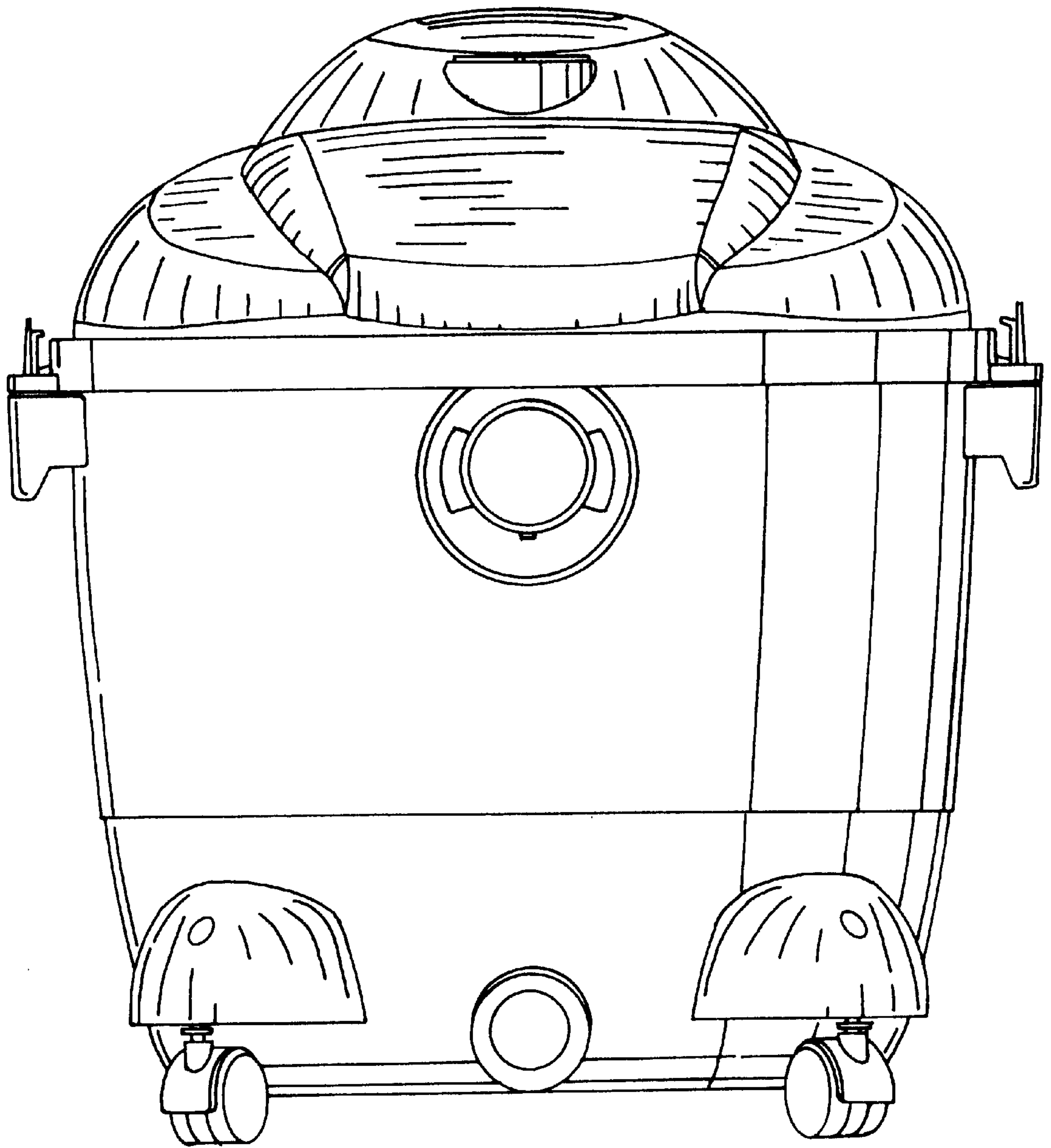

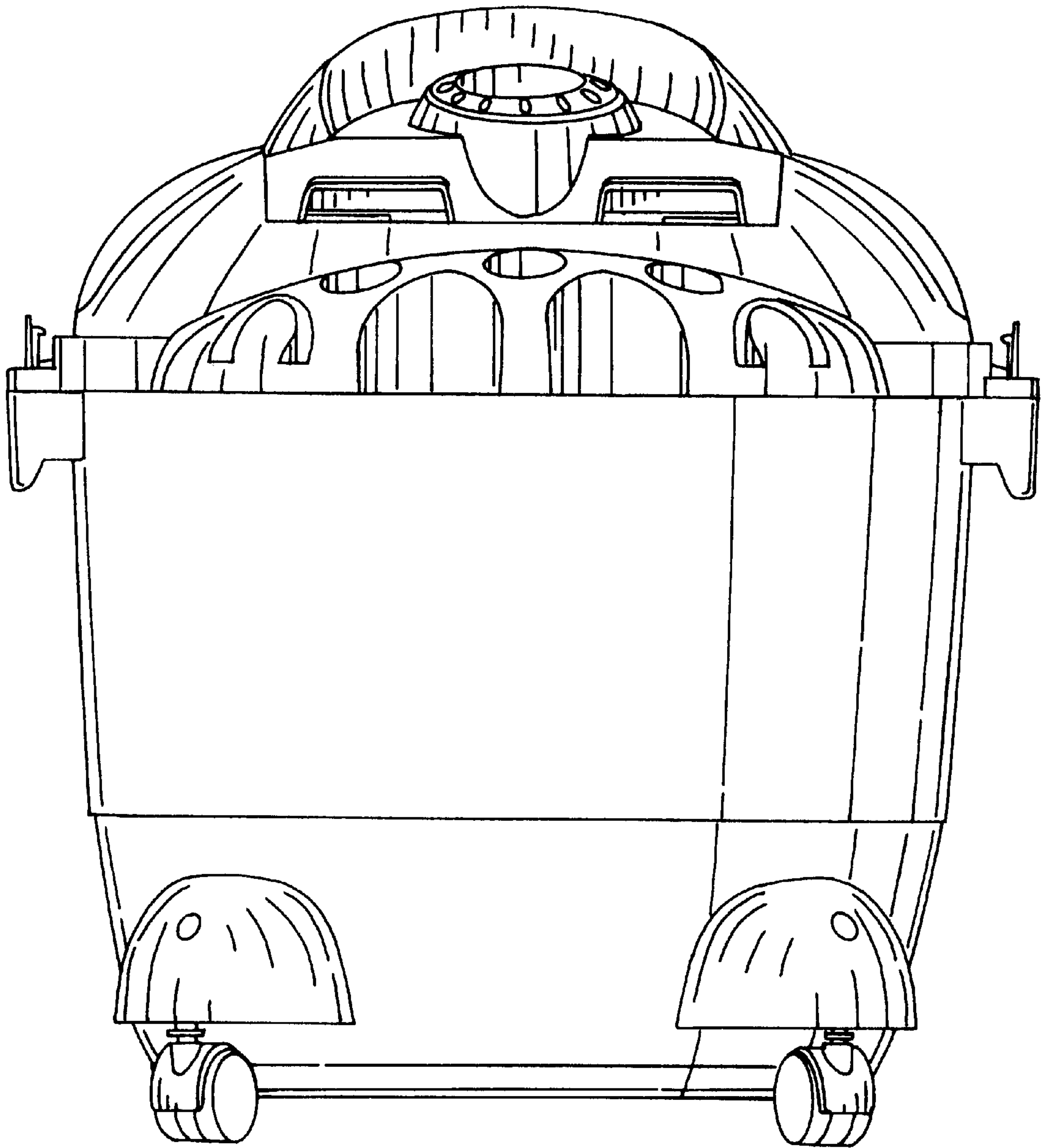
