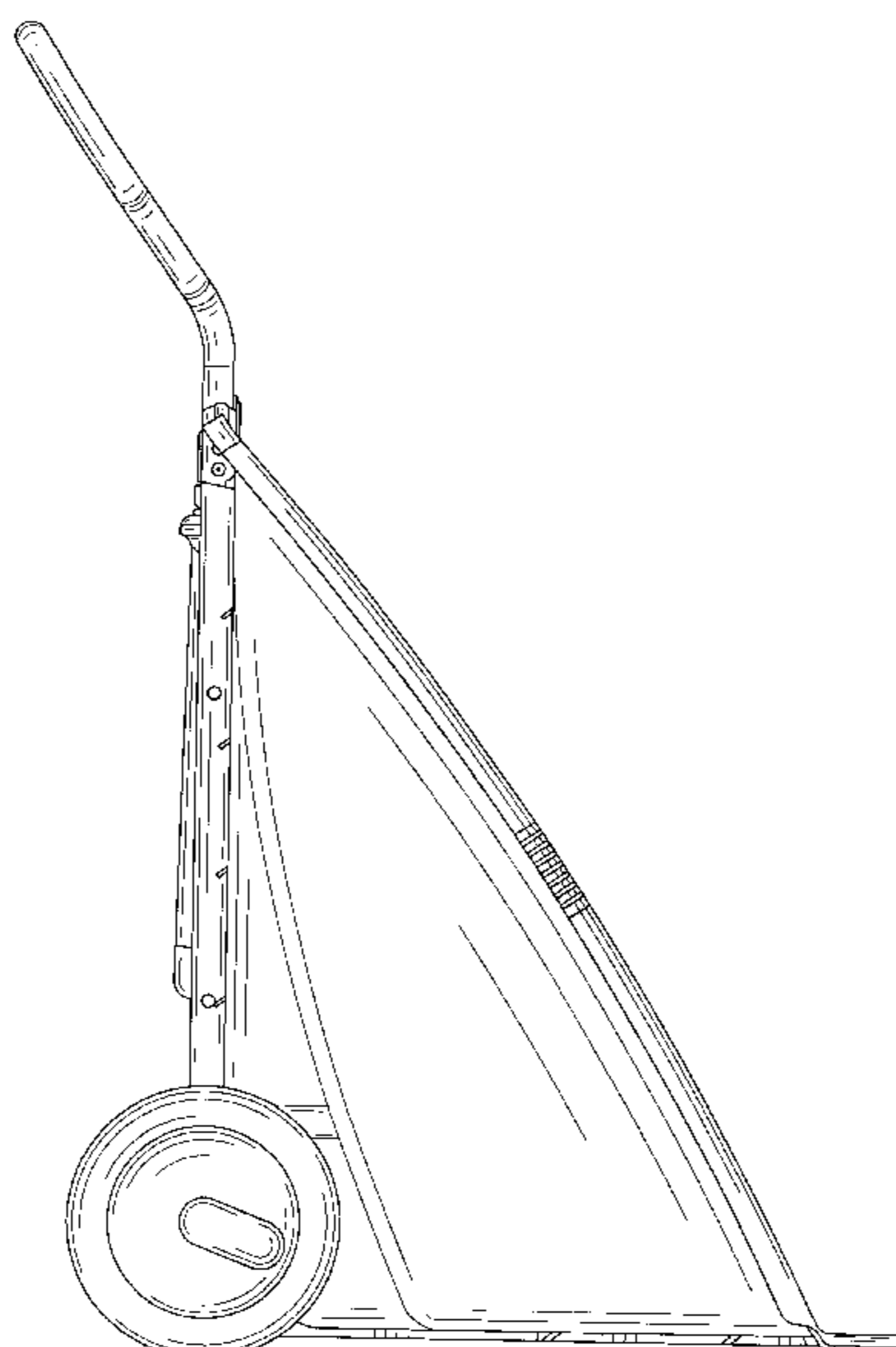

DESCRIPTION

FIG. 1 is a first side view of a stackable yard cart according to one embodiment of the invention;
 FIG. 2 is a rear view of a stackable yard cart, as shown in FIG. 1;
 FIG. 3 is a frontal view of a stackable yard cart, as shown in FIG. 1;
 FIG. 4 is a top view of a stackable yard cart, as shown in FIG. 1;
 FIG. 5 is a bottom view of a stackable yard cart, as shown in FIG. 1;
 FIG. 6 is a perspective view of a stackable yard cart, as shown in FIG. 1; and,
 FIG. 7 is a perspective view of a stackable yard cart, as shown in FIG. 1, stacked with multiple stackable yard carts. The broken line showings in FIG. 7 are for illustrative purposes only and form no part of the claimed design.

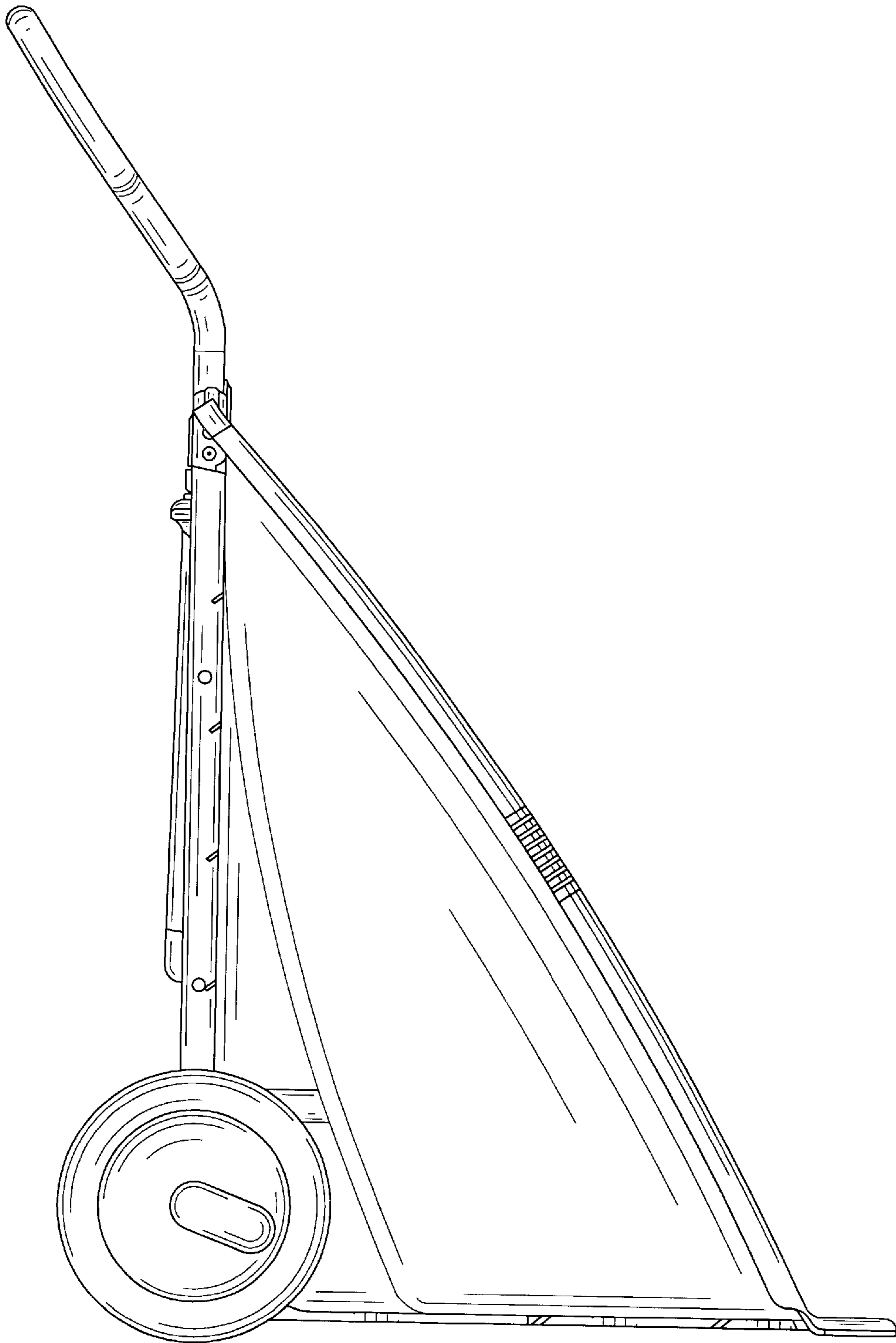

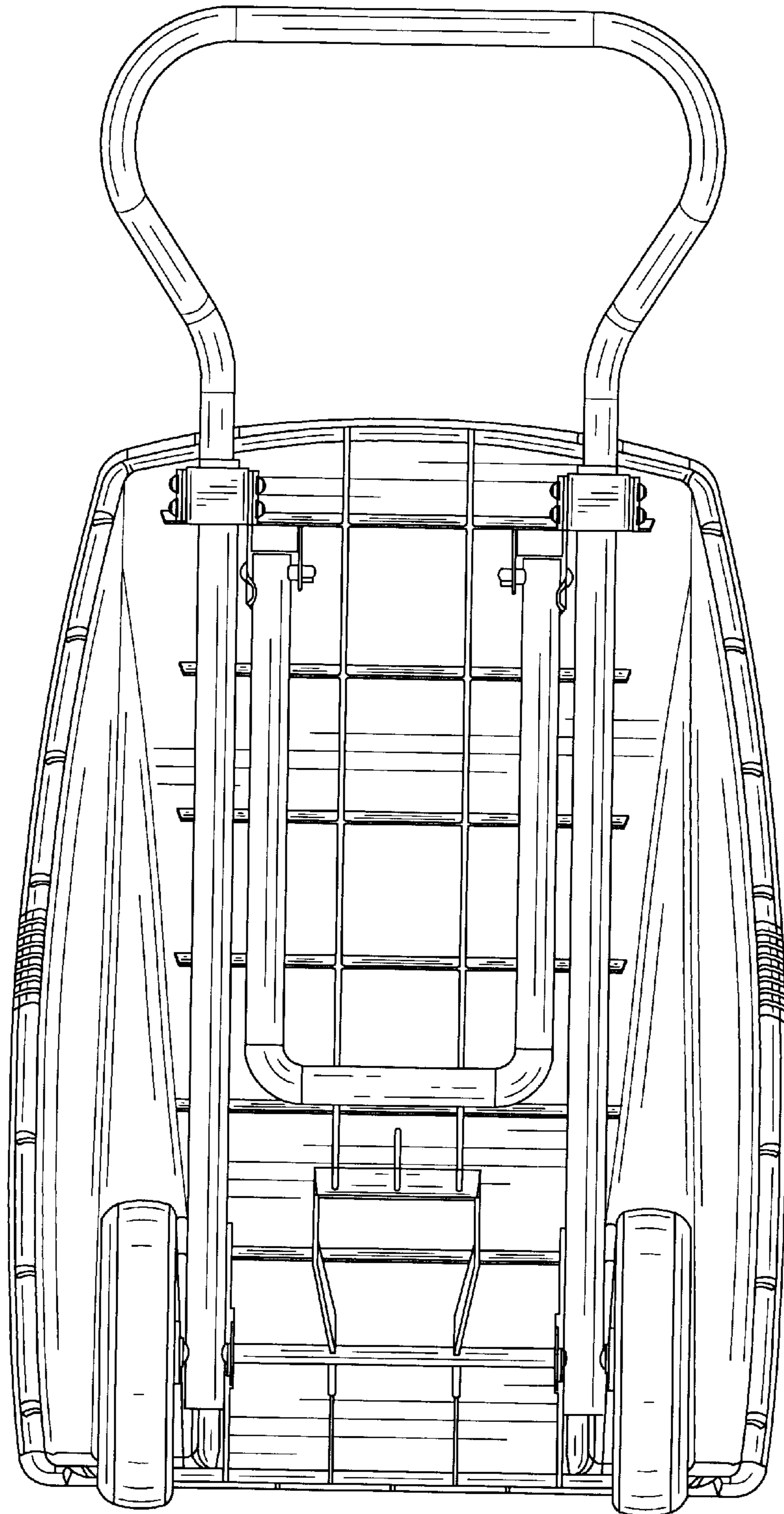

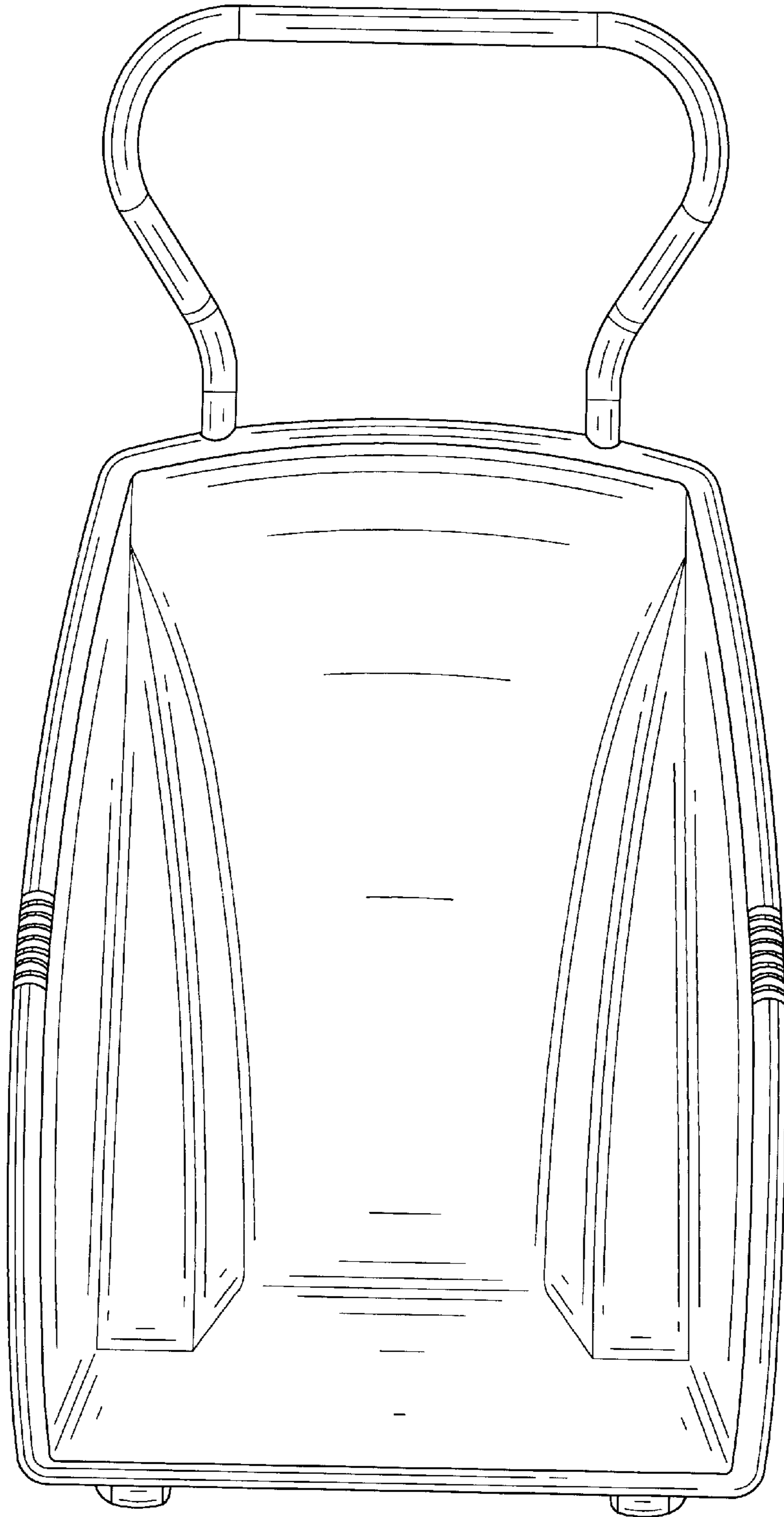

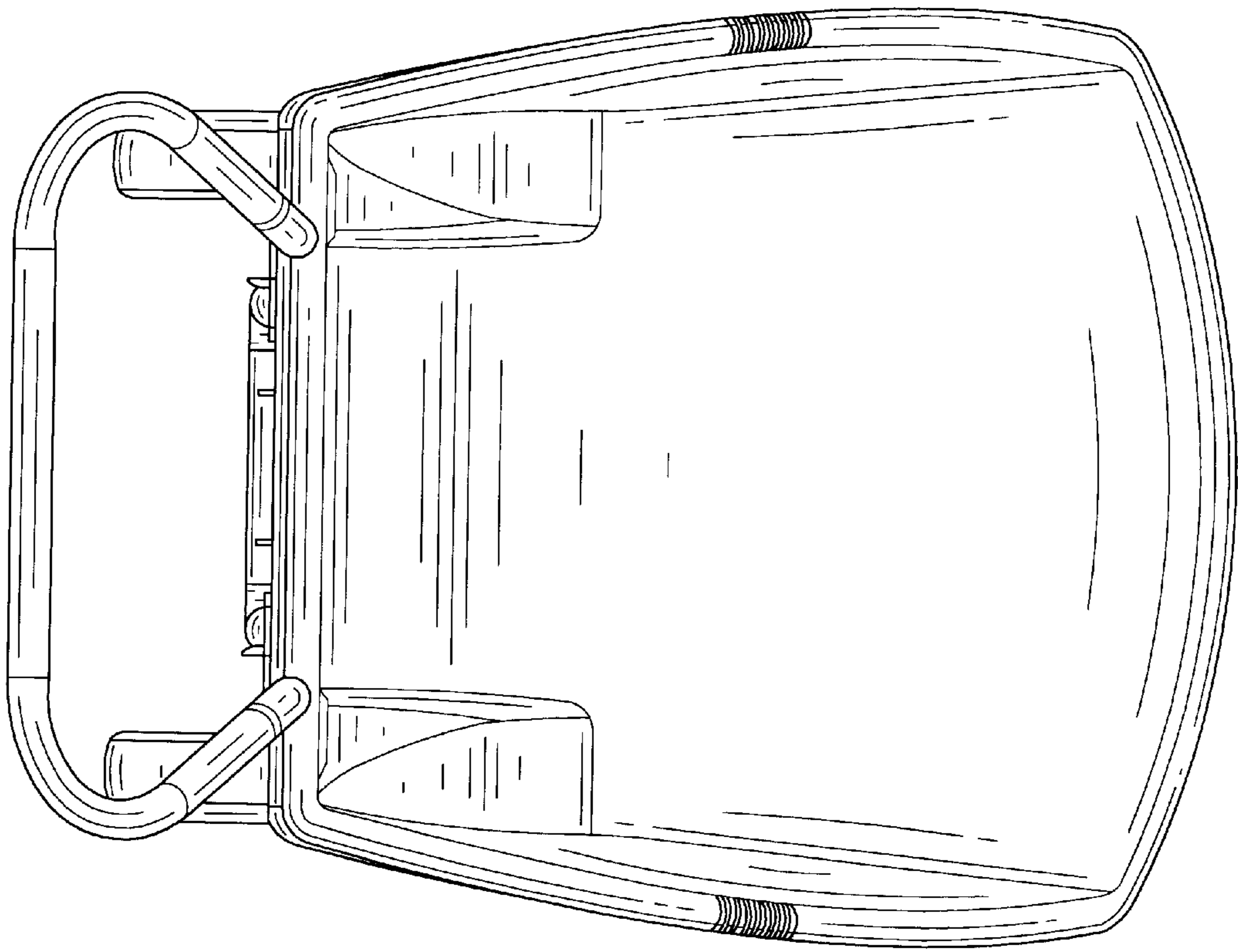

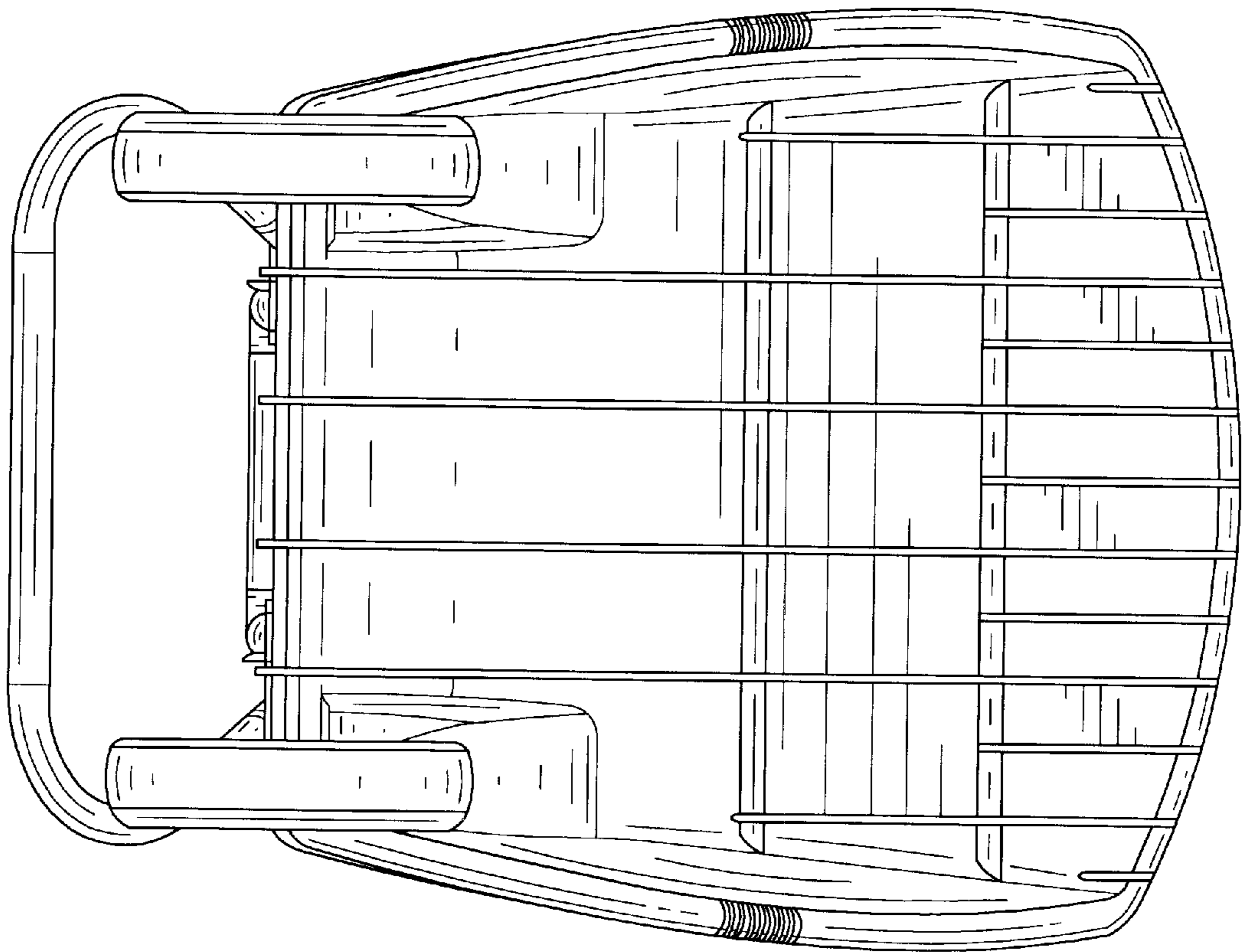

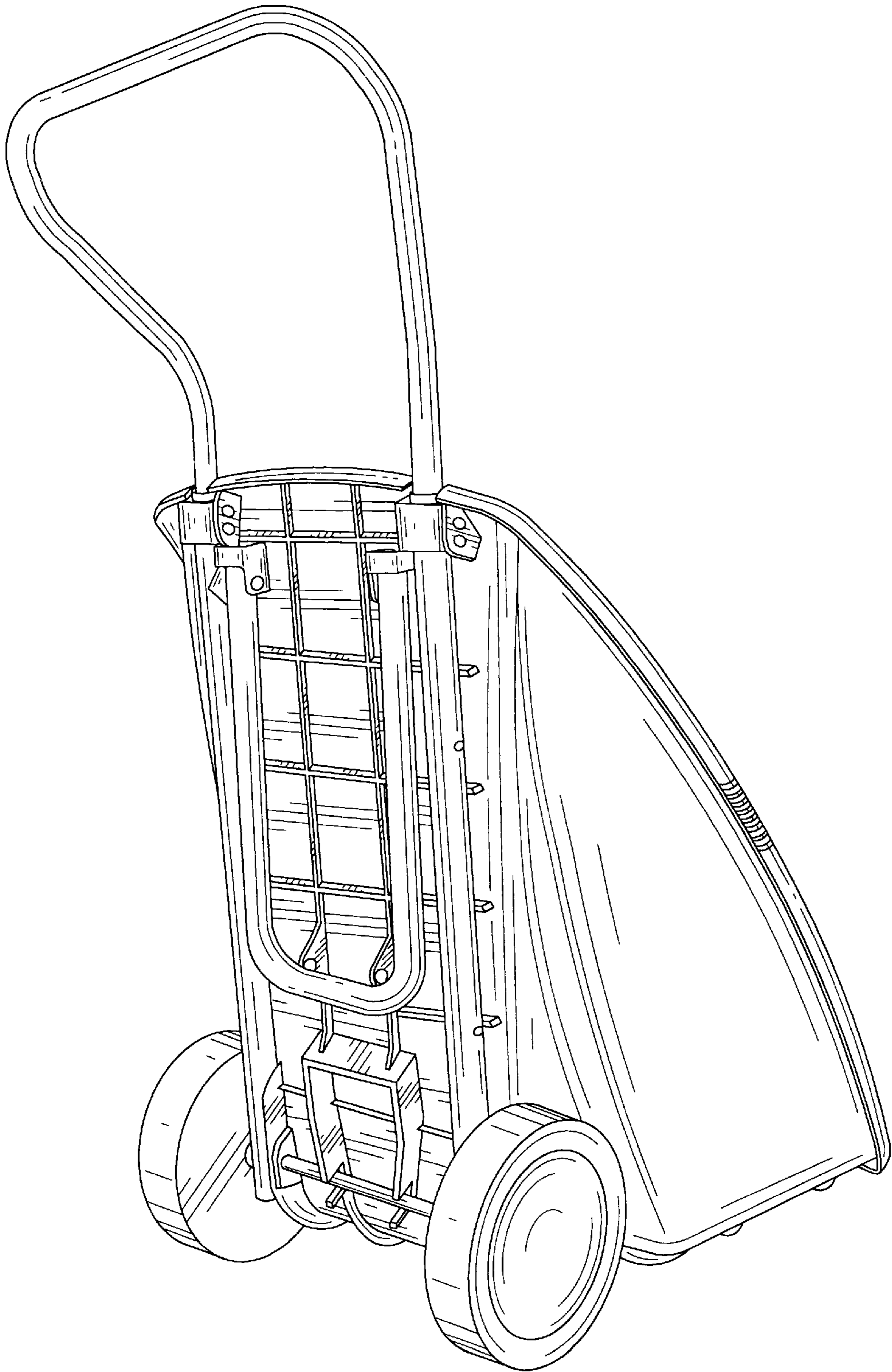

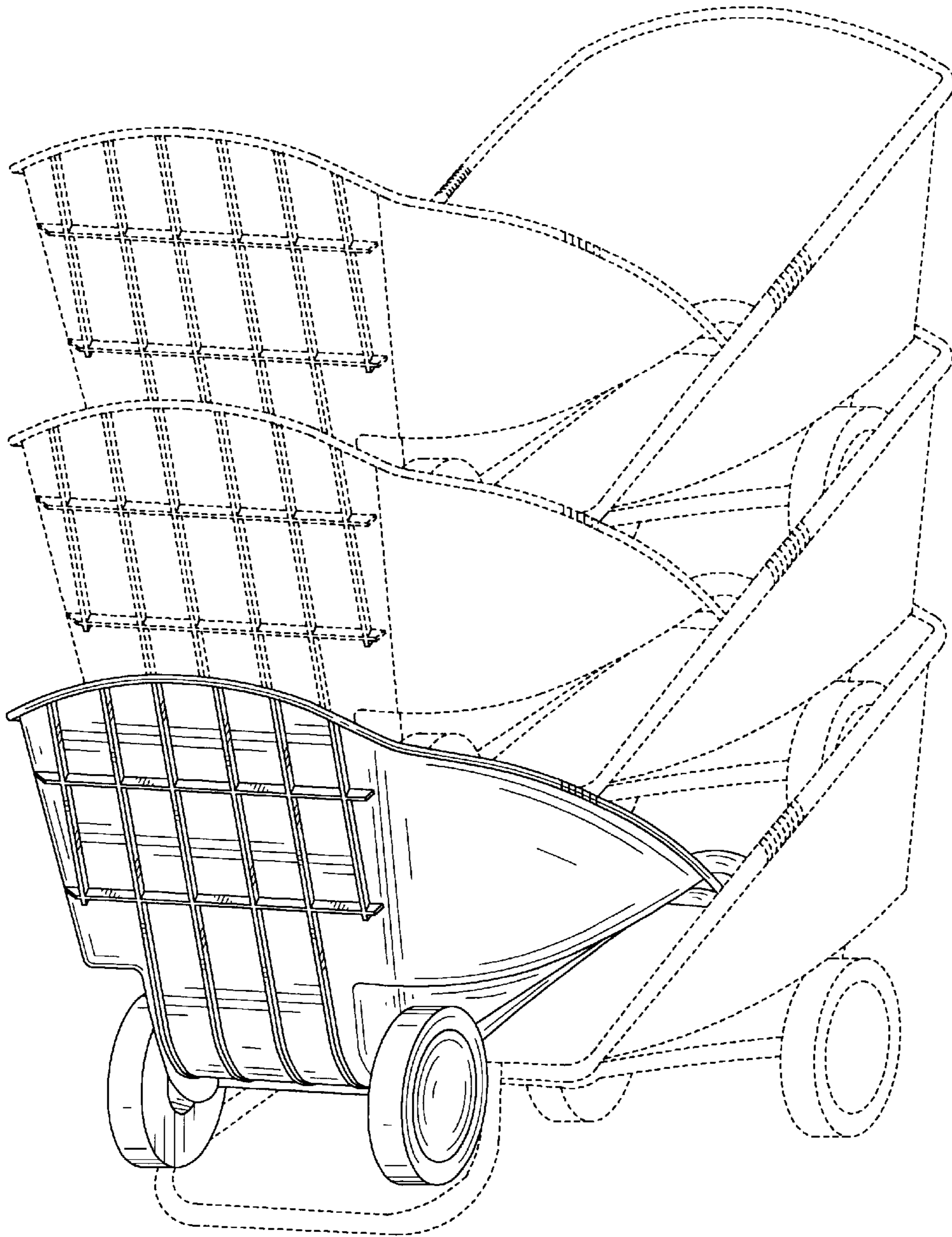
