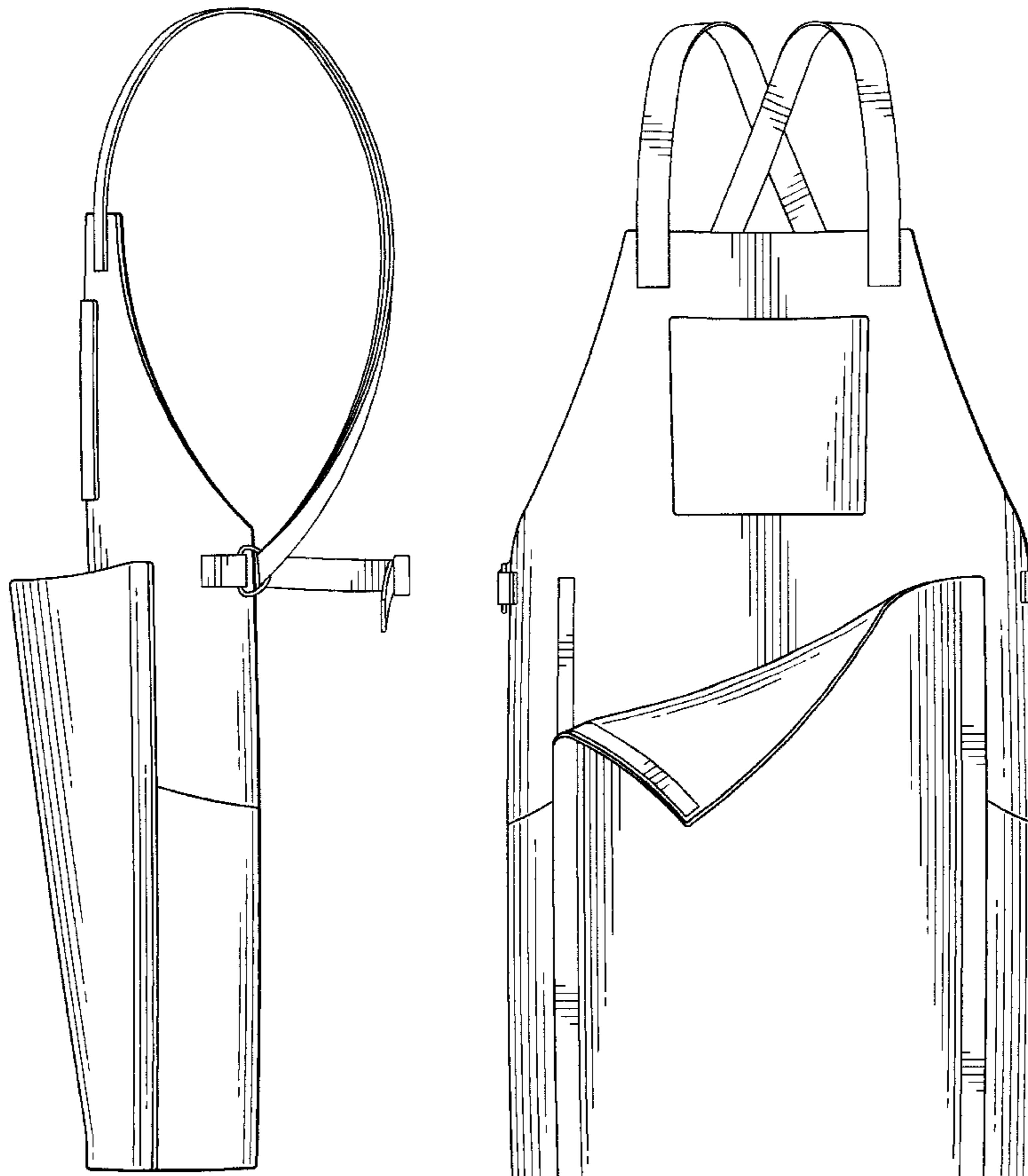
(57) **CLAIM**

The ornamental design for an apron with an openable pouch, as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevational view, of an apron with openable pouch showing my new design;  
 FIG. 2 is a right side elevational view thereof, the left side being a mirror image except for the overlap of the rear straps;  
 FIG. 3 is a top plan view thereof;  
 FIG. 4 is a bottom plan view thereof;  
 FIG. 5 is a rear elevational view thereof; and,  
 FIG. 6 is a front elevational view thereof, with the pouch partially opened.

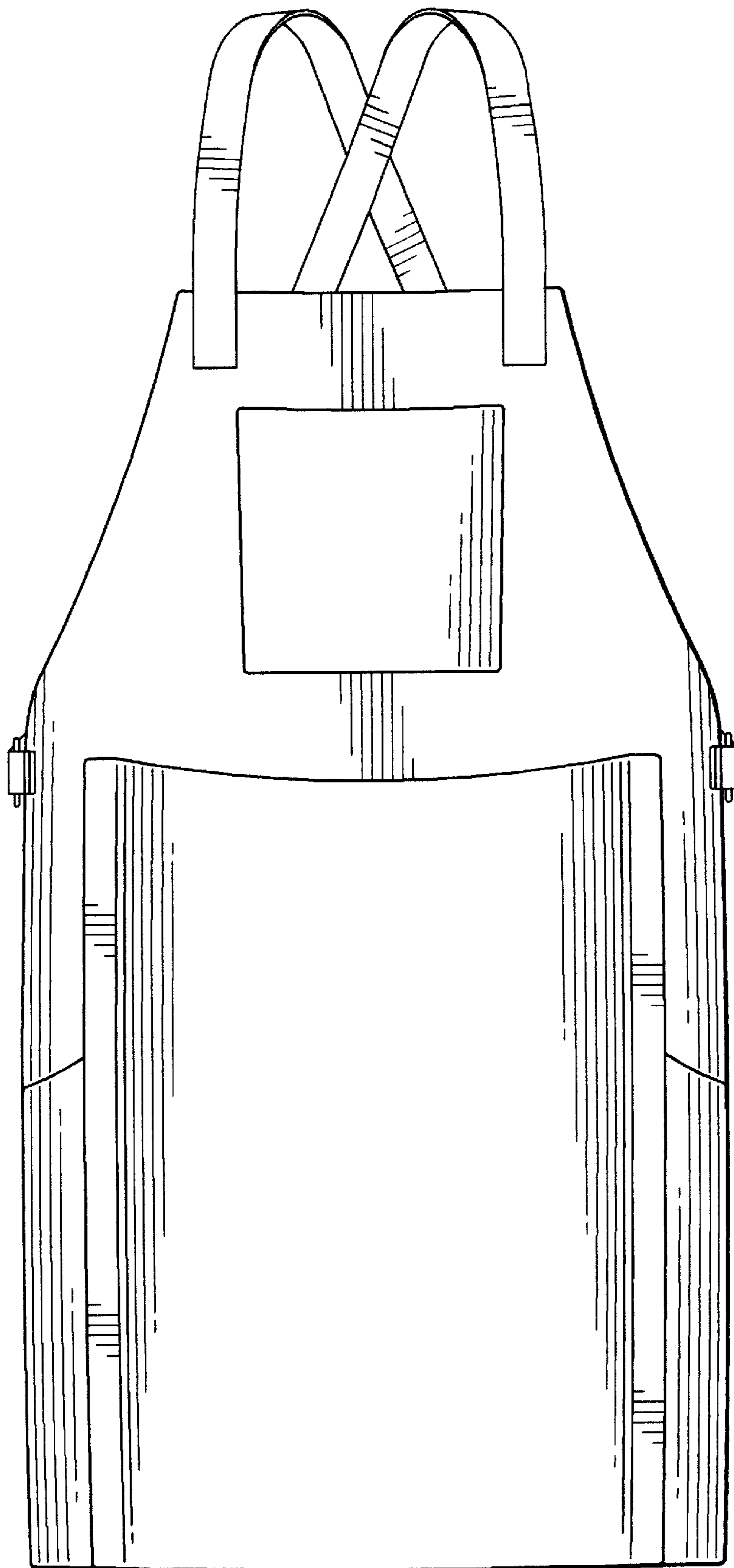

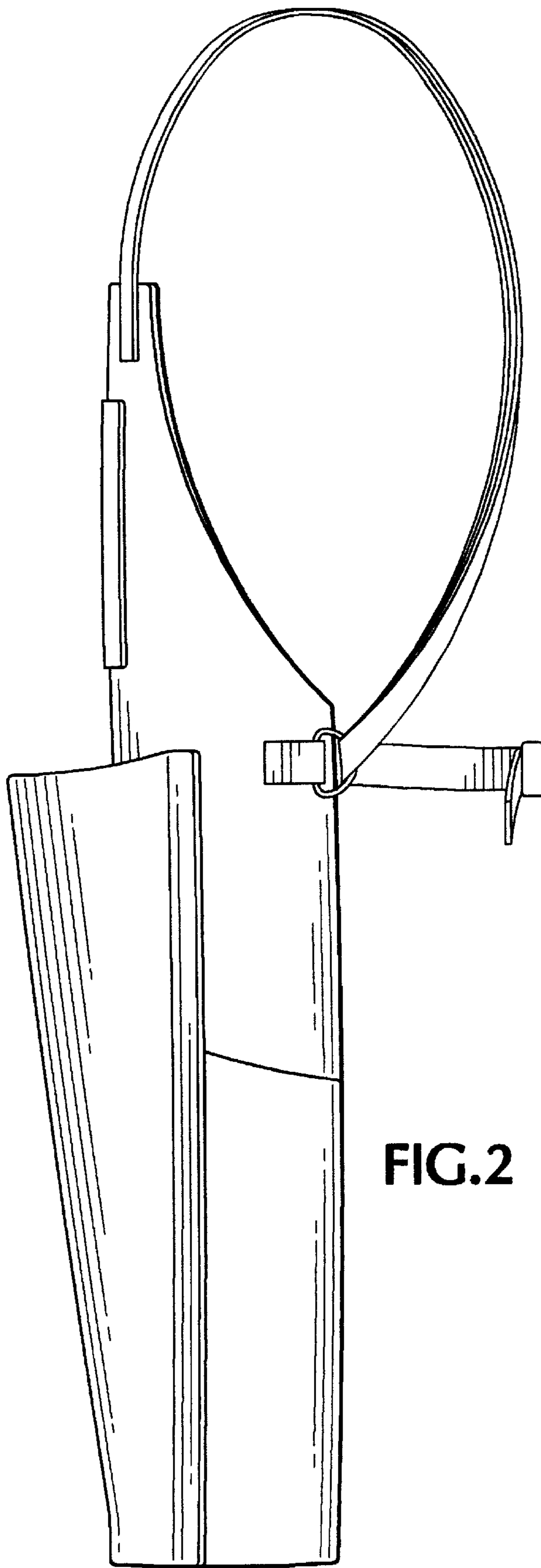

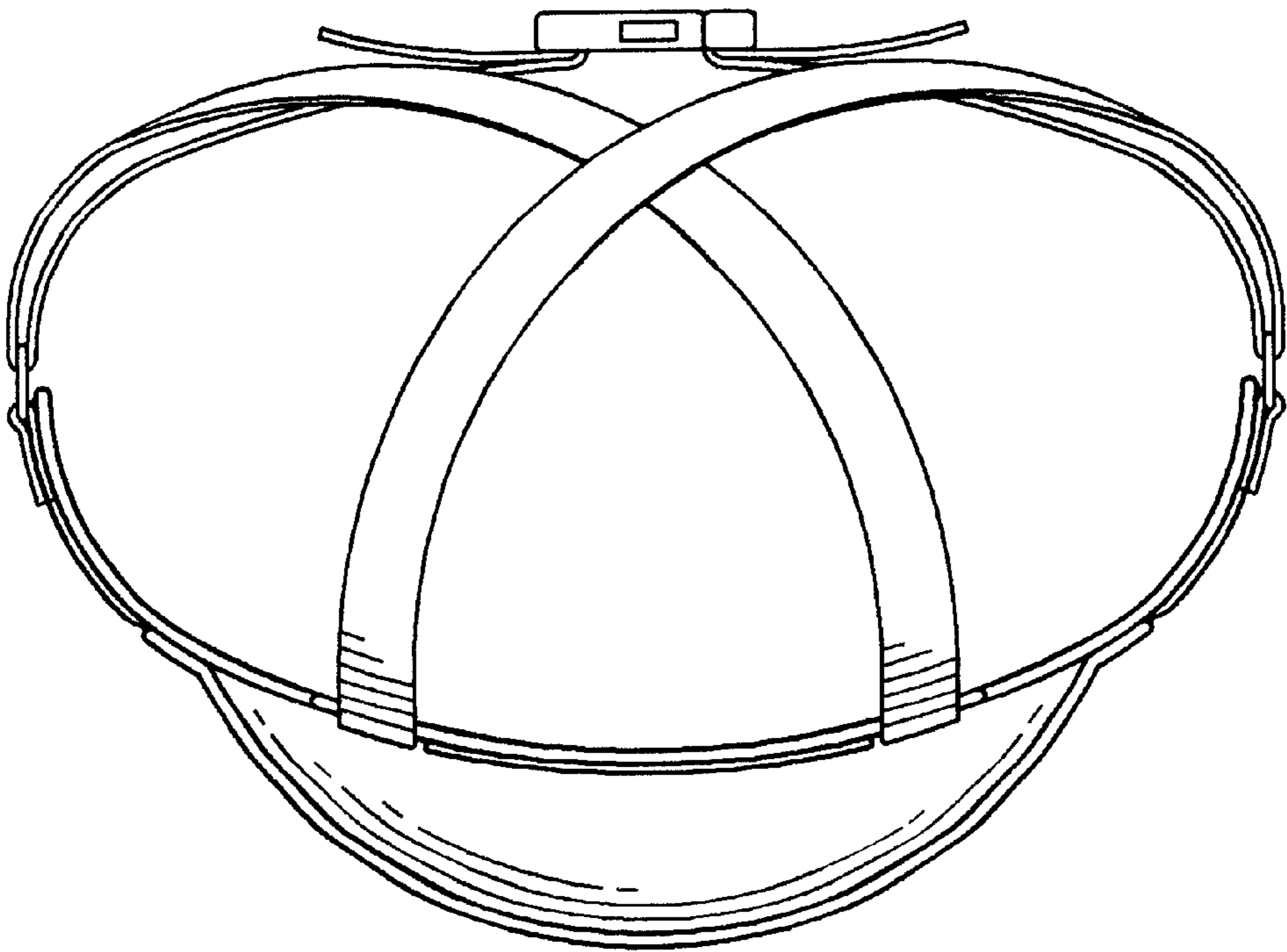

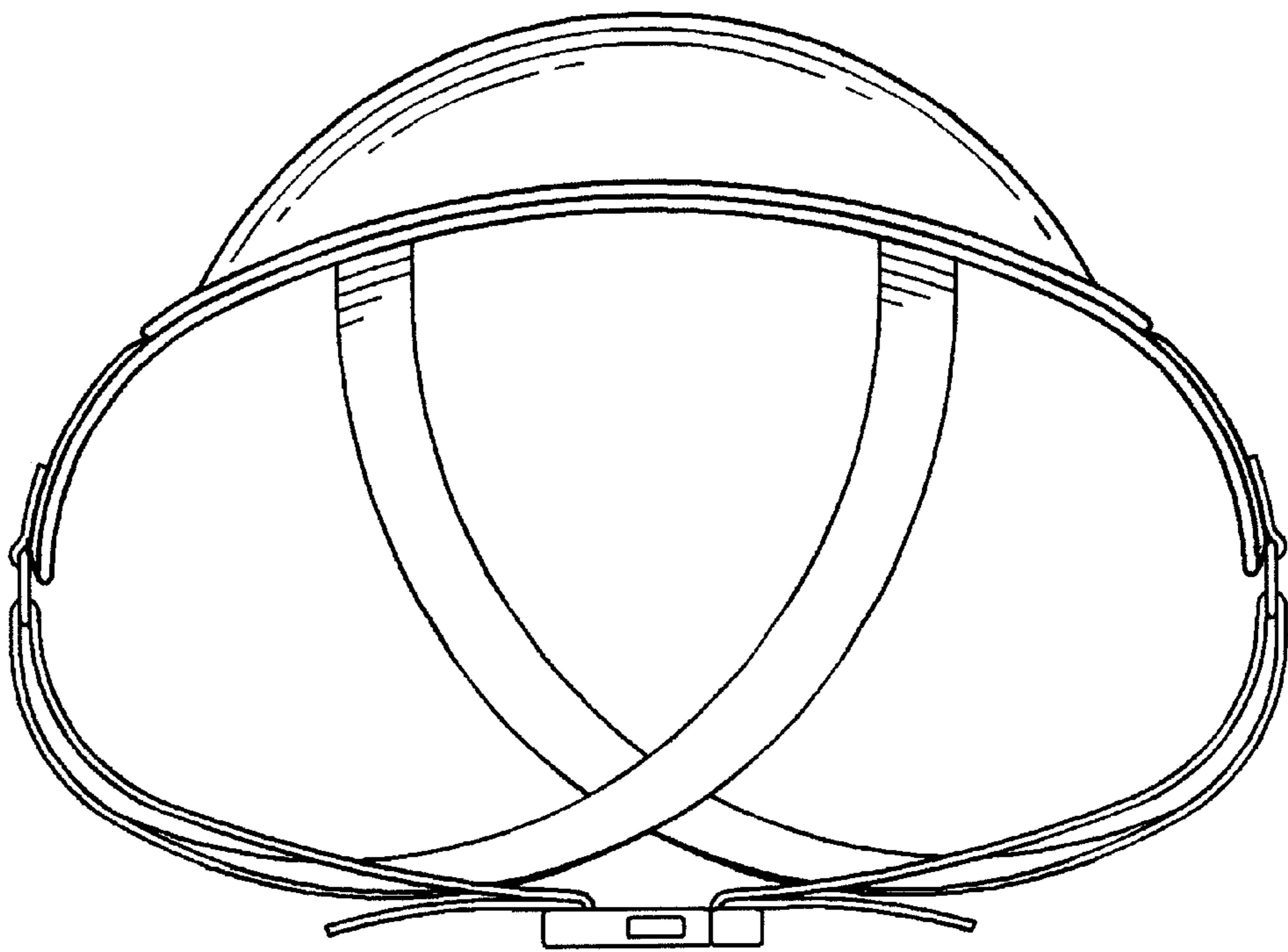

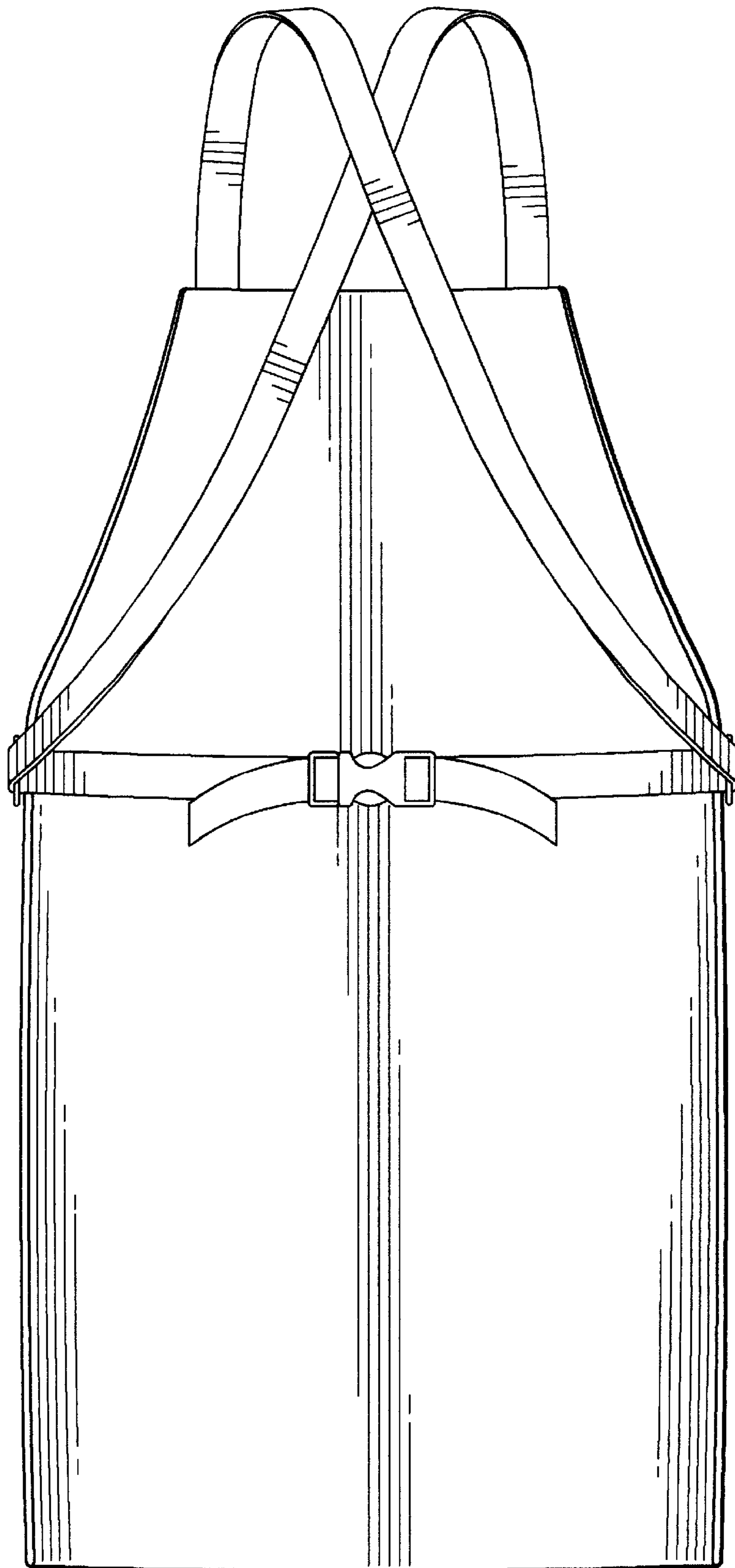

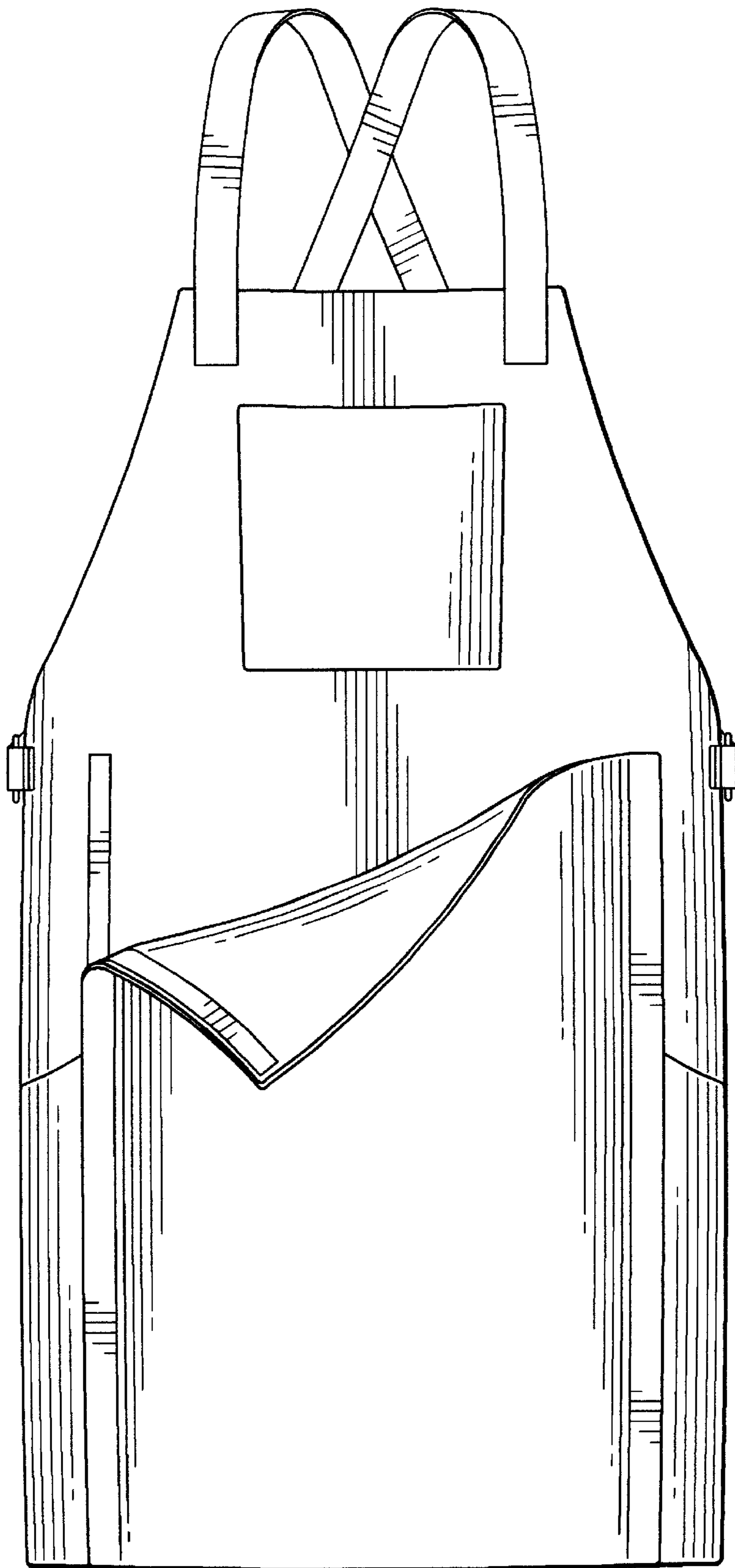
