DESCRIPTION

FIG. 1 is a top plan view of a paint brush handle showing our
new design;

FIG. 2 is a side elevational view of FIG. 1;

FIG. 3 is an top perspective view of FIG. 1;

FIG. 4 is an bottom perspective view of FIG. 1;

FIG. 5 is a side elevational view of the second embodiment
of the paint brush handle;

FIG. 6 is an top perspective view of the embodiment shown
in FIG. 5; and,

FIG. 7 is an bottom perspective view of the embodiment
shown in FIG. 5.

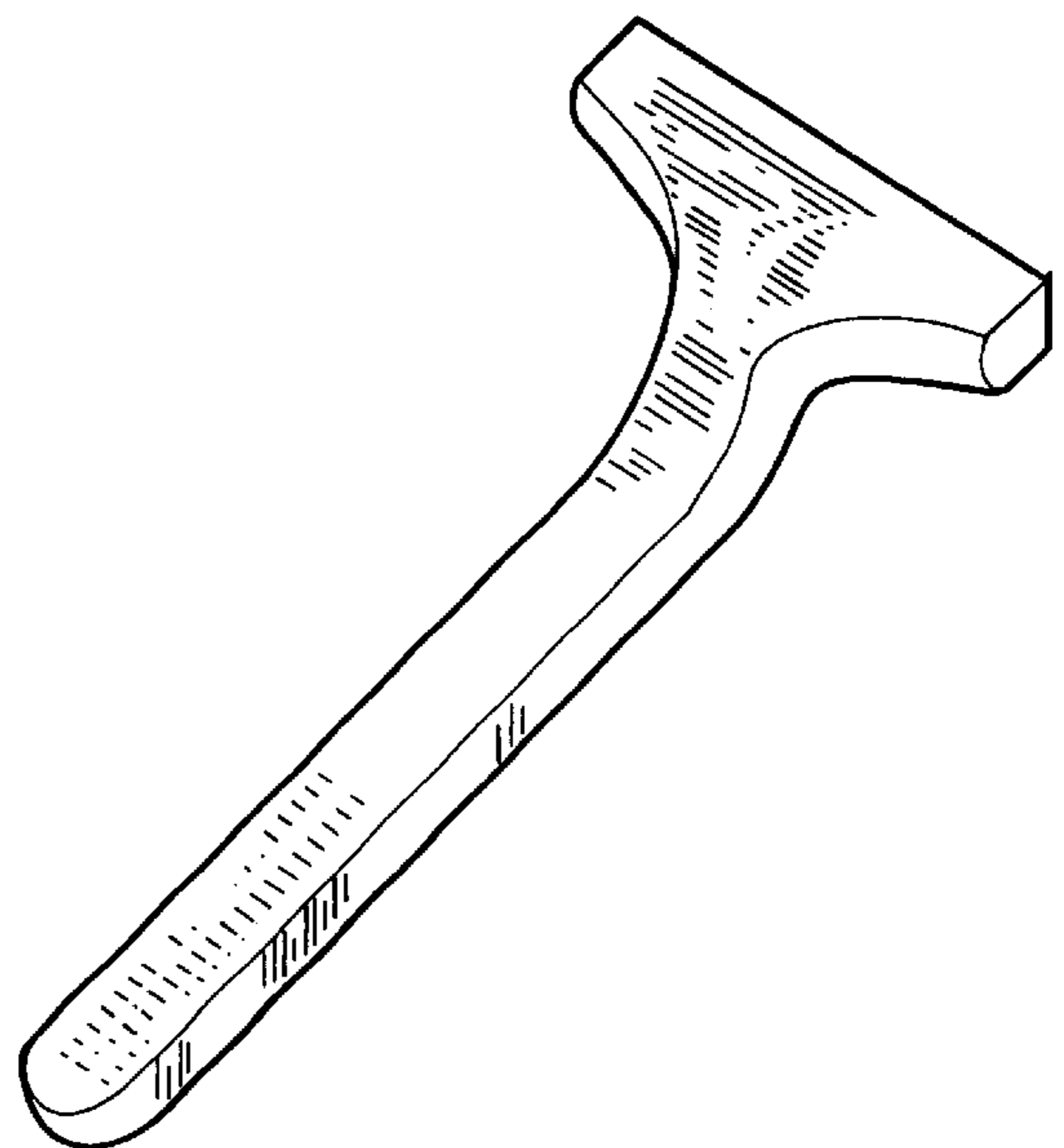
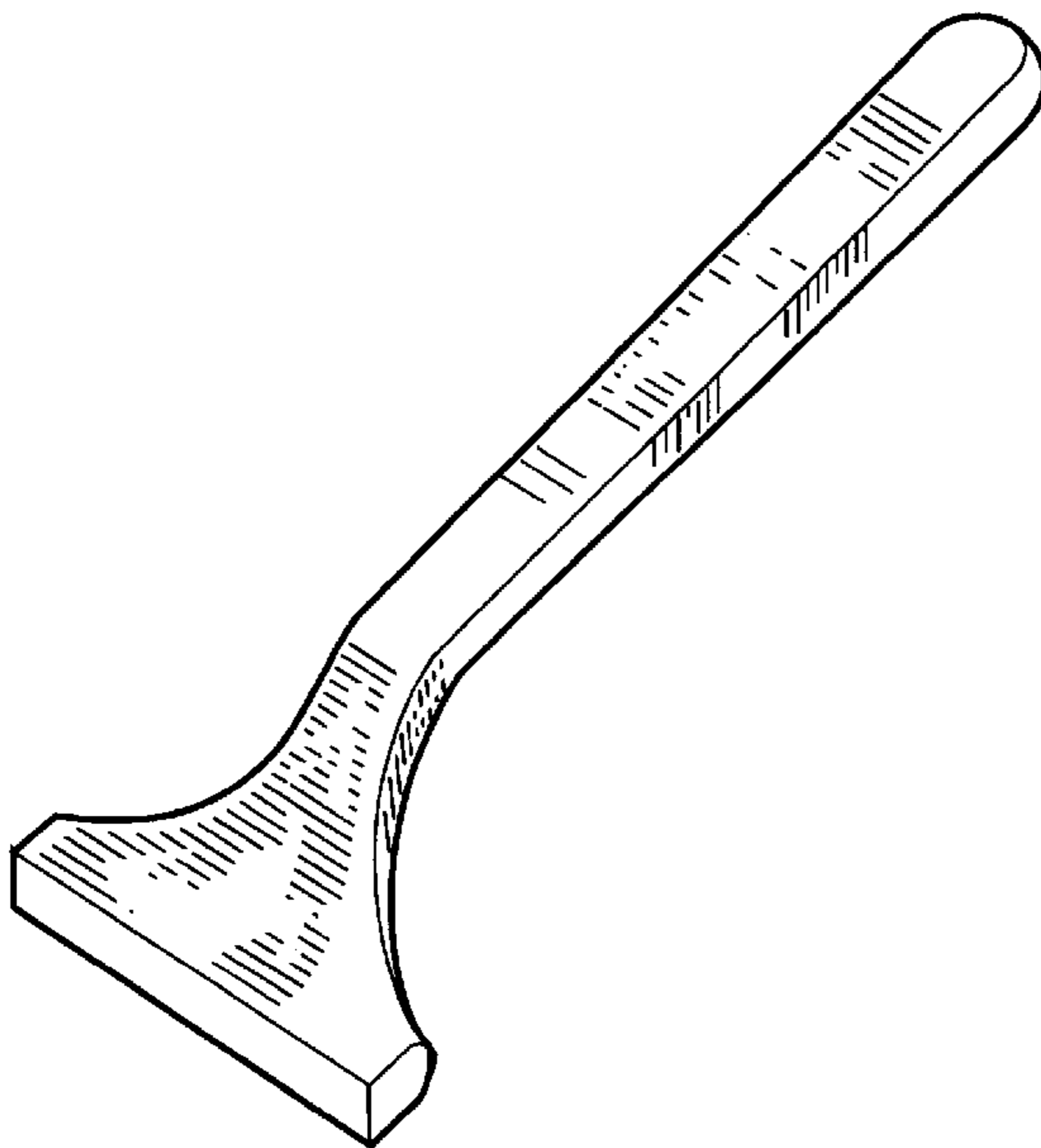

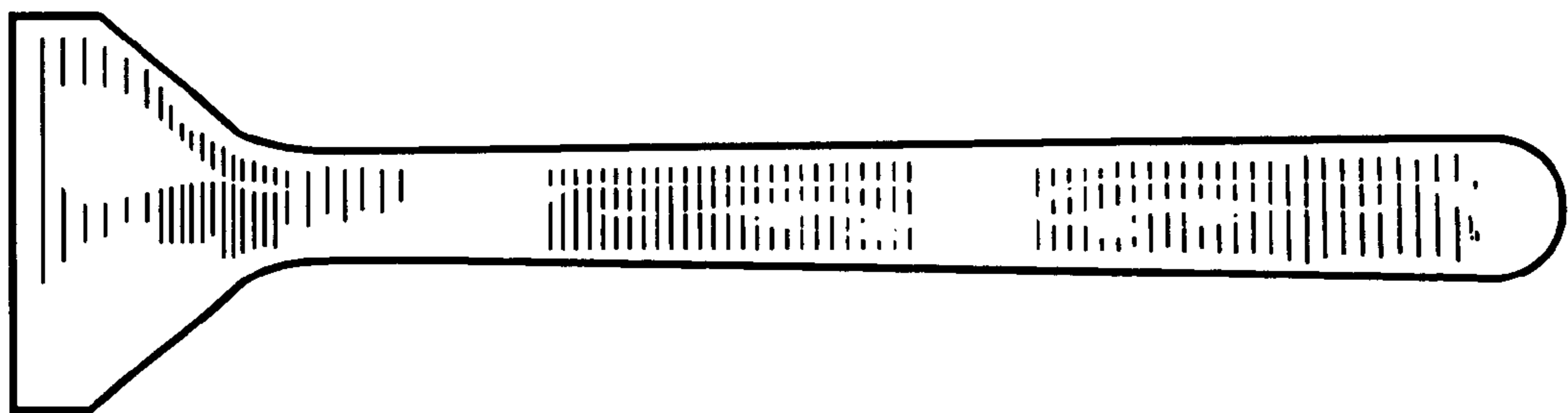

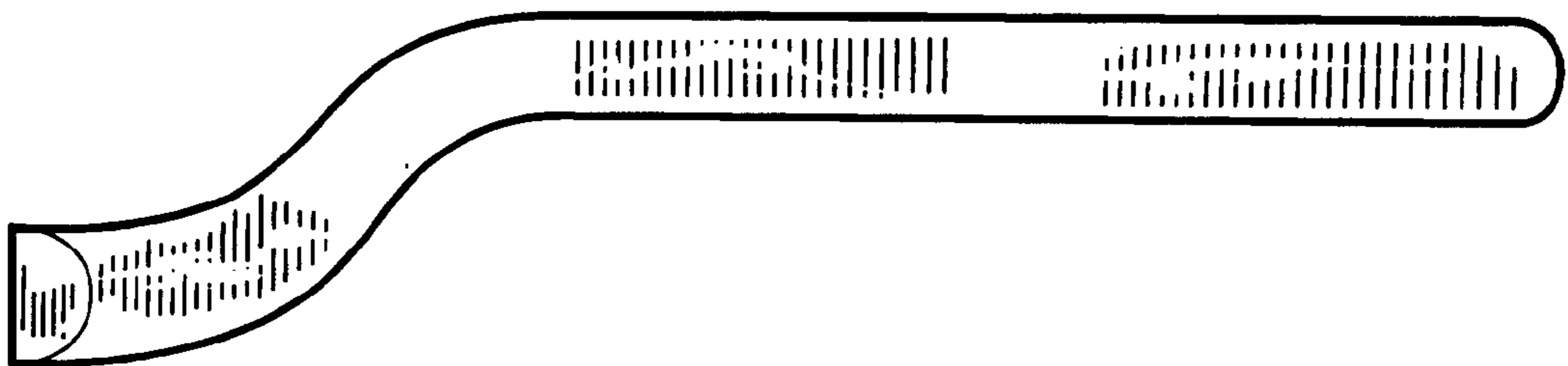

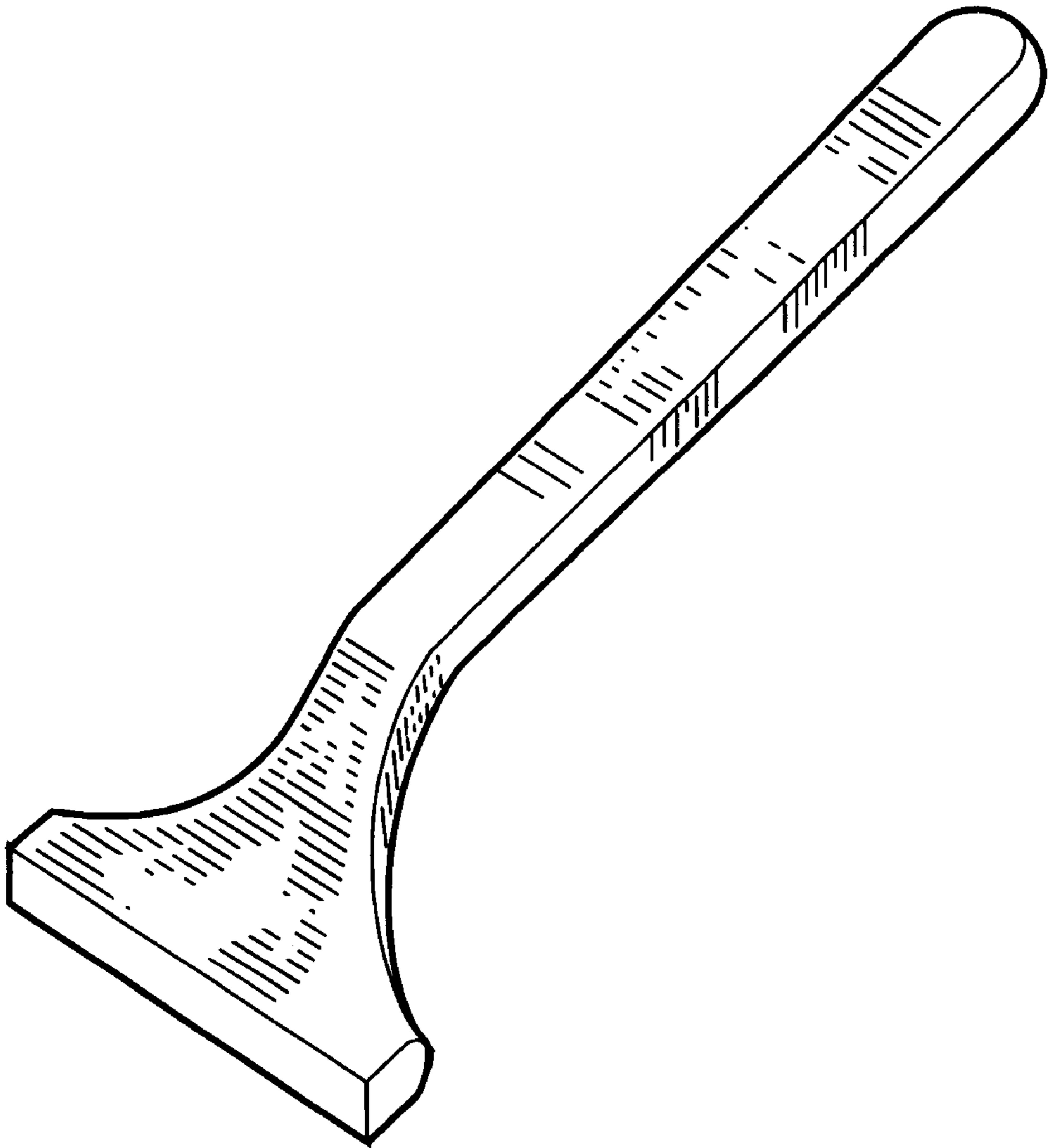

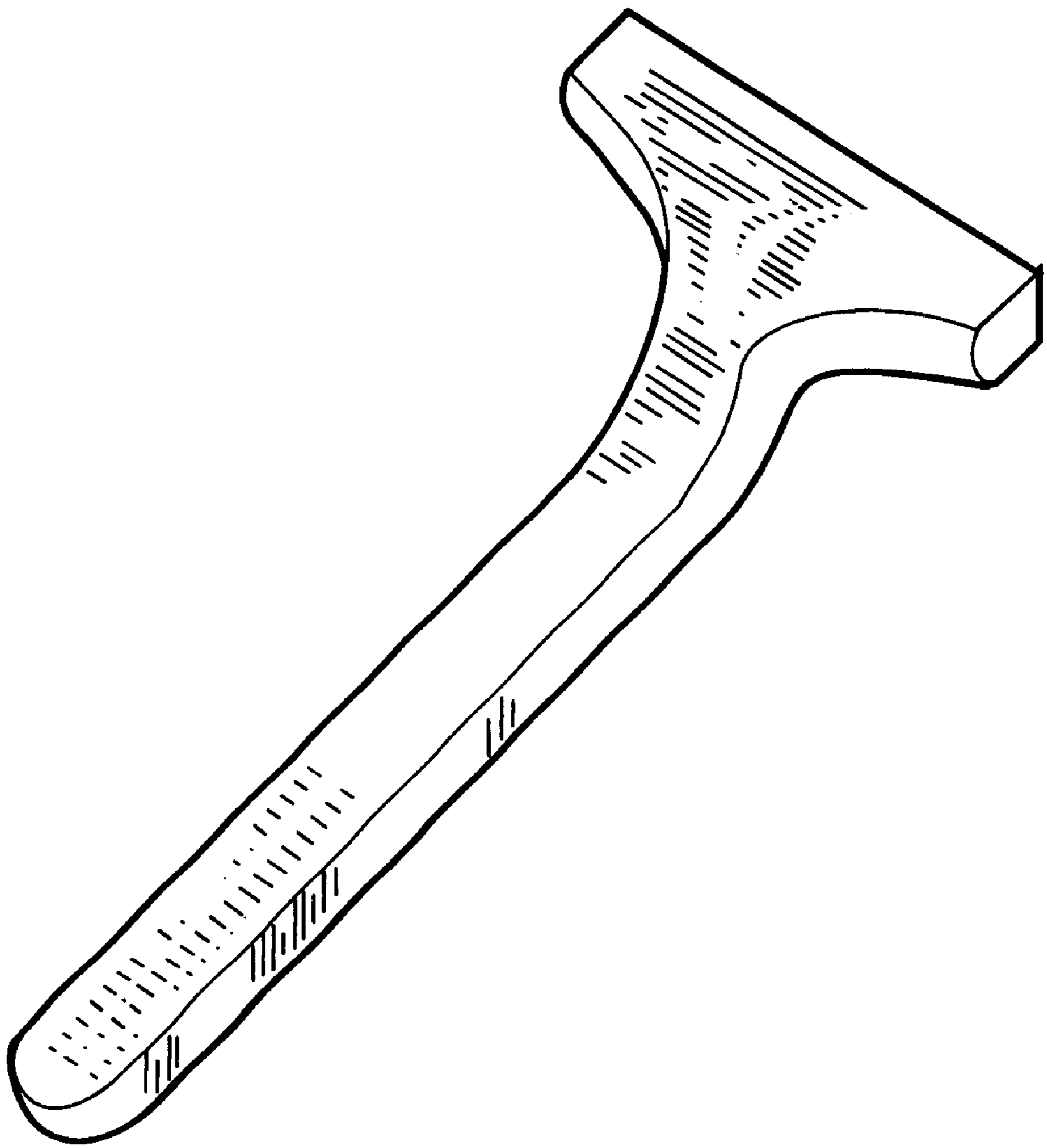

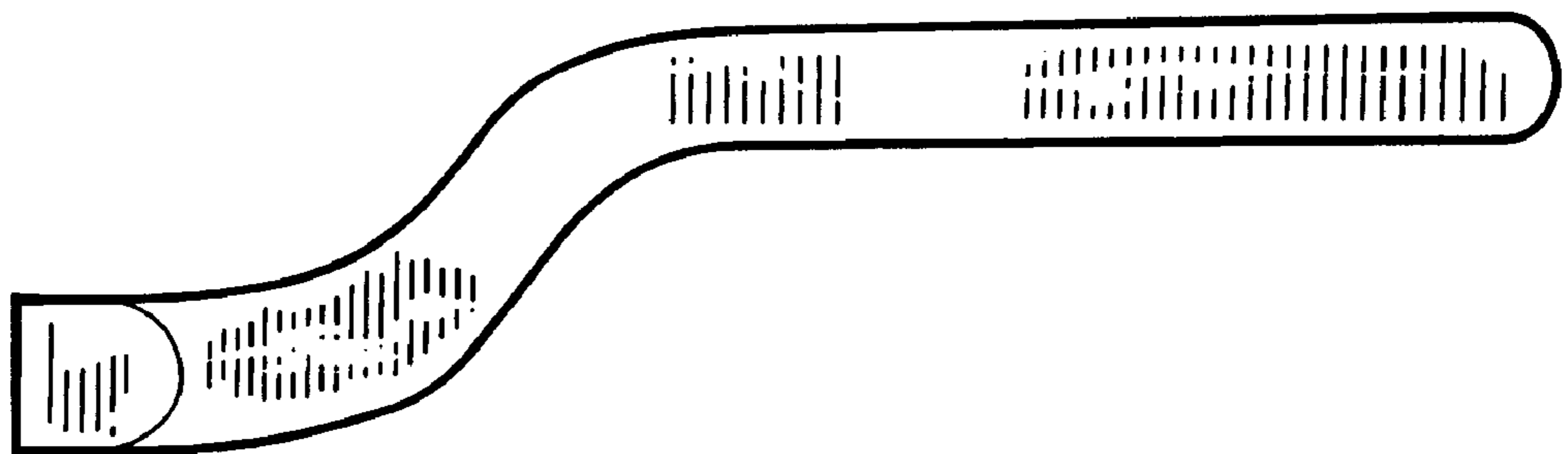

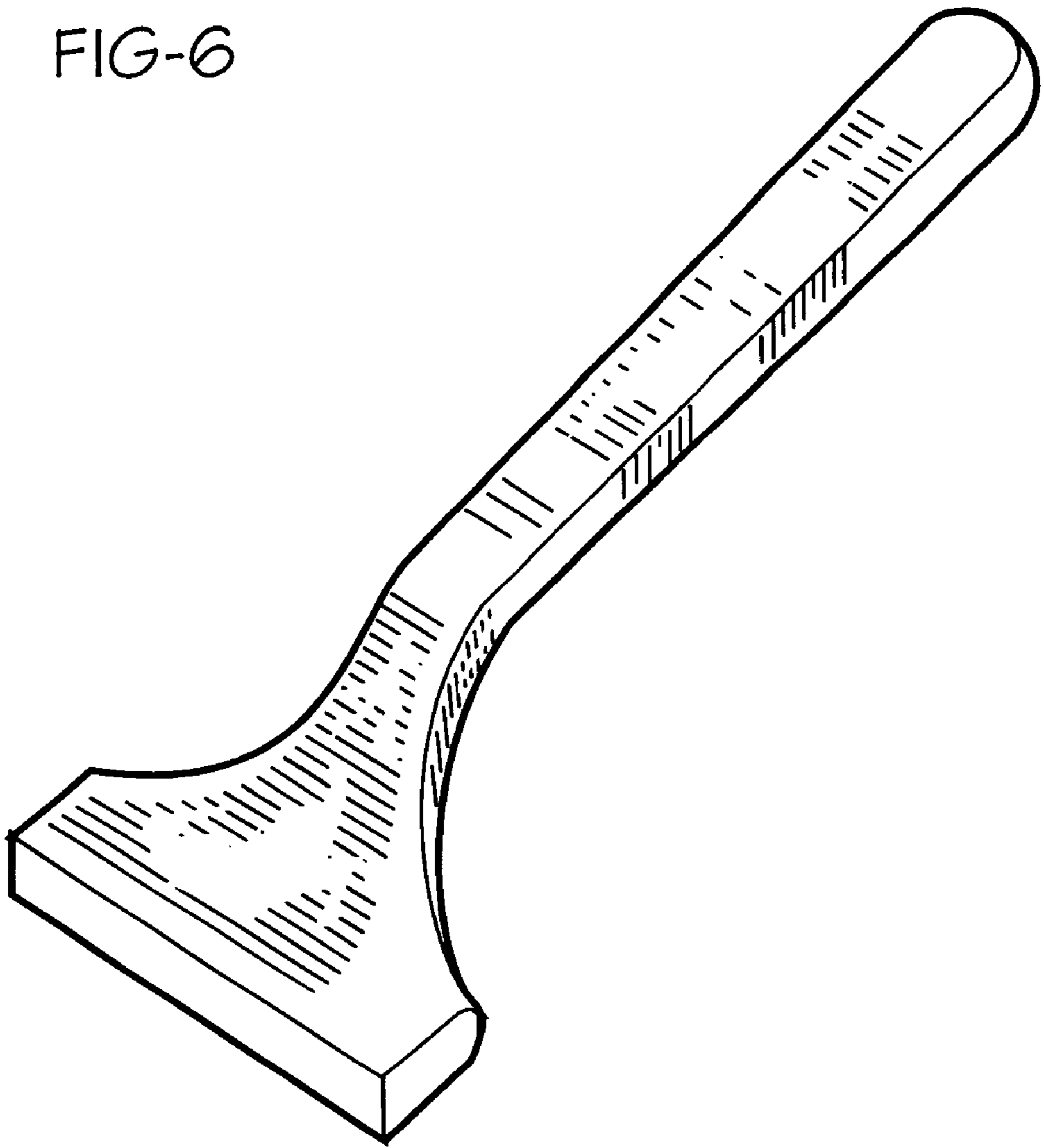
