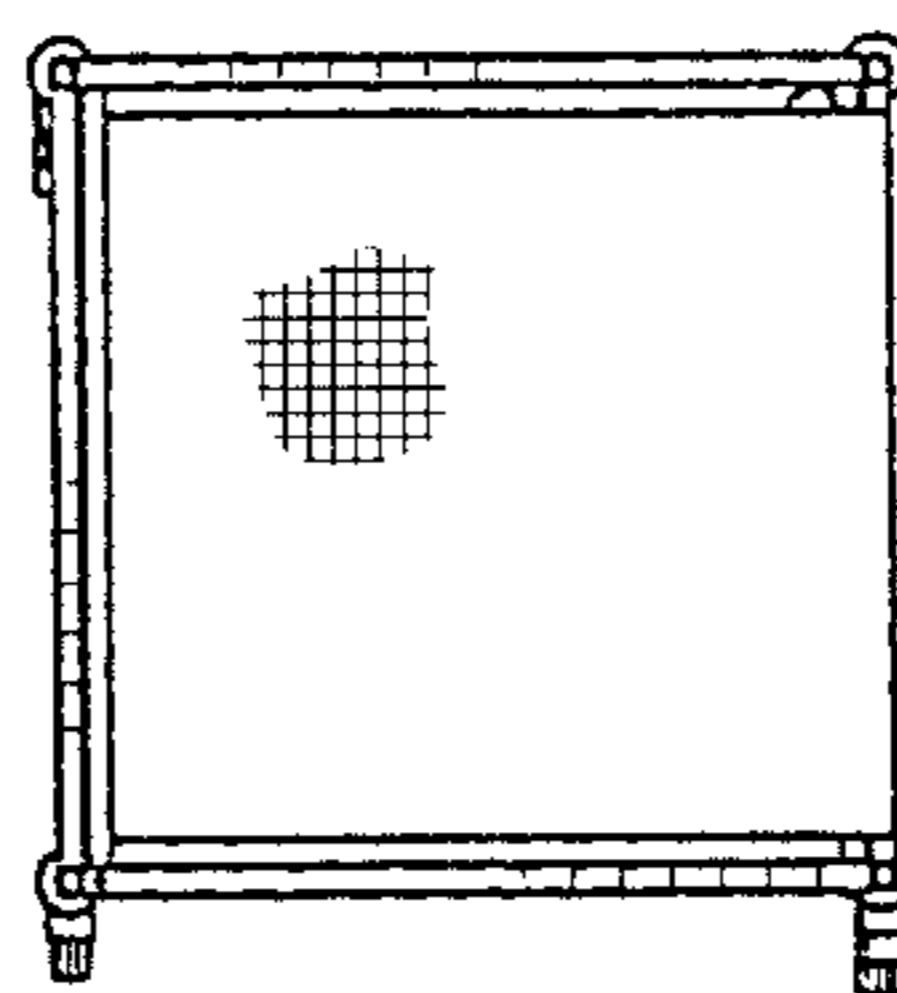
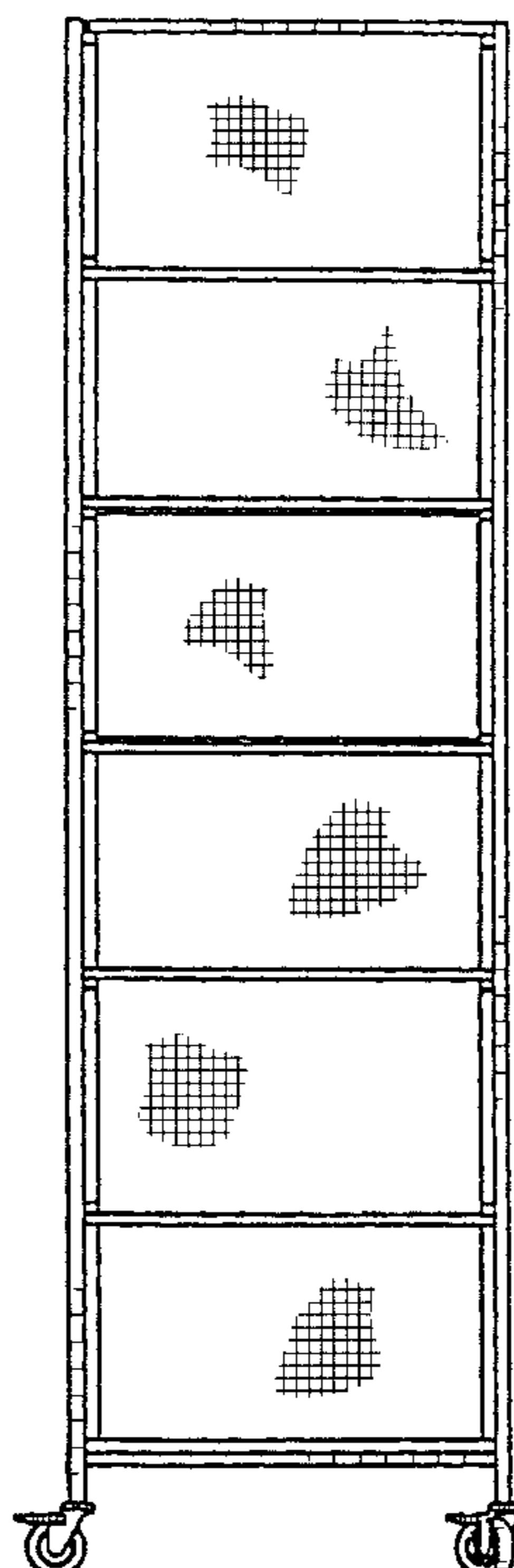
(57) **CLAIM**

The ornamental design for a rack, as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevational view of a first embodiment of a rack according to our new and ornamental design, FIG. 2 is a rear elevational view thereof, FIG. 3 is a right side elevational view thereof, FIG. 4 is a left side elevational view thereof, FIG. 5 is a top plan view thereof, and FIG. 6 is a bottom plan view thereof, FIG. 7 is a front elevational view of a second embodiment of a rack according to our new and ornamental design, FIG. 8 is a rear elevational view thereof, FIG. 9 is a right side elevational view thereof, FIG. 10 is a left side elevational view thereof, FIG. 11 is a top plan view thereof; and, FIG. 12 is a bottom plan view thereof.

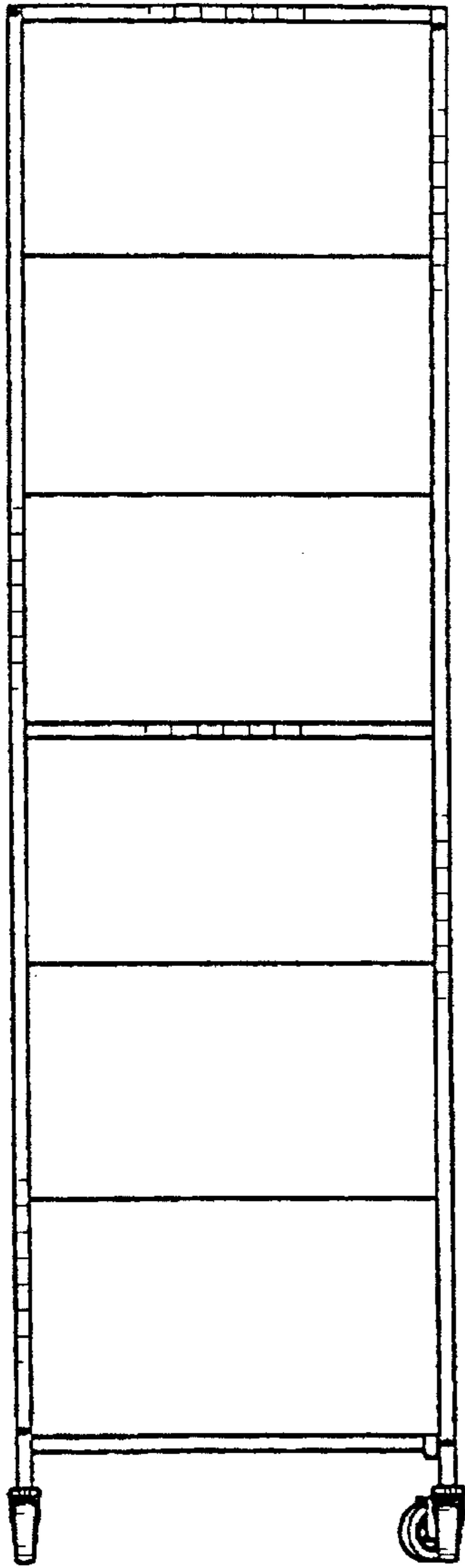

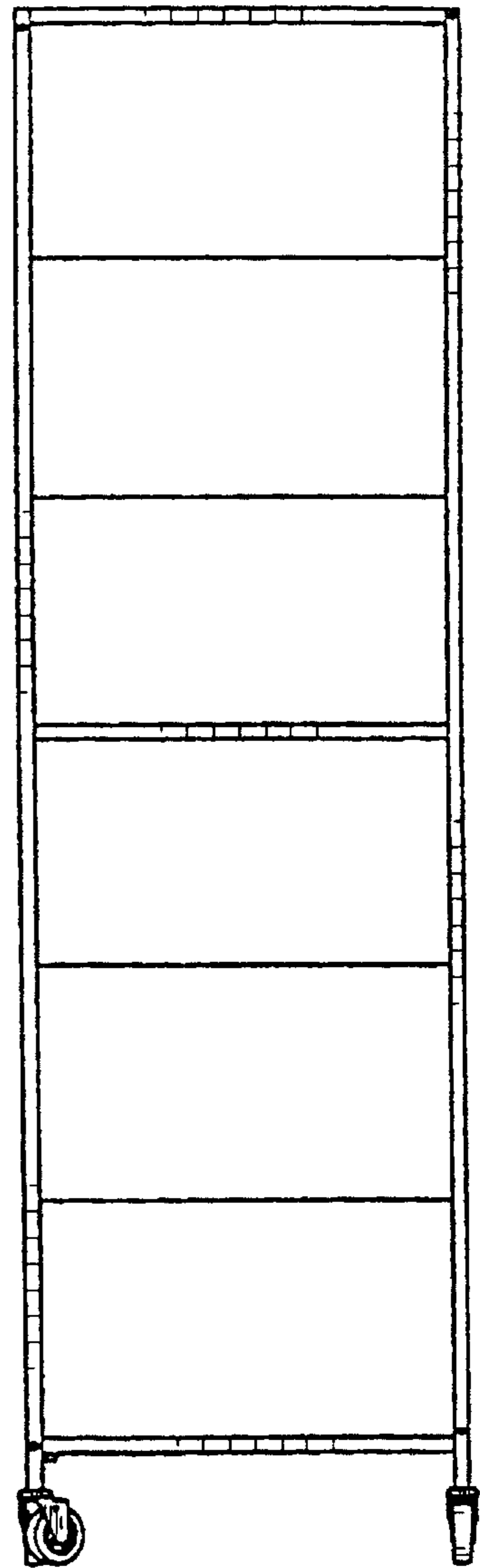

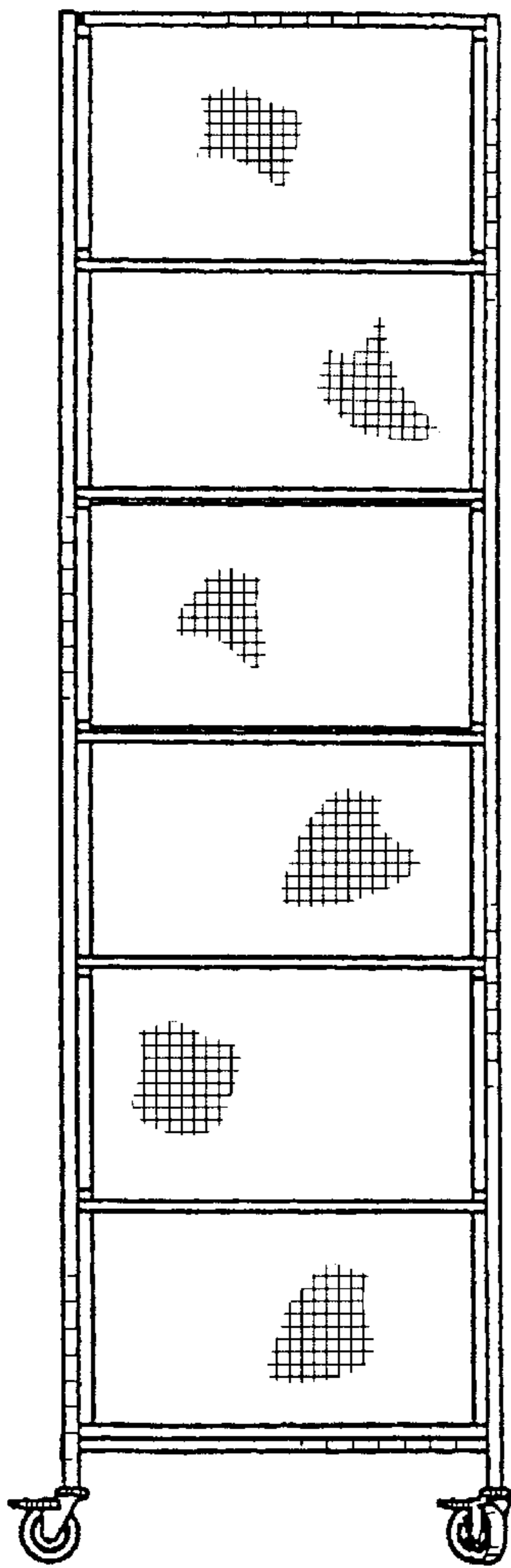

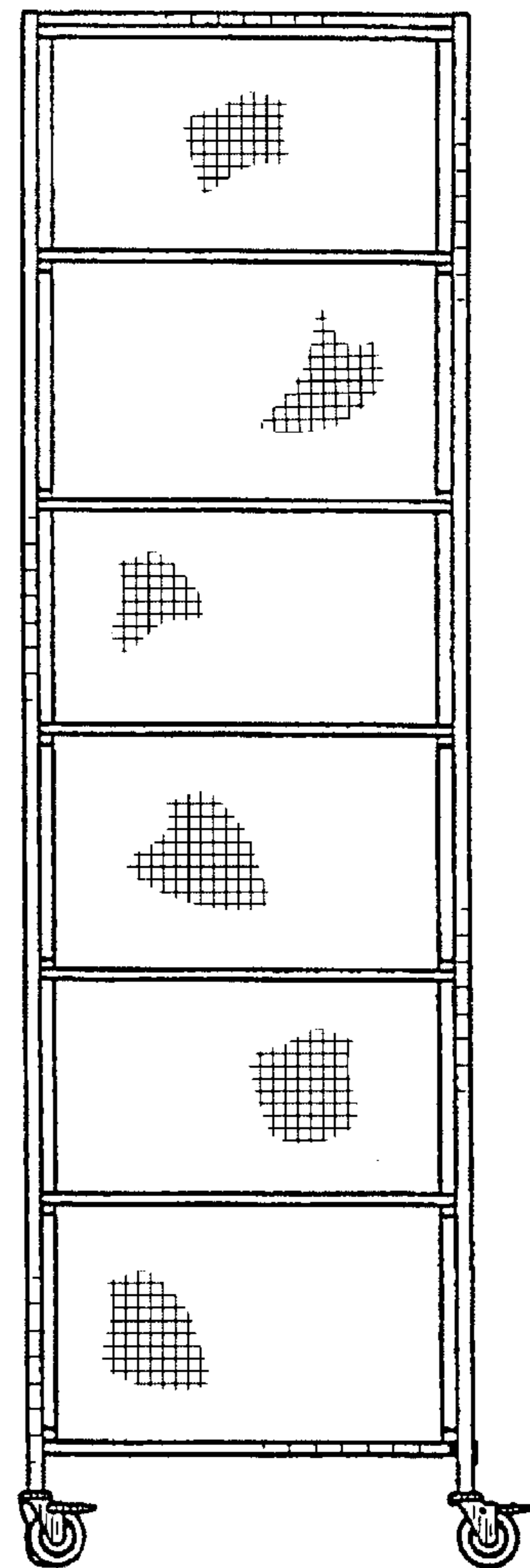

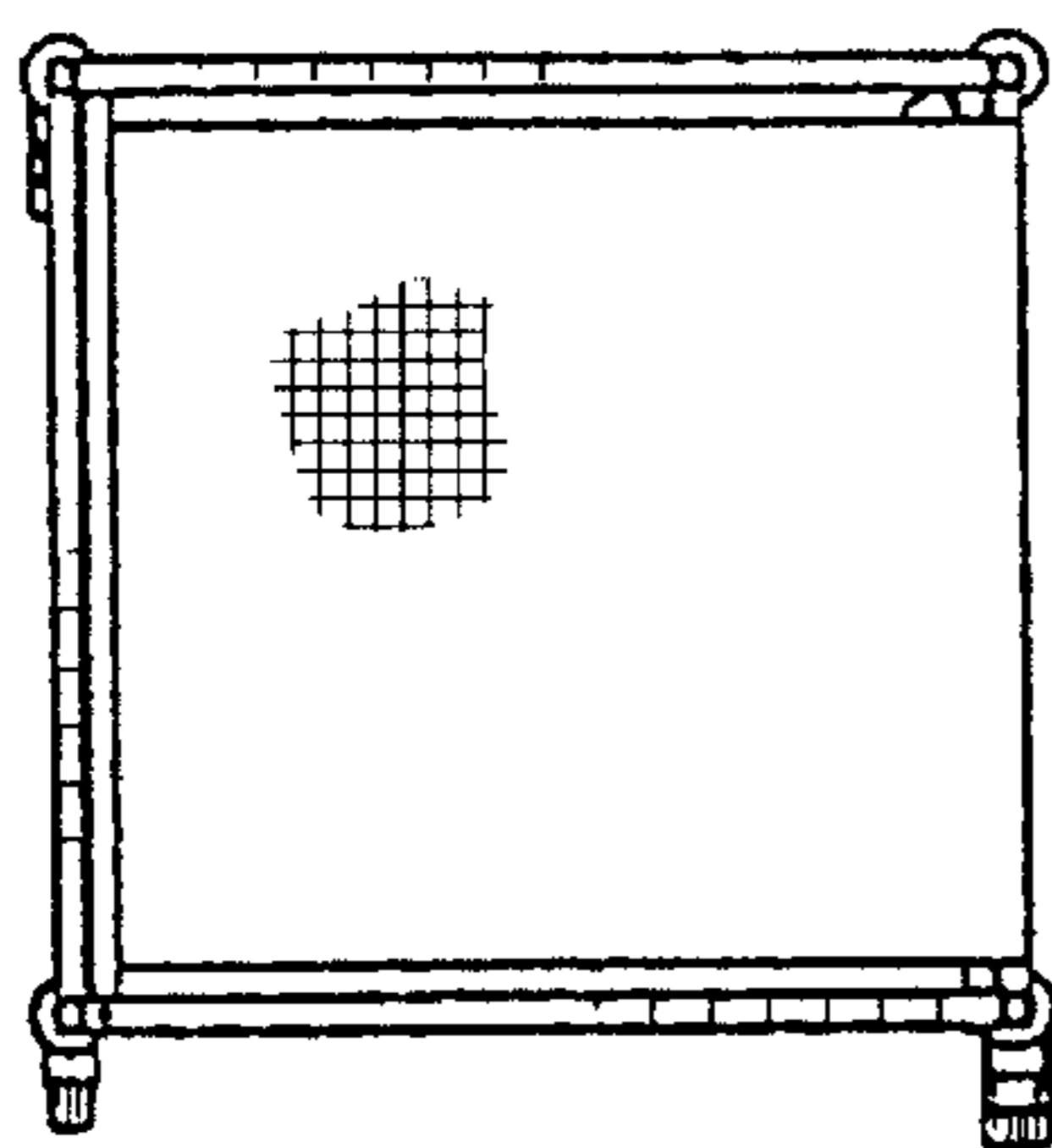

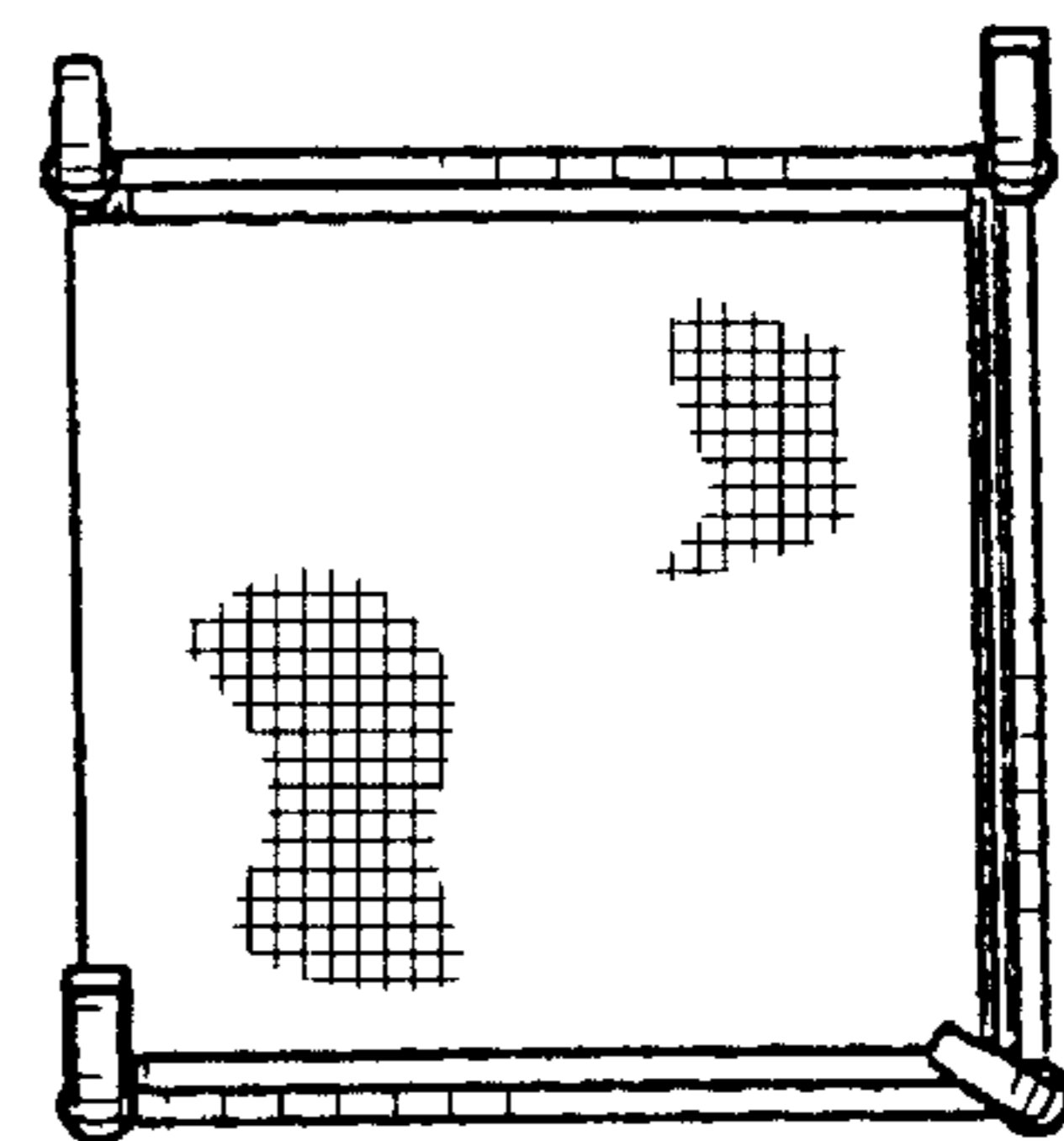

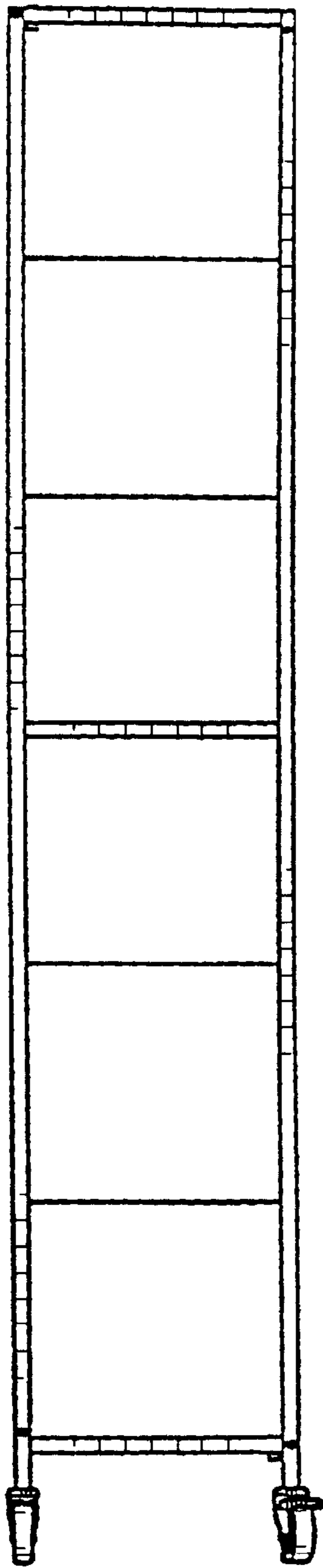

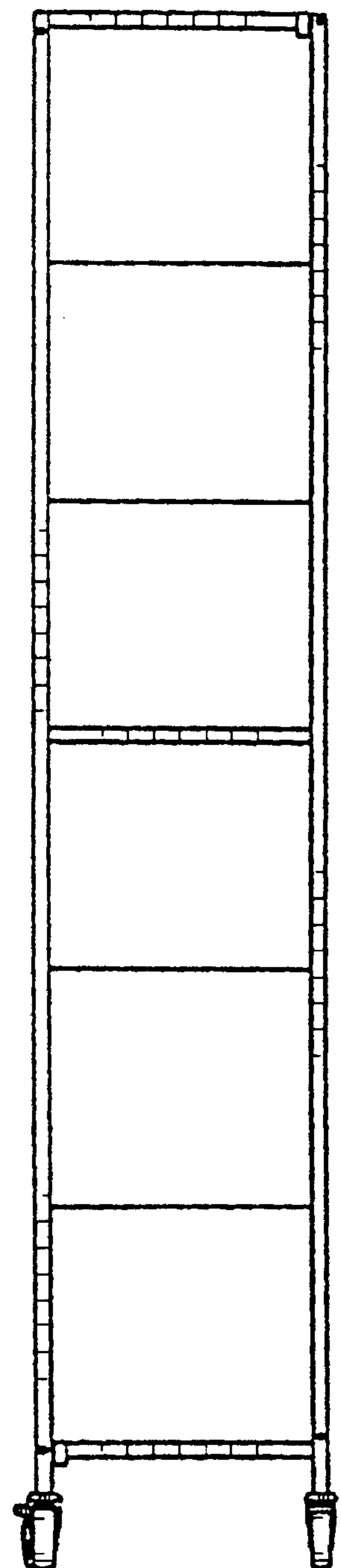

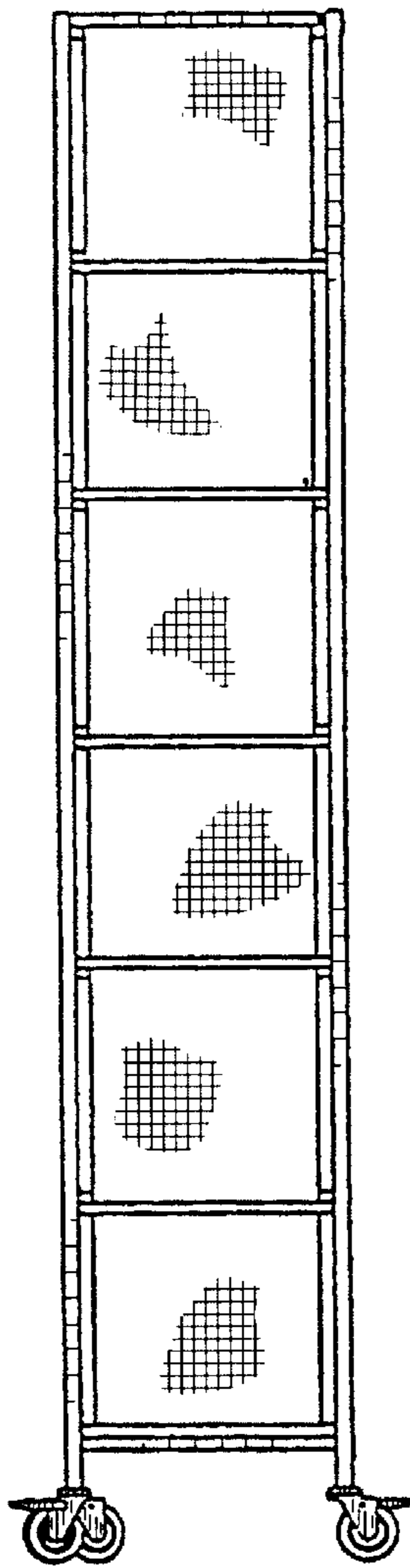

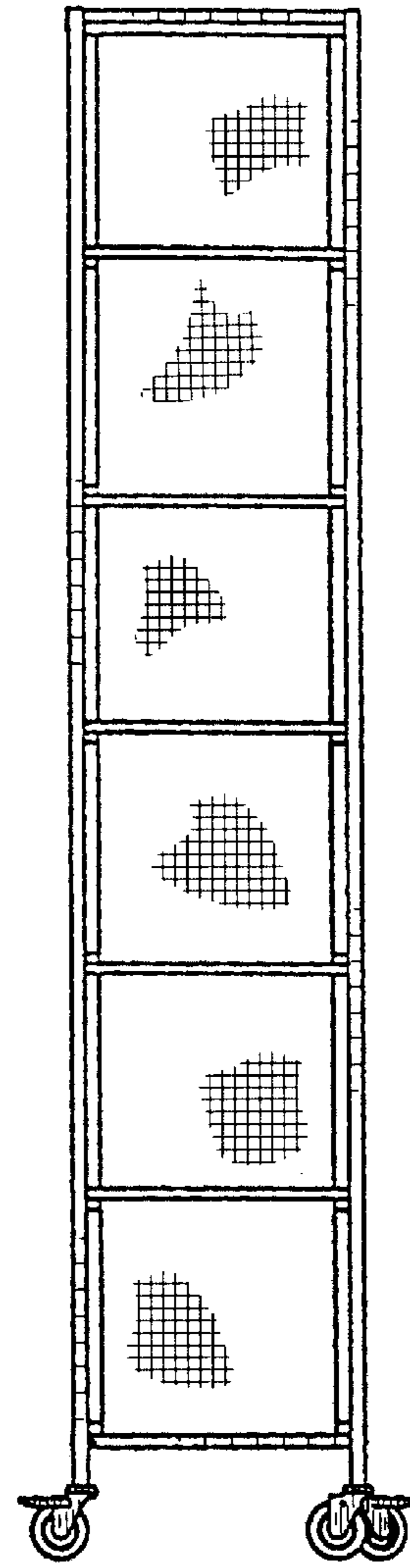

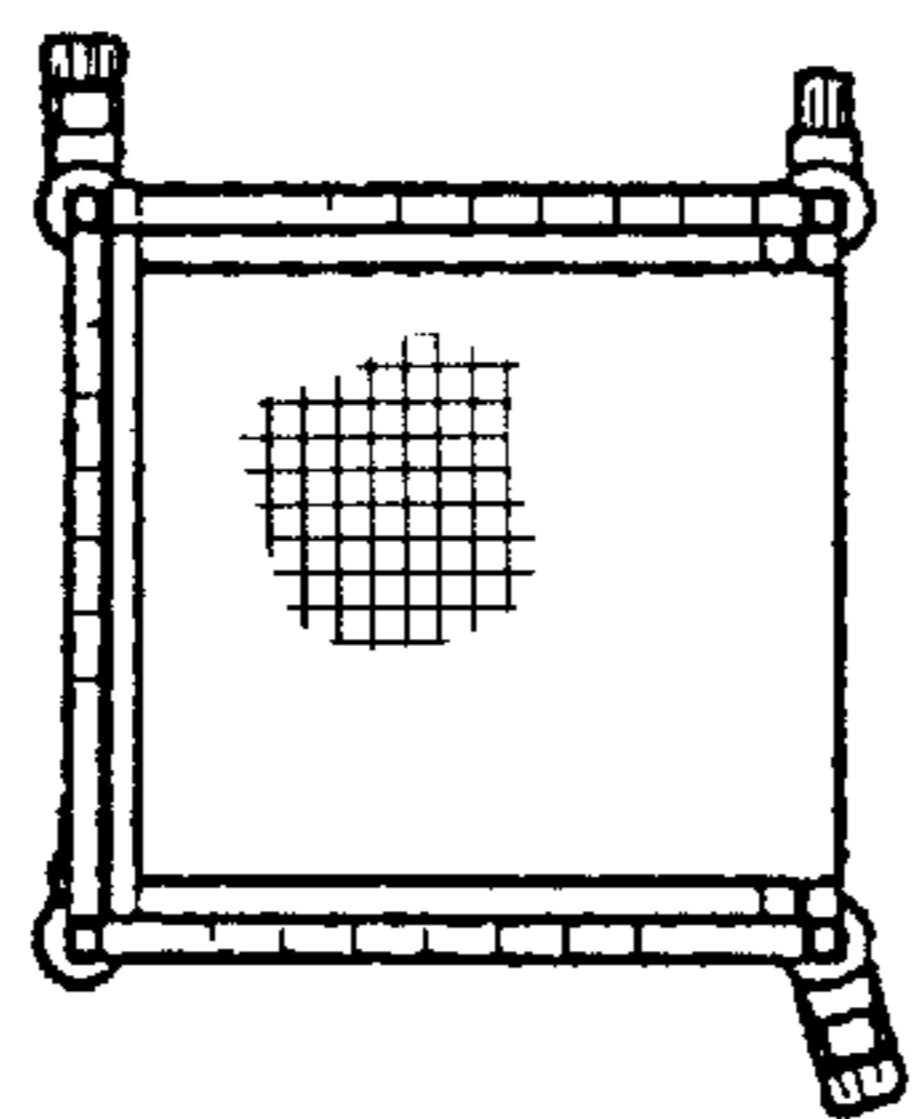

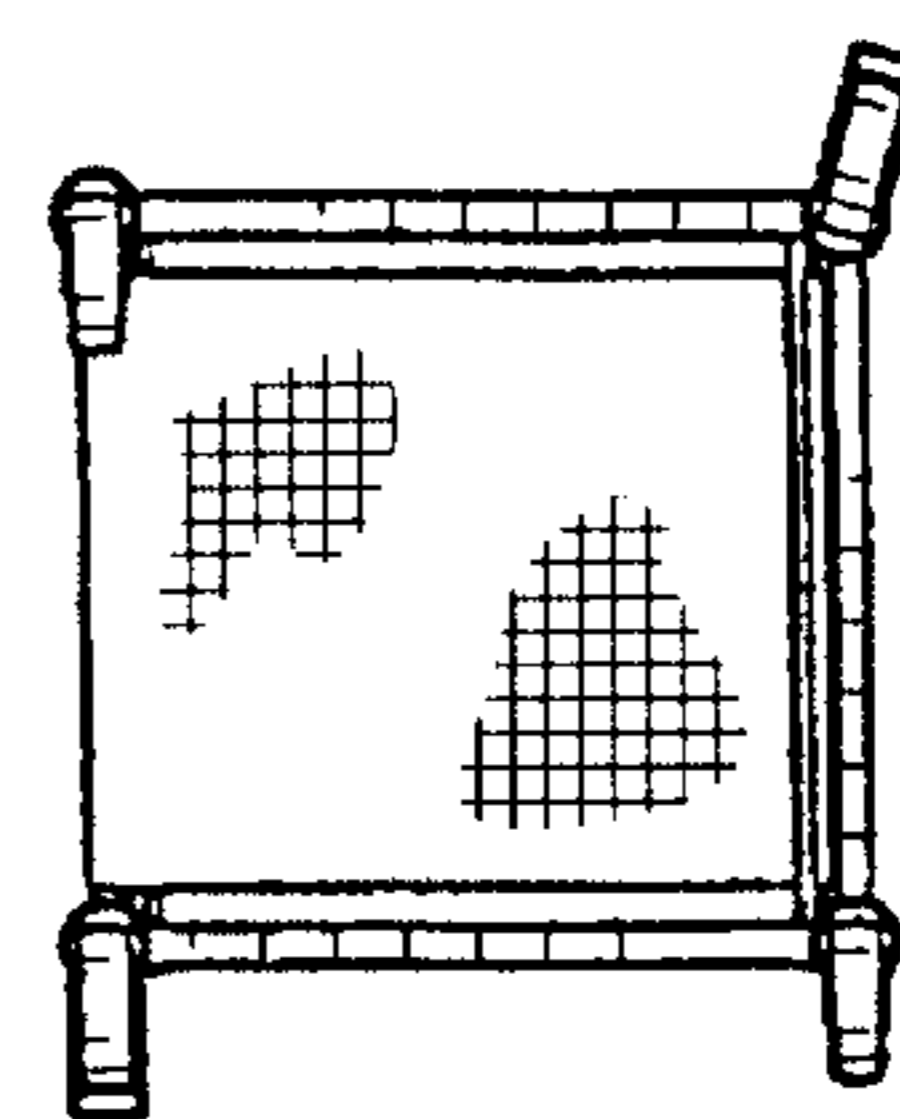
